1. (S/NF/SK) MISSION: Determine if the crew-boat identified as [REDACTED] is or will be transporting contraband in the form of illegal drugs within an actionable period of time.
2. (S/NF/SK) VIEWER TASKING: Viewer 079 was front-loaded with all available operational data known on the [REDACTED] See attached tasker.
3. (S/NF/SK) COMMENTS: No inclemencies noted. Note the word "lobela" (lobelia) surfaced phonetically to describe the type of cargo being transported by the target vessel. Neither the viewer nor the facilitator was familiar with the word. The dictionary defines "lobelia" as a herbaceous plant - leaves and tops of indian tobacco. A Summary of Information is attached.


SUMMARY OF INFORMATION

**SG1A**

The crew ship [REDACTED] is currently located on the eastern shore of Honduras in a area identified as the "Laguna de Carcatasco" where it is currently unloading a sizeable amount of hashish being stored amidships. The hashish is disguised in the general shape of a cigar (ENCLOSURE 1) within and among a load of "lobelia", a herbaceous plant comprised of leaves and tops of indian tobacco. Specifically, the illegal contraband is stored directly below the steward's cabin.

**SG1A** In about a week or less (about 20 December 1988), the [REDACTED] will be located about 140 miles south of "Pointe au Fer", Louisiana, at geographical coordinates estimated as 27 degrees 20 minutes N and 92 degrees W. The [REDACTED] can **SG1A** readily be intercepted at this location. The [REDACTED] will then sail northeast to New Orleans where it is projected to unload its cargo for further dissemination to various destinations in the US.


