Summary of Informant

EEI: #4

The target is a male. He is around 50 yrs old \pm 5 yrs. He is a little over weight, average height, somewhat light complected, wears glasses and has some form of facial hair. He either wears or collects high quality gold jewelry or gold objects. He is cautious, very careful, sly, ~~involved~~ manages his life in a covert fashion, is a perfectionist and always covers his rear end (CYA!!).

EEI: 1

He is not currently involved with trafficking narcotics. However, he is involved with some sort of illegal smuggling activity, especially in the lower Caribbean area. He keeps himself extremely well isolated from any direct connection to illegal activities conducted by his boat(s). *He knows that his operation is under surveillance and that there are ~~de~~ attempts to watch him personally.

EEI: #2

There are two levels of loading his vessels; one is covert and is conducted under deck & the second is the overt (on deck). There is an emphasis that the latter activity is very obvious & visible. Venezuela, Caracas; the numbers 43 and/or 47 are significant to the operations.

EEI: #3

He is currently involved with a meeting of sorts. There are 3 to 6 other individuals present. The room is reminiscent of a corporate conference room; the target is looking at & studying something - papers, schedules - documents of some sort. The target is agitated and this is causing fear, concern & intimidation in the others. *The target is also concerned about planning and accounting.

This meeting is taking place in a private residence. It has a magnificent view of a valley and feels like it is above the surrounding area i.e. a small mountain, ~~foot~~ foothills, etc.

There is a sense of the presence of sophisticated electronic equipment in the structure. It is reminiscent of an oscilloscope, VCR and a piece with digital frequency


