The vessel known as the [redacted] is currently located at 19 Degrees North and 115 Degrees West. It is close to an area known as Isla De Clarion.


SUMMARY OF INFORMATION

The vessel identified as "Humu" is a clean-appearing, vessels with smooth lines, and painted yellow and blue. The name "Mcehi/Michel/Michael" surfaced phonetically to identify the owner of the vessel. He appears to be a very proud man. In about eight days, the vessel will arrive in an area identified phonetically (sounds like) San Moritz * (France?) where it will off-load at night to a smaller open vessel (~~rowboat~~) holding one or two men. The drugs are packaged in square boxes and wrapped in brown paper.

Communications associated with the delivery of the drugs seem to be comprised of "land to land" communications and the use of "double messages" (some form of code).

Efforts to determine the call sign associated with the "Humu" resulted in the surfacing of the phonetics, "JXNZ."

SUMMARY OF INFORMATION

I RECEIVED AN IMPRESSION OF THE TARGET VESSEL EITHER DEPARTING FROM, OR PASSING VERY NEAR THE PENINSULA OF YUCATAN HEADING NORTH. THE NAME "CAN CUN" COMES TO MIND. I PICTURE THE VESSEL CONTINUING ON A NORTHERLY HEADING TO THE WEST COAST OF FLORIDA AND PUTTING-IN TO A LARGE BAY. THE TAMPA BAY AND SARASOTA AREAS SEEM TO STAND OUT.

SUMMARY OF INFORMATION

The contraband is wrapped in plastic and is positioned inside or behind wooden walls. These wooden walls are along the ribs of the hull -- there is a dead space there where the contraband is laying. It would take a great deal of effort to get to these packages.

The ship is located in the Pacific but will not make port -- something drastic will happen aboard the ship. My perceptions were of severe weather destroying the ship prior to it's arrival at it's destination. The ship is capsized and destroyed.

The drugs aboard the ship are cocaine.

The ship was headed for the West Coast of North America but turned and moved south. Location of the projected loss is at sketch B.

SUMMARY OF INFORMATION:

1. (S/STD) Determine the destination of the contraband in the form of illegal drugs: Somewhere in Delaware Bay (north of the Washington, D.C. area). The person unloading the contraband was seen to be standing in soft mud-bottomed water, slightly lower than waist-deep. He was seen unloading the packages of contraband by handing them upward to someone above.
2. (S/STD) Determine the current location of the vessel: The vessel is currently located near Port Au Prince, ^(Haiti) at a location where a high rise of land a few hundred feet from the shore is directly between the ship and a small city a few miles away across low, flat land.
3. (S/STD) Determine the type of drug aboard the ship: The drug is a dry, white powder, very fine in texture. There is no smell, and there is a very mild tart taste to it.
4. (S/STD) How is it packaged?: It is wrapped in yellowish, thick waxed paper, in bundles about 9" X 6" X 3".
5. (S/STD) Where is it stored?: It is stored as the bottom layer of a large flat of other packages of the same size and shape in the cargo hold.

SUMMARY OF INFORMATION

The vessel travels around the southern tip of the United States (Florida) and its intended destination is near the coast of Georgia at coordinates $31^{\circ}N - 86^{\circ}W$. * It is carrying different drugs including cocaine which can be found where the rails are in the back side of the vessel.

* location is about 30 miles east of St Andrew Sound, located in the southern part of Georgia.
