THE [REDACTED] IS TRAVELLING IN THE GULF OF MEXICO. THE MARIJUANA WILL BE DROPPED OFF AFTER THE PORT OF GALVESTON. IT WILL THEN PROCEED BACK TOWARD THE GULF OF MEXICO PAST ACKLINS ISLAND, WHERE IT WILL RECEIVE INSTRUCTIONS AND PROCEED DOWN TO THE CARIBBEAN SEA. WHERE IT IS GOING FROM THERE IS UNKNOWN.
