3. (S/NF/SK) ~~Summary~~: Summary: ~~Site located in the~~ Site is ~~underground with access via a shaft (elevator?)~~ ~~horizontal and vertical shafts and a large metal sliding door.~~  
The site is a large room underground.

Access to the target is via a vertical ~~to~~ shaft (elevator?) located beneath the domed building. ~~Once~~ Two ~~horizontal~~ horizontal shafts extend "to the right" away from the vertical shaft. The people at the site, (one with oriental features), are monitoring information received from 'waves'. This information is in the form of flashing jumbled numbers on large screens. People are seated at a large console in the room.

4. (S/NF/SK) : Ops officer opined that source was ~~probably~~ on target. He briefed monitor on ~~the~~ ~~gen~~ what was known about this site ~~and~~ in the intel community and supplied monitor with a diagram which depicts target in relation to surroundings. Ops officer requested that monitor, armed with this new knowledge, return source(s) to ~~the~~ target ~~for~~ one more time. Monitor decided on the spot to employ a different set of coordinates to the problem, now that a more ~~specific~~ specific 'address' was available for the target. ~~Monitor plans to~~ ~~the~~ ~~same~~ ~~of~~ ~~the~~ For the next session(s), then, monitor plans to inform source(s) that the same site as before will be worked, but that a more specific 'coordinate address' (encrypted) will be used.
