S4 1/2 activity is occurring even though instigators said it wasn't; as it s. thing mutually agreed on; but people involved w/ project felt a necessity to conduct it despite agreement. Idea of ends justify means.

Site involves event composed of 5 steps; planning; preparatory; conduct; evaluation; during course of conduct of project, moving ^{object} receives input which is informational in nature + directs, controls, verifies status; + has ← something w/ parameters + "supervising" + strict "performance envelope." After 1st part, when impetus for object no longer present, information flow reverses; output involves response/reporting. Periodic input during 2nd part affects attitude, perhaps course or orientation. ← Entire project has sense of "quasi-legality"; as if people at site felt activity would be frowned on by 3rd party, it organization of it; that it would evoke a feeling of betrayal or unfairness; as if activity is occurring even though instigators said it wouldn't upon mutual agreement. But people involved felt necessity to conduct it nevertheless; "ends justify means."
