1. (U) Personnel:

- PAG-TA has three civilian vacancies (two long-standing and one resulting from retirement in June 93).
- No change in status on our submission for civilian hire to conduct foreign assessments.

2. (U) Administration:

- PAG-TA classified material holdings at DIAC continue to be reviewed. Review of data held in both PAG-1D and PAN-2A should be completed NLT 10 Dec 93.
- Game plan for move to Building 2845 being updated. Cost estimates received from Directorate of Public Works on 23 Nov 93. Copies of the cost estimate forwarded to DAL-2 for action on 30 Nov 93. Copies also furnished to DAC-2 and PAG for information. DAC-2 will be our focal point for upgrading Room 111 for SCIF-level activity.
