

- (S/NF/SG/LIMDIS) Source A: SG1A

-- The target [REDACTED] may be caught in a severe lightning storm and go down in route before August. Some type of radio communications and perhaps a helicopter may be on the scene. The target is located near coastal waters and beach area. The target is associated with a dark skinned man with corn rows or braids and a slight accent. This individual has been involved in illegal dealings for money. A vision of "packed ice" or ice cubes in a storage container came to mind which could be a means of concealing goods.
