

(S/NF/SG/LIMDIS) Following are the perceived highlights from each source.

- (S/NF/SG/LIMDIS) Source A:

SG1B  
-- The target [REDACTED] is dealing wherein something this individual is doing may manifest between August and November of this year. He has been known in the past to have certain relationships but was hung up or delayed in receiving paid dues for his services. He may have been temporarily out of commission. He has been known to be involved with vessels and perhaps drugs.

-- Target is a personality who has a rather small build. He has dark hair and dark eyes. Personality is a drug runner and has been doing this for sometime. He knows exactly what he is doing and it is difficult for law enforcement agencies to get him. He may know street gangs.
