out - cargo & crew*

THE TARGET APPEARS TO BE A TWO-MASTED SAILING VESSEL. THIS SHIP IS
PRESENTLY UNDER-SAIL AT APPROXIMATELY 20° NORTH BY 84° WEST AND IS HEADING *(100 nm south of Fla. coastline Cuba)*
IN A NORTHWESTERLY DIRECTION. THERE ARE STRONG WINDS AND A MODERATE SEA.
THE SHIP IS BASICALLY WHITE IN COLOR AND IS LONG AND SLEEK-LOOKING. IT AP-
PEARS TO BE COMING FROM THE DIRECTION OF THE CAYMAN ISLANDS AND IS *(250 miles E of current pos)*
HEADING FOR MIAMI, WITH A STOP-OVER IN THE FLORIDA KEYS. I DO NOT PER-
CEIVE ANY ILLEGAL CARGO OF DRUGS ON BOARD AT THIS TIME.






SIDE VIEW
