SUMMARY OF INFORMATION

On or about 14 November 1988, the [redacted] unloaded illegal contraband in the form of "hashish" in an area located in the Gulf de Papagayo at a location situated between Liberia and Bagaces, Costa Rica. See Number 1, ENCLOSURE 1. The [redacted] then sailed for Masatepe, Nicaragua, where it unloaded illegal contraband in the form of hashish. [Masatepe is located immediately south of Managua, Nicaragua. See Number 2 at ENCLOSURE 1.

The vessel [redacted] is currently located at the point marked "X", ENCLOSURE 2; this site is located about 1100 miles south of Acapulco de Juarez and 600 miles west of Galapagos Island. (At about 0 degrees latitude and 100 degrees W longitude).

The vessel's destination is on the Pacific Ocean side of Baja California Sur, in a westerly direction from a site identified as La Paz, Mexico. See ENCLOSURE 3.


