

The ship is equipped with many electronic systems: antennas, detectors etc... Thus it is far more capable and sophisticated than its outward appearance indicates.

The ship is carrying a powdery, bitter-tasting white drug, which appears to be cocaine/crack. The contraband is concealed in a mat-like container, (long and wide but thin) which is plastic or rubber lined and flexible. The outside is black/dark gray in color and is either rough, worn plastic or canvas. The mat is thin and wide and stored so that its position is curved. The mat looks "like" a gym mat or a concrete warming sheet. It is baggy and ruffled in appearance, not smooth. This mat normally has an acceptable use and is expected to be on this ship.



The mat is located low down in the ship.

The ship is currently (8812150910) at sea moving in a NNE direction somewhere not too far from a coastline.

After it left Nicaragua, the ship stopped in Jamaica, in the vicinity of Montego Bay.

The ship will unload in Pensacola, FL.


