ESSENTIAL ELEMENTS OF INFORMATION REQUESTED IN ORDER OF PRIORITY

1. Determine if the vessel is carrying contraband.

RESPONSE: VESSEL IS CARRYING CONTRABAND. IT IS ^{SEMISUBMERGENT} WHITE, HARD SOLID COCAINE.

2. Determine current location of vessel.

RESPONSE: VESSEL IS CURRENTLY LOCATED EAST OF TRINIDAD/TOBAGO (11° 7' N 56° 40' W). VESSEL WILL FOLLOW A NORTHWESTERN ROUTE WHICH WILL TAKE IT BETWEEN GRENADA + BARBADOS + THEN BETWEEN THE GRENADINES + ST LUCIA TOWARD THE SOUTHERN SIDE OF PUERTO RICO.

3. Where is contraband located aboard the vessel?

RESPONSE: CONTRABAND LOCATED BELOW DECK ABOVE WATERLINE MIDWAY BETWEEN THE CENTER + THE PORT SIDE, 1/4 OF THE LENGTH OF THE VESSEL FORWARD OF THE STERN OF THE VESSEL (C 7 + 8 ON SCHEMATIC)

4. Where will the off-loading/transfer of the narcotics take place?

RESPONSE: AN UNLOADING PT WAS NOT DETERMINABLE. VESSEL WILL STOP SOUTH OF PUERTO RICO IN THE VICINITY OF 17° 5' 30" N 67° 12' W
