- Where will the off-loading/transfer of the narcotics take place?

SUMMARY OF INFORMATION


The vessel is carrying drugs in liquid form (highly flammable) mescaline and peyote. The drugs are located aboard the vessel near the food/kitchen area at the bottom of a steep stairwell. They are packaged in white paper boxes and tied with string. The current location of the drugs is near Ivory Coast around Tabow at 4°N - 7°W. The off-loading location is in the United States on the coast of South Carolina at 33°N - 79°W above Charleston.
