SUMMARY OF INFORMATION

An airdrop will take place on 24 May 1990 between 0130-0430L hours at 23 40'N 73 12' W [REDACTED] Airdrop activities will not take place on either 23 May 1990 nor 25 May 1990.

SG1A The vessel [REDACTED] will be involved in the airdrop. Its role is to be at the above location to pick up the contraband. The plane will use a visual cue of the vessel to initiate the drop.

The 45 foot cigarette boat is involved in the activity, in some aspect other than pick up or transfer of the contraband.

SG1A [REDACTED] will be used to stash the narcotics. The contraband will be stashed on the eastern tip of the island.

Plastic buoys are somehow involved in the way the narcotics are wrapped/stored.

There is a strong feeling that the operation can be halted/diverted at a moment's notice, i.e., at the first sight of anything suspicious. An alternate landing/refueling area (not unloading spot) is a private strip in the vicinity of the Dominican Republic.




