Though one of the crew members seems to have his own "recreational" quantities of some illegal substance, the vessel itself does not give the impression of transporting illegal narcotics at the present time, nor will it within the scope of this operation on-load any. It is presently (260930 Apr 90) located at approximately 18 deg 20 min N/75 deg 05 min W., vic Navassa Island, off the west coast of Haiti.


