SUMMARY OF INFORMATION

SG1A

The  is currently (26 1130L APR 90) south of the Dominican Republic at 15 30'N 70 42'W heading 49 degrees (approx NE) toward Puerto Rico. It is carrying drugs which are in dark, rectangular, well padded bundles (value over a million dollars). These are stored underneath a large, horizontal metal plate (rivets visible) with a hidden hinge. This panel lifts upward and is located in the bow, on the port-side, well below the waterline. The bundles are leaning against the hull, which at this location is at a 30-50 degree angle to the floor/deck. The contraband will not be offloaded because the vessel will be intercepted before it crosses the 17-17 30' latitude line.

One call sign associated with the vessels sounds phonetically like "Marguerite/Margo/Marco." Another is either M1A CØ or M1A CO (Mike One Alpha Charley Zero or Mike One Alpha Charley Oscar).
