1. (S/STD/NF) On 12 April 1990, two remote viewers (# 018 and 032) conducted a total of two SOLO sessions in an effort to answer requirements against the suspected narcotics smuggling vessel known as [redacted] Its last known location on 5 APR 90 at 1542 EST, was in an area located along the northern coast of the Dominican Republic. The customer provided the following EEI:

- a. Is the vessel carrying contraband narcotics, if so, where on board is it stored?
- b. Determine the vessel's current location.
- c. Determine the date, time and location where the contraband narcotics will be unloaded/transferred.

2. (S/STD/NF) 018 reported that the vessel is not carrying contraband at this time (12 0840L APR 90). The vessel is currently (same time) located off the coast of Jamaica at 18 53' N 78 13' W.

3. (S/STD/NF) 032 reported that the vessel is not currently (12 1100L APR 90) carrying contraband. The vessel is currently (same time) located off the coast of Jamaica (16 05' N 76 06' W). The vessel is moving toward port. The vessel was carrying contraband two days ago, located in small, easy to handle packages, wrapped in plastic. It was stored in easy to find places on board (in closets, under bunks etc.) The contraband was unloaded 2 days before (9-10 APR) on a small but inhabited island. There were a lot of tourists in and around the port facility of this island. The vessel did not dock, but anchored off shore and transported the contraband to shore in a very small craft during the night. This contraband is not destined for the US. The location of the port is one of the islands in the vicinity of 23 02' N 73 02' W.

4. (S/STD/NF) Located at TAB A is a map showing all the points provided by the viewers. Located at TAB B are all the viewers' session summaries and EEI report sheets.




Repeated searches (0800-0830 hrs 12 APR 90) did not turn up any narcotics, or any other type of contraband.


