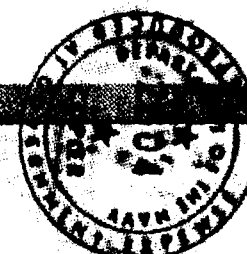

SUMMARY OF INFORMATION.

Contraband was hidden on island behind/under a light colored rock (coral) out crop. Hiding the contraband on the other side is a clump of heavy, thick vegetation some of which was placed there by smugglers (may be dried out/brown by now).

In front of the Rock/outcrop is a sea grape tree. Further to the front (20+yds) is water. The contraband is in a rectangular, dark colored (dark green, dark brown or black) container with ^{slightly} rounded sides. Its dimensions (approx) are 3 ft x 3 ft x 1.5 ft.

On THE NOTIONAL grid contraband is located AT I 8/4. For an aerial view of immediate area see sketch.

The terrain in the immediate area is basically flat, but walking is difficult/bumpy. Area is white, gritty, sharp coral with lots of low scrub vegetation (nothing higher than a sea grape tree). Much of the vegetation is thorny/grabby ("Catch'n keep"). No palm trees.
