This vessel will travel in a northern direction and can be located at geographical coordinates 22 Degrees North and 74 Degrees West within two to three days.

This vessel will unload its contraband in the Gulf of Mexico at Jefferson, Louisiana within 10 to 14 days.

The name "Lola/Lolita" phonetically surfaced in reference to a call sign or a second vessel involved in the drug smuggling.
