1. {S/NOFORN} FOR YOUR INFO, ON 12 JULY CONGRESSMAN ROSE {NC} WAS BRIEFED ON GRILL FLAME BY REPS FROM DIA, USAF ACSI AND THIS OFFICE. THE BRIEFING WAS REQUESTED BY ROSE AND WAS FOR THE PURPOSE OF BECOMING BETTER INFORMED ON WHAT DOD IS DOING AND PLANNING TO DO IN THIS AREA INCLUDING FUNDS BEING SPENT AND PROJECTED. MR. ROSE IS VERY SUPPORTIVE OF THE PROGRAM, EXPRESSED HIS FIRM BELIEF THAT DOD MUST BE ACTIVE IN THIS AREA AND WAS GLAD TO HEAR ARMY IS TRAINING SOME OF ITS OWN PEOPLE SO WE WON'T HAVE TO RELY COMPLETELY ON SOMEONE ELSE. HE WAS VERY EMPHATIC THOUGH THAT DOD MUST KEEP HIM FULLY INFORMED ON WHAT WE ARE DOING AND HOW MUCH MONEY IS BEING SPENT AND PROJECTED.

2. {S/NOFORN} BASED ON INPUT FROM EACH ADDRESSEE THE FOLLOWING DOLLAR FIGURES WERE USED IN THE BRIEFING:

A. AMSAA--220K COMMITTED SINCE SEP 78 IN CONTRACTS WITH SRI FOR TACTICALLY ORIENTED EXPERIMENTS. PROGRAM TO CONTINUE UNTIL APR 80. PROJECTED 200K FOR FY 81.

B. MIRADCOM--PK PROGRAM IN TWO PHASES. FIRST FOR WHICH 118 K CONTRACT HAS BEEN LET WITH SRI FOR DEVELOPMENT OF HARDWARE AND SOFTWARE PACKAGE. INITIAL EXPENDITURE FOR PHASE II EXPECTED TO BE 90K WITH ADDITIONAL FUNDING AVAILABLE IN AMOUNT OF 190K IF NEEDED. PROJECTED 500K FOR FY 81.

C. INSCOM--HAS 75K CONTRACT WITH SRI FOR TNG AND FAMILIARIZATION OF RV CADRE IN FY 79. PROJECTED 150K FOR FY 81. {25K END-OF-YEAR FUNDS WILL BE REQUESTED BETWEEN INSCOM AND ACSI TO SUSTAIN PROJECT THROUGH FY 80}
