EXPLANATION OF ABOVE: C-5

2.- Interrogation of Kenneth H. Glasheen, Petrolman, Imperial, California at 1845 hours, 19 May 1952, at Imperial Police Station.

Q. Where approximately were you when you first observed the object?
A. I was on 9th and E Streets in Imperial at 0350 AM 13 May 52. Our reason for being in the area was to deliver a message. I saw an odd glare shining down. There are high trees in the area and my partner, Sweeney, noticed them first. There were three in number and they were breasting North from this location of observation, and were joined by two more and they all began to orbit.

Q. What was their size, shape and colour?
A. I couldn't identify them, except for the light which was underneath the object shining down, a white light, five in total.

Q. Any noise?
A. No.

Q. Did you notice any particular behavior?
A. Some of them were circling and changing over positions. After a while three of them disappeared, vanished. Their speed was very fast.

Q. Like a jet?
A. Faster.

Q. Any exhaust-like flame?
A. No.

Q. About how high were the objects?
A. (no comment, unable to estimate)
