They presented a number of such cases, whereby, after enduring a NDE { Near Death Experience } that person became open to Contact from the Extra terrestrial, Spiritual and Inter Dimensional realm. As Disclosure draws near, more and more people are returning to Ufology, it's as if they sense something major is about to happen. With this in mind, I would like to draw your attention to a letter which was sent to me in April last year. I read it and filed it, but now I have become aware that more people are reading it as it circles the internet.

The main assertion in the letter is that human civilization is now in an uncontrollable free-fall implosion which cannot be "fixed" from within existing social systems. The implosion is causing, will cause a major rupture in all human orders. 

We decided to set up the other side of the mountain and get an overall view looking towards The Oaks and beyond. After taking some video & still photo's it wasn't long before the rest of the group and members arrived. Darren Brodie had his camera set up on a tripod and was just randomly taking snap shots of the sky and horizon. This proved to be a valuable premonition, as the next morning he discovered a couple of anomalies on two of the photographs.

As per usual though, nothing was seen with the naked eye. This is why it is imperative to be taking random shots with still and video camera's towards the sky. Sometimes you think that the night was 'very quiet', but beyond what the eye can see can sometimes give you a nice surprise when reviewing your footage/shots.

We also viewed a couple of falling stars/meteorites which one seemed to put on a bright 'light show' and change colours. Quite spectacular !

He told me, in broken English that he was not long in Australia and was newly settling in this Country. I felt empathy for the guy and to cut a long story short, I got the guy a few jobs! Precognition – Visions of the future

Precognition is a human ability as old as time. Texts from all over the ancient civilisations contain descriptions of dreams and prophecies, which were taken seriously and acted upon. Today it is an area that is still surrounded by scepticism and misunderstanding, yet I believe that this ability to see or sense the future, may in fact be an innate human faculty which could be cultivated even if we do not yet understand fully how it works. It may be far more widespread than modern Western society seems to be able to accept.

Precognition, which literally means foreknowledge, can take many forms, from the most subtle feeling of *déjà vu* right through to a powerful vision of some event many years hence. It can come in dreams or while we are awake; it can happen unexpectedly or as a result of concentrated meditation. It may manifest simply as a vague feeling of knowing what is going to happen next; most people have experienced thinking of a friend just before that friend telephones. Or it can take form of a premonition (forewarning), for example a feeling that it would not be a good idea to travel on a particular day. What classifies these experiences as precognition is that the event foreseen actually occurs.

If precognition is a natural gift, what is its purpose? Nature usually endows us with abilities that are of some use to our survival, as individuals or as a group. If some special skill improves the chances of survival, in humans or animals, it tends to be passed on to future generations. In a group of animals only a small number is needed to raise the alarm when they sense a forthcoming danger, and the whole group is alerted into action.

Perhaps every species has developed some precognitive ability, which in the human race may be enhanced in a small percentage of individuals, or may reside in a less accessible part of the brain so that only a few are constantly aware of it.

What cannot be denied is that it does exist, and should therefore be regarded in the same way as any other skill – as a natural faculty. And its purpose, at least in part, could be to warn us of impending danger or disaster.

A good example is given by Richard Lazarus in *Beyond the Impossible*. An American parapsychologist, Professor William Cox, believes that many people act on premonitions in everyday life although they are quite unaware of it. Over a six year period, he took statistical details of the numbers of passengers who usually travelled by rail; he found that, on days when accidents occurred, far fewer passengers than usual were on board the trains involved. Using a computer, he calculated that the statistical odds against there being fewer passengers on those days by chance, were over a million to one. In other words, a proportion of potential travellers had some unconscious knowledge of the future and acted on it, without consciously realising they were doing so.

Many premonitions and clairvoyant visions involve warnings of floods and other natural disasters. One of these such predictions was noted by *Jenny Cockell* who is the author of *Yesterdays Children*. Not only has Jenny traced back her previous life as Mary, an Irish woman who died in the early 1930's but she has had many premonitory dreams which have in fact come true.

In the Autumn of 1989, a woman's magazine asked readers for accounts of their experiences of precognition. Assuming that their interest was serious, Jenny wrote to the magazine suggesting that it might be of greater value if people were to write in with their premonitions before the events foreseen occurred, so that the premonition could be put to the test.

Having recently had a premonitory dream, Jenny felt she had a useful contribution to make.

She told them in a letter to be published that she had seen the River Severn breaking its banks and causing major and life-threatening floods, the worst in that area for many years, and that this would happen in about four months time. Sure enough, four months later in the February of 1990, there was indeed terrible flooding when the River Severn broke its banks; numbers of people were cut off and had to be rescued. There had been little warning and the floodwater covered large areas, threatening towns and farmland alike.

Encouraged by the family and friends who she shared this premonition too, Jenny wrote again to the magazine asking if they still had filed the original letter as requested. She never had a reply. Annoyed at the lost opportunity for proper documentation, she then wrote a brief letter to the *Mail on Sunday* about the incident; at least they thought it was worth printing.

Can everyone see the future? I believe they can. The people who make use of psychic ability within their lives are usually born with a natural psychic gif which they develop over time through trial and error. Many more people could access that unexercised part of their mind, or spirit. There is nothing magic or mystical about *psi*, nor is it anything to do with religious belief. It can be an ordinary part of life and a natural means of communication and understanding. As with all human abilities, some people will be good at it and find it easy, while others will have to work at it, and a few might find it difficult.

There is a lot still to be discovered about the links between the mind, our overall awareness and the brain, which the mind uses as a living machine to process information.

Precognitive abilities all seem to be more apparent in a number of people who have been through a near-death experience. It is known that the more you use a particular nerve pathway, the better it functions. It is possible that NDEs stimulate the brain into developing hitherto unused nerve pathways, enabling psychic experiences to happen more easily.



Flood warning

IN the autumn, when a woman's magazine was taking a look at premonition, I wrote to say that I'd had a dream about the River Severn breaking its banks and threatening lives through flooding. I forecast that this would happen in about four months' time.

Perhaps it would have been more useful if I had written to the river authorities.

SIGHTING REPORTS

STRANGE OBJECT OVER LOUISIANA.

I am a photographer, and on March 19th I was outside taking pictures of the moon during its lunar perigee. My grandparents were also outside with me, playing with my daughter on her swing set. While aiming my shot of the moon I noticed what I thought was some debris on my lens, so I cleaned it and prepared to try the shot again. I observed at this point that I could make out the object only through the camera lens, and that it was not obvious to the naked eye. At that point I realized that I was not seeing a spec on my lens but rather something in the sky. I tried to use my auto focus to capture the object, but it kept focusing on the moon. I turned off the auto focus and manually targeted the object: this is the picture that is attached to this report. I don't know if it is important, but my camera is a Canon Rebel T2i with a Sigma 18-250 mm lens; the photograph was taken zoomed all the way in. Once the image was captured, I reviewed it on my camera and called my grandparents over to see what I had photographed. None of us had ever

seen an airplane like this before. My grandparents and I both looked up but none of us could see the object. I set my camera to "live mode" (allowing us to see the viewfinder's image on the screen on the back of the camera), positioned it, and we all saw the object. I'm not sure if we couldn't see the object with the naked eye because of its size in the sky or something else, but whatever the case we could only see it through the camera. While I never actually saw the object moving, it was in slightly different positions to the moon every time I looked at it. We talked about it for a couple of minutes and I tried to get another picture of the object (I couldn't find it this time) and we decided to come upload the images to the computer to look at them a little closer.

OBJECT OVER LOUISIANA



Narwee (Sydney), NSW
18-12-1976 21:00

It was approximately 9pm on Saturday 18 December 1976 - I was aged 11. I was in the backyard of my parents' home in Narwee (Sydney suburb). I was in the backyard because it was a very warm night and I had received an early Christmas present, a trampoline, and my parents were only metres away just inside the back door talking to visiting neighbours. I was jumping on the trampoline facing the south-eastern sky when a large, bright red, round, glowing, pulsating "light" appeared in the sky and started moving left to right at the approximate speed of a plane, but it was about the size of the moon when it is very large. It was along the approximate flight path for planes coming IN to Sydney Airport, which means the planes only fly right to left along that flight path, not left to right (I am getting chills again just thinking about it). I ran inside very quickly, but the only other person in my household! who had seen it was my brother, but it was through a closed bathroom window which was made of corrugated/opaque glass, and he had dismissed it.

My Mum Talks to Aliens

Aired by SBS Australian TV shown originally on 30th November 2010.
23rd Dec 2010 and March 7th 2011

Mary Rodwell comments :

Due to the huge response from the public and media, My Mum Talks to Aliens. I have been continually asked what I thought about the show. The filming was over 9-10 days in 2010, we went to a number of locations in Australia, it included a trip to Adelaide, Sydney, the National Archives in Canberra to view UFO government files and also a trip to Wycliffe Well in the Northern territory. After the filming, I had no further input. I only saw the final production a few days prior to the show being aired by SBS Australia.

My comments below, contained my thoughts on the finalized documentary, and contained comments brought up by the public, the media or by participants of the documentary.

My first issue is regarding the documentary title , “My Mum Talks to Aliens” A journalist commented in interview, “ you don’t really talk to aliens at all, do you?” Which of course is correct, I help people with encounters, how that can be translated into I communicate with extraterrestrials is beyond my comprehension!!! And seems to be more of a production strategy to make me look strange, or flaky, as if my line of work was not enough! I had questioned the ‘title ‘ some months before and I had been told by the production team, it was a ‘working title, “ not the final one. To my dismay this proved untrue, it was retained. My primary issue at that time, as now, is despite being untrue, it immediately puts me at a disadvantage in terms of my credibility. **It does NOT reflect either my research or how I support individuals with encounters.** I can only assume this title was used to incite public interest in the program. For me it compromised the integrity of my professional reputation and research.

As regards the UFO/ET content and my research, many of the viewers felt that there could have been more evidence presented of the extraterrestrial presence. It is important to note the primary purpose of the documentary was not an expose on the UFO /encounter phenomenon, but to highlight the relationship between my son, in relation to my work with individuals with encounters. It primarily explored the conflicts that arise from my working within a phenomenon that is outside of “accepted’ consensus reality. This issue, is one that many of my clients experience when having encounters, and feel they are unable to share their experiences with close family and friends, because of fears of rejection or disbelief. My son Chris was in the role of open-minded scientist /skeptic who wanted to see for himself what it was that convinced me, that people with encounters were having a genuine and real human experience.

The main aspects of the documentary that caused the most comments from the public were :

- The debate in Canberra
- The failure of Greg to pass the polygraph
- The lack of whistleblower testimony which shows the ‘cover up’ by governments to this phenomenon.

My comments as to the above are:

The debate in Canberra

The debate organized by the production company was ‘supposed ‘ to emulate a debate similar to one I participated in, at Oxford University in the UK, in 2006.

Both debates had similar themes, but the differences between the two were significant, and contributed to the final outcome.

*In Canberra, the topic was treated amusement and derision by the opposing speakers. However at Oxford University the speakers took the subject seriously.

* In Canberra, I had 8 minutes to present my data. At Oxford University I had 25 minutes.

* In Canberra, the audience contained many students of the speakers in opposition to the motion. The students at Oxford were NOT students of the astrophysicist.

I received many emails that were very upset by the attitude of the academics in the debate.

Emails of support came from those who had experiences, as well as academics themselves who were horrified at this disrespectful behavior shown by their colleagues.

The debate at Canberra, highlighted that some of the academic, scientific community, are still confronted by such enigmas as this phenomenon, and can demonstrate a very limited mindset.

Derision, a good excuse for ignorance.

Every truth passes through three stages before it is recognized.

In the first it is ridiculed,

In the second it is opposed,

In the third it is regarded as self evident

Arthur Schopenhauer.

Note: RE the debate: I made an error when speaking about Hon Paul Hellyer (Ex-defense Minister of Canada). In my statement, I had meant to clarify that it was Paul Hellyer's reading of the book **"The day After Roswell; by Col Corso**, and personally checking the veracity of Corso's statements, convinced Hellyer of the truth concerning the cover-up of the extraterrestrial presence. In that book, Col Corso, held a high level security clearance and his job was to disseminate alien technology from his position in the White House. Technology that we now know of such as fibre optics, the digital computer chip, Teflon etc.

The failure of Greg to pass the polygraph

The failure of 'Greg' to pass the polygraph was not explained in the documentary and was left hanging as to why this occurred with a very reasonable explanation. I had an in-depth discussion with the facilitator of the polygraph, which was not included in the final edit of the documentary. The testing for the veracity of subconscious recall IS NOT within the mandate of a polygraph. Normally testing by polygraph is not for 'subconscious recall' only **conscious** recall. Greg, did have conscious recall of seeing UFO's both as a child and as a seaman in the Navy. But when he was questioned on his hypnotic regression, ie subconscious recall, in hypnosis, he found it hard to be as certain, because he was not fully aware, being in a trance state during the encounter. This is why he failed the polygraph. This did not mean the encounter didn't happen, just that he couldn't be as positive due to how he had recalled the event in trance.

The lack of whistleblower testimony which shows the 'cover up' by governments to this phenomenon.

Finally the lack of significant UFO evidence in the doco was due to the length of the show. I had personally hoped to have whistleblower testimony, which is very compelling. Chris was shown DVD verbal testimony by many credible witnesses including pilots and astronauts, and military personnel but this was not shown.

Finally, statements by the voice over that are incorrect.

* It stated that the scientist who did the DNA testing on the 'Hair of the alien,' re Peter Khoury's Encounter, was a biochemist, this is incorrect. It was in fact a scientist who specialized in genetics. The Scientist was unable to go public, due to his employment. I am told that he may well make himself known in the near future.

The 'voice over' statement that my son may think of me as 'delusional, is incorrect. My son has never implied or believed, I am delusional. In fact I want to thank my son Christopher for sharing this journey with me. He demonstrated a courageous and loving heart and I am extremely proud of him. He was aware that by doing this it would challenge our relationship as it does any family with diverse beliefs or perspectives. But he had enough belief in our love and respect for each other to take that risk. I treasure the respect and love he demonstrated throughout this process, which shows what a very special person he is.

I also want to thank Greg and Peter Khoury for their courage, and honesty, by sharing their extra-ordinary experiences. Both these individuals have already helped so many people by sharing their stories to give them courage to own theirs.

Also Megan Hazelwood for her permission to show her footage, taken in the UK, and which was so compelling and extraordinary, and had a huge impact on those who viewed it.

The huge response from the public, and media was overwhelming. Over 1,000 people tried to access the chat line after the airing of the show. I received over 200 emails and phone calls. This still continues.

The response to the documentary was extremely positive and have made me grateful for this opportunity because it achieved my primary purpose, which was to publicize the phenomenon, and highlight support.

I enjoyed working with the production team who were very considerate, and made the experience one I will treasure.

Again my grateful thanks to all involved. The positive support from the public has been most appreciated, and I hope that this will encourage more of those with encounters to own their experiences.

Second Spirit Lifting Session with StarFeed Young Adults

Time: 1.45pm

Date: Sunday 19th December 2010

Place: Dallas Street, Yanco. NSW. Australia.

Present: Kate, Phoebe, Lauren, Mick, Amanda

Sunday afternoon on 19th December 2010 I received a call from Kate asking me to attend the stated location and assist with understanding and managing paranormal activity. The paranormal activity had been ongoing for a period of time and as I pulled into the driveway Kate told me that the most recent paranormal activity had her bed being moved away from the wall.

I entered the house and could sense the presence of spirit in a general sense but could not discern or identify an individual spirit. I had not even sat down when a computer on the lounge room floor burst on unexpectedly, playing loud music. The laptop was on the floor with the top open and plugged into the electricity supply in the nearest wall. There were no other appliances plugged into the electricity socket, no adaptors or double adaptors.

I was not shocked by the computer turning itself on and my first thought was that there were not only humans and earthbound spirits present but perhaps Intergalactic Visitors.

Kate commented that this was not the first time the computer had turned itself on that day but was one of several such instances. I sat down and spoke to the people present about themselves and what had been happening. I passed around a copy of a report I had written about the first session we had experienced the previous Sunday. As we were either reading or speaking I sensed that Mick was not participating and wondered why.

A few moments later he confirmed that he had felt a very heavy presence and did not feel as though he could speak and join in the conversation.

During our conversations I learned that Lauren and Mick also exhibited characteristics of Intergalactic Visitation. I suggested to them that they were Unawakened Experiencers and that personal research and experience would help them on their journey. I explained that as an Awakened Life Long Experiencer I could recommend the answers to questions and relief at understanding an enormous amount of previously misunderstood experiences in my life. I explained that having a teacher, as it were, was of great benefit as I had not had anyone to talk to or share information with while I was growing up. I felt that had I had a teacher I would have understood my journey with greater depth and placed more relevance to my purpose and journey here on Earth.

I suggested we move to Kates bedroom. The bed had been moved from the wall at a 45 degree angle and at the widest point there was a gap of about fifty centimetres. The bed is queen size, made of wood and would pose a considerable weight for a person to move. The bed had been moved sometime between 5am and 11.30am. Everyone present in the house had slept in the loungeroom and no one had entered Kates bedroom until 11.30am. Kate also checked her landline telephone which is connected and utilised in her room. It had been non operational and emitting an unusual noise. Kate passed it to Phoebe who listened and confirmed the unusual noise.

We all turned our focus to the spirit who was present in Kates bedroom. It was a young male of about 25 years of age who called himself Derek. He told us he was missing his mother. He told us that he had to get our attention because we were taking too long. He had moved the bed. He told us that his death was sudden and due to an accident but did not elaborate and did not want to speak about it.

Everyone focussed on helping Derek move to the light and after a short while a sense of release was felt by everyone present. There was a sense of comfort when his spirit had left.

We all returned to the loungeroom and could still feel the sense of spirit being present throughout the house. We all moved outside via a side door. As I walked along the side of the house I could sense a spirit as I walked past a section of the house. I indicated to the others where the presence commenced and where it faded. I had focussed on my senses and had not looked closely at the house and I was informed by Kate that I was outside a window. Inside the house, correlating to the placement of the window was a room with furniture that had once belonged to a family relative. The furniture belonged to a grandmother of two of the people present.

Mick had left the premises at this stage and only Phoebe, Kate, Lauren and myself were present.

We continued walking outside, across the front lawn to a tree where I sensed a male figure reclining. He was up against the tree and was from the pioneer time, before settlement or establishment of even a village. He had perished from exposure and lack of food. His spirit was sensed as peaceful but fatigued and he explained that he had very simply given up his life, he turned to the light and left quickly.

Kate, Phoebe, Lauren and I returned to the house and discovered that a large leather chair had been turned completely around. I recalled walking past the chair when I first entered the house and it was facing the side window, it was now in the opposite direction which was facing an interior wall. A small table that sat directly in front of the chair had been moved forward as well.

I felt drawn to sit in one of the older style chairs, one that was facing the same way as the large chair that was now facing an interior wall. Kate sat on the other older style chair, adjacent to the

'moved' chair and Lauren and Phoebe sat on a couch situated beneath a large window. After we were all seated Mick returned to the house after having been gone for about half an hour. He confirmed that he had not moved the chair and everyone present watched as he used one hand and then both hands to move the chair back to its original position. Mick remained long enough to confirm some objects in the bathroom appeared to have been moved and then left to attend his employment.

The spirit of Kates Grandmother who was called Lilly-Anne remained and talked for awhile. When I sat down I felt a heaviness in my legs and strange in my chest, it was not a heaviness but a tightness or fatigue type of feeling. Kate stated she felt heaviness in her arms, like she could not lift them. I encouraged her to lift them and she did.

This was to exemplify that spirit attends our presence and we gain a perception of their feelings, usually the feelings preceding the moment of death. I wanted the StarFeed Young Adults to see that spirit would not harm us or make us do anything against our will. This was important to me as a teacher because the three girls had exhibited fear on our return to the house to find the furniture moved. The presence of fear means that proper communication can be violated and allow for misinterpretation and even poltergeist activity. Once fear manifests then so will the fearful activity that accompanies some spirit.

Eventually the spirit of Lilly-Anne turned to the light and was gone. We all felt only a brief sense of peace because we all instantly felt the presence of another spirit. We were all feeling different physical symptoms and I felt that each of us had connected to an individual spirit each. I sensed a communication that explained that the house was situated on what was described as the focus for a spiritual vortex. It was explained that we could continue on with

lifting a spirit, each, as there were plenty waiting for human assistance.

As individuals we encouraged our spirit to move toward the light and return home to their Creator. We all did this silently and with respect. When we all felt comfortable we resumed our personal conversations. We remained seated and spoke for sometime about spirit, Mother Earth and our lives on our planet.
