





# Two daylight discs in photo; two men report CE3 in same area



The photo above was taken by Lyle Vann in the Angeles Forest a few miles from Palmdale, California and not far from Edwards Air Force Base. It was taken on December 3, 1979, in the early morning. Vann was with his friend Kent Davis at the time. He used 400 ASA color film. Vann told CUFORN the UFOs are heading toward an underground base in the mountains. Vann, a former California resident, said he and Davis heard machine-like sounds coming from underground in the area, where they were out looking for Big-foot creatures. At 7 p.m. that night, they saw a silver saucer-shaped object land 30 to 40 feet from them.

After it landed, they saw two "men" in khaki jump-suits, with dark hair, approach them. Their uniforms had a patch on the left side of the chest. It was round and

looked like a black planet, with a bolt of yellow and orange lightning running through the planet's equator. There was a sky of red in the background of the patch. The "men" questioned Vann as to his intentions; then they left Vann and Davis paralyzed for ten minutes, with their minds blank. When they regained control, the UFO had left and the "men" had gone.

# Unknown element found in Israel landing case trace analysis

Articles in our January-February and May-June, 1988 issues concerning two physical trace or CE2 reports described large burnt patches of soil discovered on Shikmona Beach at Haifa, Israel.

The beach was covered with thistles and other debris. The reports and burn marks occurred on September 28, 1987 and on May 28, 1988.

CUFORN Associate Investigator Hadassa Arbel of Haifa sent soil samples of both traces to a professor who is a mineral expert residing in the northern part of Israel. CUFORN presents the results of the analysis of the September 28 case here for the first time.

The normal brown soil and the black burnt soil were tested for chemical elements. The black material comes from the area where there were cone-like holes in the soil. We show on this page and

the next two pages tables and graphs of an x-ray spectrum-diffraction analysis of the samples of the September 28, 1987 report's traces in a computerized format.

The elements discovered in the normal or brown soil are shown on this page. The elements are as follows: lead sulphite, ferrous sulphate monohydrate(iron II), calcium metaborate(monohydrate), lead, tin, antimony, sulfide.

Constituents of the normal soil are also shown in a graph form at the top of page seven. There are only twelve known elements identified. The one crossed off seems to be an error. Two readings are questioned by the professor, but we do not know his reasons for this, nor do we know why he circled various readings.

The typeface on the readouts is rather small, so in order to avoid eyestrain, we suggest using a magnifying glass to read the figures.

On this page we see the printout of the analysis of the burnt soil, again in a computerized format.

The elements and/or compounds here are: calcium silicate, an unknown element signified by "y", plumbous arsenate chloride(lead II), and silicon pyrophosphate.

Have we reported a "first" here? Is the unknown element something which has never been seen before on Earth? Is it something which will eventually be named and added to the table of elements? Is this evidence of something which is extraterrestrial in origin? We have many questions, but no answers. We need the help of a reknowned chemist who would report the discovery if he were to contact the Israeli chemistry professor through Hadassa Arbel. We would forward a query to the professor through Arbel if some

one were to contact a scientist here in Canada, or in England or the U.S. Naturally, this would mean a trip to Israel for any scientist interested in announcing the discovery to the scientific world. But, perhaps it is not anything unusual, and this is merely an element which needs more detailed analysis which would show it to be a common element after all.

In this analysis, you will note that there are ten items circled by the professor. Again, we do not know his reason for doing so.

Now, compare two items in the lists for the brown and the black powders. The number of peaks in the file and the maximum intensity are much higher for the black, burnt soil than they are for the brown soil. We need to know the significance of the differences.

The graphs on page 7 represent the same elements in a different format only and by themselves are no different from the rest.




# Research shows non-human tissue in abductee's implant

We reported on the five abductions of Betty Stewart Dagenais of Bond Head, Ontario in our May-June, 1988 issue, mentioning that surgery had been done to remove a possible implant in her left ear, placed there in 1961.

On this page, we reproduce a report on the analysis of the biopsy material taken from Betty. It was given to us by the University of Toronto.

One very important point made in the

summary reproduced here is found in the sentence underlined by your editor. Credit for noting the point is given to our Co-Director, Harry Tokarz.

Although the tissue was not placed in a preserving chemical, it was placed in a plastic, sterilized container immediately after the operation was completed. It was analyzed at the University within two hours of the operation on March 7, 1988.

## REPORT ON ANALYSIS OF BIOPSY MATERIAL. (24/3/1988)

Three specimens excised from the patient were prepared for chemical analysis using conventional embedding and sectioning procedures. The tissue was dehydrated using ethanol and embedded in epoxy resin. Sections were cut using an ultramicrotome. These sections were first examined by light microscopy and all three showed gross structural features similar to normal cartilage. Further structural examination using high resolution electron microscopy strongly suggested that the material was of a biological origin. However, the material showed no distinctive organization typical of human tissue. This lack of structure is almost certainly a result of the fact that the tissue was not chemically fixed immediately after removal from the patient.

Chemical analysis of the samples by X-ray microanalysis revealed only the presence of the elements typical of biological material. The large copper peak seen in the spectral plot comes from the specimen support. In addition, the relative amounts of the elements present are consistent with the explant having a biological origin.

No firm conclusion can be reached regarding the structure of the material largely because of the omission of early chemical fixation.


The graph below points out the various elements found by the University of Toronto's x-ray microanalysis of the purported implant in abductee Betty Stewart Dagenais.

# Two witnesses report daylight disc in Thorold, Ontario

The Niagara Peninsula town of Thorold, Ontario was the setting for a multiple-witness daylight disc sighting of a UFO on Friday, June 17, 1988, in a clear blue sky.

It was 6.12 p.m. when Mr. A.W. and his friend and co-worker Mr.G.F. left work. A.W. gave G.F. a ride home. Mr.W. described what happened: "We drove out of our car park, turning south on Front Street, about 50 yards from the highway stop at St.David's Road. My attention was drawn to an object in the sky in the top left of my windshield. It was moving very fast at about 2,500 miles an hour. As it came toward us, it appeared to be similar to a weather balloon with no tether lines."


"Then, realizing that it was travelling too fast to be a balloon, I stopped the car and drew Mr.F.'s attention to it. Still looking at the object, I drove very slowly forward, crossed St. David's Road and stopped again. We could both still observe the object through the windshield."

"I drove on again and turned into the Fraser Paper Mill car park on our right, stopping in the entrance. At this time, I couldn't see the object as it was directly overhead. But Mr. F. could see it through

the passenger side window. I immediately drove into the car park and we got out of the car. Looking overhead and to the west, we could see nothing. Looking toward our left over the paper mill, we observed the object moving rapidly away from us in a southwesterly direction. In about 10 to 15 seconds, it had disappeared into a cloud formation on the horizon. Having retraced the route and timed it, the whole incident would only cover one minute and twenty seconds. There were other people in and around the area, but no one else seemed to see the object. We then got in the car and drove away. I might add, feeling stunned and amazed. One hour later, I phoned the police. "


Mr. W. is a tire retailer, 49, with some experience in the Canadian Army's Royal Engineers with weapons training. He has fair hearing and good eyesight. He described the object as "silver, smooth and shiny." It changed course during the observation, from northwest to southwest. The sighting was near railroad lines and the Welland Canal. The sun was in the west at the time. The UFO was the size of a basketball held at arm's length. It's edges were sharp. It appeared solid and was silent. It was seen at a 45 degree angle at first. Mr. W. was wearing glasses for distance viewing at the time. Mr.F. has a Grade 8 education, good hearing and good vision. He is age 56.




## TWO CE1'S REPORTED BY AUTOMOTIVE ENGINEER; TWO OBSERVERS IN SECOND REPORT

CUFORN received two reports from one individual in February, 1984 through the efforts of President Joseph Muskat, who was in the home town of the percipient at that time.

45-year-old Paul A. told Muskat about his sighting of June 2, 1983 and filled out a sighting report form. At the same time, he mentioned briefly that he had had another sighting in 1979. Both sightings were in St. Catharines, Ontario in the Niagara Peninsula section of Southern Ontario.

One night in July, 1979, he awakened at 3 a.m. and looked out his window toward the southwest, where he saw a hat-shaped object, colored green. It moved from the west and changed to a southerly direction. In a few seconds, it had disappeared.

His most recent report was of the one shown in the drawing at the top of this page.

The time was 10.45 p.m., The date was June 2, 1983. Duration was 15 seconds. It was a warm night when he saw what may have been one object or three joined together moving at 125 mph. The round lights had fuzzy edges and were silent. He said they were "huge" and it moved in a straight flight path. It was a clear night.

"I felt the urge to go outside after the sighting, but I didn't as I was too upset to do so. The sighting itself occurred in his back yard. He first saw a star pattern move. "I signalled with my lighter. Then I called my girl friend to bring a flashlight. We signalled to them. It was a large object," he said. The automotive engineer said he told his friends about the sighting. He said he saw a dark band joining the three lights.

# American government's UFO cover-up exposé on TV Oct. 14

Mark this one on your calendar!

On Friday, October 14, 1988, a television special documentary will expose the U.S. government's cover-up of the truth about UFOs. This will be a "live" show to be seen on Global TV in Ontario. Global is a network which covers the entire province so about 5,000,000 people could see it here.

The show will run two hours, from 8 to 10 p.m., Eastern Daylight Saving Time. The TV show entitled, "The UFO Cover-up: What is the Government Hiding?", will be aired in the United States on LBS, the Lexington Broadcasting System. The show is produced by Michael Seligman and his company, Michael Seligman Productions. He is well-known in the American television industry and has a fine reputation to uphold. LBS is a Washington, D.C.-based network and is not a major network, so it is likely that its production will be seen on independent stations as well as network stations in major U.S. markets. One tentative sponsor is General Motors Corporation, according to Tracy Torme.

Torme told CUFORN's Larry Fenwick and Harry Tokarz in a telephone interview that he has a small role to play in it, in that he has "pointed out some of the things that they might want to focus on."

He said that there will be "some art work done by Syd Meade, a well-known illustrator." Included in it is Jaime Shandera's speech made at the MUFON UFO Symposium held in June, 1988 at the University of Nebraska in Lincoln, Nebraska. "There will be some people on camera from the old Project Blue Book, some well-established ufologists such as Budd Hopkins, and people such as Lonnie Zamora who were involved in major UFO events," Torme said. "There will be a few individuals from the military intelligence community."

Torme pointed out that the documentary "will center on the MJ-12 documents." He also stated that U.S. coverage will involve "150 to 190 television stations. This means that 95 percent of the U.S. market will be covered."

He was asked what impact it would have on the general public. "As a whole, I think it will be a good show. As to whether it will mean that a lot of people will have their minds changed, it's difficult to say. It will be run twice within a week." Torme went on to say that "this show will have more stuff on the MJ-12 documents than has ever been on before."

Torme, who spoke to CUFORN from his home in Century City, California, was skeptical about the impact of the documentary on the skeptics. "I doubt that it will change the minds of the skeptics," he said.

Since the MJ-12 document most people have heard about is the Briefing Paper prepared for President-elect Eisenhower and it referred to the UFO crash-retrievals at Roswell, New Mexico and El Indio, Texas, it is expected that a large portion of the production will deal with the information given in the document and with the book by William L. (Bill) Moore and Charles Berlitz, The Roswell Incident.



Will this show change the minds of those in the U.S. military who want the cover-up continued? We will see.



# Startling statements on "UFO Cover-up? Live!" TV show drew large viewer response; thousands report close encounters on TV network's special telephone lines

A series of startling revelations about UFOs was the highlight of "UFO Cover-up? Live!", a live television show on the Lexington Broadcasting System network in the United States. The October 14, 1988 show from 8 to 10 p.m., Eastern Standard Time, ran in Canada on the Global Television Network which is only seen in Ontario.

Two men, code-named "Falcon" and "Condor", disclosed information classified above top secret concerning UFOs. They appeared on camera with their outlines blurred by computer pixels and their voices altered electronically to disguise their true identities and thus avoid repercussions from their employer, the United States Government.

## **Americans flew UFO in 1980**

After Betty Cash and Vickie Landrum were interviewed about their famous CE2 in Texas, "Falcon" stated that "the craft that was observed was an alien craft piloted by military aircraft pilots. Although they had been trained and were somewhat familiar with the craft," he said, "they found that the aircraft did not respond to certain controls. They radioed that they thought the craft was going to crash. Standard procedures for the military in a situation where an aircraft is going to crash: the military would send up search and rescue helicopters. The helicopters were following the craft. The craft experienced severe problems. It was thought the craft was going to crash. However, the craft did not crash."

## **Moore, Shandera interviewed**

Half-way through the TV show, Jaime Shandera and William L. (Bill) Moore, were interviewed by the show's host, Mike Farrell, an announcer-actor. Moore described his contact by phone with "Falcon" in 1982. Moore said "Falcon" was a government intelligence agent "who wanted to disseminate information about UFOs to the public."

Farrell heard from Moore and Shandera about the Majestic 12 documents while the audience saw the documents briefly on camera. Farrell suggested that

the viewers listen to "Falcon's" explanation of Majestic 12. Then the camera moved in on a wall TV monitor where "Falcon" appeared with his visual and voice disguise. In the background, you could see an automobile driving past the building where "Falcon" was being televised.

"Falcon" said "MJ-12 functions as a policy-making group relating to extraterrestrial activities and contacts and UFO activities within the United States. They make the policy, obtain Presidential approval and then field activities implement the policies."

## **puzzles and riddles**

Shandera, who is a television producer based in Los Angeles, said he got the MJ-12 documents in the mail. After that occurred, he said, he got a series of Ethiopian postcards mailed from New Zealand which contained puzzles and riddles. Moore was by that time working with Shandera. He gave an example of one clue they found on a postcard. An advertisement read "For a stylish look, shop Suitland." That led them to the National Repository in Suitland, Maryland. There they found top secret documents and filed a Freedom of Information request which led them to the Cutler-Twining document.

After saying that all of their meetings with "Falcon" were secret, Shandera stated "We always looked for a hoax, but within every clue there was always some verifiable fact." Moore added that he and Shandera have on-going contacts with "Falcon" and nine other government agents.

Shandera said he and Moore were able to meet with their contacts and to verify their credentials. He did not say how this was done. Nor did Farrell ask them how they did it. Shandera pointed out that their contacts were in secret "Need to Know" positions. He said that "Falcon's" job gave him access to the MJ-12 infrastructure.

### ***MJ-12's origins, members***

"Falcon" stated his position thus: "MJ-12 is a group of people in the government. MJ-12 was created by President Truman in the early 1950's and their job was to investigate and keep track of information pertaining to UFOs. Part of their job was scientific advancements. But their primary purpose was to keep track of the information coming in on UFOs, evaluating information, depending on what it was, both scientifically and in a way that would advance our technology."

"There are government officials and elected officials that are briefed on the existence and view of MJ-12 activities. These officials include the President and the Vice-President as elected officials, the Director of Central Intelligence and the Director of the National Security Agency. The MJ-12 policy is headquartered at the Naval Observatory in Washington, D.C.," he added.

### ***U.S. Navy's role vital for MJ-12***

"Falcon" went on to say that "the United States Navy has the primary operational responsibilities of field activities relating to the MJ-12 policies. All information gathered in the field, not necessarily by Navy personnel, is transmitted to the Navy for analysis."

Bill Moore interjected "Other known government agencies feed information to MJ-12 through a Top Secret cover project known to us as Project Aquarius." Jaime Shandera pointed out that "MJ-12 connects to select individuals within the National Security Council, the Joint Chiefs of Staff, the White House Intelligence Unit, the National Security Agency, the Central Intelligence Agency, and the Defense Intelligence Agency. The research is conducted, the data classified and catalogued, all under the umbrella of strictest national security."

"Falcon" continued his statement: "The fact

that I've given my identity to you, showed you my credentials and verified my existence within the government community" proves that he is who he says he is. "You also have some of my colleagues who have verified the same information."

"Falcon" was asked where he found his information about extraterrestrial biological entities or EBEs.

### ***aliens guests of U.S. Govt.***

"This book on- it's called the Bible in the MJ-12 community, contains historically, everything that occurred from the Truman era up through the three aliens being guests of the United States Government, technological data gathered from dead aliens that were found in the desert, autopsy information gathered from dead aliens found in the desert, and information obtained from the extraterrestrials regarding their social structure and their information pertaining to the universe."

He went on to say: "Presently, as of the year 1988, there is one extraterrestrial being. He's a guest of the United States Government and he's remained hidden from public view. The Yellow Book is a book that was exclusively written by the second alien. The book relates to the alien's planet, solar system, suns, the culture and society make-up on the planet, the social structure of the aliens and the aliens life among earthlings."

### ***alien crystal pictures***

"What was most intriguing to me in my experience with the aliens is, I believe, an octagon-shaped crystal which, when held in the alien's hand and observed by a second person, displays pictures. These pictures could be of the alien's home planet or pictures of Earth many thousands of years ago." Falcon said the aliens came from the "Zeta Reticuli star group."

"Condor" took up the narrative from "Falcon" at this point. "From what I

understand, there is an agreement signed between the U.S. Government and the extraterrestrials. Essentially, the agreement says that we will not disclose their existence if you do not interfere in our society and we will allow you to operate in a designated base here in the United States. It's in the state of Nevada in an area called Area 51, or "Dreamland."

Next, "Falcon" gave more information: "The extraterrestrials have complete control of this base, which is located in Nevada. My understanding of it is that three different aliens of the same species have resided in the United States from 1948 or '49 until the present day. The first alien was captured in New Mexico in the desert after its craft crashed. The alien, who was named "EBE" by the government, was kept in captivity for three years. We learned a great deal of information about the aliens race, culture and spacecraft.," "Falcon" said.

"The second alien was part of an exchange program. I don't recall what year that alien visited. The third alien was also part of an exchange program and has been a guest of the United States Government since 1982."

### **autopsy data**

As to their looks, "Falcon" said: "They're about three feet, four inches to three feet, eight inches tall." As the ensuing description went on, computer- or laser-generated three-dimensional green-colored graphics appeared on part of the TV screen. "Their eyes are extremely large, almost insect's in style. Their eyes have a couple of different inner lids. The face was extremely bright-came up to three times as bright as ours. They have just a tube opening where our nose would be. Small mouth. They have no teeth as we know it. They've a hard, gum-like area. Their internal organs are quite simple. They have one organ which does the job of our heart and lungs: "CUFORN members, possibly you will recall this description was given to us by Stanton Friedman at a CUFORN meeting in 1983 at the Park Plaza Hotel in Toronto. "Their digestive system

is really simple. Their skin structure is extremely elastic skin, and hard. Probably hardened from their sun. Their brain is more complex than ours. It has several different lobes than ours. Their eyes- where our eyes are controlled by the back of our head, theirs is controlled by the front."

"Their hearing is quite better than ours, almost better than a dog's. Small areas: their sexual organs. They have males and females. Their kidney and bladder are one organ. They excrete waste. They have another organ which I don't know if our scientists know what it is for, but we believe it's to transfer the solid wastes. They have hands without thumbs. They've four fingers without any thumbs. Their feet are web-like-small, web-like."

### **'universal religion'**

"Their average life span is approximately 350 to 400 earth years. It's my understanding that the aliens have an IQ of over 200."

He added that "they have a religion, but it's a universal religion. They believe in the Universe as a Supreme Being."

Concerning aesthetical matters, "'Falcon" said "the aliens enjoy music, all types of music, especially ancient Tibetan-style music."

### **strawberry ice cream**

"They do eat vegetables. They like vegetables and their favorite dish or snack is ice cream, especially strawberry."

"Falcon" wrapped up his statements by saying: "I personally feel that the information should be presented to the public. There is only a small portion of the information that we gathered from the extraterrestrials that should be safeguarded or classified."

"Condor" said he'd like to have the U.S. Congress hold hearings on the subject. He, "Falcon", and a third source have agreed to meet with a Senator's staff to discuss all of the information they claim to have about UFOs and aliens, according to Farrell.

Farrell said that the meeting could be followed by a Senate investigation.

### **important omission**

One of the items omitted from the show, according to William Moore, was an interview videotaped with Richard Doty, former special agent with the United States Air Force's Office of Special Investigations. Moore said in a telephone interview with your Editor that the interview with Doty concerned the UFO incident at Kirtland Air Force Base at Albuquerque, New Mexico in 1980.

The Doty segment was three minutes in length, Moore said, and was edited down from its original 20 minutes. He said that Doty had been transferred to the U.S. East coast and was retired from the Air Force. Actually, Doty had been fired or, to put it less forcefully, relieved of his position. Moore said that the interview would have brought out the truth about the KAFB incident. Moore said he hopes to have it for sale as a video in his publications listings which are circulated to ufologists regularly. He did not say when he would make it available nor give any price for the videotape.

Moore expressed his disappointment with the fact that the Doty interview was not on the show itself.

### **phone calls totalled 71,000**

Interspersed in the show was a phone-in feature whereby viewers could call one of a series of special "900" phone numbers which were displayed on camera. People who had what they thought were close encounters

of the first kind could call the network in Washington using one number; other numbers were for CE2's, CE3's and CE4's or abductions. Phone lines were left open until 1 a.m. for calls. There was even one number for those who had never had a close encounter. According to Bill Moore, there were about 71,000 calls **received**, many of them after the 1 a.m. deadline; some of them on the next day.

Here are the percentages as shown on the show just before it ended: CE1-66%; CE2-5%; CE3-3%; CE4-6%; no CE-20%. Taking the CE4 or abduction reports alone, this translates to a potential 4,260 abductions. Since we do not know the total number of people who watched the show, we do not know what percentage of the viewers 71,000 represents and therefore we do not know the same for the number of potential abductions, or for the other categories.

Another poll was taken on the show. It asked how many people were in favour of an investigation of the cover-up, by the United States Congress. The figures given were: 87% in favour; 13% not in favour. We were not told how many of the audience registered their vote by phone.

Getting back to "Falcon", a media man,

Peter Leone, appeared on camera and said: "I met with a government intelligence agent with the code name of "Falcon" in 1983 with Jaime and Bill at the time that I was an executive producer of news for the CBS station in Los Angeles. At the time, we verified as authentic his credentials. And then again in 1987, we met again with "Falcon" and again verified his credentials. I'm satisfied at this time that he is who he says he is."

**Gulf Breeze segment**

The second most lengthy part of the TV documentary dwelt on the controversial Gulf Breeze, Florida case. The chief observer known only as "Mr. Ed" did not appear, as he wants to remain anonymous. The man is a building contractor in the small town near Pensacola, Florida.

Close to 100 local observers from Gulf Breeze were gathered in that town's local TV station and the show's host, Mike Farrell, questioned some of them about their observations and opinions of the incidents. The five and one-half month flap involved some 36 photographs and videotape of acorn-shaped UFOs in the air in that town. There were other photographs taken by people other than Mr. Ed, but attention was paid to his pictures, some of which were shown on on screen.

Budd Hopkins, author of Missing Time and Intruders told the viewing audience: "I believe Gulf Breeze will turn out to be one of the most important UFO cases of all time."

Three different cameras were used to take the pictures, including one stereoscopic or three-dimensional camera lent to Mr. Ed by MUFON's investigative team which is in charge of the investigation. Witnesses include Ed's wife and children, friends, neighbours, city officials and others. Ed himself described one CE in which he found himself enveloped by a blue beam from a UFO which lifted him into the air some six feet and then dropped him. The same blue beam was seen by other witnesses and was seen in one of Ed's photos taken through the windshield

of his automobile. An entire sequence of his videotape of an object was shown.

Other people who appeared on camera were Duane Cook, editor of the Gulf Breeze Sentinel, MUFON's Donald Ware, who is a U.S. Air Force veteran, and Chief of Police Jerry Brown, who was skeptical of the case. It was pointed out that there were a total of 153 observers. Of these, four people have reported CE3's, six reported blue beams of light coming from a UFO, and there were ten reports of missing time, or possible CE4's.

Reporter Mike Curtis of the newspaper in Pensacola was interviewed and made a favorable comment. It was also pointed out that "Ed" has taken two lie detector tests and passed both of them. Observers interviewed on the show included Charlie Summerby and his wife Doris who saw a UFO in November, 1987. A young boy, Jesse Bertram, who was on the show with his mother Alice, said he and some friends had seen a UFO while they were climbing a tree near the local school. Jeff Thompson described his daylight CE1 of November 11, 1987, at 8.10 a.m., where a 400-foot-long object appeared at tree-top elevation. Immediately afterwards, two military jet aircraft were seen to chase the UFO.

Pro and con statements were presented on the photographic evidence. Dr. Robert Nathan of the Jet Propulsion Laboratory in California, attempted to debunk the pictures, although he only had examined five of the photos using computer analysis. He said there could have been several methods used to fake the pictures: overlays, or double exposures. This is, according to MUFON, highly unlikely, as it is very difficult to do so with a Polaroid camera, which was what Ed used for the majority of his photos. He pointed to the bottom of each object's image in the pictures, saying that the bottom edges are too sharp compared to the top, meaning it could be a cut-off from a separate photo which has been superimposed over the background. It could be a cut-and-paste job, he said.

Dr. Bruce Maccabee, famed ufologist and U.S. Navy optical physicist, defended the photographs. He said he had analyzed all of the pictures and the videotape and found no evidence of a hoax.

One of the most unique parts of the TV show was a direct live link-up to Moscow with comments by Soviet scientists and one man-in-the street interview.

### **Soviet participation**

This was the first look at UFOs ever televised from the Soviet Union, obviously part of Gorbachev's Glasnost policy. It was previewed at the start of the show by an on-the-street interview with a young man speaking English and telling of his personal report of a UFO sighting.

The Soviet participation in the show was divided into two separate segments. First, Tass reporter Sergei Bulantsov expressed his view that the show so far had been "exciting". He went on to tell of the 1984 sighting by pilots and passengers of a Tupelov airliner flying from Tsibili to Tallin, Estonia. One of many excellent pieces of art work showed the audience what was observed.

Other reports illustrated were the 1981 Yugoslavian CE3 by two observers of a landed UFO in a park where seven-foot-tall creatures emerged from the craft, which opened up like a blooming flower; a June, 1975 CE4 at Gurosovert in which one of two Soviet army officers reported one hour of "missing time" and subsequent recurring dreams; and finally, the viewers were shown a series of photographs taken in countries such as Bulgaria where a Polaroid picture was taken of a UFO in July, 1978.

The appearance of Leonov Nikishin, Science Secretary of the Working Group Extraterrestrial Intelligence, of the U.S.S.R. Academy of Sciences, was marred by the obvious unfamiliarity of Farrell with the delay in satellite transmission which had him and Nikishin waiting until their words were heard in each country. Often, Farrell and Nikishin talked over each other out of frustration and words were missed. Nikishin ended his portion of the show by saying that "we may meet extraterrestrials soon, perhaps sooner than we think." Does he know something we don't know?

Bulantsov talked about a new bit of information about the famous Tunguska explosion of 1908. The Soviets have

discovered that there were two explosions at two different times on the day of the event. Two objects exploded, he said, one at 8 a.m., and a second one in the afternoon. He suggested that there should be a joint U.S.-U.S.S.R. expedition to Tunguska to probe the evidence there.

Nikishin, who is a scientist, technician and journalist, remarked that in 1984, a plea for UFO reports which the Soviet government placed in two Soviet newspapers, received 20,000 reports.

### **the Holloman film**

In another segment of "UFO Cover-up? Live!", an American Air Force film of three UFOs appearing at Holloman Air Force Base in 1970 was described. Robert Emenegger, author of the book, UFOs, Past, Present and Future, was a guest, along with Paul Shortell, former Security Manager and Chief of Requirements for the Audio-visual Program at Norton Air Force Base.

Emenegger had gone to Norton AFB to get film footage for a television special publicizing the Air Force. He was working for Gray Advertising at the time in 1973. Shortell showed him a piece of film of three discs, two of which left the area while one landed after exhibiting the oscillating or "falling leaf" motion associated with UFOs in trouble. Emenegger said "one landed on three pods, a ramp came down and out came three aliens, human-sized, with gray skins and pronounced noses, wearing tight-fitting jump suits, thin head-dresses that appeared to be communication devices, and held "translators" in their hands."

"A Holloman Base Commander and other Air Force officers went out to meet them." He was all set to take the film with him when "the Pentagon confiscated the film at the last minute. What I saw and heard was enough to convince me the phenomenon of UFOs is real-very real," he said.

Shortell said he was told it was "theatrical footage the Air Force had purchased to make a training film." Training for what? Shortell said his job was to keep records of any such purchase and he had no record of such a purchase. He said it was "too real" to be theatrical film.

The exchange of humans for humanoids was hinted at in the movie "Close Encounters of the Third Kind", along with the cover-up, and the landing at an airstrip is reminiscent of the climax of the movie. It appears that the movie was part of an attempt to prepare the public for the truth about UFOs, if and when the public is told it by the U.S. government. We do not usually deal in rumours, but one which we have heard is that two of Stephen Spielberg's closest associates work on a contract basis for the National Security Agency. Spielberg is unaware of their connection to NSA. On the humorous side, William L. Moore's favorite snack is ice cream. If he prefers strawberry, we may have something of importance here.

There were many other segments in the TV documentary. We have no space left to mention them in this magazine. If anyone who has a videotape cassette recording of the show will

## Letters to the Editor

In a letter to the Editor, member Lloyd L. Arnold, age 82, of Lakewood, Colorado, U.S.A., mentioned his daylight disc sighting of the summer of 1915 in Lansing, Michigan, when he was eight years old. Arnold is now a consulting engineer with his own company.

# CUFORN reports go to on-line users of ParaNet - an association of computer bulletin boards across North America

CUFORN's published UFO reports are being sent to those persons who are members of ParaNet, a computer bulletin board set-up in North America. New member Tom Mickus has arranged to send all reports immediately after he has received the latest Bulletin.

ParaNet is a loose association of computer bulletin boards which "specialize in mature discussion of a variety of paranormal phenomena," according to Mickus. He said in a March 31, 1988 letter to CUFORN, that he is "interested in the Canadian UFO scene, and its evolution over the years."

"Recently, I have set up here in Toronto, the Crucible Bulletin Board System, which is a member of ParaNet. Currently, we number close to 20 BBS. One of the primary areas of discussion (on the systems) is in the field of UFOlogy. Thus we are often on the cutting edge of recent sightings and UFO flaps occurring across North America," he said.

"As of this date, we are still involved in analyzing the recent Gulf Breeze, Florida incidents along with some sightings in Texarkana and Seattle."

Mickus said it is his intention to be a "clearing house for Canadian UFO developments for ParaNet," he stated. CUFORN has agreed to allow him to reprint in whole or in part the CUFORN Bulletin, which is now available to On-line users across North America.

He said that "the Crucible is a non-profit operation, and indeed, we do not solicit funds even for operating costs. Our only purpose is to promote intelligent and mature discussion on subjects such as UFOs, in the hopes of making the public more aware and informed."

CUFORN urges all members to contribute their own expertise in various areas of ufology to the Bulletin, by sending short articles to the Bulletin. This is especially applicable to those of us with a scientific background. We need your input. Aside from that, we are sure you'd like to see your name in the Bulletin as the author of an article. Your contribution to the field of ufology is just as important as anyone else's, even though you may not be considered as a famous ufologist. Who knows where your article may lead? Even an opinion piece or editorial is welcome. Write to us.

While we are on the subject of ParaNet, there is one rather famous name in ufology who is a member of that association. He's John Lear, Jr., son of John Lear, founder of Learjet Corporation.

## MJ-12 has British equivalent

British member Mark James has been corresponding with your Editor for some time now. He is a Field Investigator for MUFON in England and lives in the Shropshire area of England.

From his letters and several long distance telephone calls we have received a few tidbits of information about items of interest in the U.K. He says he has a few very good contacts in the British Ministry of Defence. He has also met Gordon Williams, the Base Commander in the famous Rendlesham Forest, Bentwaters AFB-Woodbridge AFB incidents of 1980. He claims Williams followed him on a local bus after he spoke with him. He said Williams admitted there was a cover-up on the case and on UFOs in general.

James says he knows of the British equivalent of MJ-12. It is called Operation Apotheosis. It was started ten years ago, with only eight members on the panel. A British Air Commodore told James "the government is getting very worried about the future. A six-page document was sent to the Chief of Staff, which caused quite a stink. # FOUR "PALE BLUE" NL'S GYRATE OVER TORONTO

On Thursday, November 17, 1988, I received a call at 10.10 p.m. from a couple in Toronto who live near the intersection of Weston Road and Eglinton Avenue West. This is in the west-central part of the city, in a heavily populated residential-commercial area.

The couple, whose first names are Michael and Lorraine, told me that they were very skeptical, but wanted an answer as to what they had seen. They had first phoned the police. Then they called Downsview Air Force Base who gave them my phone number and they called me.

Michael was first attracted to the window by a blue streak of light. He then called his fiancée. They proceeded to watch the object(s) shown in the accompanying drawing from 9.45 p.m. to 10 p.m.


Above the apartment where they live, they observed four large circles of "light pale blue" (the size of a thumbnail at arm's length) coming together to form one large circle. Next, the smaller circles slowly fanned out in opposing directions. At this time, they appeared to be 1/4 mile apart and approximately 1/2 mile high. They then turned a quarter turn and came back together. Again, they fanned out. The same inward and outward motions were repeated again and again for the entire 15 minutes of their observation.

Both Michael and Lorraine were so excited, they left the opened window and missed the departure of these objects.

There was no noise noted, nor any EM effects, according to the couple.

We hope further information will be received from them. They said they would send a more detailed account to CUFORN.

Michael and Lorraine refused to give their last names, nor their phone numbers and addresses.
