

Houston is situated at the juncture of the Morice and Bulkley Rivers, with a population of approximately 2600.

Originally known as Pleasant Valley, Houston was established in the early 1900's as the tie-cutting center for the Grand Trunk Pacific Railway. Its first hotel, a large tent, was pitched in 1913. The 1940's brought the forest industry to Houston, which has flourished ever since. The town was named the 1999 Forestry capital of BC, and today you can see one of the world's largest sawmills under one roof on a free sawmill tour. Two famous fly-fishing rivers, the Bulkley and Morice, meet at Houston. Their legendary steelhead runs provide much of the recreation, along with fishing for spring and coho salmon. As a tribute to the sport, the community built the world's largest fly rod - 18 metres long (60 feet) and weighing 364 kilograms (800 pounds), which can be seen at Steelhead Park.

In winter, cross-country skiing is popular, and the Morice Mountain Nordic Ski Club maintains 25 kilometres of cross-country trails. These trails double as mountain biking, hiking and nature walking trails in the summer. A hike up China Nose Mountain rewards you with panoramic views and opportunities to spot many different plant and wildlife species, including lady slippers, ferns, mountain goats, black bears, bald eagles and more.

Other outdoor recreational activities include golfing on two nine-hole courses, snowmobiling, rock climbing at Owen Hat, camping, hunting, and snowshoeing.







The UFO Challenge

December 1997
By Stanton Friedman

As a nuclear physicist who has had a serious interest in flying saucers since 1958, I have reached four major conclusions:

1. The evidence is overwhelming that Planet Earth is being visited by intelligently controlled extraterrestrial spacecraft. In other words, SOME UFOs are alien spacecraft. Most are not.
2. The subject of flying saucers represents a kind of Cosmic Watergate, meaning that some few people in major governments have known since July, 1947, when two crashed saucers and several alien bodies were recovered in New Mexico, that indeed SOME UFOs are ET. As noted in 1950, it's the most classified U.S. topic.
3. None of the arguments made against conclusions One and Two by a small group of debunkers such as Carl Sagan, my University of Chicago classmate for three years, can stand up to careful scrutiny.
4. The Flying Saucer story is the biggest story of the millennium: visits to Planet Earth by aliens and the U.S. government's cover-up of the best data (the bodies and wreckage) for over fifty years.

Since 1967 I have lectured on the subject "Flying Saucers ARE Real" at more than 600 colleges and over 100 professional groups in all fifty US states, nine Canadian Provinces, twelve cities in England and nine in other countries, with only eleven hecklers. I have also appeared on hundreds of radio and TV shows. Overall, I have probably answered about 35,000 questions about UFOs and secrecy.

It's clear that over 97% of the people have NOT read any of the five major scientific studies I discuss, and are unaware

of the mountains of evidence that support my conclusions. They are also unaware of the scientific data, as opposed to tabloid nonsense. However, it is also clear from the Opinion Polls and from my own experience that indeed most people accept the notion that SOME UFOs are alien spacecraft. The greater the education, the MORE likely an individual is to accept this proposition. In an October 25, 1995, Oxford University Debate on the resolution "Planet Earth is being visited by intelligent extraterrestrial life", the affirmative side, of which I was a part, garnered 60% of Debate Union Member votes on the question. Ninety-two percent of 100,000 people calling during a TV Debate in London on June 27, 1997, said Earth has been visited by aliens!

The problem is NOT that there is not enough evidence to justify my conclusions; but that most people, especially the noisy negativists, are unaware of the real, non-tabloid evidence.

Debunkers seem to employ four major rules:

- A. What the public doesn't know, we certainly won't tell them. The largest official USAF UFO study isn't even mentioned in twelve anti-UFO books, though every one of those books' authors was aware of it.
- B. Don't bother me with the facts, my mind is made up.
- C. If one can't attack the data, attack the people. It is easier
- D. Do one's research by proclamation rather than investigation. It is much easier, and nobody will know the difference anyway.

Many major media people will concede that if indeed aliens are visiting earth, that would be a major story. But because they take great pride in their KNOWLEDGE of major stories, if this were happening they would know about it. But they don't. Therefore, anybody who says visits are real must be a crackpot.

I have noted four major reasons why the big names in science and journalism haven't jumped on the pro-UFO bandwagon:

1. Ignorance of the data. Scratch a debunker and one usually finds somebody who is putting down what he is not up on.
2. Fear of ridicule in sponsoring a thesis (only about ten have been submitted relating to UFOs) if a professor,

or sponsoring a detailed reportorial investigation if an editor. I check all my audiences and find that, while in agreement with polls, 10% have had a sighting but only 5-10% of these witnesses have been willing to report what they saw Biggest reason? Fear of ridicule.

3. Ego. If aliens were visiting Earth, they would call a press conference or ask to talk to the National Academy of Sciences. They haven't, so aliens must not be visiting. Flying saucers finish the job Copernicus started in taking man out of the middle of the universe. Priests fought Copernicus's ideas. Today guys in lab coats, rather than priestly robes, fight alien visitations.

4. Failure to use our knowledge of technology to understand UFO behavior. They say "It is impossible," rather than "I don't know how." Despite the absurd claims of certain ancient academics and fossilized physicists, it is clear on the basis of solid engineering studies that trips to nearby stars are feasible with round trip times shorter than the average person's lifetime — using, for example, staged fission and fusion propulsion systems. I have worked on both. It's clear that technological progress comes from doing things differently in an unpredictable way. The history of science is littered with challenges, leveled by people who know nothing about the job at hand, against traditionally "impossible" claims.

The cult of S.E.T.I. (Silly Effort To Investigate) with its crazy notions that nobody would travel — but that aliens, stuck at the level of radio, are trying to attract our attention — mocks the notion of flying saucers, not by dealing with the evidence, but by proclamations about the ABSENCE of evidence. This ignores science.



I prove at every lecture that the NSA and CIA are withholding UFO data. Having worked under security for fourteen years, visited seventeen document archives, and having become aware of the huge black budgets of the NSA, NRO, CIA, DIA, etc., I know how easy it is to keep secrets. My nineteen years of study about crashed saucers, and thirteen years on the Majestic-12 documents have convinced me these are real. The challenge for us all, as we enter the new millennium, is to recognize that while our future is in space, we are not alone. I truly hope we qualify for admission to the Cosmic Kindergarten.

NORTHERN B.C. HOT SPOT FOR UFO ACTIVITY


A huge number of unidentified flying object sightings have occurred recently in northern B.C. particularly around the area between Prince George and Kitimat. These have taken place during February, March and April of 2002.

I've been kept extremely busy traveling around the countryside taking reports from witnesses and my phone line has been running hot. I've been wishing I had a couple of

assistants up here who could travel to a number of the communities to carry out some of the necessary interviews. I've been inundated with not only telephone calls, but also emails, personal visits from witnesses, snail mail in my letterbox and interviews by newspaper reporters and also radio guest spots.

My latest venture into broadcasting had me on the Jeff Rense Radio Program emanating from the USA and before that it was the CBC Radio Morning Show and Strange Days Indeed program out of Ontario and our local radio made mention of these strange occurrences in their news slot. After the first newspaper article came out I had many other reporters from other towns throughout the north wanting the story as soon as possible.

It all began on the day of February 1st 2002 when three ladies were traveling home from Smithers to Houston on highway 16 when they noticed a huge bright object descending from the cloud cover in the distance until it was over tree top level and started moving closer towards them. It was happening ten minutes traveling time east from Smithers at the town of Telkwa. (A quiet little place situated on the banks of the Bulkley River). They had no idea what it was and became quite

scared. The object passed right over the top of their vehicle which gave the ladies a close look at the underside of it and enabled them to really see how large it was. One of the three witness is still frightened by what they saw and after the incident it took several weeks before she would stay alone.

The RCMP in both towns of Houston and Smithers became extremely interested after I enquired if there had been any reported sightings from other travelers on that night. The Smithers office of the RCMP opened a file and asked me a large number of personal questions which I was most

surprised at. I provided them with answers to their queries and I then asked other colleagues was that normal procedure and they told me they hadn't encountered that type of questioning at all before. My investigations into the sighting led me to an understanding that military exercises had taken place around the same time the sightings were reported or just after. I was flying to Vancouver a few days after the ladies' encounter and was told by the pilot that there would be a slight deviation in our flight plan due to military exercises. I felt this worth checking into due to already haven received other sightings in this same area, around the same time.

This report and others from Burns Lake and Houston caught the medias attention and after an article was written further reports started coming in. People were reading their newspapers and suddenly they were aware of someone or some place where they too, could report what they had seen recently or many years ago. It almost seemed like they were relieved that what they had seen in the skies had probably been seen by others as well. They were obviously encouraged to come forward and report their experiences. Some had even told me that they wouldn't have bothered with it at all because they did not know where such things were reported to.

Where The Reports Came From

After I received the reports from Telkwa and Houston, B.C., the newspapers caught wind of the story and printed the articles. To my surprise peoples' sighting started to pour in from all points along Highway #16 and Highway #37 which is between Prince George through to Kitimat. I wanted to keep track of where the reports were coming from, to see if there may be some kind of pattern forming, due to the number of reports. I put together a map of the relevant areas in northern B.C. and marked the location of the sightings with a "dark black ball".

There are thirteen areas (or towns) where the sightings have come from. The highest number of reports came from around the Terrace area which was no surprise to me as I have received a number of people telling me of strange lights, or objects been seen in and around that area in the past years. But I have never received so many cases in such a short period of time. To date I have been contacted 56 separate times from witnesses reporting what they saw.

Check out the net for the best in UFO information.

Out of the 56 cases, four reports are from the past and were from: (Wilmer - 2 reports, Edgewater - 1 report, and Courtney - 1 report).

The Courtney case started in the 1960s with a large saucer shaped object hovering in a field behind the families home. It also left a large burnt circle in the field. This case continues today with the family reporting the possibility of having been abducted. Medical records reveal strange markings left on the mother's, son's and daughter's body and they have no idea how this happened. I will be investigating and meeting with these folks over the summer.

The total number and locations for the reported sightings since February 1, 2002 are as follows:

Francois Lake - 1 report

Vanderhoof - 4 reports (plus looking into a sighting & crop circle connection)



Dealing With The Reports

Well to be honest, I have one heck of a time trying to keep up with the amount of cases to work on. I took each report which was telephoned, or emailed to me and investigated it as best I could from my location. I asked the normal questions and any other information that may help in identifying

what it was each person saw. I later sat down and wrote up a report on each case, stopping and making notes as more questions popped into my head which I had not asked in the initial interview. I made a great number of phone calls back to witnesses to ask for more information. There are a good number of cases on which I have little information, only because I have made plans to contact each of the witnesses for a face to face interview. These reports I feel need to be followed up with a personal visit and hopefully I will be able to have the people draw a diagram of what they saw.

What I found very helpful was to tape each telephone conversation, (with the person's permission) so as not to miss the smallest detail of the reported sighting. It proved to be a great asset as the reports were coming in faster than I could write them down. Some days it was half a dozen in the same number of hours and the tape recorder provided a quick and accurate way of dealing with the calls.

The Number of Sightings I Thought Were Worthwhile Against The Number I Thought Were Misidentifications.

There were a small amount of reports (totaling 4) in which I believe were explainable. One witness on his way to work in Kitimat watched an object falling at a steep angle trailing blue, red and yellow flames and a smoke plume. Others reported flashing colored objects, colors changing from green, red to blue and moving with the rotation of the earth. As I asked more questions it seemed clear that what these witnesses may have been seeing were nothing more than stars and a meteor. Each of these sightings were seen in a populated area with many people travelling around.

The majority of the reports remain unexplained. They do not fall into the category of stars, meteors or planets which can be seen very clearly. These objects have performed aerial feats which don't conform with a normal aircraft as we know it. A couple of examples would be five points of light being observed, but while watching these white lights the witnesses said they moved in on themselves, and back out as if in a ring, then vanishing completely. Another was of a large bright white light with an orange glow/haze around it. This object was seen by three completely different witnesses in the area of the town of Houston, B.C. on the same night.

In a clear blue sky there was one cigar shaped cloud with many blueish tubular shaped stringers coming out of it. This again was seen by two different parties. So from moon sized objects to boomerang shaped crafts, these remain a mystery.

Closing Statement

I started with three sighting reports and when the media

caught wind of what was taking place in the area they printed articles telling their readers what others were seeing in the skies where they live. From that point on a flood of reports came in to HBCC UFO Research. It shows that folks are seeing objects and lights which they cannot explain. The problem I have found is that witnesses do not know where or who to report to in most of the cases. This shows just how much influence the media has and what an important role it can play in informing the public about relevant information

I am not sure why there has been such an increase in UFO sightings in the early part of 2002. A lot of them have occurred over mineral deposits and around high tension power lines. Is this a possible attraction ??

The north consists of mountains, rivers, streams, lakes and mining areas running throughout and the reports have been from all or any of these areas. There has been no one specific region so its hard to pinpoint a direct connection to the land properties.

I am also working on other cases which have come to my attention which should prove to be quite amazing. I will have details soon. *END.*

Researcher Brian Vike says Terrace is a B.C. hot spot for unusual sightings

It all started at around 9 p.m. on a dark winter's eve in February. Three women from Houston, B.C. were driving home from Smithers after a day of shopping when they noticed something unusual in the sky.

A bright, shining object was visible high in the clouds, above them. They thought it was the moon. Then it did something strange. It moved. Without warning it swept through the cloud bank, dropped down towards the dark forest next to the highway, flew over their vehicle and vanished out of sight.

Enter Brian Vike, an independent field researcher who's been a full-time investigator into strange occurrences across northern B.C. for the past four years. "They're just normal folks," Vike says. "But what they saw scared the heck out of them. One of them didn't even go to work and had to have someone stay with her for about a week".

A mutual friend put them in touch with Vike, a former forest industry worker who lives in Houston, B.C. Vike, 50, is a friendly-sounding guy with a plain way of talking. He likes to interview people face to face. That way he can see if they're telling the truth.


The women, seated around a kitchen table as they told their story, were visibly nervous. On Feb. 1 they'd seen a huge, boomerang-shaped object with seven rectangular lights across the bottom. "These people here are credible. They're not a bunch of hooligans," he says ... They're church-goers who are married with children. And they're definitely not the only "normal" folks" in northern B.C. who've seen a UFO lately.

After the Telkwa sighting, other reports from people along the Highway 16 route began to trickle into Vike's investigative headquarters, HBCC UFO Research. He wondered if the sightings were connected, so he issued a call all along Highway 16, asking anyone who had seen anything unusual in the sky to contact him. He was inundated with reports by phone, email and through the post as Vike's request appeared in newspapers from Prince George to Kitimat. But he wasn't prepared for the sheer number - a whopping 66 unexplained sightings from communities along, and north of, the highway making UFO history.

Terrace, Vike says, is the undisputed hot spot of the region, with 17 sightings from here alone. He received

three sightings from Kitimat, two from Cranberry Junction, eight in Kitwanga, four in Old Hazelton and one in New Hazelton. That's not counting the sightings that have come in from further east. "That's a lot of sightings," Vike says, adding most of the reports came in during February and March.

They share some similarities, but mostly the reports are different. Some UFO's looked like meteors or stars that changed direction all of a sudden. "Meteors don't do that and stars, of course, stay stationary". Another report involved a group of older men who were camping south of Burns Lake when they saw an object they thought was an airplane at first. It stopped in the distance above a field.

"He described it as, "the light was sweeping something,".... then it was gone faster than it even arrived, so what was that?" A group driving into Terrace watched a cube-shaped cloud hover above the peak of a mountain near Usk and then vanish.

Vike, who used to volunteer at the H.R. MacMillan Planetarium in Vancouver, and was also a member of the Royal Astronomical Society, may be a scientist at heart. "What I'm trying to do is look into (the report) and come up with possibilities that might fit.

Venus, also known as the Evening Star, has been responsible for countless UFO reports. The planet has tricked a few people who should know better, including astronauts and pilots. Other UFO's are found to be aircraft, meteors, satellites, stars or even blimps.

Still, most of the north-west sightings remained unexplained - for now. "Is there an attraction to Alcan? There's a big power source there". So far he's ruled out secret military exercises above regional airports, but there's more work to be done. He still has to contact observatories, and aviation agencies like Nav Canada. Data can also be run through astronomy programs to see if a sighting can be correlated with a known object.

"I can tell you right now, a lot of them are not going to have answers." he says. Meanwhile, Vike, the Telkwa Sighting and the Terrace reports are slated to be the focus of an upcoming episode of a new Discovery Channel show. "Our town is excited, he says. "I'm invited to the next council meeting - whenever that is!"

UFO Base In B.C. ?

Hi Brian

Just read your story on the CAUS website. I was born in Vancouver, but have spent much of the last ten years in Arizona. I'm very close friends with some of the most recognized names in UFO investigations, and in fact, lectured on the topic myself in the '90s.

Since you're going to be visiting this lady with regards to her UFO experience, and you obviously are a B.C. resident yourself, I have some information that you may be interested in and might want to pursue further.

I used to train horses in the 100 Mile House area around 1980-81. Some of our clients were wealthy German and Swiss families who seems quite out of place considering the remote location. In 1991, while staying in Paradise Valley,

AZ, I was told by a well-known Bulgarian UFOlogist that B.C. had been home to a secret German encampment where high-tech flying saucers and advanced aerial vehicles had been engineered and tested since the '50s. It was said to be isolated and near a railroad. Putting 2 and 2 together, I asked a friend of my dad's, a Lac La Hache resident since 1955 if he'd heard any stories about odd objects seen in the skies, and a secret encampment of sorts.

To my surprise, he answered right away, with a "YES" to both inquiries. Plenty of sightings and definitely a remote, highly guarded, foreign-inhabited, self-contained village. There are several mines on the property and their supplies and personal are largely brought in by float plane. This fellow used to deliver oil to most ranches and businesses in the Cariboo - so he knew who and what was out there. Nobody I've ever told this to has investigated further, which still leaves me wondering what is going on.


The location is called Eagle, and/or Murphy Lake. Both names show up on the topographical map. It is south and east of the Lac La Hache ... I believe near the Green Lake area. From what I've heard, armed guards will meet you on the roughly-kept logging road and deny entry to outsiders. Sounds tougher than Area 51 to get a glimpse of.

If the opportunity arises, perhaps asking a few questions from locals around Lillooet will get you a bit more information, or some nervous glances. Their reactions will tell you a lot. That area is well known to hunters, as I understand it, and they know to keep away from Eagle lake.

Good luck with your investigations. Nice to meet a fellow CAUS fan. Peter is a great friend of mine and an incredible crusader for UFO information.



Crop Circles



On the evening of September 6, 2001. Brent Miskuski owner of Central Air Corp. was flying home from Vanderhoof airport where he had noticed a formation of crop circles. The site is located approximately three miles east from the threshold of runway 25 at the Vanderhoof airport.

Late afternoon on Friday, September 7, 2001 I had an email from Jennifer Crosby, reporter for Northern Television asking if I had heard of a new formation of crop circles in the Vanderhoof, British Columbia area. I told her no, I had not but if she would give me a little while I would be happy to check into this story to see if there was any truth to it or not.

After a few phone calls, I placed another call to the Prince George Citizen who informed me that indeed there was a report from a Mr. Brent Miskuski owner of Central Air Corp., he had spotted the formation of 6 circles in a field approx: 5 Ks from the airport in a farmer field.

I looked up the number for the small airport in Vanderhoof and made the call, Mr. Brent Miskuski answered the phone and I asked him if he may be able to help me.



He was kind enough to supply me with the location of the circles, and how many there was in this formation. He also sent me 3 pictures that he took from an aircraft while flying over the crop circle formation.

I made arrangements and prepared to leave first thing Saturday morning, September 8, 2001. I arrived early in Vanderhoof at 9:10 AM, on Saturday 8, 2001 and made my first stop at a local variety store to pick up a couple of items, I mentioned to the store clerk if she had heard about the crop circle. She said she did, and went on to tell me about a foul, smoky odor her and her family noticed late the same evening the crop circles appeared. The smell was so bad that she got up and closed the bedroom window hoping to keep the unpleasant odor out where it belonged (outside). She also mentioned to me, she had no knowledge of any crop circle at the time of this foul smell.



(Investigator's Note)..... This lady who complained about the foul odor lives in the same area where the crop circles were discovered.

I continued on and stopped at another farm to ask for directions to the farmer who owns the land where the circles are located. I needed to get permission before entering his land. At this stop I talked with an elderly lady who was out tending her garden, I introduced myself, and went on to explain about the Crop Circles, and I pointed up the road with a short description of the area I wanted to investigate, to find out who was the owner. This pleasant lady told me the same story I just heard from another woman in town, about a foul, smoky type smell in the air the night the Crop Circles appeared. She believes they took note of the foul scent in the air just after Midnight. She also went on to tell me that she was discussing the bad odor with another friend who lives next door to her, this other lady claims she also smelled the same smoky foul smell.

This was from 3 separate witnesses who confirmed that there was a smoky type smell in the air on the early morning the circles appeared. Now if this has anything to do with the circles, I don't know, but it is good to make a note of this.

After talking to the elderly lady I continued up to the home of the farmer who leased the field where the crop circles were found to get permission to investigate. I talked to the man's wife and explained why I was there and if it would be ok to do my field work, she said there would be no problem and gave me permission. I also was holding a copy of the Prince George Citizen which had just come out the morning of September 8, 2001 showing one picture and telling about the circles in their field. She was so surprised to hear this news, she asked me if she could have the newspaper to show her husband when he got home, which I was glad to give her.

Back down the road about 4 miles or so I went to where I came to the field where the crop circles were located. After running around trying to find the location, and getting permission it was 12:00 (midday) when I first entered the field. (the crop circles could not be seen from the road). I followed along the edge of the grain field as not to destroy any of their crop. (approx: 600 feet) then swung into the center of the field to look for any signs of the circles. From this point I was able to look over the field as I was up on a very small elevation in the field, and there was nothing to see other than grain blowing in the wind. I figured I had walked to far, so I cut, heading back toward the truck from where I was now, to where I came upon the first circle.

For my records I have named this one Mickey Mouse (the crop circle) as you will note from the picture. There is the main body (circle) for the head, and two smaller circles almost touching the main body (the head) which reminded me of ears, and of course Mickey Mouse.


Above Right: I have given a description of the formation, the size of the circles and where they were located in the field.

Interesting Information !

Recently, in March 2002 while receiving the large amount of UFO reported sightings. I had a report of a large bright object hovering over the area the night before the Vanderhoof crop circles were discovered.

Two biologist were working on a salmon enhancement project and had to check the fish traps in the wee hours of the morning, while inspecting for fish they observed this large bright glowing object. Investigation is on going.

In all of the crop circles the Grain was not broken, it was like if it was pushed hard to the ground. The bend in each of the stalks were bent a couple inches up the stalk from the ground.

The Grain in Mickey's Head - Circle Number # 1 Was bent clock wise right to the ground until it reached the center where the grain became over lapping. (swirled on top of each other)

The Grain in Mickey's Right Ear - Circle Number # 2 Was bent counter clock wise to the ground until it reached the center where the grain became over lapping. (swirled on top of each other)

The Grain in Mickey's Left Ear - Circle Number # 3 Was bent clock wise right to the ground until it reached the center where the grain became over lapping. (swirled on top of each other)

The Grain In Circle Number # 4 - Was bent counter clock wise to the ground until it reached the center where the grain became over lapping (swirled on top of each other)

The Grain In Circle Number # 5 - Was bent counter clock wise to the ground until it reached the center where the grain became over lapping. (swirled on top of each other)

The Grain In Circle Number # 6 - Was bent clock wise to the ground until it reached the center where the grain became over lapping. (swirled on top of each other) As seen from the aerial photo, there looked as if there may have been one person who walked into the circles prior to my arrival. There was a small path which lead to Circle Number # 1 but no other traces of anyone walking through the grain to Circle Number # 4. But I did not there was some braking in the stalks of the grain from Circle Number # 4 to Circle Number # 5. There was no other disturbance in any of the circles, and no more paths leading into or out of this area where the circles are located. I also took notice of chunks of solid ground which looked as if it had been moved. There certainly wasn't much of this, but if you looked closely you could see where chunks of harder soil had been moved when the Crop Circles were created.

Grain Samples from each of the Crop Circles were taken, and bagged, also soil samples were taken as well from each of the circles. Other sample of each were taken from around the surrounding area for comparison. I also have taken pictures of the whole area, each of the circles and will have these developed Monday, September 10, 2001 and as soon as I pick them up I will scan these in and place them to my website, on this page.

Investigators Note: This may, or may not be of importance, but I think it is worth mentioning with this report. Two weeks prior to this set of Crop Circles an article ran in the Vanderhoof Express Newspaper. The story was about people profiting on these sightings of Crop Circles, which turned

out to be a hoax to collect a few dollars.

2. - This picture also shows how the grain was affected in the center of the circle.





WIRELESS WORLD

In 1905, Nikola Tesla dismantled his large transmitter on Long Island, N.Y. and in doing so also dismantled his dreams. The 20th Century should have been filled with incredible wireless wonders. 
What if we were to discover an organized network of

1) ATLANTIS - The original, main transmitter that powered 12 other colonies around the world. After thousands of years of utopia or Eden, the main transmitter was blown up. An entire continent sank as paradise fell.

2) EGYPT - The Pre-Egyptians rebuilt the Great Pyramid which took over as the main transmitter; Giza now being in the center of all land masses. Later it was also destroyed, rebuilt and once more stripped of power. The Pre-Egyptians became the lesser Egyptians.

3) PERU - Near Lake Titicaca, the Pre-Incas mastered anti-gravity technology. They had advanced knowledge, flew and built massive/stone cities high in the remote Andes Mountains. These survivors also came to a mysterious end and later de-evolved into the Incan culture.

4) ENGLAND - Stonehenge became a broken transceiver that was rebuilt by sophisticated Druid scientists. Smaller, prehistoric circles and mounds were positioned throughout England and northern France. They still surround Stonehenge in a specific pattern.



FROM THE HBCC UFO FILES

Bridge River, Lillooet, British Columbia

Winter of 1966, Time 9:00 PM

In 1966, finding myself alone, except for the family cat, Caboodle, after the family breakup and ultimate divorce, I traveled up the Fraser River Canyon to the small village of Lillooet, two hundred road miles north of Vancouver. My former C.O. from my Army days, (name deleted), lived in a mobile home and worked with (name deleted) on her Bridge River-Lillooet News. I joined them, and having spent a month living over The News Office with (name deleted), I learned I could rent a dandy suite overlooking the Fraser River Canyon.

The sliding doors opened onto a wide sun deck. The P.G.E. rails were just beyond the fence at the end of the lot. When the 110 car freights rumbled by I was face to face with the engineers. I used to try to list the many boxcars, the rolling stock of railroads from all over North America in those pre computer days.

At nights no lights shone from the few homes scattered on the bench land below, on the other side of the tracks. The highway connecting Lillooet with the outside world was in the far side of the river. Came the darkness, the valley was pitch black except for the odd set of headlights of cars traveling into town.

There was no road on the mountainside which loomed up on the town side of the canyon.

One winter Friday night my friend (name deleted) had walked over for a visit. the folks in the adjoining suite had the TV on for the Dean Martin Show which aired at 9:00 p.m. (Name deleted) relaxed in an easy chair from which she could see out through the sliding doors. I sat opposite on the chesterfield, too far back to share her view. As we chatted, she suddenly, turned her head, and, staring out through the glass door, exclaimed in a sharp voice, "What's that ?"

I jumped up quickly to share her excitement and immediately saw a huge red swirling ball with flaring red orange flaming edges coming towards us from above the west side mountain.

Grabbing the glass door catch I shouted "let's get out onto the deck !" which we did. As we stood side by side, we watched the whirling fire ball hurdle towards us, so fast that we both ducked down, putting our hands on our heads as we truly expected to be hit as it crashed upon us. But, as we crouched and watched, the thing hovered "just above the mountainside" so to speak, spinning and flaring, to right, to left, to right again, for a few seconds.

It hesitated on the final jerk to the right, then in erratic short jumps, still spinning and flaring, it began to recede, grow smaller, to nothing, back into the sky from whence it had come.

We returned to the room, quite shaken up, and (name deleted) snapped, "Exactly what did we see ?"

I put into words much as I have in this account, using my extended arm to describe the movement. "Exactly !" she snapped.

Being Friday night with everything closed for the weekend, we had no way of finding out if anyone else had shared the sight. the News was being printed, not in Lillooet, but in Fort St. John at Ma'sson Dan's newspaper shop, so nothing was "of the moment"

By the time the weekend was over and folks were back on the job, we felt rather foolish in speaking of our UFO encounter. Had we not rushed to the sun deck, causing us to be physically involved, had we just focused and seen it with our sight, we may well have pondered if we had seen it at all.

I recall when I saw the movie "Strange Encounters" some years back I thought the UFO props were not nearly as exciting as what (name deleted) and I had shared on that Friday night in Lillooet, B.C.

So here in 1993, have watched a TV program on UFO sightings I am moved to record the event while sound of mind with 20 - 20 vision, from my notes written in 1966.

It is now August 20, 2000 and in Houston Newspaper, Wednesday 9 August 2000 one Brian V is asking for news of any sightings "past or present" and as (name deleted) passed on at 83, years ago, and I am now living in (location deleted) on the shore of (location deleted) at age 87, I decided to pass on our joint experience of that special Friday night in Lillooet. (name deleted) would truly approve !

Year of the UFO Invasion

In 1967, an abundance of UFO sightings were recorded around the world. Out of those, UFO researchers sat up and took notice of one area in particular ... the Cariboo. Canadian UFO Report focused an entire section of their publication on the region in 1969 entitling it "the year we were invaded without knowing it." Sightings of flying saucers were reported in detail, the witnesses accounts, from Lone Butte, Green Lake, Lac la Hache, and McLeese Lake. Here is one of the stories from that time.


The year was 1967. According to locals who remember the time, residents of the Cariboo enjoyed a hot summer and beautiful fall weather with clear night skies. For Barbara Begin, 1967 will remain a memorable year for much more than just great weather.

It was an evening in August before dusk, when Barbara and eight family members and friends witnessed what they believe was a UFO. "You could see it as clear as day. We were just dumbfounded," Barbara recalls with enthusiasm from the kitchen of her cozy lakefront property at McLeese Lake. "We watched it until it went over the trees". "What they watched, Barbara says, was obviously much bigger than an airplane and made no sound. "It looked like a big, fat silver cigar."

Although it was still light out, Barbara says the bright silver look of the object seemed to be caused by self-illumination. The object appeared above Sheridan Hill to the north (Barbara and the other witnesses were at McLeese Lake), and headed southward until it disappeared. The "cigar" UFO was the first encounter Barbara ever had with a UFO, but it wouldn't be her last. "Everybody was seeing them (UFO's). You didn't walk outside in 1967 without looking up."

Barbara's next sighting would be only 24 days later, with her good friend Barb Beck. "It was like a pulsating red light about the size of a soccer ball. It was quite a ways away." Barbara says the object travelled above the newly installed cables leading to the Peace River power project as if it were studying them." The sighting lasted for approximately three to four minutes before it disappeared over a ridge. At least a dozen residents of McLeese Lake witnessed the sighting.

Barbara estimates she saw about 10 other sightings of strange lights in the sky in the fall of 1967 ... but has never seen another since then. "I know what I saw," Barbara says with confidence, "It only stands to reason ... we can't be the only ones in the universe". And what did she think of that time in 1967? "It was an exciting year!"



Strange Circles Which Appeared Near A Cariboo Home

At the time of this incident the power project had not yet started operation and no power was passing through the cables. It seemed as though the object was studying the mere existence of the lines. A long time employee for B.C. Hydro's Peace River Project in Hudson Hope has confirmed unusual sights in and around the power project since its completion up until just a couple of years ago, including fast moving lights and objects.

He would not give his name for fear of being judged by his peers and co-workers as "insane."

Abductees, Implants & Other Alien Stuff




Listening to the guest speakers at Roswell's 50th Anniversary UFO Encounter, it was easy to get caught up in the whole subject of aliens and close encounters of the third kind. It was exciting and almost satisfying to be able to listen to "specialists" talking about what was known so far on a such a new topic of discussion. That is unless you yourself were an unwilling abductee.

For them, the discussion was more painful than exciting. The only satisfaction to be derived from the conference for them was that now at least they could talk about their experiences without being thought totally out of their heads. The questions they had to ask of the speakers could not be answered in any satisfactory way. The invited speakers even seemed somewhat reticent to even deal with people who thought or knew they had been abducted. Like most people in the counseling and psychiatric fields, alien abduction and its after effects is still a fairly taboo subject.

As one well-known psychotherapist in Albuquerque commented, "most of the people in the field don't want to get into trouble with their colleagues." In fact, trying to find a professional who deals with the kind of problems abductees have is a daunting task in itself since none of them like to publicize the fact that they deal with abductees.

Even when Budd Hopkins, a pioneer in the field of treating abductees, was asked by one woman what she should do about the many symptoms she suspected hinted at her and her child having been abducted and implanted, the only answer he seemed willing



to give was that she should go see a doctor. How many local general practitioners do you know who can deal with alien abduction? In fact, what many of the speakers had to say tended more to keep the subject shrouded in mystery than to open up new avenues of understanding and possible treatment. Of course, where does one go to study about alien abduction? What school teaches classes in how to counsel abductees? Truly, those in the various fields of psychology who are attempting to help abductees are real pioneers in their field. But is the problem something bigger than they can deal with?

Travis Walton's own story of abduction, made famous in the movie "Fire in the Sky", turned out to be one of scattered memories and brief images, memories and images that were then turned into a full-blown scenario of nightmarish proportions by a Hollywood seeking to satisfy the public's desire for more specific details. And herein lies the root of the whole problem. Professionals in the field say that so little is remembered, if at all, by the abductees, that little or nothing can be done to help them after the incident is over. Like the small flashing light used to erase and reprogram the memories of humans

encountering alien colonizers in the movie Men in Black, most people who have experienced alien abduction are simply not consciously aware of the fact. More often than not it is only through nightmarish dreams, clinical hypnosis, or physically unexplainable scars appearing on their bodies that any of the abductees even suspect that something might have happened.

One Encounter attendee I spoke with had a story to tell of missing time, a phenomenon which often accompanies an incident of alien abduction. While driving through the broad, vacant expanses of western New Mexico, he and his wife noticed that they were being followed by what appeared to be the red tail lights of a car, a car that would have had to be going backward at something like seventy miles per hour. A short time later the lights disappeared, only to reappear directly above the cab of their pickup as it drove down the highway. Once again the lights disappeared, only this time, they didn't return.

When the man and his wife finally arrived at their destination many hours later, it was with only a vague memory of the lights that had followed them, but the question that still haunts them to this day is the fact that they arrived at their destination four hours later than they had expected to arrive, and with no explanation for where those missing hours had gone.

When I talked with this man about the possibility that he and his wife had been abducted and implanted, he was at first leery, but at least he was open to listening.

One of the hallmarks of being human seems to be that we inherently harbor the attitude that "it can't happen to me"—'I could never get AIDS', 'I could never see a UFO', 'I could never . . .' And so it goes on. How many of us would ever believe that we could have an encounter with a UFO? How many of us would ever believe that we could be kidnapped from our homes, taken to an alien spaceship, and then surgically implanted? Things like that only ever happen in movies or to "other people." Local psychologists and counselors in the Roswell area admit they don't know how to deal with people who say they have, or might have been, abducted. The psychotherapist in Albuquerque admitted she had come across people who seemed to have been abducted, but she had to "pass them along" since she was already thought to be "on the lunatic fringe" for delving into past-life therapy, spiritual healing and 'seeing.' I have now worked with many dozens of people who have been abducted, either against their will or as part of their life contract—or, worse still, have been 'birth goddesses', 'alien fronts' or simply have alien entities still connected to them in some way, shape, or form. Others are simply aliens here in physical bodies as ambassadors to the planet, or as spectators to what is now taking place. And the percentage is a lot higher than anyone guesses at. Those who are abductees seem to be able to tell those who are and those who aren't. And the percentage of people who are abductees seems to reach as 40 to 50 percent of the population.

Do we call that a minor social problem?

One couple who say they do deal with abductees are Drs. Loren and Diane Mickelson, a psychically gifted couple from St. Paul, MN. Frequent visitors to New Mexico, the Mickelson's say they have worked with many thousands of abductees over the past few years, and estimate that as many as forty

percent of the "average population" have been abducted and implanted with what they term crystal implants. These crystals are used to track and cause limitations to the person who has been implanted.

The Mickelson's say that, once again, the major factor common to almost all the abductees they have dealt with, is the fact that the people involved had no remembrance of the event, only the lingering effects of the crystals. They have also found that in many cases where these crystals have been implanted on specific organs of the body they have been found to be the root cause of a disabling illnesses such as cancer and chronic fatigue syndrome.

One Roswell resident who prefers to remain anonymous says she has experienced "a 95 percent recovery" from her chronic fatigue syndrome since having her crystal implants removed by the Mickelsons. After spending most of the past ten years significantly limited in the daily routine she has been able to perform, she is now able to return to a more regular lifestyle, one in which she has even more energy than she remembers ever having before. Another of the Mickelson's Roswell patients says for him it is like a great weight has been lifted from his shoulders.

"All of a sudden I have an energy I've never known before. I think for the first time in my life I'm experiencing what it's truly like to be fully human without any controlling limitations. I guess if I had to put it simply, I would say that I have a new sense of freedom and clarity after having the crystals removed."

The Mickelsons, a multi-talented and multi-degreed couple who until recently spent most of their lives working in academia and the corporate environment, say that working with alien abductees would have been the last thing they ever would have thought of

doing as a life mission. Like many psychically gifted people, however, they say they have been "led" to utilize their paranormal abilities to educate people to the alternative levels of existence, in particular to help people remove limitations—both those placed upon them from outside influences such as through alien abduction, and those acquired through the normal course of interaction with an often oppressive world.

Loren says he is clairsentient, while also having the ability to tune into and channel the energies of any dimension. Diane can both "see" and "hear" multi-dimensionally—not only in the present, but also in the past and in the future. Both of the Mickelsons are certified Reiki masters. The Mickelsons involvement with alien abductees began at a rock and mineral show a couple of years ago where a strange man appeared to them and gave them "an other-worldly message" of importance to their future. After struggling for a while against what they saw to be the ultimate outcome of this message, Loren and Diane received further confirmation under similarly strange circumstances, and all of a sudden their lives took a rather abrupt change in direction.

"You have to understand," says Diane, "This was so out of character for us, it nearly scared us to death. This person told us this astonishing story: Over 45,000 years ago in Lemuria, a continent which once existed in the Pacific Ocean, there were politicians who wanted to remain in office for life—the average life span of humans in those days being so much longer than now. To limit or punish anyone who would oppose them, these politicians had the people implanted with programmed crystals which, when activated, served to control or limit the natural abilities or rebellious tendencies of those people."

The Mickelsons listened quite attentively, but the last sentence struck a particular nerve with them because they had recently regressed a client back to the days of Lemuria where she had been an infant selected for crystal implantation.

"We certainly didn't understand the regression at the time," says Diane, "but all of a sudden it was beginning to make more sense." The Mickelsons say they went on to find out that not only were programmed crystals implanted back in the days of Lemuria, but also in the civilization that later followed in Atlantis. It even occurs frequently today in people who have been subject to alien abduction, whether they are consciously aware of ever having been abducted or not. The story the man told the Mickelsons seemed far out to them at the time, but they ask if it is really any stranger than the crash of a UFO some fifty years ago near Roswell? When one looks deeper into the technology that is available today, the implications of this story may not seem so unlikely. Descriptions of both Atlantis and Lemuria appear in the traditional literature and folklore of almost every culture on Earth, both supposedly having been technologically advanced societies that were destroyed by major Earth upheavals.

It is also not out of place, say the Mickelsons, considering the fact that the US military is currently implanting small micro-chips in many of their new recruits to act as a means of identification rather than using of the old familiar dog tags which can be lost or destroyed during combat. Banks are also now talking about implanting a bar code-like micro-chip under the skin of a person's wrist that will identify them and the details of their bank account. These implants will then enable them to make purchases by simply running their wrists over a scanning device such as the ones commonly used in grocery stores. The Norplant contraceptive and other medical treatments use

implants to release hormones and other control drugs into the system at a calculated rate. It is also not impossible considering the fact that the whole technology of radio, television, and space communications is based on one form of crystal technology or another.

I have already written before on the 'digital angel' and its microscopic size. California is now trying to pass a bill to have all pets implanted, perhaps as a prelude to all humans too.

"We asked how a crystal programmed 45,000 years ago could still be affecting us in this lifetime. The man replied that it is the nature of crystal programming that a program continues until it is erased or removed."

Loren explains that the imprint of the original crystal implant is carried forward from lifetime to lifetime in the etheric body of that person, one of the higher dimensional bodies surrounding the person's spiritual essence. It then shows up in the current lifetime whenever that person tries to rise above the level at which he or she has been stymied for so many lifetimes.

"The crystals were programmed thoughts of limitation. Your strongest natural ability has been programmed to be your weakness, causing you great personal frustration each lifetime. It's extremely frustrating knowing internally that your life really could be easier if you could just remember how to do it. Imagine a life without limitations; without interference."

The news the Mickelsons say they are trying to share is that these crystal imprints can be removed, and with them, many of the limitations that hold a person back from fulfilling their full potential in this lifetime. Working as a team, Loren lighting up the crystals with the energies passing through his body while Diane removes the crystals from the etheric body, the Mickelsons say they are able to completely remove

all the crystal imprints from a person's past and current lives in one simple 30 minute session. This then allows the person to then be able to start their life again unencumbered by outside limitations.

Echoing this idea, another of the Mickelson's Roswell patients interviewed said that he felt "less inhibited and less self-conscious," "more able to express what I really feel." Similar themes of clarity, unshakable inner calm, and heightened energy and endurance, were also echoed by other patients interviewed.

Testimonials from other patients treated by Loren and Diane suggest that not only physical problems, but also emotional and mental problems have been alleviated or totally removed as a result of the removal of the crystal imprints. Even physical addictions to substances such as drugs, alcohol and tobacco have often disappeared along with the removal of the imprints.

Diane explains that removal of the crystal imprints is only the first level of the six levels of treatment into which they have now expanded their practice. The second level involves removal of self-imposed limitations such as negative beliefs; religious, cultural, societal, and family dogma, both from this lifetime and other past lifetimes. The final levels have to do with what the Mickelsons term "soul emergence patterning" and preparation for ascension.

The Mickelsons say that levels one through three can be done absentee—that is, without the patient even being present. Only the later level needs to be done in person. People interviewed for this article who had the treatments done absentee quoted the same extraordinary results as those who had the work done in person. The number of crystals imprinted in a person seems to vary.

The Mickelsons say they have seen as few as 91 crystals in a person, ranging all the way up to people such as the woman with chronic fatigue syndrome who have had as many as 15,000 crystals imprinted throughout their body, severely disabling them on every level of their being.

Diane says the crystals may also vary in size from the early Lemurian crystals that were implanted in systems and look like a string of Christmas lights, up to the credit-card size crystals that were implanted in the time of Atlantis, and in recent alien abductees.

Is the procedure to remove the crystals safe?

"Crystal removal affects people in different ways," says Diane. "You may feel nauseated, you may feel euphoric, or you may get a traveling headache, etcetera. All these feelings will go away almost as suddenly as they come up. One thing is pretty constant, a sense of calm comes over most everybody, a sense of calm that never really leaves them."

How can you tell if you are one of the people who may have been abducted or had crystals implanted?

"If you have any questions at all in this area, there is a strong probability that you do have crystal implants," explains Loren. "Just get quiet and check in and ask yourself if you do—intuitively you will know. Not all individuals have crystal implants. Only about 40 percent appear to have been implanted." "Crystal removal is not for everybody. We do not try to talk anyone into it, nor do we defend crystal removal. Crystal imprint removal does not cure or solve anything. What it does do is remove limitations. You will just know if it is right for you."

The Mickelsons say that the average price of a crystal imprint removal treatment runs about \$110 absentee or \$150



Date: October - November, 2000

Hi Brian,

I thought I'd reply to the questions you mentioned. Yes I did see the light well before I got my camera and took photos of it. It was moving south . When I first saw the object, the light was flashing about erratically over my field out back below the hydro lines. My camera was nearby in my car so I quickly grabbed it , ran to the fence and by this time it had just crossed over the fence and was hovering over my neighbor's property.

I took 3 pictures, I've reviewed the negatives and found the first overexposed, the 2nd is the shaky one and the 3rd the best one. At the time all I saw was the light and it wasn't until I got the photos developed that I saw the image below the light. As for the slanted line I assumed it was just a cat-hair on the lens or so. Upon enlarging the photos on my PC, I believe the craft itself is the lower gray image and the light above it exactly mimics it. Since the sun had just gone down but it wasn't totally dark, I 'I'm considering the possibility that normally one cannot see these crafts because of their light- bending technology but that under certain light conditions as in this view towards a recent sunset, that technology doesn't work perfectly allowing one to see the object separate from light.

After my third photo was taken, the light moved south


along the power lines, I drove down the road here which also runs south but did not see it again. Ahead of these objects, the witnesses then saw "another two much larger round shiny objects traveling parallel to each other". The witness goes on to say, "then as we watched, coming from the NW to the SE, came one of these ball objects. The object appeared to move up a little and down a little until it reached a point where it made a "...complete 'U' shape, then came back the other way". After this at least 3 or 4 followed the same path with some moving fast and others slow. Finally, "...two came back from the southeast and slowly moved to the northwest". No sound was heard. Weather at this time in St. Albert consisted of clear skies and warm temperatures.

Update: (July 9, 2002) The witness wrote back to say the entire event took place over an hour and a half. The individual events occurred at regular intervals of around ten minutes and each lasted for about 5 to 15 minutes. On two of the higher objects the witness states that she could "... see what appeared to be a dark line in the center of the object and a shadow underneath". After all the objects went to the NW sky, they returned at regular intervals moving towards the SE when one suddenly stopped and did a complete 'U' turn and went back to the NW and the others followed, again, at regular intervals.

Terrace, British Columbia

Date: April 26, 27, 28, & the 29th (four nights)
Time: After dark

This is a short version as I just got off the phone with this witness and re-wound the tape to grab a little off it to let everyone know. I will have a full report really quick.

A witness called me tonight May 2, 2002 (Thursday night at 10:30 p.m.) to report of a lot of UFO activity going on in the Terrace, B.C. area. He reported that he was unpacking after his move from the Kitwanga, to Terrace, B.C. He stopped for a cigarette when he saw an object very close to his location. He watched the object move from east to west, but at a low level, and very close to him. I asked this witness how large was this object ?? He said it had to be approx: a quarter the size of a full moon, and as bright, if not brighter and then would become dim, then only to repeat in brightness, to dim.

The fellow also said this object would move very quickly, only to come to a complete dead stop, then it would disappear. On the following night, the light returned, again at a low level and he watched as the light dropped a pale green in color, lights from the underside of it. These green lights vanished before hitting the ground. As the next night came along, he had witnesses with him, just in case whatever it was showed up once again, sure enough, they all stood watching this light, plus other strange objects.

The sightings did not last for any length of time, approx; 5 to 10 seconds before disappearing, but they did return the same night. Also he mentions that at times the object would stop and blink several times before moving on.

On the last night the witness said, that the object (light) slowly rolled over exposing some kind of shape to it. He said it was a defiantly saucer shaped.

Anyway , I have this conversation on tape and plan to head out pretty quick for a sit down interview with him and the other witnesses. Also while on this trip I will drop in and gather a few of the other sightings I have not reported on. Lots more to this sighting, so stayed tuned.

Vanderhoof, British Columbia

Date: First week in February ??
Time: Between 6:00 - 6:30 PM

The witness telephoned me explaining she watched an extremely bright white light just east of Vanderhoof on Surgeon Point Road. (Note: This is where I investigated the September 2001 crop circles) I mentioned that I had investigated the crop circles and she said her sighting took place 2 miles east of where I carried out the field investigation. The witness said she only observed this light for approximately a minute after she came up over a hill on Surgeon Point Road and it was there above her. After she got home the next morning she told her husband what she had seen and said it resembled an airplane coming into an airport with a bright light on. This lady said she observed it for about 200 meters before she drove behind the trees and could not see it anymore.

She then said she did not realize what she was looking at as she was too far down the road. She said now she wished she had stopped and looked at it longer. When she got further along the road in a position where she would probably be able to see it again .. it was gone.

I asked what colour were the lights. I was told it was very bright and it looked just like an airliner's landing lights, but it had only one extremely bright white light. I also asked her if she could remember the time that this took place, and she said it was between 6:00 p.m. and 6:30 p.m. Her impression of it was that the light was below the crest of the mountains, between Vanderhoof in a south-westerly position.

I asked her if the Vanderhoof airport was able to take any commercial traffic, she said no because the airport does not have any runway lights for night time traffic and went on to say they are not even allowed to land due to this reason.

("Investigators Note") - I already knew that there was no commercial traffic at the Vanderhoof airport and it is not

equipped to have night landings as I had talked with Mr. Brent Miskuski back in September of 2001. He was the gentleman who flew over and discovered the 6 new crop circles. She also mentioned that this light was too bright to be from any type of aircraft that we know of.

I have to check to see if any helicopters were flying around the date and time frame mentioned here. This lady after telling her husband and reading my letter to the editor said, "hey I seen that light" And of course the light disappears so quickly.

Now here is where it gets really interesting:

Just before the end of the conversation she said she was surprised no one else had phoned from Vanderhoof to report this strange very bright white light. (Investigators Note: I gave a very brief statement about the two other Vanderhoof residents who reported to me. One report was south of Prince George and the other report was spotted over Sinkut Mountain.)

After I mentioned Sinkut Mountain she said "hold the bus"! It was either Thursday or Friday morning which would have been February 28 or March 1, 2002 there was an unusual light in that direction of Sinkut Mountain which she can see from her kitchen window. Her first thoughts were that it was just a logging truck. I asked her then what color this light was, she replied that the light was white and extremely bright. The witness actually told me she had looked at this through binoculars and it was just a pure bright white light and was there for quite some time. I then asked did this light do anything out of the norm? She told me the light would move, then stop and was gone, but in an instant it was back where it started from. She told me the light would zip around so quickly in that area it could not have been any aircraft or logging equipment. I asked her if she was able to remember a time and she said approximately 5:30 a.m.

("Investigators Note"): Well I almost fell over because the other two witnesses reported the very same thing, at around the same time. This lady went on to say again that they live on a hill over looking the valley and have an uninterrupted view of Sinkut Mountain and she said it seemed to her that the light was west of Sinkut Mountain and even using binoculars she could not make out anything but a bright white light.

Keep in mind what caught my interest was when she mentioned the February 28 or March 1, 2002 sighting she watched from her kitchen. This would be "exactly" what the other two witnesses told me when they were traveling on Langston Road heading towards Prince George at

approx: 5:30 - 6:00 a.m. This new sighting confirms the other couples report.

What this was is anyone's guess but I do plan to spend some time on this and see if I can come up with an explanation. I know for a fact there was "no" equipment working in the area at the time of the sightings. I did check this out. I am going to also have to rule out snowmobiles.)

The object was observed to slow, reverse direction and proceed slowly to the west. A balloon might have been a possibility except for the reversal of movement. Sasquatch In B.C.

Does a large hairy covered humanoid roam the wilderness of the Pacific Northwest? Changes are more likely that you will encounter this creature close to civilization than in the deep woods. If very lucky it may even be in your own back yard. This creature was no stranger to the first nations people of western Canada and the U.S. In fact the name "Sasquatch" loosely translated means "Wild Man of the Forest". It's tracks and sightings have been made from the mountains ranges in northern California to the tundra of the Yukon and Alaska. To the none natives in the U.S., it is called "Big Foot", and in the Himalayas the "Yeti". A recent T.V. program on the learning channel revealed that a dozen other countries, including Australia have similar creatures with their own names.

In this article we will only cover our own area. For obvious reasons many peoples names and some locations cannot be given. Also the sightings will be given in the order that they were received in the late 1960's a veterinarian by the name of Dr. Proctor opened a clinic on the 4600 block on Lakelse Ave., just east of the Bank of Montreal. In the front window there was a pair of large plaster cast footprints. When he was asked for the reason of the display of these footprints, the reply was that he was very interested in this creature. The sight of these big feet may bring in more information and it did.

Sighting # 1

In 1974 a friend and I applied for two expired gold placer leases on Lorne Creek, 30 miles east of Terrace, British Columbia, on the railroad side of the river. The boat used to cross the river was tied up at Jim's place on the highway side of the river. Since there were grizzly bear in the area we carried rifles. In shooting the breeze one evening, we asked Jim what kind of wildlife was in the area. Of course there was Moose, but recently he had seen something different. While doing some work there he spotted a moving patch of brown a short distance away. Curious as to what it may be, he sneaked closer. It appeared to be a brown colored bear that had its back towards him and was standing up on its hind legs eating Saskatoon berries, however, it was using its front paws like hands. The last cover was 50 feet from this creature and this was as close as he could get. From this point he saw that the paws were hands and this was not a bear, but some kind of hair covered human like creature a little over 6 feet tall. Also it had a very strong odor that reminded him of a camel smell when he once worked in a circus. After about 10 minutes the creature sensed that something was near it and turned sideways and spotted Jim who then saw it was a female as it had breasts. The creature then just trotted off.

It was then Jim's wife spoke up. The pervious summer

about the same time of the year she was home alone. Suddenly their two tied up watch dogs raised an awful commotion, more so than if a bear was around. Stepping outside she saw through the trees about 100 yards away skirting the yard a large black bear walking on it's hind legs. She knew a bear didn't walk on it's hind legs. This couple were told of Dr. Proctors interest and if they would be willing to grant him an interview if he came out. They agreed and he was notified. Later on down the street I asked him how he made out. His reply was that it certainly appeared that this is what they saw.

Sighting # 2

This also occurred in 1974. At that time the new highway bridges into Terrace had reached a point in construction where it was safe for the public to inspect them after working hours. Taking advantage of this, Dick and a friend decided to cross to Ferry Island from the Terrace side and explore it. On the river bank they found fresh large footprints. They went back and picked up some plaster of paris and a camera. After the casts were made a through search was made for the creature but it was not seen. They kept their find a secret until they were sure it was no longer around. It is quite possible that this was the one that was seen at Lorne Creek.

Sighting # 3

This took place near the end of January at one of our local landfills. At about 2:00 AM a worker returned to the landfill to pick up a set of keys that had been left in a piece of equipment. As he was walking past the area where the last dumping was, he saw a figure crouching amongst the garbage. He called out with a "hello there, what are you doing in the dump at this time of the night." The figure stands up and this worker who was about 100 feet away was amazed at it's huge height and size. It stood at over 10 feet tall. The creature turned and looked at the worker, then just walked out to the bush at the rear of the landfill, looking back several times to see if it was being followed. When it was a safe distance away the worker went to the spot where it was first seen. The footprints were 5 feet apart, further than the worker could spread his legs. Also it walked through 2 feet of snow as easily as a human could walk through ankle deep snow. It was learned later that 2 days after this sighting, a similar sighting, maybe of the same creature was made at Usk about 12 miles east of Terrace.

Sighting # 4

This took place around 1950. Two logger brothers set up a bush sawmill on the Babine Lake road just out of Smithers.

Sasquatch In B.C.

The staff and workers built cabins to be near the mill. One Sunday having nothing else to do, the younger brother decided to do a little exploring in the woods. Coming across a game trail, he decided to follow it. On the trail were giant footprints that looked like those made by a large grizzly bear, but they had no claw marks on their ends. Also the steps were 5 feet apart and still 4 feet apart even when going up a steep hill. The logger was 6 foot, 2 inches tall and could barely match the stride by stretching his legs to the limit. Even when going up the hill his steps were only half as long. While following the tracks he noticed the trail was littered by a lot of fresh stripped twigs. Looking up he saw all the alder trees up to 20 feet on both sides of the trail had all of their upper branches stripped bare. The taller 20 foot trees had 4 inch trunks near the ground. It was very evident that this creature was big and strong enough to bend over these trees to get at the tender tips, leaves and buds on he top branches. The twigs that broke off were spit out like humans do with fruit or berry stones. When the logger tired to bend these trees he could hardly move them.

Sasquatch researchers have long speculated what these creatures ate, and especially during the winter time in the woods. So far two things were mentioned, Saskatoon berries and alder buds and shoots.

Sighting # 5

This took place around 1980. two men were driving to Kitimat one summer morning. Coming down the airport hill they could see a ground fog over the William Creek flats. This was a 2 mile fairly straight stretch of highway that was built over a swampy area that was part of the north end of Lakelse Lake. The grade or fill here varied between 5 to 6 feet high. As the car came around a slight bend at the bottom of the hill they could see arms waving in the fog ahead of them. Thinking that someone had gone off the road they prepared to stop. Since it was foggy the driver had to get over the white line and right on the shoulder. When the vehicle was still several car lengths away from the figure, the passenger who told me this story saw that it was not human. It was a very tall hair covered human like creature that was standing in the water at the foot of the grade and was facing the highway. When the car came to a stop they were alongside the creature. The creature's head was level with the occupants in the car and about 5 feet away from the passenger. After a brief moment the creature's eyes and mouth opened wide in terror. The head was thrown back and it's arms crossed over the front of it's head as to be warding off a blow from a club. It then turned around and dashed into the swamp, going at times through waist deep holes of water until lost in the fog and leaving two stunned men in the car. While mulling over this story I measured the eye level height off the road in a similar type of car and it was 4 feet

Since the grade shoulder would have sloped a bit it would have been about 5 feet above the water. The creature was standing in water halfway to it's knees. Adding up each foot of height on my fingers took all ten of them. This was followed up by another visit where two questions were asked. The first was if the creatures face was relatively free of hair as we see on the T.V. shows of the chimps and apes. The reply was that the face was covered with hair much the same as a full beard would be on a man. The next question was, "did you see the dished face of a chimp or ape or was it more human like"? The answer was that I saw a human face. It definitely was not the face of a chimp or ape.

What apparently had happed here was the Sasquatch was feeding on the brush on the road grade as it was standing in the water. The movement of the arms through the fog was the creature reaching out and pulling the bushes towards himself. Like most wild creatures it did not pay much attention to the traffic as they went by at highway speed. However, if you slow down much or stop, then they are gone. You can imagine the creatures surprise when this large object suddenly stopped in front of it.

Sighting # 6

This sighting was from a lady now living in Terrace, B.C. in 1985, she was living in the Queen Charlotte Islands in a cabin by the Honna River. One afternoon an acquaintance stopped by to tell her of a strange event he had just witnessed. He had been fly fishing further along the river when a very tame Deer came out of the woods near him to drink from the river. he had stopped his casting to admire the Deer. Suddenly a rock flew out from the trees, striking the Deer and knocking it down.

This was immediately followed by a very tall hair covered human like creature who threw the Deer over it's shoulder and dashed back into the woods. Of course this took the pleasure out of further fishing and he didn't want to stick around with the rock chucking ape in the vicinity. This is the first that I heard of the Sasquatch being on these islands. According to this lady, the local native people speak quite openly about them. Now if anyone is curious whether or not this Deer was roasted, just read on.

Sighting # 7

This took place in 1967. Fred arrived in Canada in 1960 along with a flood of German immigrants. In 1967 he was in the Houston area where he had joined an outdoor club. In the fall Fred went hunting because it was a man think to do.

This is an urge that harkens back to a dim and distant past where humans had to hunt in order to survive.

Sasquatch In B.C.

A favorite place to hunt was on a prospector trail that ran up a mountain in the direction of Kemano in the Bower Lake area. This weekend Fred was only accompanied by a medium sized dog as he was after a young Moose that he could drag back down the trail himself. Halfway up the mountain he ran into a fresh fall of snow a foot deep. Suddenly he was hit with a very strong pungent odor similar to a large decaying carcass. He was up here the weekend before and there was nothing like that here. When he tried to go on, the dog laid down on it's belly blocking his way. When he tried to go around the dog, it crawled forward continuing to block his way.

Fred then climbed up on top of a rock that was beside the trail but he could see nothing ahead. However, he decided to heed the dogs warning and headed back down the mountain much to the dogs relief.

In *sighting # 7* Fred had moved to Terrace in 1974. During that summer he visited another German immigrant family with 8 children who were living in an acreage community of Rosswood about 30 miles north of Terrace. There was a houseful of guests that day and the hosts had a strange story to tell. The previous winter had a very heavy snowfall. In March the snow was still 4 feet deep but hard enough to walk on. The snow had melted away from around the smaller jack pine trees to leaving them sitting in holes in the snow. During the Easter school holidays the children saw two hair covered human like creatures about 100 yards behind the house. One was an adult and the other a youngster about half as tall. It was presumed that the larger one was the mother but it kept its back to the whole family who were watching from the back of the house. These two figures were going from one small jack pine to another, picking and eating the needle tips of the branches. Here we have another item on their menu.

Two days later on the afternoon a large passenger airplane without wings, tail or engines, and making no sound, flew very low and slow, following the path that these creatures had taken. In my correspondence with UFO*BC they had mentioned having a number of reports from people who had seen a Sasquatch and a UFO in the same area around the same time. They were wondering if there as some kind of connection between them. It is my feeling that the aliens are every bit as curious about these creatures as we are.

This covers the verbal stories collected so far. The remaining printed stories will be photo copied.

A local moose hunter once mentioned that he could easily have shot a Sasquatch. However, it looked so human like that he didn't dare. Although it would have been a real boom to science, he was concerned that he could be charged

with man slaughter if it would be classed as a sub human by these scientists. This question was put to the homicide department of the local R.C.M.P. The reply was that they couldn't answer this question and referred me to the crown prosecutor. His statement was the same as the police, so the next visit was to the game warden. According to him the Sasquatch was not a game animal, so it has nothing to do with his department. If one was shot and declared a sub human, then it would be up to the police and courts to deal with it.

It seems here that the safest thing to do would be to capture one alive. If it turns out to be some form of human, then it could always be turned loose. However, if it realizes that it can just laze around and still be fed, it may not want to leave. If food is put out for a homeless dog or cat, it sticks around.

The next question would be, where doe the Sasquatch fit in to the scheme of things. It appears that this was one of natures experiments in evolution that got stuck in a rut. Anyone that listens to the news and watches the T.V. educational channels will be aware the oldest human bones found go back almost 6 million years. Here we have an upright walking primate that was very good at climbing trees. However, its brain was the same size as the primates that were still walking on their hands as the chimpanzee does today. The chimp branch had forked sometime earlier with each branch then going its own way. With the upright walking primates the hands were now free for other tasks and the brain began to increase in size to accommodate this dexterity. As these hands were used more and became more skillful, the greater the brain increased in size until two distinct species had developed.

Somewhere near the beginning of this separation a third branch had spouted between these two species. This primate also walked upright but it's brain remained chimp size. Here we have half of each main branch, with the body following the upright walking side, and the brain following the side where the primates still walked on their hands, like the chimps do today.

However, it must have had something going for it, for this species also survived along with the other primates including the one that became humans. The Sasquatch is now comparable in size and weight to the gorilla and probably has the same size of brain. In all of natures evolution only the human primates has made it into the stone age and beyond.

Humans were the only creatures that made tools and weapons. We are the only ones that used fire for warmth and cooking.

The other primates do not even have the intelligence of how to keep a fire going. Humans were the only creature to have a full and written language, and the only creatures that built permanent shelters.

The Sasquatch had none of these and probably didn't even need them. Its heavy fur coat was adequate for all weather. Like our moose it just spent its days roaming the wilderness in search of food. There is no evidence that it even had its own territory as many animals do. It just followed its food supply. When needing to rest any comfortable place would do. A permanent bed was a disadvantage as it would soon have been heavily infested with fleas, lice, mites and ticks. As its diet was mostly vegetation it did not have to compete with the more intelligent human primates for the available food supply. The Sasquatch was for the most part a solitary creature that just came together with a female to mate like much of our wildlife. Most of the sightings are of a single creature. It was up to the female to raise the offspring alone. If like humans, it would take a good many years to raise a youngster to where it could look after itself. This would mean a mother could only raise 2 or 3 children in its lifetime which would barely sustain their numbers. This would explain the scarcity of these creatures.

For those who have watched the wildlife documentaries on the T.V. educational channels will be struck by the almost human behavior of the chimpanzee. They tend to remind us of our children quarreling. For a long time scientists had thought that the dividing line between human and other creatures was in the use of tools. However, many wildlife pictures do show that the chimps, other animals and even birds will use sticks and rocks as tools in order to obtain food.

With our recent rapid advancement of our genetic research scientists are now saying that the chimpanzee, depending on its species have from 98 to 99.3 per cent of the genes of a human. In fact they are more closely related to humans than they are to the other large apes. Because of this some scientists have started a movement to declare the chimp a sub human with all the protection humans have. The Sasquatch with its upright walking and very human face could fit in between humans and the chimps. Does this mean the Sasquatch is the missing link? Not likely as all 3 species evolved from an earlier life form around the same time.

After all, in the scientific category humans are classified as a primate or more crudely an ape. Keep this in mind the next time you call someone a big or stupid ape.

Sighting # 8

This report was received after my report had been completed and photo copies made.

In the summer of 1988 Dan and his wife visited a friend on Old Lakelse Lake Road past Jackpine Flats. After awhile Dan had to stretch his legs and decided to look at his friends garden which was a little distance behind the house. Midway on the way back on his left was a dense grove of low leaf trees. Suddenly there was movement there and Dan thought he saw what looked like a very large rear end of a moose taking off. Dan, an avid hunter couldn't believe that a moose could be that high. At that moment the owner let out his two small house dogs. Dan hadn't smelled anything but apparently the dogs did. They ran yapping into the dense grove of trees. A few seconds later they came yapping back with high pitched yelps right up to the house and scratches madly at the door to get back into the house.

The owner came out and asked Dan what made the dogs act so strangely. Dan said he didn't know but would take a look around. He couldn't find any moose tracks in the grove of trees. There were a number of large faint impressions in the moss that were still rebounding out. Dan was familiar with the stories of the Sasquatch and suspected that this is what he saw. However, since there was no firm evidence to back him up, he decided to keep quiet rather than face teasing or ridicule. However, this event shows that although the Sasquatch will usually avoid humans, they can occasionally still stumble into their yards. In this area a story of bear and moose in your yard is believable but a Sasquatch still isn't. It should also be noted in this report and the other information included, the strange reaction of the dogs. These dogs will not hesitate to go after a full grown grizzly, but yet run and hide from a Sasquatch. Do they instinctively know something that we don't?

Sighting # 9

This took place in 1991 during late July or early August. Dan and his wife were returning to B.C. from a visit to Ontario. Midnight found them near the Ontario - Manitoba border close to Westhawk Lake. Suddenly ahead of them in the car headlights they saw a large hair covered human like creature running hard across the highway. Dan remembers that the hair on the top of the creatures head was standing upright like a comb or brush. His wife noticed that steam was rising from its shoulder. It was obvious that the creature was in a panic situation and was running from something. Later they heard that others had seen it and it made the news on the local radio stations and the newspapers. From the above report is proof that the Sasquatch is not confined to the Rockies but can be anywhere, even on the prairies.

Smithers, British Columbia

Date: February 1, 2002

Time: Approx: 10:00 p.m.

Investigators Note: I received this report March, 24, 2002 which may be a confirmation to the February 1, 2002 sighting in which three ladies witnessed a large boomerang shaped object 3 kilometers east of Telkwa. The witnesses to this sighting were heading east on Highway #16 towards Houston, B.C. their home town. The object passed right over head, going west towards Smithers, B.C. Telkwa is a 10 minute drive east of Smithers. I started out making enquiries into the February, 1, 2002 sighting but I must admit I wasn't ready for the amount of sighting reports which kept coming in.

Today, Sunday, March 24, 2002 I received a telephone call from a gentleman who lives in Smithers, British Columbia who had read an article in the Smithers Interior Newspaper about some of the sightings which have taken place from Kitimat, B.C. right through to Prince George. The paper also carried my contact information so if anyone had seen anything strange and wanted to, they could at least find me to file a report for investigation.

This witness told me he had gone to rent a video from the Smithers Hollywood Video store and after he came out and got into his car and starting driving down the road, something caught his eye. He mentioned, due to the lights from the town of Smithers he could see the object rather well. He pulled his vehicle over, got out and watched it fly slowly over and around the town for approximately five minutes. He also told me he thought it was descending and his first thoughts were of a para-glider and said it was the best way he could describe what he was looking at. He also said the object had "one" bright white light on it. He mentioned the light would go bright to dim, but said he wasn't sure if this was due to the object turning.

The witness mentioned that para-gliders often flew off Hudson Bay mountain and I asked him, because of that fact, had there ever been any other sightings of the gliders he replied "no, not at night".

I asked him if he had an idea what the size would have been of this object. He said it was hard to tell, but went on to say it would have been about the size of a para-glider if you were standing next to it. He also said the height from the ground would have been approx: 1500 feet. It slowly made turns over the town of Smithers. I also asked about the weather conditions at the time of his sighting, and he said it was overcast as did the three witnesses for the Telkwa sighting the same night.

The witness said he would never have mentioned his sighting to anyone as he did not know who or where to report this anyway, until he read the article in the newspaper.

Investigators Note: I was talking to some new friends (I am keeping their identity secret) and they told me that they knew for a fact that there was more than normal air traffic in and around our area after the sighting on February 1, 2002. Their source would not elaborate on what was taking place, but again said there were a number of aircraft patrolling the skies our way. I thought this was very interesting as well.

Houston, British Columbia

Date: March 21, 2002

Time: Approx: 7:00 p.m.

Object: Bright white with orange glow around it.

The witness reported that when he and a friend were looking at new trucks at Sullivan Pontiac dealership in Houston, B.C., which is along the business frontage road just off Highway #16, a very bright white object caught their eye. The object would have been in the field behind the car dealership which would be facing southwest at some distance away from them both.

When I was talking on the telephone to the witness, he said that in all of the pictures the object looked like a bright white "star". But in one of the photos he said, if you look really close you can barely see an orange glow around the white object. He also said that seeing the object in person was totally different from how the object looks in the pictures.


He mentioned also that it was so far away when he took the picture that it looks like a star in the photo. He added that you could tell it was something really bright because there are also lights from the town in the picture as well. 
Houston, B. C. Sighting Continued.....

Investigators Note: The two fellows dropped into my home to show me the pictures and give me the rest of the story. As mentioned by the witness above, the object was in the distance, but after I looked over the area today where this took place it really wasn't as far as the pictures make it out to be. There is a barn standing out in the field where the object was hovering. From the photos and from what I saw when checking the area out, the object would have been still some distance above the barn. I am going back tomorrow to take some pictures myself, and to look around the area a little more just in case there may be something I might have missed. Also one of the witnesses said he did have a hard time sleeping that night after watching this object, knowing it was something he was not familiar with.

Investigators Note: The Barn in the below photo is directly behind this power station. Could there be a connection?



Ufo was filmed hovering over-top this barn in Houston, B.C. The barn in this picture is directly behind the power station. When the flash was used by the witnesses, the object started towards them both.

The Witness said the object was hovering over the old barn which is in the field behind the power station.

There was four separate sightings on different nights of the same object. The white light, with an orange haze around it was also viewed in different locations around the town.

From some of the reports I have received since February 1, 2002 there seems to be a pattern of very frightened people. As a matter of fact I talked to one of the ladies from the February 1, 2002 sighting of the large boomerang shaped craft which went right over the top of the car when they were traveling back from Smithers heading home to Houston, B.C. and she still gets goose bumps just talking about it, and is still very nervous over the whole experience.


Also an important note about the pictures. The fellows took the three pictures using the flash on the camera. Due to this event taking place at night the flash does wash out the image in which the person is trying to capture on film. Also it can be detrimental if the flash exposes things close to the camera.

Corners of buildings, or tree trunks, light poles etc. will reflect back "flash" light that washes out the target image.

Like many of us, these fellows did their best in trying to catch the object on film, not thinking of what the flash may have done to the outcome of the pictures. To be honest, in a case such as this, with the excitement of seeing something you can not explain I may have done exactly the same thing




