



STANFORD, California (AP) -- Unidentified Flying Objects deserve further scientific study, say 80 per cent of 1,356 astronomers replying to a questionnaire.

In a survey mailed to 2,611 members of the American Astronomical Society, positive responses to the question of whether the phenomenon merited further inquiry ranged from "certainly" to "probably" or "possibly".

Sixty-two persons said they had seen or had made instrument recordings of events they couldn't identify, but which they thought may be related to the UFO phenomenon.

The questionnaire was conducted by Prof. Peter Sturrock, an astrophysicist and member of Stanford University's applied physics department.

Eighty per cent said they would be willing to help solve the problem if they could see some way of doing it.

CRISIS OR SOLUTION?

Those strange "agents" who terrorize UFO witnesses :



PHONE CALL TO UFO LANDING WITNESS
REVEALS MORE DATA ON MEN IN BLACK

A Canadian UFO research organization has discovered that a mysterious telephone call and a return visit of a UFO to a witness' home occurred after he saw a landed object.

On Sunday, January 2, 1977, three field investigators from Reptune Research Organization were in southern Ontario interviewing several persons in Turkey Point who had seen UFOs in late December, 1976. The three had come from West Hill, just outside Toronto; they were Harry Tokarz, Joe Muskat and Tom Grey.

Tokarz recalled reading of an incident which had occurred one night in 1967 at Caledonia, a small town near Turkey Point. The group visited the witness, Carmen Cuneo, whose case was described in "Encounters with UFO Occupants", by Jim and Coral Lorenzen, (Berkley Medallion Books, New York, 1976, page 202).

Cuneo, a worker at Domtar Limited's gypsum mine, saw three UFOs, a cigar-shaped one on the ground and two discs hovering nearby. He told the investigators he had also seen at least a dozen small beings wearing miners helmets moving around near the landed object and a small creek on the mine property. He watched for ten minutes and then called his fellow miner Merv Hannigan to come out to observe the scene. When he and Hannigan came out of the mine building, the landed object and the little men were gone. But the hovering objects remained for 20 minutes in the same spot 12 feet in the air.

Cuneo also said a boom or aerial protruded from one end of the cigar-shaped object, with a bubble-shaped projection visible on its underside.

At 3:05 a.m., the two discs headed southwest toward Lake Erie flashing coloured lights. The whole incident took place in complete silence. The next morning Cuneo found a large gouge in the ground and an oil residue on burdock leaves in the area. Analysis of the oil showed it was not an ordinary type of lubricating oil.

Reptune's investigators interviewed Cuneo using a portable cassette tape recorder. When Cuneo mentioned the phone call, mysterious interference punctuated his statements, although this was only evident when the tape was played back by the interviewers. The miner's dog also howled at times during the interview which was done in the basement of his home. The interference noise sounded like a zipper being moved back and forth close to the microphone.

The following is the complete transcript of the taped interview, with all three investigators contributing questions:
 Note: The number of occupants (12) was stated prior to taping.
 "How close were you and what details were observed by you between 2:30 a.m. and 3:05 a.m., Tuesday, June 13, 1967?"

Cuneo: "It was really dark, you know and it was about 500 feet from me and then the stream was another--well, from where I stood the stream was about 500 or 1000 feet from where I was standing, but those fellows were 500 feet from me."

"Did they have any headdress on?"

Cuneo: "Yeah, they had little helmets on."

"Did you see any lights on them?"

Cuneo: "Yeah, they had little clearance lights across on top-- little wee--four lights across the top of their heads."

"What colour were the lights?"

Cuneo: "They were multi-coloured."

"What utensils, if any, were used to scoop samples?"

Cuneo: "Well, I couldn't see--it looked like they were holding something there, you know, and putting it up and taking a look at it and showing the other guy."

"What were their movements like?"

Cuneo: "They moved sort of like a robot. You know--stiff--real sharp and fast."

"Did they notice you?"

Cuneo: "Well, they did. They weren't paying any attention to me 'til I went and called that Merv Hannigan because he worked maybe another 1000 feet from where I was."

"Then did they notice you?"

Cuneo: "They noticed me. They knew I was there, but they weren't scared of just one person, eh? I went back in the building and they must have thought I was arousing somebody else. They knew I was there and actually I knew they were there."

"You saw two craft, didn't you?"

Cuneo: "Three! One big cigar-shaped and two little ones--two discs--they were sitting in the air. One big one was landed and the other two were just suspended in the air."

"How did these occupants enter and exit the craft?"

Cuneo: "They were going-- like, the craft was facing me like this and they were going in off this other side with this funny little scissors staircase--it was retractable, you know--because I went there after at the break of dawn. I could see oil spots out there and they dug into the dirt."

"Had you heard about UFOs previous to this incident?"

Cuneo: "Why, I heard about it lots of times. I always thought it was fantasy and all that."

"During your observation, did you receive any impressions or feel any particular emotions about the occupants?"

Cuneo: "I didn't even seem to be scared. You know, when I first went out there I went out to urinate. That's what I went out there for. The outhouse is too far away to go, you know. I just went out the door and I seen all these lights out there in the field about 500 feet from me. I thought maybe it was the guy at the other end--which was Syd Spring at that time--he was the leader of the crew. I thought maybe he had backed in one of those tractor-trailers there and thrown on some scraps or something. I thought 'What the hell, maybe he had spilled something.'"

"At that point, you weren't too concerned, yet you kept watching?"

Cuneo: "I kept looking at it. I said to myself 'Man alive! Well, this is not a tractor or a trailer'. --because I couldn't see the tractor out in front. All I could see was a big long thing. So I kept looking at it and, after you look at things at night for a while--after you're outside the door--you see shapes of things. So the reason I first thought it was a tractor-trailer was because the lights were dimmed right off--just little wee squares. They kept brightening up and going back and forth."

"You described portholes."

Cuneo: "They'd be those square ones like our storm window. The lights would go right up bright like that."

"Did you notice any shadows behind the portholes?"

Cuneo: "I could see shadows moving out opposite me down by the stairs there. They had a big boom on that craft, too, and a big bubble--a big stick sticking out from that cigar thing and a big globe here underneath. That thing must have protruded and then telescoped in when they went to take off."

"That boom was resting on the ground?"

Cuneo: "That was anchored on the ground--must have been sitting on legs or something."

"Where were the other two objects?"

Cuneo: "Well, the other two--the big craft would be here--the big mother craft facing me and one would be sitting up over here and another one would be sitting over here." At this point, Cuneo drew a sketch of the scene.

"Just hovering?"

Cuneo: "Just hovering."

"What colour were the craft?"

Cuneo: "They were similar in shape--sort of like silvery."

"What were the occupants' suits like?"

Cuneo: "It was so dark, all I could make out was forms--headgear. They were moving pretty well."

"What do you think they were collecting down there?"

Cuneo: "I imagine weed samples and something out of the stream. It's right at the bottom of the hill. They may have been trying to get water samples."

"After all this time, you would think that they would have finished their soil gathering experiments!"

Cuneo's reply inaudible due to some sort of interference on the tape--a noise similar to a zipper or a saw.

"What physical traces were found later? I understand that oil slicks were discovered.

Cuneo: "On a big burdock leaf, there was a--where that staircase had come out--everything has to move with some kind of oiled mechanism. It was grimy there in the morning because I went up there at the crack of dawn. I was anxious to get out. I just called for relief and went out there on the hill."

"What colour was this substance?"

Cuneo: "It was just like dirty oil from cars--like used oil." Recurrence of interference on tape here, obliterating question.

Cuneo: "Nobody paid any attention to me. No, they weren't even interested. As a matter of fact, the management of the plant came down--this was Tuesday or Wednesday--and he came down about on Friday and says to me 'I hear you seen something out here the other night' and all this stuff and I says 'yeah'. He says 'What the hell were you drinking? You were seeing things.'"

"Until one day he sees something himself!"

Cuneo: "Oh, then you gotta believe it yourself. So after I reported the story (interference here) the Sach (the Caledonia Grand River Sachem) reported it. It just exploded from there." (Interference here)

"Did any government officials visit you?"

Cuneo: "Oh, no, they never came around, but I had some threatening phone calls." (Interference here)

"From who?"

Cuneo: "I don't know. They seemed to know a hell of a lot about me."

"When did this call come?"

Cuneo: "I'd say maybe a week or so after that."

"What did he say?" (Interference here)

Cuneo: "Oh, yeah, they knew everything about me."

"What did his voice sound like?"

Cuneo: "It was a man's voice and there seemed to be a lot of motors in the background or something."

(Interference here)

Next question obliterated by interference.

Cuneo: "Sort of military voice, I thought--told me to keep quiet--knew everything about me (interference here) He asked me if (interference here) any other person had seen it. The man said they could make it hot for me if I didn't keep quiet. I'd be visited by three people in black and all that stuff.(Interference here)

"What did you reply to this intimidation?"

Cuneo: "I said 'Oh, you must be kidding.' He was supposed to make a rendezvous with me and get more stories, but he never ever did."

"Did you arrange to meet this caller?"(Interference here)

Cuneo: "He didn't name the place where to meet him and I said 'If you're that much interested and think that I should keep quiet, I want to see who you are.' And I said 'I'll meet you someplace.' He said 'Well, I'll get in contact with you again' and all this sort of thing. (Interference here)--never ever did."

"Was that your last threatening call?"

Cuneo: "I changed my number after that because I got a couple more calls."

"Similar to the first call?"

Cuneo: "I just let the guy talk when he was--well, there was the odd crank call, yeah."

"I mean the serious type of threat?"

Cuneo: "No, they didn't threaten me any more. I just picked up the phone. They wanted me to come to the phone. The person would say ' I hear you seen something.' (Interference here)

"Perhaps the same group?"

Cuneo: "Maybe somebody from this alien people. (Interference here) must of got the story, too."

"How do you think they got all this information about you?"

Cuneo: " I don't know."

"If it were the RCMP or Federal government, could they possibly have all this information about you personally?" (Interference here, blotting out the next question)

Cuneo: "Well, the only time I got scared was when the guy didn't seem to know anything about religion or nothing or the colour or pigmentation of the skin. He didn't seem to understand any of that."

"You discussed religion?" (Interference here)

Cuneo: "Yeah. He asked what nationality I was--Italian descent and all that crap. (Interference here). He asked me if I was Canadian. I said 'yeah; Italian descent '-asked if I was white. I told him 'Yes'. He didn't seem to know anything. Then he wanted to know about religions. Now at that time my mother was sick, so I told him my mother was sick. I said I didn't want to bother with him. I went on to different diseases and that. He was lost."

"In other words, these human aspects seemed alien to him?"

Cuneo: "Oh, yeah. He didn't know."

"Did you feel he was serious or putting you on?"(Interference here)

Cuneo: "No, I thought he was really serious." (Interference here)

Question not heard due to interference.

Cuneo: "Definitely."

"Did anyone attempt to explain this strange call to you?"
Cuneo: "Well, this is the same guy like I said earlier-- that in the end of the whole conversation he said he's been-- well, he knew something about Keyhoe--some Major Keyhoe. Said he was made to keep quiet and he said if he didn't-- and I kept repeating my stories and went into it any further I'd be visited by three people in black. I said 'What's that supposed to mean?' Well, he said 'I could make it hot for you.' He said 'It might cost you certain injury.' Cause some injuries to me or something or my family--sort of like a threat. I thought he was off his rocker."

"After ten years now, do you have any idea of who the caller was?"

Cuneo: "No, I have no idea because I kept quiet after that. How would he get my number in the first place? Mine's unpublished since '67 now."

"They act stupid about things like pigmentation."

Cuneo: "He didn't know anything about that. He was stupid to that effect."

"What about a topic like disease?"

Cuneo: "I told him my mother was sick--that she was--I mentioned they thought it might be something to do with cancer. He said 'Oh, what's this'and all this stuff? 'What's that supposed to mean? Is it fatal?'"

"He didn't know?"

Cuneo: "He didn't know anything about that!"

"Was the word 'time' ever mentioned by him?"

Cuneo: "Only like 'sometime' or something like that. Well, at the end of it I said 'If you're that serious I'll meet you someplace.' He said 'Well, I don't want to be put down to a certain area, but I'll be getting in contact with you again!'"

"That was the last time you heard from him?" (Interference here)

Cuneo: "Yeah, that was the last I ever heard of him."
(Interference here)

"Was there any electrical interference in your household afterwards?"

Cuneo: "Short-outs, you mean, or what? No."

"Did anything odd occur after this phone call?"

(Cuneo's dog began yelping upstairs here)

Cuneo: "Well, one time after that was sorted out, we were leaving for Burlington Beach Amusement Park. That's when our kids were small, over ten years ago. We have a kid of 20 now. So this was the summertime, too. This must have been 8:30 or a quarter to nine at night. I was just out in the front of the driveway. It had just started to get dark or dusk. This thing came right over the top of our house and circled and went that way by the lake, came back across me and made a half moon shot right over the top of our house. It was a disk shape. I said 'Look at that!'"

(Dog yelping here)

"How long was this incident after the phone call?"

Cuneo: "That'd be about a month or two after the phone call-- about six weeks."

"Was the disk very low above the house?"

Cuneo: "Oh, yeah, about as low as that water tower. No noise or nothing--just like a kite. It knew right where I was living, too."

"Did you report it immediately to anyone?"

Cuneo: "When I seen the thing go over the house?"

"No, the phone call."

Cuneo: "Well, that was serious and all I did was get on the phone. Well, I was home alone at the time and I called my wife at work. I said 'I just got a phone call from some idiot, trying to threaten me about three men in black--I have read stories like that before, you know. I know a little bit of it-- and I said 'These guys must be cranks or crackpots. What do you think we should do?'"

"A crackpot wouldn't know that much about you personally."

Cuneo: "No. He shouldn't know that much about me personally."

"Did you phone the police immediately?"

Cuneo: "After that threat? No, I didn't bother with the police. My wife suggested phoning the telephone exchange. The next day we changed ours to an unlisted one."

"Did you get any further calls?" (Dog yelping here)

Cuneo: "About that?"

"Were there any threatening calls after the number was unpublished?" (dog yelping here)

Cuneo: "No, they didn't know my number after that. Nobody did, not even my relatives can get it."

"You say an object hovered over your roof a month or so after?" (Dog yelping here)

Cuneo: "Well, it didn't hover over my roof. It zeroed in from the lake and then we were just getting into the car, had the cat and the kids in the car. I just seen this thing coming-- looked like a plane--a low-flying plane at first. It came right over the top of the house. (Dog yelping here)

"Probably a sign to let you know!"

Cuneo: "Yeah, they seemed to know where I lived all the time."

"You haven't seen anything since?"

Cuneo: "Well, I've seen the odd thing up there. Nothing that I've...(inaudible portion here).

"In other words you probably would not report it again?"

Cuneo: "Probably wouldn't report it."

"Did this caller ask you what you saw or was he aware of it?"

Cuneo: "You mean this guy that called me? He seemed to know that I was telling my story around through newspaper clippings. He seemed to know."

"Through clippings or otherwise?"

Cuneo: "Well, through me talking so much to my friends and people like that."

"Anyone else?"

Cuneo: "He seemed to know that I was mouthing off. That's what he seemed to be getting serious about or uptight. Must have been bothering him. He said 'bigger people than you have been made to keep quiet. Then he mentioned to me about this Major Keyhoe."

"There is evidence of Keyhoe having been silenced."

Cuneo: "No!, Has he?"

"Did this caller leave any name when he called?"

Cuneo: "No."

"Any name at all?" (dog yelping here)

Cuneo: "He didn't mention any names at all to me." (Dog yelping)

"Was there any background noise during the telephone call?"

Cuneo: "Well, there were noises in the background. This sounded like a long distance call. There was a lot of static and it was just like the static you hear once in a while on the line."

"They could have cut in on the line."

Cuneo: "A wind was going through the line, honing through. You could hear it. I had mentioned it to him. 'This sounds like a long distance call. Where are you calling from?' He wouldn't tell me. 'I just can't tell you that. I can't give out that information.'"

"Because the call didn't originate here. It may have been another source."

Cuneo: "Other places, I don't know. How did they ring my number through?"

"Did this caller speak with an accent?"

Cuneo: "Seemed to be a low tone of voice. And like a military voice. I wish I had that on tape so I could... "

"Robert Suffern had a similar call."

Cuneo: "Alien?"

"They don't carry out threats. The government knows what is happening." (Dog yelping)

Cuneo: "We're going to get into something like uncovering of the Watergate or something--the big-wigs kind of stuff."

"What did you discuss about religion?"

Cuneo: " Well, with these guys, they know God created the earth and he's going to destroy the earth by the year 2000.(Dog yelping) He wanted to go into the subject of religion. He didn't know much about religion. I mentioned about my father being Pentacostal. He said 'What's that?'. I said "Well, Protestant.'"

Reptune's investigators decided to have the tape of this interview analyzed to attempt to find out what caused the interference on it.

The analysis was done by Kenneth Baxter of Toronto, electronics engineer and UFO investigator. He put the tape on a test TECHTRONIC oscilloscope and came up with the following:

The onset of several of the interference patterns appeared as 'clicks' i.e. sharp cracks, as if one had kicked the table on which the recorder was placed. The recorder itself was not defective because the patterns of this interference clearly showed that the noises were fluctuating magnetic fields. Audio signals in the range of 400 to 600 cps. Passing a magnet over the tape could induce similar patterns. Baxter concluded that the superimposed noises were deliberate and electromagnetic in nature. No patterned sequence of signals was evident. He suggested that either there was a poltergeist standing in front of the microphone generating these noises or the signals were superimposed by an electromagnetic source.

As for the dog's barking, Baxter says the poodle sensed a feeling of fear in the area, causing him to yelp.

The investigators said that neither they nor Cuneo made any noise-producing movements during the interview. The tape recorder had been used before the interview with no unusual interference in previous taped interviews, nor has there been any problem since that time.

If this sounds like a rather interesting or unusual MIB case, maybe it is. Readers can add this one to their files. Reptune's investigators have speculated on the mysterious caller's identity, with guesses ranging from a Man in Black through RCMP to U.S. military to Central Intelligence Agency. We doubt if the mystery guest will sign in, so take your choice.

Note: The landing case itself was also mentioned in an article in Saga magazine in the Autumn of 1967. The authors, Brad Steiger (real name--Eugene Olsen, also known as Eric Norman and Warren Smith) and Joan Whritenour had one of the oil-stained burdock leaves from the landing site. Cuneo had drawn a sketch of the UFOs for investigators Brian Skinner and Gene Duplantier of Toronto. Olsen may have the soil analysis results and the photo of the tripod landing marks, but this is unconfirmed to date.



News Flashes . . . UFO TELETYPE

NAPANEE, ONT.

On November 19, 1976, at about 9 p.m., Brad Richmond, an RR#6 construction worker reported he observed a red massive object illuminating a large portion of an apparently deserted farmer's field. He and a friend, Brad Davey, first spotted the object at between 8 and 9 p.m. hovering over the field about a half mile from the Richmond house. According to Richmond, "it lit up an area about the size of a normal house." The brilliantly lit object of which no details could be discerned, remained in one spot for about 20 minutes and then "went out like a light." Immediately afterwards, a smaller red light 'appeared' in the same location and quickly ascended to about 200 feet before streaking north and seeming to gain altitude as it went. In about 10-15 seconds the light was lost from sight and no noise was heard during any part of the observation.

TORONTO, ONT.

David Heneman reported that on March 2, 1977 at approximately 1:30 p.m. he observed from the window of a westbound bus a large disc-like object over a condominium. The bus was stationary at the time, the driver having left the bus to take care of biological needs, and only two passengers (including Heneman) were aboard. From angular figures derived from this observation, the object is estimated to have been approximately 450 ft. above the condominium and 100-150 feet in diameter. Heneman stated that "it looked like two shiny silver plates inverted on each other." When first seen it was tilted towards him at a 35 degree angle and he noticed a whitish protrusion on top. The object then quickly accelerated to the south, presumably Lake Ontario. The entire sighting lasted about 15 seconds and we have found no corroborating witnesses.

PRINCE GEORGE, B.C.

On January 4 at approximately 11:45 p.m. several tremors were recorded in this community. Then, at 4:00 a.m. on January 5, two men in different vehicles on highway 16 encountered an unidentified aerial object and suffered a 'black-out' along with a 'time loss'. It is too early to make any conclusions but this case has all the ear-marks of an abduction and it is hoped that the two drivers will eventually consent to undergo regression hypnosis. The principal witness, who prefers anonymity due to his position in the community, was returning to Ft. St. James from Salmon Arm when he saw the headlights of an oncoming car. Above and behind the car he saw a very bright red light moving towards his truck. The light became so bright that it flooded the interior of the cab. When he was about 20 or 30 feet from the approaching car the object swooped down on him, forcing him into the lane of the other car. He blacked out at this point. After about 20 minutes he regained consciousness and found himself sitting in the passenger side of the truck with the other driver looking in. A search of the road turned up no skid marks and no damage was detected on the vehicles. Both men had seen the object and the other driver, from Prince George, had also lost consciousness. The Ft. St. James man's radio and motor also blacked out. He described the object as 'saucer-shaped' with a base like a pedestal. The main portion was somewhat oblong and the top looked similar to an egg yoke. Its size was estimated as larger than the width of the highway. The following week a landing was reported in the Nescolle Valley.


MORE...

WHITEHORSE, N.W.T.

During the week of February 12, 1977, there were many reports of UFOs illuminating the ground. Pilot Lloyd Ryder saw a bright light like "from a welder's arc" light up the entire area around where he was standing. A Wein Air Alaska pilot, flying a team of hockey players to a game, spotted a bright light above his plane shortly before midnight Feb. 10 while over Takhini Hot Springs. Two ambulance drivers, Tom Banks and Ken Schofield, claimed they were buzzed by an unusually bright and low object while on duty. On the same night Don Smith of Crowley Lake saw a large object light up the area at about 11:00 p.m. A Whitehorse Star newspaper reporter had quite an experience himself. Andy Hume saw bright flashes from his home which overlooks the cliff at Takhini Traylor court. "It was like a strobe light-very brief and intense. It seemed to come from the north, northwest of Grey Mountain, but I couldn't really pinpoint any one source of light." He went outside but saw nothing, however while going back inside the area became 'illuminated' again. The 'flap' area is triangularly bounded by Carcross, Kusawa Lake and Fox Lake. Dr. McNamara of the National Research Council in Ottawa was consulted for his evaluation of the situation. It is interesting to note that the good scientist has never deviated from his postulations since 1959, and true to form, he offered the conclusion that all activity was attributed to meteorite showers. Dr. McNamara also assured the two ambulance drivers that their harrowing experience was nothing more than the planet Venus.

MONTREAL, P.Q.

During the latter part of 1976 and early 1977, Quebec was experiencing a mini-flap similar to the 1973 wave. Thanks to the expertise and co-operation of investigator Howard Gontovnick of Chomedie, Laval, we now have the details of the roof-top UFO/occupant landing in the city of Montreal. Mr. Gontovnick advises that the investigation of this and other related events are not yet completed but the essential findings will be presented now and follow-ups will be presented as they come.




FRONT PORTION OF LANDING SITE


On January 6, 1977, at 1:15 a.m. Mrs Florida Malboeuf of Casgraine St. in Montreal, observed an 'oyster-shaped' craft land on the roof of a house across the street from her. On that night, due to a bronchitis problem, she awoke from her sleep and sat by the window. While gazing she noticed a white object coming slowly from the north, and passing over some duplexes across the street, it began to descend and eventually landed. Shortly after the object touched down, Mrs. Malboeuf said that

she observed two humanoids about 6 feet tall, wearing a tight white suit and a cap which covered their entire face (similar to a skin-diver suit), emerge from the craft. She couldn't describe any facial characteristics or the hands and feet due to the distance of the observation (60 feet). The two occupants walked around the roof as if they were looking for something, then one of the two looked up towards the sky and immediately they turned around and headed back to the UFO. As soon as the beings disappeared from her view, Mrs. Malboeuf saw the craft begin to ascend, suddenly stop, and then proceed on a straight easterly course. Mrs. Malboeuf's son Andre, learning of his mother's sighting the following day, called Dorval Airport. He was given a special number to call in North Bay, Ont. and officials at NORAD there not only confirmed the sighting but advised him that three other witnesses standing near a subway station had been startled by the same craft that morning while it travelled slowly about 60 feet off the ground. So far, attempts to obtain these witnesses' names have been futile.


Andre Malboeuf went on to the roof the following day and discovered a 15-foot circular depression of ice in the snow. Then, to his astonishment, he located footprints in the exact spot where his mother said she saw the occupants walk. Howard Gontovnick accompanied Andre subsequently for a more thorough examination and samples were gathered for analysis. Further investigations disclosed that a Mr. Dubeau had seen an unusual object in the skies at 6:20 that night coming from the north. Also, on December 26, 1976, several people witnessed a huge cylindrical craft over Montreal. The circle of ice on the roof was difficult to photograph in its entirety because of its size, and snow which by then covered the area. The well-defined footprint found by Paul Dubeau and investigator Marc Leduc was photographed and further results are forthcoming after study.

Extra _____ QUINTE mini-flap _____

Investigative reporter Robin Chase of Belleville, Ontario, reports that he has interviewed 32 persons in connection with alleged UFO phenomena and has learned of 64 persons who claim to have observed either strange lights or unidentified objects. The number includes 11 reports of unidentified objects, 14 of unusual lights, five of soil disturbances and/or effects on vegetation, and two of unknown sounds. Thanks to the capable efforts of Mr. Chase, two of the more interesting cases are presented here.

NAPANEE, ONTARIO

Beverly Mitchell, 35, a registered nursing assistant at Lennox and Addington County General Hospital, reported a disc-shaped UFO over an area of bushland just past this town's western limits on January 8, 1977. She was lying in bed reading a book at about 12:30 a.m. when a strange droning sound attracted her attention. She went to the window and saw the UFO on the north side of the road about a half mile away and about a half mile in altitude above the bush. She described the UFO as being disc-shaped, on a slight slant and rotating slowly counter-clockwise with the low-pitched drone accompanying the rotation. She described three steady bright yellow lights on its rim which were so bright they were lighting up the backyard of a nearby residence. Presumably the object was greater than 40 feet in diameter for this accurate an observation at that distance. Mrs. Mitchell watched the object moving in circles slowly, just behind the hospital property and about a mile from the Slash Road hydro substation, till about 2 a.m. when she returned to bed. She related later, "I was frightened. I got up and went to the door and turned on the outside light." Her husband was at work and her son out of town so at 2:45 a.m. she called the Ontario Provincial Police detachment at Napanee. About this time the UFO slowly ascended to a higher altitude, its lights changing to a blue colour. Constable David Willis, upon his arrival, noticed the blue light departing in the sky and told Mrs. Mitchell that he wished she had called earlier when the object had

been closer to the ground. Mrs. Mitchell learned that the OPP constable had himself witnessed a UFO while on patrol three years previous. Mrs. Mitchell also reported that she heard an identical droning sound a week after the sighting but not as loud. Her husband reported that he checked outside but could not determine the source of the noise nor could he detect any lights.

BATH, ONTARIO

Three Ontario Provincial Police officers of the Napanee detachment observed a brightly-lit UFO hovering over the Lennox hydro generating station early in January at about 2:30 a.m. Constable Miller Hodgins related that Constables Richard Fenton and Jack Reppard, while cruising in one car in the Bath area, witnessed a large bright red light which "swooped down low" over the village and then streaked upwards. They immediately radioed the sighting over the police frequency and Constable Hodgins, in another cruiser, joined them to watch the UFO. The officers watched the UFO for about 45 minutes before continuing their patrols, and during their observation, the object changed colours of red and blue with no set pattern. Constable Hodgins closed the interview with Mr. Chase by remarking "I've always thought they (UFOs) were real...they are something. There's too many people who have seen them up close." Indeed they have, and from all indications, more reports should be forthcoming in the next edition of the PULSE-ANALYZER!




I saw man from space says Ontario farmer

Robert Suffern knows he saw a being from outer space near his Bracebridge-area farm house Tuesday night and skeptics be damned.

The 27-year-old carpenter says he saw a darkened space ship sitting in the middle of a gravel road — and a figure of some kind 300 to 400 yards away while investigating his sister's report of a "glow".

Suffern, father of two young boys and a life-long resident of the farming community 13 miles north of Bracebridge, said he saw it all — near and clear.

The spaceman he saw and almost hit with his car was wearing a globe-type helmet and a silvery-grey suit.

"He had very, very wide shoulders which were out of proportion with his body," said Suffern, between in-

terviews with a barrage of newspaper and television reporters last night. The "it" was four to six feet tall.

Suffern, patient with the curious, recalled everything that happened after his sister, who lives down the road, told him about the glow. He got into his car and checked out a barn where the light had been seen and was back on the road when he saw the space ship on the road.

The space ship was saucer-shaped and about 12 to 14 feet in diameter and left no exhaust fumes when it travelled.

"I was scared. It was right there in front of me with no lights and no sign of life. I really hadn't come to a full stop when it went straight up in the air out of my sight."

Suffern said he quickly turned his car around and was heading home in a panic when the "it" walked out on

the road in front of his car. He braked and skidded and the "it" retreated over a fence into a field.

"When he got to the fence, he put his hands on a post and went over it with no effort at all. It was like he was weightless."

Suffern drove home and looking out his window, saw the space ship return, fly around a hydro pole and then disappear into the sky.

"I know what I saw and seeing is believing, but I don't care whether I ever see that creature again. He went his way and I went mine. I don't know why he landed there."

It was the third sighting for Suffern in the past two years. Two previous UFO sightings were of lights only.

Scientists and UFO researchers are on their way to his farm from as far as Chicago to follow up on the sighting.

NEW EVIDENCE **TOP SECRET**

Government/Alien Liason?

FOLLOW-UP ON 1975 OCCUPANT ENCOUNTER CASE REVEALS GOVERNMENT INTERVENTION

By October 9, 1975, all the news wire services from coast to coast had picked up on Robert Suffern's unusual experience. The media as well as UFO investigators and hordes of curiosity-seekers from all parts of North America, turned up on his farm to scrutinize and exploit the 27-year old carpenter. Most of the serious researchers came away with the facts they wanted, however little did they realize that

there was a further sequel to this case, an important event that took place after the encounter itself, a scenario that may one day prove to be more important to the UFO mystery than the October 7 landing.

On July 15, 1976, freelance cinematographer Wayne Forsyth and myself were tracking down several UFO reports throughout Ontario. Forsyth was looking for material for his documentary

film-UFO-THE CANADIAN PERSPECTIVE-and I was trying to nail down some of the more interesting and elusive reports brought to my attention. While in the vicinity of Bracebridge we decided to pay a visit to Suffern and perhaps get a follow-up on his 1975 encounter. Being familiar with the details of this case, I thought perhaps he might, instead of rehashing the incident, consent to be filmed while expressing personal opinions on UFOs he may have formulated during the time that had elapsed. Little did we realize that Suffern was keeping a closely-guarded secret all this time which was so unnerving in its implications, that it may in fact confirm the uneasy suspicion held by many throughout the 30 years of UFO investigations---that governments have not only known all about UFOs, but have actually had some alliance with these alien intelligences as far back as WW11.

Suffern and his wife were not anxious to discuss UFOs and they were in particular not enthralled at seeing the sophisticated camera and recording equipment we brought with us. Having refrained from discussing October, 1975, we apparently put his fears to rest (the media) and after we agreed to keep the equipment out of the picture, his suspicions dropped quickly and he was willing to confer. We made it clear that we were only interested in getting any new details that may not have emerged during the initial hurried investigations of the previous year. Once the Sufferns eased into the topic of UFOs, a couple of intriguing facts came to light. First, both Suffern and his wife 'believed' themselves to be totally enlightened on UFOs without necessarily attaching a lot of importance to the subject. Secondly, we discovered, they had not discussed the following matter with anyone previously, despite the

fact that they have been bargained by investigators of all types, who offered all types of hypotheses. Startling revelations were made after a 5-hour interview and although this information cannot be confirmed yet, due to 'moral obligations' as Suffern puts it, it certainly adds weight to either the 'government conspiracy of secrecy' theory or the 30 year old Men In Black problem.

On December 12, 1975, after the Sufferns were beginning to feel some semblance of order again (their farm was literally swamped for weeks by roving bands of curiosity seekers) three men were delivered to their home in an Ontario Provincial Police cruiser. The appointment had been pre-arranged in November. These officials arrived in full uniform, bearing impressive credentials and representing themselves as the TOP BRASS from the Canadian Forces in Ottawa, the United States Air Force, Pentagon, and from the Office of Naval Intelligence in Washington, D.C. Suffern, previously perturbed about the nature of his UFO encounter, claimed that ALL his questions were answered POINT BLANK and with NO HESITATIONS by these three helpful gentlemen. They 'opened the books' to him and gave him the answers to the WHERE FROM-the What & the why. They implied that the U.S & Canadian governments have known all about UFOs since 1943 and have in fact been co-operating with the ALIENS in some unknown capacity since then!

As if this wasn't enough to swallow in one gulp, the military 'know-it-alls' threw yet another curve when they made a formal APOLOGY for the

unfortunate incident of Oct. 7. They claimed it was a MISTAKE!! To which Suffern immediately thought out loud that it must have been a super-secret military craft. No, they claimed. It was a malfunction in the saucer that brought the craft down, complete with aliens, on his property. Mrs. Suffern found all this quite impossible to accept, but when she quizzed them, the officers actually came up with the exact time of the landing-to the minute-a small detail that only the Sufferns knew and had not conveyed to anyone. They have had three different UFO sightings over their property, only the last of which they reported, and again the times and dates were duly related to them by the knowledgeable trio. The enlightened agents, carrying a battery of books and data, again emphasized that the landing was an ACCIDENT and should not have occurred.

Suffern adamantly insisted that all his questions about the craft and the occupant were answered 'to his satisfaction' despite the fact that dozens of civilian investigators have visited him and offered alternate hypotheses to clear up the mystery for him. Many came close but none answered him with the same 'degree of accuracy'. At this point, our own investigation took a different turn for we felt we were being 'put on' in order to get rid of us or to test our naivety. Perhaps Suffern was amusing himself at our expense. We proceeded on a different key, with this idea very much in mind.

Robert Suffern strikes one as an individual who carefully measures his thoughts. His sincerity comes through clearly as he slowly relates his concepts and ideas. His wife, a home-bred country girl, is quick to air her views and state what she believes to be fact. This part of her nature was responsible

for the 'slip' she made in an obviously well-kept secret. Once we became alerted to the situation Suffern dropped his guard and decided to confide in us. Reluctant at first, he soon began discussing the situation seriously. He seemed genuinely concerned with our own particular concern in this matter. The less we pried, the more he revealed about the secret meeting in December. They were affirmative in their assertion that all three military personell answered all their questions with uncanny PRECISION and IMMEDIATELY. An interesting highlight prior to this meeting was that the Canadian and U.S. authorities did a thorough medical and psychological check on the Sufferns to ascertain their mental state. Only then were they judged responsible enough to be entrusted with the TOP SECRET information.

All this information seemed too cut and dry to accept as fact and in view of the fact that many UFO witnesses in the past had been duped by smooth-talking bogus officials, we suggested they had been handed a 'cover story'. This was their means of 'placating' witnesses. Granted, this was definitely a new tactic, opening the books to silence perturbed UFO witnesses. Suffern's belief could not be shaken. Furthermore he claimed that he was pleased and surprized that the Canadian officer was exceptionally informative on UFOs, having spoken more than the American counter-parts. The Sufferns deny that they are under the 'Secrets Act', however they intend to keep all details secret for 'moral reasons'! They simply want to keep their 'part of the bargain' by complying with the government's wishes. At this junction a thought came to mind.....

PLANNED LEAKS?...am I the unwitting victim this time? As I report this information in this journal, Suffern could be busy denying it. Walter Cronkite pulled the same 'about-face' after discussing his intimate knowledge of NASA's UFO files!

Further along we learned that the military still refer to UFO occupants as 'humanoids'. Contact was apparently made in 1943 and now our forces are aware of the alien's movements on this planet. We now know that governments no longer have any interest in investigating sightings or landings. In fact, most of the time they do not even go through the motions any more. Could this be relevant?

An interesting sidelight to this scenario is that although the Sufferns have been offered a small fortune in return for their exploitation by various media, the U.S.A.F. Lieutenant advised them to refuse all offers. Of course this was after they were filled in about the government's knowledge of alien intelligences. In reply to my

question about officialdom's secrecy policy, he said there would be many 'disappointments' on this planet. As to the identities of the three agents, Suffern claims that he can prove these visitors were not imposters...or M.I.B. In fact he has been threatened before, by phone calls and two visitors whom he ejected from his farm.

The critical key to Suffern's encounter is the fact that he had a 'near-miss' car situation with a physical entity, dressed in a one piece silver suit and short in stature. If contact indeed has taken place then there could have been serious repercussions, had he actually run the being down. This could account for the military's intervention and unusual frankness. If it is a new C.I.A. ploy or M.I.B. caper of 'satisfying' the witnesses instead of threatening them it certainly achieved its goal.

In any event, the Sufferns are no longer puzzled about their three UFO sightings and perhaps one day the need for public truth will override the 'moral obligations' clause!
