# UFO Dictionary

Here is the tenth part of the UFO dictionary. In this issue I will try to explain some of the special UFO words, terms and abbreviations starting with the letters "K" and "L".

## Kingman Incident

A possible UFO crash and recovery took place 1953 near Kingman, Arizona. However, the case is considered as a hoax by many researchers today.

## Kirtland Air Force Base

An Air Force Base in Albuquerque and also home of the Sandia Laboratories which are involved in secret weapon research projects of the U.S. government.

## Lubbock

A town in Texas where a series of UFO sightings occurred in 1951. The so-called "Lubbock Lights" were later explained by sceptics as simple light reflections on the clouds.

## Lunar Transient Phenomena

A term describing unidentified lights sighted on the moon (usually inside craters.)

## Langenargen Case

A famous German UFO case from 1977, involving a possible close encounter of the third kind. Langenargen is the name of a town on German Lake Bodensee where the sightings occurred.

## The Simplest Explanation

Do UFOs come from outer space?

Some of you are maybe familiar with the term "Occam's Razor". According to Paul Dickson's "The Official Rules", the original Occam's Razor (named after William of Occam, who said it in the 14th Century, so needless to say this is a translation) is "Entities ought not to be multiplied except from necessity". This has been restated in numerous ways, much as the original Murphy's Law has been modified to something simpler, and the most common version

**"The simplest explanation is probably the correct one"**

is a simplification of the original (effectively applying Occam's Razor to itself); another version is

**"When two or more hypotheses serve to answer a theory, use the simplest"**

When I read this explanation for the first time, I thought that it should be possible to use this "rule" to find the correct explanation for the UFO mystery. When we have a look at all the various explanations and theories during the last 60 years which try to explain the UFO mystery, and if we try to delete those explanations which seem too far-fetched or too unlikely, the remaining theory should be the simplest and, therefore, the correct one. It should be the truth. But is it really that simple? Let's try it.

The following is a list of the most common theories about the origin and nature of UFOs:

- UFOs are some kind of solid ships from outer space and piloted by extraterrestrial beings.
- UFOs are some kind of solid ships coming from inside the earth and piloted by an ancient human race.
- UFOs are some kind of solid ships coming from under water and piloted by an ancient human race.
- UFOs are some kind of non-solid "projections" coming from another dimension.
- UFOs are some kind of non-solid "projections" coming from our own future
- UFOs are secret human/military flying devices.
- UFOs don't exist; every object in the sky can be identified after a certain period of time.

Which one of these theories is now the simplest, the most likely, the correct one? Let's have a closer look to try to find an answer.

## UFOs are extraterrestrial ships from outer space

The most common theory, the so-called ETH (Extraterrestrial Hypothesis) is mainly based on the fact that some observed UFOs seemed to accelerate with high speed into the sky or into orbit, and that outer space seemed to be their destination and origin. Furthermore, the first people who claimed to have met beings from inside the UFOs (in the 1950s the contactees like George Adamski, later the abductees like Betty and Barney Hill) also claimed that the "UFO pilots" had definitely **confirmed** that they really come from outer space, usually from **well-known** star constellations like Sirius or Vega.

There were at least two major theories when the first modern UFO sightings occurred in the U.S. in 1947. The first theory was that UFOs are a secret weapon, most likely Russian. The second theory was the above mentioned ETH, the idea that UFOs come from outer space. This one became the favourite, especially when people noticed that no human technology - neither American nor Russian - would be able to do such things (e.g. extreme acceleration). The ETH was shown in various famous science fiction movies in the early 1950s and more and more people started to consider the word UFO as a synonym for an extraterrestrial spaceship. By the way, one of these early movies was "The Day the Earth stood still" where we see an examination room and table inside a circular UFO. Many sceptics later said that some of the stories about certain abductees are just "copies" of what they saw in this and other movies. The role of "Flying Saucer" movies in the early 1950s is a difficult one and it's not easy to say whether the reality copied the movies or the movies copied the reality (in order to make UFOs seem like science fiction?)

Whatever, the ETH is clearly a product of the 20th century - undoubtedly a product of reality **and** of fiction. It may answer some questions but the theory itself is pretty incomplete and leaves many questions partly or fully unanswered, such as:

- "If UFOs really come from outer space, how are they able to travel the tremendous intergalactic distances against all physical laws. How can they produce the large amount of energy which would be necessary for intergalactic travel?"
- "If UFOs really come from outer space, why have they been visiting Earth for thousands of years? What do they want, what kind of project could justify such a long-time-examination?"
- "If UFOs really come from outer space, why do people describe so many kinds of UFOs and also so many different kinds of beings. How many races visit Earth, and again why and since when?"
- "If UFOs are really solid spaceships, why do they behave sometimes more like ghosts or projections?"
- "Why do the extraterrestrials often claim to come from well-known star constellations like Sirius or Vega? Why do they tell such weird stories to the contactees/abductees?"

You see, even the famous ETH does not seem to be the simplest explanation, because it leaves too many questions unanswered, and it can't explain many of the cases. However, some corrections and additions - like the idea that the human species was created by extraterrestrials - could help to answer some of the above mentioned

questions, but the ETH in its current form is unable to explain the UFO phenomenon completely and satisfactorily.

## UFOs belong to an advanced species living on our own planet

This explanation includes the theories which see the origin of UFOs either under the earth, beyond the sea, or hidden somewhere in remote regions of our own planet (like the polar regions.) It also includes the strange theory that there is a Hollow Earth and a second Sun inside our planet. The beings inside the UFOs in such theories aren't extraterrestrials from outer space, but either advanced human beings belonging to a million year old race of people or non-human reptilian beings which have evolved from the dinosaurs and which are usually hostile against the human species.

The theory that there is a Hollow Earth is indeed pretty ridiculous and mainly based on simple legends and a few pseudo-proofs without any real meaning. To give you a short example: when you ask such strong believers how the sun inside the earth should be able to produce light and heat by fusion with such a small mass, they reply that the inner sun isn't made of hot gas but of crystal (by the way, all stars in the universe are made of crystal and the scientists and astronomers lie to us - at least according to such theories.) Another possibility would be, that there is no real Hollow Earth but just some very large caves or caverns, and that advanced races live there in subterranean towns and the UFOs come from there (according to some famous legends, major subterranean sites can be found under Mount Shasta in the U.S. and under the entire Himalaja Mountains in Asia.) However, I already mentioned my doubts about such stories in my sceptical comment about the "Lacerta File". If there would be really such large caves at such a depth, the weight of the stone above would undoubtedly crush them.

The theory that UFOs come from beyond the sea is also without any proof, but we have at least some interesting incidents where UFOs were observed while either diving into the ocean or appearing from there and flying up into the sky, so this theory can't be dismissed completely. Maybe there are really UFO bases beyond the sea but nobody can say whether these bases were built by some ancient human race (like the civilizations of Atlantis or Mu or of some other well known lost continent as some legends claim) or by extraterrestrials who simply hide beneath the sea, so we are again back to the ETH and to the old problems and questions connected with this hypothesis (see above.)

However, the assumption that UFOs belong to a species which is native to our own planet would be able to answer one important question, namely "Why have UFOs been observing us for such a long time?" because the simple answer would be "They don't observe us, we just live by pure chance on the same planet." But this theory is again unable to answer an awful lot of questions connected with the phenomenon and especially the many scientific errors and weird claims which make the theory rather unbelievable for many serious researchers, except for a couple of very strong believers. We can say one thing for sure: it is definitely not the simplest and most likely explanation.



Or do UFOs come from beyond the sea?

## UFOs are non-solid projections

This explanation includes the theories which see the origin of UFOs either in another dimension or in our own future. UFOs are considered in this theory not as solid objects made of metal or some other material, but as some kind of non-solid and "holographic" projections which are not really part of our reality. The beings inside the UFOs are also not extraterrestrials, but either entities from another dimension or humans from the distant future (the "Grey" species as an advanced stage of human evolution?)

This is a pretty interesting theory and it's not as far-fetched as it may first seem. We have indeed some strange cases where UFOs and even "alien beings" appear as non-solid or ghost-like appearances, and where witnesses walk straight through nebulous UFOs or beings (the UFO sightings in the British Warminster area in the 1960s are a good example). We also have cases where UFOs seem to enter our world through some kind of "gate" or "black hole" in the sky. In addition, such a theory could also explain why UFOs are able to behave contrary to all physical laws, because as projections they wouldn't be part of our world and our system of physical laws. And it would again answer the question "Why have UFOs been observing us for such a long time" because as dimension- or timetravellers, UFOs would be able to appear not only **wherever** they want but also **whenever** they want.

However, this theory also has its problems. When UFOs are projections from other dimensions or from the future, why do they appear in so many forms, why do people describe so many kinds of beings, why are some UFOs definitely made of metal or another solid material which leave traces on the ground. Why do they bother to fly around our planet if they are able to "appear" at certain times and places whenever they want? What about the physical and logical problems inherent in timetravelling (paradox)? Finally, why do people claim that beings from inside UFOs told them that they come from outer space? The theory is again not perfect and it's also not the simplest explanation, especially because of the tremendous scientific problems inherent in the assumption that interdimensional travel is really possible.

## UFOs are secret but human/military flying objects

This is a theory which assumes that nearly every sighted UFO is a flying object which belongs to the military of some country (a skeptical approach). It seems to be

"unidentified" for the normal witness, but is, in fact, something from our own planet, manufactured by humans without any involvement of alien forces.

Many UFO sightings in the 1950s were later identified by the Air Force as sightings of secret U.S. spy planes which were tested in the Southwest of America without the knowledge of the people in this area. Even today many people mistake military operations as UFO activity (especially people who "want to believe" everything). The famous "Area 51" in Nevada is a good example, because many test planes like the mysterious "Aurora" or the Stealth Bomber can be seen in the sky over the test site as well as normal jet planes with unusual lights during maneuver operations or green and yellow lightflares and so on. Many inexperienced visitors mistake such objects as UFOs, often "confirmed" by self-styled local guides who want to make easy money from such believers.

Unusual military operations or secret flights of new test planes have always been a source for UFO sightings and many believers often refuse to accept simple explanations, but prefer to see extraterrestrial or interdimensional "ships" in the sky. But can this really explain everything? Can it explain UFO sightings where UFOs behaved contrary to all physical laws? Can it explain sightings in former times? Can it explain sightings in areas where it seems to be very unlikely that secret military planes or other projects are responsible (like the triangle UFO sightings in Belgium 1990). Can it explain the entire abduction phenomena? No, it can't. Some percentage of UFO sightings (even of the officially unidentified) can be explained with secret military flying objects, but definitely not all.

## UFOs don't exist

This sounds, at first, similar to the last theory but it's not exactly the same. If we assume that UFOs don't really exist, that they are a product of science-fiction-writers and "crazy believers", we must also assume that every sighting is explainable somehow. This involves not only secret military planes, but everything that can be mistaken for a UFO. UFOs are not mysterious objects but merely comets, planets, shooting stars, weather balloons, light reflexions, strange weather phenomena, lightning and, last but not least, simple hoaxes (to give just a few examples.)

To say it in the words of the sceptics: UFO means simply "Unidentified Flying Object" and this term has nothing to do with any unscientific theory involving extraterrestrials or timetravellers or some other "crazy" stuff. UFOs are maybe unidentified for a certain period of time, but they will sooner or later be identified as something normal and explainable. There **was** no UFO mystery, there **is** no UFO mystery, thus every other explanation is completely senseless.

Are they right? Can everything be explained in this way? All the thousands of sightings by both, inexperienced and experienced witnesses (like pilots or astronomers), all the photos, films, physical traces? Are all UFOs simple misidentifications? I think we can clearly say "No".

## Conclusions

To come to an end: which one of all these theories is now the simplest and according to "Occam's Razor" the correct one? Are UFOs extraterrestrial ships, flying devices of an

advanced human civilization, interdimensional or intertemporal projections or are UFOs a simple myth created by some wacky believers?

Most of the sceptics would say that the last explanation is definitely the simplest and, therefore, the correct one, because it conforms with our scientific view of the world. But is this true? We must ask: what are the criteria for "Occam's Razor", what are our criteria for simplicity? Is the most simple explanation always the explanation which conforms with our science? Is the most simple explanation always the explanation which most of us would like to hear?

Each of the above mentioned theories has its advantages and disadvantages, and not even the ETH can give us a complete explanation of the entire phenomenon. Maybe the final truth about UFOs will contain parts of not just one, but of several theories, maybe also of some we haven't discovered yet.

Which one is the **simplest**, the most **likely**, the **correct** explanation? Not even "Occam's Razor" can help us solve the UFO mystery, at least not with our current knowledge. The only thing we can do is to continue with our research, to add new knowledge to old theories, and to find new theories. As long as we do this, there is hope in finding the correct explanation - the truth - one day. As a final thought: maybe the correct explanation is so simple that we don't see it? That's something we should think about.

## Visitations -- The Strange Experiences of Philip K. Dick in the 1970s

*Remark by Chris: in the following you can read an article about the very strange experiences of author Philip K. Dick. The article was written by his former wife Tessa B. Dick and sounds rather unbelievable. Some of you will certainly think that such a strange and bizarre story can't be true and even I had such sceptical thoughts when I read it for the first time. However, I'm not familiar with the case and thus I can't say whether these things have really happened or not or whether they have happened in reality or just in imagination. To be honest, I'm rather sceptical, but I've read it with an open mind and I'm looking forward to further parts. Feel free to send me your opinions about this article.*

*Personally, I've found the part about the electromagnetic influences very interesting but it's too early and I have not enough information to theorize already now. When I asked the author if there were any powerful transmitters near to the apartment, she said that there was just a student radio station with very little power, so I think there was no strong electromagnetic pollution which could explain certain phenomena (for example by use of Albert Buddens theories.)*

"Am I crazy?" I can't even count the number of times Phil asked me that question. I always figured that he probably wasn't crazy, as long as he could ask that question. Others were not so kind. I've kept silent for almost twenty years because I don't like being regarded as a "crazy". Besides, most people won't even listen. Yet the experiences that I shared with my late husband, SF writer Philip K. Dick, have continued to haunt me. Many self-styled experts (who met him only once and spent less than one hour with him), and even a few of his close friends, have dismissed Phil's experiences as the ravings of a madman, saying that he was manic-depressive--as if that explained everything, or as if it explained anything at all. Phil might have been bipolar (the current term for manic-depressive), but that does not explain the visitations that we experienced in the mid-1970s and early 1980s. At this point, the skeptics fall back on the idea of co-dependence, or folie a deux, which basically states that I caught the madness from Phil in the same way that one catches a cold. This does not explain anything, either.

For one thing, I had similar experiences before I ever met Phil, and he had similar experiences before he ever met me. In addition, we had some physical evidence of the strange phenomena that happened in and around our apartment in southern California in 1974 and 1975. For example, one afternoon a yellow van pulled up and parked in front of our apartment complex one, and three men in gray overalls stepped out of the van and went into the vacant apartment next door to ours. They carried large metal suitcases, spent about an hour in the empty apartment, and then emerged with the same metal suitcases and left in the same yellow van. Several weeks later we found the door to that apartment open, so we went inside. We found a working telephone in the kitchen, and some kind of electronic equipment which had been set up inside the hall closet. Perhaps this does not have anything to do with UFOs, but then again, maybe it does.

Our radio had been behaving strangely. Sometimes it came on when we were sure that we had turned it off, and several times we could still hear it, even after we unplugged it. I couldn't make out what the radio was saying, but Phil was certain that it was telling him that he was a horrible person and he should kill himself. Strange electrical phenomena occurred all the time in our apartment. Strange people seemed to be keeping us under surveillance. Strange voices spoke to us.

All the while, we were trying to put the finishing touches on Phil's novel, *A Scanner Darkly*. It was based on split-brain research, which showed that the two hemispheres of the brain, left and right, are capable of acting as independent persons. In patients who had the corpus callosum severed in order to alleviate severe epilepsy, these two "persons" often had no knowledge of each other's activities. The corpus callosum is the communications center which allows the analytical left hemisphere to consult with the intuitive right hemisphere when observing the environment, analyzing data, and making decisions. The title of the novel comes from St. Paul, who wrote, "For now we see through a glass, darkly; but then face to face: now I know in part; but then shall I know even as also I am known" (1 Corinthians 13:12, King James Version). To elucidate,

"through a glass, darkly" may also be translated "through a mirror, in a mystery". The protagonist of the novel, a police detective named Bob Arctor, uses scanning devices to conduct surveillance on suspects. When he sees his own image "reflected" in the scanner, he does not recognize himself.

Now, after this brief side-trip, let's get back to the mysterious events. Phil became suddenly ill and did not get better. At one point, when Phil insisted that he wanted the last rites, I called the local Episcopal priest, who came to the house and gave him a healing unction. When Phil finally went to the doctor, he learned that his blood pressure was dangerously high. Several months later, he was hospitalized for several days while they tried to bring his blood pressure down to a safer level. He suffered from hypertension for many years, and this condition had prevented him from participating in the Korean conflict in the 1950s. In the midst of his illness, Phil had a healing vision. He was lying in bed, staring at the blank white wall, when a rectangle of bright pink light appeared on the wall. It opened like a doorway, and our recently deceased cat stepped through the door and into the room. Our cat, Pinky, was walking upright on his hind legs. He stepped around to the side of the bed and patted Phil reassuringly on the shoulder. Then Pinky stepped back out through the doorway, and the luminous pink rectangle faded, shrank and disappeared.

This could have been the fevered vision of illness, or the hallucination of insanity, but then subsequent events made it seem more like a meaningful coincidence of the sort that C.G. Jung discusses in his writing about synchronicity. About two weeks later, in the course of an argument about something trivial (which I do not remember), Phil picked up a small seashell and threw it against the wall. I remember thinking it odd that I heard the sound of the shell breaking before I saw it hit the wall. The sound that I heard was actually Phil's shoulder dislocating. It was the same shoulder which Pinky had patted when he appeared through the pink doorway.

We began to catch brief glimpses, at the edges of our peripheral vision, of people in our apartment. They were strange-looking people, with small chins and long foreheads, like the famous Egyptian busts of Akhenaton and Nephretiti. Akhenaton was the pharaoh who introduced the worship on one God into Egypt. Phil began to lapse into a Christian heresy, a sort of dualism. He believed some of the ideas found in Manichaeism, as well as some ideas of his own. Basically, this heresy states that there are two gods--a good god and an evil god--and that the evil god made us, but the good god is trying to save us. As a scientific agnostic, I had little objection to his seemingly irrelevant detour. Meanwhile, the people began talking to us. Phil thought that they could tell him the secrets of the universe. I was hoping that they could explain the implant in my spine.

Since my early teens, I have had a small metallic sliver in my lumbar spine. I don't know how it got there, or whether it serves any purpose. I don't want it removed because of the obvious risks of surgery on one's spine, and besides, it doesn't give me any trouble. What does trouble me is that I knew about it before I ever had any X-rays of that area of my body. In fact, I remember many strange things from childhood, such as people visiting me when I was alone in my room, taking me for rides on space ships, giving me tests, and teaching me things. I have always remembered these things, and I have never had any help from a hypnotist. However, I have a strong feeling that I am not supposed to remember, and when I try to describe these experiences to other people, something stops me.

I do not believe that I was abducted by space aliens. In fact, I believe that the US government did a secret study of me and about a dozen other second-graders, beginning in 1961. Farragut Elementary School in Culver city, California. was designated experimental in 1961, as part of President Kennedy's education agenda. Fourteen second-graders, including me, were put into a combination class with third-graders. I remember almost nothing about the entire school year, except that every day we would be sent out of the classroom and into the school auditorium for an hour or two. I don't remember what happened there. I do get bits and pieces of it in dreams from time to time, but they don't make much sense. I can tell you the names of all my teachers from Kindergarten through the sixth grade, except the name of my second-grade teacher. I can name all of the girls in my Scout troop, plus many of my fellow students in elementary school. But I cannot tell you about the second grade. All I know for sure is that we learned to say "bon jour" and to count to ten in French, and that I failed arithmetic. When several of our families moved across town, the principal from our school was transferred across town to Culver Elementary (now named Lynne E. Howe Elementary, after the same principal), and our new school was designated experimental.

Phil had been one of the subjects in a famous longitudinal study of gifted children that was conducted by university psychologists. They lost track of him when he was a young adult, and he was quite happy to be out of the study. But the study that was conducted on me and my classmates was of a different nature. For one thing, it was clandestine. For another, it had something to do with long-distance space travel on huge ships with large crews, at the time when the Mercury program was just beginning to send men up into space, one at a time, for a few hours at the most.

So it seemed quite normal to me, in the 1970s, that alien people should come down and visit us in our apartment in southern California.

## Nothing To Fear But Fear Itself

Investigating anomalous flying objects (UFOs) has an extremely important aspect attached to it, one that is so crucial it is essential before any investigation can begin. The witness must be willing to tell the investigator what was observed; in other words, file a simple report. As basic as this seems, it is very often the stumbling block to pursuing a sighting which may have tremendous potential.

Over the last couple of months I had two instances where friends told me they knew someone who had a recent sighting. In each instance, after hearing what was seen, I

asked if they would be kind enough to contact the individuals involved, give them my phone number (and/or business card) and ask them to give me a call. I insisted that the witnesses be told "all information will be held in the strictest confidence." Unfortunately, I never received the awaited phone call.

After more than fifty years of UFOs being officially reported in this country, there is still a high degree of ridicule attached to the phenomenon. The ridicule is, more often than not, imaginary, yet this doesn't deter a witness from not reporting what was seen. With more UFOs being observed worldwide than ever before, one would think that we should have overcome the "laugh-ability factor" a long time ago. We have not.

Something in the human makeup has taught us to feel comfortable in our beliefs and resist change at all costs. This concept hasn't fluctuated much as far back as man has been keeping records. Paradigms (or ways of thinking on a particular subject) are difficult to break. Galileo encountered this with the revolutionary (but factual) theory that the earth revolves around the sun. On a lesser scale, The Wright brothers were exposed to ridicule every time one of their "airplanes" failed. "If man was meant to fly, he'd have wings." And of course we need to remember the once widely accepted notion that the world was flat, and if one sailed too far from the sight of land it would mean utter destruction.

Today we are faced with the new paradigm that we earthlings are not the only intelligent life in the universe. The old argument is the same as with any degree of non-acceptance of a new idea: the other planets in our solar system are not hospitable to life. This is one statement that is often used to refute the possibility of life. Yet, my original statement was based on the "universe" and not limited to our solar system. Those who resist change will often argue from a very particular point of view . . . in this case the solar system. It may very well be true that intelligent life would find difficulty existing on one of our nine planets other than Earth. However, the same argument doesn't hold when we expand the possibility to ANYWHERE in the universe.

The other argument which is commonly used is "If there is intelligent life out there, it couldn't possibly get here from there. The distance is just too great." Again, the assumption that we know all the physics there is to know, and we possess all the knowledge in the universe. It is refreshing to recall that this statement comes from scientists who told us a few years ago that eating eggs is bad for us. Today the same scientists say they may have been wrong and eggs are OK, as long as we don't overdo it. Of course, the point is we really don't have all the answers, and just because our present way of thinking tells us that extreme distances in space travel are impossible, that doesn't make it so, in actuality.

With the Hubble telescope exposing our eyes to billions of galaxies we have never seen before, and each of those galaxies containing billions of stars of various sizes, the possibility of no other life except that on earth becomes ludicrous. Further, life on earth is relatively young. If life existed "out there" thousands, millions or even billions of years before us, the possibility becomes more tenable that intelligence exists greater than we can imagine.

Herein lies the rub. We humans see ourselves from an extremely narcissistic point of view. We believe that we are not only the epitome of creation, but also the most intelligent. We can't see anything except our own reflection. Unfortunately, what we may believe to be true stands in the way of our arriving at what may be reality.

Change involves fear of the unknown. Fear must also be dealt with in some way as we resist the change ... the change that makes us uncomfortable. One way to resist change and deal with our fears is to laugh at anything new. Ridicule is a powerful tool in keeping things status quo. What better way to resist the concept of extraterrestrial intelligence, aliens, UFOs, than to laugh at those who claim to have seen these otherworldly entities and objects. It seems to be working well, for as I stated previously, it still keeps witnesses from reporting anomalous events and consequently hindering investigation.

Truth will always prevail. Although there are many witnesses who remain silent out of fear, there are many who are able to conquer their anxiety and report what they have seen, regardless of consequences. If extraterrestrials are visiting us, concealing the evidence will not change that fact, anymore than ignoring an illness will make it go away. Sometimes we must face truth square in the face ... stand eye to eye with what seems impossible, and accept what may very well be not only possible, but probable. UFOs are the next challenge. They are the modern day paradigm shift which must be dealt with in a positive manner without fear of reprisal. As investigators seeking the truth, it is important that we help dispel the fears in reporting anything unusual.

Let us become worthy of the public trust. Let us respect the witness and seek the truth.

At 10:45 PM on the evening of July 11, 1947, Clark [REDACTED] of the Washington Field Office called and stated that at the instruction Mr. Hennrich he wanted to pass on to the Bureau information he had just received from one [REDACTED] Laurel, Maryland, to the effect that a "flying disc" had just landed in [REDACTED] yard and the machinery is still buzzing." [REDACTED] stated [REDACTED] was apparently so excited he had a difficult time even getting his name out, and no further detail could be obtained from him.

At 10:50 PM I passed the above information on to [REDACTED] duty office at G-2 who indicated he had also received the same data from another source, and would pass our information along to appropriate army quarters.

[REDACTED] of the AP called at about 10:55 PM and asked whether the Bureau had received any report on a "flying disc" in Laurel Maryland. After checking with Mr. Nichols I told him we had received such a report and had passed it on to army authorities.

Reference is made to [REDACTED] memorandum to you dated July 11, in the above-captioned matter.

At 11:55 P.M., July 11, I took a phone call from [REDACTED] of the Laurel, Maryland, Police Department. Sergeant [REDACTED] said that he had examined the "flying disc." He said that it had been made from a Gulf Oil sign and the top of a garbage can and had been painted with aluminum paint. It had been recently painted because the paint was still wet. Attached to it were a dry cell battery, a flashlight bulb, some wires and a buzzer. He asked if the Bureau was sending anyone out to look at it. I told him that we were not, that we had referred the matter to the Army, and suggested that he call them.

I subsequently telephoned Captain [REDACTED] the Duty Officer at G-2, and passed on to him the information furnished by Sergeant Lons.

# The KRILL papers (Part 7)

Alien anatomy - or just a fake?

*Remark by Chris: in the following text you can again read some "true" information from the KRILL papers, this time about the mysterious Men in Black and about the physiology and anatomy of the Grey species. You know my usual comment: the story is rather weird and difficult to believe, but maybe there is a small true core. Please make your own opinion. By the way, the Maury Island case which is mentioned in the text as real UFO incident was most likely a hoax.*

## The Men in Black

All things considered, UFO research has become pretty much of a circus today, and the most intriguing and controversial sideshow skirting the edges is the question of the "silencers," or the mysterious "Men in Black." There is a strong subliminal appeal in these accounts of visits by mysterious dark-suited figures (I have been visited myself, as have others I've known) attempting to silence UFO witnesses. A typical situation would be that a witness has a UFO sighting or UFO-related experience. Shortly thereafter he is visited by one or more "odd"-looking men who relate to him the minutest details of his experience, even though he has as yet told no one for fear of ridicule or other reasons. The men warn him about spreading the story of his experience around and sometimes even threaten him personally, sometimes obliquely, sometimes directly. Any evidence, if it exists, is confiscated in one way or another. Sometimes the visit is for some totally meaningless reason and the subject of UFOs is hardly mentioned, if at all. But again, the men all seem to look alike.

We actually seem to find ourselves in close proximity to beings who obviously must be directly connected in some way with the objects themselves or the source behind them, yet they seem to be functioning unobtrusively within the framework of our own everyday existence. The classic conception of an MIB is a man of indefinite age, medium height and dressed completely in black. He always has a black hat and often a black turtleneck sweater. They present an appearance often described as "strange" or "odd." They speak in a dull monotone voice, "like a computer," and are dark-complected with high cheekbones, thin lips, pointed chin, and eyes that are mildly slanted. The visitors themselves are often on absurd missions. They have reportedly posed as salesmen, telephone repairmen or representatives from official or unofficial organizations. Their mode of transportation is usually large and expensive cars -- Buicks or Lincolns, sometimes Cadillacs, all black, of course. I might note at this point that their physical appearance also has included beings that have pale-greyish skin, and that some of

them have been seen to have blond hair, yet they wear the clothing and drive the cars previously described.

Their cars often operate with the headlights off, but ghostly purple or greenish glows illuminate the interior. Unusual insignia have been seen emblazoned on the doors and the license plates are always unidentifiable or untraceable. The fabric of their clothes has been described as strangely "shiny" or thin, but not silky -- almost as if they have been cut from a new type of fabric. Their often mechanical behavior has caused them to be described by some as being like robots or androids (think back to the Dulce lab). A lot of descriptions of some of these "folks" are pretty bizarre. A businessman's family in Wildwood, New Jersey, was visited by an unusually large man whose pants legs hiked up when he sat down, revealing a green wire grafted onto his skin and running up his leg. There are other cases of MIB appearing on the other side of a wet, muddy field after a heavy rain, but having no mud whatever on their brightly shined shoes and in the bitter cold, out of nowhere, wearing only a thin coat. Their shoes and wallets all seem new and hardly broken in. They are not alone. They seem to have faceless conspirators in the nation's post offices and phone companies. Researchers and witnesses often report their mail going astray at an unusually high rate and being bothered by bizarre phone calls where they are spoken to by metallic, unhuman-sounding voices. Unusual noises on the phone, intensifying whenever UFOs are mentioned, and voices breaking in on conversations, have all led many people to suspect that their phones are being tapped.

One can't discuss the MIB for long without mentioning the name of John A. Keel, an author who has written much about them. Keel has done more than any other writer to publicize this bizarre aspect of the UFO situation. Keel suggests that the UFO are part of the environment itself and come from another time-space continua; that most of the UFO phenomena is psychic and psychological rather than physical. Well, I personally would not define it that way, although those two components are certainly deeply involved in what's going on. The first noted appearance of the MIB was in 1947, at the scene of the Maury Island incident, where some debris was ejected from a disk, and subsequently recovered by officials, who loaded them on an Army bomber which crashed on takeoff. To illustrate a little how bizarre some of the incidents are regarding the MIB, I have assembled a short list of some of the more interesting factors in some cases:

- An ex-Air Force man is gassed and interrogated by MIB after he has learned classified NASA secrets.
- Closeup photos of UFOs were seized from a teenager who is also directly threatened by MIB.
- MIB sighted in the lobby of the U.S. State Department leave a mysterious artifact.
- MIB pose as Air Force officers to silence witnesses.
- MIB tries to buy before-hours Coke and sings to birds in trees.
- MIB disintegrates a coin in a witness' hand and tells him that his heart will do the same if he talks

Throughout all this information, I have neglected to mention some aspects of the psychology of the Greys. Dr. Paul Bennewitz, in his original report to the government entitled "Project Beta," goes into some detail, which I will now discuss:

- The alien, either through evolution or because the humanoid types are "made," will exhibit tendencies for bad logic.
- They appear to have more frailties and weaknesses than the normal Homo Sapien.
- They are not to be trusted.

Because of the aliens' apparent logic system, a key decision cannot be made without higher clearance. All are under control of what they call "The Keeper," yet it would appear that even this is not the final authority. Delays as long as 12-15 hours can occur for a decision. Because of this apparent control, individual instantaneous decision-making by the alien is limited. If the "plan" goes even slightly out of balance or context, they become confused. Faced with this, possibly, the humanoids would be the first to run.

- Psychologically their morale is near disintegration. There is pronounced dissension in the ranks -- even with the humanoids.
- Because of their own internal vulnerability mind-wise to each other, there is a basic lack of trust between them.
- They appear to be totally death-oriented, and because of this, absolutely death-fear oriented. This is a psychological advantage.
- The prime, and weakest area discovered, probed and tested is exactly what they have used, thinking it their key strength - that being the manipulation of and control of the mind. Manipulated in reverse-psychology they face a situation where they have a vulnerable, integrated weakness.
- They totally respect force.

## Grey Physiology and Anatomy

The approximate height of most specimens is between 3.5 and 4.5 feet. The head, by human standards, is large in comparison with the body. Facial features show a pair of eyes described as large, sunken or deeply set, far apart or distended more than the human, and slightly slanted as Oriental or Mongoloid. No ear lobes or apertures on the side of the head were seen. The nose is vague. One or two holes have been mentioned. The mouth area is described as a small slit or fissure. In some cases there is no mouth at all. It appears not to function as a means for communication or for food. The neck area is described as being thin, in some instances not being visible at all because of the tightly-knit garment. Most observers describe these humanoids as being hairless. Some of the bodies recovered have a slight hair-patch atop the head. Others have what appears to be like a silver skullcap. There were no breathing attachments or communications devices. This suggests telepathy with higher intelligence.

In one instance there was an opening in the right frontal lobe area, revealing a crystalline network. This network implies the development of a third brain. The arms are described as long and thin, reaching down to the knee section. The hangers each contain four fingers, with no thumbs. Three fingers are longer than the other. Some are very long. Some are very long. Others are very short. No description is available of the legs and feet. Some pathologists indicate that that section of the body was not developed as we would anticipate, showing that some of these beings were adapted to life in the water. There was a webbing effect between the fingers on most of the specimens. According to most observers, the skin is grey. Some claim it is beige, tan or pinkish-grey. No reproductive organs or capabilities were discovered. No phallus. No womb. Confirms cloning mentioned by other sources. The humanoids appear to be from

a mold, sharing identical racial and biological characteristics. There is no blood as we know it, but there is a fluid which is greyish in color.



In the following an interesting comment by Ray Cecot about my Bible article from the last issue

Chris,

I would like to make a few comments on your recent article "The Book of Exodus or Project Genetic Separation." It is important that you placed, at the beginning of the article, the fact that some people might find the idea of "genetic purity" offensive. But, as I mentioned in previous correspondences with you, to limit new ideas because they don't conform to what we believe only promotes prejudice and lack of growth. One does not have to believe what you wrote in your article, especially when there is no definitive proof. Yet, to incorporate the information into one's thoughts as a possible explanation keeps the mind open to new concepts and potentially viable options.

You ask the question "Why do UFOs observe us?" Although you ask this question, you never really answer it. This is understandable because there is probably no one answer at this time. In light of the Exodus article, "God" (I use this word to mean extraterrestrials for the purpose of this brief commentary) may have watched over the Hebrew race to promote some sort of genetic purity.
