

IS "ALIEN" TECHNOLOGY DESTROYING US?

It has long been rumoured that many of the rapid advances in science and technology post 1947 have developed by back-engineering captured alien craft of the time. This of course can be hotly disputed as a great deal of information, particularly in the field of nuclear science and rocket propulsion, was known to have come from German scientists who took up with the Americans or Russians at the start of the Cold War.

Whatever the origins, some frightening realities are coming to light at the present time, and there is a good chance many of these have covered up by "big business" or governments for many years:

① Travelling in modern aircraft which do not need to refuel for many hours or thousands of miles can lead to deep veined thrombosis, DVT, (blood clots) in the legs for passengers who do not move around. If the clot moves to the lungs or heart fatal consequences may ensue. This has been known about for several years, but kept quiet by airlines who try to cram more and more people into economy seats on flights with result that legroom is severely restricted - placing profit before health of passengers.

② Recirculated air containing untold bacteria and viruses passes round 300-400 people on long haul flights. Little fresh air is allowed in the cabin (presumably because of the very high cruising levels, c40,000 ft,) so untold numbers get colds and flu a few days after landing.

③ The AIDS virus is estimated to have caused the deaths of 2.5 million people worldwide in year 2000. In parts of Africa 25% of the population are carriers or infected. The plague is spreading to the poor countries of East Europe who lack the drugs to contain it. After more than 20 years we still do not know for sure where AIDS started. Was it alien technology?

④ Radiation from high-tech mobile phones and booster towers may be the cause of brain tumours and other cancers, as previously mentioned in Awareness. If the figures are to be believed there are now 30-40 million of the devices in Britain alone.

⑤ Depleted uranium tipped shells used in the Gulf and Balkans wars during the 1990s are believed to be causing leukaemia and other serious illnesses amongst troops involved in mopping up operations. (See latest update after editorial).

⑥ Unknown radiation effects come from televisions and computers present in almost every home and office nowadays. For instance a computer server standing close to a bedroom window in my home may have caused paint to peel from fascias beneath the gutters outside. At no other place on the house perimeter has this occurred.

All the above situations have been subjected to evasive answers from governments or large companies involved. Where levels of radiation are measured in laboratory conditions, there is rarely any public conclusion made that there is a problem, but clearly something must be happening which scientific testing cannot establish, as the victims will testify.

If this is "alien technology", then it is clearly designed for aliens! They would be immune from the harmful effects of radiation belts and cosmic rays having reached Earth alive and kicking. We could also expect their body structure would be designed to withstand the stresses of travel unlike our fragile human frames. **We accept the technology without being designed for it!**

Other events in the past few months have shown that if such a thing as an alien invasion should take place, the good citizens of Britain would be helpless within days! The petrol blockades of September 2000 showed how this could be achieved with minimum effort. A group of disgruntled truckers and farmers protesting about the price of fuel in the UK ran a picket line outside the 8 or so main oil refineries in the country preventing tankers leaving with petrol. Although there was no official trade union involvement this small group, co-ordinated on the Internet, managed to drain garages within 3 days and almost brought the National Health service to its knees within 6 days. Pathetic 3 miles long queues of cars formed outside the few filling stations with petrol. Jerry cans from World War II were seen being loaded with the precious liquid; tempers frayed and some unscrupulous garages doubled the cost of the already overpriced commodity - all in all a total shambles with the government still on holiday and your editor fearing he was going to miss his! Complete dependence on the car and the frightening speed at which garages need replenishing - some as much as 3 times a day - exposed the incredible vulnerability. When it was rumoured another blockade might take place in November, panic buying again ensued, although supplies were perfectly normal.

During the past year various news reports indicated 42% of the front-line RAF defence/attack aircraft were out of service; the nuclear submarine fleet were all laid up and German U-boats were being borrowed by the navy; army rifles seized up in the Kosovo campaign and communications equipment was so bad that personal mobile phones were used instead; and artillery gunners are unable to practice firing with real shells because of economies, so instead they shout "bang"!!

On top of this the army is well under strength because couch-potato recruits do not match up to the fitness requirements. Fortunately the threat from Russia is no longer a problem as their forces and armaments are even a bigger shambles! But take comfort, we still managed to come out on top after a similar rundown state in 1939.

Since the last Awareness came out there has been almost continuous rain making the autumn of 2000 the wettest for 200 years or so. "Global Warming" is as usual placed at the centre of the blame. Only 5 years ago counties such as Kent and Sussex were desperate for water, depending on underground supplies (aquifers) in many areas which were almost spent. Now they are inundated! At that point we were to become a semi-desert climate, but now it is more likely to be extremely wet! Interpretation of the present situation should be done with great care. The effect of the Sun might be a factor or even unseen warming of the water deep in the Atlantic, due to submerged volcanic activity, might generate powerful depressions for a time, rather than anything Man may have unwittingly created.

Over a 50 year period, the following extreme weather conditions have been recorded over Britain:

1947 - Huge snow falls for 3 months, then massive flooding. (Roswell incident July - any connection?)

1950s - (Early) Massive tides flood east coast of England and Holland; many drowned. Lynton/Lynmouth flood disaster.

1962-3 - Freezing conditions for 3 months causing transport chaos.

1976 - Very hot summer; drought conditions; subsidence of houses.

1987 - October hurricane devastates southern England. Millions of trees lost.

1990-5 - Hot summers, low rainfall, water rationing in places.

There has been a fair selection of "extremes" none of which lasted for a very long period, so is the future in Man's hands or does nature still decide?

NEWS IN BRIEF

"ALIEN" BACTERIA FOUND: Unidentified bacteria not known to research has been found in the filter of a high flying balloon operated by the India Space Research Organisation. It is suggested that the bacteria, picked up 10 miles into the stratosphere may have come from a passing comet. Samples are now being examined at the Astrobiology Centre, Cardiff. At this centre is Professor Wickramasinghe who postulated the "Panspermia" concept with Sir Fred Hoyle some 20 years ago. It proposed that the "seeds of life" in the form of DNA or dormant bacteria drift round the universe on asteroids or comets and eventually fall into the atmospheres of suitable planets setting up the basis of more advanced life to develop over billions of years.

Alternatively, it might be postulated that certain life forms exist native to the area 10 miles above the Earth as they equally do in vast depths of the ocean, in almost perpetual darkness. Minute bacteria could drift up from the surface - not being constrained by gravity and mutate over millions of years.

SPACE LABORATORY LIGHTS UP: The new international space station has now been fitted with reflectors which will utilise the Sun's rays to power it. An additional effect of this is to make the station the 3rd or 4th brightest object in the night sky so we are informed. It was reported to be visible in British latitudes between 5-6pm in December, but no particular surge of UFO sightings have been recorded. At the same time, the abandoned Russian space station, Mir, was temporarily out of contact with its ground controllers and could break up in random fashion spewing out large chunks of metal over built-up areas as a worst scenario. The intended plan is for Mir to come down in the Pacific ocean at some remote spot in February.


DEPLETED URANIUM SCARES AND COVER-UPS (2): It was previously mentioned in these notes, Awareness 23.3, that depleted uranium coated shells might be the cause of "Gulf War Syndrome". Deadly radiation from spent casings were ruining the health of our "own side". The last sentence warned ominously: "It is further suggested that depleted uranium shells were used in the Kosovo conflict with unknown consequences." A year on and Italian forces report 9 deaths from leukaemia within their Balkan contingents. Several deaths are also reported from Spanish, Belgian and Dutch troops. Fifty others are known to be very ill.

Only one seriously ill ex-soldier from the Balkans campaign has so far been interviewed in the UK, and the Ministry of Defence, as always, denies any problem, but is now prepared to mount an investigation using independent medical experts from the The Royal Society to investigate: "Because of the levels of concern, and because our knowledge of the stuff is not comprehensive."

The alarms must also extend to the test ranges used for firing off uranium tipped shells. These are known to be in Scotland near Kirkcudbright, Eskmeals Cumbria, and Portland Dorset.

CROP CIRCLE MARTYR? The first prosecution of a crop circle "hoaxer" took place at Devizes magistrates on November 6th. It turned out to be the well known UFO lecturer and editor of "Truthseekers Review", Matthew Williams. Since presenting his dynamic talks to conferences in the mid-90s, Williams has broken into RAF bases and underground facilities supposedly in his search for the ultimate. Latterly he moved from Wales to the crop circle hotspot near Avebury and made unspecific claims in the 1998/1999 seasons of being a crop circle creator. During the 2000 season there were reports of Williams and cohorts being evicted from meetings and conferences in the Wiltshire area and sending abusive e-mails.

A seven pointed star formation appeared at West Overton on August 25th night in the middle of the hotspot area. Williams claims to have made it over 3 nights in response to researcher, Michael Glickman's claim, that such a figure could not be man-made. Having boasted to Glickman he had made the formation, the latter reported the matter to the police and farmer resulting in a prosecution. The subsequent fine of £100 plus £40 costs might be considered trivial compared to the publicity and press coverage that resulted and may have been part of a covert agenda.



STAR OF MATTHEW?

7 POINTED STAR
FORMATION 25/8/00
WEST OVERTON, WILTS

Whether the Williams team actually DID make the formation is a moot point. Were they caught in the act of making it? The star looks totally complete. If it was made over 3 nights it would almost certainly have been photographed in a partial state at this location. No such picture has surfaced. At this late stage in the season, past August 20th, the farmer might be expected to harvest wheat at any time so a 3 night project seems a bit odd. The Daily Mail reporter in court seemed to think Williams had made a star "similar to this one" in grass rather than the wheat formation illustrated above, which was the photograph placed on the Internet on August 25th.

All in all, the facts do not add up, but as CIUFOR has no direct information other than press and magazine reports, readers are invited to draw their own conclusions.

CULTIST ACTIVITY IN RURAL ESSEX: A group of extreme pentacostalists are close to taking control over the local Conservative association for Brentwood and Ongar, the sixth safest Conservative seat in the country. As usual, the presence of one charismatic leader, Bishop Michael Read, appears to be the main thrust behind this. Read's Peniel church offers miracles and healing amongst other things, but of course wants 10% of your salary if you sign up! The sitting MP, the rotund Eric Pickles, appears to be compliant to Peniel infiltrating his constituency, so much so that guardian of the nation's morals - "Man in the White Suit" - Martin Bell, will take on Pickles at the General Election. If anyone has local knowledge of what is happening please keep us informed.

BICESTER CRASH EXPLAINED? Our detailed report of the mysterious object that crashed near Bicester in 1967 appeared in Awareness 23.4, P13-17, by Bill Foley has been identified as a USAF, D21 supersonic reconnaissance drone according to an Internet report sent by Mr Chris Burleigh of California. He thinks the description of the "UFO" fits the D-21 which entered service in 1966 as a replacement for the Lockheed U-2 spy plane - one of which had been shot down over Russia with the capture of the pilot Gary Powers. The idea was to launch the drone from under a B-52 heavy bomber at high altitude; overfly Soviet airspace and then return to home base with information gathered. Clearly to control a pilotless aircraft to land safely every time after a complex mission to Russia would be difficult and some of the 31 built are known to have crashed. Hence the D-21 in question at Bicester would have been whisked away very quickly by USAF recovery teams to avoid the top secret drone being seen by too many people. CYNTHIA HIND: We regret the passing of our southern Africa contact. Cynthia Hind died at 21st August 2000 at 6.30 am in Harare, Zimbabwe.

Her colleague, Maria Sullivan, says she passed away peacefully in her sleep after an incredibly short illness - cancer of the liver and pancreas. Maria added that besides Ufology, "she was a most generous person who dedicated many years of her life to charitable pursuits. She was a *helper of lame dogs over stiles* and one could always depend on Cynthia when help was needed, regardless of gender, religion or race. The door of her heart was always open - one just had to knock."

She grew up in Namaqualand, South Africa. She served in the S.A WAAF and then married an RAF pilot living in Northern England, where her son and daughter were born. It was here that she started writing professionally. The family moved to Rhodesia and started a successful furniture business. Soon Cynthia became interested in UFOs. eventually coming a MUFON investigator and representative, later its co-ordinator for Africa. She knew the late Elizabeth Klarer, South Africa's most famous contactee.

She contributed numerous articles to newspapers and magazines, including FATE mag. In 1982 she self-published a paperback, UFOS AFRICAN ENCOUNTERS, which includes cases from Southern Africa and a chapter on Klarer. After 20 years of investigating, the first issue of her modest A-5 magazine, UFO AFRINEWS, appeared in July 1988. In late 1996, a large softcover book appeared in the USA published by Horus House: UFOS OVER AFRICA, which includes some local close encounter reports. Incidentally Cynhia took a special interest in the Welsh Triangle flap of 1977.

I exchanged considerable correspondence with her over the years, and have been surprised just how many people knew her. (Lionel Beer).

ARTHUR TOMLINSON: Distinguished Ufologist, Arthur Tomlinson, died on September 18th, 2000, from a heart attack.

He was Chairman of DIGAP - The Direct Investigation Group on Aerial Phenomena, founded in 1960 in the Cheshire/Manchester area. DIGAP was a founding member of the British UFO Association (BUFORA) in 1962, and it is fairly certain that both he and its secretary, Joan Nelstrop, would have been at the inaugural convention. He also helped to organise northern conferences in those days. Arthur was actively involved in investigating the Ilkley Moor alien entity case of 1987. He is remembered for hairing round the country in a trusted Robin Reliant, so that he could give UFO lectures. These included talking to BUFORA in London. He was a committed ET supporter and will be remembered for the help and friendship he gave to fellow Ufologists. (Lionel Beer).

Place: Gloucester
Date: circa November 1996.

Time: 9.10pm Saturday

Kevin very kindly sent us in this newspaper clipping which readers may remember in a past issue we had an extraordinary sighting which involved a boomerang type craft, - this is one for the files!

Mr. Rob Martin was gazing up from the back garden of his house in Gloucester when he spotted a mysterious object. He was puzzled because it was silent, bigger than a plane and left no smoke trail behind.

"It looked as though there were five pinpricks of light on each wing" (sounds familiar) "It flew in a straight trajectory underneath the cloud cover and moved pretty fast".

When Mr. martin first spotted the object it was actually overhead, but within five seconds had disappeared into the distance.

"It looked exactly like a great big boomerang but had the wingspan of a very large jumbo jet. It really foxed me at the time - I just couldn't believe it."

Mr. Robin Cole's Group (Circular Forum) had also been alerted to a black boomerang type object over Charlton Kings on July 29th at 12.45pm.

Place: Oldham Greater Manchester
Date: 11th September 2000

Time: Night - unspecified

Mr. T. Hill an 18 year old student, was attracted by his brother calling from the garden of the house and ran into the garden and saw almost directly above a large very bright light. It moved up higher into the atmosphere whereby its size decreased. It then stopped for around 10 -15 seconds and then began travelling north in a straight line.

"The speed of it must have been very fast for its height as it decreased in size so rapidly". Within 10 minutes another object appeared in the same place but was much smaller in size. There were 3 witnesses to the event and they said it was difficult to discern an actual shape as it was too far up and all they could see was the very bright light it gave off. The second object appeared to have a "bouncing motion" before flying off in an upwards direction.

The weather conditions at the time were clear, and fairly warm with no wind.

Place: Cranhill, Glasgow, Scotland

Mr. B was getting ready for work in an urban area of Glasgow and saw what he thought was a very bright light above the roof top of the house opposite.

The light was, or appeared to be, the shape of a bell, veered slightly to his right. Mr. B turned to get out his video camera and on return could still see the light behind a cloud, then suddenly a second light appeared to the right of the first. He zoomed his camera into this light which appeared circular in shape. It then flew around at great speed as he watched it for a few seconds, he then spotted a third light which came into view which was

flashing, but then this seemed to become as large as the second light then all three lights suddenly disappeared. His visual contact was approximately 2½ minutes and he states the sky was very clear. He also stated that usually his cockatiels are never awake when he rises early in the morning, but that morning the birds were squawking loudly.

Mrs M.Q. was looking out of her attic window and enjoying the view of sky which was a clear blue with white "fluffy" clouds scattered here and there. As she looked she heard the sound of a plane and looked towards the sound. She scanned the sky but was unable to see anything then suddenly she saw an almighty flash in the sky just above the window, similar to a mirror suddenly catching the sun, she then saw out of the flash a dark grey object drop below it. She thought at first it was a man with a parachute but the chute didn't open and it then stayed in an oblong shape and just kept dropping, then suddenly it disappeared from view.

She reported it to the local Evening Telegraph as something similar had been reported but on a different day.

Place: Neath West Glamorgan

Mr. P.S. was in his back garden with his dogs when he heard a strange sound. The next thing he noticed was an object "dancing" in the sky. He was unable to see a defined shape but stated that it had coloured lights. There were 2 witnesses to the event which lasted for approximately 15-20 minutes. The lights were clearly visible and were Green, White, Yellow and Blue. The object seemed to make a two tone Whine sound. The weather conditions were dry and clear.

Place: Leeds
Date: 20th December 1980

Mr. J.P. sent in this sighting to Contact which is worthy of note as it seems almost a close encounter of the second kind.

Mr. J.P. saw the object which was initially about 60 yards away from him and he estimated was fifty feet off the ground. He noted the dimensions were five yards across and probably about four yards high. The shape of the object was difficult to define and only became clearer later. He stated he could see it revolving around its own axis and was a very bright bluish white - like an arc welding light.

He could hear no noise throughout the extraordinary event and suddenly within 2 to 4 seconds it accelerated vertically and stopped dead in the night sky. He stated

"You could literally feel the acceleration and a strange relaxation feeling came over me".

He estimated the object at this point to be anything from 500ft to 1000ft up. The shape becoming more defined and seemingly looking like a pyramid and he could clearly see three lights. He stated he was sure it tried to camouflage itself into a star. It stayed at this position for approximately twenty minutes. It then started to rotate on its axis again and the shape of it changed and then suddenly without warning the object disappeared.

"I know this sighting is nearly twenty years old but my memory of it is crystal clear as if it was yesterday" I also am convinced the object was the same one as mentioned in the Rendlesham Forest. Few sightings were reported locally but on the Monday or Tuesday of the following week Mr. JP was told the sighting was reported on Radio Leeds, although this has yet to be confirmed. He was also informed that this was reportedly seen in Scotland.

HEAVENLY OPENINGS AND UFOs (The Astronomy and Astronautics in the Bible and Iconography)

On the ceilings of early churches - I think those of the Byzantine style - in the sub-dome area, on the vaults and arches, are depicted astronomical representations as they were imagined in old times - in the biblical period and in the Middle Ages. In fact the sub-dome area represents the heaven(s) on which are added some detail. It is especially interesting for us, that together with astronomy, there are depicted UFOs like Glory and the Holy Spirit in a special manner similar to illustrations in biblical texts. Thus the UFOs and the Holy Spirit are vehicles sent by God. So we come to the conclusion again that the Bible is inspired by Him, but in a special way.

The Heavens Open Over Ohrid

When a visitor enters the church of Saint Sofia, in the town of Ohrid, Republic of Macedonia, he usually directs his sight to the frescoes in the altar space and beyond - above the altar itself where is painted a monumental scene of the Ascension of Christ in which the art, dynamics and excitement of the apostles, archangels and the Virgin witness Christ being taken up into heaven. The witnesses of this event are depicted on both sides in the lower zones on a vault so they appear in vertical positions like full length figures, while in the zenith is depicted Jesus Christ during the ascending in company with 4 angels depicted symmetrically round about him. Jesus is sitting on a rainbow and his legs are supported on another rainbow. (Fig.2)

On the other composition where the Ascension is represented, the 4 angels are holding the God's "Glory" - this is a circular round object with the help of which, Christ is ascending into heaven and in iconography this is called "mandorla". (Fig 1). In the Fig 2 representation the Glory is not apparent though is viewed from another angle.

In Fig 2, with the 7 "concentric circles" are depicted coaxial circular openings in 7 concentric heavenly spheres. The openings are given in perspective: the nearest is biggest and the furthest, I.E the highest up is smallest. Higher up in the heavenly openings it becomes darker - this means the illumination comes from below. One wing of every angel is projected on the first, and on the second and on the third opening; the head with the aureole - on the first and on the second, and the fingers of both hands (palms) - only on the first opening. This means the angels with Jesus are located under the openings, approaching towards them in an upward motion. The symmetry of the composition together with the positions of the angel's fingers gives an illusion that the heavenly openings, at least the first one represent a Glory held by the angels - this was the purpose of the painter. (Fig 3)

Scenes with the Ascension of Christ exist in every painted church, but this one in the Ohrid church, St Sofia, on the basis of eleventh century knowledge, when this church was painted it was conceived, that the Earth was like a circular plate vaulted with 7 concentric spheres of solid material and therefore for the concept of heaven there exists the term "firmament", (See Gen, 1.7, King James version) as if made of FIRM or solid material and as it is also in the old Slavic language: "nebesnaya tverd".

On every heavenly sphere is fastened one, then known, heavenly body. Within different old texts there are alternative arrangements. Here is one - the Moon is on the first sphere, Mercury on the second, after there follows: Venus, the Sun, Mars, Jupiter, Saturn and the

fixed stars.

On the zenith of those spheres are depicted the same number of circular openings as if some projectile had been shot vertically upwards. The people, or to be precise, the painter imagined that through those openings the resurrected Jesus, accompanied with 4 angels (or with 4 angels holding the God's Glory) leaves this world sitting on one rainbow with a parallel one supporting his legs. (See Fig 2).

UFOs in the Iconography and in the Bible Texts

The concept of the Ascension is an illustration on the same theme contained in 3 Gospels (Mark 16.19, Luke 24. 50-52, see also 24.26; John 20.17 and Acts 1. 9-11 - see also Romans 6.4). The iconography composition contains elements which are not mentioned in the 3 gospels and in the Acts. For example the 2 rainbows are not mentioned in the bible, nor the 4 angels holding the Glory, while "the men in white" (Acts 1.10) are represented like angels or archangels with wings. Also the text does not mention the Virgin and the opened heavens.

The elements containing the art composition of the Ascension of Jesus are undertaken by other biblical books, especially by the Old Testament book of the prophet Ezekiel which is indicated in the initial verse: "when I was among the exiles by the river Kebar, the heavens were opened and I saw a vision of God." (Ezek 1.1).

We note that Ezekiel says "the heavens were opened" - in fact everywhere in the Bible that is said the same, except when it speaks of rain when it descends; then it is said "Window" (Genesis 7.11, Malachi 3.10), or "door" (Psalms 78.23). When in the iconography are depicted heavenly openings the Bible speaks about open heaven: Ezekiel 1.1 - "the heavens were opened"; Matthew 3.16: on the Baptism - "heaven opened"; Mark 1.10 : on the Baptism - "the heaven torn open"; Luke 3.21 on the Baptism - "heaven open"; John 1.51 : when the disciples discovered Jesus is the Son of God - "heaven wide open"; Acts 7.56 : during the martyrdom of Stephen - "a RIFT in the sky"; Acts 10.11 : the vision of Peter - "a RIFT in the sky". All cited cases are from the New English Bible.

The "rift" looks like a "heavenly opening"; however in other Bibles we read otherwise. For example in the King James version in Acts 7.56 we read: "heavens opened" and in Acts 10.11 - "heaven open". The last 2 verses, Acts 7.56 and 10.11, in the Good News Bible are the same: "heaven opened". It reads the same in the Slavic language Bibles. Only in one place in the Bible, in Revelation 4.1 is said "door" : "before my eyes a door opened in heaven; and a voice that I first heard speaking".

Ezekiel in detail describes the Glory of the Lord accompanied by 4 "living beings" (see chapters 1 and 10), which since "the heavens were opened" (Ezekiel 1.1) came from another world. The 4 living beings in iconographic form are represented in medieval art like angels, or in scenes with the Pantocrator, more often with the symbols of the 4 evangelists: Matthew - the man, Mark - the lion, Luke - the bull and John - the eagle. In some iconographic representation there may be depicted 2 angels holding the Glory - these are the 2 heruvim from the Tent or from the Temple, transformed into angels; also the number of the angels holding the Glory may be 6 - the 4 Ezekiel ones and 2 from the Tent or from the Temple).

In connection with the Ascension, the GLORY is depicted in iconography everywhere although in Acts 1.9 it is named "cloud". However we know that the "cloud" is another name for the Glory. In the 3 English bibles at my disposal, I found only in one of them the word

"glory" in connection with the Ascension - in the King James version (1 Timothy 3.16) : "Jesus was received up into glory". In the Slavic language Bibles - Slovenian, Croatian, Serbian, Macedonian as well as in the old Slavic language, the term used is "glory" - "slava".

For a Ufologist it is significant that the Glory, as well as the Holy Spirit are flying vehicles. Note that most often they are circular shapes or double convex lens-shaped objects, or there is depicted only the radiance from them as some types of UFO are reported today. So the Bible and the iconography are influenced by UFOs; also it is influenced by angels and "men in white". In other words, we repeat once again, the Bible is inspired by God.

The Christian iconography is by no means a simple interpretation of the biblical verses, but it was inspired also by UFOs seen by men including painters through the history of mankind.

We must note a detail: since the men from the past were not able to imagine a flying object without wings, the medieval painters have added angels holding the Glory in flight or hovering in the air. (Fig 2).

The concept of the Ascension of Christ has also been painted without denoting heavenly openings. On an icon from the monastery of St Catherine in Sinai (from the end of the 12th and beginning of the 13th century) the Glory and the aureoles are depicted with metallic shining. (Fig 4).

Finally we must bear in mind that in Byzantine art, the Glory and the Holy Spirit (the aureole) always are placed parallel with the plane of the picture. In Renaissance art the aureole is depicted in perspective - it is placed related to the angle at which the head is turned.

ABSTRACT: A remarkable "instinctual" and personal use of radioactivity has been "unearthed" and based on the properties of these emissions various practical and safe devices can be made for general use."

MAIN DETAILS: When I visited a recent rock and gemstone show at Cheltenham, with the Geiger counter I often carry when checking for UFOs, I was delighted to find that some of the wares (and even some of the stallholders) were slightly radioactive (due to the practice of increasing the value of gemstones like Topaz by placing them in nuclear reactors so that the colour darkens and increases the value). This is common knowledge in the gemstone industry and entirely legal, although many of those carrying the enhanced stones were unaware of their past. (Do not be put off by these wares, since whilst the colour change remains, the artificially induced radiation fades in weeks to only just above background - no cause for alarm here). Additionally at the fair I found that some stallholders had actual radioactive minerals like Uraninite for sale under their tables, and were happy to sell them. It is also interesting to note that some yellow orange glass in nineteenth century stained glass windows is also radioactive, since uranium oxide was widely used as a pigment before the radioactive properties were determined. Hence quite a few churches in Britain have glass "with that extra sparkle" which, presumably not all people are aware of.

In Cornwall I picked off the bare earth in the central region, a fine example of uraninite only a few metres from a public footpath, through the most attractive luxuriant heather I had seen, and these natural minerals which humankind has lived with presumably for millions of years pose no threat at all and may even be beneficial for us. We utilise many minerals in the body - even salt crystals in the inner ear.

THOUGHTS: Searching through the mystical literature one can find from Middle Eastern sources that overflights of flying saucers, whether seen or invisible, do effect the humans underneath to the extent of changing our minds or inspiring us, and because belief systems in those areas do not accept concepts beyond their own dogmas - this activity, deemed to be by the "djinn", is considered harmful. Yet this is only a religious view, not one necessarily consistent with the West which values sources of inspiration, and as I have said many times before in Awareness the genesis of many new artistic and literary movements seems to happen at the solar minimum when there are fewest sunspots, though the cosmic ray flux is approximately double compared with the solar maximum. Thus, willy nilly, we are effected by these rays - rays which are most likely to emanate from the overhead craft of our UFOmuses. From the evidence of radioactive traces left at landing sites, which have been found even at the non-landing of the Australian 1990 Nullarbor case, the expectation that the craft emit rays at a very low and safe level in a downward cone is very likely indeed.

MORE MATERIAL: In order to check this memory channelling with deduction, I placed above my workplace a largish piece of radioactive material about 1.5 metres above the head - the level is entirely safe - compared to the mineral museums and gem shows visitors approach the exhibits much closer than this - and was surprised to find that my production rate of original papers, theorems and poems increased quite dramatically, although the test was done near the solar maximum (minimum cosmic rays). I was quite stunned by this discovery - the brain does quickly use these safe, slightly diverging rays for inspiration and explains very neatly why hills and mountains are considered inspiring in folklore - all very

clear indeed.

FURTHER DIRECTIONS: Now the ancient memory channel turned on here was remarkable. Firstly came through some rhymes (almost nonsense)...

'I know a place where the cats all bark
And the pups all seem to sing
And three small men in conical hats
Can fly on a crystal ring'

I had a vision of a loud buzzing sound and conical craft, points uppermost with tilted down flanges flying in the sky - making a buzzing sound, which I believe have been reported in modern times. (A French case). And another earlier impression: -

'Water with no future
Voltage with no top
Metal with no bottom
And light with no past.

And then in the next phase I saw that in times when they felt bereft of inspiration, humankind instinctively have always built spires, AND PLACED THE SPECIAL STONES ON TOP - note the connection with the stupid and irritating things done with bells (changes), some way up the spire. What comes through is stupid - head banging repeatedly - bells - UFO FLANGES - UFOs? And the fact that smashing against a mono-crystalline bell shaped shell ruins the crystal - that is operation - of the craft - thus craft out of operation - stupidity - no rays - hence the clear indication 'stupid - in the spire there are no effective rays - stupid men'.

However in the most recent spate of spire building the culture was too frightened (possibly from centuries of ergot poisoning), or too unintuitive to see that the "cap stone device" was needed - that the special and blessed rocks were obtainable with ease only from the "sacred isle"(the meaning of "Britain"), should be with due ceremony and thought placed near the apex. Note special apices are missing from many of the pyramids, there to increase the inspiration in the sacred inner chambers - naturally ray active cap stones. Note those sacred inner chambers have no hieroglyphs on the walls - the "inspiration" was from "without".



MILITARY MIND CONTROL AND ALIEN ABDUCTION

Ufology today is a mish mash of many weird and wonderful ideas, speculations and theories about like there is no tomorrow and one wonders can this subject get any more fanciful !! Admittedly we should not forget that speculation is fine so long as it is constructive and is done with the sole purpose of finding some answers. Ufology has seen many books all portraying our subject with these differing ideas. Some authors would have us believe that we are being visited by "beings" from Zeta Reticuli, whilst others would have us believing that we are being visited by Time travellers, Parallel Universal 'beings' or whatever. The list is extensive. One thing for sure there is no denying that we have a UFO presence, that much we can say but a presence is one thing determining what that presence can be is another.

I am in total agreement with researchers wearing as many 'hats' as possible and opening as many UFOlogical doors as possible, the truth of the matter is within all these avenues of possibilities-an answer must lie somewhere it's just a case of finding it. I am in the fortunate position of being sent many UFO and paranormal books by publishing houses to review and recently I was sent a copy of a book which absolutely blew me away !!! Why ! wee because it was so new, and was so shockingly important to the subject of UFOlogy that it just screamed out to be read by UFOlogists and sceptics alike. The book is entitled **MILABS**, subtitled (Military Mind Control and Alien Abduction) and is written by Dr. Helmut Lammer and his wife Marion Lammer. It is my opinion, that this book holds a very big piece of the UFO puzzle and I hope that through this article I can at the very least, share some of the salient points with you. Of course for a more overall view of the book, one must purchase a copy oneself, but take it from me, it will be the best money you will have parted with for some time. Dr Lammer has a Ph.D. in geophysics and works at the Austrian Space Research Institute as a planetary scientist. He has published many scientific papers in prestigious scientific journals such as *Journal of Geophysical Research*, *Geophysical Research Letters*, and *Planetary and Space Science*. Dr Lammer is a member of the European Geophysical Society (EGS) and the New York Academy of Sciences. In his spare time, he writes for numerous UFO magazines and is the Austrian representative for the American society, The Mutual UFO Network (MUFON) and is also an associate member of the Society for Scientific Exploration (SSE). Marion Lammer studies law at the University of Gras, Austria, has a lifetime interest in Fortean phenomena and has helped her husband with his studies in his **MILAB** research. OK let's take a look at what Helmut and Marion Lammer have to say.

MILABS, A STUDY OF UFOLOGICAL IMPORTANCE THE MILITARY KIDNAPPING OF ALIEN ABDUCTEES

The main thrust of the Lammers's book is to inform us that 'not all' is as it seems! We are informed that many UFO abductions are the result of Military personnel, men in business suits, or men in white lab coats each who are abducting individuals either to

- Obtain as much information from the abductee as to what transpired during their abduction i.e. to obtain any 'technology' or advanced information as they possibly can which could potentially be used by their country (America) to advance their own technology from the 'abductors'

OR

- The American Government 'agencies' are themselves imprinting false and misleading information into the minds of the unsuspecting public to further the cause/belief away from what really is going on i.e. a new Stealth technology or advanced black budget technology to which they (the Americans) do not wish the public to learn about and they are more than happy for this technology to be camouflaged under the guise of '*alien abductions*'.

Now as we progress, both the above categories play an important role in the understanding of the **MILAB** scenario and it is my hope to paint a presentation of facts which you, the reader, can judge for yourself. So let us now continue on with what the Lammers have to say about the above and I ask that you keep an open mind and try and grasp the importance of what this article is all about.

Now, what we have to bear in mind, and what is a proven fact, is that numerous UFO Abductees not only report seeing small grey 'beings' during their abduction, but they have also told researchers the world over that they have also been 'interrogated' by what appear to be 'humans' who not only threaten them but implant devices into their head which cause them much distress. They describe being taken to Military Hangars in which strange UFO-like craft are housed. For instance, Brenda, a Canadian UFO abductee explains that she was abducted and taken to a Military Hangar where she was met by two 'men' in white coats who interrogated her for a period of time. This proved most distressing to her more so because these men used chloroform to knock her out. The main thing is though, she claimed to have seen advanced disc shaped objects in this 'facility' similar, it is said (by the author) to advanced disc shaped objects that are apparently being developed at Lockheed's Hellendale underground research facility near Palmdale in southern California.

Another **MILAB** abductee Melinda Leslie, has also experienced both alien and Military abductions. One of which occurred at an aerospace facility in southern California near Lancaster. Not only did she witness men in navy uniform during her abduction, whilst she was being examined by small grey 'beings' but she also claims to have seen a strange triangle shaped craft in a large hangar and also a dark unmarked helicopter. Melinda remembers being forced to sit in a chair where she was forcibly given a strange drink and had a syringe inserted into her arm by a human in a lab coat. She was then asked repeatedly by a red-haired Military officer to tell them all about her 'alien' experiences and that he wanted information about the 'aliens' technology. Leah Haley one of America's more noted UFO Abductees, also talks about being taken by a helicopter to a military base where she was interrogated by 'humans' in regards to her 'alien' experiences. She also states that she was given a shot in her arm and asked repeated questions by military officers to tell them all about the 'aliens' technology.

These are but a few of the many references that are made by the author in regards to individuals being forcibly taken by military people in order to try and extract some details to better the minimal knowledge of the military chiefs. We are also told that the husband of the late Dr. Karla Turner (a noted UFO Researcher) also recalls an abduction in which he too was forcibly taken by military personnel to an underground facility where he too was drugged and repeatedly asked all about the 'aliens' technology. Although some of these UFO abductions involving military personnel being seen on board strange looking objects, have been reported elsewhere, it has only been tentatively, as if the authors of previous UFO books really didn't know what to do or make with them. I would probably say that some, if not a lot of other UFO authors, have in point of fact, kept these vital facts away from their readers not knowing whether there were any truth in them or moreover, it may well spoil the thrust of the book they were writing. Thankfully these stories are now surfacing. Karla Turner referred to them numerous times and told many people that we should start to sit up and take notice of these accounts, Dr Lammer states, "*The presence of human Military and/or*

civilian personnel inhabiting the same physical reality as the alien beings exceeds the mindset of the sceptics and the open minded researchers by several orders of magnitude". A more truer statement has never been said. Dr Scott Jones believes that it's quite possible that the military machines interest in UFO Abductees may well be due to them (the Military) gaining important ground as to developing brain implants, virtual reality implants, holographic image projection and cloaking devices but more so for genetic research. This all sounds incredible and seems like something out of Star Trek or Deep Space Nine, but the facts are, that more and more UFO Abductees are coming forward with stories of not only meeting up with 'aliens' but seeing and being interrogated by their fellow human beings. Of course as things stand, this would all appear to be hidden from the US Congress and may be masked under the secret 'black budget' projects. During the 1980's a lot of money we are told, was being used for top secret military projects, the major one being for (SDI) Strategic Defence Initiative. It's not that hard to imagine, that a certain percent of the black budget programme, went towards the procedure of finding, locating, abducting and interrogating helpless UFO Abductees to try and elicit from them, what the 'aliens' were up to. Now this all presupposes that we 'have' an alien presence, and this is what makes this book so darned important. The evidence contained within this book, clearly shows that there is indeed, without any shadow of a doubt, an alien presence on this planet who's programme is decidedly targeted towards a genetic programme of sorts. Let us now take a look at some of the other important issues contained within this book.

CONTROLLED EXPERIMENTS ON HUMANS WITHOUT CONSENT, AN INFRINGEMENT OF HUMAN RIGHTS

The Lammers present the reader with case after case of experimentation by the people we have been led to trust, military chiefs-on not only the people of the United States, but on citizens of Canada and other countries. These experiments from many years ago, were nothing to do with UFOs or the search to understand alien technology, it was to find out various things about what the human individual could endure. Covert operations have been deployed on countless thousands of people for many years, even our own Ministry of Defence has carried out secret radiation experiments on humans during the past 40 years. In America, nerve gas, LSD, and various biological agents were used on people without their permission. We often talk about the atrocities that the German Army committed during the second world war. The experimentation on the Jews both children and adults, filled us with horror, and to think that the people we elected to serve and protect us are still experimenting on our minds and bodies of citizens today should make everyone everywhere stand up and protest from the highest tower. Whilst I appreciate that mankind must learn what biochemical agents can do to someone, to use it on people without their consent is immoral. Dr Lammer tells us that horrific psychological experiments were conducted on American soldiers at Edgewood Arsenal Maryland. Eight former Nazi scientists worked at Edgewood for the Americans between 1947 to 1966 developing and testing lethal nerve gas and psychochemicals on humans. Dr Ewen Cameron led a CIA funded laboratory at McGill University during the 1950's where people were used as guinea pigs for brainwashing experiments. People were given huge amounts of hallucinogens, some were given electro-convulsive therapy, and others were subjected to sensory deprivation. More importantly, Dr. Lammers tells us that a panel appointed by the Clinton administration in 1994 to look into these matters found that four hundred documented Government backed bio-medical experiments involving humans were undertaken between the years of 1944 and 1975. How much more has gone on that we don't know about! I'm sure we'll never really know. Mind control victim Claudia Mullen testified before the advisory Committee on Human Radiation Experiments in Washington DC during March 1995 where she explained that she was taken by military people over a course of many years, and subjected against her will, in

experiments concerning chemicals, radiation, drugs, hypnosis, electric shock, sleep deprivation and even sexual abuse! Another witness, Delora, recalls that her father who was a career navy officer, was stationed at an ammunition depot in Shoemaker, Arkansas, and during those early years whilst he was stationed there she remembers flashbacks of being with both her parents inside a military bunker where she saw 'aliens' performing experiments on humans. Delora knew that this bunker housed chemical and biological weapons which may have been an interest to these 'aliens'. She also claims to have seen a number of humans suspended in gas or liquid filled capsules. Delora holds the opinion that those people that were contained inside these capsules were clones and being used for secret bio-warfare or chemical warfare experiments. American UFO researcher Dan Wright who is head of the MUFON Abduction Transcription Project has a number of records on file which detail this description of humans being witnessed in large tubes or containers. Some of his cases, feature humans who somehow had to 'breathe' the strange liquid that was found inside these containers. This puts me in mind of the famous Scottish A70 UFO Abduction, where one of the two witnesses, Colin Wright, found himself enclosed in a large glass or Perspex container. He was naked and was strapped to a chair when suddenly this glass or Perspex started to frost up. Colin doesn't recall the container being filled with any fluid, but certainly recalls the situation very vividly and with a certain amount of fear.

The Lammers explain that this concept about 'fluid breathing' more or less began in the mid 1960's when a certain Dr. J. Kylstra, a physiologist at the state University of New York in Buffalo, found that salt solutions could be saturated with oxygen at high pressures. He went on to perform experiments with mice and was able to keep them alive for 18 hours, however his eventual use of this practice did not work when he applied it to humans! Other researcher's began to take an interest in the work of Dr Kylstra and a number of people began their own experiments (mostly on mice). We learn that the early 1990's proved successful, scientists kept dogs alive for around 2 hours in a perfluorocarbon container. After removal, the dogs were apparently hypoxic but returned to normal after a few days. UFOlogists will of course recall another famous American UFO witness by the name of Betty Andreasson. Betty claimed that she was placed inside a large tube filled with liquid of which she was told was to cushion the large force of the gravity during the UFO's acceleration. The Lammers also go on to explain that during the 1960's a Dr. Robert Goodwin experimented with human embryos by keeping them alive in artificial wombs like steel containers. However, pressure applied by the scientific community and also members of the public forced him to abandon these experiments. Clearly then this business with UFO Abductees reporting tubes and containers which hold some form of liquid and which they have either been placed in there themselves, or have seen others in there, is something which is a major part of the UFO abduction phenomenon. But of course why! What real purpose does these containers hold? Is it as was told to Betty Andreasson 'to cushion the G forces of acceleration', or does it hold a more sinister purpose! Is it really for the benefit of the UFO abductee!! It's frustrating that in the new Millennium, we are no further forward in answering these and other questions, than we were when the modern era of UFOlogy first began.

One might say however, that we do have the answers, and those answers are all to do with the genetic interbreeding programme that seems to be part and parcel of the make up of the 'aliens' agenda. They may be modifying the genetic make up of humans for their own purposes, introducing their own DNA to create some kind of hybrid species, a species which will be adaptive in all environments which can stand high pressures, breathe liquid with ease etc., However, and I've said and written about this many times before, why oh why is this abduction procedure 'still occurring!' Haven't they (the aliens) got enough genetic material by now! They have been abducting the people of this planet for nigh on 50 years if not more, and here at the close of the

century, they are still taking people from their homes and environments and subjecting them to clinical and medical procedures without consent. As a researcher, this angers me as I'm sure it does to most people, but more so because, if there truly is any truth to what these UFO Abductees are telling us, i.e. that the Military chiefs of this world know what's going on, and are assisting in this, then this is the biggest deception, this is the biggest lie, and this is the biggest shock. As human beings, we expect those in power to look after us and to think that those we elected to serve us can betray us in this way, well it just beggars belief.

The Lammers present case after case of factual data which informs us that the governments of this world have not been treating their citizens with any respect, far from it, they are abusing our trust, abducting us for medical procedures which can cause lasting harm if not death, all in the name of science. We quite rightly concern ourselves about the plight of the animal kingdom, it's also about time that we should equally be concerned about the plight of humans as well! During the Cold War scientists were using mind control on helpless victims by inserting devices up their nostrils in order to control them, a procedure all too reminiscent of alien abductions. In the authors studies, they soon came to realise that there were around 3 'human' agendas associated with the 'alien abduction' scenario. They found that one group of humans were interested in UFO Abductees purely for mind and behaviour projects, sensory deprivation and liquid breathing experiments. Another group were interested in biological and genetic experiments, indeed a number of MILAB Abductees, clearly recall seeing other human beings enclosed in tubes filled with liquid, they also tell of seeing genetically altered animals! All these were witnessed in Military Underground research facilities. A third group the authors explain, are solely interested in the actual alien abduction phenomenon itself, purely for information gathering purposes.

Dark unmarked helicopters, have been a growing trend within the confines of Ufology of late. A large number of UFO witnesses (but more so UFO Abductees) claim that their lives have been subjected to harassment by low flying unmarked helicopters that have buzzed their homes morning afternoon and night, and when they complain to the local or national airports, no one can provide them with an answer as to where or who they belong to!!! Debbie Jordan, Budd Hopkins star UFO abductee, claims that her life has been a misery since she had her UFO abduction, for since that time many large dark unmarked helicopters have stalked both her and her family. Debbie was quoted as saying:

"Even when I am outside and obviously watching back, it doesn't seem to bother them, they just sit there in mid-air about 60 to 90 feet above the ground whirling and watching. They are completely without identification and are always low enough so that I could easily see the pilot if the windshield were clear glass. But the windshield is smoky black and with a finish that makes it impossible to see who's inside".

What I, as the author of this article find hard to believe, is that this form of harassment is necessary!! For surely the pilots of these helicopters are drawing much attention to themselves by doing this! If they are so interested in these unfortunate UFO Abductees, then this form of behaviour surely shouldn't happen and could be done in their usual 'covert' way. Of course we can't forget the fact that these black unmarked helicopters have been seen many times over the pastures in which cattle mutilations have been found, and more recently, dark unmarked helicopters have been witnessed flying above the wheat fields of England where many strange crop circle formations have been found. Clearly then, there is a great interest by these shady 'agencies' in the lives of the UFO Abductees, and the crop formations in Southern England, for forgetting the obscene and tragic animal mutilations that have been discovered in unusual circumstances with each passing

year. In their book, the Lammers present many cases where dark unmarked helicopters have made the lives a misery of many a UFO abductee.

WORKING IN HARMONY

Probably the most important aspect and significant if not disturbing part of the Lammers' book is their presentation of facts which clearly show that certain American Government 'agencies' have been working side by side with the 'greys' for a good number of years now. This aspect of UFOlogy has of course been speculated on by many Ufologists for a number of years now. And this is way perhaps Ufologists and the general public at large never obtain a statement of sorts from the American Government admitting what is going on. They 'know' what's going on 'they' are part of it. The abduction of humans from this planet is part orchestrated by the Military chiefs of this Earth in order to obtain information from these visiting 'intruders' which may further and advance the cause of potential warfare capabilities of those who learn the secrets first of people from other worlds.

The above of course sounds incredibly fanciful and full of speculation but can there be any real truth in this! The Lammers again present an incredible amount of information to say that this is so. The MILABS book will clearly change your perception about what ufology is all about, it certainly changed mine. I was sent this book to review, believe your me, it's impossible to review a book of such a proportion in so little words, hence I chose to do a slightly more worded version, and seven so, this will not do it justice. At the end of the day, where would Ufology be without the sterling work of a number of Ufologists like the Lammers and the late Karla Turner who are bringing these Military/Alien cases to our attention.

TERRESTRIAL & EXTRATERRESTRIAL IMPLANTS

The finding of implants in the bodies of UFO Abductees is a well known factor in Ufology. Strange small metallic devices some round, some small and slim, have been found in nasal cavities in Abductees and also other parts of their bodies as well (sometimes even their big toes!). Why would a sophisticated intelligent race of beings want to track and monitor a person in this way is beyond this writers comprehension. If they (the aliens) can ghost into someone's bedroom and abduct someone of an evening, it seems unusual that they would need to know where people are, or do these devices perform some other kind of function? The Lammers present the reader of the MILABS book with an in-depth look at the implant phenomenon. They tell us that the military have been implanting electrodes into the bodies of unwitting subjects as early as 50 years ago and some horrific tales can be found in this book. I present the following paragraph (with permission) to illustrate the point.

During the 50's and 60's neuro scientist Dr. Jose Delgado invented the stimoceiver, an electrode capable of receiving and transmitting electron signals via FM radio waves. Such a device implanted in the brain via the sinus cavities will act as a powerful stimulant when activated by FM radio waves. One can speculate that the stimoceiver has since been modified to receive stimulation from microwave pulses, and is capable of wielding a great degree of control over the implanted victim's response mechanisms.

We then learn that this implant technology was developed after World War II and by now as we approach the millennium, I'm more than sure that this technology has superseded it's expectations.

The Lammers speculate that the military Intelligence community are or have more than likely been using this technology for secret Government project. Some of the photographic plates contained within this book, clearly show the implants on the X ray skulls of various individuals. The Lammers uncovered a pre-classified 1960's Government document pertaining to a secret project called MKULTRA which clearly showed that the CIA was interested in expanding implant studies onto humans, they speculate could the various military agencies that implant various humans, be using the 'alien' cover story to mask their own clandestine endeavours? This is entirely feasible and may account for a high percent of abductions the world over. This is not to say, that the actual 'alien' abduction phenomena is not real, it may well be, but we have to consider the fact, that the Military Chiefs would be more than happy to use the 'alien' abduction cover story in order for the public at large to be kept in the dark about their secret and unsavoury actions.

Of course there is another way to look at the implant phenomenon, and this is that the military chiefs may be inserting these implant devices, to monitor 'real' UFO Abductees respiration, muscle tension and physiological data. There is no denying the evidence by UFO Abductees, when they say that they have witnessed military personnel, either on board a strange craft, or in an underground cavern whilst they have been 'operated' on by 'beings' which are clearly not human. Admittedly implant technology has it's medical benefits, (for a whole range of reasons). One can safely say that a pacemaker is one of the biggest implants that we have in the human body which serves a very useful purpose, but what we are talking about here is entirely different. We are talking about the implanting of devices (without consent) into bodies of terrified victims by humans and 'non humans' alike. The one main aspect of the Lammers' book is the continued reference to the fact that many UFO Abductees are taken to underground facilities where they see both humans and 'non humans' alike. They (the Abductees) also witness strange disc shaped craft, large dark unmarked helicopters. They are interrogated by military personnel, sometimes viciously, and with mind bending drugs, all in a desired attempt to find out from these poor unfortunate Abductees what the 'aliens' have told them. I found the following paragraph quite illuminating in regards to the overall theme of the Lammers' book.

"Perhaps the military split the personality of some Abductees with known mind control techniques like sensory deprivation, spin programming, flashlights, electric shocks, rape, in order to create 'Manchurian Candidates' for information gathering purposes during alien abduction experiences".

The Lammers then pose two interesting questions to the reader.

1 Are MILAB Abductees Military programmed 'Manchurian Candidates' who spy for a secret Military task force in alleged 'alien crafts'? Are they so called 'Trojan Horses' inside 'real' UFOs during an alien abduction experience

OR

2 Is their alien abduction experience a synthetically programmed screen memory for hiding secret spy or military missions?

We can deduce from all this, that the military people are clearly involved and very much concerned about the alien abduction phenomenon as they have been for decades now. The CIA FBI and NSA have in the past denied their involvement in the UFO study, but thankfully under the Freedom of Information Act passed several years ago now, it was plain to see from the documentation released,

that the above agencies were indeed, very much involved with 'what's going on' and are surely now 'still so!' In closing this article, I must say that I am deeply concerned about not so much the threat from the 'non humans' in all this, (although that is still a concern) but the threat and deceit from those people of whom we elected to serve and protect us. They are abusing their trust, they are abusing their positions to learn what is going on, but ultimately they have now become a 'big art' themselves in the UFO problem. It seems inconceivable that we have a situation such as this, it's like something you would find in a 1950's B movie or back street American comic shop, but this is 'real' this is 'happening' and it's happening now. I think we should be deeply concerned about what is going on, this is a crime against humanity. But like any crime, we require proof, and this subject is so bizarre that the stories told to us by these unfortunate UFO Abductees may not be believed, but slowly we are turning the screw, this monumental book has untold possibilities for the community, no longer are we talking about strange lights in the sky, we are now on the threshold of an alarming twist in the UFO enigma, a twist that is unsavoury and demands action. It's bad enough having to deal with UFO abductions at all, but to have the military involved (who deny everything) just begs for action to be taken.

I don't know what comes next, it is my hope and the hope of many others that something can be done about this, that the tables can be turned (so to speak). As we approach the new century, I am concerned and intrigued at what might happen next within the confines of the UFO subject. It's been with us for many years now, what lies ahead! I expect that there are more twists and turns to follow and whatever happens next, I hope that for the sake of humanity the new experiences will prove beneficial to us, and may lead us into a better world, a world of which may find us sharing with people not of this Earth.

The following information is compiled mainly for use in assessing whether a heavenly object could be a UFO. Many mistakes are made by misidentification of VENUS which is extremely bright and usually seen just after sunset or before dawn low in the sky towards the direction of the Sun. After disturbed atmospheric conditions, usually after wind or rain, Venus, at low elevation is known to "bob about" as if it is a moving object, but this is an illusion caused by viewing through layers of turbulent air. MARS becomes very bright every 2 years and will be prominent mid-year 2001. Its distinct "red" colour amongst all the white stars nearby often leads to UFO reports (the colour in the murky atmosphere of southern England is more often orange-yellow). The MOON can also cause confusion if sitting behind thin cumulus cloud at low elevation - it can take on strange shapes and colours. A check on the phase of the Moon on the night in question should eliminate rogue sightings.

The system used to determine apparent brightness of stars and planets is called MAGNITUDE. A scale is derived by comparing the brightness of the star VEGA in constellation Lyra, or ARCTURUS in Bootes as the zero figure. Anything brighter than these will have negative values of magnitude and dimmer objects, positive values. A change in magnitude of 1 unit denotes an increase or decrease in brightness by a factor of 2½ times. In practice, nearly all stars have +magnitude while only a few stars and planets have - magnitude. Over Britain only negative magnitude objects will be bright enough to show up against the background stars. The following list comprises the brightest astronomical objects:

Polaris (Pole Star) +2.0	Saturn (Planet) - 0.4*

Monthly Information 2001

JANUARY: Mercury might just be seen close to the sun in the SW after dusk. Venus is brilliant evening star lasting past 9pm. Jupiter is very bright overhead visible to 3am from early evening. Sirius visible below Orion constellation from early evening.
MOON: First quarter 2nd, Full Moon 9th, Last quarter 16th, New Moon 24th.

FEBRUARY: Venus again very bright until 9pm. Mars beginning to show by 2am but not very bright. Jupiter very bright overhead for most of night. Sirius visible to midnight.
MOON: First quarter 1st, Full Moon 8th, Last quarter 15th, New Moon 23rd.

MARCH: Venus still visible to 3.5 hours after sunset on first, but disappears by 30th to become a morning star. Mars rising at 1am - just into negative magnitude by end of month. Jupiter on view until midnight. Sirius visible to midnight.
MOON: First quarter 3rd, Full Moon 9th, Last quarter 16th, New Moon 25th.

APRIL: Venus just visible in E towards sunrise. Mars is now in view by midnight with Moon close by on the 13th. Jupiter becoming less prominent, setting by 10pm on April 30th.
MOON: First quarter 1st and 30th, Full Moon 8th, Last quarter 15th, New moon 23rd.

MAY: Mercury offers best views of the year close to sunset. Venus becomes very bright before dawn to east. Mars on view from 10pm close to Moon on May 10-11th. Jupiter setting by 9pm so will not be seen.
MOON: Full Moon 7th, Last quarter 15th, New Moon 23rd, First quarter 29th.

JUNE: Venus rising 2 hours before dawn by June 30th - very bright. Mars reaches opposition on 13th; closest to Earth on 21st reading -2.4 magnitude but at low altitude near south horizon. Jupiter is not visible.
MOON: Full Moon 6th, Last quarter 14th, New Moon 21st, First quarter 28th.

JULY: Venus showing at 1am by end of month - very bright. Mars gradually fading but still visible low to south.
MOON: Full Moon 5th, Last quarter 13th, New Moon 20th, First quarter 27th.

AUGUST: Venus rises 3 hours before sun as brilliant morning star; Close to Jupiter at 3am on August 6th. Mars still visible but very close to south horizon. Jupiter showing post midnight.
MOON: Full Moon 4th, Last quarter 12th, New Moon 19th, First quarter 25th.

SEPTEMBER: Venus rises 3 hours before sun as brilliant morning star. Mars visible on southern horizon until 10pm. Jupiter rises by 10pm in late September, visible in early hours.
MOON: Full Moon 2nd, Last quarter 10th, New Moon 17th, First quarter 24th.

OCTOBER: Venus rises 2 hours before the sun by end of month. Jupiter appears earlier to end of month (8.30 pm). Sirius showing after mid-night.
MOON: Full Moon 2nd, Last quarter 10th, New Moon 16th, First quarter 24th.

NOVEMBER: Venus rising almost with the Sun so may not be very prominent. Jupiter now seen most of the night high in the sky; near Moon on 5-6th. Sirius shows late evening.
MOON: Full Moon 1st and 30th, Last quarter 8th, New Moon 15th, First quarter 22nd.

DECEMBER: Venus changes to evening star - not readily seen. Jupiter is very bright and visible all night - near the Moon on the 3rd and 30th. Saturn is in a good position and fairly bright. Sirius visible beyond Orion by 9pm.
MOON: Last quarter 7th, New Moon 14th, First quarter 22nd, Full Moon 30th.

METEOR SHOWERS: The heaviest regular showers are Quarantids 2-4th Jan, Perseids 11-14th August, Leonids 16-18th November, Geminids 12-14th December. In recent years publicity has been strong particularly in relation to the Leonids which are said to be in their most active phase, but very few good viewing sessions have been reported. A meteor or "shooting star" is visible for barely a second. If object is seen for more than 5 seconds, it may be a UFO.

ECLIPSES: A total eclipse of the Moon on January 9th is the only major event over Britain in 2001. A total eclipse of the Sun occurs on June 21st over southern Africa, and an annular on December 14th over Americas. Minor Moon eclipses over Australia and NZ, 5th July, 30th December.

CONTACT INTERNATIONAL - "A DEADLY CONCEALMENT"

Opinion - By Geoff Ambler

Contact International held a conference at Oxford Town Hall on Saturday, October 16th 1993 with an impressive array of 5 visiting speakers. It was known several of these were writers who were in the throes of producing books so would give a free talk in return for publicity. At the time I disagreed that we had sufficient local helpers to steward the event so took no part in the planning or even attended the conference being at work on Saturdays.

Amongst the speakers was Derek Sheffield, who was investigating the Belgian Wave black triangle sightings of 1989-90. A review of the proceedings, including Sheffield's talk was written up by Brian James - who had only recently joined Contact - and published in Awareness, Vol 19 No 3, pp 24-27. As editor I reserve the right to check and correct manuscripts, so made a few minor adjustments (so I thought) to Brian James' piece. Unfortunately not being present at the conference and being unfamiliar with Mr James' writing style, I later was told that I had altered a section on the D. Sheffield lecture referring to the interception of scrambled Belgian air force jets who went to intercept the triangular UFOs to read as "flights of an Air Patrol nature" rather than referring to "Combat Air Patrol and Interception". Unknown to me this small faux pas was later used as an illustration of how Contact International was part of a "deadly concealment" of information on the Belgian cases and an implication we were in cahoots with the Ministry of Defence amongst other things.

Mr Sheffield first produced his book in 1996 (pub. Blandford) entitled "UFO: a deadly concealment". The whole of Chapter 12 is entitled "Contact International" and consists of an exchange of letters between Derek Sheffield and Brian James, published in full, plus a reproduction of James' conference review that appeared in Awareness. At the time I had no idea of how our group was being used as part of Sheffield's "grand conspiracy" concept. Comment might have come earlier, but as Brian James was an active member of the Contact International/ later CIUFOR council until 1998 it was not considered prudent to deal with this matter until now.

Mr Sheffield's book consists of about 40 pages of solid facts concerning the Belgian UFOs - the remainder for the most part (c 200 pages) consists of a mass letter exchange between Sheffield and MPs, government offices, both home and abroad, the military, United Nations, NATO, the press and anyone he can complain to about the failure to respond of the above! Only the Queen and the Pope seem to have been exempt! His zeal reaches such a height that he appears to have written a letter to himself! (Chapter 20, Page 188). When the other parties reply with the usual politeness and formality, his implication is they have something to hide, and pursues them with further mailings until they eventually cease the correspondence - then taken as a sure sign of a cover-up. Virtually nowhere in these rambling exchanges does any new information emerge on the Belgian UFOs and like many other cases they remain totally unsolved. Ten years after the Belgian flap many hundreds of sightings of similar shapes and light configurations have been reported worldwide and remain beyond our comprehension.

It is encouraging for Ufologists to know we have replicable data indicating something of tremendous technology is out there, but, in my opinion, the "McCarthyite" or witch hunt approach of Mr Sheffield's book is totally counter-productive in establishing anything beyond what is already known. Other recent books showing masses of semi-blacked out

government documents might appeal to some readers, and probably add to the fantasies that "more is there" but which is never found.

Back to Chapter 12 - at the time of Derek Sheffield's enquiries, Nick Pope was running the UFO desk at the Ministry of Defence. For the first time in many years, Mr Pope did endeavour to answer our enquiries with something more than the off pat: "There is no threat to British air space." Having discussed a number of matters with our researchers, the Contact International group was apparently recommended as a source of information on the Belgian cases to Derek Sheffield by the MOD. By implication this might appear as if there was some collusion between CI and the MOD by suspicious minds. In fact the more likely explanation was to "pass the buck" after a continuous bombardment of Sheffield correspondence to the UFO desk. In the event Derek Sheffield was booked into the Oxford conference by Michael Soper after a number of phone calls.

In Chapter 12, Sheffield reproduces the Brian James review that appeared in Awareness 19.3 (As editor, I was totally unaware of this). Having commented that the script contains very "pro MOD" statements concerning the nature of the threat of these UFOs, he then questions Contact International's motives. Since James wrote this review when he had only just joined the group, it surely would not be the policy of CI but of the writer himself. Sheffield then concludes:

"Taking all these factors into account, I have reason to doubt the motives of Contact International. It could be that their actions are purely circumstantial. I hope that they are. I suspect, however, that they are being used in a deception by an intelligence that is beyond their wildest dreams."

Well very flattering indeed the last remark - but I'm afraid "purely circumstantial" is more like the correct conclusion.

The chapter then goes into a sequence of 3 letters from D. Sheffield to Brian James and one from James to D. Sheffield. He entitles the first "A LETTER TO CONTACT INTERNATIONAL" and James' response "REPLY FROM CONTACT INTERNATIONAL". The letter to "Mr James" is published in Awareness 19.4, pp 20-21. Any implication that CI council as a whole drafted, or even saw this return letter by B. James is erroneous. The last 2 letters are actually denoted as "A LETTER TO BRIAN P. JAMES." Most of the council were totally unaware that Sheffield intended to use our conference proceedings and this correspondence as part of his book.

There is much technical detail in relation to the nature of the interceptions in Brian James' letter, but towards the end he produces a monumental paragraph which virtually gives Sheffield's conspiratorial ideas a field day:

"It is true that CONTACT has recently used associations within the MOD to enable them to view at the Public Record Office, specific documents of RAF interceptions, from what I have seen they date back to the mid-1950s, but one document that I have seen a copy of does suggest an exchange of data on sightings when an object flew back towards Europe. I was not involved in this visit, and I am not sure if others are planned in the future, but I doubt if I will be invited to participate."

The visit to the Public Record Office was arranged by myself, using my car, and open to any data research member wishing to attend. In the event 4 persons including myself made the trip, but there was no reason to prevent Mr James from coming also. A report on the visit is to be found in Awareness 19.4, pp 3-5. The implication that Contact had covert knowledge from the MOD for this visit is laughable - we went through the same security and

procedures as any other visitors to the Public Record Office at Kew. During the tenure of Nick Pope at the UFO desk, he forwarded a reference list of files we might be interested in looking at the PRO. This is the very same list that Sheffield also received in a letter from the MOD dated 24/2/93 and reproduced on page 82 of his book. Any photocopies brought back from Kew were from released files available to any bone-fide researcher - the files that Sheffield should have seen himself.

In reply to this letter (10/4/94), Sheffield considers:

" You will understand - bearing in mind my application to the European Parliament - that it would be unwise for me to become involved with any UFO groups. A very effective weapon of the establishment is ridicule. Unfortunately UFO groups leave themselves open to this charge."

Thanks a bundle Derek, but I fail to see how one talk at a UFO conference could have made any difference to your European Parliament venture which appeared to have ended in a maze of bureaucracy and missing letters in any case.

In this "conspiracy by correspondence" we see the slightest slip of the pen, failure to reply, or reply by a minion as being clear proof of covert activity. Assuming people in high places know any more about UFO events than the groups who study the phenomena year in, year out is both patronising and naive. Mr Sheffield seems to have spent 3 years of his time going nowhere - apart from the pilots who intercepted the UFOs, the radar controllers and the ground witnesses, nobody else can probably add a single piece of information to the 1989-90 events over Belgium. The British system of justice is based on the premise of "innocent until proven guilty". In the Derek Sheffield system everyone is guilty (of covert activities) until proven innocent. At least I hope the above cleans up the accusations or insinuations concerning Contact International, but perhaps it would appear rather more titillating if all these fantasies were real (and sell more books)!


