# The Experts Assess The China UFO IMAGE.

It was November 4<sup>th</sup>, 2017, when I had a private message on Facebook ask me if I could assist with checking two photographs that might depict a UFO. The details of the photographs are as follows:

Hi. Mr. Mantle,

These photos were taken at Dian Lake, Kunming, Yunnan province, China. I had two colleagues with me. The date was November 1<sup>st</sup>, 2017.

They were taken using a HTC U11 mobile phone.

I am a sales V.P. of a medical equipment company in Taiwan. We had a booth at the CMEF show in Kunming, Yunnan Providence, from October 28<sup>th</sup> to November 1<sup>st</sup>:

(<https://www.cmef.com.cn/g1407/s3961/t4279.aspx>). My name is Chiung-Wei Chen and I am from TAIWAN, not China and I am 44 years of age.

After the show was finished, my two colleagues and I took a taxi to Dian Lake for some sightseeing. We got there around 3:00 P.M. The weather was great, just a little cloudy and I personally like taking photos while travelling.

As usual I took some photos there. You may refer to the attached photos I have sent which were taken on the day in question. However, I didn't notice the object there at the time of taking the photos, so, of course I heard no noise either. After going back to my hotel, I posted those photos to the family group of IM software called LINE (social media- IM software LINE which is like WhatsApp.). My wife's little sister was the one to notice the object on my posted photos and advised everybody (on social media) at 8:58 P.M., but I didn't pay much attention to what she said as I thought they were making a joke. Finally, after an hour, I checked the photo's again and saw that object was on two of photos that I had taken.

I checked with my two colleagues that had been there with me but they only took photographs of them selves at the lake o they did not see anything nor did they photograph anything unusual.

As you can see the two photographs depict a 'doughnut-shaped' object jut below the branch of the trees which overhang the edge of the lake. I asked Chen if the two colleagues that were with him had taken any photos as well, they had, but






only of themselves (selfies). Chen had some other general photos taken at the same time but none of them showed the same 'doughnut' UFO (see left & below).



So what do the two photographs actually depict? Well, with today's digital technology that is available to just about anyone I think it only fair that all such photos must be judged with an air of caution. What I can say is that Chen has been very cooperative but of course that means nothing. Are the photos authentic, do they depict a genuine UFO? Are they authentic but depict something tossed into the air and then photographed? Are they a fake/hoax, something added digitally after the photos were taken? Rather than simply offer my own opinion I have instead turned to three different photo-analysts. The first of these

is Dr Bruce Maccabee. Here is what he had to say:

### DR BRUCE MACCABEE



Dr Maccabee received a B.S. in physics at Worcester Polytechnic Institute in Worcester, Mass., and then at American University, Washington, DC, (M.S. and Ph.D. in physics). In 1972 he began his career at the Naval Ordnance Laboratory, White Oak, Silver Spring, Maryland; which later became the Naval Surface Warfare Center Dahlgren Division. Dr. Maccabee retired from government service in 2008. He has worked on optical data processing, generation of underwater sound with lasers and various aspects of the Strategic Defence Initiative (SDI) and Ballistic Missile Defence (BMD) using high power lasers.

### ANALYSIS FROM DR BRUCE MACCABEE

There should not be a "truck tire" in the air over this lake. Whatever it is I would guess that it is not far away (closer than a mile) because the bottom is very dark (sky brightness readings like 180 out of a grey scale of 256 [0 to 255 brightness level] while the dark areas read around 20) the width of the image is about 0.028 of the total width of the picture. Don't know the angular width of the picture but probably about 35 degrees or about 0.61 radians Thus, if it were a mile - 5280 ft - away its diameter would be  $5280 \text{ ft} \times 0.028/0.61 = \text{about } 240 \text{ ft}$ .

**VERDICT:** I don't know. They might hang something small from tree branch but just because it could be faked doesn't mean it was. Maybe flying triangles will be replaced by flying donuts!

Dr Maccabee just doesn't know what the photos depict. He simply says "I don't know" although there is a hint of a possible "hoax" there I reckon.

HTC U11 mobile phone, quite clear and decent quality. Upon analysing the images closer the object appears Disk-Doughnut in shape with serrated edges around the circumference of the object and overall dark in appearance. I overlapped two of the supplied main images which proved the object had moved its position. I also enlarged, enhanced and inverted the two images of the Object and overlapped them, slightly off-set, where you can clearly see the serrated edges on the Object match up. The witness Chen (Chen, Chiung-Wei) did not see anything when he was taking the scenic photographs; it was only much later when a relative had been viewing his images noticed the strange looking object.




Analysis of Serrated Disk Shaped Object Captured Over Dian Lake, Kunming, Yunnan province, China, 1st November 2017.

Interesting images, definitely a Disk/Doughnut Shaped Object with serrated edges around its entire circumference in free flight (unknown if in free-flight or thrown). Object does not appear to be suspended in any way, upon closer analysis of the four similar images all appear to be taken from the same location at the same time, enhancement of the object show that it has an illuminated glow emanating from it (Aura). 




#### ANALYSIS FROM TOBIAS LINDGREN

My analysis of the "Chinese pictures" One of the images, with the object in sight, has been destroyed by some software that puts an HDR-filter on. The second image shows signs of highlights from the sun, suggesting a three-dimensional form. Between the two pictures I suppose the object moved naturally like it was being blown by the wind.

My idea is that the object is lighter than air, possibly some kind of balloon. If there is something that is lighter than air, there is a physically smallest size to float in the way it does in the pictures. The idea came to me when I remembered one of our own cases. A very small object in a picture, round-shaped or U-format high in the sky, but under the clouds.

I will add some pictures to help explain what I mean.

As always, I do not say that this is the truth, but that the theory that it is a balloon is highly probable.

UFO-Sweden

It goes to show that photo-analysis is not as easy and as straight forward as we might imagine in these days of digital technology. I think it is fair to say that all three of the above photo-analysts agree that the 'UFO' is not the product of CGI but is something that is airborne and was photographed as explained by the witness. Tobias thinks it may be some kind of balloon and he may well be correct. Jason is of the opinion that this object is in free-flight or has been thrown and Dr Maccabee just says he doesn't know what it is. I think my suggestion that this could possibly have been something picked up and dropped by the birds is as good a theory as any other but for now I think it only fair that we leave this photo-case open, as we have not reached any definitive conclusion one way or the other.

# A Strange Train Journey & More Unusual Tales By Malcolm Robinson

The following story may sound incredible, and one may be tempted to think that the event was 'made up', who could blame them, but what we have to remember, is that we are dealing here with a phenomenon which in the strictest sense of the word, is totally 'alien' and we should never discard any information purely on the basis on how absurd it all sounds. This case, does not deal with any UFOs, so why then do I include it here? Well simply because it contains information of which was relayed to the percipient, information concerning 'people' (!) who apparently lived under the waters of the Firth of Forth! I said it was incredible and now you are about to learn why. During 1988, I was in conversation with Peter Hough, Peter, who lives in England, is a prolific writer on matters such as UFOs and ghosts and is a first class Investigator. I had asked him to send onto me, any cases that came his way from Scotland, this he duly did, and the following information is gleaned from an interview that I conducted with the percipient, one Audrey Hunter (\*), at that time a 45 year old nurse who worked and lived in Edinburgh. During my interview with Audrey, I learned that she had experienced many strange and paranormal events throughout her life, and I was of the opinion that she was herself, to a degree, somewhat psychic. I've noticed in my studies that there is a fair percent of UFO witnesses that are psychic, and I've often wondered if the more psychic one is, perhaps there is more chance of them seeing a UFO or indeed ghost. This is a subject which I will be discussing in a later chapter. Indeed, I will be featuring a UFO sighting that Audrey experienced over Perth, in the upcoming Tayside Chapter. Of all the incidents that Audrey recounted to me that warm

afternoon in July 1988, the following incident was the most strangest.

It was back in 1982 that Audrey Hunter left Dundee train station at 11:45am travelling onto her destination which was Edinburgh. The journey was pleasant and the scenery was nice as she gazed out of her carriage window. After a while the train pulled into Cupar Station where everything seemed to be going haywire. Audrey noticed, as she gazed out of the window, a British rail guard rushing up to the train explaining as he came into each compartment, that the train would be delayed due to something that had happened to a puller the main Engine of the train. Audrey continued to look out of the window where she then observed lots of police and an ambulance. It was at Cupar station that she saw a young chap come onto the train and come into her carriage where he sat directly opposite her. Outside, there was still a lot of activity going on of which, as Audrey recalled, there was one particular Scot Rail Guard who was running to and fro in a twenty yard line, backwards and forwards, saying, "*Something's happened, something's happened*"! As if this wasn't strange enough, suddenly Audrey started to hear 'Religious Music' pervading throughout the carriage. (Audrey was in one of those older trains in which compartment carriages were the norm, I remember them well). This music sounded to her, as if it was being played on a recorder, and she couldn't for the life of her understand where it was coming from. The chap who had just come onto the train and was sitting directly opposite Audrey, rose from his seat and informed her that he was going out for a look. On his return, Audrey noticed that he was quite shaken and he informed her that there was a whole line of police out there and that no

one could tell him what had happened. Amazingly, this Scot Rail Guard was 'still' running up and down the platform shouting, "*Something's happened, something's happened*". Another puzzling Aspect of this already peculiar incident, was that she then observed that there were lots, (and she stressed 'lots') of people getting into a line of taxis, and that they appeared to be in an extreme hurry to get into those taxis! She couldn't account for this as Cupar is a small station. She also observed that the ambulance now had its back doors open, and that two men were carrying an empty stretcher towards it. Audrey felt, that as she was a nurse, she would be better going out to offer her assistance, however, for some strange reason; she just couldn't get out of her seat! At this point, a guard came in and said that he thought that they would now be moving off any minute. A few minutes later, a light that was fixed onto a railway bridge came on, and she felt the train shudder and start to move out of Cupar station. Still puzzling over these incidents, she was then surprised to see a child lean right out of the train door and start to make faces at her. Audrey started to comment on this to the chap who was sitting across from her, she mentioned that this was ridiculous if not totally dangerous. She can't recall going over to the child to pull him back onto the train. It must be obvious that she did not, for as she mentioned to me in our interview, this child was still in this position and making these faces, all the way up to the Forth Rail Bridge, (which was quite some distance).

Audrey was by now becoming increasingly alarmed, 'everything seemed totally ludicrous'. She began to think that she was a player in some sort of 'Twilight Zone Episode'. To

cap it all, as they approached the Forth Rail Bridge, the chap opposite her, a young man in his early twenties, and who as we may recall, got on at Cupar Station, started to talk 'all funny', (as if someone was talking through him, as Audrey related). As the train pulled onto the Forth Rail Bridge, this chap said to Audrey that there was 'another world below the water of which the bridge spanned, (The Firth of Forth). He said that it was a beautiful place and that 'he' used to live there'. Audrey immediately asked him *"How could you have possibly lived there?"* He replied that he had come into our world for his work and continued by saying that he had wished that he had never left this beautiful place. Audrey asked him if he was sure that he did not live 'near' the bridge, on Inchcape Island perhaps. His swift reply was "NO" followed by, *"There is a better world down there, and I hope one day to go back to it, but I feel that it will be a long time before I do so"*.

Audrey was by now thinking that she was going crazy. She assessed her situation and was convinced as she could ever be, that this was 'not a dream', that she 'had not' fell asleep on the train. No, she was fully awake and in command of all her faculties, she just couldn't explain any of it. This strange chap continued to speak to Audrey about this world under the water then he mentioned briefly where he was working at present. He told Audrey that he had to get a few taxis and buses to his place of work which he explained, he intensely disliked? As far as Audrey can recall, she was sure that he said that he worked in a nuclear power station, but can't recall where about. The strange man kept saying that he should never have left *his* world! Eventually the train reached Waverly Station in Edinburgh, and Audrey noticed that this strange chap made a quick exit, but before he was fully out of the carriage, he turned round to Audrey and said, *"By the way, you'll read about today's accident in the papers tomorrow"*. And with that, he quickly turned around and was lost in the crowd. As Audrey pondered over these Events, she heard over the station's intercom, an announcement which stated that Scot Rail were sorry for the late arrival of the Dundee to Edinburgh train which was held up at Cupar Station. After departing the train, Audrey felt sick and disorientated. That same day, she mentioned to her fellow nurses about her strange train journey, she had to, for they had commented on how dreadful she looked. One chap who worked at the hospital and was listening to her strange tale, said that he had an uncle who actually worked at Cupar Train Station and that he could check through him if in fact the train had been delayed there. This he did, and on returning to inform her, said to her, *"I've got something to tell you, and I hope that you won't faint on me"*. Puzzled by this remark, she asked him to tell her what. He said that the train did "NOT" stop at Cupar Station, and that there were "NO" accidents reported there for some time. And anyway, surely if there had been an accident then it would have been reported on the six o'clock news? Accepting this with bemusement, she asked, *"Well why was the train late, why did I get into Waverly Train Station at 4 o'clock instead of 2 o'clock?"* With a shake of his head, her informant replied, *"I really don't know, I just really don't know"*. Audrey felt that the station announcement was 'still part' of this strange episode. She recalled that this chap who claimed to have lived under the water below the Forth Rail Bridge was smartly

dressed and did not look out of place or out of the ordinary, and it wasn't until they reached the Rail Bridge that his manner and voice took on a new mannerism.

Well, quite a tale eh! What are we to make of a story like that? It simply sounds beyond belief. Was it all a dream? We can only take the witness's word that it was not. So where does that leave us? If the Corroboration is correct, i.e., that on checking it was found that the train did not stop at Cupar station then we are left with four possibilities. (A) This 'must' have been a dream. (B) It was partly a dream up until the bridge when this strange man was only pulling her leg about living under the waters of the Firth of Forth. (C) The witness is lying. (D) The witness is telling the truth. I've known Audrey for some years now, and a more pleasant person you'll not meet. She attended our SPI meetings when we held them in Stirling where she would sit quietly and take in what was being said. She is not out to seek publicity, far from it, she would rather just listen to other people's stories knowing that she too can relate to them for 'she too' has had many strange incidents occur to her throughout her life, no more so, than that strange and disturbing train journey back in 1982.

## THE STRANGE EXPERIENCES OF A PILOT.

The following information, was given to me by a presenter at Grampian Television when I was up in Aberdeen doing the live T.V. show entitled, "We The Jury", which I've related elsewhere. She stated that I had permission to use those events 'on air' so long as I did not disclose the name or whereabouts of who wrote it. The witness felt, that he just had to get these events of his chest, and would like some of them debated live on T.V. more so the events of when he was a pilot. He felt that the many sightings by aircraft personnel, should be given a fair hearing, and although he was not keen to come on T.V. himself to discuss his own events, he did want those events to be revealed. As it turned out, I never really got the chance to discuss this chap's UFO encounters on air, but I present them here to illustrate that it's not just the ordinary man in the street that can witness UFOs, but it's also the case that many pilots can as well. The following, in his own words, are the incredible incidents that John Logan (\*) has experienced.

John, who lives somewhere in Aberdeenshire, now takes up the story.

*"As a young boy I lived in Paisley, and from my window I could see Glasgow Airport and its runway". "I took a great interest in aircraft from that time (I was aged about 7), and it wasn't long before I could recognise and name every aircraft by name". "Even after dark, I could recognise the type of aircraft by the sound of its engines". "When old enough, I would visit every air show that I could, and so learned to recognise Military Aircraft as well, even at unusual angles during their displays". "I became an apprentice engineer aged fifteen and a half, and a private pilot aged eighteen". "To date, I have 27 years experience in Aero Space engineering, and flying as far afield as the Far East and South East Asia". "I would say that from this information, a person such as I, would not easily mistake an aircraft for something which it is not". "Whether seen from the ground or a cockpit*

window.” “Pilots and other professional Aero Space people, do sometimes see objects which are not readily explainable, but most choose to say nothing about it because they see no point in getting into a discussion with, or being ridiculed by, someone who ‘wasn’t even there’”. “A lot of very interesting cases are being lost due to those very knowledgeable people who look at the Universe through closed eyes and minds and then decide how it was made up and how it should be”.

“I first became interested in UFOs at about the age of 12”. “In front of my house then, was a large area of open ground and waste land”. “My friends and I would sometimes camp there at weekends”. “Then we started seeing lights on the ground, always long after dark”. “I don’t mean lights like light bulbs, but exactly like the round area of light given off by the spot lights at the theatre”. “These spots of light, usually two, would move slowly along the ground and over the area where we camped, then continue along and over the golf course until out of sight”. “There was no beam with these lights and no noise, and no indication of their origin”. “The nearest road was 200 yards away behind some high ground and trees; this meant that these lights were not from cars”. “After it became more frequent, we became so scared”. “We ran off one night and left our camping equipment, I don’t remember if we ever went back for it” (!) “Some months later, some local people said that they had seen odd glowing lights slowly descend into the forest by the golf course (during daylight”!). “Over the next ten years, I saw some very interesting things, but for now, I’d like to relate some Aviation related events.”

### SPRING 1982, GMT 17.00HRS.

“From my Hotel room window in Liverpool while waiting to go on duty, I noticed a flat shaped object moving slowly and erratically across the city at a height of between 1,000 to 1,200 feet and with a speed about 400 knots”. “Its movement was like that of a large falling leaf, but it never approached the ground”. “Its height just varied in a climbing and descending motion by about 200 feet”. “I got an estimate of its size as it passed over the Old Tower Restaurant, its size being about 50 feet”. “Due to its motion, the underside flashed when in view which was odd because it should have been the top side due to the bright sky”. “I watched it for around 3 to 4 minutes heading in the direction of Liverpool Airport, so I decided to call Air

Traffic Control, who informed me that a Dan Air pilot who was on the approach could also see it. “

“The following morning, 02:00am we were en-route from Liverpool to Edinburgh with Royal Mail cargo”. “Heading north from Liverpool and at a height of 9,000 feet on a climb, we noticed that the ground below us had become illuminated by something like a giant camera flash which appeared to originate below our height”. “It happened several times then stopped”. “It was not lightning and it did not affect our radios and we didn’t see it again.”

### SUMMER 1983.

“En-route from Glasgow to Shannon (Ireland), we had just started our descent, when it suddenly appeared that another aircraft was directly below us on the same course and climbing”. “It seemed to be only 50 feet or less below us and very slightly faster as it was appearing below our nose cone”. “It took one or two seconds to realise what was happening before executing a full power climb turn to the right”. “We immediately called Shannon Radar, but they assured us that there was no ‘known’ traffic to affect us”.

“We turned back onto a heading which should have enabled us to see the other aircraft as it had passed so close, but ‘nothing’ could be seen”. “For the record, it had been a clear day with ‘no cloud’. “On discussing the matter between ourselves a little later, we both agreed that we saw no flight deck, windows, or cockpit”.

### 1996, STRASBOURG.

“My most recent sighting of an odd looking object, took place in 1996 in Strasbourg”. “The time was 10:00pm and it was dark”. “We were preparing to fly to Paris as we did every night at the same time”. “I was walking around the aircraft removing the ground locks, when I noticed an orange dull coloured sphere moving with no sound across the Airfield”. “The cloud base was 500 to 700 feet so the object had to be below that height which made it possible to estimate its speed at 75 to 100 knots”. “It was a damp misty evening with little to no breeze”.

### **John Logan.**

John went on to inform me that he had numerous other stories concerning his time piloting aircraft and witnessing strange phenomena in the skies, but the above illustrated some of the more unusual ones.

# The Pentyrech Incident

**26<sup>th</sup> February 2016**

On a cold night in the early hours of February 26<sup>th</sup> 2016 multiple witnesses to a huge UFO and other lights became a part of what was to be known as The Pentyrech Incident. This is an investigation which uncovers the story of military planes and helicopters, a chase, explosions and shaken buildings, damaged trees and wreckage on the ground.

The more unexpected; such as an Apache helicopter landing with its cockpit on fire, multiple road closures into Smilog Wood, yellow taped areas for military access only, weird snow with mystery men in white coveralls and an entire countries airspace being shut down for the night.

If you're a fan of the X-Files, This scenario could be scenario worthy of an episode. Fiction though entertaining, never matches up TO THE REAL WORLD, whatever you may think this really happened on a cold winter night in South Wales in 2016.

What you are about to read is as follows. Testimonies collected from the witnesses, photographic and video evidence from the day of the incident and a polygraph test confirming the sighting as true. In October of 2017 a full and thorough investigation was launched by Swansea UFO Investigation, which found correlating and corroborating evidence, which led to the conclusion this incredible sighting was TRUE.

Caz Clarke opens the investigation with her statement, which is going to be accompanied by her neighbour Dave, who is another eyewitness to the craft and lights.

**Friday 26<sup>TH</sup> February 2016 Statement of Caz Clarke (Alias) – EYE WITNESS**

*"I suppose it really started a couple of days before the "Event"..."*

*To be honest it was my neighbour Dave who noticed it first, a small propeller driven plane larger than a Cessna flying very slowly in a figure of eight pattern.*

*After a few of these passes the plane would fly in a large circle but still close enough for you to hear it and return to continue its pattern. Once this had been pointed out to me that was all I could hear day and night. This went on for three days. An identical plane would turn up and the other would leave. The airspace was never left unwatched.*

*My neighbour Dave made some enquiries at the MOD to find out what the plane was all about, but no one admitted having a plane in the area. "*

**Caz's neighbour Dave (Alias) – EYE WITNESS says the following in his statement.**

*"Started 23rd Feb with a prop plane circling our area all day and all night.*

*"24th woke up to the same noise as we all went to sleep. Once again stayed circling all day did start to wonder are we under some sort of threat with world tensions as they are. I spoke to the neighbour Caz and asked have you heard that plane circling for 2 days Caz said yes I think something's going on but what we just never knew."*

*"That night went to bed with the sound of the plane echoing over our house's by 11.45pm I was pissed off with it so I decided to email local M.O.D a shitty email about their plane keeping me and my neighbours awake they didn't reply to my email at all put a pillow over my head and tried to get to sleep eventually did about 2am. 25th woke up to the same drowning noise from the plane above."*

Despite the attempts to uncover the mystery of the planes peculiar flight pattern, the Ministry of Defence made no effort to answer the questions of concerned citizens. By now it has become clear to the witnesses that greater attention must be drawn towards the small military plane behaving in an unusual manner, this would continue for two days and nights prior to the main event.

By this time another neighbour named Donna (Alias) who lives in the same street, had become intrigued by the planes appearance and in her statement she says the following.

*"I had received a message from Dave on the 24th to ask me if I could hear the plane. I had turned everything off so I could hear and then it seemed that the plane was all I could hear."*

**In Caz's statement she also noted**

*"It occurred to me there was more going on than first meets the eye and not a small training exercise at all, it costs a lot of money to keep a plane up 24 hours a day for three days for no particular reason."*

It's also worth noting, that this planes actions along with its partner plane, has never been fully explained by the MOD at any point during the mysterious events of February 23<sup>rd</sup>/24<sup>th</sup> ,25<sup>th</sup>/26<sup>th</sup> 2016.

**Identifying the Planes**

What follows in this article is the culmination and combination of all evidences and proofs. During the early night hours of 26<sup>th</sup> February 2016 in Llantrisant Wales; the Military & Air Force knowingly and expectantly anticipated the arrival of an UNKOWN FLYING OBJECT or UAV (Unidentified Aerial Vehicle) in the farmland area

of Pentyrch.

Swansea UFO Network has not only been able to identify the planes involved but have radar evidence of their aerial activities in the days prior during and after the “Event”. An interesting fact arose during the investigation, when it was discovered the **whole** of the Welsh air space was closed to all traffic on the night and early hours of the 25<sup>th</sup> and 26<sup>th</sup> February 2016.

Why would the Military close the entire counties airspace if there really was a “planned” Military exercise in the back of South Wales? Or is it as we suspect the Military were expecting a chase?

The two planes have been identified as military planes by the website planefinder.net. The details of these craft are listed below as well as photo images.



**Circling Patterns.**

To understand the strange behaviour of the planes we must review the planefinder.net radar returns. As early as Tuesday 23<sup>rd</sup> February 8:30pm GMT the planefinder.net


radar reads the transponder signal at 8:30pm, the planes themselves were spotted early on in the day circling the skies of Llantrisant. Military planes can be seen on planefinder.net radar in Llantrisant; days before, during and after it was over. The official explanation for the Military activity on the 25<sup>th</sup> and 26<sup>th</sup> February 2016 was that it was part of Exercise Chameleon which was a joint operation in Durham, England.

Exercise Chameleon was a Military exercise that ran the week BEFORE 26<sup>th</sup> February 2016. It did not include South Wales nor in any of the Sorties listed did it mention low level flying over a civilian area




in the early hours of the morning using live ammunition!




**Call-sign JACKAL02 – 11:50pm Wednesday 24/2/2016**





The constant circling of these planes along with the fly-over of other military vehicles began to get the attention of civilians and many began to sense something was not right here. By Thursday night and into the early hours of Friday morning, people living in Pentrych started to see the reason the military was there.

It's here that Caz, Dave's and Donna's statements continue into the night and early hours explaining exactly what they did what they saw and what they heard, in their own words.

**Caz's statement continues...**

*"After discussing with Dave and Donna (another neighbour) the aerial activity we all came to the conclusion the military were watching for "something". On this note we decided we would skywatch to see if anything happened. I remember it was freezing and lit a fire to keep us warm with the small plane flying above us in the same figure eight pattern. It was getting late approx. 2am and I was just about to go back into my house when a second plane turned up."*

*"We watched as the small plane left the area and the now much larger plane started to fly big circles, we estimated it took approx. 5 minutes to do one revolution. As the plane turned we could see it had a large mushroom shaped object on its back my neighbour Dave immediately identified it as an E3 Sentry plane. At this point I decided to stay and watch a while longer and Donna went in the house to make hot drinks. I threw another log on the fire and began to count the revolutions as the E3 sentry plane went around. Seven times the plane went around."*

**Along with Caz, Dave also describes the night's events as they began to unfold.**

*"We watched for hours but nothing happened until about 1.30/1.45am, we were just calling it a night as nothing was going to happen, or that's what we thought anyway, until another plane joined the circle then we thought this is interesting we watched for 10 or so minutes them both circling and then another turned up and joined the circle but one left and headed off we thought to refuel as it had been up so long 2 more planes joined the circle whilst the other one was gone but 15 minutes after it leaving he was back there were now 5 planes circling. So we watched on in amazement as to what's going on."*

**Donna wasn't the type to watch the sky but this activity had raised her curiosity to a new level and in her statement she said.**

*"The next day 25/2/16 the plane was still moving around the area so we had decided to go out that night I could see the plane it seemed to be going around above the garden the plane was going out wide and coming back in a bit like a number 8 and it was doing that a few times and then would do a circle and keep repeating the same pattern this had gone on all night. We had all been out for a good few hours as the night had gotten colder and to be honest I had gotten a little bored watching the plane and had decided to go into Caz's house to make some hot chocolate's and use the bathroom. When I was in the bathroom I thought I heard Caz call my name I knew that Caz and Dave had seen something but couldn't rush out."*

*"I had gone into the kitchen poured the drinks and started to walk out the garden to where I had left Dave and Caz only to find that they weren't there. I did call out but had no answer so I went back into the house to wait for them.,*

*I heard something coming fast I first thought it was helicopters but I ran to the front room window to see two planes coming towards the house heading in the direction of the fields behind Caz's house, I did go to the kitchen window but by the time I got there (7 big footsteps) the planes were out of my sight, there was lots of air activity I just couldn't see it from where I was but I could hear it."*

### **The Military Presence**

What Swansea UFO Network has found out during their vigorous investigations, is there were over twenty (20) vehicles in the sky surrounding the area in all directions. These actions were not so much a military exercise, but more the actions of setting up a perimeter net of Military air craft. The reader would have to ask the question; are these actions that of an ambush? Or preparing a welcoming committee for an expecting visitor?

An E3 Sentry plane is a sophisticated piece of military hardware; its primary role is for surveillance and is used in for **Air Intelligence, Surveillance, Target Acquisition and Reconnaissance (ISTAR)**. The RAF uses the E3 Sentry along with the Shadow R1 to gather intelligence for other units to plan strategies for combat or defence purposes.

The E3 Sentry came into the area some time just after 2am. Caz and Dave were able to identify this plane by its protruding radar dish on top of the middle body. This plane has many capabilities such as **on board command centre, radar, air to ground communications, satellite surveillance and electronic radar jamming systems.**

Spotting an E3 Sentry plane is not a difficult task, but. Unlike the two previous planes named Snake and Jackal, they had transponder signals that could be located on planefinder.net, the E3 Sentry had no such transponders signal to identify it.

This however did not halt SUFON's attempts to do so. Thanks to a plane spotter website whose members are able to log planes as they appear, an E3 Sentry plane was logged on the 25<sup>th</sup> February flying over St Athan airspace. An E3 is not something spotted in the same everyday skies, it is the belief of SUFON that this was the E3 Sentry connected to that night.

This here is the main part of the case, other events will play a part in the story, but it's all centred on what happened during the time between Friday night 2am-4am GMT. Military officials and the mainstream media that reported it, called this a training exercise codenamed CHAMELEON, but as you are about to find out the evidence does not fit the explanation of what would be defined as an exercise.

Many people witnessed many things that night, but none more so than Caz and Dave who are the two KEY WITNESSES that SUFON team have spoken to, and we are **convinced** that they're telling the truth and what seen that night, was exactly what the Air Force and Military were waiting for.

From the conversations, interviews and general discussions we have had with the KEY witnesses, it's clear the main craft with lights was enormous. It towered over the tree line and one such description was 'it resembled a huge high-rise building so big that if you were looking at the bottom you couldn't see the top and visa versa'. This is where the two key witness testimonies differ, solely because one was watching more the top of the craft whilst the other was fixated on it touching the ground. It benefits the investigation of SUFON more as this gives everyone the more whole picture.

**Caz continues and at this point we have decided not to interrupt her testimony because if what she has said is true and we at SUFON believe it is true then this should be read by everyone and not just us.**

*"It was approx. 2.40am when suddenly, "THERE!" One red light was visible in the field behind us! I shouted for Donna but there was no answer. I said, "Come on Dave" and with that we jumped over the small fence and ran to the gate, next to the field. Dave ran through the gate but I called him back (I don't mind seeing them but from a safe distance). We stood by the gate staring now there were three red lights, closely followed by many more that formed a pyramid shape with a curved bottom. The object appeared in the space it didn't come down from outer space." A green object shot out of the top of the large ship and just bobbed about skipping but not really going anywhere it appeared "happy." I couldn't*

tell the shape of it because it was so bright, brighter than the moonlight. The large craft was getting lower in the sky heading to the ground I stood on the five bar gate to get a better look through the bare trees and exclaimed again to Dave "It's landing, it's landing!"

"As I watched the lights on the craft started to change colour the closer it got to the ground. The right side string of lights lit up really brightly and went from tail light red to white/orange illuminating part of the sides of the ship showing it was a pyramid shape. The lowest lights were the brightest and from the corner light five fingers of what appeared to be an extended hand of lightening reaching out to touch the ground."

As you will read here; the E3 Sentry is circling but can still be identified amongst a crowd of gathered planes, this is still possible even when a building sized UFO appears in the fields behind your house.... a little humour for thought.

"For the entire time the E3 sentry had circled above but now our silence was broken by four larger planes, I don't know what they were I just remember the green light emanating from the green object in the sky, reflected on the backs of the planes outlining the engines on their wings and illuminating them. The green UFO flashed three strobes at the planes as if deliberately trying to get their attention and the four planes followed the green UFO.

"I wouldn't say they chased it more like they were following it. The green UFO skipped around in its own time almost child-like; it wasn't in a hurry and bobbed away towards Llantrisant in a skipping motion from side to side. The red ship had faded and disappeared into the darkness it had come from."

Dave's account is equally astounding; as he goes on to say many similar things but has his own details to add. "The closer it got to the ground more smaller very bright

red lights lit up around its perimeter until it was fully lit up around the outside it then tilted to the right and showed a curved bottom semi-circle. It just paused for a second planes still circling overhead then about 15/20 red orbs all come from it as if they were floating around it protecting it intermingling with each other some started to turn green whilst others stayed red the large craft started to slowly move west without gaining any height as it drifted away slowly it turned to darkness and the lights all went off."

"The orbs remained some also went to darkness and invisible to the naked eye one of the red orbs slowly went up into the centre of where the main craft come in it stopped turned to green flashed very fast and slowly moved off towards the south west bobbing along slowly 3 of the aircraft from the circle pulled out of formation and followed it although it wasn't going fast these planes wasn't going to catch it for sure".

**While Dave is witnessing these events unfold with Caz noticing things of her own. This is not the end of the event, for something else is about to happen that not many people will ever experience. Caz goes on to describe what happened next....**


"I was still standing on the gate when right above us were two red barrel shaped lights flattened on the top and on the bottom and about the size of a small car about 30 feet up, one above the hedge to our left approx. 30 feet away and one above the oak tree to our right approx. 20 feet above us. Whilst standing on the gate I waved. I could see that it was made up of lots of smaller bulbs, not as small as LED's but more like the ones you would see on a fairground ride but when you looked closer the contents of the barrel were moving it reminded me of sitting too close to the TV as a small child and watching the little black dots jump around on the screen."

"It hovered over us silently it felt like we were being scanned. Suddenly the object changed colour from tail light red to traffic light green and slowly began to move off drifting over the houses without a solitary sound. The other object stayed red in colour but only moved when the green barrel started to move. The red barrel moved towards St Athans in a south westerly direction and the now green barrel travelled North East towards Cardiff."

"I did not see any other craft in any other part of the fields it seems they came to look at us. We walked through the wooden side gate and stopped... " Dave and I walked down to the next gate closer to where the ship came down...the E3 sentry plane followed us. It was pitch black and neither of us had a torch the ground was uneven and slippery so we decided to walk back to the first gate."

**In Dave's statement he continues to corroborate Caz's version of events, as he is also now witnessing the barrels observing their human counterparts.**

*"I jumped the gate and was heading over towards where the remaining orbs could still be seen when Caz shouted where you going?"*

*"Over there I shouted and Caz said no stay here don't be silly so I listened as I was in a state of shock and awe of what I had seen. 2 red orbs started to come across to the right of the gate where we were standing one of them come closer just above us and stopped it turned green as if we wasn't a threat to them and carried on towards the east with the red one we watched them until they also went to darkness. We then both decided to walk the path through the field to have a look as by now you couldn't see any orbs or lights."*

*"We walked to the next gate along but couldn't see anything. The 2 other planes were still above us as if they were still watching something that we couldn't see we hurried back towards home with one of the planes just above us like they were watching our every move it stayed above us right back to the house."*

**As these momentous events continued to unfold, Caz continues with what happened next.**

*"After the two barrel shaped objects moved off we began to walk back to my house when our silence was broken yet again by three apache helicopters. They were flying from the direction of St Athans towards Llantrisant very low across the fields in a pyramid formation about half a mile away, big red pulsing lights from the three helicop-*

*ters lit up the ground in front of them and you could see the grass/shrubs moving with the force of the rotor blades. Dave and I walked past my house to the telephone box and the road frontage there to get a better view of them but by this time they were already out of sight."*

*"We returned to my house Dave was physically shaking but elated and I was a little saddened and angry that our military pursued them. We sat and discussed what had happened over a cup of hot chocolate...it was late and I was exhausted and freezing cold through to my bones...I needed sleep. I got undressed and lay in my bed my head still buzzing with what I had witnessed I couldn't sleep at all. I tossed and turned and "BOOOOM" an enormous explosion from the direction of Llantrisant which is a couple of miles away."*

*"The whole time the E3 sentry plane was flying in the airspace above the event and at one point actually began to follow the witnesses. Three apache helicopters were also there flying low across the fields at ground level from left to right on a course to intercept the green coloured UAV."*

**Dave's testimony continues.**

*"We decided to go down to the other field which looks over at St Athans airbase as we could here very heavy chopper's in the distance and as we did 3 Apaches were heading in our direction flying in pyramid formation with one red light on each we then decided we had seen enough and it was time to both go home."*

*"I went home and I was full of adrenaline so wasn't going to sleep anytime soon so sat in the window looking across at the fields where these Apaches were scanning by zig zagging back and forth across the field where we seen the craft and orbs they slowly ended up over Llantrisant area you could see them almost five bombing whatever they were doing it was now around 4am and there was one almighty explosion come from the direction of where the Apaches were flying around followed by another huge explosion about 4 or 5 seconds later."*

*"I could only see 2 Apaches after this but could here twin rotor Chinooks coming from at Athens in the distance there must have about 5 or 6 Chinooks heading to the same place as the Apaches for the next 3 hours they were flying back to start St Athans then back to Llantrisant as if they were transporting something this was very loud and went on for hours and yes I knew they were Apaches as they have a very heavy distinctive sound to them. That's all I can recall from that night but one never to be forgotten."*

Given the level of detail that is being described between Caz and Dave, the scale of the events that are taking place is unlike any training exercise you've ever heard of. Imagination would be key and vital to making up this story, but as we go further into the case the more the statements combine to show these events did actually happen.

**Donna not only describes planes and helicopters but**

**also heard the explosions and mentions it in her statement.**

*"I couldn't see anything and Dave and Caz were not back yet I had heard some big rumbles in the sky but couldn't see where they had come from but assumed they were heading towards the planes. After a while Dave and Caz came back to the house and looked like they had seen a ghost but they were also very excited like their adrenaline was running high and had asked me "did you see what happened?"*

*"I said "I didn't see anything but did hear the planes and choppers going over the fields"*

*"After they had told me what had happened I couldn't believe that I had missed it whilst they had continued explaining what had happened over the fields and myself asking questions about it I had said to them both that "we will see what they army has to say as the air noise, they will have to come up with a cover story as it would of woke a lot of people"*

*"after about 5 mins of talking it was getting late for me so decided to go to bed and left Dave and Caz where still running with adrenaline and were talking about the event so I had left them to it. Sometime after me getting into bed (can't say a time) I had heard a big bang from outside, I can't say if I had been woken by the bang or if I was just falling asleep but it sounded like a bomb had gone off."*

### **Explosions Reported Multiple Times**

All three witnesses heard an explosion from several miles away and many more were reported on by members of the public. Swansea UFO Network in their investigations found people who not only heard the explosion but felt it too. Several reports were of buildings shaking during this explosion. They were in shock, many were awoken suddenly and along with walls shaking the windows rattled.

In an attempt to broaden the appeal for witnesses to come forward, the investigation into the Pentyrch Incident went out to the UFO research community.

The case was broadcasted by Linda Moulton Howe on Coast to Coast radio on 21<sup>st</sup> December 2017. SUFON investigator Gari Jones and Key witness Caz Clarke were interviewed beforehand via a telephone call from the home of Linda Moulton Howe in the USA.

This was a chance for people to hear the evidence so any other witnesses may feel confident to come forward. After the show aired Linda received an email from someone who identified their self as a member of staff who was working on the night of the 26<sup>th</sup> February 2016 at the Royal Glamorgan Hospital. The person who contacted Linda Moulton Howe chose not to give a name, but the email was forwarded to Swansea UFO Network and this is what the witness says.

***Hi Linda, I was listening to the very recent (Dec. 21, 2017) Coast to Coast radio show which included yourself talking to Gareth Jones from the Swansea UFO Network about the incident of high strangeness in and***

**around Llantrisant, South Wales. I was on duty as a nurse at the hospital that night (Feb. 26, 2016) and I can explain what I experienced.**

*I must add that I no longer work at that hospital anymore and am in fact no longer working in the NHS (National Health Service) and it is only now that I can contact you regarding this matter.*

*I believe it was around 02.00 (Editor: others say it was later than 2:00 AM) when I heard an extremely loud explosion, which sounded like it was right outside the hospital. This was then followed by a smaller explosion, which also sounded a little distance away from the hospital. I was on duty with two other people who heard exactly the same as myself.*

*I have combat experience in the British armed forces and can tell the difference between a bang and an explosion. After hearing these explosions, I automatically thought that it was a terrorist attack as this is a sign of the times that we are unfortunately living in. I also contacted hospital security to find out if they were aware of what was going on. Suffice to say they had no idea what I was on about.*

*I then went outside the hospital to the entrance and the smoke that was around resembled a very foggy night and it is correct that the smell of sulphur was all around. I didn't see any lights, but there again I wouldn't have seen them due to the smoke. I did however hear a lot of noise sounding like aircraft and also helicopters. I had to go back to my workplace very shortly afterwards and that was where it ended for me. I phoned security again and asked them if they had any information concerning what had happened and they told me that there had been a military exercise and that was it. I don't believe it was a military exercise at all basically for the same reasons as Gareth Jones. A member of staff informed me that all the roads in the local area were closed by the police and I can assure you that they must have drafted in police from outside the area because with the cutbacks in the police force there are not many on duty at night and they number around 10 constables and a sergeant in that area.*

*The only mention in the media was of a military exercise and this was on the Wales On Line news app. The media here is the same as the rest of the UK in that it has its own narrative and agenda. I don't believe we will ever get the truth about this incident. To give you an idea of where I was that night — if you go to Google maps and find the Royal Glamorgan Hospital — go to satellite view and you will see the roundabout just outside the hospital. As you come off the roundabout into the hospital there is a left turn which you follow and I was in the end building of the first three."*

This statement is very close to what other people have stated to SUFON. Though the names get mixed up i.e. Gareth instead of Gari (honest mistake), the time suggests the explosion was after 2am and not 4am. The person may not be able to recollect the exact time, but the statement to Linda clearly made details of explosions, smoke and road closures.

During this time the Freedom of Information requests began to go to the Royal Glamorgan Hospital. A number of

issues were raised, but one of the main issues questioned is to whether the MOD issued any warnings or gave any information regarding a Military exercise PRIOR to the event. SUFON researcher Gari Jones received a reply confirming "NO WARNINGS" were received and NO PRIOR NOTICE given.

Military exercises are a common practice in Wales and around the UK. The implied notion that the events of 26<sup>th</sup> February 2016 are of similar standing begins to be circumvented when the FOI requests are understood. Despite requesting notifications from the local authorities and officials of Llantrisant, SUFON has been unable to find any information that anyone was notified of the alleged military exercise.

Freedom of Information requests have also gone into South Wales Police regarding number of reports received by them during the night of 25<sup>th</sup>/26<sup>th</sup> February specifically mentioning explosions, helicopters or lights in the sky. **SUFON have received no response.**

The Police have also been asked what roads were closed and for what reason specifically in the Llantrisant and immediate surrounding areas. **SUFON are still awaiting their response.**

#### 25<sup>th</sup>-26<sup>th</sup> February 2016 Social Media Llantrisant

When the sun began to rise on the morning of the 26<sup>th</sup> February 2016 the residents of Llantrisant were waking up to the news that a military exercise was the cause of the early hour's activities. The website Walesonline.co.uk put out a story titled 'How military training planes and helicopters kept parts of South Wales awake' the story was published at 12:56pm, 26th February 2016.

The comments in the story offer some insight to the thoughts of people during that time, despite people being aware of the actual noises and aircraft, what is becoming more obvious as time goes on in this investigation is people had no inclination or notice to an exercise in the area.

*Diane Blackmore, of Pontyclun, said: "There were three helicopters flying very low for hours. I phoned 101 and they confirmed it was a military exercise. I was worried that something horrible had happened."*

*Christopher Buckley, of Llantrisant, said he was awoken by an explosion in the middle of the night. He added: "There were helicopters and planes everywhere and then something hit and made an explosion."*

A number of twitter accounts were referenced in the article and again the consensus taken from these sources of information is that people were disturbed by the activities of that night. People couldn't sleep, or people were either awoken by the noises and explosions that took place.

Rhian however tweets a message at 3:51am to South Wales Police suggesting an explosion happened followed by three helicopters and within a matter of four (4) minutes their response was 'This was a military exercise'; seems only after the explosion and the helicopter following it did they choose to respond to her at all. Rhian's first tweet @9:39pm 25<sup>th</sup> February 2016 was not answered.

The twitter account with user name 'MR Myself' @ 3:38am 26<sup>th</sup> February 2016 replied to this tweet by saying he had heard two (2) explosions with some sort of military exercise involving Chinook, Puma and Apache helicopters.

Amazingly within one (1) minute the twitter account of Wales online was quick to reply by saying 'they are currently working on a story about this'. These are incidences where people were talking about explosions.

We have no doubt with the volume of evidence including the seismological data and witness testimonies that a huge explosion did take place big enough to have registered 40 miles away in Monmouth. So what caused the massive explosion so close to a hospital and over a residential area in the early hours of the 26th February 2016 that shook buildings and filled the air with smoke, yet left no visible damage behind?

It's not just the timing of the responses I find odd, it's the wording of them. Very quickly the South Wales Police responded saying 'This was a military exercise' never actually saying what caused that explosion or why the Military needed to do that next to a hospital in a residential area at 4.25AM!

Again the mentioning of explosions and helicopters circling around and the mention of a strange smell in the atmosphere i.e. something burning, sulphur, this will be explained later on in the article.



Upon learning the existence of this signal recording, BGS were asked about the origin of this signal. Here is an excerpt from their response.

**It seems likely that the small transient signal recorded at approximately 0420 results from a local noise source in the vicinity of the site. As discussed in a previous reply, this may result from human activity such as traffic or machinery.**

So this signal came could've only been the explosions heard from the Smilg Wood area that night.

I think the reader of this article will be scratching their wondering what the source for all the bizarre events that cultivated into the Pentyrch Incident. Well to make things even more interesting, around the time the explosion was

reported an Apache Gunship had to make an emergency landing.

Something forced an Apache helicopter to do an emergency landing at Cardiff International Airport a civilian airport just a few minutes after the explosion with smoke coming out of its cockpit. Below is a picture of the Apache and here is the log data recorded for that time.

**Landing** at 04:34 with an emergency (smoke in the cockpit) is "*Gunship 2*" Apache AH.1 ..parking on Echo ..**departed** at 22:16 as "*Gunship 1*" for a circuit and departure to the Northeast

Since the time its taken to learn what the information gathered by all parties, Caz Clarke has been contemplating its deeper meaning and potentially ground-breaking understanding into what the UFO cover up could mean.

**Under the MOD's own rules it is illegal to use live ammunition in a civilian area in an "exercise".**

**This was a real event, and a real situation in a civilian area. The military struck with absolute precision and we think it's time we, the human race, were told the truth about who our allies are and who our enemies are.**

**We are grateful that if this UAV was hostile that our Military were there**



to deal with it. How deep are we in that we are fighting these craft of inter-dimensional origin? The build-up of space based weapons and pilotless drones like the Terranis is an indicator if there is not going to be an extra-terrestrial war they are certainly doing a good job of preparing for one.

### Pentyrch – Smilog 26<sup>th</sup> Oddities, Anomalies & Strange Weather

Once the night was over and the military was no longer in the skies, it would normally be expected that the army would pack up and go home once exercise Chameleon was over, however in the days that followed the ‘Main Event’ a number of strange incidents had begun to take place which just makes this case even more intriguing.

It had been a long night for Caz and Dave and after the explosion happened they had managed to get some sleep. It was sometime after 10am on the 26<sup>th</sup> and still energised and excited by what she had witnessed earlier; Caz at this point had been joined in her house by Dave, Donna and her long-time friend Steve. It was at this moment that Steve heard from Caz and Dave the amazing things that they had witnessed.

The craft and light in Pentyrch had provided enough evidence to keep any UFO investigator busy, but this case was just getting warmed up and only deeper in terms of its mystery. Late morning had come and Caz is joined by her friend Steve to become a witness to what followed next.

#### **Caz continues to explain the events later that morning.**

*“I don’t know how or when I fell asleep I just remember waking the next morning about 8am “wired”. My friend Steve called over as he often did and he was immediately bombarded by the events of the early hours. Dave was equally “wired” and bounced through my front door waving the cover story for the night before announcing a military exercise....only it wasn’t an exercise it was real time real life”.*

#### **Steve's’ statement to Swansea Ufo Network follows on from Caz’s**

*“I went over to Caz’s house in the morning about 10am. Before I could sit down Caz told me what had happened in the early hours of the morning. She was talking really fast I told her to calm down and I would put the kettle on. She started telling me again what she and Dave had seen the night before I was gutted I missed it and realized that I had heard the planes but didn’t think anything of it at the time.”*

*“I have known Caz for over twenty years and she has never lied to me so I do not doubt that what she told me is true. During this time Dave and Donna had also come for a cuppa Dave was really excited and was saying something about a military exercise cover story. Donna said she was gutted because she didn’t hear Caz calling her when the UFO first arrived because she was making hot drinks.”*

*“I don’t think I got a word in because everyone was so excited and I began to feel that too so I said to Caz let’s go and have a look. Caz wanted to go to Llantrisant common to see what exploded and if we could find an impact crater. I drove us to Llantrisant common.”*

**By morning Steve is becoming interested and embroiled , Donna started to see a cover up beginning to take shape.**

*“26-2-16 Dave, Steve and myself had gone to Caz’s house for our morning cuppa’s, Caz was already telling Steve about what had happened earlier on and Dave had come in saying " have you seen what is on Wales online? " We had all seen that there was report on Wales online about the Army doing a "training exercise" over the Welsh valley earlier hours of the morning.. I was saying at this point "I knew it! I told you they would have to make a report". With all of us talking and Steve seeing how excited both Dave and Caz were that Steve had said "let’s go see if we can find anything out there.”*

Caz explained that comments had been made on “Wales online” in the report that Dave had showed her regarding the military exercise in the early hours, some comments said helicopters were hovering very low over Llantrisant common in the early hours; this was the starting point for the Pentyrch investigation.

**We are now fours into investigating what happened on 26<sup>th</sup> February 2016. Here is what followed. Dave decided to take his own car to Llantrisant common and this is his account of what he saw. Dave said,**

*“26th Feb took a drive over Llantrisant common just to have a look around I come across a huge pile of white metal all precision cut and neatly stacked in a pile I did have these pics but they disappeared of my laptop along with all my FB conversation's from about 23rd Feb up until about 5th march all my personal pics of my son and myself just vanished of my laptop they did return about a week later but missing certain pics the ones I took of the piles of white metal never returned.”*

### SUFON Becomes Involved & The Pentyrch Four is Born

To this end the evidence gathered by the witnesses on the 26<sup>th</sup> and 27<sup>th</sup> February 2016 is priceless, but was only gathered for their own curiosity and satisfaction. When Swansea UFO Network got involved in October 2017 they were extremely fortunate to find the witnesses from Pentyrch had saved and kept the photographs and footage of what happened directly after the event.

SUFON have taken the investigation to another level with EMF and Geiger counter Tests and without their help and expertise this event would never have been exposed. In the words of **Mike Maunder** from Swansea UFO Network he said **it would be a travesty if this event was never told.**

**Steve drove Caz to Llantrisant common and this is what she says,**

*“So great was my need to find out what happened Steve and I went to Llantrisant common hoping to find a crater in the ground but we didn't find one. We drove around the roadway there and noticed that all the scrap metal that had been previously scattered over the common for years had been collected and stacked in neat piles along the roadside, after a while we stopped the car and we went to ask two dog walkers if they had seen or heard anything in the early hours of the Friday morning.*

*One man explained how the chinook helicopter landed behind the royal mint while two helicopters hovered over the common. They also suggested the explosion was heard coming from Smilog woods. I am not local to the area so asked where Smilog woods were located, and they pointed to the large wooded hill rising behind the Royal Glamorgan Hospital.”*

### **People were dropping hints and here is what Steve statement reads**

*“I drove us to Llantrisant common. There was **yellow tape** everywhere and piles of scrap metal stacked tidily all the way down the road. We drove around the common to see if we could see any damage on the ground but there wasn't any. I stopped the car; Caz had spotted two people walking their dogs and wanted to talk to them.*

*We got out and walked over to them there was a man and a woman Caz asked if they lived locally and asked if they remembered anything from the early hours of Friday morning. The man said there were two helicopters hovering over the common and a chinook helicopter had landed behind the Royal mint. Caz asked if they had heard an explosion and they said yes the explosion came from Smilog woods. Caz said we are not from here where is Smilog woods and the man pointed to the big hill behind us. I don't think the woman said anything except maybe to agree with the man. Caz asked if they had seen anything unusual but they hadn't. We thanked them and got back in the car Caz and me were both buzzing now. Caz said lets go and see if we can find an impact crater so I drove us up to the car park in Smilog woods.”*

Enthusiastically Steve and Caz were making progress and learning about the other events of Pentyrch, but now the case would begin to involve Smilog Wood, here is where we begin to learn why. The hunt for the cause of the explosion and what happened to the green light, took the Pentyrch Four Crew in that direction and here are the statements that describe them.

### **Caz told us in her statement.**

*“When you look at Smilog from the hospital side it resembles a giant “W” with the right hand valley being lower than the left. Knowing the trajectory of the green UFO we proceeded to Smilog woods. Nothing grows on the forest floor there everything is dull and brown. We walked along the path that leads out of the car park to the right and looked carefully for any signs of damage to the trees or the ground.”*

*“We rounded a bend and on the floor we could see large branches that had been snapped off from the canopy. The branches littered the forest floor in a straight line*

*and nowhere else. We followed the debris trail in a straight line and eventually came out at the top of the ridge by the roadside. In front of us and to the right was the damage I had been looking for. Tree trunks had been snapped off twenty feet in the air other trees had been snapped and at the top of the trees surrounding this area the trees appeared to have a chemical burn on them similar to firework damage.”*

The Pentyrch Four which consists of Caz, Dave, Donna and Steve is a name that makes it easier to get people involved in what is happening. These are the early stages of a major case that has now developed into Pentyrch Four and SUFON, whose members are Emlyn Williams, Mike Maunder and Gari Jones.

Starting from early October 2017 SUFON was learning the incredible tales the Pentyrch Four and what they had discovered. Now while Caz and Dave has certainly witnessed the incredible craft and the lights around, Steve himself was certainly starting to get his experiences documented.

### **Steve continued his account of Smilog woods and with Caz here is what they were finding.**

*“Caz had said that she knew where the green ufo was flying so we had an idea of where to start looking. We walked along a path from the car park that goes around the edge of the wood looking for damage to the ground or trees. When we walked around the bend I could see broken branches lying on the ground from the tops of the trees. We both looked and made a way through into the wood from there.”*

*“There were big branches right through the wood all snapped off left and right of us in a straight line so we followed it. We came out on a road just up the hill from the car park where we had started. We were knackered by now and needed to get back to tell the others and have a cuppa we had found the debris trail and knew in what direction we needed to go. We went back to the car park knowing we had a good starting point for tomorrow. I drove to Cazs' house and went in Dave and Donna had been waiting for us to come back. We had a cuppa and filled the others in on what we had found and made a plan to go to Smilog woods the next day.”*

### **Smilog Plan begins**

When they got back to Caz's house Dave and Donna were waiting for their return. Caz and Steve proceeded to tell them what they had found and a plan was hatched to go to Smilog woods the next day and take cameras with them to film and photograph the site. Donna and Steve wanted to go over to the Pentyrch landing field so after a short break for refreshments and a cigarette the Pentyrch Four walked over to the field and Dave and Caz lead the way.

When the group got to the site where the main craft had come down, normal expectations suggested they would find things flattened or maybe burns to parts of the surrounding area. Instead the area where they had looked for these was surrounded by snow and a very strange snow

indeed.

### **Steve said in his statement the following about the snow**

*“We wanted to see burns on the ground but there weren't any but it was snowing! Just there only in that field the surrounding areas didn't have it. We walked round all the other fields but there wasn't any snow in those. The snow was weird like polystyrene balls but smaller and it just rolled off of your clothes and didn't settle. Donna said it was spongy snow like marshmallow. The whole thing was very strange indeed and not normal.”*

### **Caz had witnessed the craft before and had expectations of her own, what we expect and what we get are sometimes never the same thing.**

*“On our return Dave and Donna wanted more info so we walked over to the landing field expecting to see scorch marks on the ground but there were no markings except for one area a single patch of grass in an otherwise field of tall snake grass surrounded by gorse bushes. The Gorse bushes weren't burnt but appeared to have had the life sucked out of them all on one side.”*

*“The only other strange thing apparent was it was snowing! It wasn't like ordinary snow either resembling bean bag balls but much smaller and spongy. It wasn't snowing in any of the surrounding fields just that one. We walked around the perimeter of the landing field in the adjacent fields but there was no snow yet you could stand on the edge of the field and hear the snow landing in front of you. It snowed in that field for two days.”*

### **Donna the other member of the P4 crew was witnessing her own accounts of a strange event.**

*“All four of us had gone over to the field behind the houses for a walk to see if there was anything there that we could see, we had gone into the field that the UFO had come close to the floor to search it, Dave and Caz were telling Steve and I which way the green one was going so we decided that we would walk the way it went. We had come out of that field into Tyn-Y-Coed road and across into another field to see if there was anything over there, when walking into the field Caz and Dave had shown Steve and I which way it went and pointed towards Llantistiant we had a look in this field for a little while but couldn't find anything so went back into the UFO field.”*

*“When walking into the UFO field it was snowing but this snow was different you could hear it hitting and see it rolling off your coat, among us we started to look at the snow but it wasn't snow it was the size of rice but in a ball shape but it felt like marshmallow, you could squeeze it and it would near enough go back to its original shape, when you had hold of the snow it didn't melt it just went away. As Dave, Caz and Steve stayed by the burnt looking bushes in the middle of the UFO field I had headed towards the side of the field to have a walk around as I came to the field the right side of my face became warm which I thought was strange 1, as I don't feel the right side of my body (nerve damage) and 2. it*

*was February !! And snowing in the field that I was walking in.”*

**As if the snow was not baffling enough, the sensation Donna was feeling made things even more puzzling. When locating the source of a warm feeling that she was sure her body should not be able to feel, the sensation and intuition of being watched came over her.**

### **Donna continues the story of the snow and feeling of being watched**

*“I moved around the fence line to see if the trees had blocked the cold wind or if I could try to pin point were to the warm air/feeling was but couldn't as I was doing this I had a weird feeling that something was with me or watching me I scanned the area but couldn't see anyone or anything around the field the feeling got so strong that I had called Dave away from the group so that I wasn't on my own and started to walk towards him and the other's I told them that I felt someone/thing but again we didn't see anything, we continued our conversation as we all started to walk back home.”*

### **Dave had helped Donna in her moment of uneasiness but during this time he was noticing the snow was not like snow at all.**

*“Also on the 26/27th we took a walk over the fields were we seen this craft looking for any signs of something landing there was a flat patch in the field with singed bushes around it not sure if this is due to this craft or not but one very strange thing in this field was that it was snowing but not like snow all I can say is it was like small plastic pellets about 2mm in size as we left the field to cross into the next here was nothing but you could still here it landing in the field we come from you could even see it not white but more like transparent plastic but only in that field nowhere else.”*

*All the witnesses in the Pentyrch group confirm the snow in the landing field but not in the surrounding fields. The unusual material resembled snow but did not melt, more accurately it dissolved completely.*

The reporting of snow in the fields prompted SUFON to look at the weather charts for the area, to see if any kind of snow had been forecasted. What you can see in the chart below is not only did IT NOT SNOW, but the conditions aren't even typical enough for snow to have formed.


Strange weather was also noted at Smilog woods seeming like near blizzard conditions yet no snow was forecast for South Wales and more specifically Llantrisant and the surrounding areas. So amongst all the other situations we have read about in this article, WHAT WAS THE SNOW?

### **Smilog Woods 26<sup>th</sup>-27<sup>th</sup> February 2016**

Smilog wood is the next part of this investigation by SUFON and the Pentyrch Four it does appear that the source of the secondary explosion originated from this

area. Smilog Wood is just outside of Llantrisant and is regularly used for walking, trekking and mountain biking. On the 26<sup>th</sup> after driving around the Common, Caz and Steve had talked to several residents and it had been indicated that Smilog Wood would be of interest to them. Upon arriving at Smilog they had decided to look for signs of an impact and it wasn't long before they found signs damage to the trees.

#### Saturday 27th February 2016.

The “Pentyrch Four” met at Cazs’ house early that morning. Armed with cameras and fuelled with adrenalin they set off in Steve's car to Smilog woods. Large branches had been snapped off from the top of the trees and lay strewn across the woodland floor in a straight line.

All four of them were encouraged by the signs of broken

trees and branches, and as they continued into the Smilog Wood, they followed a debris trail that Caz and Steve had found the day before until they eventually came out at the top, this is where Donna began filming. She said, and below is a portion of statements that Donna provided.

*“27\_2\_16, Caz and Steve had pointed out where thick branches were on the ground with green on them. To me they seemed to of came from the top part of the trees as this wood is well known for bike riders so all the tree branches are cut off from the bottom to about 15-20 foot up the tree so bike riders don't get caught by them.”*

*“We had stood on the main path and decided that we would follow the line and see if we could find anything on the way up. The path goes around the mountain like a S shape so we followed the first bend from the car park around and decided to follow the line of the UFO, we had walked straight up from that through some over grown forest and came out on a bend on the right hand side of when you came out was a little bit of yellow tape attached to a twig on the tree there was also a bit of a gap on the right so you could stand on the perch and see over the mountain towards Llantrisant hospital and you could see all the mountains – Pontypridd, Caerphilly and Gwald-Y-Garth, so we had a good viewing point to see which way the green UFO had travelled.”*

*“as we continued up around to the left it was like a smack in the face there in front of us was a bunch of trees which had looked like they had been hit half way up, the top part of the tree had landed on to the path (bearing in mind the path is big enough for quarry lorries to drive up) I had taken out my mobile and started to film and take pictures.”*



**Steve's account echoes what Donna said, more trees broken especially in a condensed area.**

*“The plan was made to meet at Caz’s house at 9am we were all there ready. Everyone got into my car and I drove up to Smilog woods. We walked up the road to the point where we had come out the day before. This is where the hike started because we had to walk on uneven ground and fight our way up the steep bike trails to maintain walking in a straight line. When we emerged at the top we came out on the corner of another road and straight in front of us were tree trunks snapped 20 feet from the ground we had just found what we were looking for.”*



*“Donna started to film the location and the rest of us continued to walk up the road in shock really of what we were looking at. Trees had been snapped in half and everything was dead it looked exactly like something had hit it with some force. There were scuff marks on the surrounding trees with some of their bark missing and what looked like a burn mark on others. One of the trees that had been snapped at its mid-way point was between 30 and 40 feet long; this tree was perfectly healthy and lay flat on the ground with its canopy branches overlapping the road. I have never seen anything like it before. We filmed and photographed the site and continued to search the rest of the woods looking for any more damage or debris but we found nothing”.*

**As the trail of broken trees and canopies led them up the foot paths and bike trails, it was not long before something had caught their eye that needed to be looked at. Donna went on to say,**

*“As we are still walking towards the damaged trees that were on the edge of the path I could see an orange colour  $\frac{3}{4}$  of the way up the trunk (20-25 foot) as I looked at all the trees it looked like something had struck the trees in the air something hard”*

Smilog woods was becoming something of interest to the investigation and as stated in the Pentyrch Four statements there is so much damage to trees and the trunks that supported them. Snapped in two and recently fresh colouring which led SUFON to suggest as well as P4 that this area must’ve been of interest to the army when Smilog was closed off for the early morning.

**Dave continues to describe the area in his statement he said,**

*“Saturday 27th February a couple of us went up to Smi-*



*felt very eerie being up there and felt like we were being watched”*

On the picture above is a line that marks the distance between the Royal Glamorgan Hospital and the area of Smilog Wood that has been identified as place of interest to SUFON. The distance in a straight line is just less than one full mile. From the Royal Glam to the Smilog area the distance is about one mile. So any loud explosions or signs of military helicopters are going to be seen from here. Pine trees that normally stand about 50-60ft had somehow had been snapped in two pieces near the mid- section. Lying across the ground were fresh branches with lush green leaves, one tree had two distinctive burns like marks to

*log woods for a look around after hearing reports of explosions being heard coming from the woods early on the 26th February we looked around the Caz who I was with that night was also with us the Caz went to Smilog woods on the 26th with a Steve to look around so knew the way they showed us what they found and I could clearly see myself a perfect straight line through the tree's to Pentyrch.”*

it at least 20ft off the ground, this burn was at the same height the other trees that had been snapped in half. The most peculiar thing that has come to light in this case and I can find no logical explanation for this... IT WAS SNOWING IN THAT LOCATION TOO. As stated in the Pentyrch fields where the UAV came close to the ground, the same weather anomaly had happened in Smilog. This has been videotaped and documented.


*“There were fresh canopies from the tops of the tree's strewn in a line through the woods and then what looked like an impact area there were trees snapped off 20ft up very fresh smell of pine like it had just happened there was scorch marks on a couple of tree's high up looked like when I used to make genie's out of bangers as a kid it would leave that white burn mark. There was huge tyre marks around the gravel path which looked like some huge vehicles had been there also yellow tape around this area which I also saw the day before up on the common*

**27th February 2016**

Dave pictured standing amongst the debris to get the scale of the damage. Broken healthy trees snapped at the mid-way point lying flat on the ground at least 30 feet long. To the untrained eye this may appear trivial but it takes a tremendous amount of energy to snap a tree trunk at its mid-way point but six trees? Something hit these trees with some force at approximately 20 feet in the air! What

could have caused the debris trail and this destruction?

Or could it be as the witnesses have described the result of the secondary explosion that sounded like something hit the ground? What did the Military take out of Smilog woods in the early hours of Friday 26<sup>th</sup> February 2016?

Upon checking the weather reports for the area Llantrisant the conditions do not appear right for the appearance of snow. Although these slides are only still frames; you can make out the particles and in the original video which SUFON has seen and copied to its own memory storages, this is indeed a strange anomaly, which when added to the broken trees and debris trail just can't be explained away as normal. The trail they followed and the images recorded suggest only that specific area of Smilog was affected, NOWEHRE ELSE, Something odd happened here.

### Local Residents on Smilog

Residents in the area and people driving cars around 4am on Friday 26<sup>th</sup> February 2016 had a difficult time accessing the area as roads and entry point into Smilog Wood and the surrounding areas had been blocked by police. What would necessitate the Police closing roads for an exercise? As already seen in the FOI requests these closures and any other subsequent actions were never really explained by the Military.

During a SUFON onsite investigation when walking the area of Smilog with Caz Clarke, Donna and Steve we were fortunate enough to speak to two residents who described what was going on that night. Whilst walking their dogs along a public footpath we discussed several events that confirmed something odd had happened during that time.

**Sarah Wyle** and **Lisa Elliot** disclosed to us that the lanes to Smilog Wood and Beddau were closed on the 26th, the main roads appeared open but back roads did not seem to be. **Lisa Elliot** stated that the Common was busy with aircraft but was blocked off and that no one could get into Smilog Wood, later on the area had a sulphur smell in the air. **Sarah Wyle** who supplied us contact details confirmed this in person and on phone, that along with roads and lanes closed, the sulphur smell was present for many days and this was after the time the explosion happened.

**Oscar Green:** a keen mountain biker and resident of the area spoke to me on Facebook Messenger service and provided some very clear information. Below are some of the messages we exchanged.

**Gari:** I understand you go biking down the Smilog trail. Could you tell me what you saw?

**Oscar Green:** I went up the Smilog in Feb last year some time and then a week later the top of the trees were gone and the pallet bench we used to sit on

**Gari:** Do you know what date that may be?


**Oscar Green:** 26th'ish it was gone, or 28th maybe

**Gari:** So you're able to say that at around the 26th February 2016 the trees at the bottom of a bike trail were snapped off the top.

**Oscar Green:** Yeah

**Gari:** Just to clarify is that the area?

**Oscar Green:** Yeah right by the pallet thing

**Gari:** Any idea what may have caused that?

**Oscar Green:** I thought that the council done it

In the statement by Oscar Green and pictures/videos provided, it's safe to say that these trees in Smilog were

snapped off around the middle section in the early hours of the 26<sup>th</sup> February 2016.

YouTube videos from mountain bike riders who have recorded themselves riding down these tracks reveal these trees to standing before the 26<sup>th</sup> and then damaged in videos afterwards. Although they note the date of the upload, I've decided to use the upload date as a time reference to the location in question. Two things that were noticed in the recordings was that certain trees were already bent over and that some were snapped before that night but **not** the ones in the videos by the witnesses.

Notice the bent over trees and stumps amongst the taller trees (not snapped)

Twenty (20) months on very little remains of the impact site. The trees damaged on their canopies that created the debris trail in February 2016 were felled by the forestry commission in May 2017. Further information will follow in this article regarding the explanation given by the forestry commission as to the felling of these specific trees.



### Strange Men Searching - Pentyrch Fields

Another development in this case was the presence of men searching and camping in the fields of Pentyrch not long after the 'Main Event' had happened. The Pentyrch Four decided to search these fields and learn more about that night, for many days after a team of men in military style like uniforms supplied with electronic equipment, satellite dishes, computers, tents and what looked to be crates began camping in the fields not too far away from where the UAV was seen.

When seeing this all four of them decided to check out why these men were suddenly interested in sleeping in this area and using various types of equipment, by now the military exercise codenamed Chameleon was surely over, yet it would appear based on statements collected by SUFON that someone was particularly interested in searching there and for an extended period of time.

The Pentyrch four gave detailed statements and provided photographs of the strange men and women and their encampment. **We start with Cazs description.**

*"Shortly after the "Event" in February the army came to the village and set up camp behind my house in the field there. Initially we did not know they were army. They had given different explanations for being there to different residents. The first disguise was they were a fracking survey team, the second, they were doing a military exercise in case of a catastrophe and lastly they were Vodaphone. After hearing and reading in our local Pentyrch group the different reasons for them being there tweaked my curiosity, and wanted to go and see what was really going on but I didn't want to go alone."*

I have lived here for approximately twelve years and we have never had people camping out there. Not before the event or since...

Steve called over to my house to find out if I knew who they were. After a quick discussion Steve hooked up the dog and we walked over to the gate under the guise of taking the dog for a walk. As we went through the wooden side gate we saw two army men in full digital cammos. The first was tall with short dark wavy hair. The other was much shorter but a lot stockier with a completely shaved head.

As we approached the soldiers on the path the first soldier announced in quite a loud, middle classed privately educated English accent "They're doing a military exercise down in the fields, if you see funny stuff down there" At that moment the dog jumped up on the stocky soldier and he bent down to stroke her, his jacket that he was carrying under his arm fell open and revealed what looked like a well-oiled sub machine gun but this gun didn't have a yellow cap in the end of the barrel this gun was pristine. The dog growled at him and Steve pulled the dog away. I turned to the first soldier and said "You need guns for that do you?" and that's when I noticed he had an identical gun wrapped in his jacket under his arm with the stock sticking out the back. "Yes we do" was his reply and they turned and walked out of the field and through the wooden gate."

**Steve also mentioned the guns and soldiers in his statement he said,**

*"It was a short time after the big UFO that the army came to the village. I went over to Caz's house and asked her if she knew who they were and what they were doing,*

*Caz said she didn't know but wanted to find out so we decided to take the dog over for a walk to see what was happening."*

*"We walked over to the gate and I saw two soldiers in full digital camouflage walking towards us along the trail. We walked through the gate towards the soldiers. One soldier said, "We are doing a military exercise in case of an emergency situation down in the fields if you see anything funny going on."*

The dog was pulling on the lead as the other soldier got close and jumped up on him. The soldier bent down to stroke the dog and his jacket fell open that he had propped under his left arm and exposed a gun, the dog growled so I pulled her back. The gun looked brand new and didn't have a yellow cap in the end of the barrel so I think they were carrying live rounds. I was shocked!

*Caz said "you need guns for that do you?" The other soldier turned around and he had the same gun under his arm with the stock sticking out the back. He said*

*"Yes we do!"*

*Caz said "Why are you hiding them?" and he said*

*"We don't want to upset the locals."*

He spun around to walk through the gate. The other soldier walked on covering his gun as he went."

As with the planes in the beginning of this saga, now the development of the men in the field and conducting searches began to take interest. Flying planes, circling patterns, strange lights, massive craft, explosions and forest shut downs are just some of the problems with this case. Now there are men with guns in the fields where the main craft came in.

Dave's continues to enlighten us on the on the encampment.

*"I took a walk over the fields to have a look there were tents and a lot of equipment there. They had satellite dishes huge aerials and lots of other tech with screens and wires. I did try and ask this one bloke what they were doing but he was very hesitant to tell me anything and kept looking around behind him as if he was making sure nothing was in my sight after realising this man didn't want to speak I walked on I looked back and he was staring as if to make sure I had left the field. They arrived in enterprise vans and land rovers they were there the best part of a week you could hear them calling out in the middle of the night as you can hear a pin drop here."*

Cazs Statement about strange encampment

*"Steve and I walked down the trail with the dog until we got to the opening to the field where they were camped. We walked into the field and to begin with we took a wide berth to see what we could see. Suddenly from the main tent a large dog charged towards us and I asked Steve to pick up the dog quickly. I shouted to the two men I could see in the big tent."*

*"You aren't country boys are you?"*

I had a reply **"What?"** Well that was my "in".

I walked up the main avenue of their encampment bordered on both sides with tents erected with some precision; everything in perfectly straight lines not one draw string out of place.

There were two men in the main tent one seated and one standing. The one seated was in his late 50's silver hair and was wearing gold rimmed half-moon glasses and a military uniform. He looked over the rim of his glasses at me and immediately closed the lap top he had in front of him he didn't say anything he just stared at me.

*"The second man, who had retrieved his dog, apologised. I reminded him that it was lambing season and the farmer is a good shot with his shot gun. I asked what they were doing and the standing man asked who I was. I told him that I was a local resident and asked again what they were doing; the standing man told me they were **Vodaphone**. So within the space of about ten minutes we had been told two different stories."*

*"I covertly took photographs of the camp before I left and returned to my home. Steve and I told Donna what we had seen and been told. **Donna asked if we went down to the bottom where they were doing "stuff" we hadn't so Donna took the dog again to get photographs.** Steve was a little shocked about seeing the guns and went on to say that **guns in exercises normally have yellow caps on the end of the barrel to show they are carrying blanks.** I have to admit the gun I saw didn't appear to have been dragged around in an exercise. There were no scuffs or marks on it at all and looked brand new."*

As the mystery of the men camping in the fields supposedly carrying live weapons on a training exercise, somehow involving the Vodaphone company? It was clear this had to have had something to do with the appearance of whatever these men maybe knew was in that field before hand.

#### **Steve went on to say**

*"Caz and me walked down the trail. When we got to the opening to the next field Caz wanted to go in and see where they were all camped. We went in and started to walk along the edge of the field staying a fair distance from them Caz cut across the field and I went with her and a big dog ran towards us from the direction of the camp."*

*2Caz shouted for me to pick the dog up so I did and then shouted at the people in camp. Caz walked up the middle of the camp and was talking to two men in one of the big tents I waited a for a bit while their dog returned to the tent and followed behind. When I got their Caz was asking who they were and they said they were from **Vodaphone**. One of the men in the tent was wearing military clothes. Caz and me went back to her house and I was still thinking about the guns I has seen. When we got back Donna was there Caz told her what we saw and she immediately grabbed the dogs lead to take her out again to get photographs."*

#### **Donnas Statement about strange encampment**

*"THE ARMY I had heard from one of the school parents that a big group of people had made camp over the fields behind Caz's house, I had a look on my phone on a group page to see what was on there. I had seen comments that had said " they said "they are a fracking" there were a few joggers and dog walkers that had made comments on*

*this page to who these groups of people camping in the field in the winter are."*

*"Steve and Caz came back and told me what they had seen so I thought I would go and have look myself so put the dog's lead back on and headed over the field. I had gone into the field and seen a camp set up on the left, when I walked past the camp I noticed that people would stop what they were doing, I kept walking up the field passed the second gate and seen a generator so took a photo of it, up ahead I could hear and see people so I decided to go around the field (off the track) so they didn't see me."*

*"As I was hiding in the trees trying to see them I had taken some photos of a group of people as I was doing this two men came out from the bottom of the field (by the car and gate to get into the bottom field) and seemed to stop what they were doing when other members of the group would walk past them. The two men were wearing white forensics suits with the hoods up I went to take a photo but the guy on the left looked over towards where I was hiding in the trees so I ducked down."*

Caz continued to unfold the rest of the day and evening, she said,

*"Donna returned with the dog she said they were searching the fields wearing forensic suits. They didn't like being watched and would stop their activities if anyone passed by. Donna wanted to get closer to hear what they were saying. Donna said she went through the quarry*

fence in the field behind them and circled through the small wooded cove so she wouldn't be seen. Donna crept up to the fence line and could hear them speaking. There were several people in the field next to her on the opposite side of the fence "Hurry up! Find it find it!" They were clearly searching for something."

Donna managed to take a couple of photographs before returning to my house to tell us what she had discovered. Steve and I decided that we would skywatch that very evening and the plan was set. I rang Mike Hopkins to see if he wanted to join us and he agreed to come down."

### Steve's account confirms the order of events he said.

"When Donna came back she showed us the photos she had taken and the extremes she had to go to, to get them. She said every time someone went past they would stop what they were doing and wait for the person to leave. She said they were wearing forensic suits in the field and had lots of equipment with them generators and computers and stuff."

"We arranged to do sky watching that night from the field near the gate not far from their camp so I went home had a bite to eat grabbed my equipment and went back over to Caz's house."

### Caz continues the story of the men in the field

"Steve returned home to get something to eat and grab his tripod and night vision camera before returning to mine a short while later. As the sun went down I grabbed my camera and tripod and Steve and I walked over to the field next to the gate where we set up the cameras and waited. A short while later Mike arrived with his son."

### Steve confirmed in his statement,

"When it started to get dark we went over to the field and set up the cameras. Caz had text a guy called Mike Hopkins as since the event he has had an interest in the

case."

Mike Hopkins arrived at the site with his son Adam who also has an interest in the UFO phenomenon and came to observe the very strange goings on in the fields of Pentrych.

### Mike Hopkins said about the men in the field.

"I was contacted one evening by Caz to go to the gate near the sighting field in Pentrych as there were a group of men camping in a nearby field. Apparently they had been there some time carrying out some sort of ground examinations."

Steve, Caz, Mike and his son Adam continued to watch and discuss the possibilities of who these people were and what they were doing camping in the middle of winter on top of a mountain.

### Steve confirms the time line in his statement and said,

"Mike Hopkins turned up with his son and wasn't convinced they were army. He kept on saying that it was a team building group from a company somewhere. We both told him we saw soldiers with guns. I noticed there was one person in camp who had lit a fire and was putting out glow sticks."

### Caz continues

"At this point I could only see one person in the camp; it was the tall "standing guy" I had spoken to earlier. He was busying himself lighting a fire and putting out night lights and that's when he noticed us. He came over and asked what we were doing so we told him sky watching."

I asked him if he was there because of the UFO that came down, but he denied any knowledge of it but didn't ask any questions about it either. I also asked what were they doing wearing forensic suits in the field and he replied they were looking for "mock mines" I laughed at this point and asked do you often send civilians to look for

mines?"

**The group laughed at the notion but the tall man didn't answer. In conversation with Caz she confirmed the question was posed to help fill Mike Hopkins in on the events of the day. She continues her statement.**

*"Mike Hopkins wasn't convinced and expressed several scenarios including the possibility of a team building exercise being carried out by "some" company. We continued to talk to the man who said that he was a close protection officer. After a short while the rest of the campers returned in jeeps and the close protection officer returned to camp. To this point Mike Hopkins was still not convinced they were army; when the close protection officer came back to us to ask if we would be there for long. I replied we would be there as long as the sky was clear. At that moment the close protection officer said "I will have to speak to my Commanding Officer!" Mike rolled his eyes and tutted, Vodaphone don't have a commanding officer and they don't carry guns!"*

**It was apparent to everyone at this moment their cover was blown and they were Military personnel after all. Steve's account is very similar and says,**

*"He noticed us and came over to find out who we were and what we were doing. We told him we were sky watching and Caz asked him if they were there because of the UFO. The man said he didn't know anything about it but he didn't ask any questions about it either. He told us he was a close protection officer. Caz asked what they were doing in the field wearing forensic suits and he said they were looking for mock mines and Caz laughed and said do you often send civilians to look for mines in a paper suit because that's a sure way to find them.*

We didn't speak for long because the jeeps came back and he had to open the gate for them. The close protection officer returned to the camp and then came back to us to ask how long we were going to be there.

We told him as long as the sky is clear and he said he would have to speak to his Commanding Officer and walked off. Mike Hopkins tutted and rolled his head towards his son. Caz said Vodaphone don't have a commanding officer and I said and they don't carry guns and we looked at each other."

**Mike Hopkins also mentions the phrase "Commanding Officer" in his statement this is his account.**

*"When the rest of the men returned, in typically military vehicles but without military number plates, the feeling was that they were either military or government agency personnel, judging by their attitude and demeanour. At one point during the conversation, I heard one of the "team" say something like he'd have to refer that to the Commanding Officer, which seemed rather strange as they seemed to be trying to behave like civilians."*

**The only question here is what private company in a civilian world would have a Commanding Officer? After a few minutes two men appeared from the camp**

**Caz continues,**

*"The close protection officer returned with his commanding officer who immediately asked, "Have you got permission to be here?" I told him that we didn't need permission and the close protection officer pointed out that we were next to a public footpath. The commanding officer pointed to the path and said "THAT'S a public footpath!" I replied "Are you serious that's twelve feet away! The only thing the country code desires me to do is take my rubbish home!"*

**Steve echoes exactly what Caz had described in his statement he says**

*"The close protection officer came back escorting a stocky built man who wasn't happy that we were there. He asked us if we had permission to be there and Caz said we didn't need permission. The close protection officer pointed out that we were on a public footpath and the C/O said that's a public footpath and pointed to it. Caz said are you serious that's twelve feet away. I could see Caz getting wound up which is not a good thing and she ripped into him and reminded him of our rights."*

**Caz unfolds the rest of the night's events she continues, by these point things are getting quite heated.**

*"The commanding officer was not happy and continued to ask us to leave. I was fed up with his attitude at this point and immediately went into a rant! I said, "*

*"We fought two world wars so that we would have the right to be free and as long as we are not breaking the Law or hurting anyone we've got a God dam right to be here! That's the trouble these days people don't know the difference between freedom and fascism. Problem, reaction, solution, they create the problem publicly react to it and get people like YOU to clean the mess up afterwards!"*

***"The C/O stood silent for a moment pondering over what I had just said and replied "I like your passion." I said, It's not passion it's my right as a free human being! The C/O and the close protection officer returned to their camp."***

The cloud was coming over thick and fast and that only means one thing when you live on a mountain – RAIN! We packed up our cameras and Steve and I returned to my house and Mike Hopkins and his son went home. A few minutes later the heavens opened and it rained heavily all night."

**By this point a number of meetings between the P4 lot and the crew had taken place. Steve statement reads, what happened next.**

*"The clouds were building and the sky began to cover so we packed up our gear mike and his son went straight home and I went to Cazs house convinced they were army because we all had our doubts in the beginning. The guns and commanding officer bit did it for me! Caz and me*

had a cuppa and discussed what we had learned Donna was at the house and heard what we said. They only stayed one night after that.

We went over after they had gone to see if they had left any clues behind we only found a fragment of one piece of paper with a partial telephone number and partial name after a little investigating it was discovered to be a media outlet in Hungary! But that was as far as we got.”

A question does need to be answered here; what exactly was the purpose of these men and women in the field of Pentyrch? Not long after an exercise that ran through the night and was unannounced. When reading the statements of Caz, Donna and Dave it seems that their presence must be connected with what the military and Air Force were waiting for during the early hours of the 26<sup>th</sup> February 2016. The equipment was delivered to these fields in vans and jeeps, for which the explanations given to passers-by were either a fracking team doing a survey or that they were working for Vodaphone. But as the Pentyrch Four rightly pointed out Vodaphone don't carry guns and don't have a Commanding Officer!

It should be noted that these men and women wore military style uniforms or clothing and when Caz was able to enter the field where these men and women were working, the style of how they set up camp was precise and to order. What kind of fracking or Vodaphone team needs guns to carry out a survey? Or to search fields in white forensic looking suits? Steve mentioned that he did not see a yellow barrel tip which is normally attached to a military weapon for the purpose of Blank Fire Training'. Caz stated that the weapon looked more brand new and not something that would be dragged around for training purposes and Donna who had managed to sneak around and snap some photographs of these men and women when working, found them dressed in white overall's like the ones seen in forensic searches.

## WHY WAS THIS FIELD SO IMPORTANT AFTER THE EVENT?

### EMF Readings Pentyrch

As part of the investigation SUFON along with the help of the Pentyrch Four decided to scan the fields of Pentyrch with an EMF Meter Reader to test for Electro Magnetic Radiation (EMR). Many scans were taking during the course of November 2017 and nearly 20 months after the 26<sup>th</sup> February 2016 reading were still registering for the meter to give off a warning signal. Set to give off a signal at 0.4uT (Micro Tesla) the purpose of this investigation was to see if any residual energy signatures would be detected by the EMF Meter.

### What is Electromagnetic radiation?

Electromagnetic radiation is a term used to describe a stream of energy-bearing particles that travels outward from an electromagnetic source. The energy in these streams can vary extensively in power, and is measured by the [electromagnetic spectrum](#). This type of radiation can be beneficial, harmless or extremely dangerous to humans, depending on the source, level of radiation, and duration of exposure.

In our onsite investigations we used a GM3120 EMF Reader a very reliable and easy to use.

Now considering this was a large open field with no power cables, no wiring underground or anything natural that could or should be registering a signal high enough for the meter to detect.

The expected outcome would've been of random spikes with no discernible pattern, but after several extensive scans of the Pentyrch fields not only did SUFON and the Pentyrch Four get multiple readings with the EMF Meter but it became apparent to all of us that a pattern had emerged. The readings varied from 0.4uT – 0.8/0.9uT (Microtesla) and followed a path from the second (2<sup>nd</sup>) field in to the third (3<sup>rd</sup>) field, which very closely resembles the path the key witnesses Caz & Dave said the UAV took when it was visible to them. Map below shows multiple signals following a path from 2<sup>nd</sup> to 3<sup>rd</sup> field.

To understand why the reading in the fields of Pentyrch are of importance to this case; consider an everyday normal household filled with electrical appliances ranging from TV's, Phones, Microwaves etc. Every one of these devices gives off a field of electromagnetic radiation (EMR). According to the website safe space protection (see link below), various appliances give off different levels of EMR which can be harmful to humans.

Depending on distance the level of EMR can vary. For instance a microwave oven at three (3) inches can be anywhere between 100-500mG (10-50 uT) and 1-25mG (0.1-2.5 uT) at three (3) feet, while a TV can be 5-100Mg (0.5-10 uT) at three(3) inches / 0.1-6mG (0.01-0.6 uT) at three (3) feet. These figures are well within the range of what was being detected in the field of Pentyrch.

Studies into the effects of EMF waves at low frequencies outline the potential dangers that exist with frequencies

from 0.2uT – 0.4uT, the studies vary in conclusions but they have put forward recommended safety levels for habitable areas and the recommendation by one report suggested noting more than one (1) Milligauss or 0.1uT

**Possible Size of UAV Estimation – Pentyrch Fields**

When Emlyn Williams, Mike Maunder and Gari Jones from Swansea UFO Network met with Caz and Dave in October 2017 they described in absolute detail where the craft first appeared, precisely where and how it moved and where it disappeared. Swansea UFO Network and the Pentyrch Four have successfully completed a field investigation and tested for EMF and Gamma Radiation with a Geiger counter. Both tests have proven positive in the exact location the witnesses described. The craft left a residual energy, a footprint of its location and tracked its movement exactly as the witnesses described **before the tests began**. The EMF readings are still registering as “harmful” nearly two years after the event so how high would they have been at the time of the event or later that same day?

During the investigation SUFON and the Pentyrch Four have wondered just how big the UAV could have been. Though it is not possible to actually measure something that is no longer there, when you outline the points where the EMF readings were collected you can make some estimations. The second (2<sup>nd</sup>) field when measured

out on Google maps is approximately 282ft, according to the statements this UAV tilted down and appeared to cover more surface area as if the UAV were laying more flat than vertical as before. When measuring this on Google map it gives a distance of approximately 531ft. That does not mean that the UAV reported was of this size, but it must’ve been somewhere in this region given the EMF diagrams.


### **Smilog Woods EMF – Forestry Commission**

To further show that the EMF readings were not just isolated to Pentyrch fields, SUFON along with the Pentyrch Four went up to Smilog Wood and took an EMF Meter Reader GM3120 along with a metal detector. The purpose of the metal detector was to make sure that no power cables or any other object underground would throw off the meter and give us false readings.

When reviewing videos of the Smilog Bike Trails we noticed that a great deal of the area was still full of trees. This is the area where the snapped pine trees and branch-

es were found on the 26<sup>th</sup> when originally found by Caz and Steve, just after the military had cleared the area. Opposite the road where the bike trail continues down the mountain, the tall trees look to be in good condition with young trees starting to grow around them.

charge of this area decided to cut down all the trees. Nothing more than a few logs by the side of the road, some dead branches and the old stumps remain however holes have been dug and new trees have been replanted already.

Since about the summer of 2017 it appears the forestry in In late October 2017 the National Resources Wales was contacted by email to ask about any tree felling operations and as to why these operations took place. The purpose was to find why certain areas of Smilog Woods had been cut down especially in the area where it did appear the trees were healthy.

In reply to the email sent by SUFON's Gari Jones to the National Resources Wales the following response was received and went as follows.

Hello Gari,

*Hello Gari,*

*In Llantrisant forest (known locally as Smilog) since 2015 we have undertaken felling of Larch infected with Phytophthora ramorum, subsequently prepared the ground for replanting, and replanted. We have also felled and pruned Beech along the roadside of the public highway to improve driving conditions. All works undertaken on site went through our usual planning processes which last up to 18 months for harvesting and restocking operations a slightly less for the pruning works.*

*I hope this answers your questions  
Thanks  
\*\*\*\*\**

So it would appear that Smilog has



been undergoing an operation of restocking and replanting of trees in order to make sure that the disease known as *Phytophthora ramorum* more commonly known as **Larch disease** does not spread to other trees or contaminate the area for future replanting.

The forestry commission has a website that provides information on preventing and dealing with *Phytophthora ramorum*, it goes into detail and offers many PDF downloads on what to do. When understanding the complications of this tree disease, there appears to be a discrepancy in the National Resource Wales email reply

### **Symptoms**

Symptoms on trees include lesions – sometimes known as bleeding cankers - which exude fluid from infected bark, visible as a black exudate which can dry to a crust on the trunk. The inner bark under this bleeding area is usually discoloured and dying. Trees die when the lesions become extensive on the main trunk.

### **Treatment and management**

**No cure has been found** and there are **no effective chemical treatments available**. There are fungicides which can suppress the symptoms, but none will kill the pathogen.

The objective of any control approach must therefore be to **prevent or minimise any further spread of *P. ramorum* and the damage it causes**. The best available scientific advice is **to remove and kill** the living plant tissue on which the organism depends for reproduction. This means that infected, sporulating trees, such as larch, should be felled or otherwise killed as quickly as possible after detection of the disease.

### **Movement and processing licences**

To minimise the risk of spreading the disease by commercial forestry and timber operations, any movement in Great Britain of *Phytophthora*-affected wood from a forest site, or any subsequent movement of the affected material from a mill or processing site, requires a Forestry Commission movement licence. In addition, *Phytophthora*-affected wood may only be moved to a facility which holds a processing licence.

### **Biosecurity precautions**

Simple bio security precautions, such as **cleaning footwear, tools, vehicles, machinery and clothing between site visits, are strongly advised in outbreak areas to prevent further spread**.

If the information is understood and interpreted correctly it would appear that the correct course of action is to fell the trees as quickly as possible, **remove all infected trunks and branches via specially granted licenses, having to use precautions that involve cleaning tools and equipment** while allowing the area to be made ready for replanting coming in the next spring season. However, because this disease is particularly harmful and has already started to affect other plant types and trees with no known cure the Forestry Commission recommend the area be **left fallow for a period of three years**. It be-

comes even more unclear when the Forestry Commission have already replanted the entire area within the fallow period and they certainly haven't cleared the area.

At first glance this does appear to be a very satisfactory explanation for the removal of the trees, and if what the email reply and the forestry website data explains are correct, then there is no more need to question this course of action. **HOWEVER....** the area in question has not been cleared, there are still many dead branches and trunks lying on the ground where these trees were felled ... if indeed the area was infected with *Phytophthora ramorum* they apparently haven't followed their own guidelines.

SUFON is in the process of seeking more information from the National Resources Wales using emails and Freedom of Information requests, in the future these questions and observations may receive a valid and satisfactory answer, the reason I bring it to the reader's attention is to demonstrate that so many oddities and anomalies surround this case that they become too difficult to ignore and require investigation. SUFON has followed this line of enquiry due to the EMF readings, Weather anomalies, Snapped trees and the odd behaviour of the Military on 26<sup>th</sup> February 2016.

The final part of this article focuses on the EMF reading of Smilog, during the EMF and on site investigations; it

was when the decision was made to contact the National Resources Wales was contacted to find out about the damaged trees. One possibility that has come up though it's not conclusively proven, is maybe the damage to this area of Smilog was caused by whatever the military was chasing and could've shot down, hence the explosion and the shutting down the area.

SUFON learned in Smilog like we learned in Pentyrch fields that EMF reading showed a pattern that made this case even more intriguing. When scanning the area for electro-magnetic radiation, the area where the trees had been felled, showed a line of signals that took it straight into the area of the snapped trees. Upon further investigation we found numerous signals inside the area where the trunks and branches had been snapped and showed signs of being burned.


The readings though not as strong as in Pentyrch were still present even after 20 months, though by now it is thought to have dissipated drastically from that night.

If indeed any craft or object capable of flight and was using an energy source that gave off Electro-Magnetic Fields was somehow suddenly forced into this area by military intervention, it may explain why this area was cordoned off on the 26<sup>th</sup>, why the military kept flying in this area, why the loud explosions and smell of sulphur were present and how the trees became snapped with a trail of canopies. There have been two incidents in UK history where areas of forest and mountain were shut down to the public followed by a large military presence.

One being the **Rendlesham Forest incident** also known as **Britain's Roswell** which happened on 26<sup>th</sup> December and 28<sup>th</sup> December 1980, this involved craft and orbs of unknown design which had strange markings, left EMF readings and affected several soldiers health who were able to get up close to the UAV's.

The second one was the **Berwyn Mountain UFO incident** which happened on 23<sup>rd</sup> January 1974 in Llandrillo, Merionethshire, Wales. Sightings of strange lights in the sky and on the mountains were reported along with earth tremors that recorded as 3.5 magnitude earthquake. The army was h the media have gone to sleep and seem to accept any official explanation just as long as it does not mention or confirm UFO's. So a final question remains,

**Did a UFO of some kind come to Llantrisant on the 26<sup>th</sup> February 2016? Or was it just an exercise?**

# THE VORONEZH UFO PHOTO – THEN AND NOW

**A look at computer analysis in the 1990's  
and then in 2018**

**Philip Mantle**

**With Photographic Analysis by

The town of Voronezh was in the former USSR when it hit the world headlines in 1989 with an official release of an alleged UFO landing there. The brief details of this event are outlined here but it is something that arrived in my office some time later that we are going to concentrate on.

Voronezh, Russia UFO landing and aliens

Date: September 27, 1989.

Location: Voronezh, USSR

The Soviet news agency TASS released this story in 1989 and as a result it made headlines around the world. The story of the Voronezh aliens recounts the adventures of

A lone black & white photograph of an unidentified image (UI) forwarded to GSW for evaluation. The photograph was taken in U.S.S.R. in the late afternoon in late fall of 1989 (November

The photograph sent for analysis was purportedly copied from original negative. The photograph is of poor quality and contains numerous photographic anomalies, i.e., marks, scratches and was 'cropped' from the full negative size, collectively making the analysis difficult.

EVALUATION METHODOLOGY

1. The photograph was subjected to the following computer subroutines.
  - o High/Low Pass FILTERING (1): used to enhance all pertinent details.
  - o Edge Enhancement (2): to highlight linear features/edges of the image.
  - o Distance Distortion (3): to measure both the shape and den of the features on the UI.
  - o High Resolution (4): to highlight all photographic details
  - o Density Slicing (5): to transform Black & White density va into specific (yet false) colors.
  - o Color Contouring (6): to isolate and measure densities.
  - o Microdensitometry: for qualitative densities.

EVALUATION POINTS/REMARKS


1. Initially, the witnesses descriptive (narrative) of the object does not support the photographic image. The image was described to have a "flat (dull) grey color with a pink halo" surrounding it. The UI has varying darker-than-sky hues and contains a bright crescent shape, with a tail, (band) of a definite curvilinear shape.
2. There is no measurable density evidence of a halo surrounding the UI. The density of the sky around the UI, reveals no evidence of density variations, rather the density is uniform around the "object".
3. It is remarkable that the witnesses did not report the crescent shaped anomaly on the UI. The density of the crescent shape image is over twice the brightest density value of the disc-portion of the image (Reference enclosed density readings of the UI image).
4. The UI is not symmetrical, whereas the shape of the UI is nonlinear for the purported "disc shape".
5. The angle of the sunlight is low in the sky, and is evidenced on the right hand side of the photograph based upon photographic evidence from the foreground features (trees/buildings, etc.).
6. There is no evidence that the UI is reflecting similar sunlight as the foreground features. In reality, the top right portion of the UI image is darker than the balance of the image.
7. The surface of the "disc" contains random rough contours (high and low spots) and is not smooth. The computer program which "filters" picture elements shows a remarkable pattern similar to that of the sky. Note: both the sky portion of the picture and the surface of the UI are computer enhanced to the same degree. The sole exception, of course, is the density variables on the disc's surface.

CLOSING EVALUATION POINTS

1. There is no evidence of the UI being evaluated to common shapes, therefore, a balloon, aircraft, kite, weather phenomena, et al.
2. There is no evidence that the image is related to a common hoax; therefore, a montage, a model, reflection, etc..

3. Negative points -
  - o Why was only one photograph taken? Especially in light of the fact that the witnesses stated the object was in view for over "six minutes"!
  - o Why didn't the photographer take or attempt to take a photograph of the "translucent smoke-like tail"?
  - o Why wasn't the crescent band detailed in the witnesses narrative of the report?
4. With an object lens of 50mm, the picture angle is approximately 46 degrees. Since the photo has been enlarged and cropped, the mathematical extrapolation to calculate the size of the image is approximately 2.5 degrees (angular size).
5. The image's true evaluation remains unknown. There is no conclusive evidence to state that the image represents a bonafide structured object.
6. The image is very similar to processing (film) artifacts (See attachment). However, the photographic technicians in Russia could easily discern this by an examination of the negative.
7. The crescent-shaped band on the UI reveals a position direction that is not conducive to a rounded (disc) shape. Note the tail of the band, off the major crescent shape, "trails" off in the opposite direction.



8. We were unsuccessful with determining, by computer enhancement techniques, the amount of "object" distortion to ascertain the distance-from-the-camera due to the poor quality of the photograph and the general fuzziness of the "object's" edges.

At this time the source of the image remains unknown. Hopefully, you can use some of the GSW supplied evaluation data to gain further information to the source of the image. As always, it is a pleasure to serve your requests.

several young children who claimed to have seen a three-eyed alien with a robot escort. The alien was said to be about nine foot tall. The craft, according to eye witness testimony, landed on the outskirts of the city. Shortly thereafter, the tall alien appeared, and upon seeing the young lad, shot a type of weapon at him, causing him to vanish before the eyes of the other people around him.

There is a lot more to this case but it is not that which we are concentrating on today. It is instead an alleged UFO photograph that was sent to me in 1990. The photo in question was sent to me by a group of UFO researchers in Voronezh asking if I could help with its analysis. This is the brief details of the back story surrounding the taking of the photo. A unique photo was taken by Alexei Fomin and Alexander Petrov, cadets of the Voronezh High Aviation Engineering School. This is what the witnesses had to say:

"On November 8, 1989 we were walking with our friend Olga Fomina along the embankment of the reservoir, not far from the Pokrovskaya church. It was five o'clock, when Olga noticed a disk-shaped object in the south-eastern part of the sky, with its large axis perpendicular to the ground. The apparent angular dimensions of the object were approximately fifteen centimetres long at arm's length. The colour of the object was a matte, gray-white and around it was a pale pink halo. In this position, the object hov-


ered for about six minutes. It seemed to us that during this time it did slightly increase in size".

Surprised by the unusual sight, the cadets did not immediately remember that they had a camera with them. Almost at random, without changing the exposure, they took one photograph. They are not professional photographers, but even then they thought that exposure was not correct for taking such a shot. When the lens was altered and the shutter speed changed, the object began to gain altitude. At the top of it was a white and pink glow that turned into a point, from below there was a contrail, similar to a smoky chimney but with sharply outlined edges. The cadets did not take a second photograph and the object then disappeared from view. After the development of the negative, it turned out that this unique photograph was a little overexposed as expected. Nevertheless, it was

ball-shaped with an unusual white pattern across it.

**GROUND SAUCER WATCH ANALYSIS 1991.**

Before the days of the home computer there was one organisation that could, for a modest fee, computer analyse UFO photographs. That organisation was known as Ground Saucer Watch (GSW). They were based in Arizona, USA and their director was William H. Spaulding. When I contacted GSW in 1991 I believe they had already officially closed their operations but I managed to persuade William Spaulding to take a look at the photograph from Voronezh. Thankfully he agreed. The full GSW report is displayed here, however they found no evidence of a hoax nor did the image (UI) correspond with any familiar objects such as balloons etc. The closing comments from GSW were as follows:



“At this time the source of the image remains unknown. Hopefully, you can use some of the GSW supplied evaluation data to gain further information to the source of the image. As always, it is a pleasure to serve your requests.”  
William H. Spaulding.

Not only did GSW supply you with a written report they also provided a number of both colour and black and white pictures of the computer screen showing the photo in question under analysis. A selection of those are supplied here.

In 2018 as part of my small book publishing outfit Flying Disk Press I agreed to publish a book by Jason Gleaves. Jason was formerly with the Royal Air Force and now concentrates his research into computer analysis of alleged UFO photographs. His book UFO PHOTO – Computer Analysis of Worldwide UFO Images Through The Decades is now on sale. The Voronezh photo as examined by GSW does not feature in Jason’s book but to me it made sense to have further analysis conducted on it and in early 2018 I asked Jason Gleaves to do just that. Here is what Jason made on the Voronezh UFO photograph.



**PHOTO ANALYSIS 2018 – Jason Gleaves.**

I was asked by Philip Mantle if I could analyse a photograph taken in Russia (date and exact location unknown) of what appears to be a spherical shaped UFO. The overall black and white image is low quality and of low resolution, so upon enlargement and using enhancement techniques reveal very little.

Upon completion of my analysis process the object appears spherical in shape and has consistent characteristics of known sphere light highlights in relation to light source (Sun) reflection. The outer surface of the sphere has a

possible to see the UFO very clearly on this one overexposed photo. To the surprise of the cadets, the photographed UFO in the picture looked quite different to what they had seen with the naked eye. It now took the form of a dark object with vague edges and the UFO was

dark twin belt structure (indefinable) which you would assume surrounds the entire circumference body, but without more photographic evidence is inconclusive. The object detail available is of a constant similarity to that of the buildings shown below the object which would lead



you to believe the object is present and not applied at a later date. Upon filtering and enhancing a segment of the original source image a faint outline is barely visible partly surrounding the object again inconclusive. The distance from the person taking the photograph and height of the object is difficult to gauge without more detail. It is also important not to rule out window (glass) reflection if the image has been taken through a closed window. My conclusion: I believe the spherical shaped object to be present at the time the image was taken but without more detail surrounding the case feel it to be inconclusive and unidentified in origin.

I purposely did not provide Jason with the 1991 analysis conducted by GSW as I wanted this to be a 'blind' test and have Jason's analysis stand alone. I think you will agree that Jason's analysis is very similar if not the same as that of GSW conducted 27 years earlier. So, despite the advancement in computer technology and image analysis I think it's fair to say that on this occasion that the Voronezh UFO photo was labelled as unidentified in 1991 and in 2018. Once a UFO always a UFO.




# WHEN THE PARANORMAL BECOMES NORMAL

## – MY MULTI-DIMENSIONAL LIFE

Blue lights flashing I was fast approaching the year 2009 and unbeknown to myself the end of a well decorated police career which spanned 17 years. A trained investigator, evidential writer and expert eyewitness at court was about to see that career moving further away in the rear view mirror of life and onto the shelves of history as it was left behind. Something that just a couple of years before would have seemed impossible. The police was my first marriage and no one ever goes into a marriage to get a divorce, it sometimes just happens that way. The best thing to come out of the police for me was meeting my wife whom I met at work.

The paranormal was about to have an influential hand in ending my lifelong path and plan in a traumatic and devastating way. However it wasn't just one thing that made me leave it was a combination of things that happened all at the same time. I had become very disillusioned with the non-serving system, manipulated crime figures and

response time figures and stop and search figures. I guess the paranormal just gave me that extra push out having timed its own arrival to perfection in order to have the maximum impact on my life.

As I neared the end of my career I was becoming a multiple paranormal and UFO experiencer which has continued to the present day. So let's rewind a few years!

Sarah, my wife, had had a number of these experiences throughout her childhood and life but I, as far as I can remember, had not.

My first real encounter was in 2007 whilst on a city break in central Rome with Sarah. We were close to the Coliseum and it was the handover between day and night, it was dusk but still clear. I saw Sarah staring into the distance between the building lines and was interested in what she was gazing at. As I looked into the same region of sky I too saw what initially appeared as a whirlwind in the usual form, like a funnel but as I continued to observe the object separated into two pieces that were then flying around the sky, alone and yet working together in controlled motion. The two objects then merged together again before separating for a second time, again darting around the sky in tandem. After about 4 or 5 minutes they simply disappeared from sight but not our memory.

We did not know what the objects were, we had eliminated all orthodox possibilities and were left with only questions!

That was for me a brief introduction into the rest of my life so far and it was about to hot up like the larva of an active volcano.

The next encounters were to be on night duty when Sarah and I were working together in the same police vehicle. We have had numerous off duty encounters too which I will detail in a little while.

We arrived for work to start our 10pm – 7am night shift and had attended the routine pre-shift briefing and postings. That night Sarah and I had been posted together. It was to be a busy night with a difference. As soon as we had sat down in our vehicle the first emergency call had already come in and we had been dispatched, an intruder alarm at a local sports centre. Was it a real and genuine call or a false alarm? As we arrived we checked the outside of the building but nothing seemed amiss and we waited outside for the key holder so that we could double check the inside of the premises. As we stood there and looked up at the night sky I noticed two objects flying juxtapose at warp speed, they were reminiscent of shoot-

ing stars flying at the same sort of speeds but I'd never known shooting stars travelling as a twosome before! They were not shooting stars.

From that point the evening was to become weird and there was an eerie sense that we were not in control here tonight. Calls were now starting to come in of intruders in rear gardens in the same area and as we arrived nothing could be seen. As we were about to leave the gardens the calls would again come in from the same residents, silhouettes and figures in the gardens, but we were there and there were no silhouettes or figures. This was happening over quite a large area almost simultaneously. We were literally chasing shadows.

Now to add to the matter street lighting over a vast area (the same areas that were experienced phantom intruders) were going out leaving the region in complete darkness. Then an underground explosion could be heard and a manhole cover shot across the sky such was its power. The area felt intense and strange and I could sense things that were not visible to the eye, yet I could feel their presence in a star wars movie sense. We later discovered that the local electricity board had had 9 underground explosions that evening which was unusual as they would expect one at the most. Something was interfering with normality this evening and it wasn't Earthly. The shift was now finally over and as Sarah and I arrived home we got in touch with a local UFO group (who later also investigated this matter) but upon doing so our emails we removed right in front of our eyes only to be returned one by one within a few minutes as if they had been copied and then replaced. In the following weeks and months our phones were tapped and an anomaly was found in the phone electrical service box outside of our house in the street. An object of unknown origin had been found by a phone engineer who we had called out to check the lines. On the night in question we are convinced that a landing had taken place and we had been at its epicentre.

Another encounter again saw Sarah and I on night duty in the same police vehicle. Whilst on routine patrol in between incidents we were traveling along an urban street and as I looked up at the sky (Sarah saw the same object) I saw clearly in the night sky a wormhole appear like a long streak of light that remained in the sky as if it was a heavenly serpent. After a few seconds a tear shaped craft appeared and left the exit of the wormhole itself travelling across the sky and away from the portal until after less than a minute it just vanished from sight followed by the wormhole which just seemed to fizzle away and dissipate.

We were now seeing things almost every day or night and the next encounter was during the day whilst not at work. It was a bright and sunny summer's day and Sarah

and I were in our own vehicle travelling around our home town. As we negotiated a small island I looked up into the daylight sky and could see, in different locations of sky but forming a trinity, 3 gigantic cigar shaped craft around 500 feet high, just silently observing and watching the goings on below them. The craft were completely silent and still but appeared metallic and the term the 'watchers' came to mind. We expected the area to be like the scene from a Hollywood movie where people had just abandoned their cars to stare at them, but no one did, just Sarah and I, as if we were the only people in a crowded area who could see the craft. Had we simply merged and synced with their frequency and caught a brief glimpse of them? That seems the most likely possibility.

My Rendlesham Forest:

I was with my wife and friend walking through a dark and unlit park near to our home.

A walk and track that we had taken many times before, not always without incident, but nothing like what was about to happen.

No cars present, no people present other than ourselves and there were no street lights present at all.

We had taken many photographs of the area around us that night as we felt something following us, the photographs confirmed the presence of an unusually high concentration of Orbs! Some containing what are known as extra-terrestrial 'Rods'.

But nevertheless we continued on our track as the night drew in faster and faster!

As we walked through the dense park a light appeared from nowhere in front of us so bright that it hurt our eyes to look directly at it.

The mass of pure white light was at ground level raising about 20 feet into the air, amongst the trees, and about 15 feet ahead of us! But unlike Rendlesham Forest, this didn't appear to be a craft it appeared to be a dimensional gateway/portal to another place.

There was no sound, just a silent stillness lasting about a minute or so until the light simply disappeared as fast as it had arrived restoring the park back to normality and complete darkness.

As we frantically moved around my wife's mobile phone, which was in her hand, seemingly took a photograph of the light by itself as she did not press the button to do so herself!

As the darkness returned the questions were endless, and this was my Rendlesham Forest incident and will remain with me, with us all, for eternity! The photograph taken revealed that the orbs that had been following us were

entering the white light as if passing through a doorway to another world.


Although I have had many other UFO encounters I will soon move onto my many other paranormal experiences, my next encounter was like a scene similar to the 1980's movie 'close encounters of the third kind' In that movie the cast were invited to a certain location at a certain time to witness and event. Well this has happened to me also!

I was once telepathically invited to a set of 4 monoliths at a set of hills about an hour's drive from my house. I was with Sarah and two friends. The night previous I had had a strong urge that I needed to go to these hills, and so did Sarah and my two friends and I was shown several images in my mind of me looking out over the hills across the vast land mass and seeing orbs floating over the hills towards me. As we stood by the monoliths, strangely four of us and four monoliths, in effect one each, we all had the feeling to move anti-clockwise from one stone to the next as if unlocking a gateway!

As I looked back at the photographs taken the images were exactly had I had seen, orbs were floating over the hills towards us and the monoliths.

The paranormal is often a daily occurrence for me. I have seen green coloured grids in a funnel shape coming from the bottom of the Moon and numbers in the sky instead of clouds. I have heard what the Native American Indians called 'Voices of the wind'. We are not the only living existence in this universe and we are not the only living existence on our own planet!

I also once stood to a 'being' not of this world, standing a little more than 3 feet away from him in broad daylight as he just walked passed me and Sarah and a friend. His energy field made me spin like a washing machine internally. He was about 6'3" tall, pale and gaunt with stretched skin as if it had been forced over the bones and contours of his face and his hair was greyish and looked as if it was a hundred years old, it was thin like a fibre wire and below the collar line.



There are numerous other UFO encounters but I will now move onto some of my other paranormal incidents.

#### WHEN MURDER TRAVELS THROUGH TIME:

The pinnacle year for us both and for me was 2009 when we actually resigned from the police force into the unknown with nothing to actually go to. That year was to change our lives and my life forever in more ways than one as I was introduced to the Paranormal. Here's how it began!

My wife Sarah had once been told that she had the spirit of a young girl with her, as a child she lived in the area that this spirit girl had lived, on the same region of land. Sarah's family was aware of the story of this girl and the rumour was that she had died of Weil's disease.

Through the help of a psychic medium we discovered that this version of events was far from correct. When I came onto the scene I also inherited this spirit and around the 2008/2009 time we both visited the same medium who gave us both an individual reading. From that reading it was established that this spirit girl, named Sarah Jenson, wanted us to investigate her death, as she was "taken by another's hands" which we took to mean she was murdered which actually turned out to be correct. Sarah and I attended the central Birmingham library (UK), which was the area in question to search for any registered deaths in that name, but the problem we faced was that we didn't have any actual time frame to work off. We had little or no clue as to the timeframe when this event actually took place.

So we decided to pick a date at random and went back to the 1960's, and a little earlier not for any particular reason other than we just had to choose a start point. We couldn't find anything relevant having spent the complete day at the library looking through hours and hours of slides of registered deaths.

We then decided, albeit a little frustrating, that we would have to stop and give up on our search for answers, a discussion we had privately over lunch, or at least that's what we thought, but it was overheard by Sarah Jenson as we were to later find out.

That decision was to be a negative turning point for us!

Things now started to take a nose dive and we would have double glazed windows at home smashed in front of our eyes from the inside, with no sign of anyone or anything that may have been responsible.

I spoke to the medium on the phone and explained that we needed help, but as I was talking to her our house became calm again. The medium stated that Sarah Jenson was now with her and that she was upset with us stating that we didn't help her as we said we would. We arranged to collect the medium the next day from her own house so that she could resolve the matter or at least help in some way.

That night was about to become the scene from a horror movie involving myself and my wife as the cast.

It was now the February of 2009 (February 8<sup>th</sup>) and whilst I was sitting at home on the laptop computer I could feel something entering my body and attempting to take control of it and possess it.

I became very snappy and instantly angry which was not my personality coming through, it was the entity who was trying to possess me. I managed to resist and the sensation disappeared. Within a short time we could smell flowers in the room and the radiator which was on hot suddenly drained of any heat and went freezing cold, this was not a mechanical issue.

We had to leave the house and stay at Sarah's mother's home for the evening such was the events taking place. We arrived and spent the night there going to bed around 1.30am in the early hours of 9<sup>th</sup> February in a bedroom which was a ground floor garage conversion. The time was now about 3.30am and I suddenly remember being taken back to an old wooden type room that had a bed, which I was laying in, a window opposite and a wooden door in the right hand corner of the room.

I remember the door suddenly creaking open the wind of which caused the light blue coloured curtains to move and it was at that point I heard the voice of a young girl saying "He's here" I cannot remember much from that point on, and I didn't recognise the girl's voice. However Sarah told me that I was screaming hysterically in utter fright and that she couldn't calm me down. It was like I was being attacked and it later turned out that I actually was being attacked.

As I came around I felt tingly but back in my room. In another twist of fate as I looked over to Sarah she was the one screaming hysterically and not me, but when she came round she couldn't remember herself screaming. The same thing was happening to the both of us at the same time, each another's audience without us realising that it was happening to us personally or individually, just the other person almost like an individual yet joint

multi-dimensional slip. Sarah and I got out of bed and sat downstairs eager for daylight to arrive, shaken and baffled.

Later that morning we boarded our vehicle to collect the medium but as we were doing so she called saying she couldn't make it. Needless to say she was convinced otherwise and we continued to her house to collect her and as we arrived she was nervously standing outside her front door. She told us that during the morning her coffee cup had been moved from the kitchen to her living room window sill and had had a spoon placed inside it.

She also said that her washing machine that was not switched on had lifted off the floor by itself and although she'd been a medium for a long time dealing with all aspects of the 'Other Side' this had been the first time she'd been scared and had had to leave her own house

We made the hour or so journey to my house and it was now through the medium that we actually found out what had happened.

Sarah Jenson had been abused and murdered by her stepfather who smothered her in the year 1850, Victorian England, hence why we were not able to locate any trace during our library visit, we simply had not gone back far enough in time. At this point we discovered that the stepfather's spirit was also with us and that he'd been causing much of the problems we were facing leading up to the 9<sup>th</sup> February event! He gave us his name as John Berkshire. The medium stated that this day was the anniversary of the murder hence why we smelt flowers the night before and that I had actually relived this girl's last moments alive, which is what my wife was witnessing with my screaming!

She stated that Sarah Jenson would sit crouched up in the left hand corner of our bedroom below the window for considerable time frames, I didn't know if that meant our time or hers.

Sarah Jenson could now leave this realm, now that her story had been told and in the following days she left us a pink and Lilac flower in our kitchen, pink and lilac were her favourite colours! The stepfather was also eventually removed but that was a hard fight which made the medium physically ill for a long time after the event.

This was to be my awakening that changed my life but also ended my career in the police, neither Sarah or I went back after this event.

With all of the things that I had seen I was now well and truly open to other realities and other dimensions. I had also seen what are described as Angels, which I consider electromagnetic universal forces, causing controlled energetic explosions as they entered my house, then floating as a shape changing morphing orb, I could recite many other such encounters.

I have also seen many spirits and shadow people, had my bedroom door rattled at 6am in the morning and then seeing a shadow figure walking through the wall as I went to investigate it.

I have also seen the spirit of King Charles I in my home town.

The English Civil Wars (1642-1651) stemmed from conflict between Charles I and Parliament over an Irish insurrection. The first war was settled with Oliver Cromwell's victory for Parliamentary forces at the 1645 Battle of Naseby. The second phase ended with Charles' defeat at the Battle of Preston and his subsequent execution in 1649.

Charles' son, Charles, then formed an army of English and Scottish Royalists, which prompted Cromwell to invade Scotland in 1650. The following year, Cromwell shattered the remaining Royalist forces and ended the "wars of the three kingdoms," though Charles II eventually ascended to the throne in 1660.

Then long after the event has been written into the history books and the shelves of numerous libraries a remnant appears in the 21st century in front of my eyes.

I live in the ancient capital of Mercia but in modern times, yet time has travelled from the 17th Century England to greet me now!

One evening, whilst within a local meeting place, I looked up and saw the spirit of King Charles 'I' walking out of a room through the door and across the room I was sitting in.

The King just looked straight at me as I looked straight at him, no words spoken between us, just eye contact for that brief moment when time merged.

Charles was wearing a burgundy cavalier suit and a matching burgundy cavalier hat as he simply vanished back into the realms beyond my five senses. The encounter brought with it a pungent smell, activating several strands of mediumship, third eye vision and Clairolfaction, which is psychic smell.

The moment lasted less than a minute but the memory of it will last forever, a brush with English Royalty from days gone by.

Just what must he have been thinking as he saw me sitting there in modern attire looking at him?

Was I the ghost in his reality or was I a time traveller?

Time and reality is far more than we understand or know and has far more facets than we often realise.

This was one evening when the past walked passed!

2009 was the year that I was also given a golden key, which is the gnostic key of the worthiness to receive se-

cret knowledge. I also continuously see the number 22 both then and now which is also the number of gnostic secret knowledge. Even whilst writing this article I looked down at the computer clock and the time was 22:22. And the relevance of this will now become apparent.

It was always the gnostic principle that only the eyes that can see and the ears that can hear will come into sacred knowledge. With that in mind I have been able to decipher an ancient code that spans across the whole ancient world and connects them all, which is still hidden in the present day by metaphors and allegories and religious texts and scriptures which are hiding a much deeper and greater truth of ourselves. So the gnostic principle is not only knowledge but knowledge of self. I have found this code within the pyramids of Egypt, Stonehenge, Odin myth, King Arthur myth, the Sumerian scrolls literally translated by the late Zechariah Sitchin (I have a different interpretation), Santa Claus and even the bible, where all of the most famous characters and stories have an internal human connection, these characters were not real or individual people, it is really talking about all of us.

I have also discovered a connection between the great monuments of Earth and the Cydonia city on planet Mars. I have also been visited by an Egyptian Pharaoh in a multi-dimensional encounter as he joined me and was walking along side me dressed in full golden headdress. I could see him from the side, the front and as if I was looking out of his eyes all at the same time! A week previous to this I saw an Egyptian scarab beetle manifesting out of thin air in my living room at home and when I looked down at my feet I saw a serpent of light scurrying away from my left foot. In 2010 before going on vacation to Egypt I was contacted out of the blue by a UK psychic medium who had a message from her spiritual council which stated "Regarding your trip to Egypt, you need to look passed the tourism, learn about her, understand her and then teach about her, a messenger will find you". Seven years after that message was delivered it finally made sense and it finally meant something as I now understand her and teach about her having learned of her secrets, her of course being Egypt. I now go around the UK giving talks at small venues and also large conferences and appear often on global radio in order to do just that and fulfil my part in this overall passing of ancient knowledge having deciphered a code that tells us of the true purpose of the pyramids and sphinx and what they really represent, as with many other ancient monuments.

There is a theory that picks up an enigma, which is of extra-terrestrial intervention in the creation of humanity from a race of beings known as the Anunnaki, which means 'Those who from Heaven to Earth came' who

were evidently far more advanced than Earth humans, simply because they had been around longer than we had.

It is claimed that they tinkered with human genetics mixing primate genes with that of existing humans creating what we are today, Homo-Sapien. This story was made world famous by the late author Zechariah Sitchen who gave the world his translations of the Sumerian Scrolls (Sumer being modern day Iraq) which championed this version of history.


In my opinion Zechariah Sitchen has made a literal face value translation and has missed the deeper message which I have found to be that of genetics and enlightened consciousness spanning all across and connecting the people of the ancient world.

The Anunakki story has Anu as the chief Sumerian God and Anu means the 'ultimate physical atom of creation' and the word Nakki means to change, therefore the atom has been changed which I acknowledge does support the Sitchen translations.

Enki and Enlil, the snake brothers, are the two strands of the double helix of human DNA, which resembles two snakes coiled together.

Many people are seeing what appears to be an object adjacent to the solar Sun and claim this to be the planet X, Nibiru, spoken about in the Sitchen translations, the home of the Anunakki. Nibiru however means 'Wandering planet' and in Egyptian astronomy their name for the planet Venus is Neb-Heru, (house of Horus) which is far too close to be a coincidence.

Venus's orbit wobbles noticeably and is therefore known

It could not have been flown as a craft with only orbiting power.

Scientifically this cannot be correct for the following reasons. The Moon has the same Isotopes which are chemi-

cal elements as the Earth and is the same age, therefore it was created in the same region of sky at the same time. The Moon is a planetary stabilizer for Earth keeping her at a 23.5 degree tilt and without it there cannot be life on Earth, therefore if the Anunakki brought the Moon here with them they could not have discovered life here on Earth when they arrived. I am not denying genetic tinkering, it is the most likely cause of our sudden advancement, but as I use that word Consciousness again I am saying that as with the whole coded theme of this book there is a world of sacred knowledge that is being deliberately concealed from us and clues to this sacred knowledge are cleverly hidden in plain sight within such works as the scrolls and many other significant places. But all we need do is look beyond the upper surfaces and literal translations of historical content and we will see the true meanings.



# The Raveo (Villa Santina) CE3 case 50 days after the Kenneth Arnold sighting By Roberto Pinotti.

The author of this account (now deceased) was a well-known Italian painter and writer who lived in Milan. An anti-fascist and partisan during WWII, in the 1950's his science fiction book "C'era una volta un Pianeta..." (Once upon a time there was a planet...) and its sequel "Quando ero Aborigeno" (When I was an aboriginal) were published by Mondadori in Milan. The subject of both was the exodus to Earth of advanced human-like inhabitants from a fifth planet from the Sun (between Mars and Jupiter) just before its explosion due to an atomic war and their mating, before their extinction, with Neanderthal hominids producing a new hybrid species: Homo Sapiens. Readers will have to form their own opinions as to whether the following account by Professor Luigi Rapuzzi (aka L.R. Johannis) is the report of a real experience destined to inspire his science fiction books as he later said and to anticipate the "Ancient Astronauts" theory.

The following translation by FSR Editor Gordon Creighton, a resume of which was included in FSR's "The Humanoids" (1966) Special Issue, is from the original Italian account, titled "*Ho visto un disco volante*", published in CLYPEUS No. 2-5 of May 1964. This journal, devoted to Fortean subjects, was published in Torino (Turin) and its founder and editor was Signor Gianni Settimo.

As readers may know, the Latin word "*Clypeus*" denoted the round bronze shield carried by the Roman soldiers. Certain Roman writers refer to sightings of a flying "shining object" defined a "burning shield" or, in Latin "*Clypeus ardens*" and our friends in Turin are not alone in thinking that some of these things may not have been natural or meteorological phenomena.

## I SAW A FLYING SAUCER (1) - (As told by Professor L.R. Johannis)

During the first half of August 1947 I was in a small village called Raveo, near Villa Santina, in Carnia (Friuli). In my boyhood I spent a large part of the summers in that district where I'm consequently well known (2).

I've always been interested in geology and anthropology and I spent all my leisure time studying these, my favorite sciences, an integral and indispensable part of which involves the systematic search for fossils.

On the morning of August 14, 1947, as usual, I was making my way again up the short valley of the mountain stream called the Chiarso. This valley ends on the lower slopes of the central mountain massif, the Carnico del Col Gentile. I had with me a small knapsack and my geologist's pick. (3)

I was following a path along the left bank of the stream (which was almost dry) which winds up through clumps of fir trees and deposits of alluvional rubble and detritus. On my right the face of the mountain, with a gradient of about 45°,

towered away, consisting of fractured and weathered rock mixed with layers of gypsum.

As I emerged from one of these clumps of fir I noticed, on the rocky river bank and at a distance of about fifty meters from me, a large lenticular object of a vivid red colour. I am slightly short-sighted and so I quickly put my glasses on. When I had arrived at a spot a few steps distant from the “thing”, I was able to establish the fact that it was a disc – seemingly of varnished metal like the metal of an ordinary toy – having the shape of a lens and a low central cupola (4) with no apertures.

At its tip a sort of shining metallic antenna, of telescopic form, was protruding, roughly similar to those we have on our present day motor cars.

(And here I must state straight away that I knew nothing whatever in those days of flying saucers and I do not think that the Italian newspapers had even started to talk about them.)

The object, some ten meters wide, was embedded, to the extent of about a quarter of its length, in a great transverse cleft in the friable rock of the mountain side and was at a height of about six meters above the bed of the stream.

Without more ado I decided that I would climb up there to it and see what it was, but first of all (and anybody else would have done the same) I looked round to see whether there was anybody about who – should the need arise – could help me.

It was then that I perceived, at a distance of fifty meters or so from me, right on the edge of the grove of trees from which I had just emerged, two “boys”. At any rate, that is what they seemed to be, at first.

I shouted to them and pointed to their disc. And then I started towards them. When I had halved the distance between them and myself, I stopped, petrified. The two “boys” were dwarfs, the likes of which I had never seen nor even imagined. They were coming towards me slowly, with tiny strides, with their hands at their sides and their heads motionless.

When they had come to a few paces from me, they halted. I had no strength left. I seemed to be paralyzed (5) or to be dreaming. But I was still able to observe them in every detail.

And those details have remained impressed upon me so indelibly that even now I could make a portrait or even a statue of those extraordinary beings. However I must confess that the dominating sentiment in me then was one of enormous astonishment combined with fear, as you will well understand.

They were no more than 90 centimeters (6) in height and were wearing dark blue colored overalls made of some material that I would not know how to describe.

“Translucent” is the only term for it. They had collars and rather deep belts, all of a vivid red colour. Even the cuffs and the shins of the legs ended in “collars” of the same type.

Their heads, according to the impression that I got, were bigger than the head of a normal man and gave them a caricaturist aspect. (7) But I think the sight of their

“faces” would have out an end to anybody’s desire to laugh.

At this point I’m obliged to explain that the terms I have used in this description are purely indications and are of a purely anthropomorphic nature. I don’t know, today, whether those things that I have defined as nose, mouth, eyes and hands were like that or whether it would be correct to name them in some other way.

They had no signs of hair but in place of it they were wearing a sort of big brown tight-fitting cap, like an Alpinist’s bonnet. The “skin” of their faces was an earthly green (*verde terroso*). The only colour that comes close to it is that of the plasticine commonly used by sculptors or of clay dipped in water. The “nose” was straight, geometrically cut and very long. Beneath it was a mere slit, shaped like a circumflex accent, which I saw opening and closing again at intervals, very much like the mouth of a fish. The “eyes” were enormous, protruding and round. Their appearance and colour were like the colour of two well ripened yellow-green plums (*due prugne gialloverdi ben mature*).

In the centre of the eyes I noticed a kind of vertical “pupil”. I saw no traces of eyebrows or eyelashes and what I would have called the eyelids consisted of a ring, midway between green and yellow, which surrounded the base of those hemispherical eyes just like the frame of a pair of spectacles.

I remained there in astonishment, for what seemed to me an interminably long time, gazing at the two extraordinary creatures. Only later I was able to calculate roughly

How long it was. I think the silent confrontation lasted no more than two or three minutes. Then I raised my arm with the pick and waved it in their direction and then in the direction of the disc and, in an agitated voice, I shouted and asked who they were, where they came from and if I could be of any help to them. They wheeled round very quickly and I can’t remember what I said after that, for things began to happen fast.

I now believe that the two beings had interpreted my precipitate gestures as being threatening to them. But I don’t know for sure and don’t suppose I ever shall. What is certain is that one of them raised his right hand to his belt and from the centre of the belt there came something that seemed as though it may be a thin puff of smoke.

I now think it was a ray (9) or something of the sort. Anyway, before I had time to move or do anything, I found myself laid out full length on the ground. My pick shot out of my hand, as though snatched by an invisible force.

Only once in my life I had the experience of suffering a violent electric shock. That was in 1924, when I was a student at the Technical Institute in Udine and the Physics

Professor made us all form a chain and take the charge from a Leyden jar. Well, I can only tell you that, as soon as I was struck by that smoke-ray, I felt a similar sensation. Moreover I felt myself deprived of all strength and all my efforts to raise myself meant an expenditure of energy that was beyond me.

Meanwhile, the two midgets were coming towards

me and they halted at a spot two meters from me, where my pick had fallen.

I managed to roll over on to one side and I saw one of them bend down and pick up the tool, which was longer than he was. And this was how I was able to see his green "hand" quite distinctly. It had eight fingers, four of them opposable to the others! It wasn't a hand: it was a claw and the fingers were without joints.

I also noticed that the chests of the two beings were quivering: like a dog's chest when it pants after a long run.

I made fantastic efforts to get up and finally managed a sitting position. But I had to brace my arms against the ground so as not to fall back again.

Meanwhile the two entities had arrived beneath the disc. I saw them climb up, slowly but surely, to the cleft in the rock and disappear into the disc itself, which was embedded almost vertically in the rock.

A few more minutes elapsed and then the strange object shot straight out from the rock and rose into the air. A cascade of stones and earth fell down onto the bed of the river. And that was the only noise that broke the silence in that lonely spot. The stream, being at low water, was trickling silently over the pebbles.

The disc remained there stationary in the air, like an enormous suspended gong. I could distinctly see its sharply cut flange four or five meters from me and for a moment I was seized with terror that it was going to come down and cut me in half like a worm.

I'm not sure, but I think I shouted at the top of my voice. At any rate, I am certain that I made every effort to get up and escape. The result was that I kept falling back again, supine and racked with pain.

Meanwhile, the disc had tipped slightly away from its vertical position. Then it suddenly grew smaller, (10) and vanished. Immediately afterwards, I was struck by a tremendous blast of wind (the air shock?) which rolled me over and over on the ground and filled my eyes with dust. I ended up against the stones in the river-bed and remained there for I don't know how long. Finally I managed to get into a sitting position again and it was then that I looked at my wrist watch. It was 9:14.

But it was only at about midday that I was in a fit state to get back home. In the meantime, I even slept for an hour. My bones all felt as if they were broken and trembling, as though after a fearful bout of drinking. I looked in my rucksack for my thermos flask of coffee and was not surprised to find it shattered to pieces, but what did surprise me was not being able to find any trace of its metal casing. Also gone were my aluminum fork and an aluminum can that had contained my cold lunch. (11)

Everything had been soaked with coffee, including a pack of cards with sketches of the region which I usually carried with me.

I had to be content with bread soaked in coffee and throw away the salami and all the rest.

Finally I should add that I searched in vain for my pick, which would have been very useful to me at that

point as a walking stick.

At 2.00 p.m. I reached Raveo and went to bed. I told the proprietress of the inn where I was thinking that I had fallen from a rock and she replied that that served me right for it was high time I stopped going around picking up stones (she had known me for more than 35 years since I was a boy).

Next morning I armed myself with another pick and- I confess- with a revolver and went back to the spot. Naturally there was nobody there. I climbed right up to the cleft in the rock since I thought the two creatures might have thrown my old pick- to which I was very much attached- in there, but I found nothing.

I believe that that old pick of mine is now in a museum on some other planet. I hope that somebody up there is trying to decipher the marks cut on the handle, my name and a mountaineering motto and a pair of stylized Alpine flowers and an eagle.

I hope they rack their brains to a standstill trying to make it out. Finally I must tell you that at that time I tried to explain my strange adventure in many different ways, but none of them having anything whatever to do with flying saucers or other craft of extraterrestrial origin. At first I thought the "saucers" was an experimental machine of the Allied Forces which were then in occupation of the Campoformido aerodrome in the Friuli area. My next thought was of some device of Russian origin. I wandered about some unknown civilization still hidden away in some unexplored regions of the world like the Mato Grosso of Brazil (\*).

The most absurd hypotheses could be adapted to fit my extraordinary adventure. But no one of them was satisfactory, since not one of them could account for the presence of those two little men.

Anybody else in my position would have decided that the only sensible thing to do was to say absolutely nothing whatever to anybody about what had happened. And this was what I did, quite consciously. I had no wish to be considered a crazy visionary, or worse and I don't think anyone could blame me.

Two months later, I sailed for New York. During the crossing I heard for the first time about the flying saucers seen by Kenneth Arnold. Only then I did realise that I had seen a flying saucer.

During my five years in the USA I followed with the greatest of interest all developments in the "Flying Saucer Story" and in 1950 I decided to relate my experience to two persons in whom I have confidence, who can give their testimony about it at any time and whose addresses I have given to Gianni Seedtime of Clypeus in Turin which has now been good enough to publish my account.

In 1952, before returning to Italy, I read an article in the weekly review *L'Europeo*, about the book by Frank Scully, (12) who spoke of two flying saucers that had landed in America and, as he stated quite clearly, contained the corpses of little men. Then I sent a letter from New York to the director of *L'Europeo*, asking him to publish the account of my experience which, at any rate, possessed the merit of priority in time.

When, two months later, I returned to Italy, I went to Milan and called upon the director of *L'Europeo*. There I was told that the subject was an interesting one but that, in order that it could be published, it was necessary for to furnish "proofs" (!) of its authenticity.

I replied that if on that morning in August 1947 I had imagined that I was going to encounter creatures from another world, I would certainly not have hesitated for one moment to take along with me a whole troop of journalists, cinematographers and (why not?) a company of soldiers too.

As a result of my experience, I had made enquiries in the village next day (August 15, 1947) as to whether anybody had noticed any sort of "airplane" the day before.

Two people (an old man and a boy) told me, separately, that they had seen one, in the one case at 8.30 a.m. and in the other case at approximately 10.00 a.m. The old man had been sitting down in the village square enjoying the sunshine. He noticed "a red globe being carried aloft by the wind" behind the mountain on the slope of which the village lies. The boy was with his mother and other people, working in a field scarcely outside the village and he noticed a red ball ("like the ones they have at fairs") which was rising at great speed and vanished in the clear sky.

That is all that I have been able to gather in the way of "local testimony". It is doubtful whether it would have been of any interest to the director of *L'Europeo*.

And with that, my story is finished. I will only add that I was deeply disgusted by the mean campaign of vilification which has been carried on in the USA in connection with the matter of the flying saucers and which I followed closely in all its details between October 1947 and 1952. And my disgust ended by turning into bitterness here in Europe when I realised the enormous levity with which the important question of the flying saucers is treated. I say "levity" because I don't regard as worthy of any sort of consideration at all the hoaxes and the frauds perpetrated for the purpose of making money or for witless propaganda.

And I must conclude this brief account with a warning similar to the one with which the American, Major Donald E. Keyhoe, closes his book *Flying Saucers From Outer Space* (13):

"There are intelligent beings that are coming from Outer Space and have been observing us for years, perhaps for centuries. Perhaps there will be beings similar to us. Others might be very different from us regards their physical aspect (I am not sure about this).

"We must be ready, at any time, for meetings with these beings and ready to demonstrate that we are "civilised". When? Perhaps tomorrow or perhaps in two centuries from now. We don't know. But it is certain that, immediately, at the first meeting, we must give them impression that we are in fact not their enemies.

Because, while we can surely learn from them things that will increase our scientific knowledge, we might be treated by them on the same level as inferior beings or savages. No, we cannot deny that our own "highly civi-

lised" exploratory expeditions in Africa, Australia, Malaysia and Arizona, have answered the poor arrows of the natives with their more lethal leaden bullets. What sort of reply might the "flying saucer people" give to our modern weapons? The mysterious power (magnetic?) which silently drives their craft should make us think."

**Letter from Professor R.L. Johannis to Gianni Settimo, editor of CLYPEUS Magazine**

Milan, March 20, 1964

"My dear Settimo:

In accordance with your request, I am sending you two China-ink sketches to illustrate the account of my meeting with a "saucer" and two of its "pilots" in Carnia away back in 1947.

As I told you, at such a distance in time, many of my recollections-exact enough at the time- have weakened and have consequently become a little confused. I refer particularly to the exact appearance of the "bodies" of the two "beings" met by me, as well as the shape of the eyes since I am no longer certain whether they were vertical or horizontal slits or whether weren't any pupils at all.

When I sent my account of the episode from America to the Italian weekly *L'Europeo*, I sent with it a sketch of the "pilots", but when I came back to Europe that sketch was not returned to me because their editorial office had lost it." That sketch was done by me two months after the meeting and consequently was much more faithful a reproduction than the ones done by me now. However, generally speaking, the front view of the "head" can be taken (apart from the pupils) as corresponding to the absence or not of eraser something similar that I can't recollect absolutely.

The sketches of the complete figures are to be considered as rough and approximate outlines and consequently of purely general value. Besides, I am at present inclined to believe the two pilots were nothing more than two "robots" whereas in 1947 I was convinced that I had met real and actual extraterrestrial beings. Please give all these considerations, as contained in the present letters, to the CLYPEUS readers, for I want my account to be taken at its just value and not decked out with suppositions that are purely gratuitous and therefore of no value.




**Notes by Gordon Creighton**

1. The Johannis case was 50 days after the Arnold sight-

ing.

2. Friuli is the extreme north-eastern province of Italy, north of Venice and bordering on Austria and Yugoslavia. The mountains are the Venetian Alps and Carnic Alps.

3. On pages 199-200 of his excellent new book *El Gran Enigma de los Platillos Volantes* (Editorial Pomaire, Barcelona) Antonio Ribera gives a summary of the Johannis case and reproduces the sketches of the entities: But by some curious quirk or error, he translates the Italian word for pick (*piccozza*) as “easel” (*caballete*) in Spanish and portrays the professor as walking up the mountain side carrying his easel and his paint brushes (*su caballete y sus pinceles*) and as waving a fistful of paintbrushes at the entities. It seems to me important to have this small point (in what is otherwise a splendid book) rectified, for even to alien entities a pick would presumably seem a more dangerous weapon than a cluster of paint-brushes.



THE RAVEO HUNANIDS DETAILS

4. Note the striking resemblances (disc shape, low central cupola, metallic antenna) to the features in the seven much disputed photographs of a landed disc-with small entity near it- allegedly taken at 9.30 a.m. on July 31, 1952, by the Italian engineer Giampiero Monguzzi near the Cherchen glacier on the Italian side of the Bernina Massif, a little to the south of Saint Moritz.

5. The Cherchen Glacier is not much more than 100 miles from the scene of the Johannis encounter and both cases occurred after 9.00 a.m. First Prof. Johannis feels the “paralysing effect”, later the process is taken further and he is felled to the ground.

6. See *The Humanoids* Special Issue of F.S.R There were twelve South American reports in 1965 of little creatures of between 80 centimeter's and 1 meter and no less than nine came from the mountainous area of the Andes. *The Johannis and Monguzzi cases were also both in mountains.*

7. Here are Aimé Michel’s “pumpkin-heads”, the little men seen at Valensole, “with brains at least three times as big as ours.”

8. Do we have here the creatures that gave rise to the stories about “little green men”? Compare case 64 of my article in *The Humanoids* relating how, in October 1965, some Argentine children, on their way to school on the

western slopes of the Andes, encountered “several creatures of short stature, greenish skin and only remotely resembling human beings” who tried to capture them.

9. “Flashes” or “rays” from the belt or chest are now seen to be frequent features in reports of encounters with small entities.

10. The disc “grew smaller before it vanished”. One feels that there is something of fantastic importance here, a tremendous clue. Captain Howard told me that his gigantic UFO, seen over the Atlantic in 1954, seemed to grow smaller while remaining at the same distance from the observers. In the Whidby Island case of October 1963 (see FLYING SAUCER REVIEW, November-December 1964, p13) the grey ten-foot long craft, shaped more like a wing- aero plane than a disc, “suddenly shrank considerably in size and tilted so that its rear portion dipped into the ground”. Professor Johannis’ disc was also tipped up in a strange way and sticking into the rock. For Heaven’s sake will all our experts on tempic fields and the plurality of dimensions please put their thinking caps on about these cases!

11. It looks very much as though the entities put Johannis to sleep and then came back and rifled through his rucksack robbing him of all metal objects.

12. Frank Scully: *Behind the Flying Saucers*. (Gollancz, London, 1955. Second British Edition) 13. I have not found these exact words in my English version of Keyhoe’s *Flying Saucers from Outer Space* (Hutchinson, 1954). They may however appear in the Italian translation of that book.

Three other witnesses?-The Raveo/ Villa Santina Case confirmed?

“I am aged 51 and have long been fascinated by the still unsolved mystery of the flying saucers, the reality of which I accept as more than merely possible. As my thirteen-year-old daughter is also interested, I recently bought for her in London (where I have lived for the past eleven years) a copy of *The Humanoids*, in which, to my great astonishment, I read the account (p. 187) of the experience of Professor R.L. Johannis at Villa Santina, Italy. I must emphasise that I know nothing about him and have read none of his science fiction books which you mention. The fact is that I was myself born in Udine. Re-reading the story more carefully, I was even more amazed to see that the date was August 1947! In that month I was living at Caporiacco, in the municipality of Colloredo di Montalbano.

I don’t recall the precise date, but it was certainly in August and certainly before August 15. I feel pretty sure it was August 12. With my mother and a friend I had been to the cinema at Fagagna to see Vivien Leigh in the film of Shaw’s *Caesar and Cleopatra*. Cars were a luxury in those days and we had to walk to and from Fagagna (about 4 kilometres and a half each way). We were returning home at about 11.00 p.m. It was a beautiful, warm night and the sky was full of stars. Suddenly, from behind us there came a vivid yellowish-orange light and it seemed a ball of fire shot over our heads at a terrific speed and carried on north towards the mountains ahead

of us, *on a dead straight, horizontal course* and lighting up the whole area around. For a brief moment you could have read a newspaper as well as in broad daylight. No sound whatever accompanied the sight. For a few moments we stood there without moving, without saying a word and quite scared. Over the years my mother and I have often spoken of the experience and speculated as to what it might have been. Lately, we had even discussed the possibility that it might have been a flying saucer. But of course in those days, in 1947, who had even heard of jet or supersonic planes, not to mention saucers!

Is it possible that what we saw has any connection with Professor Johannis’ experience, which took place in that same part of Italy on the morning of August 14?



# UFO IMAGE FROM WILTSHIRE

## A REPORT BY

## PHILIP MANTLE

In November 2017 I had a UFO photo-case in the national media here in the UK. As a result of that several more alleged UFO photographs found their way to me via email. One such photograph was from a commercial pilot from Brazil. The photo he sent me was taken in Salisbury, Wiltshire in 2004. The gentleman in question is Mr Luis Kantek and this is what he had to say:

“ I took the photo on the 28<sup>th</sup> of February 2004 (the exact time on the camera details can be seen with the time of Barcelona - but it was daylight). I took the photograph near to Minster Street, Salisbury, Wiltshire. I did not see the objects. I was taking a picture of the flag. I took a lot of pictures in auto mode to have one good one of the open flag. I did however see the Jet Fighter coming and going around (chasing the objects?) The camera I used was a Canon PowerShot A70 velocity 1/800.

My name is Luis Sergio Bernardes Kantek; I am 44 years of age with Brazilian and Spaniard nationalities. At that time I was living at Barcelona and was in UK on vacation. I actually live in Curitiba, PR Brazil. I am a commercial pilot and fly airplanes and I am a private pilot for helicopters. I'm also a pilot of drones (semi-professional jobs). I am also an amateur astronomer. This pictures I've sent was going to be my second of three contacts with UFOs.”

This is the alleged UFO photo (see above) taken by Mr Kantek, (see above image).

As stated above Mr Kantek did not see anything at the time and only noticed the two 'objects' later. As I have done previously I sought the assistance of three different photo analysts to take a look at Mr Kantek's photo above.

ANNALYSIS:

The first to take a look at the photo was Dr. Bruce Maccabee. He was brief and straight to the point: “The flag photo looks like a classic "bug shot" with two bugs.” Next up was Tobias Lindgren from Sweden: “My spontaneous assumption is that the photo



shows birds, but the resolution is so low that I do not think it is possible to analyse the purely technical information that the image contributes.

If they are birds, they are maybe twice the distance between the camera and the flagpole and may be crows, pigeons or something of a similar size.

The shutter speed of 1/800 seconds is so fast that any movement does not become apparent. Bird photographers usually lock the birds flapping with shutter speeds of 1/500 or faster. A common coincidence that something unwanted passes the camera viewfinder according to me.

Last up to take a look at the photo is Jason Gleaves from the UK: “I was asked recently by Philip Mantle to conduct a detailed analysis of an image that shows a quite detailed view of a Union Jack flag on flagpole, either side of the pole two separate unknown objects can be seen. Upon closer analysis of the image the detail revealed appears to show both of the objects look similar to military aircraft in close formation (again because of the quality and distance of the objects, it makes it difficult to accurately identify the aircraft type and model).

The witness 44 year old Luis Sergio Bernardes Kan-

tek from Curitiba, PR Brazil is a qualified commercial pilot himself and took the photographs near to Minster Street, Salisbury, Wiltshire, U.K.

He was there in Wiltshire on vacation and stated he was taking the photo of the flag (subject) and didn't see the two objects captured in the distance, the camera used was a Canon PowerShot A70 velocity 1/800, which was set on auto mode for user ease.

In my opinion it is so easy to misidentify objects seen and captured within photographs taken, especially if aircraft engine noise is not heard at the time of the incident.



I have inverted and filtered the original source images

supplied to enhance the detail, also similar type/model aircraft silhouettes have been overlapped for example and comparison only.

I think it is fair to say that we can now rule out the possibility of this photograph being labelled as unidentified. It is quite clear from all three photo analysts that the two objects do have a conventional explanation. However, I do thank Mr. Kantek for sending me this photograph in the first place.





