# Roswell

## The Case That Will Not Die!

### DO WE HAVE ANOTHER WITNESS TO THE UFO CRASH AT ROSWELL IN 1947 ?

Irena Scott the author of the new book, *Inside the Lightning Ball: A Scientific Study of Lifelong UFO Experiencers*, tells in it that she found out about a new Roswell witness. She recently interviewed a relative she knew well, who told about working for a medical doctor, who had been asked to examine a being that was frozen and was kept at Roswell, New Mexico, at that time. This relative had worked in this doctor's office 1983-1987.

The doctor had previously been a former flight surgeon and dermatologist in the U.S. Air Force. The relative said he had until recently been in practice as a dermatologist. He is now a retired MD, and was a US Air Force Flight Surgeon, who retired as a Colonel. She said that he told that when he was a young doctor, he had been sent to Roswell to take a skin sample from a being he called an alien. She said this being had been cryogenically preserved. He was to take tissue samples and analyze the outer covering of this being. He had talked about this when he was younger, but no one believed him, so he has not talked about it recently.

She said he spoke intellectually and had never joked about it. He told her this at a gathering at his house with some other people also. She had told her daughter about this after she heard it. I asked her daughter and she confirmed this to me. The daughter also knows him. The relative thought that she recalled that he had said this was at Roswell, but possibly, it had been at Wright-Patterson Air Force Base.

The author had been able to contact the doctor and he told her that he had never been to Roswell and did not know what I was talking about. He said he did have several quite interesting UFO sightings though. Scott again contacted the person who told her this, and the relative said he was untruthful. She said he was in his house, he told her and several other people about this, and they were drinking a little but no one was drunk. She had worked in his office and knew for sure that he was a doctor.

She thought that he might still be in the military, or that he might have come under security or been silenced after telling this. She is trying to remember the other people to whom he gave the account. He had lived an interesting life. He said he was not a "jet pilot," as some thought. That in the Air Force the flight surgeon is al-

lowed to fly an airplane ("stick time") if that person has enough hours in the aircraft to be familiar with it and has an instructor pilot with him.

He sometimes had more time in an aircraft than the co-pilot did. He had over 500 hours in the KC-135, and had logged over 350 combat hours in Vietnam. Over there, people did not pay any attention as to whether or not there was an instructor pilot with him. He had been very fortunate—he had watched 4 of our aircraft go down and was not hit...one Navy and three Air Force. He said he could tell several interesting stories, but one in particular was one of the most amazing "war stories" that anyone will ever hear.

He added that for years people have told him what an interesting "character" he is and that he should write a book on how he worked his way through 4 years of pre-med and 4 years of med school and all of the many other things he had been involved in while on active duty. He also told me about several events he knew about that the government had covered up. These included several quite interesting UFO sightings. One was at Ellsworth AFB. He saw a UFO on the ground near the base and said police, firefighters, and other emergency crews surrounded it. It kept trying to lift off from the ground but was not successful. Then it very rapidly flew away. He saw something about it for one day only in the newspaper and is looking for the issue. He said he had been stationed at Ellsworth AFB from late 1965 until 1968, thus, this incident would have probably occurred in 1967 or 1968.

I searched for reports and found the following report about a Staff Sgt. Albert Spodnik (USAF Ret.), who was a Former Electro-Mechanical technician, 44th Missile Maintenance Squadron, Ellsworth Air Force Base, South, South Dakota. Spodnik stated that on one summer night in 1966, he and a fellow Electro-Mechanical Team technician were dispatched to Launch Facility (silo) Juliet-3 to correct an electrical malfunction. For an unknown reason, both the commercial power supply to the site and the emergency power systems had simultaneously failed, which rendered the Minuteman I missile temporarily inoperable. Thus in Air Force parlance, the ICBM had "gone off alert status."

After they restored power to the launch facility, he and his partner started an automated start-up procedure to return the missile to normal operational status. When they left the underground silo, the technicians' security escort alerted them to a sudden, exchange on the Crew Cab's two-way radio. As they men listened, they learned

about a triggered security alarm at nearby Launch Facility Juliet-5. The missile there had dropped off alert status. As with Juliet-3, the site had lost commercial electrical power and its diesel-powered generator, designed to charge back-up batteries, had failed to start. As this drama unfolded, they found that the Security Alert Team had reported that a strange object was sitting on the ground inside the security fence that surrounded the missile silo. They heard the Flight Security Controller order the SAT to approach the object, but the team leader refused. He reported that this mysterious object was round, apparently metallic, and resting on a tripod landing gear.

Spodnik said that about 30 minutes after the Command Post had been notified about the UFO landing, he saw a helicopter in the distance, as it approached the stricken launch facility. When it was around five minutes away, someone screamed into the radio that it flew away. Spodnik watched a brilliant white light directly above Juliet-5, ascending vertically at enormous speed. (This was found in a NICAP report [https://www.nicap.org/babylon/missile\\_incidents.htm](https://www.nicap.org/babylon/missile_incidents.htm)).

I asked the doctor if this could have been what he saw.

His comments were that as a flight surgeon, he frequently made his "rounds" at the launch control facility (LCF) in the Ellsworth area. He would go deep underground to the actual launch control panel and visit with the two launch control officers on duty. He said that he can't say any more than that other than to say that the two officers manning that station never said anything to him about a problem with the electro-magnetic system having occurred at their facility. But they very likely wouldn't have been allowed to do so. However considering all of the back-up systems available, he thought it would be hard to believe that any of our minuteman missiles would have been inoperable...even temporarily.

He also said he saw a UFO over Lake Charles in Louisiana. It flew over a group of people quite low and had a multi-colored exhaust. He said the newspapers said it had come in from the Pacific Ocean and passed over California, Arizona, New Mexico, Texas, and Louisiana. It exploded over Lake Charles. He thought this had been in the 1940s. He also said that he had copies of an Air Force bulletin about how to investigate UFO crashes, that was official. He is now looking for this.

He wondered how the government could so completely cover up these events. I should have asked him if he was part of the Roswell cover-up. This account is still under investigation. Scott had previously reported about a new witness in her last book, *UFOs Today: 70 Years of Lies, Misinformation and Government Cover-up* and has added new information about this person to her most recent book.




# Conference 2018

toilet facilities.







# DEATH FROM AN UNKNOWN MENACE



There is a phenomenon which has shocked and baffled police investigators, veterinary surgeons, farmers and ranchers around the world. It is the unexplained dissection of animals, and the precise removal of specific body parts, by agents unknown. The realm of unidentified but obviously intelligently controlled aerial craft has continually been linked with the discovery of such animals, especially in the United States since the late 1960s. The victims have organs (including tongues, tails, eyes and sexual organs) removed with clinical precision. Incisions are found to have been cauterized, and very often there is a baffling lack of blood on site. This indicates that medical procedures, akin to laser surgery, are performed on the animals, often in extremely remote locations. American investigative reporter, Linda Moulton Howe, won an Emmy Award for her groundbreaking documentary, *A Strange Harvest*, on this alarming phenomenon.

The prospect of an unknown intelligence harvesting organs from our animals, of varying species, should be of great concern to us all. The investigation of these incidents has been cloaked in secrecy for many years, with government agencies tasked with covering up the frightening reality of who - or what - is responsible.

Several countries, including the UK, France, Spain,



Brazil, Mexico and Ireland, having released declassified UFO files, are now admitting that they had in fact pursued an avid interest in this phenomenon. As they have admitted that the subject is authentic – with the United Kingdom's *Condign Report* stating that the reality of unidentified flying *objects* is 'indisputable' - are they now keeping secret files on an agenda that those who are controlling the unknown craft may be pursuing, concerning the harvesting of specific animal body parts?

This about-turn by governments, in admitting the existence of unidentified flying objects, demonstrates that files *are* generated and maintained on strange phenomena. The continuing denials and cover-ups involving these animal-related incidents point towards the involvement of these same intelligence agencies, whose role it is to keep the truth hidden from the public.

One of the earliest cases of this disturbing phe-



rested there. The unfortunate animal had been surgically opened from the neck to the chest, with the lungs, heart and thyroid all missing. The removal of the organs had been done with precision, but there was no blood evident. Furthermore, flesh at the edges of the wound was a dark colour, as though cauterized by very high temperatures. Later laboratory analysis suggested that discoloration at the cellular level indicated that a burning process had indeed been used.

All of this contradicted the view of officialdom, with a local veterinary surgeon saying that the horse, Lady (subsequently referred to as Snippy in the media), had died from a leg infection, and that a (never identified) passerby had slit the animal's throat to end its misery. This explanation ignored the accuracy of the organs' removal, the apparent presence of heat to cauterize the incision, and the total lack of blood. Nor did it account for the fact that further marks found on the ground - let alone the six holes - were akin to those caused by an exhaust, and that they gave off higher radiation readings than the background. It didn't account, either, for the fact that a family member somehow burned their hand when they squeezed a piece of horse tissue that had been found nearby.

nomenon to come to public attention occurred in September 1967, in the San Luis Valley of Colorado. A horse was found dead on a ranch belonging to the family of Berle and Nellie Lewis. Six holes, bored into the ground, were discovered close to the carcass. It was as if something large and heavy had

Although the Lewis case involved the sinister death of a horse, the similar demise of cattle and sheep have also since become the focus of media attention. Their injuries include the excision of eyes, tongues, jaw tissue, and the coring out of the sexual and excretory organs. To add further mystery - and

to increase suspicion and anger among the animals' owners - a government or military interest in what has been happening has been suggested by the observation of unmarked helicopters in the vicinity of where the phenomenon has occurred.

The presence of someone (or something) carrying out surgical procedures similar to those performed on the Lewis family's horse was a police affair. Not only was there the issue of animal cruelty to consider, but also the matter of ranchers and farmers experiencing their livelihoods being seriously damaged by the financial losses which the peculiar deaths of their animals incurred. Interestingly, though, when the unfortunate horse was discovered on the ranch of Berle Lewis, a local sheriff refused to begin an investigation.

The presence of unmarked (predominantly black)

helicopters has been reported at various scenes in which these animal-related incidents have occurred throughout the United States. Ted Oliphant, a former police officer in Fyffe, Alabama, came across such helicopter activity when he took part in thirty-five investigations in the early 1990s. A curious case began on 9 January 1993, when Tommy Cole, a chief detective with the Albertville Police Department, lost a Black Angus steer to this perplexing and disturbing enigma. The previous day, his wife had noticed an unmarked helicopter over the family's property, and Cole duly brought in an investigator from the Federal Aviation Administration to evaluate her testimony. The FAA official was sceptical about the potential link between any such helicopters and this incident, but he soon changed his mind after he and Cole saw a similar helicopter (or possibly the same one) as they drove around in Cole's police car.

When they saw the mysterious aircraft, the FAA official hailed it on a radio, asking the pilot for identification. There was no response. Getting nowhere using this approach, the annoyed investigator later managed to trace the helicopter to Maxwell Air Force Base, also in Alabama. When he proceeded to pose questions to the base, he was simply instructed to stop his investigation, and not to speak about it again.

By what authority was the FAA official - a representative of the federal government - told to back off? What was being hidden? Ted Oliphant stated, in the wake of this case and others, that he had been given information that could shed light on at least some of the cases reported throughout the US. He was informed that there was a covert monitoring operation in place, watching the national herd not only for the effects of nuclear weapons testing, but the spread of Bovine Spongiform Encephalopathy (BSE) before it could affect humans as the related Creutzfeldt Jakob Disease (CJD). Cows in failing health could be detected using





thermographic infrared scanners attached to helicopters, as circulatory shutdown would start with the animals' outer skin.

On 25 February 1999, members of a 14-man logging crew witnessed a bizarre sight as they made their way back to their vehicle for a lunch break while working in the Mount St. Helens area of Washington State. The incident was investigated by Peter Davenport of America's National UFO Reporting Center, and Ruben Uriarte, Robert Fairfax, and Kathleen Anderson of the investigative organisation MUFON, the Mutual UFO Network.

One of the work crew members stopped to rest as his colleagues made their way towards their truck from various positions on a mountainside. He noticed a herd of elk on a nearby slope, to the northeast. Then, from the same area, he observed the movement of a peculiar airborne object coming into view. It flew at treetop level, hugging the contours of the terrain as it moved. The peculiar craft was about 200 feet below his elevation, and perhaps 800 yards away.

His first thought was that it looked like a paraglid-

er, or a similar sort of very light aircraft. It had a red patch of colour on its right side, and a white one on its left. However, if it was such an aircraft, then it was neither attempting to gain altitude over the afforested terrain nor, apparently, seeking a landing spot. Instead, it was methodically stalking the elk herd.

The animals separated from each other and ran in panic. One, though, became isolated from the rest and ran towards the north. The object followed it, and it soon caught up with the terrified beast, whose escape was hindered by felled logs strewn across the ground. Moving along at only 7 miles per hour or so, the mysterious craft had soon caught up on its quarry.

The resting worker cried out, and two of his colleagues looked at what was unfolding. (The attention of the rest of the crew members was still focused on the fleeing herd). The 'wing span' of the object wasn't much larger than the elk - but it still had no difficulty in lifting the 500-pound animal off the ground.

The device had an unusual wobbling, oscillating movement as it flew along, the elk somehow gathered in underneath. Bizarrely, the animal moved in tandem with its captor, as though it were welded to it. The resulting MUFON report referred to the elk appearing like 'a solid metal sculpture' joined to the craft. It moved away, eventually heading skywards at a 45 degree angle and becoming lost among clouds. The rest of the herd gathered into a tight group near the tree-line back on the mountainside - which indicates a defensive stance when a threat from a predator is perceived.

While eleven members of the work crew knew that something had spooked the herd of elk, three others had observed, in broad daylight, as these strange and somewhat unnerving events transpired - events in which an otherworldly technology and intelligence were clearly evident.

In late 2001, UK researcher Graham Birdsall's *UFO Magazine* was contacted at its Leeds office by an elderly woman, Lilian Goodge, who had a strange tale to tell. During the Second World War, she had joined the Women's Land Army to help out on farms while Britain's young men were in the armed forces. The WLA continued on after the war, until the country's economy and infrastructure had recovered sufficiently. In 1949, while she and her col-

leagues were billeted at Brockington Grange, near Hereford, they were driven approximately ten miles to a farm to help out with various tasks. When they arrived, the farmer displayed several dead sheep in one of his fields. He couldn't explain what had killed them - but they had not been mauled by dogs.

In the 1990s, Lilian Goodge had become interested in the subject of UFOs and associated mysteries, and had started reading up on the subject. Before long, *UFO Magazine* ran a feature on weird deaths involving farm livestock ... and she recognized the photographs and descriptions of the animals' unusual injuries as being identical to those that she had seen on the farm to which she and her friends had been taken all those decades earlier.

A case in Northern Ireland was brought to the attention of the authors at the 2006 Irish UFO Conference, in the course of a private conversation with British investigator and researcher David Cayton. From studying the summary notes that the former Royal Air Force member subsequently handed over to us concerning the case and from an initial lengthy interview with the County Derry farmer at the centre of these shocking events, the resulting inquiries led to our investigation file growing to several inches thick.

As recently as 2017, despite all of the efforts made by all concerned to find a solution, the mysterious incursions on his property were continuing - leaving well in excess of *five hundred* sheep dead.

The experiences of farmers attempting to liaise with officialdom in regard to inexplicable animal cases serve as a reminder to us all that when it comes to keeping certain topics away from serious public scrutiny, a government is a secrecy machine without equal. And if those responsible decide to turn their attention from animals to human beings, that machine goes into overdrive.

Is it possible that among the many thousands of people who go missing around the world every year, that there are some who have fallen victim to the intruders' sinister agenda? And that this horrific prospect has been concealed from us?

Our book, *Circle of Deceit: A Terrifying Alien Agenda in Ireland and Beyond*, details cases where retrieval teams have been deployed to remove human bodies that have been subjected to the same bizarre procedures that have been evident within the animal kingdom.

## About the authors

### CARL NALLY & DERMOT BUTLER

We have been involved in the research and investigation of the paranormal for over two decades. From an early age, we both read extensively on various aspects of the subject, watched countless hours of paranormal-themed documentaries, etc. By the mid 1990s we both found ourselves as committee members of a Dublin-based research group, which gave us access to a wealth of information from witnesses coming forward to tell of bizarre encounters they'd had with various unexplained phenomena. Ghosts, poltergeists and religious apparitions were reported to us on a regular basis. We were also aware of the vast amount of UFO incidents being reported globally, and of encounters, specifically, between pilots and unidentified flying objects (UFOs). We founded our own organization, UPRI (UAP and Paranormal Research Ireland) in 1998.

# AN OVERVIEW OF UFOLOGY FROM AN AMATEUR

After studying the UFO phenomenon and ancient history for many years it seems increasingly likely to me that the academic author Zecharia Stichin may be right in part at least with his theories of 'Ancient civilised beings' visiting our planet in the distant past. It would explain a considerable amount of unknowns and seemingly impossible feats performed by long gone bronze age civilisations several of whom were in existence longer than our relatively modern civilisation have been, and it seems arrogant in the extreme to assume that people in ages past were any less intelligent than we are today but simply their terms of reference were very different to what we find in common usage today and at the risk of appearing flippant and quoting a 1980's English game show called 'Catchphrase' people just 'said what they saw' and I think that could be exactly what they did in the past but as mentioned previously using the only frames of reference they had at the time. A good example may be 'A flaming sky chariot' and as the only vehicles known at the time were horse powered chariots, if it was in the air they would not have the word 'flying saucer' or 'spaceship' in their vocabulary.

In the 21st century (Government secrecy and cover ups aside for the moment) we are as far as we know

at the top of the technology tree in our known universe. Any unexplained phenomena seen by people from all walks of life around the world today are immediately jumped on by a host of media and some unsavoury 'interest groups' that make a mockery of the amount of remarkable things seen around the globe. The usual 'experts' and 'new age gurus' are summoned for their opinions and suggesting everything from world peace to weather conditions. I think that the vast majority of unexplained happenings can indeed be put down to natural phenomena that we may not be fully aware of but there are a significant amount that defy all rational explanation despite all our knowledge and technology. Today, I think it would be correct to assume that the majority of the science fraternity accepts that life in various forms in the known universe is a fact and it is just a matter of time before they find us or we find them. The thing we need to ask ourselves as a species are what would we do with the technology to travel by whatever means throughout our own galaxy or further? We would of course as Nations compete with each other to get there first both for the prestige to prove to others we were somehow better than the others, and for the undiscovered potential of currently unknown minerals and undiscovered riches in whatever form that they may take. It would seem illogical to think that any other sentient species would not want to achieve something similar as-

suming they had the same inherent desire to obtain as much knowledge as possible to further their species.

Moving on to Government secrecy and cover ups it would seem that the majority of their work is done for them in recent times with the advent of sensational 'documentaries' purporting to 'solve' various well known unexplained cases from around the world. Without exception it seems that some of these shows are made as entertainment with 'reconstructions', special effects of supposed events and 'expert opinion' from various individuals some of whom do more damage than good to genuine academic study on this difficult subject. In our unchanging desire to continuously get 'one up' on other competing and upcoming Nations it is unlikely that world Government is going to cooperate with each other openly and honestly on this subject, you only have to look at the looming disaster of climate change to see that whatever calamity is going to affect every one of us in the not too distant future, rich or poor around the world, power, economics and wealth will always take precedence over everything else. Where does that leave those of us that try to get to the truth of the seemingly endless 'When' 'Why' 'How' and 'What for' questions. Personally I think it will take an unprecedented event of a kind that cannot be ignored or covered up in any way. Also to be considered is, what if visitors have already arrived and been here for some time

and some Governments have been collaborating with them for years. We also need to think of any potential motives a visitor may have, if they for example thought like us in respect of gaining power or wealth in any form it would seem logical that they would clandestinely approach one Government or another to trade off knowledge and or technology. If however they have been around for as long as Sitchin maintains it would seem correct that they visit all parts of the planet to see what we're up to and how far we'd got in intervening years and any threat we might pose to a potential wider community in galactic terms. The eternal conundrum of why they don't stop and make their presence known once and for all continues to baffle. If anything it just feeds the rumour machine globally and we need to ask why and what for, which in turn, the way our society functions, enables those that want complete control to further their aims and be the first to make meaningful contact if that hasn't already been achieved.

The generally accepted view of National Security from world Government/s is, I maintain largely pointless due to the fact that if another civilisation can traverse the known or wider galaxy by means of propulsion, time travel or dimensional travel I don't believe that we have any technology that would overly concern them should they make their presence known to all and because of that it would appear for the minute at least their motives remain unknown for the time being.

Returning to Sitchin's theory it would seem to be perfectly reasonable to consider for a moment the achievements of a number previous civilisations mainly but not exclusively Egypt, South America, Sumeria to name but three. All of these societies achieved a number of staggering landmarks throughout their history mainly in construction much of which still survives relatively intact today and is still seemingly impossible with the known technology they had available at the time.

For example, over and above the obvious technological marvel of the pyramids of Egypt the old capital of Thebes has some incredible construction including lintels that weigh in excess of fifty tons and defy explanation as to how the builders of the period made these edifices. Some are even it seems made purposely overly difficult when there are easier ways to achieve the same result, also places like Macchu Picchu in South America defy any rational explanation. Only two rational options are available, either these

civilisations had invented a technology we are unaware of at present or they were assisted from elsewhere, however, the generally accepted reasons for these incredible structures in archaeological terms are that it was done for prestige which seems implausible at any level.

The Sumerian civilisation routinely describes encounters with 'Gods from the stars' as a matter of everyday life and there are still countless texts yet to be translated so who knows what information they hold. It is imperative we 'get over ourselves' as a species and accept that there just may have been more technological civilisations around for longer than we have been around in the modern sense. Once all the mystical, inferred hidden meanings and religious assumptions are taken out of many ancient texts many do in fact read as actual events that took place, if one is prepared to take in to account the probable world view and hierarchy of the era as much as is possible anyway. Equally translations from lost and now unspoken languages are exceptionally difficult to translate with any real meaning without imposing modern terms and views on them which inevitably distorts any original meaning.

The other major hindrance in ancient texts are the religious connotations and the generally accepted views as actual fact, that in numerous examples are more outrageous and unbelievable than the entire UFO and Ancient visitor theories combined, and if anything are a convenient 'get out card' to explain the seemingly impossible relying solely on faith alone. It is genuinely hard to accept that we as a species are prepared to believe in a Supreme Being that put us here just so that we could worship his or hers very existence with no concrete and unassailable scientific proof and yet the vast majority of those who have a devout faith in any religion dismiss out of hand the UFO and Ancient visitor theory!

In summary I propose that we as a mainly amateur and disparate group of individuals who have an interest in the incredible field of Ufology and Ancient Civilisations work together, share information and try to shake off the 'fringe elements' that continue to make serious academic research unacceptable to the wider scientific community and we may at some point in the future make sense of the now by researching the past in a different light, unless of course anyone decides to make their presence known in an unmistakable fashion that is.

# UFO PHOTOS OVER POLAND & 'MISSING TIME'

UFO sightings as we know are not that uncommon, but UFO photographs are few and far between, especially ones that could be the genuine article. I have worked on several alleged UFO photo-cases down the years with most of them turning out to either be something convention or a hoax.

On June 23<sup>rd</sup> of this year I was contacted by a long-standing colleague in Poland by the name of Robert Bernatowicz. Robert is a UFO researcher and journalist. Here is what Robert had to say:

*Thank you so much for email. I've got two things. First, I'd like to tell you that we just received a series of interesting UFO photos taken in 2013. The witness reports that he saw a UFO then took the photographs and then has a break in his memory of what happened next. I thought you would like to see these photos.*

More emails were exchanged, and I offered to assist Robert in any way I would, and he sent me what scant information he had available:

*The story of these photos is a bit complicated and it all started with the information sent to the Nautilus Foundation via Facebook. Here is that first message on Facebook:*

*"Hello. I saw you the latest article about UFOs over Warsaw. I remembered that I had similar photographs. I want to send them to you and ask for your opinion. These are not my photos. The photographs were taken by my friend a few years earlier (I know the place where they were taken) in one of the forests in the Wielkopolska region. Regards"*

*As you can see the author does not want to give us a phone number which is a problem. This is the reason why we approached these photos very carefully. I wrote him a request about the circumstances surrounding the taking of the alleged UFO pictures. He wrote back that he knew very little about them:*



*"My friend was on a bike trip. Suddenly he heard a rustle and saw a UFO object rubbing against the crown of a tree. He remembers only that he watched it and suddenly the UFO object disappeared. Then he took some pictures (he did not see a UFO during the taking of the photos!). At home, it turned out that on the pictures is UFO. He felt like he had a period of missing time. The pictures are not a joke and I exclude the fact that they were the result of using a graphics program like Photoshop."*

*We have tried to meet the author of the e-mail. He also took the photos of the location where the alleged UFO photos were taken. Is he telling the truth? Well... We do not know that. My friend from our UFO group suspects that he is the real author of these photos, but he is afraid to give his real name and surname. Why? In Poland, talking about UFOs means that people will take you as a person with mental problems. If I know something more I will let you know. For now, we only know the location*

where alleged Close Encounter occurred. It's close to the town "Jastrowo" and it is about 300 km from Warsaw.

On July 11<sup>th</sup> Robert sent me more details concerning these 5 photographs.

The problem is that the person who sent us this photo does not want to give his name and we only know her nickname "Bruno (real Facebook name on file)". This is the address of this man's Facebook. We also have his email address and are trying to meet him. My colleague believes he is the photographer. He has told us some more details:

"Hello. I do not know exactly but it seems to me that it was 2013 (receiving and photographs were taken a year earlier). The month, unfortunately, I will not specify, although it was the spring-summer period. I received the photos on a low-quality memory card (I do not have it any more) in the form of copies that I have on my computer's hard drive. I do not know anything about editing photos. I compared them with the material available on the Inter-

net, especially with photographs of Edward Meier, and these seemed to me the most similar in quality and surprisingly similar form of capturing these vehicles near trees. As for the picture you presented recently, I noticed that it is different from the ones I sent. I am not an expert, but the ship seems to

stand still and is much clearer from the background. What does this mean? Its shape reminds me very much of the UFO which was photographed by George Adamski and which turned out to be an ashtray or dome of a lamp from what I once read. contribute to their growth.

# Volumes One & Two

While waiting for more information to come back from Robert I decided to start the analysis of these photos and enlisted the help of Jason Gleaves. Jason was formerly in the Royal Air Force and now specialises in UFO photo-analysis. He is also the author of the book 'UFO PHOTOS-COMPUTER ANALYSIS OF WORLDWIDE UFO IMAGES THROUGH THE DECADES'. Jason's initial analysis was very positive:

**COMPUTER IMAGE ANALYSIS  
BY JASON GLEAVES**

I was recently contacted by fellow ufologist Phillip Mantle regarding five separate clear and high-quality images of what appeared to be a metallic disk-shaped object hovering at low altitude above a remote unknown location.

Phillip asked if I could analyse the images using the latest up-to-date enhancement techniques, no other information regarding the images was known and further research was needed to ascertain the source etc...

Working through each image methodically (1-5) I was amazed at such a high quality they were, after upscaling the images I overlaid the five separate images to confirm the movement of the object, which it did, it appeared to move in a small radius of approximately 200 feet, staying within approximately 150-200 feet altitude from ground level.


Also, very noticeable and helpful regarding the analysis process was the mass of foliage etc, this was very productive to ascertain perspective relative to the object and its surroundings and tree line positions.

The unknown camera operator appeared to have taken the photographs from five slightly different positions (all pointing towards the subject object) in each of the images but all within an approximate few feet distance from each other as recognisable foliage and tree branches are seen in each.

Other important factors come into play regarding the images, location (to gauge more accu-

rately the distance to the object) Sun positioning, time of day (relative shadows etc) not only trees etc but the object itself, without this information makes it more difficult to give a more accurate conclusion.

The object itself appears to have structure and



be metallic in appearance, exhibiting a larger main circular base/body tapering upwards to a pointed apex (like a church steeple) below the larger circular base a smaller domed protrusion is seen. Also, the shadow of the object on the ground is not detected, which makes me assume the Sun is behind the camera operator thus positioning the shadow off towards the distant foliage (like the nearby central tree).

I have also embossed one of the images showing an enlarged and enhanced view of the object which is exhibiting No device(s) or cabling system to suspend the object.

In my conclusion to my analysis of the five images draws me to believe there is a structured object present and it is of an unknown origin.

Verdict: Unidentified. Jason Gleaves.





# The SPI Book Review

I'll be honest, when I was sent this book to review I went, "*Here we go again another book on the history of UFOs, guess it will be the same old same old*". How wrong was I!

It is probably the 'best' overall book that I have read which gives a picture of the UFO subject. You name it, it is more or less covered here. It truly is the first book that an interested person in the subject should read, for after reading this book you will be left in no doubt how 'massive' the UFO subject really is. I've so much to say about this book and not a great deal of space to do it any justice, but I hope that by the end of this review, you will understand like I did when I completed the book, that Ufology is a subject that you just can't let go of.

The author is honest when he tells us that he has never met a Ufologist (someone who studies UFOs) that said, he has always had an interest in the subject and clearly knows his stuff, but like many people he is a wee bit wary of all the weird and wacky conclusions that certain Ufologists have come up with to explain the subject. He accepts that mankind is still learning about this vast universe of ours and that we have to accept that something that sounds ridiculous may not necessarily be so (how often have I said this!) A good example of this is when James refers to how a chap called Ernst Chladni from Germany first proposed back in 1764 the idea that rocks from outer space were crash landing here on Earth, how ridiculous was this, stated the Earth's scientists at the time. We now know that rocks 'DO' fall from the sky, they are called meteorites and yet here were learned men of the day totally denying this and likewise here today we have learned men of today's generation totally denying UFOs. Scientists he says, are not always right and are very protective and jealous and to some degree, stubborn, in their way of thinking (you got that right James!) In 1890 Baron Kelvin of the Royal Society stated that heavier than air flight

was impossible, then in 1903 Dr Simon Newcomb, a Canadian American scientist also stated that he too believed that it was impossible. James tell us that we should never use the word 'impossible' and who can argue with that.

The book looks back in time to what could be UFOs these were observed by Monks in St Albans England back in 1254 to the Nuremburg UFO display of April 14<sup>th</sup> 1561 and the discs over Basle in 1566. A substantial amount of early UFO sightings are given many from Great Britain, for instance the Windsor Castle UFO event from 1783 is looked at. The great air-ship wave of the 1890's is also looked at with some interesting cases to ponder over, these of course could well be early inventors testing their 'heavier than air' inventions. From air ships to Foo Fighters all get scrutinized through the careful eyes of the author. During the Cold war there were a lot of paranoia and some people felt that both the U.S. and British Governments might be behind these amazing aerial displays, but of course Russia too were thinking that it might be the Brits or the Americans that were behind the sightings in the skies across Russia. The Scandinavian ghost rockets are also looked at here, again were these objects from outer space, or could they be test rockets from right here on planet Earth? No book on UFOs could be published without looking at the classic UFO cases such as the so-called Roswell Crash of 1947 and the Kenneth Arnold UFO sighting that ushered in the UFO craze! The author truly has done his research and there a lot of British UFO cases that he has uncovered that even I was not aware of.

The engaging style of the author is also refreshing and throughout the book his wit and humour lighten up the text. As I said at the start, this book leans heavily on UFO history and provides the reader with all the historical facts from the American Government's UFO study groups which as you will see, set out to 'disprove UFO's rather than careful find out the truth! Indeed, the author reminds us that Project Grudge an American Government Air Force team set up to Investigate UFO's, had its main aim

which was to tell the public that it had solved ALL UFO reports and that they all had natural identifiable explanations. This obviously destroyed the desire for those airline pilots and police officers to come forward and say what they had seen due to this whitewash. Probably though the most damning account that the author reminds us about is found in the joint Army, Navy, Air Force publication (JANAP) 146e, which, and I quote, 'threatens to prosecute 'anyone' under its jurisdiction, including pilots, civilian agencies, merchant marine captains, and even some fishing vessels for disclosing reports of UFO activity relevant to U.S. security. By the way, the infamous Condon report (US Government study of UFOs, could not identify 30% of its study!)

The author then tells us that the British Government have many times stated that UFOs do not pose a threat to the security of Great Britain! Really, how do they know? The author also looks at some of the best UFO photographs that have been taken around the world and there are some truly interesting revelations, (The Paul Trent photographs being a good 'for instance' as to what happened to the negatives!) The author quite rightly looks at people's misperception of UFOs, in other words, looking at things in the sky that are natural, but they interpret them as something un-natural. The author then looks at our own aerial technology some of which looked decidedly like UFOs, could the UFOs seen in the skies during the various decades be our own? The German Horten brothers Flying Wing as a prime example. We all know that the various Governments around the world keep secrets, are these flying devices seen in the skies across the world our own black budget aircraft?

The author quite rightly states that just because we can't identify what's going on in our skies, doesn't mean we should ignore them (and reminds us that those early scientists said that stones do not fall from the sky) Most notably is the electromagnetic interference that UFOs can effect on cars, aircraft and missile systems and a good few cases are mentioned here. We also look at WHY! If they are advanced craft coming from somewhere, why not stop and say hello rather than traverse the universe only to disappear! Good point James.

There are some really cracking chapters in this book, chapters with loads of info on UFOs and the Police, and boy oh boy you are in for a treat here. UFOs seen over airbases is another chapter that will make you sit right up in your chair, (probably the best chapter in the book!) Then we have a chapter on UFOs and Civil airlines, man it just gets better. The sceptics will love the

chapter on UFOs and Military Aircraft, (read and weep sceptics) There have of course been hundreds of alleged UFO landings and we have a chapter in this book which deals with some of the best ones, (sadly Scotland's famous Dechmont Woods case is not given a mention but then again there are so many the author couldn't discuss them all) UFOs of course are not just seen singularly, and there is a chapter on Mass UFO sightings which will blow your mind and the author states that the Washington DC sightings of 1952 are for him, the most compelling and convincing UFO sightings on record. There is so much good stuff in this book that I would need to write another book just to mention them. The author is correct when he says that UFOs could be covered up the Government and by way of an example he reminds us about the cover ups that were used on the following scandals, 'the Manhattan Project, which was the development of nuclear weapons, the loss of HMS Dasher in 1943 and the infamous Slapton Sands Incident of 1944, I dare say that you the reader have a few more in mind.

There are, as the author states, many people who believe that there is a UFO 'cover up' in place, people such as former astronauts Gordon Cooper and Edgar Mitchell, FAA executive John Callahan, ex White House chief John Podesta, and ex Admiral of the Fleet, Lord Hill Norton. At the end of the day this is a mind-blowing book, a book of immense proportions, a book with more facts than you can shake a stick at. Yes, there are a lot of UFO compendium type books out there, forget those, this is the one you want, this is the one that should be read. A monumental book which should firstly be given to sceptics and watch their face change as the realization that this subject is way above what they thought they knew. Superb, truly superb.

# My Paranormal Life

**By John Ventre**

**This is an excerpt from my book, *The Ufologist*. I now go to church twice per week and go to 4 different churches.**

**1991**

In 1991, we moved to Roxbury Knolls, New Jersey. No sooner had the moving van left, than I began to hear strange sounds in the garage.

While we were watching TV in the den, we could hear a distinctive sound. It was the sound of cardboard moving boxes sliding across the concrete garage floor.

My parents came over to see our new home and also heard the sound. My father asked me what the sound was that he heard. I told him it was the moving boxes sliding across the garage floor on their own. As with the previous occurrences, no reasonable explanation could be found. This was only the beginning.

**1992-1996**

In 1992, I separated from my wife and moved out. My ex-wife's personality had taken an abrupt change in 1990 and she was no longer the person I knew. The children had remained in the home in New Jersey with their mother. From August of 1992 to June of 1994 was without doubt the worst 22 months of my life. This was not a typical separation and divorce. It was mental cruelty and torture for me. I won't go into the details of dealing with someone I knew since high school who had become someone else. Man has dominion over the earth but this entity broke my marriage up and denied me a third child.

My son Nolan told me that while lying in bed, he heard a loud male voice next to his right ear say, "I'm going to get you." He also told me that he would hear loud dripping water in the bathroom but when he would get up and go to the bathroom there was no dripping. He also told me of another occurrence that happened to him. One morning while brushing his teeth, he saw a seven-foot tall black creature with braided hair and long nails run past the bathroom door. His cat, Sweat Pea, was sitting on the counter in the bathroom and turned

to look. Nolan ran from the bathroom and jumped over the rail and landed on the first floor. My son would see a thin tall dark shadow in the corner of his room and always felt that his bedroom was cold and dark although there were multiple windows on two sides. One time, he closed his eyes at night and reopened them and it was morning yet he knew he never slept. He woke up confused as to what happened. He felt there was an evil presence in the house. My daughter said she could hear a rocking chair and baby crying in the spare bedroom and when she put her ear to the wall, could hear voices. Sometimes she would sleep under her bed for protection.

I divorced in 1994 and got the house back in the settlement. I slept downstairs in the fifth bedroom, refusing to sleep alone upstairs in that eerie house.

In 1995, my girlfriend Caroline moved in. She told me she heard a baby crying and the sound of a rocking chair in the empty bedroom upstairs.

One night while we were sleeping, I awoke to the sight of a boy standing at the foot of the bed. He wore overalls and a plaid shirt. His hair was cut in a bowl cut. I thought it was my son. I told him to get into bed and I put my arm around him. In the morning, I asked Caroline where the kids were. She told me they hadn't slept over last night. I believe a family of settlers died in Oklahoma where we were living and their spirits followed us to New Jersey.

In 1996 while still living in the same house, Caroline and I had another strange experience.

We were in bed talking. All of a sudden, she looked up and said, "What's that?" There was a dark cloud or shadow above her. It started to move across the ceiling above me. I also said, "What is that?" It settled in the corner of the room. We looked at each other and then back at the cloud. It was gone! There was one light turned on located on the end table, but there was no source of movement to create the moving shadow. This shadow appeared one other time across the den ceiling and my sister and her husband along with my son saw it. My son's dog, a collie, would hide in the corner of the Den and run from the house every chance he got.

Years later, my daughter and her friends drove past the house at night to take a look at it. All the lights

on both floors and outside simultaneously went out. My daughter never went back out of fear that the entity would follow her.

I moved to Greensburg Pennsylvania located near Pittsburgh, in 1997. There seemed to be a constant tapping in the wall in the spare bedroom. When I would tap back it would stop and then start again a few minutes later. I'd hear it almost every night for years.

While living there, I attended my first MUFON UFO Symposium in Northern Virginia. At the Symposium, I met a strange looking attractive blond woman. She had gray blood shot eyes and albino features and was very large on the bottom. I had lunch with her and never saw her again at the Symposium. I returned home from the conference on July 4<sup>th</sup> 1999.

The following night, I started waking up approximately every hour or two. I was absolutely paranoid that something was in the room. I'd wake up swinging my fist at the air. I even hit the bedpost and hurt my wrist. This continued for four or five nights. People at work told me I looked tired. I was unable to sleep. Every time I woke up, I'd look around the room expecting to see someone. My children came to visit the following week and it never happened again.

Coinciding with the sleepless nights, I had my second out of the body experience. I was floating above the house. I could see the peak of the house and almost touch it. I could also see my green Grand Cherokee in the driveway.

My girlfriend Nancy looked up a UFO site named NUFORC. She found that there was a UFO sighting in State College, Pennsylvania and Morgantown, West Virginia that night. My home is in a direct path of that flight pattern. A few weeks later, I read the book "Communion." There was a paragraph in the book, which referred to out of body experiences. It mentioned that most people believe there are situations where your soul leaves your body while it sleeps. It is actually an alien abduction. Sometimes you awaken; it's like during surgery when you're under anesthesia. All you can remember are the rooftops and trees passing by as you are taken up to the ship.



I also recalled the piece of metal that I had blown out of my nose. It had resembled a scalpel tip, which seemed odd even though I did have an operation in 1982 on a deviated septum but that was 17 years earlier.

I wondered if there was a connection to what had happened during my youth. It was exactly thirty years since my similar out of body experience in New York. I asked Dr. David Jacobs and he did not think abductions occur thirty years apart but happen often over a shorter time period. I disagree and I know they'll be back in the summer of 2029. This time, I'll have my motion sensitive camera equipment set up in my bedroom. Thirty is a combination of three which is a marker of the devil.

During that week in July 1999, I had two recurring dreams. One was of a large hairy creature standing by my bed. The other dream was of a strange looking kid poking my 95 pound Doberman Pincher in the ribs. I kept saying to stop poking my dog but the kid would continue to do it. My dog was rigid and stiff and floating in the air. The kid was bald and looked like Nosferatu the vampire or a rat boy with very tight or pulled skin on its face but I also have a second memory of a kid with bulging eyes, straggly hair and pointy ears and elbows. His forearms were large like Popeye. It was half human and appeared to be eight or nine years old. Was it a lucid dream or an interaction aboard their craft with my hybrid son?

A few weeks after this incident, I experienced three years of erectile dysfunction. I was 42 and consulted with two urologists and no cause could be

found. I was prescribed Viagra, which worked fine. As the memory of this incident faded, so did the E.D. and has never occurred since.

There are a number of questions that you ask on an abduction case. I'll list them and my response:

- 1 Missing time- No
- 2 Flashes of light- Not at this time but in 2009
- 3 Memories of flying- Yes
- 4 Dreams of beings- Yes
- 5 UFO sighting- No
- 6 Social consciousness- No
- 7 Important mission or task to be completed- Yes
- 8 Awoken at night startled- Yes

In December of 1999, my 95 pound nine-year-old Doberman died of a heart attack. I'm still uncertain whether this was an ET abduction, lucid dream or demonic incident. I believe that the fact that this occurred after attending my first UFO Conference is significant. I had regularly attended Horror-cons and Comic-cons with no adverse effects.

#### **2004**

I met my girlfriend Colleen on June 3<sup>rd</sup> 2004 only hours after I was told that my job transfer to New Jersey was filled by someone else. This was nearly ten years after my divorce to the day. She moved in with me in November.

Colleen and I went to bed Thanksgiving around 12:30 AM. We closed the bedroom door since my children, Nolan and Vanessa, were downstairs watching TV. Around three in the morning, I awoke to the sound of someone shuffling their feet outside of our bedroom door.

Colleen and I awoke at 7:30 AM. She left for work at 8:30 AM and I proceeded to get up and brush my teeth. As I turned on the light, I noticed two arm and hand- prints that were located on the mirrored wall above the sink. They were crossed. The hands had six fingers. The elbow to the fingertip measured twenty-two inches, which was three inches longer than mine. That would make the creature at least seven feet tall. The imprint started at the top of the mirror. I could not put my hand and elbow on the mirror at that height without climbing onto the counter. The forearm imprint was of two bones. The latent imprint was not on the mirror when we closed the bedroom door and went to

bed. Colleen had not put it there. We dusted the imprint with makeup and took pictures.



I later asked Nolan why he was outside my bedroom at 3:00 AM. He looked at me with surprise and said, "I was going to ask you the same thing. I got out of bed at night and saw a green mist in the hallway from the floor to a foot from the ceiling and I thought I heard you walking outside my room later that night checking on me!" He also told me that he also heard a playful tapping on the walls but never felt it was evil like in the New Jersey house.

Another paranormal experience occurred over the Thanksgiving holiday in 2004. Earlier in the day, I laid down on the bed on my stomach to rest. After a few minutes, I tried to roll over on my side. Something was holding me down! I could not roll over on either side. I turned to look behind me and I saw a milky cloud backing away from me towards the corner of the room. I was now able to turn over. When I looked back again, it was gone!

#### **2007**

On Wednesday October 3<sup>rd</sup> 2007, my father passed away. He was 77 years old and not very religious. He was very "old school" and for years told us that he was not going to have any operations when his time came. He planned on passing away in his chair at home in peace. He did just that. His abrupt death was a surprise and shock to me since he had always been very alert and fairly active. We took a family cruise in 2006 and he kept up with me in the weight room and walking to the sightseeing. He enjoyed a

little gambling and telling tall tales. He had bought a new car over the summer and had booked a trip to Las Vegas for October 8<sup>th</sup>.

Two weeks before he passed away, both my son and my ex-wife's mother contacted him. My ex-mother in law had not spoken to him since we had divorced 13 years prior. She drove over and spent two hours talking to my parents. My son had never called my father due to the fact that we moved away from Long Island at an early age and my career kept us moving. He felt an urge to call him, which he did. My son called me and told me that he had a good talk with Grandpa and was happy that he did. He called his sister to do the same.

When I went to bed on Wednesday evening after a day of grieving, I lay in bed in the dark looking at the corner of the ceiling. All of a sudden there was a flash. I could only see it with my left eye, which means it registered on the right side of my brain; the side that registers emotion, creativity and artistic traits. It was like a fountain of energy flowing from the center outward and back around. It looked like a fountain of water if you were standing over it watching the water flow away from the center. It was perfectly round with a dark black core like a tunnel. The electricity that was flowing was multicolored and very bright and intense. I believe this was a portal to the spirit world or to another dimension. A few seconds later, the hair on my arm moved and I jumped and rubbed my arm. I believe it was static electricity as my

father put his hand on my right forearm. I called his name but there was no further interaction. I saw my two children the following day and told them what had happened. My son said that he was working at his computer and had also seen a flash of light on the windowpane.

After the funeral, we went to the house to gather a few family photos. I saw a birthday card to my mother from three weeks prior that read, "To Pauline, Love Tom and Good-bye". He obviously knew that his days were nearly over. He also had told my mother a few days earlier, "Not to count on the trip to Vegas on Monday."

In June of 2008, my son graduated from Penn State and was the first "Ventre" with a college degree. We went on a European cruise for 16 days. While in Florence Italy, we turned a corner and I absolutely recognized the view. I knew I had seen it numerous times before.

## 2009

I was awakened at 4:40am on September 1<sup>st</sup>, 2009 to a strange sight. My bed is situated so that I can look down the hallway. When I awoke, I looked down the hall to see a seven foot tall figure standing there with back lighting from the attic. In the summer, I nor-

mally leave the attic door open to allow air from the two open skylights to flow through the house and for heat to escape. I thought that maybe the attic light was left on since the cleaning woman had come over the previous day. I sat up in bed, viewed the figure from different angles and I said to myself, "What the hell is that"?

The figure was tall and thin with a very small waistline and long arms. It looked like the alien from the movie "District 9". It had a square head as if it was wearing a helmet. I crawled to the foot of the bed. It did not move. It just stood there frozen in step ready to ascend the steps. I rolled to my left out of bed and turned the end table light on and proceeded down the hallway. It was gone. My dog was sleeping on its bed at the top of the stairs. I walked to the attic door and there was no light on. I looked at the rug for footprints since the rug was just vacuumed and there was none. I went back to bed and turned out the light and the hallway was now pitched black. I keep the three other bedroom doors at the end of the hall closed so the dog doesn't sleep on the beds. There was no light at all. I kept looking down the hall as I lay in bed. A light then shown through the front hall window. It was similar to the car light of the newspaper delivery person except that I live in a cul-de-sac and the car light always turns to my left as it turns around. This light was different. It shown through the window for a longer period of time and then seemed to pull away and dim instead of turning in the street.



I'm know what I saw and I was definitely awake and saw a thin helmeted figure standing down the hallway with a light coming down the attic stairway! Oddly, my dog slept through the entire affair. Was this the entity that left arm prints on the bath room mirror in 2004?

In 2014, Terry Ray wrote a book on orange orbs. He went through over 2000 MUFON orb cases. In cases where there was also an entity sighting, it matched my 2009 thinly built helmeted creature but is it an ET?

### 2010

On Saturday April 24, 2010, I attended the yearly JDRF Gala in Pittsburgh with my daughter, son and his girlfriend. At 4 am on Sunday, my daughter ran into my bedroom panting and frightened. She said, "Dad, you have to believe what just happened. I know you won't believe me but just listen to me." She proceeded to describe her ordeal. She said she couldn't sleep at all the entire night since she lay down at midnight. She explained that she had been pacing around the house because she could feel a presence in her room and it followed her around the house. At 2 am, she went downstairs to grab a water bottle. Realizing there was none in the upstairs kitchen, she proceeded to the basement refrigerator with caution. She explained that it felt as though someone was walking around with her. As she grabbed the water bottle, she got a sensation that someone was definitely in the room. She even called out, "Grandma?" When it appeared that it was just her and some unknown entity, she ran up both flights of stairs constantly peering behind her back in fear.

She walked creepily down the upstairs hall into her bedroom feeling petrified. She decided to go into the bathroom and turn the light on, splashing some cold water on her face to try and help alleviate her anxiety. She explained that at that point in time she began to feel pains, and realized that her period had just begun; although, she usually gets it on the same cycle and time- this not being it. Some believe that during the menstrual period females are more susceptible to paranormal encounters due to increased vulnerability of the mind and body. She felt weak and went back to her room where she sat on her bed with the light on in a panic, as she still did not feel alone in the room. When she finally gained the courage to turn her bedroom light off, she laid down in an attempt to sleep at 3:30 am. Lying as stiff as a board under the covers, with her eyes pinned open gazing at the ceiling, she felt an extremely intense pressure in her body. It felt as though someone had lain on top of her and absorbed into her body. In pure panic, she tried to move or speak, realizing that she was paralyzed; All of the muscles in her body had tensed up, as she was unable to move. This was painful, as every tiny muscle in her body was tightened like a rubber band. This sensation brought on immense pressure inside and out. Her teeth were clenched, the muscles in her face were of no use, and her head felt like it was going to explode. She had considerable trouble breathing as it felt like her chest was being crushed by the full weight of another human being and everything in her body felt an inability to move, including her rib cage as she tried

to breathe. As her ears rang with piercing pressure, she heard voices all around the room as if her bedroom was crowded with people's random conversations. She then heard a female voice above her say "*When you're done with her, I want to try out the other two.*" At this point, the panic had taken over her body and mind as if she was completely helpless. She felt as though one entity had entered her body and the other was watching in sadistic enjoyment.

When the entity left her body, it was very painful. It felt as though her insides were being pulled out, and the pressure was slowly descending. As it exited her body she explained that an enormous weight had been lifted. She slowly began to move her fingers and could, now, fully breathe in. She was traumatized. She lay there in extreme panic feeling like the experience could not have been real. As she was sweating and panting, she became aware that she was still not alone. No sooner did the entity leave her body that it occurred again. If not the same one, a second entity had entered her body. The exact same sensations instantly took over. The pressure in her ears and head were immense. Being that she was fully aware of what was happening this time, she explained that she desperately thought of how she could stop the pain. She attempted to scream "Dad", but the inability to speak was too strong, as she could not breathe in or move. She tried with all of her energy to move her arm, but it felt as though she was completely held down. The second time, the room was full with voices that were too distant or low to understand. She explained that


## 2013-14

The house had been quiet since April of 2010. In 2012, loud booming sounds were heard all around the world as if the sky was torn apart. In the fall of 2013, I started hearing the tapping again in the spare bedroom. It appears that when a spirit attaches itself to you, it has no concept of time and can leave and come back years later. I returned from my usual book writing trip to Fort Lauderdale on November 22 and when I lay down to sleep, I heard a mild tap on the wall in the corner of my bedroom. I ignored it and closed my eyes and then heard a very loud bang above me where the ceiling fan is. I also have a 105 pound male Doberman. When I got up out of bed in the morning, my dog came over to me to be petted and abruptly bit my left hand. He has been very temperamental all week; growling at me at times and showing his teeth.

My son and his fiancé visited for Thanksgiving. They said they heard the tapping in the spare bedroom. I have a home theater with a projector on the ceiling in the den and while watching the Cowboys football game, I was standing speaking to my son about the camera system I installed on the inside and exterior of the house that records all motion, when we both saw something move in front of the projector light at ceiling height. It reflected the light and moved in a waving pattern like a snake. These minion spirits have mass because it reflected the light.

On December 30, I was sleeping and woke up abruptly to a loud sound that seemed to originate from my bathroom. It was so loud I thought a truck crashed into the back of the house. It sounded like a tractor trailer hitting a large pothole. The second I closed my eyes there was another loud boom from the corner of my bedroom. I could feel the percussion on my face like an explosion went off.

My 84 year old mother was over to visit in May of 2014. She can be very annoying. I wanted to say something hurtful to her, so I said "There is no God". She didn't even react, but did I inadvertently



renounce my belief in God? I wasn't feeling very religious after publishing "*An Alternative History of Mankind*" and still brooding over being divorced and the lack of quality dates out there.

On June 6, (6/6) 2014, I celebrated 20 years of being divorced. The following evening, I was upstairs and decided to use the bathroom in the hallway rather than in my bedroom. There was such a stench in the room. I thought that maybe the sewers had backed up and I could smell it coming up the shower drain. I couldn't determine if it smelled like a dead animal or feces. I ran the shower water for a few minutes and then put the ceiling exhaust fan on and closed the door and then headed downstairs to watch a baseball game.

My 105 pound Doberman has a habit of coming up alongside my reclining chair and laying across my legs while his hind legs are still standing. He likes when I pet him as he lies on my legs. While petting him, all of a sudden we both heard a bang on the wall and the Indian picture on the wall lifted. I also have two Indian sculptures with feathers hanging on either side of the picture and the feathers also blew as if a wind hit it in this enclosed room. Both my Doberman and I looked at the wall where we heard the sound.

After watching the Tiger baseball game, I went upstairs to go to bed. I heard the fan on in the hallway bathroom so I opened the door and turned the fan off. I thought it was odd that the foul odor still persisted after three hours of having the exhaust fan on which did nothing to relieve the smell. I brushed my teeth and turned the TV on as I lay down. My dog then walked down the hallway, looked up the attic stairs, and started barking ferociously as if he was looking at something at the top of the stairs. Dogs can absolutely see or sense these "Other" intruders from another dimension. I went up the stairs with my dog to confront this entity, but everything seemed normal. I again lay down and my dog lay on the chair at the foot of the bed. There was another loud bang in my bathroom. Again, both the dog and I looked in the direction of the

sound. I wasn't afraid. I was angry, like finding a burglar in your home.

When I got up the next morning, I walked past my dog and he showed his teeth and started snapping at me. This is something he has done over the past year for no reason. I walked down the hallway and the odor was gone. The incident didn't frighten me; it made me angry that an entity would be in my house and try to intimidate me. As I thought about it, it really started to concern me as to what is coming next. I spoke to a priest who said it's not the house but me. I purchased some books to rid myself of this hitch hiker and started asking a lot of questions. I also wonder if publishing my anti-religious "*An Alternative History of Mankind*" had encouraged them.

In September 2014, I met Wanda who is a devout Catholic and, like me, has had many paranormal-demonic occurrences like I have. She blessed the house and recited the exorcism cleansing prayer from memory. How many women you know can do that? I believe Wanda was sent to help me fight this invisible war. The house feels safe now except for the family of cardinals that relentlessly keep flying into my windows.

I wonder if an entity attached to me in Oklahoma where I heard an Indian chant and then saw a farm kid ghost dressed in overalls in my NJ house. I say this because the picture that lifted and the head dress feathers that blew to the side in June were Indian. Was there a symbolic message in that?

I've completely changed my view of the paranormal, supernatural and metaphysical. Through applying theology, I fully understand the dark powers and their intentions. Through October, the house has not only been quiet but seems very clean and fresh, no heaviness. I told my son about the generational sin that has been plaguing me. He said he doesn't want that to happen to him as he is trying to start a family. I told him not to worry; I've broken the chain. . . .

### 2015-16

January 10, 2015, I went to bed at 10:30pm and my dog immediately went nuts barking; a familiar scenario in this house. My dog ran downstairs to the door and barked as if the UPS man was standing there. I got up and looked from my upstairs balcony. The motion sensor lights were not on. I could see no movement outside yet the dog was going crazy. I

walked downstairs to the front door and heard a tremendous bang like a sonic boom.

The following morning my neighbor asked me if I heard anything around 10:30 pm. I told her about my dog. She said there was a tremendous bang against her house as if a car hit it or a transformer blew. Those loud bangs were familiar to me. My guess is that the Fallen came back, couldn't get in because my house and my spirit had been cleansed. I only wish I could've seen his gross face as my house shined bright!

As mysteriously as Wanda showed up, like a grifter, she was gone two months later. I had never been to her house or consummated our relationship. She said she no longer consummates. I believe she has a condition known as Poikilothermic or low body temperature. She was physically as cold as a corpse. She seemed to show up at the right time to get me back on track with Jesus and then she was gone like a guardian angel. I get the sense that she was sent to help me.

Out of the blue, my son called me and said he is moving from D.C. to Pittsburgh; 12 miles from me. Sounds like I will see my grandkids on a regular basis soon. When you do things for the right reasons, you are already in the kingdom of God! I believe we all give off a light; some brighter than others. Adam was clothed in light before the fall. Lucifer was the angel of light before his fall. The way these demons identify their victims is by the amount of light you give off. My light had been dimming with my research into the unknown. I frustrated the demon on January 10<sup>th</sup> and he could do nothing since my light radiated.

In April of 2015 the noises came back. I seem to wake up a lot between 3:00-3:33 am. That is the devils time since Jesus was crucified at 3 pm and 333 is half of 666 and it shows contempt for the Holy Trinity. When I lay down at night, there is knocking in one corner of the ceiling and then in the opposite corner. There is also a very loud knock right above me. It even happens if I get up and go downstairs into my office. I'll sit down and hear the knock right above me. It is so loud. Welcome to my nights with the invisible man. There seems to be a sonic boom in my bedroom when I wake up as if a spirit is fleeing into another dimension. But just who is causing this knocking? While reading Timothy J. Dailey's book "*The Millennial Deception*", my heavy gold chain around my neck unlatched and the cross it

holds dropped into my lap. I thought that was odd since I usually need help to unlatch the spring type clasp and this has never happened in the 18 years I've worn it. I might need to contact Wanda again.

A few days before the November Pittsburgh MUFON Conference, I had lunch with a pastor from Queens who heard me speak in October at the Philly MUFON Conference. He wanted to discuss my paranormal experiences. I told him what has happened and he said I am marked and "They" will definitely return. He said he wanted to stay in touch but when I emailed him as to what happened at Thanksgiving, there was no reply. I'm wondering what type of pastor he was. .

Unfortunately, "They" always return for Thanksgiving when my kids visit me. I was fully expecting my daughter to stay a few nights at my house after flying in. On Monday, her bedroom door opened on its own. I closed it. On Tuesday, her bedroom door opened on its own. I closed it. Vanessa then told me Wednesday that she was staying all five nights at her brothers. I'm glad Vanessa and her husband stayed at my son Nolan's house. The tapping noises came back on Wednesday of Thanksgiving 2015 as the entity turned its attention to me. I believe the door opening twice to Vanessa's room was a signal that they intended to attack her again but more severely than in 2010. There's loud scratching in the dining room wall and I'm also getting pricked by a needle in my leg when I enter my bedroom.

On Wednesday, I laid down to sleep and felt a stabbing pain on my scalp. I thought I was stung by a bee. I sat up and lay down again and it was even more severe than the first time. I got out of bed to check my scalp in the mirror, but there were no marks. I could hear the tapping sound in the wall of every room I entered. There was also a loud sliding, then banging then creaking noise coming from the ceiling. I felt a chill in my soul as if it was afraid of these forces. There was a presence in the room. Let's face it; their goal is to take your soul. When I went back to bed, I noticed how pitch black the room was; total blackness, not even any light coming through the windows. I could hear the heavy creaking in the ceiling. The chill was still in my spine and my hairs were standing up. An evil was present that only faith, not science, can confront. The ceiling creaked again. Was this the actual angel of death prematurely coming to claim me? I twice commanded the entity to leave in the name of Jesus Christ.

When I said that it will be sent to the pit of fire now instead of later, a dull light started to come through the window. I thought it was a car light but what was weird was the light entered the room as if a veil or screen was slowly lifted. I could see the light enter from the bottom of the window to the top like the darkness was being pulled off the room. As I looked around, I could see a dull light coming through the other windows also. There was a quarter-moon so it was moonlight and not a car light. I used to love to sleep in total darkness. For the first time in 58 years, I sleep with a night light on (I asked my son why he sleeps with a light on. He said it is because of what visited him in the New Jersey house; see *"An Alternative History of Mankind"* for details). I also asked Jesus to protect my dog since he protected me, my mom who was in the hospital with kidney failure and my brother who just had his thyroid out due to cancer. I took my dog for his Lyme disease test and it read zero. The Vet was stunned since his last test came back at a 35 and it is rare to test at a zero; cured. My mom's kidney failure became a kidney infection and she was cured overnight and my brother went weeks without thyroid medicine after having his thyroid removed. Miracles do happen.

Its mid-January 2016 and all was quiet. The tapping came back immediately after telling my son that the tapping was gone. Sometimes it happens when the blown hot air heat is on. Most times it is when no heat is blowing. It also stops when I yell at it or bang the wall and then starts right back up. Sometimes it is slow tapping and others are fast tapping and in different walls and corners of ceiling. One night, I opened my left eye and could see a number of dark shadows circling counter-clockwise around the ceiling fan; just as my daughter did in 2010. When I opened my right eye, it wasn't present. I could only see it through my left eye; same as when my father died in 2007. I'm not sure if these are ghosts or demons. Ghosts cannot be compelled to leave. I often feel as though something brushes up against me as I enter my bedroom.

I always let the dog out through the basement. One day, as I approached the sliding glass door, a hand ran across my forehead and scalp. It wasn't like hanging cobwebs. It was clearly large and had fingers. I didn't feel this was negative though. It was similar to how I pet my dog. It seemed more like an approval of how I'm fighting back.

The oddest thing now is the dreams. I'm waking up again at 3am; five nights in a row. I have a dream that someone is laying against my back as I sleep on my side and it is cheek to cheek with me whispering in my ear. It is clearly a dead person. Once it was Whitney Houston. I also see hairy creatures and I wake up as something approaches my bedroom from the hallway. It absolutely feels real in that split second that I open my eyes and feel it still pressed against my back and face. If this is a lucid dream, it feels fucking real! I have many sleepless nights looking at the ceiling and listening for the noises; anticipating its return. I have no choice but to expel this entity or face it in the afterlife.

I told my story on an internet radio show and two of the hosts who are paranormal investigators suggested I bind and sell my wedding band along with my fathers that I have. I also decided to get rid of two items I picked up at antique stores; a bone box and a werewolf head enclosed in a glass case.

At this same time there were five women who sought me out. One was a former "girlfriend" who decided she'd rather get paid than go to dinner. This was a soul tie through sex who believed she had an old soul linked to Egypt. Another was a woman I sat next to on a plane trip who didn't work but had everything. She bragged about how she finally figured it out and wanted me to meet her in Pittsburgh; no thanks! None of them were the type you'd bring home to mom. One was much younger and launched a Facebook rant against me. She was manipulated by a "colleague" and a delusional UFO nut. We're still friends today via Facebook. I absolutely believe these women were sent. "They" know your weakness. Let's face it, I never attract five women in five weeks; never had that kind of luck. I don't know what is planned for me but if their goal is to stop me, I'm even more determined.

I spoke to three local Priests and a Pastor and they didn't seem to be interested. They are more interested in running their business and not their core responsibilities! They were very nonchalant about my concerns. My guess is they have never dealt with a real entity case or feared involvement. I had former County Commissioner Bob Cranmer on my UFO Talk Show and he said he had the same issues with the local clergy regarding his house on Brownsville Rd but he has a Pittsburgh Priest and exorcist who can help if needed.

In March, I watched the TV series "Damien" which

is a continuation of the Omen storyline. The tapping immediately came back the following day. Apparently they are always around watching for an opening. I commanded them in Jesus' name to leave and they did. I can't watch this show and am leery about any demonic movies or TV shows. The tapping sounds finally ended at Easter. The last crescendo took place the night after Easter as I stood in my bedroom doorway looking at my dog, I could hear a low vibration that increased into the tapping sounds. It was right next to where I was standing. Then it was gone like a dying animal's death throngs.

I flew to Myrtle Beach to visit my daughter and returned April 20. While there, I stated outlining my next book called, "The Ufologist". In the fall, I had ordered a large religious head stone which was being installed at this time. As they finished, about 150 feet of the wooded area of my yard burst in to flames; coincidence, synchronicity or have they finally left? The birds also stopped flying into my windows. The house was completely quiet for about a week. In 2011, I had bought a wolf's head in a glass display case from a large antique store in Pittsburgh. I put it in the trash. Who knows what it was used for? The noises came back immediately but very weak and momentarily. I had dropped by two jet-skis off prior to the trip to be serviced. The batteries were charged and installed and I tested that they worked. Now, both batteries were completely dead and an overnight charged did not restore them.

On April 30, I gave my first lecture on this subject matter at the Erie UFO Conference. It was very well received. Two guests gave me their blessed Rosary beads which I hung on my bed posts when I got home.

On May 4, my ex-wife's birthday, I could hear the movement in the ceiling at night. There were popping sounds all around the room and I could feel a presence. The dog paced all night. I could hear the dog in the kitchen and at the next moment hear him upstairs outside my bedroom door. He doesn't move that quickly. I yelled at the entity that I am not afraid, I'm angry so get lost. I said my prayers with one hand on the rosary hanging on the bed post. In the morning, I called my church and asked for a house cleansing. They took my name and never called back. This is my second attempt with my church and I also spoke with an evangelical pastor

with no luck. I don't know if they don't believe or are afraid to confront it. They say it is rare so they are skeptical. I'm not afraid! I also know that at any moment, God can allow an attack on me if I have an impure thought or intention, just His way of teaching you a lesson. I am only safe and defiantly arrogant as long as He allows it. That's why I flinch when I hear them.

On May 21, my neighbor invited me over. One of the priests from my Our Lady of Grace parish, Father Dinga, was there. My neighbor mentioned my involvement with UFOs and the fire in the yard. I leaned over and asked my priest if he knew who I was. He said he knew. I mentioned that we need to speak. He said he knows. Two weeks later, Father Dinga called and I explained what has been happening. He suggested that we start with a house blessing and then move on to a house cleansing but an exorcism would first require me to undergo psychological testing. Every Diocese has an Exorcist whose name is kept secret. Father Dinga performed the house blessing on June 23. I doubt a blessing would be powerful enough but I also suspect the entity had already been driven off by my prayers and faith because "He that is within me is stronger than he that is without".

The week prior to the blessing, I vacationed in Scotland. The morning I was leaving, June 13<sup>th</sup>, there was tapping in both walls in the hallway. I tapped back and when it replied with a tap, I said, "Boo, you can't scare me anymore"! While there, I had a four hour lunch with fellow paranormal investigators Rich Ritchie and Brian J Allan. Our conversation confirmed much of what I already had concluded in this book and gave me the knowledge and motivation to put the final touches on this book. I highly recommend Brian's two books listed in the suggested reading at the end of this work.

Unfortunately, in early July I started smelling gas in the upstairs hallway and bathroom; the same area that I smelled death two years ago. My dog again went down the hallway and looked up the stairs and started barking. I had Donohue's HVAC come over and test for a gas leak. They checked the water heater, furnace, gas fireplace etc. and found nothing even though my carbon meter read 57 (the year I was born). So odd how your logical mind looks for answers and it wasn't until the serviceman told me he found nothing that I realized what it was. It appears that "They" plan to continue to

come back and check on me for the taking. That's what happens when you've been marked for life and after death. The unusual pastor who told me last November, ten days before I was attacked, that I was marked and the demon would be back, called me mid-October of 2016 to tell me he was coming to the Philly conference. He seemed unusually excited to hear he was right about his prediction. I know his name and if "It" returns this Thanksgiving I will send it back to him!

Like clockwork, Halloween passed without celebration or incident but the birds flying into the window and the tapping came back a few days later. Hopefully the bird is just memory of flying into the window six months earlier. The tapping starts around 8 pm in the TV room and continues all night in my bedroom; a slow methodical tap all night or a loud tap on the ceiling above me. It ends as soon as the sun rises. These are poltergeists and not demons. I've made three large donations to two churches and gave one of the priests the first edition of this book. Still, there is a strange non-interest when I try to talk to them about the devil and needing help.

I can't seem to logically deduce if this is a generational curse or connected to moving to Oklahoma in 1989 or related to attending a UFO Conference in 1999. Are they related; unrelated? Are the Greys demonic, alien or both? Scientists all agree that there would be non-interference *Prime Directives* in place when contacting an inferior society on another planet yet the alien abduction violates that. If it is not alien but Fallen, then the goal is to alter the human DNA and make us non-human.

Two friends tried to covertly help me: I received a call from a psychologist who said he wanted to join Pa MUFON but was more interested in my situation. A metaphysical teacher contacted me to explain what I was doing wrong with my chakras. Both people were directed to me by friends. . . .

There are five stages that humans go through in dealing with serious situations; *denial, anger, bargaining, depression and acceptance*. For me, each time my mind first searched for a logical answer or denial. I then got angry and challenged the entity. I will not bargain with it or accept it. I called upon God for protection. That's the only bargain I will make. From what I have seen with other people, they communicate and accept and join the entity and they know not what they do. These things

seem to absorb energy like in the first episode of *Star Trek, The Menagerie*.

It is Christmas day 2016 and my last entry in this journal. I'm in the home theater room watching TV and I hear footsteps shuffle across the tile kitchen floor. Sounds like how my 86 year old mother walks. The dog is sitting behind me and gets up and goes to the doorway and stairs at the floor as the steps continue. He rotates his head back and forth as he can hear it but see nothing. I move to the couch in the back of the room and feel the hair on the top of my head move so I swat at it and hit a straw finger or tube-like structure that disappears. Was it an angel, demon, relative or guest from the adjoining cemetery? There are loud bangs from under the refrigerator and I can hear a low growling hissing sound like whisper.

In January 2017, I meet a woman who is a year older than me. She is fairly attractive and in shape. She looks me up online and is also all into the paranormal except that she is a new ager and Unitarian who contacts ascended masters in her sleep for guidance. She has participated in exorcisms in South Africa but she will not speak Jesus' name. She tells me she doesn't believe in the God of the bible and wants her friend Olga the South African Exorcist to come to my house and remove the entities. I'm not inviting anyone or anything into my home that doesn't believe in Jesus especially when all it takes is an invitation so I severed the relationship. It's obvious "They" are coming at me through women since I am single and many a "soul of a woman is created from below". That's a line from a Led Zeppelin song *Dazed and Confused* referring to women as demonic succubus . . . . I don't drink, smoke, gamble or do drugs and am financially secure. "They" are always plotting and roaming like a lion for attack and "They" use people to latch onto you.

Lastly, I have read that Satan attacks when God has plans for you or if you are a threat to his kingdom. I am a threat to his kingdom because I plan to speak out on my monthly UFO TV Talk Show, this book, radio shows and my conference lectures on the reality of Satan and the trick of Grey ET abductions. I believe I have the string theory of everything figured out! Faith in Jesus and asking for his protection is the only thing that works. All of my decisions are now based on how they affect my soul.

This time, she felt the muscles in her face tighten

so hard that her mouth was cringing on one side. This sensation caused so much fear, she felt as though she was suffocating. She really believed she might die. As the entity lifted out of her body, she was in shock. She lay there petrified and too scared to move, for she did not want to draw attention from them. They were still in the room.

My daughter further explained that she could see a dark shadow circling above her like a whirlpool. When she looked to her dresser mirror, the shape of a male figure was in the left corner. For one whole minute, she watched the shadow carelessly moving, trying to figure out how she could escape from the room. She slowly moved her right arm to push back the blankets, feeling as if she had absolutely no energy to move. She ran out of the room and down the hall. After she told me what happened, we went to her brother's room to awaken him and his girlfriend, and proceeded to tell them what transpired. His girlfriend instantly said she felt nauseous and very hot. My son began to say the same thing, as he peered towards his dresser mirror with faint detachment. He explained that as he looked straight ahead, he felt as though he was going to fall sideways right off the bed. His girlfriend went pale and her face became clammy and wet. I felt nausea and light headed also. I explained to them that my daughter's room is the closest to the cemetery, which is right behind our property; that's where they might have come from. A few minutes after my daughter finished explaining the incident to them, the sick feelings slowly began to dissipate for all of us. My son and his girlfriend packed their bags and headed home to D.C. at 5am. My daughter slept in my room with the light on. As a child living in the haunted NJ home, Vanessa used to grind her teeth at night which is a sign of stress.

I spoke to my son the following day and he said that both he and his girlfriend started to cry as they drove away from my house and were overcome with a feeling of sadness. He also said that he set his Garmin GPS to find the nearest hotel and it took them to a cemetery.

# This is only the Beginning - Perspectives from North America By Bryan M. Bowden



Earlier this Spring, I received the following communication from Chris Evers, the publisher of this very The Outer Limits Magazine. "Bryan, I'm looking for a North American (including Canada) correspondent to provide an article for OLM once every 6 to 8 weeks. Do you know if anyone with a sound knowledge and long experience of the subjects that may like to do this?" Chris is a great guy, who I consider a true friend. I am always willing to offer my help and support and as such I responded in kind with - "I think I have a few ..."

My brain started going through the usual suspects, including nominating myself, but before I could really get thinking, the bell of an inbound message went off. As suspected, it was Chris replying with "I was implying you Matey ... Do u fancy doing it?" I could not help but chuckle and then agree to be the correspondent. So here we are. It's the moment of truth and I have to figure out a good way to get the ball rolling from North America. There are many styles and concepts, individuals, experts and just plain old experiencers, that I will visit over time; however I feel that an introduction about me and my interest in the field is the best way to start.

I have long been a researcher and investigator of things that go bump in the night. Most of my work, investigations and research have been compiled on my own, for my own knowledge, reference and use. After all, when you start talking paranormal and UFO's, the strange looks start to appear and there is most often several references to "tin foil hats" while whistling the theme to the "Twilight Zone" (or people changing your ringtone to the X Files...) However, when the topic comes up at most any

social circle, you eventually get a few people that will come by and start off the conversation with, "Well, there was this one time..." That is when I start to smile and take notes.

As the chief information officer and chief technology officer for the Bronxville Paranormal Society (BPS), I have seen a drastic change in the attitude of many regarding UFO's and the existence of life beyond our planet Earth. In 2017, to promote the release of its film, Phoenix Forgotten, 20th Century Fox Home Entertainment commissioned a national survey regarding UFOs, aliens and abductions. Of the 1,756 Americans surveyed, 99 percent were high school graduates with the majority having higher educational experience, i.e. Bachelor through Graduate levels.

The survey showed 47 percent of the participants believe in aliens; nearly 39 percent of these Americans believe aliens have visited Earth before; more than 16 percent say they have seen a UFO; 18 percent believe abductions happen; and 27 percent know someone who claims to have seen a UFO. Combine these survey results with Tom DeLonge's To The Stars Academy, recent press and the UFO-related video footage released by the US Government, and one can safely say that we are now more awake and acceptable than ever before of the UFO experience.

Being open minded to these possibilities is wonderful and allows more individuals to embrace their experiences, and share them within a safe environment. This is exactly what is needed, and often required, for most ex-



periences of the UFO phenomenon. Despite that, the ridicule associated with the subject does still exist.

Suddenly I had an epiphany – given the research and the general public’s attitude, I took the plunge and opened up the New York State UFO Project (NYSUFOP) – a non-profit grass roots organization that allows anyone to report, discuss, and meet in person to discuss about all things UFO related. I drafted my BPS brother Alfred Santariga and together we have opened up an access point for whoever wants to join. We conduct monthly meetings, which we broadcast via Facebook Live (offering all their anonymity, while still being able to participate.) To date, even in its infancy, it has been a huge success and well received. We are often asked to be presenters on a variety of paranormal subjects, and it’s at these events where we let people know what resources are available to all and for all.

Alfred Santariga and myself, as the Bronxville Paranormal Society, were asked to be presenters at the annual Pine Bush New York UFO Fair and Conference taking place on June 9, 2018, for the 4th time. We provided four separate presentations - Paranormal Activity, Cryptids, High Strangeness and Area UFO related experiences. The Pine Bush UFO conference is one of the largest and draws notables in the field. This year, the speakers list consisted of: Dr. Bill Wiand, Linda Zimmerman, Thom Reed, Dr. Nathan Rosenblum, Cheryl Costa, Rosemary Ellen Guiley, and Marc D’Antonio.

Pine Bush has a major significance in the UFO Community. This hamlet in the town of Crawford, in Orange County NY has been an area of High Strangeness and a UFO hotspot for decades. In my opinion, Pine Bush is the Roswell of the East Coast and plays a significant role in Ufology on the East Coast. The hamlet is pockmarked with Stone Chambers that date back thousands of years. Many of these chambers are on ley lines and correlate to High Strangeness, UFO sightings and abductions, not only on the eastern coast of the United States, but globally!

Author Whitley Strieber was living in upstate New York in 1985, around Pine Bush, when he had the alleged alien encounter on which he based his best seller, Communion. In addition, thousands of witnesses in the Hudson Valley and Connecticut observed a football field-sized V-shaped craft, the so-called Westchester Boomerang, hovering over the Taconic Parkway. The sighting is chronicled in the 1987 book, Night Siege: The Hudson Valley UFO Sightings, by Dr. Allen Hynek, Philip Imbrogno, and Robert Pratt. From Native American folklore to modern out-of-this-world experiences, the activity continues today.

I wanted to do something very significant for our presence at Pine Bush. It is not that I am showy – I am not. I just wanted to take a risk with something big and different. If successful, then it is a win-win for all; if not successful then I am getting knocked down a few pegs. In my tenure in the field as a research investigator, I have taken my fair share of lumps, stepped on things I wish to forget



and have held “the Cup” high. As such, I decided that this year at Pine Bush, we would allow anyone who attended the conference an opportunity of a lifetime. We were going to do the ultimate experiment - we were going to try to make contact! It was our goal to take advantage of the areas’ attractiveness to crafts not of this world. As such, we would be conducting a live CE-5 (Close Encounter of the 5th kind)!

The Close Encounter protocols (listed below) clearly detail the differences between each kind. For clarity however, the first four are passive encounters and the 5th through 7th are active encounters and interactions.

#### **CLOSE ENCOUNTER PROTOCOLS...**

##### ***CE-1 Close Encounter of the First Kind:***

is a sighting of an extra-terrestrial spacecraft within 500 feet.

##### ***CE-2 Close Encounter of the Second Kind:***

is a landing trace or an electromagnetic trace - some sort of physical trace that is left by one of these objects.

##### ***CE-3 Close Encounter of the Third Kind:***

as everyone knows from Stephen Spielberg’s famous movie, is the sighting of one of the humanoids or life

forms, usually in association with a spacecraft, but not always.

##### ***CE-4 Close Encounter of the Fourth Kind:***

is when someone is actually taken on board a craft and while this is rare, there are a few cases where it appears that this has happened.

##### ***CE-5 Close Encounter of the Fifth Kind:***

is when humans deliberately take the initiative to interact with or communicate with, no matter how simply, with these life forms and their spacecraft. It is that simple. It may be as rudimentary as someone driving down a road and seeing a space craft that is obviously not of human manufacture, and signalling their bright lights on and off, and the object stops, comes over and signals back in the same sequence.

##### ***CE-6 Close Encounter of the Sixth Kind:***

Death of a human or animal associated with a UFO sighting, although some might consider this as a more severe example of a second-kind encounter.

##### ***CE-7 Close Encounter of the Seventh Kind:***

The creation of a human/alien hybrid, either by sexual reproduction or by artificial scientific methods.

When conducting a CE-5, many variables must align. The primary requirement is perfect atmospheric conditions. The skies must be as clear as possible, though slight cloud coverage is okay. An optimal temperature is also needed, eliminating humidity, which can create distortions in your field of view on a personal level as well as a scientific reflection/refraction basis. Excessive humidity can give false positives.

The night portion of the Pine Bush conference ran from 5 –9 pm, we were very lucky as everything was in perfect alignment for the CE-5, weather-wise. It was a fantastic and informative experience for all. Once the speakers were finished with their presentations, anyone wanting to take part in the CE-5 would need to travel from the conference site to the secluded area where I was conducting the CE-5. As we rolled up to park, about 40 participants were waiting to greet us. We parked the car and headed up the street about 100 yards to a grass location. Everyone settled down in a comfortable location while we gave a few stragglers time to find the location, and in the end we had around 60+ people join us for the event. We even had German TV there to capture the event for ProSieben.

At around 10 pm, I began the event by providing everyone with details of what we were going to attempt to do - make active contact with extra-terrestrials (races and crafts). We used a guided meditation, having everyone empty their minds of the excitement of the day and focus on calm, stress-free images and peaceful thoughts.

People used various breathing techniques to find relaxation and to enjoy the beauty of the location they were in. Once we were all settled, I had everyone ask in their mind and their minds-eye to connect with images of crafts and aliens (whatever their own perception of these may be for themselves). In the process of focusing on these extra-terrestrial craft and beings, I told them to send out the thought and idea that “we want to make contact with you.”





At around 10:30 we had everyone start scanning the sky for unusual objects and lights. One of the missions in doing a scan is to determine the normal flight paths of commercial and private craft. We discovered where the air traffic patterns were and focused on the other areas. This process lasted around 30 minutes and started to get strange lights blinks in a variety of places. Part of doing an outdoor environment event is to take in consideration

celestial objects and weather-related issues. I always employ the use of real-time weather as well as a celestial application to identify objects when something strange appears. Too many times people mistake planets and galaxies for UFO and UAP. According to all my instruments, we were free and clear of the common mistaken objects.

At around 11 pm, Al and I were still focused on the night sky and helping the participants identify objects using our green laser pointers. I started to take notice of what sounded like kids at a distance making a lot of noise. There was a lot of hooting and hollering, and it sounded like teens having a good time in a very quiet town. Nevertheless, the sound took precedent in my mind and I was about to ask Al what all that noise was, when a young man who was taking part of the event cried out, “Does anyone else hear that owl?” It was at that moment that it clicked in and the noise that I was attributing to children was in fact an owl.

The owl’s hooting was coming from behind the group and to the left in the western woods. Everyone started to turn in that direction. It was at this point that an object came out of the western sky and started to provide a variety of light bursts - low burst, high burst, pattern bursts. This wasn’t your ordinary light. It was a white, pure white LED type of light and looked to be in an octagonal casing with a glass bubble surrounding it. Its movement was purposeful and at a slow pace, allowing everyone to see it with their own eyes. Behind the light there looked to be something solid but there also seemed to have a distortion just enough that you could not make anything out.

The object seemed large in scale and whatever the craft’s size, it was significantly low to our position and exhibited no sound whatsoever! A variety of light bursts took place - low burst, high burst, and some pattern bursts. Al was using his flashlight to send the craft Morse Code signals to which the craft responded in kind. At one point the light and craft just vanished. I asked out loud, “Can you give us another bright burst?” And without hesitation the craft responded. Then I asked, “Can you give smaller bursts?” And the craft again responded with smaller bursts. The craft was moving in rather strange pattern, up and down, then making a hard right and then back on its path. The “oohs and ahs” by the group of participants who joined us stood testament to them being thrilled beyond belief. The entire interaction for the night



seemed to go on for a solid hour, but in reality it lasted only a few moments. It was an absolutely an amazing experience; a true Out-of-this-World event. For investigators, researchers and fans of the UFO experience, the CE-5 event is a Grail like occurrence. Yes, we can continue to attempt this type of active contact but there are no guarantees of success, I can personally attest to that. We have had some good days and some bad days. But it is the desire to know and see more that keeps me going. I like answers and I like sharing my discoveries with others.

Nevertheless, there are some in the field that make shocking claims regarding constant CE-5 contact. I have a big problem with these claims and some people that stick out in the forefront of the field. I am also very sceptical of many (including the big reporting agencies) because there seems to be some players who are way too connected to significant government-related individuals as well as a significant monetary component to a lot of these events. And as anyone can attest – if ever there was a corruptor and a root of evil and deception, then money is it. My summation is that the success of these individuals is either due to establishing a relationship and trust with specific races/beings; or they are getting hoodwinked by some government agency and used as pawns. I lean to the latter.

Either way, more research into these events and the relationships made should be conducted – not only on a scientific level but also on a social level. If we can continue to repeat the process and document results, then we are closer to a true scientific study than every before in the public sector. However, if these active encounters are taking place more and more; and almost everyone in society has a video and still camera on them 24/7; then why are there fewer sightings captured digitally or on film? Even further, why are reports to the various reporting agencies like the Mutual UFO Network (MUFON) and the National UFO Reporting Center (NUFORC) currently on a serious decline?

Journalist and author Cheryl Costa was recently awarded by the International UFO Congress, UFO Researcher of the Year 2018. Cheryl and her group have painstakingly hand inputted thousands lines of data, to complete research and number crunching over the last decade. Her results drill down into the county level for most of the states. I cannot thank her enough for all her hard work. This is something that hasn't been done before, but I believe it will start to happen on a national level. It's a must

if we are going to be able to map or quantify the patterns and finally get some answers. In my next article, I plan to examine these numbers and ask Cheryl, and others in the North American field, to chime in.

In the future, I will be doing my best to provide all the readers of the Outer Limits Magazine of the latest sightings and happenings throughout North America If any of you, the readers, who digest this wonderful resource and magazine, have any requests of subjects, topics, or anything UFO/Paranormal/High Strangeness, please do not hesitate to let me know. Until next time, keep your feet on the ground and keep reaching for the stars.

# Astrology & These Latest Eclipses


Normally, I would introduce Astrology as a subject for this new column of mine in Outer Limits Magazine with much depth. I would talk to you all about what it is...a study of (ology) the Stars (astro) and I would inform you of all the myriad of details that goes into learning this profound subject not just slip into the most recent occurrence of the last Eclipse, which happened on Friday the 13<sup>th</sup> of July, 2018!

So why have I decided to dive in? I think you would be bored to tears if I just went into all the 12 signs of the Zodiac (Aries, Taurus, Gemini, Cancer, Virgo, Libra, Scorpio, Sagittarius, Capricorn, Aquarius and Pisces.) I would then have to describe in detail what each sign is about and how the newspaper Horoscopes are not right unless you add your Moon Sign and your Rising Sign, which is reached by your time of birth, and what time the Sun was rising over the horizon, as well as your Sun Sign, (Date of Birth). These tiny but important factors set up a birth chart, as individual as the individual is! DNA got nothing on Astrologers as we decipher, dig deep and analyse you better than Freud and Jung and your Mother! Better and deeper and certainly more correctly!

This is the joy of Astrology. Give us just an hour, OK, perhaps 20 minutes in a pinch, and we can sort out your whole life...how can you do that, I hear you all say! It is easy when you know how.

If you were to give me your exact time and date and place of birth and it has to be as exact as possible to be correct, but if not we can "rectify" the chart to get the time of birth. That is a technique many Astrologers use. It allows us to get the right Rising Sign which sets up the entire Wheel. And what does a person's Astrology Chart (their Natal Astrology Chart) look like? I will show you, just scroll down.

This is my very own Natal Astrological Birth Chart and as you can see below it is made into a wheel. We read the chart by the Eastern part of the chart as it faces us and so we begin where the line across the middle of the chart ends on the left. This is called The Rising Sign also marked at the Ascendant (ASC.) and this tells us Astrologers, and our clients, what kind of birth they and their mother had as they made their grand entry into life on Planet Earth! It is all done using the calculations and



mathematics that most modern Astrologers don't do any more, we have computers to do all that now, thank Heavens! It was a long and laborious process, like birth itself!

Starting at the left side of the chart and looking at what looks like the slices of the pie (they are called "Houses") we are look from the Rising Sign to the 1<sup>st</sup> house and what shows up in there. I have Mars, the planet of energy and action exalted (in a great placement!) in Capricorn. For this woman, (me) it means I like to work and am attracted to successful men. (Because Mars represents Male energy) But this is not the whole truth. I have had plenty of unsuccessful, poetic and spiritually adrift rascals in my life too in my youth. Look for that Square (a negative aspect) to my Neptune in Libra in the 9<sup>th</sup> house for the culprit! (I like spiritual people, creative but alas, some are dreamers) and so, we move on and see the Moon in Aquarius, still in the first house, which represents my Mother. Moon is the mother and how you see her. My mother had a love of theatre and was an actress and a choreographer in her day. Once she had us 4 kids (Mars in Capricorn also denotes my older brother as I enter into this family) she was more in the audience (Aquarius) than on stage (Leo, the actor, its opposite). If I were to carry on deciphering my own chart again, this might bore you to tears! Come and have your own Birth Chart done and see how exciting it is when I am able to not just look at your chart but see all the twists and turns it shows too. A chart for me is like a Map of the Soul. That is the kind of Astrology I like to do. I call it "Soul Level Astrology". The first house is the baby is born, the next house, the 2<sup>nd</sup> house is the early childhood and the 3<sup>rd</sup> house is the house of our neighbourhood, early education and brothers and sisters and cousins. I have my SUN sign there which is Aries and my Mercury which is Aries as well. They are in an aspect called a Casimi which



means they are less than 1 degree apart, extremely close together in degrees. This means I speak my truth as only an Aries can, brutally honest. The key words for Aries are "I AM" and so they are highly individual, like to pioneer and bring in the new and exciting, unique ideas, fashion, art, in my case, Metaphysics and as I recall, some of my love for vintage way back in the mid 1970's! They are true mavericks. My chart shows a love of writing and speaking, which is the 3<sup>rd</sup> house as well. Wherever your Sun lands you see how that house really influences the person or displays their own quirky or unique self. The Sun sign is their SOL, their being. The Moon sign shows their Emotional nature, what their Mother was like for them, (mine was unique as an Actress amongst the neighbourhood of housewives) and we became good friends as I grew up, another Aquarius trait.

Now one can have a variety of planets in any house and



they them make connections to other planets, this is called, "Aspects". There will be good aspects which are harmonious. So Venus in Gemini and Mars in Libra like each other and are similar because their element is the same, "Air". They relate and can chill out together in a fun and lovely way. But if you have a Mars square Moon, that means Mars is the assertive and aggressive one and can bully the gentle nature of the Moon if they are for instance in Aries and Capricorn. (Fire sign, a leader, outgoing, original) even if their first house is Gemini (an Air sign, represents two, opposites, and the same, loves to talk and is a quick thinker) so the Astrologer combines the two= "So you have Gemini Rising and in the first house and this makes you very chatty, loves to seek knowledge but loves gossip too and a real trend setter and Leader in your own neighbourhood or environment. Parents could have seen you as "double the trouble"!

My first house is Capricorn, with Mars in Capricorn. I take my responsibilities seriously and also did this when I was young. I am ambitious but also an empath with my Moon (emotions) in the "well being of humanity" sign of Aquarius. I would believe in "out there" unusual ideals, very New Age and humanitarian issues, and for sure, Aliens!

So as you see the Chart, as we slice it up into Houses gives us a lot of areas to understand when a variation of hundreds of thousands of planet placements could happen on the time and date and place of someone's birth day making each chart unique to the individual.

I want to just run through these houses briefly:

First House: (The Natural House of Aries and key words, "I AM") Birth and the experience of it for the mother and baby. How the person looks (their body) and how others see them/ experience them.

Second House: (The Natural House of Taurus and key words, "I HAVE") Money, properties, what we value. Self worth too.

Third House: (The Natural House of Gemini and their key words are, "I THINK") Your neighbourhood, brothers and sisters and cousins, what we learn in grade school or elementary school, early education and travel but more local or near.

Fourth House: (The Natural House of Cancer and their key words are, "I FEEL"). The Mother and her ancestry, our feelings, our security and how we experience HOME, the one we grew up in and the one we create later in life.

Fifth House: (The Natural House of Leo and their key words are, "I WILL"). Creativity, children, drama and love affairs.

Sixth House: (The Natural House of Virgo and their key words are, "I ANALYSE"). Work and service to others, healing, medicine and veterinary arts and sciences, natural medicine, psychotherapy, animals and animal husbandry and plants, agri-

culture and growing food, chefs.

**Seventh House:** (The Natural House of Libra and their key words are, "I BALANCE") . Committed relationships whether married or not, business partnerships, the law or Lawyers, how you see others. Open enemies too.

**Eighth House:** (The Natural House of Scorpio and their key words are, "I DESIRE") Mastery over our desires, sex, death, rebirth, transformation, the occult, other people's money, inheritances.

**Ninth House:** (The Natural House of Sagittarius and their key words are:, "I SEEK") Publishing and Higher Education, Philosophy, Metaphysics, Foreign Languages, Foreign Travel, Universal Laws.

**Tenth House:** (The Natural House of Capricorn and the key words are, "I USE") The house of Career position (the label: Doctor, Lawyer, Artist, etc) and the house of the Father and his ancestors.

**Eleventh House:** (The Natural House of Aquarius and the key words are, "I KNOW") Hopes and wishes, societies we belong to, our FRIENDS and Astrology.

**Twelfth House:** (The Natural House of Pisces and the key words are: "I BELIEVE") Endings, the subconscious mind, karma, hospitals and institutions, the sea and unconscious beliefs too, our undoing. Secret Enemies.

Now take just this information and put your own Natal Birth Chart over it. So the 12 houses are mingled with the way the wheel is set out when using the time of birth. So in my case, I was born in Pittsburgh, Pennsylvania, USA at 2:00am exactly and this made my Rising sign (what was rising in the East at that time) as 17 degrees Capricorn.

Then using the Placidus House system (and there are many and different charts call for different house systems, like Equal House or Koch House system and some Astrologers have preferences.) This sets the chart for the degrees around the wheel and the beginning of each house. What Planets fall into these houses are determined by where they are in the Heavens. And if they are Retrograde in motion or Direct. **Astronomy is the study of the Stars...but Astrology is the study of what the Stars and Planets MEAN going round our Sun, affecting our own personal Natal Birth Chart and how they affect us all personally!** Big Difference!

How does an Astrologer find out where all the planets were at the time, date and longitude and


latitude of a person's birth? They use an Ephemeris, which is usually Raphael's Ephemeris which shows where all the planets are on any given day, for a year and then there are the bigger ones like the American Ephemeris. Today most Astrologers use their computer programs or a free site like <http://www.astro.com/>

There are so many ways to interpret a chart. And so many different charts to make which can be used for just relationships, called a "Synastry" chart, which compares the two charts together or a Composite chart which makes the relationship itself a 3<sup>rd</sup> chart and allows you to see what the purpose of the relationship is all about, the karmic connections and what are these two meant to do together.

I always suggest a new parent get their baby's chart done. Then you see who has come to join your family! Astrology reads the Chart like a map of the soul so the child's reason for incarnating is clear and also the previous connections to one or both parents. The child's talents, skills, relationship issues and their future life is all in the chart, and their quirks and possible problems (Venus in Virgo, fussy eater!) and so forth.

It is nearly impossible to describe what Astrology is all about because it is a vast subject, with many different interpretations from various forms and schools of Astrology but this is what makes it so mind-blowing, fun and fascinating! AND IT WORKS!

There are two more BIG Eclipses coming up soon. The next one is at 4 degrees Aquarius which will hit the South Node in Aquarius (past life issues) and Mars in Aquarius for the collective on 27<sup>th</sup> of July, 2018. You look for anywhere in your personal Birth Chart to find 0-8 degrees of Aquarius, its opposite Leo, the squares to it, Scorpio and Taurus, any more Air signs like Gemini and Libra or Fire signs Aries and Sagittarius and see how this affects your chart. Eclipses are door openers but they are also cutters,



releasers and letting goers!

The follow up Solar Eclipse is a Leo at 18 degrees on August 11<sup>th</sup>, 2018 and this is similar, so you would look for the later degrees from 10-20 in Leo, its opposite, Aquarius, Scorpio or Taurus but also the other Fire signs of Aries and Sagittarius and their opposites, Libra and Gemini. How will these Eclipses affect you and for the whole year ahead? Leo is about our love affairs, children, bravery, the heart, creativity, drama and the actor/show off/theatre people. How will this be for you?

We are coming into a time where we need to see how the needs of the collective (Aquarius) are just as important as the needs of the individual (Leo). These are the themes of these next two Eclipses.

Six Key Facts The first major UFO scare occurred in the USA in 1896 to 1897.

Thousands of people throughout the nation saw mysterious lights in the sky that they thought were carried by an airship. Many people declared that they met with the landed airship and spoke to its crew, who claimed they were testing a technologically advanced aircraft. The phantom airship sightings disappeared after the work of hoaxers and mundane explanations for the sightings came to light.

The flying saucer era truly began when Kenneth Arnold was flying his Callair plane over Mount Rainier, Washington on 24 June 1947. As he was flying eastwards, he saw 'a chain of nine peculiar looking aircraft flying from north to south at approximately 9,500 foot elevation'. He calculated that they were travelling faster than 1,609kph (1,000mph) and he described them as flying 'like a saucer would if you skipped it across the water.' From that, the term flying saucers was coined and it triggered literally thousands of people throughout the world to report seeing similar objects.

Flying saucers have a bad habit of having to land to make repairs or they simply fall out of the sky and crash. The most famous UFO crash occurred near Roswell, New Mexico. On the 8 July 1947, the Roswell Army Air Base publicly announced that they had recovered the remains of a crashed flying saucer from a nearby ranch.

The wreckage was sent to Wright Patterson Air Base where it was quickly identified as the remains of a conventional weather balloon. Since then it has been claimed that the wreckage was analysed to build highly advanced aircraft and that alien bodies were retrieved and put in storage by the USAF at Area 51.

To some this is the ultimate proof that the US government has concrete evidence of the alien presence; to others it is a myth that has been inflated out of all proportion to the facts. In the 1950s, so-called Contactees claimed they met with peace loving humanoid looking aliens, who often took them for rides in their flying saucers.

The most famous Contactee was George Adamski who reported meeting fair-skinned, androgynous aliens who had long blond hair. Adamski photographed distinctive flying saucer craft, as they flew over Mount Palomar, and he claimed these craft took him on trips to the Moon, Venus and Saturn. The first alien abduction that attracted worldwide publicity occurred to Betty and Barney Hill on the fateful night of 19 September 1961, as they drove from Canada to their home at Portsmouth, New Hampshire, USA.

They saw a UFO following their car and then they returned home two hours later than they expected. Under hypnotic regression it was discovered that both of them had undergone rigorous medical examinations by the aliens during this period of missing time.

As Betty was escorted from their flying saucer she told them, 'This is the most wonderful experience of my life. I hope you'll come back. I got a lot of friends who would love to meet you.'

Today, the vast majority of UFO sightings are caused by Chinese Lanterns.



### Crash retrievals

Despite being able to whizz across our skies at great speed and make stupendous manoeuvres that can run rings around our own aircraft, flying saucers have a bad habit of having to land to make repairs, or simply fall out of the sky and crash. So their technology is not much more infallible than, or superior to, ours.

Of all the crash retrieval cases, that at Roswell, New Mexico, is the most familiar. On 8 July 1947 the Roswell Army Air Base publicly announced that they had recovered the remains of a crashed flying saucer from a nearby ranch. The wreckage was sent to Wright Patterson Air Base and it was quickly announced that it was the remains of a conventional weather balloon. The case was then largely forgotten, or at best dismissed as a footnote in UFO history, until the late 1970s. Since then it has encouraged all manner of 'eyewitnesses' (or friends of friends of eyewitnesses) who claim to have seen the debris, and talk of dead alien bodies being retrieved and held in storage by the USAF. To some this is the ultimate proof that the US government has concrete evidence of alien visits to our planet; to others it is a myth that has been inflated out of all proportion to the facts.

Rather than being a spaceship, some ufologists have claimed that the crash at Roswell was one of the Japanese Fugo balloons launched during World War Two finally coming to earth. Another explanation was that it was a balloon used in Project Mogul, a top secret US project intended to spy on the USSR. Due to public pressure, internal investigations were launched by the General Accounting Office to disclose the truth of the matter. Their first report, in 1995, confirmed that the wreckage was of a Project Mogul balloon. In 1997 their second report looked at the rumours and stories about recovered alien bodies. This concluded that they were a combination of rumours and half-forgotten memories of missions involving the recovery of injured pilots or anthropomorphic dummies used in experimental projects unconnected with UFOs.

These reports did little to dent the public's enthusiasm for speculation about the Roswell crash. Indeed, in 1995 more fuel was added to the flames when Ray Santilli, a British entrepreneur, released film footage which showed a graphic autopsy of a recovered alien from the Roswell crash. Several years later he admitted that this was a reconstruction of the autopsy, as the 'genuine' film footage had been lost.

In 2011 Roswell hit the headlines yet again when journalist Annie Jacobsen's book *Area 51: An Uncensored History of America's Top Secret Military Base* claimed that the aliens recovered from Roswell were actually genetically mutated 12-year-old children.

They were sent to the USA by the Soviet Union in a remotely piloted aircraft to promote hysteria in the American population. Several years earlier a similar theory was put forward by Nick Redfern, who claimed that the Roswell crash was caused by a balloon based on Japanese technology. The balloon was used to launch a glider that had a pilot and crew consisting of handicapped people. The object of this and other missions was to study the effects of radiation and high altitudes on the human body.

Such continued speculation reinforces the concept of the 'Roswellian Syndrome' put forward by Joe Nickell and James McGaha. They note that there are five main stages to this myth-making process:


1. The incident: This is the event that initially triggers the crash-retrieval rumours.
2. Debunking: The recovered wreckage is quickly given a mundane explanation.
3. Submergence: The story lingers in the fading memories and speculation of the local population.
4. Mythologising: As time passes faulty memory, exaggeration and deliberate hoaxing comes into play.
5. Re-emergence and media bandwagon effect: The story resurfaces in the media and takes on a life of its own.

This process also plays out with other crash retrieval cases and UFO incidents. Roswell is only the tip of the iceberg, as there have been nearly 300 alleged flying saucer crashes throughout the world since 1947. Like the Roswell incident, they become more spectacular and mysterious as time passes.

### Crash retrieval motifs

British ufologist John Harney has identified the following crash retrieval motifs:

- The precursor – eg something seen in the sky, an explosion heard, or mysterious object tracked by radar.
- Crashed UFO – almost always in a remote place. Aliens, dead or alive, in or near crashed UFO.
- Arrival of military.
- Civilians expelled from crash area.
- Aliens cruelly treated by military.
- Aliens helpless and unarmed, and apparently not very intelligent.
- Military personnel sworn to secrecy.
- Civilian witnesses threatened or bribed to keep silent.
- Authorities give unconvincing cover story to media.
- Authorities remove all wreckage from crash site, usually on a flat truck covered with a tarpaulin.
- Witnesses pick up bits of wreckage but authorities always recover all of it from them.
- US Air Force nearly always get involved, sometimes allegedly by putting pressure on government of country where crash occurs.
- Long after event, persons contact ufologists to claim they were involved in recovery operation.
- Such persons claim to have seen alien bodies or worked on UFO wreckage.
- Official photographs, films or videos of aliens are never made available or are obvious fakes.

## PASCAGOULA –

## THE CLOSEST ENCOUNTER

In 2015 I set up my own small one-man-band publishing outfit called FLYING DISK PRESS. Today's modern digital technology allowed me to publish on a print-on-demand basis my own books and books by other authors as well. In 2017 I was able to re-publish a book that had originally been published in 1983 by Wendelle Stevens. This book was 'UFO CONTACT AT PASCAGOULA' by Charles Hickson and William Mendez. Charles Hickson was one of the two witnesses to the close encounter at Pascagoula, Mississippi in 1973 and William Mendez was an author and researcher. The other witness involved in this close encounter was Calvin Parker and while he is mentioned in this book it was largely a book by Charles Hickson. Charles Hickson died in 2011 so I had the idea of trying to locate Calvin Parker and perhaps asking for an interview which I could use in the re-published book. Eventually I managed to track down Calvin Parker and speak to him on the phone. To my great surprise Calvin was considering writing his own book. That of course caught my attention. But before I tell you what I was going to learn about this case from Calvin I think an outline of their encounter might be appropriate.

### **PASCAGOULA, October 11<sup>th</sup>, 1973.**

On the evening of October 11, 1973, 42-year-old Charles Hickson and 19-year-old Calvin Parker — co-workers at a shipyard — were fishing off a pier on the west bank of the Pascagoula River in Mississippi. They heard a whirring/whizzing sound, saw two flashing blue lights, and reported that an oval shaped "craft", some 8 feet across

and 8 or more feet high, suddenly appeared near them. The ship seemed to levitate about 2 feet above the ground. A door opened on the ship, they said, and three creatures emerged and seized the men, floating or levitating them into the craft. Both men reported being paralyzed and numb. Parker claimed that he had fainted due to fright. They described the creatures as being roughly humanoid in shape, and standing about five feet tall. The creatures' skin was pale in colour and wrinkled, and they had no eyes that the men could discern, and slits for mouths. Their heads also appeared connected directly to their shoulders, with no discernible neck. There were three "carrot-like" growths instead - one where the nose would be on a human, the other two where ears would normally be. The beings had lobster-like claws at the ends of their arms, and they seemed to have only one leg (Hickson later described the creatures' lower bodies looking as if their legs were fused together) ending in elephant-like feet. Hickson also reported that the creatures moved in mechanical, robotic ways.

On the ship, Hickson claimed that he was somehow levitated or hovered a few feet above the floor of the craft, and was examined by what looked like a large football-shaped mechanical eye, about 6 to 8 inches in diameter, that seemed to scan his body. Parker claimed that he could not recall what had happened to him inside the craft, although later, during sessions of hypnotic regression he offered some hazy details. The men were released after about 15-20 minutes and the creatures levi-

tated them, with Hickson's feet dragging along the ground, back to their original positions on the river bank. Both men said they were terrified by what had happened. They claimed to have sat in a car for about 45 minutes, trying to calm themselves. Hickson drank a small amount of whiskey. After some discussion, they tried to report their story to officials at Keesler Air Force Base, but personnel told them the United States Air Force had nothing to do with UFO reports and suggested the men notify police. At about 10:30 p.m., Hickson and Parker arrived at the Jackson County, Mississippi Sheriff's office. They brought the catfish they'd caught while fishing; it was the only proof they had to back up their story. Sheriff Fred Diamond thought the men seemed sincere and genuinely frightened and he thought Parker was especially disturbed. Diamond harboured some doubt about the fantastic story; however, due in part to Hickson's admitted whiskey consumption.

### The "Secret Tape"

Sheriff Diamond interviewed the men, who related their story. After repeated questioning, Diamond left the two men alone in a room that was, unknown to Hickson or Parker, rigged with a hidden microphone. Sheriff Diamond assumed that if they were lying, that fact would become immediately apparent when the two spoke privately. Instead, they continued to talk in the voices of the terribly distressed. This so-called "secret tape" was held on file at the Jackson County Sheriff's department, and has since earned wider circulation amongst UFO researchers and enthusiasts. Parker, who seemed particularly shaken, spoke repeatedly of his wish to see a doctor. A partial transcript of their interrogation and of the "secret tape" is available; immediately below is part of the conversation on the "secret tape", as transcribed by UFO researchers:

**CALVIN:** I got to get home and get to bed or get some nerve pills or see the doctor or something. I can't stand it. I'm about to go half crazy.

**CHARLIE:** I tell you, when we're through, I'll get you something to settle you down so you can get some damn sleep.

**CALVIN:** I can't sleep yet like it is. I'm just damn near crazy.

**CHARLIE:** Well, Calvin, when they brought you out-when they brought me out of that thing, goddamn it I like to never in hell got you straightened out.

His voice rising, Calvin said, "My damn arms, my arms, I remember they just froze up and I couldn't move. Just like I stepped on a damn rattlesnake."

"They didn't do me that way", sighed Charlie. Now both men were talking as if to themselves.

**CALVIN:** I passed out. I expect I never passed out in my whole life.

**CHARLIE:** I've never seen nothin' like that before in my life. You can't make people believe-

**CALVIN:** I don't want to keep sittin' here. I want to see a doctor-

**CHARLIE:** They better wake up and start believin'... they better start believin'.

**CALVIN:** You see how that damn door come right up?

**CHARLIE:** I don't know how it opened, son. I don't know.

**CALVIN:** It just laid up and just like that those son' bitch-es-just like that they come out.

**CHARLIE:** I know. You can't believe it. You can't make people believe it-

**CALVIN:** I paralyzed right then. I couldn't move-

**CHARLIE:** They won't believe it. They gonna believe it one of these days. Might be too late. I knew all along they was people from other worlds up there. I knew all along. I never thought it would happen to me.

**CALVIN:** You know yourself I don't drink

**CHARLIE:** I know that, son. When I get to the house I'm gonna get me another drink, make me sleep. Look, what we sittin' around for. I gotta go tell Blanche... what we waitin' for?

**CALVIN (panicky):** I gotta go to the house. I'm gettin' sick. I gotta get out of here.

Then Charlie got up and left the room, and Calvin was alone

**CALVIN:** It's hard to believe . . . Oh God, it's awful... I know there's a God up there...

Seeing that the police were sceptical of their story, Hickson and Parker insisted that they take lie detector tests to prove their honesty.

Hickson and Parker returned to work the day after the encounter (Friday, October 12). They did not initially discuss their purported UFO encounter, but co-workers noted that Parker seemed very anxious and preoccupied. Within hours, Sheriff Diamond telephoned the men at work, stating that news reporters were swarming in his office, seeking more information about the UFO story. An angry Hickson accused Diamond of breaking his confidentiality pledge, but Diamond insisted he had not done so, and that the case was too sensational to keep quiet. Hickson's foreman overheard Hickson's side of the conversation, and asked what had occurred. Hickson related his story to the foreman and to shipyard owner Johnny Walker. After hearing the tale, Walker suggested that Hickson and Parker contact Joe Colingo, a locally prominent attorney (who was Walker's brother-in-law and also represented the shipyard).

Colingo met the men, and, during their conversation,

Hickson expressed fears about having been exposed to radiation. Colingo and detective Tom Huntley then took Parker and Hickson to a local hospital, which lacked the facilities for a radiation test.

From the hospital, the men went to Keesler Air Force Base, where they were examined extensively by several doctors. Afterward, reported Huntley, Parker and Hickson were interviewed by the military intelligence chief of the base, with the "whole base command" observing the proceedings.

Colingo drew up a contract to represent Hickson and Parker. However, nothing came of this, and Hickson would later have nothing to do with Colingo, charging the lawyer with base financial motivations: Colingo, said Hickson, "just wanted to make a buck." Within days, Pascagoula was the centre of an international news story, with reporters swarming the town. Professor James A. Harder (a U.C. Berkeley engineering professor) and Dr. J. Allen Hynek (an astronomer formerly with Project Blue Book) both arrived and interviewed Parker and Hickson. Harder tried to hypnotize the men, but they were too anxious and distracted for the procedure to work—Parker especially so. Hynek withheld ultimate judgment on the case, but did announce that, in his judgment, Hickson and Parker were honest men who seemed genuinely distressed about what had occurred.

Tiring of the publicity, Hickson and Parker went to Jones County, Mississippi (about 150 miles north of Pascagoula), where both men hoped to find relief with family members. Parker was eventually hospitalized for what was described as "an emotional breakdown."

In an interview several years after the claimed UFO event, Hickson speculated that Parker fared worse after the encounter because he had never previously experienced a profoundly frightening ordeal. While Hickson described the UFO encounter as the most terrifying event in his life, he also noted that he had seen combat in the Korean War, and that he thus had some familiarity with a terrifying experience. The younger Parker, on the other hand, had never suffered through a terrifying encounter, let alone a bizarre confrontation with something that was not even supposed to exist.

On September 9, 2011, Charles Hickson died at age 80, but never backed off the alien abduction story despite ridicule. As noted above, both Parker and Hickson volunteered to take polygraph exams to prove their stories. In the end, only Hickson did so, and the examiner determined that Hickson believed the story about the UFO abduction.

### **Aftermath**

Calvin Parker has avoided most public attention since the event. Hickson appeared on Dick Cavett's TV talk show in

January 1974, and spoke at occasional UFO conferences; he co-wrote a book about the event with William Mendez titled *UFO Contact at Pascagoula* (1983).

### **Calvin Parker – my story**

As soon as I began talking with Calvin he made it abundantly clear that he had never, and I mean never told his side of the story and he now wanted to set the record straight. It wasn't long before Calvin and I decided to work together on his own book which we entitled 'PASCAGOULA – THE CLOSEST ENCOUNTER, MY STORY BY CALVIN PARKER'. The first thing that Calvin wanted to but straight was his statement that at the beginning of the close encounter in 1973, when he and Charles Hickson saw the 3 entities 'float' out of the craft that he 'passed out'. This was not true as Calvin had not passed out at all and he had a full recollection of being taken on board the UFO and was subject to a similar 'examination' as Charles Hickson was. So why did he and Charles Hickson say that Calvin has 'passed out' and there had no recollection of what took place onboard the UFO. Well, the reason behind this was to protect Calvin. He was only 19 years old at the time and Hickson was 42. Throughout this whole affair Charles Hickson had always sought to protect his young friend and he thought to say that he 'passed out' and therefore had no memory of the abduction then this would help protect him. This is the story that is in Hickson's book and it is in all the articles written about them. But it was not true. Calvin Parker did not pass out and he had a full recollection of being taken onboard the UFO just the same as Hickson had. Calvin's recollection of this event features in chapter 2 of his book but it pretty much mirror's what Charles Hickson had to say and how he described their close encounter.

### **Budd Hopkins in 1993**

Calvin had, down the years, lost most of his documentary information about his encounter especially when his home was under 8 feet of water after hurricane Katrina. One thing that Calvin did tell me was that in 1993, twenty years after his encounter, he was persuaded by a friend to visit alien abduction researcher and author Budd Hopkins in Florida. Budd was speaking at a UFO conference in Florida and Calvin somewhat reluctantly agreed. For those who are not aware Budd Hopkins was New York artist who probably became the world's leading researcher of alien abduction cases and he was trained in and used regressive hypnosis to help abductees reveal more of their encounters. He was also an author of such books as 'MISSING TIME' and 'INTRUDERS'. Sadly Budd Hopkins passed away in 2011.

Calvin went on to tell me that at his meeting in 1993 with Budd Hopkins that he was offered the chance to have Budd conduct a regressive hypnosis session with him back at his hotel. Again, somewhat reluctantly Calvin agreed. Calvin had no recollection of what transpired dur-

ing the hypnosis session but he did inform me that the session was tape recorded. Now I knew that Budd had passed away so I asked his long time friend and colleague Peter Robbins what had happened to all of Budd's research. He informed me that it had all been given to another abduction researcher, Dr David Jacobs. I quickly sent an email to Dr Jacobs asking him if he had a copy of the tape from Calvin's hypnosis session with Budd and thank fully he di and with Calvin's permission Dr. Jacobs sent me a copy.

Now this is a cassette tape and my tape player had long since bit the dust. Thankfully a new one wasn't that expensive and I was now able to listen to the cassette tape and transcribe it for inclusion in Calvin's book. The full transcript is in Calvin's book. The hypnosis session with Budd and Calvin took place on the 14<sup>th</sup> of March, 1993. The first thing to hit me when listening to the tape was hearing Budd's voice. I knew Budd pretty well and had had stayed at my home on one occasion and he was a lovely guy. So slowly but surely I managed to transcribe the two sides of this tape. There are bits and pieces in the tape where the talking can't be transcribed as it is just too quiet, but the majority of the tape was good enough to transcribe. There is one section of the tape that I don't like and that's when you hear Calvin screaming. I mean literally screaming in pain. Thankfully this didn't last long and Budd was able to calm Calvin down.

To my surprise the hypnosis session produced quite a lot of information that had not previously been available. Calvin goes on to describe his encounter with a 'female alien' on board the UFO who he believed was going to kill him. Calvin at one point attacked this female alien in an attempt to kill her first and allow him to escape. Calvin also claims that this female alien hurt him and here is a quote from the transcription:

**CALVIN:** And she has something in her hand,  
(inaudible) ....she's takes the thing down my nose  
(inaudible) around my nose and she's reaching for my lip. And she pulls my lip up and I feel a stinging and my, my blood pressure, I don't know what it is and I can't catch my breath and I'm bleeding and my lip is bleeding and I remember my prayer (inaudible) ... what it is. And then the blood just starts rolling, it rolls and (inaudible).....face and she grabs me by the side of the face (inaudible). And all I could think of was killing her, but I knew that I was gonna die in there, (inaudible). Then everything just settles down, so, I just kinda, lowered back down.

**BUDD:** Now your senses are very, very sharp and clear. Now you know that Charlie has been with you. Do you hear any sounds that would suggest that Charlie is somewhere nearby. Any noises?

**CALVIN:** No sounds, no noises except for, sounds like rain dripping into a bucket, just a steady drip, drip, drip, drip.

**BUDD:** Let's just see if you could hear Charlie call you.

**CALVIN:** I don't hear Charlie.

**BUDD:** Okay. (inaudible)...What's this dripping is this close to you (inaudible)?

**CALVIN:** Close, real close. I'm thinking its blood, my right hand. That bitch just cut my right hand now, I'm bleeding, just a steady drip of blood onto the floor, I can see it, she's sat there. On the outside of my right hand, she's cut it. She's really just pushing me now too far, I will get out of these straps, I will get a hold of her now. There's no doubt and I'm just fighting with everything I got in me now, because this is getting like, this strictly is not right.

**BUDD:** I'm sure it's not. She has no right to do this to you without asking your permission.

**CALVIN:** And I don't know what it is she put in my right hand. And I remember seeing it and I see it now, black and it almost resembles a needle. And there's a serious cut and now she's cutting it, it's really bleeding now; she's cutting into my right hand, right on the outside. And then, it's like a miracle, it's just quit bleeding and it's healed.

**BUDD:** Okay.

**CALVIN:** But there's some object, definitely still there, it's in my hand.

**BUDD:** There's an object inside your hand?

**CALVIN:** Yeah, she put it in there.

**BUDD:** Okay, you will be able to tell us exactly where that is and you can point that out to me. Okay, just concentrate where that is in the hand and you can point that out to me. (Inaudible).

**CALVIN:** She's cleaning my feet and I can see her, she's pulling and tugging and I don't know, I don't know what she's doing, she's, but I feel a real serious pain in my left foot where she's pulling (inaudible)...she's really pulling me with some little, and my shoe fell off. And now she's undone a strap, all the straps, she's taking the straps off and this is my time to get out of here now, time to go.

Tell her adios, I'm going and now I can't move, just here, the straps are gone but I can't move. She's trying to pull my clothes off and I still can't move, yet for some reason I just pushed up on my heels and helped her, I'm in total agreement with everything she's doing now. I don't care what she (gap in tape for some unknown reason.). I

don't know what this is, I don't know what she's trying to do now but it looks pretty serious to me. I can see her sitting her head up and I'm looking now, staring at her.

Clothes is down, got blood all over the front of my shirt, and I guess she's a little (inaudible.....I just wish she'd go ahead and leave me alone, ugh, (inaudible)....oh, damn, it's burning all over, it's going all over. It does, it's burning. It feels like the blood was pumped out of me, lead inside. She put hot.

**BUDD:** Were you (inaudible)?

**CALVIN:** (inaudible)...Christ, oohhhh. (Calvin makes an uneasy noise as if he's in severe pain).

**BUDD:** Easy, easy, you're okay Calvin.

**CALVIN:** (Still makes an awful noise as if suffering in some way).

**BUDD:** Easy, take a deep breath. (Calvin's can still be heard making a noise as if in great discomfort and pain). I'm gonna put my hand on your shoulder, as soon as you feel my hand on you shoulder you can breathe, feel my

hand on your shoulder you can breathe now, feel, the breath is coming back, your breath is coming back, feel my hand on your shoulder, breath is coming back. Okay, it feels much better, that was bad but now easing off, easing off, easing off (in the background you can hear Calvin's breathing returning to normal), easing off, you can breathe. That was tough but it's in the past, now it's in the past, you're okay. Tell me what you think happened there; we don't have to do that again. Just what you feel happened, what do you think happened?

**CALVIN:** She's injected something (inaudible).

**BUDD:** Where did inject it?

**CALVIN:** In the side of my hand.

**BUDD:** Did you feel something going in?

**CALVIN:** Oh yeah, it was going in and then I felt blood coming out, warm blood. I feel like she changed all my blood out of my veins, I've never felt anything that hot (inaudible)...in all my life.

**BUDD:** Did you feel it all the way in your hands, your arms and your feet?

**CALVIN:** It was all over.

**BUDD:** All over your whole body?

**CALVIN:** Even the bottom of my fingers felt like they'd just exploded. Well she's done it now; (inaudible)...She's leaving now. I'm able to move, I start to feel a little bit better. It still hurts; oh boy does it hurt bad.

**BUDD:** Does it hurt all through your body or is it just in the one place where she injected?

**CALVIN:** All over.

**BUDD:** The whole body?

**CALVIN:** Uh, uh. All over. I'm able to get up now, I'm getting up now and I look at the table but it's not a table, I don't know what it is, it's clear, all the way, but it's not glass. I put my shoe on and I pull up my pants.



at the ceiling, I'm looking at the floor and I'm looking around for a door to get out, I know I came through a door. But I see me in a mirror, but I also see something else in the mirror, I'm not there by myself. I have a real strange feeling that I'm being watched, I'm being watched, that's what I'm feeling, it's more than that.

**BUDD:** Do you think one person's watching or two, or more?

**CALVIN:** No, watch, just watching.

**BUDD:** There's one thing I want you to do when you're getting ready there, Calvin, look around and you might see something similar that looks like writing, some kind of funny writing, you might see something like that or maybe you don't see anything like that, look around and see if you notice anything. On the table or on the wall, or anything, something that looks like kind of funny writing.

**CALVIN:** Ain't writing.

**BUDD:** You don't see anything, okay.

**CALVIN:** No writing.

**BUDD:** Okay. Maybe there's nothing to see then, okay.

**CALVIN:** I see me.

**BUDD:** Okay. You see you. You're getting up there and you get your shoe back on?


**CALVIN:** Uh, uh.

**BUDD:** You get your pants back on and everything. What do you feel like doing now?

**CALVIN:** I'm looking at, I'm looking around, I'm looking

**BUDD:** Just watching?

**CALVIN:** Electricity is bouncing off of the walls (inaudible)...little balls of electricity just bouncing and bouncing. I remember dodging them; I was dodging them there from one side to the other.



**BUDD:** When you look in that mirror do you think you can actually see faces in there?

**CALVIN:** Oh yeah there's faces all in there.

**BUDD:** What do they look like?

**CALVIN:** I don't know but there's faces in there. There's faces all in there. But she's coming back in the room, the door opens and I can leave. She walked in and I

grabbed her. I got her round her skinny - ass little neck and I'm choking her right now and she's fixing to go with me. And I'm beating her head against this mirror and there's some kind of black stuff, yuk, coming out. And then through the door the thing that brought me in and I felt a stinging again.

**BUDD:** Where's that black stuff coming from, look at the face?

**CALVIN:** She's got ears; it's coming out of her ears.

**BUDD:** She's got big ears, little ears?

**CALVIN:** Oh, she's got ears like, like us guys, (inaudible) ....bigger, she's skinny, a skinny little thing.

**BUDD:** What color hair does she have?

**CALVIN:** Her hair was bluish-green, but the lights were bluish-green.

**BUDD:** Right, so it's hard to tell?

**CALVIN:** Right.

**BUDD:** Was her hair loose and curly?

**CALVIN:** Yeah, yeah, loose and curly, a lot less of it though.

This is just a sample from the entire transcript that is published in full for the first time in Calvin's book. Whether you feel that regressive hypnosis is a useful tool when investigating such encounters or you are of the opinion that it should not be used at all, you can't fail to see how it can affect the subject, in this instance Calvin Parker.



Without breaking free of the box, it is impossible for anyone to come to an accurate understanding of either the civilizations we have determined to study, or the situation humanity currently finds itself in.

Does the idea of time travel prove difficult for the average person to accept? Yes, most of the time it does. I am the first to admit that it may have been more than I was willing to accept myself, had I not experienced it first hand. When I make the statement that time travel is not only possible but is being utilized on a regular basis by both alien races and our own black ops military groups, I do so from a position of knowledge, not speculation.

The aspect of time travel I would like to discuss in this chapter is the idea, which comes from multiple inside sources who have chosen to become whistle-blowers,



that certain alien groups have made a habit of traveling back into our past. From there, it is reported, they have manipulated events in a manner which results in changing our history in a way which proves favourable to them. I'm sure we can all agree that if we were in their position, we would not hesitate to do the same thing.





would continue to manipulate events in the past for as long as they felt it was useful or necessary to do so. If it is no longer being done, it is almost certainly because they feel they have already achieved all they can. If that is not the case—if they still feel there are advantages to be gained for the military by tweaking the past—then, in my opinion, we should operate under the presumption that they are still at it. Careful consideration of the ideas contained within this chapter should result in a new appreciation of the possibilities and potentials which are inherent to possessing the ability to travel through time. Those who control the past also control the present, and those who control the present control the future.

When world events and power structures are viewed from this perspective, we can see even more clearly the extent to which the entire human race has been made into pawns, forced to participate in a game they are not even aware of. We live out the course of our lives, never suspecting a thing, even as we are pushed around the board by the unseen hands of invisible masters who are not in the least concerned with our best interests or welfare.

This is the state of the world today, brothers and sisters, and perhaps it has always been so. I see no compelling reason to believe otherwise. When the full extent of the power wielded by these shadowy figures and alien intruders is considered, it is difficult to find any scenario which makes me feel comfortable.

We are encouraged to believe in self-determination. We are taught to think that the ability to shape the future lies within our hands. If I could avoid spreading such news without placing others in danger, I would certainly do so.

It is an unfortunate fact, however, that those who misunderstand the nature and scope of the dangers we face are little more than helpless, stationary targets

who can do almost nothing to save themselves. I understand clearly that few of those people will ever actually read this manuscript, and that most of those who do will fail to heed the call to action it contains. That is beyond my ability to change—it is the way of the world, unfortunately.

For the few who will read these words and choose to do all within their power to help save what is left of our society and our world, I have dedicated not only this series of books but my life. It is far beyond my power to predict what shape the future will take, or to affect it in any significant way...but let it never be said that I stood silently by and did nothing while my people were in danger. Circumstances have dictated that I deliver these warnings and sound the alarm. What others may decide to do with this information is out of my hands. I can only do my best and hope you will choose wisely.
