The Parallel World: Stepping Outside of Time

We refer to the visitors in our skies as extraterrestrials because it is easier for humans of the 20th and 21st Centuries to envision ETs traversing the unfathomable distances of interstellar space than it is to tackle the concept of parallel worlds in which other humans live.

There might be a variety of parallel worlds but one world we can be certain exists is our own future, that's unless we exterminate ourselves. The future is a parallel world to our world because time is not consecutive as we perceive, it is concurrent moments.

All time happens – Now.

What level of technology will our great, great, great grandchildren have? What will they have discovered scientifically? Will they still be organic humans like us or will they be artificial intelligence? The answers depend on how far we gaze into the future, perhaps.

Humans are all over the surface of Mother Earth in every layer of time which is laid down. The prehistoric time-layer is still right here, in the same exact spot as we now live. To the cave men, it is the Eternal Now, just as it is for us today. We never are in the past, we never are in the future, and we only are in "the now." So, the Eternal Now is a crowded place!

The next layer which is laid down upon this infinite mo-

ment in time, is the layer of "ancient times" as human-kind begins to expand and invent; survival and curiosity drive us onward in that Eternal Now, the same as they do today.

Layer upon layer is laid upon the same spot: Planet Earth, and by the same race of beings: Homo sapiens.


What if, with advanced (most likely) quantum technology, humans in the future find a way to drill through those

layers of time, never needing to travel the vast distances of space, and always with inherent passion and "ownership" of their Mother Earth. It is more than an interest; future humans feel they have the right to Earth too. Visualize this one spot - Planet Earth - with all her layers of human civilization, all layered on top of each other. Space does not separate us, only the small matter of time.

Then one day, we advance science and technology enough to transport through to those other layers. "Time is

simultaneous" and "All time happens at once" becomes absolute truth, not just the ranting of a genius named Einstein.

Perhaps it is not ancient aliens who helped build ancient civilizations, but it is instead, ourselves? Have humans



from what we perceive as the future, done this every "time" before? Have we seeded ourselves, perhaps endlessly, throughout time? This becomes a chicken/egg question since we need to start this nearly infinite cycle at some point.

And so perhaps there were original cave people many cycles ago and no visitors from the future; but then, the cycle became self-perpetuating after the original generation of cave people.

Is our species "the snake eating its tail" as in the symbol of infinity and wholeness, Ouroboros?

If this idea is correct, then the question of "Who were the ancient astronauts?" is answered. It was us. It is us. It will be us. It seems ancient astronauts guided early humans to make incredibly advanced structures but only out of the available materials, which were mostly enormous stones. We might guess that there are therefore guidelines and rules which dictate non-interference.

We must realize that if a species advances enough to reach through time, they have essentially made "time" non-existent for themselves. Their parallel world is free of the chains of time; if they can travel to our Eternal Now, they can also travel to the cave people's Eternal Now. They have made huge strides in understanding and manipulating gravity and light as well as time.

Possibly these "parallel future humans" do not interact with us by stepping into a time machine. They may reach through layers of time using the universe's natural forces.

There is a theory that extraterrestrials don't have to travel thousands of light years but instead upload themselves into quantum computer informational particles and send themselves superluminally to Earth. They would be traveling above the speed of light as information.

But what if it's not ETs visiting us but our human descendants?

They would likely not use superluminal travel because they are already here on Earth; they are not thousands of light years away. However, there may be other methods of using what the universe provides to upload travelers into an information form to get them through the barrier between the parallel worlds. Then once here, they might manifest into physical form. This possibility has been put forth by a leading astrophysicist, Dr. Rudy Schield.

Remember that "information" and "consciousness" seem to be interchangeable. Quantum physicists refer to the universe as being composed of "information,"

whereas ufologists and metaphysicians think in terms of "consciousness."

What would this "other method" of arriving into this layer of time, be? Possibly it would involve electromagnetic energy, possibly gravity, possibly a combination of those – or some other components) of the universe. And, quantum computers now in their 5th generation, are opening unimagined knowledge and potential.

So, the difference between "information" and "consciousness depends on your point of view because they seem to be the same phenomenon. Most of us agree that the aliens have something to do with consciousness and that they can affect our consciousness. But scientifically, do the aliens reach us as information and we accordingly perceive this information?

But again, what if we replace "aliens" with "parallel humans" who are from the future, in our perception. However, we are dominated by time, so our perception is not accurate. In fact, these beings are outside of time.

In researching the possibility of time travel, two problems are presented:



Problem #1: Humans are a long way from being advanced enough to develop time travel. It might involve creating worm holes or some quantum manipulation. After all, today we are still debating the basics of quantum mechanics.

Problem Solved: There will come a day when humans are advanced enough to traverse time. Just because we view the impossibility of time travel today, does not mean our descendants will still be at our lowly level of science and technology. Perhaps in one hundred or one million years, beings who had their roots as Homo sapiens, will travel to any moment in time they wish; they might show up right

at our Moment, our Now!

It might be a matter of sending one's mind into time rather than the physical body, or it might mean physically boarding a silver star ship and creating a wormhole to send either physical beings or simply, to send information/consciousness. Whatever the specifics, our artificially enhanced intelligence should open the time travel doors – doors to a parallel world!

Problem #2: If traveling time, backward or forward, means opening a wormhole to a parallel world, and holding it open in order to get back, then humans might not be able to stand the radiation, g-forces, and other hardships. So those UFO occupants just cannot be Future Humans, so says the argument.

Problem Solved: Artificial intelligence will make us near-

ly invulnerable and immortal and yet I believe we will have the option of remaining human at the core, at least for a few thousand years. Perhaps artificial intelligence is the course human evolution will take or must take. At any rate, we will be durable enough to withstand the hardships of dimensional travel, if there is literal travel involved. Remember, time travel may not be involved since all generations of human beings are already right on top of each other in the same eternal Moment! It may be a matter of time manipulation.

There is a lot of evidence that some UFO occupants are from (what we call) our future. For one thing, UFO occupants are obviously very interested in Earth and may well have been here for thousands of years. They have certainly been here since 1947, mostly observing, turning off and on a few nuclear missile codes, capturing humans in a "catch and release" program, taking human tissue samples, and taking environmental samples. Certainly our future as a species will be better if there is no global nuclear war. No wonder they warn us about nukes! It is their world too.

They have never attacked us, one army to another. Perhaps they are not exploring our skies as much as they are patrolling our skies.

What alien species would continue to hang around Earth? If true extraterrestrials managed to find tiny Earth out in the mind-bogglingly enormous galaxy, would they stay year after year? Wouldn't ET explorers move on after they had examined us and our world? Yet, UFOs and their occupants just seem to remain here. Consider the UFO activity over and in Ontario's lakes: it has gone on for decades at about the same pace. Do future humans have bases on their own planet? That is likely.

Many questions are answered if we consider that "our aliens" are future humans. Why would true ETs want our tissue samples? Chances are next to zero that an alien race could benefit from our DNA but future humans might. If they possess artificial intelligence but are still somehow human, they might need fresh basic DNA. Perhaps there was a nuclear holocaust which changed them into those emaciated white/grey aliens we have seen. Or perhaps artificial intelligence is the norm but organic human DNA is still valued.

Our parallel Others have dealt with the "I shouldn't meet my grandfather" questions, have found some of these questions are silly, and they have apparently planned it so that the valid paradoxes and problems are "handled adequately."





The Pascagoula abduction event is a joint story involving a young Calvin Parker along with Charles Hickson, both men were co-workers and friends. On the evening of 11 October 1973, an event occurred that would change their lives.

That evening both Calvin Parker (then aged 19) and Charles Hickson (then aged 42) had been fishing off a pier on the west bank of the Pascagoula River, in Mississippi, USA, when they heard a whirring/whizzing sound, saw two flashing blue lights and an oval shaped object 30–40 feet across and 8–10 feet high. Parker and Hickson claimed that they were "conscious but paralyzed" while three "creatures" took them aboard the object and subjected them to an examination before releasing them.

Within days their story had become international news, reporters from all four corners of the United States and beyond descended upon this small quiet southern town.

Such was the interest that APRO's (Aerial Phenomena Research Organisation), James Harder and perhaps the man who would become a believer in the existence of UFOs, Dr. J. Allen Hynek, former chief scientific investigator of the US Government's Project Blue Book all spent time investigating the event.

Along with those that, shall we say, believed in the existence of such events came the sceptics, such as


aviation expert Philip J. Klass who claimed he had found discrepancies in Hickson's story.


When Hickson took a polygraph exam, the examiner determined that Hickson believed the abduction story, but Klass argued that the test was administered by an "inexperienced" operator and that Hickson refused to take another by a more experienced police operator.

But then again why should he to satisfy Klass' sceptical view of not only this case, but of all UFO reports?




Klass concluded the case was a hoax based on these and other discrepancies. Sceptical investigator Joe Nickell wrote that Hickson's behaviour was "questionable" and that he altered or embellished his story when later appearing on television shows.

Nickell speculated that Hickson may have fantasised the encounter with aliens during a hypnagogic "waking dream state", adding that Parker's corroboration of the tale was likely due to suggestibility since he told police he had "passed out at the beginning of the incident and failed to regain consciousness until it was over" Hickson's story was

featured in the 1983 publication: "UFO Encounter at Pascagoula", written by Charles Hickson and William Mendez.

Now, at long last Calvin Parker tells his own encounter story in this recent publication from Flying Disk Press.

Why does he feel the need to do so?

As Derrel Sims, points out on the rear of the new publication 'Pascagoula-The Closest Encounter My Story by -Calvin Parker', both men returned from the experience with a different perspective.

Charles Hickson returned as a so called 'Contactee' while Calvin Parker returned as an

'Abductee'. Clearly the two principles experienced different outcomes. Although Calvin's experience was briefly discussed in Hickson and Mendez's 1983 book, he has never gone deeply in to his own story in a printed, publication from himself, until now. Calvin Parker tells us he decided to tell his story after his wife and long-term partner Waynett encouraged him to do so. "You owe it to those who have supported you", she said on at least one occasion, thankfully Calvin took this onboard.

We relive the encounter in Calvin's own words, his initial capture is described. He was floated on to the craft and seemed to be separated from Charles Hickson and is taken in to what he describes as a room on board the unknown device. Which he describes as 'football shaped, fairly long and about eight feet high'. The room being almost immediately to the left as he boarded, he explains the room was 'very bright' he believes he was laid on a table, but he didn't actually see one as he was unable to turn his head, because he was paralysed when abducted on the river bank.

Calvin describes a series of events that involved some form of inspection/examination, that seemed to be over before it had really begun, but he initially thought he had been inside the craft for about an hour. He was taken from the room and placed back in almost the exact same spot he was taken from. Unable to move his arms but facing the opposite direction to his initial view point.

When he began to recover his senses he heard Charles Hickson calling his name asking if he was OK? Then hearing a noise he describes as similar to a "zipping noise", like the sound of a "strong wind blowing". The noise was really quite loud, and as he looked the craft went straight up and disappeared from sight. Both Calvin and Charles Hickson, agreed they would not tell anyone about the experience as it was too personal, and in fact no one else needed to know.

After a while they got back in to the car and tried to start it, even though it was new, they had prob-

lems. After several attempts the engine fired up. Prior to this occasion the car had always started first time. Even though it sounded rough, the engine worked. Eventually on the way back home they rang a local air force base which advised them to contact the local police as they no longer taken reports because Project Blue Book had closed four years earlier.

The local sheriff interviewed both Charles Hickson and Calvin Parker over a period of hours. They separated the two witnesses. Then placed them in another room together and left (unbeknown to both the witnesses) a tape recorder working to capture any conversation they could use to discredit them both and more than likely use against both victims.

The greatest proponent of the validity of the UFO phenomena Dr. J. Allen Hynek was on the scene of the unusual encounter within thirty-six hours. He made his beliefs known late in 1973, he endorsed the alien abduction claims of the two Pascagoula, Mississippi, shipyard workers, saying the men had "a very real experience" (Los Angeles Times 1973).

Yet, despite of Hynek's involvement in the initial investigation and the Mendez and Hickson book published in the early nineteen eighties, little is known by many modern ufologists, about this case. The Flying Disk Press publication of the Calvin Parker story is a step in putting this lack of knowledge to bed. This case deserves to stand in the same bracket as the Betty and Barney Hill encounter, the Travis Walton case and most definitely in the top three abductions related events.

Well done all concerned.

A NEW WITNESSES?

Just when you think you know all these is to know about a certain UFO sighting or a close encounter experience, life has a way of throwing you a curve ball and something else either drops through your letter box, or email in-box, or more often these days via social media. Such a thing happened to me just over four weeks after I had published the book 'PASCAGOULA – THE CLOSEST ENCOUNTER' by Calvin Parker.

The Pascagoula case is known as one of the classic close encounter cases in the entire history of UFO research. However, for those who don't know the details of it I'll provide a short synopsis of it here,

Pascagoula, Mississippi, October 11th 1973.

On October 11th, 1973 nineteen year old Calvin Parker and his friend forty two year old Charles Hickson were spending a frustrating evening fishing on the Pascagoula River in Mississippi. Both men loved to fish but tonight's fishing trip would turn out to be one they would never forget.

In the early evening both men were startled when a strange craft that descended and hovered a few feet above the ground and just a few yards from their location. Before they had any chance to run an opening appeared in this craft and out 'floated' three humanoid creatures. Both men were absolutely terrified when these creatures grabbed them and took them aboard the craft.

On the craft both men were subjected to an examination and at one point they were so terrified as they believed they were about to die. Minutes later both Calvin Parker and Charles Hickson were deposited back on the riverbank and the craft departed.

Taking off in their car the two terrified witnesses eventually located a public telephone box and phoned the local sheriff. A short time later they were being interviewed at their local sheriff's office. The two disorien-

tated witnesses told the story of their close encounter and abduction by these strange creatures.

The next day all hell was let loose as the press descended on this unsuspecting Mississippi town. Calvin Parker, seriously disturbed by these events, has largely remained in the background without ever detailing the full account of what happened that night, how it affected him and his life, and other close encounters he has experienced down the years.

Charles Hickson went on to speak about the event in public for many years and passed away in 2011.

A new witness to the UFO at Pascagoula

On August 20th I was contacted on Facebook by a chap called Stefanos Panagiotakis from Greece. Stefanos went on to tell me that he was fascinated by the Pascagoula case and more than that, he had travelled to Pascagoula in July 1981 and interviewed Charles Hickson and a number of others that were involved. Calvin Parker was not around at the time so he was unable to interview him.

Stefanos went on to inform me that during this trip he had interviewed a Greek pastor who had also witnessed the same UFO as Parker and Hickson on the same evening and was accompanied by two others at the time.

Stefanos had published everything about his trip and agreed to translate his brief interview with this Greek pastor whose name was Emmanuel P. Sigalas.

From 1975 till 1982 Stefanos was member of a Greek UFO society named SIRIUS and later PHAETHON where he would send the results of his UFO investigations and details of his own UFO sightings that happened to him while at sea (not many but very interesting cases), plus his visits to ancient areas like the Nazca lines in Peru, Machu Pichu, Zempoalla in Mexico etc.

Here is the transcript of the interview with Mr. Sigalas by Stefanos (STEPHEN):

The interview with Emmanuel P. Sigalas on July 17th, 1981 at 18 hrs local time.

I arrived at (address on file) which is where Mr. Sigalas lived. I knocked the door but no one answered. I went around the garden and found an elderly man in a green uniform, gardening.

"Excuse me sir, do you know Mr. Emmanuel Sigalas?" I asked him...He replied " I'm this man, son. Who are you?" I told him who I was and what I wanted from him..." Hello sir, I'm Stefanos (Stephen) Panagiotakis, from Athens, Greece and I came here on a cargo ship, where I'm working as a Radio Officer but also I'm a UFO researcher and investigator for a group named SIRI-US and a reporter for the Greek UFO magazine ASTRAL CONTACT.

Arriving here was a great chance to do my job as an investigator for an incident which happened here on October of 1973 and it is famous worldwide. Mr. Don Broadus, of the "Mississippi Press" told me that his late cousin Raymond and you, were both witnesses in that case and that's why I came to see you and to ask you a few questions about it"...

He was very surprised but smiled and told me, "Welcome to my home son, please come in...Are you hungry? What can I offer you? I want you to feel like you are at home...You know, I was born in America but my parents were from the Greek island of Kephallonia..."

He explained to me that he had been living in Pascagoula for many years with the widow of his brother Gregory and his grandson Andrew.

Here's is our full conversation as transferred from my tape recorder in every detail...

STEPHEN: First of all I want to thank you very much for the warm welcome you have given me, it really touched me deep inside, reminds me of the famous Greek hospitality. Mr. Don Broadus told me that the day when an alien craft landed near to the Pascagoula shipyard and abducted two local fishermen, Mr. Hickson and Mr. Parker; you were going with his cousin.... (He interrupts me at this point).

SIGALAS: Yes, Raymond, who passed away last month. He was a police officer with special duties such as a court adviser and guarantor for good behaviour of people who were about to be released from the jail. He was a good man and many times he was preaching in my church. We

were "Brothers in Christ" as they use to say.

On that particular day in 1973, October 11th as I remember, we drove to a place where Raymond used to visit every Thursday for preaching to people who cannot control their habit for too much alcohol. So we were on our way there having with us a young girl. I don't remember her name right now. Anyway, as we travelled in my car, I noticed on my left hand side a cylindrical object that seemed to be following us. I didn't pay much attention but the girl asked me "Mr. Sigalas I see something up there in the sky." I told her that it might be a helicopter which goes to Keesler Air force Base. A base where many people are coming from all over the world for training.

Then I asked my friend.. "Hey Ray, what this thing might be? It doesn't look like helicopter cause how come such a type of craft does not to have any lights and was acting like this?"

As we kept driving the object following us was at an altitude of about 3000 feet. By reducing our speed, the object did the same thing and then by increasing our speed then the object sped up as well. We kept doing this for about 10 miles. After a while as we turned towards Vancleave the object stopped, then approached us a little and then disappeared. I watched something very strange on the object. It was an extension, a fringe, pointing out in the direction of about 2- O'clock from the main body.

Also I must say that the object was covered by a bright, very bright light and I say again that it was a cylindrical shape. I tried to understand what exactly it was but all in vain. Joan (the female passenger in the car), now I remember her name, who was married to a priest, told me, "Mr. Sigalas, I think I saw God." And I replied to her "be sure of that.

Who in this world can make such a thing?" And now I recall that during our trip she was praying all the time. After a while I told her, "Joan you have great faith to the Lord and you must understand fully these things" and she said "yes but I'm afraid, very much afraid". "Me too" I said to help calm her down somewhat .

I must tell you that we were heading north and the object was on our west side.

STEPHEN: Mr. Broadus showed me yesterday the exact point where you saw the object and I took some photos of the area. He also told me that you saw the object was on flight path from where you were towards the ship-

yard and the fishing point of the two men, Hickson and Parker.

SIGALAS: I didn't know what was its destination at that time but I'm sure it was west of us.

STEPHEN: How did it disappear? Suddenly or...

SIGALAS: In a fraction of a second! Very fast. I've never seen anything like it in my life before, a vehicle disappearing like this.

At that moment I said "Lord what is this?" and I saw it change its course and was heading to the area where the fishermen Mr. Hickson and Mr. Parker, as they told us later. When we returned and passed from the same point we didn't see anything.

The next day I called Mr. Broadus and he told me "Emmanuel you must say the truth of what you saw, do not deny it please." I told him "Ray, I will say whatever we saw and that's the crystal clear truth as you know it." Finally there was a man from Michigan named Hay...Hayneken..something like this.

STEPHEN: Hynek, Allen Hynek.

SIGALAS: Yeah, right. He called me and asked me to meet him and give him some details about what I've seen. I told him that it was not possible to meet him but I was open to reply to everything on the phone. He agreed and I told him all these things which I've told you now.

STEPHEN: And I think they are enough for the particular incident.

SIGALAS: Did Mr. Broadus show you the exact point?

STEPHEN: Yes. Now tell me something else. You know very well the story of the two fishermen of Pascagoula. They were two simple, common men who never had any interest in UFO stories and suddenly they came face to face with creatures from another world. Do you believe their story? I want your opinion.

SIGALAS: Well, it is very hard for someone to be positive in cases like this, but I will try to be honest. I heard that one of them had a drink but the other had not. Mr. Broadus and Joan who were with me make a strong witness for what we saw. They say that sometimes you can see very strange things. I don't care. Our common experience is not doubted.

STEPHEN: I know that one of them had a drink just to calm himself down. Sheriff Diamond who questioned Hickson said that he could smell alcohol but the man's mind was very clear and he wasn't drunk.

SIGALAS: All these are objective but the Sheriff was a trustworthy person in his life and everybody trusted him completely. The creatures never harmed 'em.

STEPHEN: So, what is your conclusion? Did they have a

vision of some kind or did they have a real experience?

SIGALAS: Well, I'll speak to you honestly. If I haven't seen that day this craft in the sky I'd never pay any attention to them and their story. But it was a fact what we saw this strange object while driving in our car and of course they saw the same thing a little later in right in front of their eyes.

STEPHEN: But there are others who saw the same object at that time.

SIGALAS: I know Mr. Booth, Mr. Green and others. That's why I say this is a real story. Everybody with their experiences enlightened the story so the story of Hickson and Parker can not be denied. What was that craft and who were these creatures, remains unknown, Stephen my son.

These are the facts and I do not deny anything cause I was a part of this fascinating story.

STEPHEN: Did you feel any special feeling Mr. Sigalas as you were watching that craft in the sky or later in the evening?

SIGALAS: In the Bible it tells us of the existence of one God and at that moment I was certified by Him.

STEPHEN: Do you mean that it was a sign from God?

SIGALAS: Do you remember in Bible what the prophets said? "Lord, give us a sign of your existence". Of course that was not a sign but a harbinger; I cannot find another word for this to explain it to you. It was something basic but the sign we shall all see one day.

STEPHEN: My opinion Mr. Sigalas is that all these appearances on our planet are not signs of God. We have to deal with people from other, more advanced civilizations but we are not such primitives as our ancestors to consider them as gods.

SIGALAS: I want to tell you this. You're absolutely right about our space brothers but they are also created by God and when He wants to tell us - look, not to force them, but they will be revealed to us formally and this would be the absolute proof of the common Father Creator of all .

STEPHEN: But what about the many different religions on Earth? There will be a great commotion, what do you say?

SIGALAS: Not at all. I consider love and peace of the most importance...

We Greeks have the most appropriate word for this...PHILADELPHIA (ΦΙΛΑΔΕΛΦΕΙΑ) (Ed: Love of ones brothers) .

When there is this one the rest are details and I'll explain it. Since the end of WW2 starts the spiritual advance of the human race. You have seen where we have

reached already and it's only the beginning. Everyone will find their way as long as the spirit uprising continues more and more every day. Only one thing is not forgiven to the Man....Atheism.

STEPHEN: Thank you very much for the interview Mr. Sigalas.

I have to thank Stefanos for taking the time to sit down and translate his interview from Greek into English. In Calvin Parker's book there are several accounts of other sightings just before and on the night of the close encounter, October 11th, 1973. It would therefore seem reasonable to add this one to that list as well. It does also make you wonder if 'Joan' the female passenger in the car might still be alive? Could there also be other witnesses that have never come forward? Again, who knows, but it is not beyond a possibility.

Another Mississippi UFO sighting in October 1973

At around the same time as Stefanos contacted me on Facebook I had another exchange with someone else who had a sighting in Mississippi around the same time as the Parker and Hickson close encounter. Here it is in full:

Dale Lois Ulmer:

My parents and I were returning home for my aunt and uncles around 2:00 a.m. I'm pretty sure it was in October 1973. They lived in Pass Christian, Mississippi, and we lived in Long Beach, Mississippi, cities that are next to each other. We had gone over there to eat chicken gumbo and my dad fell asleep in the living room chair. It took mom several times to wake him which is why we were so late going home. We were traveling east on Pineville Road, when all of a sudden a bluish/white light illuminated all around my dad's car, even to the ditches where there were open fields to either side of us. I remember the car being stopped. I was sitting in the middle of the back seat so I could watch dad's driving because his eyesight wasn't that good. Mom was in front on the passenger side.

I remember mom saying "What's that"? At some point my dad exited the car and I think he walked in front of the car toward the field to our right. I believe there were fences near the ditch along both fields. The next thing I remember is he got back in the car and said "It's not coming from out there".

I don't recall when the light left us and the next thing I remember is that we rode the rest of the way home mostly in silence. Something just didn't feel right. When we arrived home I recall looking at the clock on the dining table, but don't remember what time it was.

The next morning my mom and I were sitting at the dining table drinking hot tea and she said "I wonder what that was; it seemed to come from above and behind us.

I was afraid to turn around." My dad was very intelligent, had a photographic memory, yet even he was at a loss for words. He was the type of person to go in specific details about something. I believe we all felt it was 'taboo' to talk about what happened, even though there seemed to be not much to tell.

Not long afterward, the Pascagoula, Mississippi UFO event was aired on WLOX-TV and my mom said: "I wonder if that was the same thing we saw"? Well, I thought what she said was a little odd because all we remember seeing was the bluish / white light, although her words may have come from her subconscious, meaning that perhaps there was more to what we recalled, but hadn't manifested into an actual memory yet.

October 2018 will mark my 45 year journey in seeking answers and truth. 1973 was only the beginning of seeing something unusual in the night sky and I had one daytime, stationary UFO directly above my driveway. That's pretty much my story in a nutshell. A curious yet fascinating sighting by Dale. There are hints here that perhaps something more than just a UFO sighting happened. It was interesting to hear Dale talk about 'bluish/white' light. It was a blue light that Hickson and Parker first saw before the UFO. Could there be a connection here?

It is difficult to say but I think it is fair to add Dale's sighting into what seems to be a much larger event than first suspected and that maybe Calvin Parker and Charles Hickson's close encounter was the culmination of a series of UFO events in and around the Pascagoula area. Just for the record I thought it would be interesting to run the above past Calvin Parker. This is what he had to say:

"Over the years there have been quite a few credible witnesses that have come forward. Some would not go on record for fear of being ridiculed. I think this book is bringing more witnesses out of the woodwork. Like I have said many times, if this case went into a court of law there is enough evidence in this book to support the case and more witnesses like the two above can only help. As the publicity for the book progresses I really think there is going to be more witnesses come forward. We shall have to wait and see."



I have been involved in UFO research and investigation for almost 40 years and I began organising UFO conferences back in the early 1980's at the Yorkshire UFO Society with Graham and Mark Birdsall. Down the years I have helped organise UFO conferences for the Independent UFO Network, the British UFO Research Association and UFO DATA MAGAZINE with Russel Callaghan. Some of the conferences that I organised for BUFORA were the largest of their type in the UK. So, with all of my experience in organising such events I think I am ideally placed to review a UFO conference.

On September 1st, 2018 I travelled to Hull to attend the UFO conference staged by Chris Evers and Outer Limits Magazine. Some have said that Hull is not the easiest place to get to but for me it was not a problem. I live just a one hour drive away down the M62 motorway. It doesn't matter where you stage such an event as it will always be awkward to get there

for someone. The location, The Freedom Centre, has ample parking and good sized conference room with an on-site cafeteria.

The event started pretty much bang on time at 10.30 am on Saturday morning and first to take to the stage was the conference organiser, and editor and publisher of Outer Limits magazine Chris Evers. After the opening pleasantries Chris outlined exactly what his magazine was all about, how to subscribe and how to submit an article as well. Chris followed this by his own personal top ten UFO events over the last 12 months. Top of his list was the revelations that were published at the end of 2018 in the New York Times, detailing the US Department of Defense' secret UFO study. I had to agree with Chris that I would have picked that as my number one as well. A short presentation by Chris that was a good opener and set the scene for the rest of the day.

Next up on the stage was Paul Sinclair. Paul readily admitted that he was old school when it came to UFO investigation and that he preferred to be out in

the field rather than sat behind his computer.

Paul is a local man living on the East Coast of Yorkshire and a lot of his research and investigation had centred around Bempton which is not far from the seaside town of Bridlington. The areas in and around Bempton have been the location for the manifesta-

tion of 'strange light forms' and not just on land but out to seas as well. The area of Paul's investigations has literally been haunted by a whole host of UFO sightings, paranormal phenomena and bizarre animal mutilations. Paul was able to back up his research with photographs, film and official Coastguard and RNLI documentation detailing many strange lights seen out at sea.

What also came across in this presentation was Paul's dedication and passion for what he was doing. His presentation was a credit to ufology, himself and the conference for inviting him to speak. A top class and fascinating presentation all round.

After each speaker there was a short interval and up next was former CID Police Detective and author and

publisher of the terrific Haunted Skies series of books, John Hanson.

John, aided by his friend and colleague David Young, highlighted some of the staggering amount of UFO information that he has obtained, collected and saved from ending up in the skip. This archive of UFO material is unique to the UK. Some of what John has in his archive has been published in his Haunted Skies books but there is a huge amount in his archives that has yet to be published. John kindly brought some folders with him to give the audience a glimpse of what his archive contains. From a UFO research point of view John's archives are a goldmine of information and he is doing a terrific job in trying to make his archive available for UFO research. Again, like Paul Sinclair, John's passion and dedication shone through his presentation and I know that when I donated items to John's archive that it was the right thing to do and my small donation is in safe hands.

In between the scheduled speakers Chris Evers brought UFO witness Darren Cooper onto the stage. Chris, in his ever cool and calm manner, had a brief 'interview' with Darren. Darren related his own encounter of a huge triangle-shaped UFO in the night sky. Darren had travelled that day all the way from Southampton. This was a fascinating if short interview with Darren Cooper who recounted his encounter in some detail and not without a good dose of emotion as well. Well

Next up was a lady all the way from Australia, Mary Rodwell. Mary is an ex-pat and has lived down under for quite some time now. Mary Rodwell is Founder and Principal of the Australian Close Encounter Resource Network. (ACERN) and Co-founder and Direc-

tor of The Dr Edgar Mitchell Foundation for Research into Extra-terrestrial Encounters (FREE). Mary's presentation was one that was as professional as anyone could wish for. It was a presentation full of passion, compassion, information, film, photos, interviews, it simply had the lot. Mary's presentation was a real barn-stormer. It had everything. It is difficult to detail the content of her presentation as there was simply so much to take on board but her new book 'The New Human – Awakening Our Cosmic Heritage' just about sums it all up: "Families, children and adults share their stories of encounters with non-human intelligences and their understanding of a intimate connection genetically. Are non human intelligences assisting humanity to evolve into a new aware specie? Exponential increase in indi-

tails he provided as he and his party on USAF air-men/police stood at the edge of the forest and were witness to a large, glowing object, orange/red in colour, that was located in a farmer's field. The intensity of this object reflected in the glass of the farmhouse behind it making the house almost look as it was on fire. The Colonel's presentation was brought into the conference hall by John Hanson and David Young accompanied by a bagpipe player. An unusual touch I must add, but one that brought a smile to everyone's face. Music is not uncommon at a UFO conference as I remember one that I appeared at in Falkirk with Malcolm Robinson. We were fortunate to have the Scottish rock band CEIV play in the interval.

Last but not least was USAF Colonel Charles Halt (retired). Exoplanet

May Hold Water?

It has been suggested that a nearby exoplanet within the habitable zone of the star it is orbiting, just 4.2 light years away from Earth, could be home to a vast ocean, boosting its chances of hosting life.

Since its discovery, Proxima-B which orbits the nearby Red Dwarf star, Proxima Centauri, questions about it have been swirling. The planet's mass is about 1.3 times that of Earth and the Red Dwarf star it circles is a similar age to that of our own sun.

Studies though over recent years have both boosted and shot down the belief in its habitability. Now though, a new study as once again boosted the possibility that Proxima B could support life and under the right conditions could support liquid water.

'The major message from our simulations is that there's a decent chance the planet would be habitable,' Anthony Del Genio, a planetary scientist at the NASA Goddard Institute for Space Studies recently explained.

In the study which was recently published in the *Journal of Astrobiology*, the researchers ran what are said to be the first climate simulations of Proxima B with a dynamic ocean. Proxima B.

The planet is thought to be tidally locked with its star Proxima Centauri, meaning it would have a permanent daylight side and night time side. Meaning liquid

water in the permanent darkness would more than likely be frozen, while this would more than likely not be the case on the continuous daylight side.

'Climate models with static oceans suggest that Proxima B could harbour a small dayside surface ocean despite its weak insolation', the researchers say in the new study.

With a dynamic (moving) ocean considered for the first time, the extent of this liquid water becomes much more significant, in some cases dipping in to parts of the nightside.

The simulations showed that 'with a dynamic ocean, a hypothetical ocean-covered Proxima Centauri B with an atmosphere similar to that of modern Earth's can have an habitable climate with a broad region of open-ocean, extending to the night side at low latitudes.

In more than a dozen simulations, the team found that the exoplanet almost always had a liquid ocean of some sort...

If you would like to see the oceans then you may have a long wait, do not cancel your trip to Spain next year, if you fancy taking a dip in the water... which in Proxima B's case may be very saline...

Cattle Mutilations in The Land of Oz

While strange and unexplained deaths to Sheep, Deer and even Porpoise have occurred on the East Coast of the United Kingdom over recent months it seems that Britain is not alone, as the following series of reports from Australia explain.

Dead cows found in paddock with udders, ears and tongues removed

A north Queensland couple has been left baffled by a bizarre finding on their property, which seems like something straight from a horror film.

Graziers Mick and Judy Cook were working on their property in Cloverly, north-west of Mackay, when Mr Cook noticed a dead cow carcass which appeared to have had its body mutilated, with its entire udder, ears and tongue removed.

Warning: This story contains images and content that some readers may find disturbing.

"It was like it had been surgically removed, I certainly couldn't do as neat a job with a very sharp knife, and it definitely wasn't an animal," Mr Cook said. "I thought at first it might have been poisoned, but then I got closer ... I saw the body parts missing, there was no blood, even where the parts had been removed, no sign of struggle, just dead.

"There was just no reason or rhyme for it to be done the way it was done, people don't use those parts, it's just not something you would wish on your worst enemy."

On the same trip, Mr Cook said he travelled down a little further on his property, about an hour's drive from his house on rough terrain, when he found another dead cow.

The second one looked like it had been there for some time.

"When I got down there I noticed another carcass, this one was a bit more deteriorated, looked like it had been rotting there for a bit.



"We don't know how it happened, but we got onto the neighbours just to let them know."

By that point we are probably two hours from your nearest neighbour, it's very mountainous country ... there's no way anyone can get there unless they come straight past our house.

Local veterinarian David Lemmon said in his 40 years working in the industry, often with livestock, he had never heard of or seen anything like it.

"I deal with everything, you know — all creatures great and small. And I can't think of any explanation for it, that's not normal human behaviour is it? That's something quite bizarre and ill, I would say the person that has done that is not mentally stable.

"We're talking eyes, we're talking ears, we're talking udders. No, I've never heard of anything like that ever, that's something or someone very ill who's done that."

In a statement, Queensland Police said it had not been notified about the cow mutilations, however, Mr and Mrs Cook said they had attempted to contact local police unsuccessfully.

NOT THE FIRST SIGHTING

According to Mr Cook, he and his wife came across two dead cows with their udders removed around the same area about ten years prior.

"I didn't think much about it at the time, we didn't really say anything about it," he said.

"We just thought it was a bit strange, let it go and put it

to the back of our minds. "But when we saw it again just recently we decided to tell someone, we came back later and my daughter tried to do some research, she found a YouTube link to other similar stories.

"They basically said other people around the world have been finding similar cases since '75 and starting in Yankeeland, it's even left police confused."

Cases of cow mutilation and murders have been reported around the world for over four decades, with carcasses found, sometimes one or two, sometimes dozens, with body parts such as ears, lips, eyes, noses, anuses and genitalia removed with "surgical precision".

tion into the widespread cow deaths, however, were unable to offer a conclusion stating that their investigation was hindered by a lack of jurisdiction.

While no solution has been confirmed to date, some scientists have also attempted to justify the findings, stating they could simply be ordinary decomposition or even carrion animals.



Speculation surrounding who — or what — might be responsible for the killings and mutilations ranged from satanic worshipers and government agents to aliens.

In the mid 70s the American FBI launched an investiga-

Animals such as vultures, Tasmanian devils and coyotes often eat soft tissue body parts first which could explain why parts of the mouth, tongue, anus and eyes are often the parts found missing on the cows.

Scientists have also explained that when an animal dies, blood will naturally begin to clot and coagulate, creating the appearance that it had disappeared.

They weren't, however, able to offer an explanation for the mass number of cow deaths over the years — for now it remains a mystery.

The next piece may not be a mutilation as we now recognise them but

Row of cows found dead after lightning strike south of Brisbane

A lightning strike was believed to have killed six cows, which were discovered laying dead in a row on a Beaudesert property last week. Grazier Eda Shirley found his cattle lining a fence last Wednesday, following a storm on February 26.

Ms Shirley's son, Derek, said it appeared that they had been killed instantaneously after lightning struck the fence. "They would have been standing in water near the fence and the lightning has just dropped them all at the same time," Mr Shirley said.

Mr Shirley said the stock was worth \$10,000. "It happened on Monday night and we couldn't get out to find them until Wednesday morning," he said. "We definitely could have done without it but I am more worried about the safety issues for people when we have storms like that."

Mr Shirley said all six cows were lost and it raised real concerns about people taking the risk of being outdoors during a thunderstorm.

"They were all killed in an instant, (there were) no survivors in that herd and it could have been any one of us," he said.

Mr Shirley was concerned that while most people were

aware of the general advice about thunderstorms some might feel safe being out in the weather as long as they avoided sheltering under a tree or near a metal fixture. "What if this had happened at a school or a kindy?" he said. Mr Shirley said the incident showed that lightning, while a common feature of storms in the Scenic Rim, could be deadly. Lightning risk expert Grant Kirkby said there had been reports of a similar incident in Norway last year when 223 large reindeer were felled in one go by an indirect lightning strike.

"Given the amount of space you would need to fit 223 reindeer, that's an indication of how big of an area could be electrified by a lightning strike," he said.



Mr Kirkby said people should treat lightning with the same caution they would give a shark in the ocean.

"If you see a shark in the water, you're going to get out and get your kids out very quickly, you don't hang around to think about it," he said.

"At the first sign of thunder or visible lightning the best thing to do is get indoors immediately.

"The majority of lightning injuries are not from direct strikes, most are indirect so the last thing you want to be doing in a thunderstorm is be standing in water."

THE REAL STORY - AN INTERVIEW WITH ITS AUTHOR

I dare say most of you reading this will never have heard of Paul Ascough. There is nothing wrong with that but I can personally vouch for him. I have known Paul for over twenty years and unfortunately we accidentally lost contact with each other for far too long. Earlier in 2016 I was extremely pleased to meet up with him again and even more pleased to discover he was just about to publish his first book. In order to discover who Paul Ascough is and what his book is all about I took time out to interview him recently the result of which is as follows.

PM: Who is Paul Ascough; tell us a bit about yourself?

PA: Born in West Yorkshire to a working class family, I left school with little in the way of qualifications. Finally leaving the Army and joining the Yorkshire Ambulance Service where I have remained as a Paramedic until my retirement.

PA: I have called my book 'The Real Story' because this is the way I perceive our place in the world to be. It is my story of personal experiences with religion, the paranormal and

PM: How and when did you first become interested in the UFO phenomenon?

PA: I first became interested in UFOs at about 11 years old. I was sat in the garden as it became dark, with my brother and my father who was pointing out one of the major constellations to us. When 2 very bright pearly white UFOs came out of a bank of cloud in front of us then just stopped dead. They were completely still for not much more than a second then were immediately moving away from us, no noise, nothing flashing, no vapour trail, just a little teardrop shaped tail as they moved. The brilliant white light from them reflecting on the cloud. The immediate feeling I got was that they hadn't meant to be seen and that's why they stopped and changed direction. It was from that moment that I wanted to know how they could be real, defying the laws of physics and blatantly on show to anyone who would have been looking.

PM: Have you ever had a personal experience or UFO sighting at all?

PA: My first experience was the incident above, quickly followed with my first sighting of LITS on the Warminster trip also narrated in the book. I have seen many LITS since and a few closer encounters which are mentioned in more detail, the latest being as recent as September 2015.

PM: Has being in the military helped you in your research of the UFO phenomenon?

PA: Definitely, because you learn how to be a better and more objective observer, how to use landscapes, the background and the foreground, the weather, the cover, type and height of clouds, the wind as well as other atmospheric phenomenon. Then you learn about the different types of aircraft, the jets, turboprops, propellers and rotors, military, private, cargo and commercial, large and small, fast and slow, there are thousands of them.

PM: Whilst compiling your research for THE REAL STORY did any one UFO sighting or close encounter case stand out to you and why?

PA: Good question, obviously the high strangeness, close encounter abduction case I investigated for BUFORA in 1995 remains a highlight, simply because it was an opportunity to try and help a number of innocent and terrified individuals come to a better understanding and acceptance of what had happened to them.

PM: Do you have anything to say to the sceptics who say ufology is a complete waste of time?

PA: I do have something to say. Not to ridicule or belittle people who have been subjected to an experience of which they have had no control whatsoever. Witnesses and abductees will tell you that it's unequivocal that what they have seen or experienced was so weird or bizarre that it could have been nothing other than alien. Almost without question the abductees will say they wish they could turn back the clock to avoid what they experienced happening at all and that they previously had no interest in the UFO phenomenon. Many of these witnesses have a lot to lose by going public and finally, why would thousands of people have a reason to lie, with nothing to gain. Many Ufologists give up a great deal of time and sacrifice to further our understanding of what is a very subjective and incredibly complex subject.

PM: What is the future in UFO research for you. More books, more research?

PA: Always more research, always more research. Having written this concise history of events in my life, maybe its time to expand on some of the theories, more stories and experiences, with more in depth explanations to help the reader gain a better understanding.

PM: In your opinion, how do we keep moving forward with UFO research?

PA: We can only keep moving forward by continuing research and placing as much evidence as we can into the public domain. There are some exceptional investigators and authors out there who will continue to educate us all. Fortunately modern technology is on our side and as more and more of the population are constantly carrying recording devices, then more and more evidence is slowly accumulating on the internet. This combined with the world governments becoming more open, will I hope, lead to a time in the not too distant future when we should see a general acceptance of the UFO phenomenon by everyone.

PM: Paul, thank you for taking the time to answer my questions and good luck with your new book THE REAL STORY.



val Europe, so completely duplicates what alien abductees have to say about the sexual aspects of close encounters that it is impossible make any meaningful distinction between the two.

There is also a direct link here to the sixth chapter of Genesis, in which angels - or the sons of God - feel compelled to come down from heaven for the purpose of having sex with human females and as a result beget a race of giants who come to be highly regarded on Earth.


The first case of sexual contact in our 'flying saucer' era was experienced by Antonio Villas Boas in South America, and is detailed in a chapter by Nigel Watson author of the 'UFO Investigations Manual.' Boas claimed in 1957 that he was dragged inside a flying saucer and forced to have sexual intercourse with a beautiful alien woman. When he left, she pointed at her stomach, at him and then at the sky, implying she would have his child somewhere in outer space.

In the 1980s alien abduction researchers in the USA accepted that women are routinely abducted, impregnated and then re-abducted a few weeks later for the extraction of the hybrid foetus. These activities explained the short-lived pregnancies experienced by female abductees. As for male abductees, they either claimed to

The book shows that such contacts have gone on since biblical times and Dr. Greg Little, who holds a doctorate in educational psychology provides a fascinating account of demonic bedroom visitors as recorded down through the ages. These were the female succubus and the male incubus, demons who were said to visit human victims of the opposite sex as they lay sleeping for the purpose of taking sexual pleasure as well as for the harvesting of sperm and ova.

This scenario, popularised in the religious lore of medie-

have had intercourse with an alien woman or their sperm was extracted by mechanical means by the aliens.'

In his book 'Communion', Whitley Strieber famously described being abducted by aliens who inserted a 1ft (0.3m)-long anal probe inside him. It seemed to be a living entity, so when it was taken out he was surprised to see it was a mechanical device.'

'Screwed By The Aliens' features a chapter that chronicles the progress of the 'anal probe' meme and how it has turned up in such programmes as the 'South Park' cartoon series. On reflection, Strieber says he regretted going public with his anal probe experience but felt that he owed it to his readership to be honest about it. He believes he is guilty of being 'compulsively honest' as opposed to being a 'compulsive liar.' More recently in a documentary 'Love and Saucers,' New York artist David Huggins confessed that, 'When I was 17 I lost my virginity to a female extra-terrestrial.' For nearly 60 years he has had regular sex with Crescent and she even gave birth to an alien child as an outcome of their otherworldly intercourse.

The notion of alien-induced pregnancy is given thorough coverage by Brad Steiger as well as in the gripping account of Christa Tilton, who reveals to Beckley the details of being used as a surrogate mother by the aliens. Meanwhile, William Kern offers new theories on the use of DNA and other genetics-related elements of alien abduction, focusing on the parallel nature of reptilian reproduction as we know it on Earth. To bring it all home, Kern also shares an interesting encounter of his own with a possible alien female.

Also included in the book is the story of the late Dr Karla Turner who accused the aliens of the literal and physical

sexual violation of their powerless human victims. Turner claimed deception was often used by the aliens to make the abductee a willing sexual partner. The alien might take the form of an abductee's spouse or disguise itself as a celebrity that the abductee was known to find attractive. The perversions involved are also quite disturbing to read about, such as alien paedophilia and their forcing abductees to have bestial sex with animals.




Yet, other abductees say that sex with an alien entity is the most pleasurable they've ever experienced, that the erotic thrills go way beyond what happens with a human partner.

To some ufologists these reports and many other similar cases seem to indicate that the aliens are conducting a hybrid breeding program to create a race of super beings, for what purpose we can only imagine. Sceptics claim these experiences are likely to be the product of sleep paralysis, where people are unable to discern the difference between fantasy and reality during the period between sleeping and waking.

Beckley is open minded about the subject and says:


'As you turn the pages, you will see that we have approached the sexual nature of UFOs, their alien occupants, and the reproduction process of the Ultra-terrestrials with an open mind. It's easy to laugh and guffaw upon reading reports of anal probes and those who claim that they have fathered a rather large family of star children, or who have sex with reptilians just about every Saturday night. We admit to a bit of chuckling from time to time ourselves, but this is potentially a very important aspect of UFO research that for the most part has been neglected because of what some see as its offensive nature.'

My name is Mark Finbow. I'm a writer from East Anglia. Born in Suffolk, now living in Norfolk. I have spent a great deal of my life looking at the skies. Which would explain why I walk into so many things.

Over the years I've had a number of opportunities to take stories from history and represent them on the stage. The one thing these shows always have in common, if I'm writing them, is their genre. No matter what the source material they always seem to, quite naturally, become science fiction shows. Commissions to create shows about Suffolk folklore, old Newmarket Stable lads or the history of a market town have become stories about paranormal investigators, a time travelling Horse and a poltergeist causing havoc down the high street.

My latest project is, to me, the most exciting yet - a theatre show about aliens. Being a trained actor, a lifelong sci-fi fan and growing up down the road from the Rendlesham Forest this was bound to happen one day.

My new script for "In Your Skies" is currently in the research phase and is being supported by Eastern Angles and Arts Council England, amongst several other arts organisations in the region.

This research phase is about delving deeper into the world of ufology than I ever have before - reading many, many books, spending hours online and travelling all over the country to conferences, including this year's Outer Limits Magazine Conference - which was incredibly insightful. A key part of this phase involves speaking directly to ufologists and experiencers of UFO phenomena - of which I am one myself, having seen two black diamonds overhead in the skies of rural Norfolk.

I'm looking to hear from as many people as possible, who have had encounters. I'm seeking emails, videos interviews + written statements that describe in detail UFO experiences. I'm keen to put the genuine voice of

ufology on stage. I feel ufologists are often seen as quirky out of this world characters whose true voice is underrepresented in the mainstream. By bringing true voices from the world of ufology to a piece of artistic, creative, commercial theatre I hope I can do a little to challenge that notion.

In October I am hosting two Flying Saucer Cafes in East Anglia. At these informal discussion groups people can come together to discuss their encounters and their views on UFO phenomena. It is intended that these sessions will inspire me to settle on a series of ideas and themes that will form the basis of my script and the eventual theatre production.

The Cafes take place at Biddy's Tea Room, Norwich on Monday 1st October and Theatre Royal Bury St Edmunds on Tuesday 16th October, both between 7pm - 9.30pm. Biddy's is famous worldwide for its amazing cakes and tea selection and the Theatre is an elegant National Trust property so they should be comfortable and atmospheric evenings. Both events will have representatives from local newspaper column Weird Norfolk and members from the East Anglian UFO group on hand to offer some insight.

The stories collected at the Flying Saucer Cafes will go on to inform some community theatre workshops and then a professional workshop week, which will result in a sharing of the first draft of the script in February.

Paul Sinclair's WALLABYS AND GIANT LEAPS INTO Un-believe

The words high strangeness reached another level writing this next account, so strange that they may even have connections to similar happenings on the other side of the world. I found an interesting article in the archive at Bridlington library from June 2011, I never realised at the time that it would open so many doors of investigation. If the research does connect A to B it suggests to me that the intelligence behind the phenomena cannot be human.

I look at all the cases covered in the Truth Proof books with an open mind, and have at all times been careful not to influence or steer the reader in any one direction. However, the plain truth is these cases are at the highest point of high strangeness. And even though I may not have any answers the evidence in the story you are about to read points in the direction of a true unexplained phenomena being responsible. In the winter of 2014, I found myself sat in front of the microfilm machine in Bridlington's central library. I love looking through old news reports; the year in front of me was 2011 one thing I have learned over the years is to expect the unexpected. The papers allow you to see the bigger picture over months years and sometimes decades.

It is possible to find many things that were impossible to see at the time the events were unfolding. A bit like looking at an area, you have been familiar with for many years from higher ground. The article that stirred my interest was from the Bridlington free press dated 30th of June 2011, it described how the keepers at Sewerby park zoo had found two of their Wallaby's decapitated. I found it fascinating and immediately suspected that something untoward had happened to these small kangaroos. If someone had told me I would be researching the deaths of Wallaby's before finding the story I would have laughed at them. The research also revealed links to similar decapitations in other parts of the world.

The Coffs Coast Connection

Before covering the Sewerby decapitations I would like to begin this account over 10,000 miles away on Australia's Coffs coast where on the 14th of January 2011 something was responsible for cutting the heads off wallaby's, something that showed remarkable similarities to the

Sewerby killings. The news report below was the first reported mutilation of its kind that I found in 2011

On their own these strange killings do not appear to be anything more than a macabre death carried out by a sick individual, or individuals. These things happen but very rarely, a bit like an unnatural wave hitting the shore. But this was more than one random act of madness, it was the meticulous precision of the killings that stood out. And the fact that in the absence of any other explanation foxes were blamed in all of the cases.

On the 14th of January 2011 Emerald heights on the Coffs coast reported that three wallaby's had been decapitated, their mutilated bodies had been discovered on a golf course at Emerald heights. The accompanying news article suggests the wallaby's had been killed instantly and that the killer was somehow removing the heads of its victims with such precision that they believed a samurai sword had been used to carry out the operation. VI have not read of any toxicology reports suggesting that the wallabies were drugged of incapaci-

tate before death, so how could this have been done to an animal that is renowned for being very hard to catch.





any reports of anyone seeing a samurai wielding lunatic chasing wallabies across a golf course. Let us assume for one moment that someone could get close enough to a wild wallaby, from what I have been told that in itself would be a near impossible task. These small kangaroos can reach speeds of up to 30 mph, but lets imagine a person could get so close that they could cut off its head with one full swipe of a samurai sword. That would sever main arteries leaving the heart pumping out blood at an alarming rate. No blood was found at the

I have spoken with zookeepers at different animal parks around the UK who inform me that these animals are very fast agile and strong. The general opinion was that if one of these small kangaroos manages to escape they are rarely caught, and that they have no problem surviving in most environments. The Coffs coast wallaby's were wild animals so we have to assume they would be even harder to catch.

There appeared to be no pattern to the killings and no clues were ever found. Placing the blame of a fox appeared to be the only plausible explanation, even when the method of killing was nothing like fox behaviour.

I very much doubt that before I began looking into the deaths that anyone had ever connected similar deaths at the other side of the world. Authorities were convinced the animals were been killed somewhere else and then being placed on the golf course afterwards. I think that has to have been the case, there does not appear to be

scene so the animals must have been killed elsewhere. The heads were never found and no other marks or signs of trauma were present on the bodies. It just did not make sense, how could three wallaby's have suffered such a terrible fate within weeks?

Wallaby beheaded 'with a sword'

A SAMURAI sword or machete may have been used to behead a wallaby in another brutal mutilation of an animal on the Coffs Coast.

Authorities are investigating the continuing disturbing mutilation of kangaroos in the area.

The most recent this week saw a wallaby cruelly killed and dumped at Emerald Heights. RSPCA and National Parks and Wildlife rangers believed a samurai sword or

machete was used to behead the animal.

It's the third attack of its kind on kangaroos and wallabies at Emerald Heights and follows similar incidents in the past at Safety Beach.

Those investigating the crimes are completely stumped why anyone would want to harm a placid animal in such a way.

"This is extremely troubled behaviour and not the first attack we've seen on kangaroos or wallabies in the area," RSPCA regional inspector Andrew Kelly said.

"What is most concerning is the motivation behind these attacks.

Mr Kelly said police have been informed and investigations are continuing.

By alerting the public to the sickening attacks, rangers hope the public provide information identifying who's responsible.

"We can't work out why the bodies of the animals are always found, but not the heads," Coffs Harbour NPWS ranger Ann Walton said.

"We thought maybe that fishermen were responsible, using the heads in crab pots, but anglers we have spoken to have said most likely fishermen would use the whole animal, so we just don't know why someone would do this."

If prosecuted, the offender or offenders face considerable penalties. Aside from police charges for using prohibited weapons to harm animals, the culprits face prosecution by the RSPCA for animal cruelty.

This offence carries a maximum \$10,000 fine and five years imprisonment, while the National Parks and Wildlife Service has its own offence of causing harm to a protected species."

It is clear after reading the articles that no-one had a clue what was responsible for the deaths of these animals, and although I talked tongue in cheek about a samurai wielding lunatic chasing wallabies across a golf course. I don't think for one second that was the case, I believe this was an apex predator, origins unknown?

I have to confess that apart from seeing close similarities to the Sewerby killings no real suspect stood out. At first I wondered if the Australian decapitations could have been the work of a cult, although I am not so sure that was anything more than a crazy notion.

There were close similarities to those killed in the UK so that would mean the people responsible were globally connected. I can find nothing suggesting such a group exists.

In the 1990s there was a group of people lead by a woman named Debra Geileskey called the, Magnificent meal

movement international. The movement [MMMMI] attracted over 400 followers and moved from Melbourne to Toowoomba in 1992. Her followers were instructed to drink up to 756 glasses of water per day and eat brains and tongue.

I have only referred to the cult to highlight how impossible it is to find any clues that could link the deaths to human involvement. There was nothing to connect the aforementioned cult to such atrocities other than an unusual diet of brains and tongue, and wallaby's that were found, less their heads.

The list of animals who's body parts are used in ritualistic magic is quite extensive but nothing linked these small kangaroos ever being used.

So do we throw the net wider and dare to suggest that a phenomenon was responsible?

Around the same time UFOs were been reported on the same coastline at Bendigo.

The Bendigo Advertiser reported that a man spotted an unidentified object on the night of Saturday January the 8th between midnight and 5am. This witness who was a retired camera operator, said he was standing at the back door of his home, facing west, when he noticed something strange in the sky.

"At first, I thought it was a bright star and it appeared to follow the same path," he said. "But I kept watching and once the sun started to come up it remained very bright and I realised I was looking at something very different." He commented that he had previously been sceptical of UFO sightings, but the extraordinary encounter had turned him into a believer."

I am not suggesting unidentified flying objects or their occupants are responsible for the killings, but if we are looking for highly unusual killers that leave no clues then we have to consider highly unusual suspects. Bendigo is approximately 800 miles away from Coffs coast, but it is clear that the Australian killings all shared the same stretch of coastline. The distance between them is considerable but at the same time it is nothing if the UK killings are linked to the same phenomena.

Lysterfield decapitation

The report below is the only information I could find on the Lysterfield Decapitation. Again, it is worth noting that the deaths are close to water and that Lysterfield is roughly 850 miles from Coffs coast.

WILDLIFE in Lysterfield Lake Park were decapitated and mutilated this week.

A small kangaroo or wallaby was decapitated near the boat launch area and another was killed by the cutting of

its neck and skull. Police are searching for information about the decapitation and mutilation that took place between 6pm on 2 May and 8am on 3 May. A short but interesting report highlighting the wallaby mutilations along the new south Wales coast, I also found out from talking with wildlife experts that other areas along the coast had found decapitated wallabies. Many of the reports failed to reach the media.

Closer to home

THE SEWERBY DECAPITATIONS EAST YORKSHIRE

The case of the Sewerby wallaby's, an intriguing article that appeared in the Bridlington free press on the 30th of June 2011 and received no more coverage after that publication. I knew soon as I read the article that it warranted more research.

Wallabies killed at Sewerby Hall zoo

Bridlington Free press JUNE 30 The Sewerby park decapitations

"FOUR of the five wallabies at Sewerby Hall's zoo have been killed. A fox is thought to be responsible for the killings, which all but wiped out the zoo's collection of wallabies, according to East Riding of Yorkshire Council. The only surviving wallaby has now been re-homed for its own safety. A concerned visitor to the zoo, who wished to remain anonymous, said she did not believe a fox could have killed the wallabies – and had heard that a severed wallaby heads had been found in the animal's enclosure.

"I think it must have been a person," she said.

"Wallabies are fairly large animals and I can't see a fox wanting to take them on. I think it's more likely that some cruel person is responsible." However, a spokesman for the council said all the evidence pointed towards a fox attack. He said: "It is with great sadness that Sewerby Hall and Gardens has to confirm that four of its wallabies have died.

"Evidence suggests that a fox is responsible and Sewerby Hall and Gardens has had its fifth wallaby re-homed, the perimeter fencing checked and has secured the other animals at the zoo. "Despite this tragic incident, Sewerby Hall and Gardens remains open for business and would encourage visitors to come along and enjoy what the venue has to offer."

I always knew I would come back to this article and here I am on the 10th of September 2017 attempting to put into words my views on the killings after many hours of research. My first job was to contact Sewerby hall and try to arrange a meeting with the head zoo keeper. The story was 6 years old and I realised its staff may have changed in that time.

On Monday the 4th of August, I gave the zoo a call, after explaining what I was researching a meeting was set up

for later that day at 1pm

I arrived at 1pm on the dot and was greeted in the courtyard in front of the Zoo by the head keeper John Pickering. After introducing myself, I followed John to an upstairs room that overlooked the zoo.

My first impression of John was that he was a professional man who took his job very seriously. I had briefly spoken to him on the phone about my interest in the wallaby deaths of 2011, so he already had an idea about why I wanted to speak with him. So with that in mind I asked him if he could recall anything unusual leading up to the events of June 2011. John said he couldn't recall anything out of the ordinary happening until the day wallaby's were found.

At that point, I did not know if he was aware of the other wallabies that had been found in similar circumstances throughout the year. I suspected Zoos within the United Kingdom might have had some kind of network where information was passed.

Zoo Keeper: "I remember it well Paul, they were killed over a few nights, it was very odd. We did think a Fox had killed them because CCTV showed a fox in the park. But that's not unusual if I am honest, think the reason we suspected a Fox was because someone had thrown two cockerels over into the lamas enclosure a few weeks before. They seemed happy enough living in there with the lamas, these things happen from time to time."

Paul: "So someone left two live chickens in the zoo?"

Zoo keeper: "Yes, like I said it happens, there owners must have been fed up with them and they probably didn't have the heart to kill them so we ended up with them. They were no bother so we just left them in with the lamas.

I remember coming to the enclosure one day, there was snow on the ground and we saw a few spots of blood on the fresh snow and the Cockerels had gone, there was nothing no feathers or anything to suggest they had ever been there.

I do remember wondering why I could not see any prints around the spots of blood but I never thought much more about it after that.

I think that was the start of it really, from that point we thought a Fox was responsible. It is strange though, we never had a problem with foxes before, and in the past the wallaby's were in an open enclosure with much less protection than they had in 2011 so it does make you think if it really could have been a Fox.

The first wallaby killed was a baby and when we looked on the CCTV we did see a fox walking around the zoo. We just assumed it was responsible after all the Cockerels had vanished. Then we found the first headless adult,

it was shocking but we thought the fox had got brave and started taking the adults.”

Paul: “So you never saw the Fox take anything from the Zoo or attack any animals.”

Zoo keeper: “No we saw nothing in the Wallaby enclosure, we just assumed the fox had got brave and took the adults.”

Paul: “Do you think a fox would tackle a fully grown animal, I know wallabies are smaller than kangaroos but I didn’t think they were that small that a fox would take them on.”

Zoo keeper: “ It was the only thing we could think of Paul and now you say that it does make you wonder. I agree they are smaller than normal kangaroos, but not that small, not the ones we had. They were Bennetts Wallabies and they are about 24klos.

I remember that I once had to catch one of them and I got hold of it by the tail. It lashed out with its feet and tore right through my uniform. They are very powerful for their size and not easy to catch.”

Paul: “I was told by someone that no meat was taken, I found it strange that they never ate the kill, I mean like you say these things would not have been easy to catch. Yet all they did was decapitate them? ”

Zoo keeper: “ Yes I agree it was strange behaviour. I think the local pub had a few animals as well and I seem to recall that they had some decapitations around the same time.” CONTACT PUB

I asked John if he was aware that a large black cat similar to a panther had been seen by numerous people around the area at the time of the killings. To my surprise he had heard about the panther and told me one of the girls who worked at the zoo claimed to have seen something similar. His description surprised me a little when he said that she described it as looking like a black lion. The witness who saw this told John she saw it around Bempton cliffs?

The number of people who claim to have seen something with fur that resembles a lion’s mane is quite high. So I do believe such a creature exists or manifests in the area. When you have so many people, independent of one another describing the same thing has to be taken seriously. I asked him if he knew the vagrant who lived in the woods at Danes Dyke, adding that he had seen something similar to a Black Panther early in the morning on 2 occasions. John wasn’t even aware of anyone was living in the woods and was surprised when I told him he had lived there for over 9 years. Danes dyke is about 2 miles from Sewerby and if this cat is real the area would have easily been within its hunting range. The vagrant is not the only person to have seen this animal so I am sure it exists. That does not mean the cat was responsible for the wallaby deaths, nothing about the dead wallaby’s suggested a big cat had killed them. Whatever killed

these animals did so for reasons we have yet to discover; it is however, another interesting and unexplainable element when poured into the strange mix that I am calling exotic nature.

Zookeeper: “Once the six wallaby’s had been killed it all stopped, you would have expected the killing to continue but it just stopped.”

Paul: “Six!”

I never realised this cloaked killer had removed the heads of six animals at the zoo, and for no reason that anyone could think of. It certainly was not the behaviour of a normal predator. The newspaper article was vague, it said four or five wallabies had been killed but now it appears that six had been decapitated, whatever had done the killings had cut the heads clean off these poor animals and done nothing else. The cuts were clean and precise which I think rules out a fox, unless they now carry sharp blades. I told him about some other strange cases I came across from 2006 in the Bridlington free press. Articles about mutilated Row deer found on Bempton lane, short lane and Wold gate. These killings were very strange in that they reported that the meat had been paired off the bone in an unusual way but no meat had been taken from the scene. I also discovered that deer carcasses had been found in Danes Dyke with meat removed clean off the bone in a similar way. This was in 2006, where had this killer been before that. Moreover, where did it go after the killing stopped, the descriptions were the same with every deer that was found, what kind of predator would or could do such a thing, and why?

To my mind no known animal acts this way, these killings are on another level. The Zoo Keeper knew nothing about the deer killings in 2006 and I still had not told him anything about the Wallaby deaths in other parts of the United Kingdom and Australia throughout 2011 and early 2012.

I don’t think my job is to try and convince other people. If the research reveals an undeniable truth then it has to be considered, even if it cannot be understood. The proof of it happening to one species in other parts of the world has been established, how and why it happened is yet to be discovered. The distance aspect of the killings is the real mystery for me, the similarities are striking. If you believe in coincidence then there is nothing unusual to any of this. I don’t have the answers but I can tell you now that I do not believe in coincidences of this magnitude. The life and death of any living thing is of equal importance and we should consider that distance is not a deterrent to this phenomena. Are we really that closed minded as to believe animals from different parts of the world just happened to die this way throughout 2011 and early 2012. Just because we do not understand how it happened does not make it any less real.



September 7, 2018

Solar Dynamics Observatory (SDO) scans detect GIGANTIC Coronal Hole!

A GIANT tear in the Sun's corona ejecting a stream of energized particles at Earth has been captured by NASA as the space agency mapped the Sun's intense magnetic field. This is a region where the sun's magnetic field opens up and allows solar wind to escape. It looks dark in extreme UV images of the sun because the hot

glowing plasma normally contained there is missing. In this case, the gaseous material is en route to Earth.” As the solar particles hit Earth’s atmosphere, they have the potential to cause aurora borealis or aurora Australis – Northern and Southern Lights. But, the consequences could be far more serious than the appearance of the Northern or Southern Lights.

For the most part, the Earth’s magnetic field protects humans from the barrage of radiation, but solar storms can affect satellite-based technology; they can heat the Earth’s outer atmosphere, causing it to expand. This can affect satellites in orbit, potentially leading to a lack of GPS navigation, mobile phone signal and satellite TV such as Sky. In extreme situations, such as the Carrington Event in 1859 (the largest solar storm ever recorded), it knocked out Telegraph systems and even set fire to paper in offices. September 9, 2018 (AM)

The SDO | Solar Dynamics Observatory catches two objects passing in different directions.

NASA Records 2 Lunar Transits. Admits It’s Impossible

On Sept. 9, 2018, NASA’s Solar Dynamics Observatory (SDO) saw two lunar transits (<https://www.nasa.gov/feature/goddard/2018/nasa-s-sdo-spots-2-lunar-transits-in-space>) as the Moon passed in front of the Sun.

“A transit happens when a celestial body passes between a larger body and an observer. This first lunar transit lasted one hour, from 4:30 pm to 5:30 p.m. EDT and obscured 92 percent of the Sun at the peak of its journey. The second transit happened several hours later at 9:52 p.m. and lasted a total of 49 minutes, ending at 10:41 p.m. EDT. This transit only obscured 34 percent of the Sun at its peak.”

The Moon does not change its direction, but it appears to do so from the perspective of SDO because spacecraft’s orbit essentially catches up and passes the Moon during the first transit. Yet it is good to note here that in the footage provided by NASA shows that the size of these two objects are very different. One is clearly larger than the other and I caught this instantaneously. If the Moon is constant in its size then rational says that from the first to the second pass, the same size object (the Moon) should appear. It did not and so it begs the question; “What was the second object? Planet X? Nibiru?




6 other observatories/webcams across the planet also went offline.







No longer could the U.S. afford the "emergency improvisation" that characterized its preparations for war against Germany and Japan. Instead, the United States was "compelled to create a permanent armaments industry" and a huge military force. He admitted that the Cold War made clear the "imperative need for this development," but he was gravely concerned about "the acquisition of unwarranted influence...by the military-industrial complex." In particular, he asked the American people to guard against the "danger that public policy could itself become the captive of a scientific-technological elite."

Eisenhower's blunt language stunned some of his supporters. They believed that the man who led the country to victory in Europe in World War II and guided the nation through some of the darkest moments of the Cold War was too negative toward the military-industrial complex that was the backbone of America's defense. For most listeners, however, it seemed clear that Eisenhower was merely stating the obvious. World War II and the ensuing Cold War resulted in the development of a large and powerful defense establishment. **Necessary though that development might be, Eisenhower warned, this new military-industrial complex could weaken or destroy the very institutions and principles it was designed to protect.**

Eisenhower's words just chill you to the bone. Again, at the time of this article, I am still conducting investigations into all these sources. LIVINGSTON UFO INCIDENT RECEIVES SIGNAGE.

Assistant Editor of Outer Limits Magazine Malcolm Robinson is pleased to report some happy news after a three year campaign with the West Lothian Council, Scotland, regarding getting some signage up in Dechmont Woods where one of Scotland's biggest UFO Incidents occurred. This is how it evolved.

Malcolm states;

The following is what I submitted to West Lothian Council 2015

Dear Sir/Madam,

This may sound quite an unusual proposal for the setting up of something in Dechmont Woods/Deans Woods but if you bear with me I'm sure you will see why that this could increase tourism to this area.

As you may know, one of the world's most famous UFO encounters occurred right in the very heart of Dechmont Woods to West Lothian Forestry employee Robert Taylor back on November 9th, 1979. The police were involved with this case as were the forensic division at Bathgate police station. All this came about when Forestry worker Robert (Bob) Taylor witnessed what he described as a spherical object hovering in a clearing in the woods. Furthermore, what resembled two second World War sea mines dropped down from beneath this hovering object and raced towards him grabbing him on each hip then rendering him unconscious.

This case, as I say, is one of the biggest in the world and has been featured in TV Documentaries not only in this country (which I have been part of) but also in America, Canada, Japan and many more countries.

Back in 1992 our society, Strange Phenomena Investigations (with the help of the Livingston Development Corporation) placed a stone cairn on the site with a brass plaque commemorating this event.

MY PROPOSAL

So, what I would ask is this.

You may not know this, but your woods receive visitors each year from people all over the world who want to visit the site where this bizarre UFO incident occurred. But there are no markers or stand up plaques to guide them to the correct spot. This I feel should be corrected with small wooden markers placed along the fire breaks. Moreover, there should be a proper stand up metal/steel board of which would should the illustration of the object, a photo of Bob at the site, some info on the incident itself and some of the police reports. In this way, those visitors who travel to Dechmont Woods would be



able to find the location easily. Tourism is always a big thing for any town or city and as we know, there are many tourist attractions across Central Scotland you could use all this information in your own West Lothian tourism brochures. Now believe it or not, this is not such a crazy idea and the reason why that is, is that this has already been done in the United Kingdom at another forest, Rendlesham Forest where the local authorities saw the tourists flock to a UFO incident that occurred in their woods. They set up a woodland trail with markers etc and are now part of their tourism package. WHAT HAPPENED NEXT?


Well what happened next was that I was informed by Eirwen Hopgood Woodlands Park Manager that 'yes' they were going ahead with my proposal. I was soon on Facebook where I left this statement.

STATEMENT BY MALCOLM ROBINSON

THE LIVINGSTON UFO INCIDENT TO BE RECOGNISED BY SIGNAGE

"Well am I happy or am I happy, no, I'm more than that, I'm bloody ecstatic! Some of my regular readers of my Facebook posts will know that I have been striving to get signage up at Scotland's most famous UFO Incident, 'The Robert Taylor Incident' or sometimes known as the 'Dechmont Law Incident'. Ufologists will know that England's famous Rendlesham Forest case has its own signage and UFO model in the forest all to provide members of the public an opportunity to visit the location and find it at ease. Robert Taylor's incident near Livingston has always been hard to find for those who don't know exactly where it happened. Having signage leading up to the area and a display board at the scene of the incident will improve this immensely. The Dechmont Law site receives visitors from around the world (some of whom still phone me asking how to get there) and I'm pleased to say that come this summer people will be able to find it with ease. I've been in discussion over the past three years with Eirwen Hopgood, the parks and woodland manager of the Dechmont Law area where I presented my idea to have proper signage put up and rather than laugh at my proposal, they have been most considerate and understanding so much so that they took my project on board and agreed that it will benefit the local community and bring more tourists to the area".

"I had a long conversation on the phone this afternoon (15th May 2017) with one of the main managers of the Dechmont Law area who confirmed to me that YES, THIS WILL HAPPEN. The wheels are most certainly in motion and I've been informed that it should all be in place for late summer this year (2017) The Dechmont

Law site is the only officially recognised site in Scotland for an event of this nature and I'm so chuffed to have played a role in ensuring that future generations can enjoy their walk in Dechmont Woods to a famous UFOlogical encounter. Of course we live in a society where some people can't see the good that others do and will try and destroy things, and our concern is of course that some local neds may uproot the woodland markers and destroy the display board (remember, someone did steal the original brass plaque on the stone at the site) Anyway It was something that I discussed with the woodlands manager and when all is said and done, one cannot gauge for what some people will do, all we can do is hope that this won't happen. Fellow UFO researcher Philip Mantle said to me many years ago that it would be good to get something at the site of the Robert Taylor Incident to commemorate this event. I ran with Phil's idea and a few years later (May 1993) SPI managed to get a large boulder/stone with a brass plaque placed on the stone of which commemorated this event and now ladies and gentlemen, boys and girls, I have managed to convince the West Lothian Council's Operational Services to help me get proper signage up at this important UFOlogical Incident. I'm so very happy tonight and it's great to see this come to fruition. I dare say that the Scottish media will pick up this story in due course. I wonder what the witness, Robert Taylor would have thought of all this? I'm sure he would have had a chuckle but knowing the man as I did he would have been very happy. I'll keep you informed as to how things progress"

AND THE OUTCOME?

Well needless to say that I was chomping at the bit to get this out to the media however, Eirwen asked if I could I leave it to them to get their press department to

get something out in the media and once they have done that, then I could go ahead and speak to the press myself. Reluctantly I agreed.

THE SINGANGE HITS THE MEDIA.

Well on the 31st of July 2018, Scotland woke up to read the following on the Daily Record web site. Titled; 'Information board will shed new light on famous close encounter of the third kind' subtitled with, November marks 39 years since Robert Taylor said he was confronted by a UFO at Dechmont Law woods in Livingston

Staff reporter Debbie Hall wrote the following;

It was a mystery that could have come straight from the pages of the X-Files. In a wooded area popular with joggers and dog walkers, a West Lothian man claimed to have come face-to-face with alien life in what would become one of the UK's most famous close encounters. November marks 39 years since Robert Taylor said he was confronted by a UFO at Dechmont Law woods in Livingston. Mr Taylor said he encountered a metallic sphere hovering in a clearing in the woods. As he approached it, two smaller spheres emerged and started to drag him towards the object before he lost consciousness.

Police investigating the incident found unusual marks in the clearing that did not match any known vehicle and tests on his clothes showed it was likely they had been ripped by a sharp upward pull, such as a mechanical device. The incident has fascinated people for the almost 40 years, due to the evidence and Mr Taylor's testimony as a very respected and credible witness and the mystery was one that even Mulder and Scully would struggle to unravel. But despite it being a well-known incident for

UFO enthusiasts, many people living in West Lothian still do not realise that a close encounter with little green men could have taken place on their doorstep. To provide more information and to mark 39 years since the now infamous incident, council bosses have decided to erect a new information board at the site. And unveiling the new plaque was Stuart MacDonald, who was Bob Taylor's apprentice at the time, and is now a tree and woodland inspector. He joined parks and woodland manager Eirwen Hopwood and Councillor Tom Conn.

Executive councillor for the environment Tom Conn explained:

"The Dechmont Woods encounter is Scotland's most famous alleged UFO incident and has featured in a number of books and TV programmes. The information board will help visitors to Dechmont Law find the exact location of the encounter, as well as give details of Mr Taylor's report of the incident. Dechmont Law is already very popular with local residents, especially runners and walkers, and we hope this board will help more people discover and enjoy the picturesque area."

Dechmont Law is managed by West Lothian Council, and offers amazing views across the region as the highest view point in Livingston. The 66-hectare open space is well-used for recreation and is popular with local walkers and runners. But was it a landing site for little green men nearly 40 years ago? The truth is out there.

NOT PLEASED!

Now whilst the above story is fantastic, there was no mention of me or SPI or our three-year campaign asking the West Lothian Council to place this signage in the woods. I don't blame the council, far from it, I'm pretty sure they would have told the Daily Record that it was my idea but I dare say the Daily Record decided to drop that bit and just concentrate on what the West Lothian Council had done! It did feel like a kick in the ribs at the time, that someone else gets all the credit whilst the man behind it who made it all happen does not get a mention. But that's life, the main thing is that the story made the press, but more importantly, we got the signage up in Dechmont Woods. One final kick in the ribs was that the Daily Record used 'my' photograph of Robert Taylor in the Woods talking to delegates from the British UFO Research association but gave no mention that I took this photo. Plus, they did not have my permission to use this photo, if they had have asked, then yes, no problem, again, such is life!

Once the story was in the media, I decided to launch my own campaign of acknowledgment, and the following is a press release that I sent out.

SCOTLAND'S FAMOUS UFO ENCOUNTER TO BE

OFFICIALLY RECOGNISED

UFO fans the world over will now be able to find with ease, the location of Scotland's most intriguing UFO incident that which occurred to forestry worker Robert (Bob) Taylor in Dechmont Woods near Livingston Central Scotland back in 1979.

In 1992, the UFO site was officially recognised as a location of local and National importance by the placement of a large stone cairn and plaque placed at the time by the Livingston Development Corporation, (Forestry Department). However, in the past it has been difficult for people to find the actual location, but not anymore as brand-new marker posts and an information display board will be placed in the woods where this astonishing encounter took place. UFO researcher Malcolm Robinson was one of the main researchers of this incident, an incident which made news around the world and has been featured on many National and International UFO documentaries. Now, 26 years later, Malcolm who asked the West Lothian Council to make this happen, is pleased to see this come to fruition and states that this is Scotland's biggest case of its kind and the marker posts and display board will ensure that the site will be easily reached by those who flock to it each year. The Dechmont Woods UFO site, is the only site in Scotland that officially recognises an event of this nature and whatever UFOs may be, there is no denying that this case stands heads and shoulders above anything that has been seen in Scotland.

The ECETI Ranch (Enlightened Contact with Extra-terrestrial Intelligence) is believed to be one of the busiest and active UFO Hotspots in the United States and attracts Ufologists and alike in their droves to catch their own personal UFO sighting. Also known as Gilliland's Ranch it's owned by American Ufologist and radio host James Gilliland and has attracted the likes of pop star Robbie Williams, actors Dan Ackroyd and Danny Dyer to name a few who have all had their own experience while at the Ranch.

The ranch itself is an area of land in Trout Lake and at the

base of the spectacular Mt Adams located in southwest Washington.

Many UFO conferences have been held there since 1986 and grow in stature every year (I have also spoke there during the 2018 conference via Skype link).








Enlarged and Enhanced View of Smaller Anomaly




also had personal extra-terrestrial experiences. I was first introduced to Peter through researcher and author Mary Rodwell who recently spoke at the 2018 Outer Limits conference and a fellow speaker at the ECETI Ranch conference.

I have personally had the pleasure to analyse quite a few of Peters (captured) footage and images of UFO's and anomalies with often remarkable results, I also class Peter within the top 1% of UFO experiencers (Worldwide) my option of course due to my research and findings. His book regarding his sightings and experiences (Shi-Ji, Available on Amazon) explains in more depth these experiences he has had and continues to have to this day.

One of my last cases I analysed for Peter and James at the ECETI Ranch During 2018 was a Bright Illuminated Orb which first appeared in the distance and tracked by numerous witnesses including Peter and James. It was captured on video using up-to-date night vision equipment and high spec high definition (HD) camera equipment. The brightly illuminated object was observed traversing at a steady constant velocity and exhibited a 'Halo Effect' while powering up (a term used when an object is observed getting brighter similar to a burst of light or immense flash of light) giving the impression to the witness of the object powering up, also it is thought by many Ufologists that it is a means of communication or a sign between the object/inhabitants and the observer. Also within the footage the camera operator zooms in and out on occasion capturing surroundings such as trees, foliage etc great for perspective when analysing distances etc in relation to the witnesses and the subject object.

Important note: during the sighting it was stated by the witnesses that no other aircraft or satellites/space station (ISS) had been in the vicinity during the entire observation period (by the use of computer apps and webpages). Heavens above <https://www.heavens-above.com/>.

An interesting observation during my analysis of the illuminated Orb was the discovery of a smaller object in close proximity to the larger sphere. Upon using frames taken from the original source footage I was able to enlarge and enhance the smaller anomaly (see attached images) with spectacular results, both objects appeared to have defined structure to the central core area and the larger Orb/Spherical Shaped Object had an illuminated aura surrounding its entirety.

Both objects appeared to have no strobe lights visible or anything similar to aircraft strobe or landing lights and also appeared to move under intelligent control conditions.

The 'UFO Investigator's Manual

UFO Investigations from 1892 to the Present
Day' [Hardcover] by Nigel Watson.

Covers the history of UFO sightings and their investigation since the 19th Century, and looks at the explanations and theories surrounding these sightings. It is a great guide for newcomers to the subject and a useful reference for seasoned ufologists.

Six Key Facts The first major UFO scare occurred in the USA in 1896 to 1897.

Thousands of people throughout the nation saw mysterious lights in the sky that they thought were carried by an airship. Many people declared that they met with the landed airship and spoke to its crew, who claimed they were testing a technologically advanced aircraft. The phantom airship sightings disappeared after the work of hoaxers and mundane explanations for the sightings came to light.

The flying saucer era truly began when Kenneth Arnold was flying his Callair plane over Mount Rainier, Washington on 24 June 1947. As he was flying eastwards, he saw 'a chain of nine peculiar looking aircraft flying from north to south at approximately 9,500 foot elevation'. He calculated that they were travelling faster than 1,609kph (1,000mph) and he described them as flying 'like a saucer would if you skipped it across the water.' From that, the term flying saucers was coined and it triggered literally thousands of people throughout the world to report seeing similar objects.

Flying saucers have a bad habit of having to land to make repairs or they simply fall out of the sky and crash. The most famous UFO crash occurred near Roswell, New Mexico. On the 8 July 1947, the Roswell Army Air Base publicly announced that they had recovered the remains of a crashed flying saucer from a nearby ranch.

The wreckage was sent to Wright Patterson Air Base where it was quickly identified as the remains of a conventional weather balloon. Since then it has been claimed that the wreckage was analysed to build highly advanced aircraft and that alien bodies were retrieved and put in storage by the USAF at Area 51.

To some this is the ultimate proof that the US government has concrete evidence of the alien presence; to others it is a myth that has been inflated out of all proportion to the facts. In the 1950s, so-called Contactees claimed they met with peace loving humanoid looking aliens, who often took them for rides in their flying saucers.

The most famous Contactee was George Adamski who reported meeting fair-skinned, androgynous aliens who had long blond hair. Adamski photographed distinctive flying saucer craft, as they flew over Mount Palomar, and he claimed these craft took him on trips to the Moon, Venus and Saturn. The first alien abduction that attracted worldwide publicity occurred to Betty and Barney Hill on the fateful night of 19 September 1961, as they drove from Canada to their home at Portsmouth, New Hampshire, USA.


They saw a UFO following their car and then they returned home two hours later than they expected. Under hypnotic regression it was discovered that both of them had undergone rigorous medical examinations by the aliens during this period of missing time.

As Betty was escorted from their flying saucer she told them, 'This is the most wonderful experience of my life. I hope you'll come back. I got a lot of friends who would love to meet you.'

Today, the vast majority of UFO sightings are caused by Chinese Lanterns.

Crash retrievals

Despite being able to whizz across our skies at great speed and make stupendous manoeuvres that can run rings around our own aircraft, flying saucers have a bad habit of having to land to make repairs, or simply fall out of the sky and crash. So their technology is not much more infallible than, or superior to, ours.

Of all the crash retrieval cases, that at Roswell, New Mexico, is the most familiar. On 8 July 1947 the Roswell Army Air Base publicly announced that they had recovered the remains of a crashed flying saucer from a nearby ranch. The wreckage was sent to Wright Patterson Air Base and it was quickly announced that it was the remains of a conventional weather balloon. The case was then largely forgotten, or at best dismissed as a footnote in UFO history, until the late 1970s. Since then it has encouraged all manner of 'eyewitnesses' (or friends of friends of eyewitnesses) who claim to have seen the debris, and talk of dead alien bodies being retrieved and held in storage by the USAF. To some this is the ultimate proof that the US government has concrete evidence of alien visits to our planet; to others it is a myth that has been inflated out of all proportion to the facts.

Rather than being a spaceship, some ufologists have claimed that the crash at Roswell was one of the Japanese Fugo balloons launched during World War Two finally coming to earth. Another explanation was that it was a balloon used in Project Mogul, a top secret US project intended to spy on the USSR. Due to public pressure, internal investigations were launched by the General Accounting Office to disclose the truth of the matter. Their first report, in 1995, confirmed that the wreckage was of a Project Mogul balloon. In 1997 their second report looked at the rumours and stories about recovered alien bodies. This concluded that they were a combination of rumours and half-forgotten memories of missions involving the recovery of injured pilots or anthropomorphic dummies used in experimental projects unconnected with UFOs.

These reports did little to dent the public's enthusiasm for speculation about the Roswell crash. Indeed, in 1995 more fuel was added to the flames when Ray Santilli, a British entrepreneur, released film footage which showed a graphic autopsy of a recovered alien from the Roswell crash. Several years later he admitted that this was a reconstruction of the autopsy, as the 'genuine' film footage had been lost.

In 2011 Roswell hit the headlines yet again when journalist Annie Jacobsen's book *Area 51: An Uncensored History of America's Top Secret Military Base* claimed that the aliens recovered from Roswell were actually genetically mutated 12-year-old children.

They were sent to the USA by the Soviet Union in a remotely piloted aircraft to promote hysteria in the American population. Several years earlier a similar theory was put forward by Nick Redfern, who claimed that the Roswell crash was caused by a balloon based on Japanese technology. The balloon was used to launch a glider that had a pilot and crew consisting of handicapped people. The object of this and other missions was to study the effects of radiation and high altitudes on the human body.

Such continued speculation reinforces the concept of the 'Roswellian Syndrome' put forward by Joe Nickell and James McGaha. They note that there are five main stages to this myth-making process:


1. The incident: This is the event that initially triggers the crash-retrieval rumours.
2. Debunking: The recovered wreckage is quickly given a mundane explanation.
3. Submergence: The story lingers in the fading memories and speculation of the local population.
4. Mythologising: As time passes faulty memory, exaggeration and deliberate hoaxing comes into play.
5. Re-emergence and media bandwagon effect: The story resurfaces in the media and takes on a life of its own.

This process also plays out with other crash retrieval cases and UFO incidents. Roswell is only the tip of the iceberg, as there have been nearly 300 alleged flying saucer crashes throughout the world since 1947. Like the Roswell incident, they become more spectacular and mysterious as time passes.

Crash retrieval motifs

British ufologist John Harney has identified the following crash retrieval motifs:

- The precursor – eg something seen in the sky, an explosion heard, or mysterious object tracked by radar.
- Crashed UFO – almost always in a remote place. Aliens, dead or alive, in or near crashed UFO.
- Arrival of military.
- Civilians expelled from crash area.
- Aliens cruelly treated by military.
- Aliens helpless and unarmed, and apparently not very intelligent.
- Military personnel sworn to secrecy.
- Civilian witnesses threatened or bribed to keep silent.
- Authorities give unconvincing cover story to media.
- Authorities remove all wreckage from crash site, usually on a flat truck covered with a tarpaulin.
- Witnesses pick up bits of wreckage but authorities always recover all of it from them.
- US Air Force nearly always get involved, sometimes allegedly by putting pressure on government of country where crash occurs.
- Long after event, persons contact ufologists to claim they were involved in recovery operation.
- Such persons claim to have seen alien bodies or worked on UFO wreckage.
- Official photographs, films or videos of aliens are never made available or are obvious fakes.




ABOVE: The 60th anniversary of the Roswell crash was celebrated on the front cover of the July 2007 edition of UFO Magazine. UFO Magazine
