UFOs - A FANTASY SCENARIO

The Annunaki, an ancient race, inhabits Nibiru, a planet circling our own sun, to which it returns at perigee but once every 3,600 years. Their lifespan is so great that each to us would seem immortal and their science so perfected that they can screen their planet from the cold dangers of its long, eccentric orbit in outer space. An essential element of this screening is gold, and some thousands of years ago they found they no longer had enough of it. So they sent out interplanetary ships to search the solar system and finally found gold on planet Earth.

They sent out an expedition to our planet, which at that time had only plant and animal life, setting up a base on neighbouring planet Mars to maintain contact with Nibiru. They mined gold in Africa, but eventually those working the mines rebelled at the hard manual labour and the mutiny was only settled when the great scientist in charge there promised to create a race of slaves to do the work. He did so by fertilising the eggs of hominid apes with the sperm of the Annunaki, and the first man thus created was called Adam.

Adam's descendants soon populated the Earth, worshipping the Annunaki as gods and doing their bidding, but eventually the numbers of mankind became beyond the power of the Annunaki to control and they were forced to leave the Earth. Centuries passed and on Earth the Annunaki were soon forgotten, but they did not forget the Earth as problems with the environment on their home planet increased, and they realised that soon it would no longer be habitable.

They needed a new home and knew where it could be found, but knew also that the intelligent slaves they needed would no longer be provided by the turbulent human race of Adam. When the android robots manning their underground Martian base sent back the news that nuclear explosions had been detected on Earth, they saw their intended future home in danger of becoming uninhabitable if nuclear wars broke out.

Their scientists, who could control gravity and travel through dimensions of spacetime, therefore formulated a plan to take over the planet and populate it with beings more versatile than the android organic robots with their telepathic bug-eyes and puny bodies, and more amenable than the aggressive humans, by mixing the two strains. The great geneticist who had intertwined the Annunaki DNA with that of the hominids had no problem programming the prototype androids with instructions and powers for manipulating the gametes of abducted humans, and cloning such robots in numbers sufficient to operate from

interplanetary craft to ferry the listless mutated hybrids they would create on Earth to their temporary destiny in the underground cities of Mars. These bug-eyed androids were also programmed to defend those bases from such interference as the terrestrial probes Phobos and Observer represented.

Mankind, of course, had to be prevented from destroying either their planet or its ecology before the Annunaki takeover, and also be controlled so as not to unite in opposition to the secret operations of what some had begun to call the UFO Phenomenon. Since it could not hope to operate unobserved, the Phenomenon skilfully controlled human reactions to its presence. Massed UFO flights eventually dispelled an original belief in their terrestrial origin, while the exploitation of Contactees such as Adamski evoked a connection between LITS and humanity before covering it with ridicule. The genetic element of the operation was revealed, only to be rendered risible also, often with the help of governments aware of their impotence without daring to admit it for fear of public panic.

Gradually, however, despite deliberate disinformation and obfuscation by governments and their intelligence services, the belief grew that the public testimony of thousands of reliable witnesses - airline pilots, policemen, sailors, astronauts and astronomers, to name but a few - could not be ignored. People of ability and repute began to give the problem serious study.

Initially the agents of the Annunaki had developed their genetic programme separately from a parallel pilot scheme of ideological indoctrination, but were finally able to combine the two in a subtle conditioning which eventually captured the unconditional allegiance of some at least of the abductees, many being brought to believe that they were themselves "aliens" in human bodies or of "alien" stock. These abductees had been conditioned to accept the android organic robots abducting them as true individual beings, though in fact they had no more individuality than an ant and shared a similar organic specificity and corporate consciousness. Such abductees could, of course, constitute a "fifth column" force to betray their fellow humans in any conflict with Annunaki agents. Indeed, some researchers believed they had evidence of deals done and facilities granted by Earth governments to such agents, and even of infiltration of human - seeming androids into key roles in national governments.

Since humanity's only advantage in any conflict with the Annunaki lay in its vast uncontrollable numbers, it was to be expected that at some point catastrophes and diseases would be engineered to decimate repeatedly the human ranks, with the simultaneous propagation of some ideology which would create eventual acceptance of participation in human society by the new breed of mutated hybrids intended ultimately to destroy and replace it, thus preparing the way for the final conquest of Earth by the Annunaki and the end of Adam's line.

INITIAL FINDINGS UPON EXAMINATION
AND AUTOPSY OF THE BODY OF AN
APPARENT ALIEN CREATURE

1. External Appearance

This body was observed to be in a state of profound deterioration. It had not been preserved but was delivered in a container of rubberized canvas, to which some of the tissue had adhered. The cadaver was 36 inches long with a weight of 8 pounds. The external appearance of this cadaver was not of a human type. The skin appeared smooth and a dark bluish-gray in color. There was no clothing on the body. There were no genitals and no way of determining sex, if any. The nose consisted of two slits, the mouth was a small opening that did not appear to be supported by an articulated jaw, and there were holes in the position of ears. The cranium was round and large in proportion to the body and the eyes were almond-shaped. The eyes were closed and could not be opened without damaging structures, due to condition of decaying tissue. Arms and wrists were very thin. The hands displayed a three-digit arrangement without thumb. The arms extended to approximately three inches above the knee. The three fingers extended directly from the wrist, with no palm.

2. Dissection

The body was opened from crotch to chin. A green liquid emerged from the incision. The skin was not backed by fascia, and the bone structure appeared to be a cartilaginous substance of light green-blue color.

Internal organs were observed but their function was unclear. The thoracic and peritoneal cavities communicated and there appeared to be no respiratory system and no stomach. The esophagus was vestigial and dissipated before reaching another organ.

There appeared to be two multi-chambered hearts and it was surmised that body fluid could be pumped rapidly. There was an extensive circulatory system that involved three different types of vein. Some material was extracted from one of these systems and suggested possible waste, leading to the notion that waste may have been exuded through the skin.

The fluid removed from the body was analyzed under the microscope and found to be a vegetable substance, chlorophyll-based. It is possible that photosynthesis was the means of obtaining energy.

The cranium was dissected and it was observed that a ridge of cartilage separated the brain into two completely isolated components. The brain was severely deteriorated, but appeared to be extensively fissured and divided into numerous lobes. Because of the deterioration the degree of bilateralism of the two halves could not be determined with any accuracy.

This cadaver exuded an unusually foul odor.

3. Conclusion

This is not a cadaver of a kind previously observed by or known to this pathologist. It appears to be a form of creature utilizing elements of both the animal and vegetable.

UFOs AND HUMANITY

For nearly half a century the human race has been puzzled and bewildered by the activities of the UFO Phenomenon and only comparatively recently has it become possible for researchers to gain a clear and unequivocal intimation of the purposes to which the majority of reported UFO activities have been and continue to be directed. The correlation and comparative study of reports by groups of witnesses who have been abducted and taken up in UFOs show that humanity has been the target of a structured and invincible attack on powerless men and women, for purposes most people find it hard to believe.

Those who have studied the evidence of hundreds of mutually supportive reports over many years, however, find that they cannot avoid the conclusion that the UFO occupants are stealing from the people they abduct human genetic material, and using it to produce a hybrid race, a cross between human and alien. Thanks to the painstaking efforts of researchers such as Budd Hopkins, David Jacobs and John Mack, we now know beyond reasonable doubt that the immediate purpose of the UFO Phenomenon here on Earth is the creation of this bastard race by altering the genetic makeup of human embryos, possibly by the insertion of alien DNA, and bringing them to term in a UFO environment.

Where the hybrids thus created are sent to await their eventual fate, or what indeed the final nature of that destiny may be, are at present matters upon which we can only speculate in the light of suggestions at present lacking adequate confirmation. The subtle approach by whatever intelligence directs the programmed operations of the android UFO crews, and its frighteningly comprehensive grasp of human psychology and physiology, are both at a level which permits it to manipulate the people and governments of our planet, and so pursue its breeding programme unhindered.

Let us therefore now examine the methods by which, over the years, the Phenomenon has been able to achieve such total success. It is important to recognise that the directing intelligence knew it could never hope to operate unobserved, but was able skilfully to provoke and direct observation so as to turn it eventually into a form of psychological concealment. It deliberately sought to make itself incredible by alternately awakening and then discrediting interest and belief in the existence and activities of UFOs by the general public. In this they were greatly helped by the moral cowardice and blind arrogance of the scientific establishment, who were dissuaded by fears of loss of tenure from even examining the evidence they dismissed out of hand. The Phenomenon now needed people to take its existence seriously, so that the required ridicule could be evoked from the cravenly unscientific scientists who would have the confidence of government and public.

The first public appearance of Unidentified Flying Objects (UFOs) is generally thought of as occurring in June 1947, when businessman Kenneth Arnold saw a formation of them over the Cascade Mountains in Washington State, USA. Certainly this was the point in time at which the UFO Phenomenon, as we have since come to call it, made its initial impact on the collective consciousness of the peoples of our world, and it has been persistently challenging us with its varying manifestations ever since.

For a while we were all intrigued by the incredible aerobatics carried out by the "lights in the sky" or LITS, as we soon learned to call them, from the initial letters of the phrase. Buzzing the White House and disrupting the electricity supplies to the American capital kept them for a time on the front pages of newspapers worldwide, but before long even the most intricate supersonic aerial manoeuvres ceased to amaze. The activities of the UFO Phenomenon slipped from the focus to the periphery of human attention, from which even the 1948 death of Captain Mantell in a dramatic attempt to chase a UFO could not retrieve it.

The intelligence directing the phenomena must soon have realised that mere Lights in the Sky were no longer of much interest, as they made no personal impact on anyone. Its purpose seemed to be to regain the fickle attention of humanity, and for this something different was clearly needed. In 1953 the new policy made its first impact with the inspired publication of a book by Desmond Leslie and George Adamski with the arresting and unequivocal title *Flying Saucers Have Landed*.

Adamski's story introduced the second phase of the UFO Phenomenon's operational plan, generally known as the Contactee Era. The first phase - the era of the LITS - had established in the corporate human mind the *existence* of UFOs, without establishing that this existence had any real implications for mankind. The function of the Contactees was to demonstrate that UFOs had a *relevance* to humanity by showing that they were controlled by entities with a direct, personal connection with people and a message for humanity as a whole. The message was important - not in itself, for it was banal in the extreme - but for credibility: if you are supposed to have come from outer space, you will be expected to have something to say on arrival.

Subsequent encounters with ufonauts have suggested that they possess exceptional telepathic abilities and it seems likely therefore that the Contactee presentation was designed by the psychologists of the Phenomenon in such a way as to conform to the expectations of the Contactees, which they were able to read. Phase One of the operation had succeeded in establishing that the UFOs were not, as the World War 2 Foo Fighters were thought to be, the creation of any nation on earth. People therefore accepted that if the UFOs were not terrestrial, they must necessarily be extra-terrestrial, bad logic but good psychology. So the ETH (extra-terrestrial hypothesis) was born, out of the expectations of the Contactees, and fostered for their and others' benefit, together with a desired but unjustified belief in the benevolence of the entities perceived.

So it naturally came about that the first contacts were the products of a skilful presentation featuring tall, blond and noble ufonauts, delivering trite messages about peace, war and nuclear arms, who offered apparent joyrides in flying saucers to Utopian lands on nearby

planets. People like Adamski were probably for the most part quite sincere, but they were deceived and exploited by the Phenomenon for its own purposes. When the necessary idea of a link between the Phenomenon and the peoples of Earth had been successfully promulgated, the trustful expectations proclaimed by the cultist contactees were cruelly disappointed and the believers left exposed to ridicule and contempt. The lesson that you can't necessarily trust an alien, however, still hasn't been learned by everyone, but at that time most people felt that the great flying saucer hoax had been exposed and everyone could relax and carry on with their material concerns as though nothing had happened. But something had indeed happened, though most chose to ignore it.

The alternation of hope and fear is a psychological process well understood by the practitioners of brainwashing everywhere, and the Phenomenon seems to have been well acquainted with the technique, an understanding possibly gleaned from its studies of the mental processes of the Contactees. Having now exhausted what dividends were to be had from hope and benevolence, it was now time to try what fear, threats and abuse could accomplish in an exhaustive study of the physical and psychic structure of the human being of each sex. The third phase - that of the enforced and exploitative abduction - could then be launched, and it is with this aspect of the Phenomenon's activities that we are still currently concerned.

At this point, ufologists became aware of a strange duality, a novel divergence in the apparent policies of the Phenomenon. Having established both its *existence* and its *relevance*, its next activities seemed to manifest a bifurcation of intent. Some of its actions suggested an *ideological* drive, featuring amongst others a promotion of what we have generally come to call "green issues" - a concern with the wellbeing of the planet and its ecology. A parallel thrust, however, seemed to concern itself entirely with the practical promotion of a *genetic* programme, ruthlessly pursued on a large scale by android clones, which appeared to have as its ultimate outcome the creation of a race of alien/human hybrids. This latter project is the one which has received the most publicity and created the most controversy, largely through the researches of ufologists in the USA, where it seems to be mainly, though by no means exclusively, concentrated.

It might thus seem that there are at least two types of alien, one engaged in the ideological and another in the genetic project, but since there is strong suspicion that the agents of the Phenomenon are capable of presenting themselves to human eyes in any form they wish, descriptions by abductees of the physical appearance of their captors cannot be accepted as objectively valid. The appearance is not necessarily the reality, and though it would be a very convenient paradigm to see the ideologues as responsible also for the apocalypse of the cornfields, while the geneticists ruthlessly ravish human gonads for their breeding schemes, we cannot with any certainty make this distinction. Indeed, if John Mack's more extreme revelations have any validity, the geneticists too may finally be promulgating doctrines similar to those of the ideologues as regards planetary ecology: they seem to want to preserve the planet they perhaps intend to take over for the hybrid race once humanity, repeatedly decimated by disease and catastrophe, is unable to oppose them.

Since we now stand at a particularly challenging point in our attempts to evolve an effective theoretical understanding of the significance for humanity of the activities of the UFO Phenomenon, it is perhaps advisable to consider now how it is that we have arrived at our present situation.

The first adequately investigated abduction took place on October 15th 1957, just ten years after Kenneth Arnold's launch of the term "flying saucer" upon an unsuspecting world. It was not until the following February that Antonio Villas Boas told his incredible story to Dr. Olavo Fontes, doyen of UFO research in South America and Professor of Medicine at Brazil's National Medical School. The case is well-known, and I have already examined it in detail elsewhere⁽¹⁾, so that I wish here only to point out that the whole account was recorded without any recourse to hypnosis and that at no time did the witness enter any alternative dimension of spacetime. In fact the landed UFO materialised wholly into our terrestrial dimension and carried out its genetic intervention in ways we would consider entirely earth-normal, both in the physical struggle of witness and abductors and in the subsequent sexual coupling.

We may suppose that the intention of the Phenomenon at this point was to produce as credible an intervention as possible if, as must surely have been expected, it was to be reported. Most significant in this respect was surely the female alien's parting gesture, pointing first to her presumably impregnated womb, and then up to the sky, especially as she also had collected a further sperm sample in a container. The message was unmistakably one of inter-species breeding - the new concept to be introduced, and ultimately accepted by humanity.

Its dissemination was, however, unexpectedly delayed by the very proper caution of the investigator. At a time when ufology was still suffering the ridicule the Contactees had finally evoked, Dr. Fontes was well aware of the probable response by the media to an account so highly strange as that of the Brazilian farmer. He therefore delayed publication of his report and advised the witness accordingly. It is especially worthy of note that in this case there was no verbal or mental communication between abductors and abductee, so that it stands as a pure example of the ideal⁽²⁾ *genetic* type, uniquely free of any *ideological* element.

A further ten years had to elapse before, in December 1967, we find an equally pure example of the ideological or apocalyptic type of encounter, also with a landed UFO but without any sexual overtones, in the case of police sergeant Herbert Schirmer of Ashland, Nebraska⁽¹⁾, which also features one of the earliest examples of the now common "missing time" syndrome. The clumsy treatment and discourteous interviewing Schirmer received at the hands of the Condon Committee robbed us of a full account of his experience from which, however, we learn that there was telepathic contact to enforce the idea of an extra-terrestrial origin for the aliens, revealed in the subsequent hypnosis, for at this time the ETH was being actively promoted, perhaps just *because* it seemed so incredible to academic scientists who could therefore be relied upon to pour scorn upon it.

In addition to the breeding and indoctrination schemes, the ufonauts sometimes indulged in a little deception I call *prospecting*, apparently showing great interest in collecting the flora and fauna of Earth. This so precisely reflects the kind of behaviour in which humans might indulge were they to find themselves on a new and unknown world that one begins to think this is the impression the ufonauts were seeking to give of themselves, so that even human abductions and cattle stealing were seen as part of some alien scientific survey, having no object other than the pure pursuit of knowledge for its own sake, and further promoting the idea that the Ufonauts are unfamiliar with planet Earth and its inhabitants.

When Maurice Masse was abducted at Valensole, France, in 1965 the ufonauts were discovered examining his lavender plants, and the Lorenzens in their 1967 publication *Flying Saucer Occupants* described a number of instances in which samples of water, grass, tomato plants and even soil were collected. In 1957 a small being had even attempted to kidnap a dog in New Jersey. This prospecting behaviour seems to have died out during the sixties and had perhaps been another attempt to support the ETH at a time when some believed the aliens had successfully established themselves in secret bases on Earth itself. The thefts of animal tissue, which still continue, are almost certainly associated, not with prospecting, but with the breeding programme.

Just as the prospecting behaviour disappeared when ETH reinforcement ceased to matter, so the direct ideological approach seems to have been abandoned soon afterwards. We have to go back to 1974 to find the last pure case of ideological conditioning, when John and Sue Day, their children and even their car were all hauled aboard an enormous UFO and apparently underwent an out-of-the-body (OBE) experience in which enormous amounts of information were pumped into their brains by a special machine to produce a complete attitude change in favour of green issues.

Sue was unable to absorb most of this, but John suffered a nervous breakdown which made him unfit for work for a whole year. The aliens seem to have drawn the obvious conclusion that this was an inefficient method of indoctrination and seem now to be combining the genetic and ideological programmes into a carefully structured assault on the persons and personalities of their abductees. This often involves dire warnings to save the planet by changing the lifestyles and ecological attitudes of humanity.

For the clearest and most concise account of the current abduction activities of the Phenomenon we are indebted to Dr. David Jacobs, Associate Professor of History at Temple University, Philadelphia, whose taxonomic investigation of some 300 accounts provided by 60 witnesses has produced a coherent statement of the meaning for humanity of this calculated assault on its future identity. The following account owes much to his work, which shows that the UFO occupants are pursuing a basically sequential set of operations on the unfortunate abductees, entirely of course without their consent. When challenged on this point, they make the extraordinary assertion that they have a right to do what they have to do. In their telepathic communications with abductees they evince absolutely no interest in anything human other than the physiology and psychology of the individual. For them Art, Literature, Music, social institutions and corporate activities seem not to exist, and they show a total inability to in any way empathise with human attitudes and emotions, or to show any compassion for the suffering they often inflict. They thus reveal themselves as sub-human organic androids, most probably clones, acting only in accordance with the pre-programmed promptings of an internal logic file. Among them there are found slightly taller individuals with more sophisticated programming, who act as supervisors and overseers of operations.

Their absolute power over abductees arises solely from the superior technology available to them, some of which extends to a temporary control of their victims' mental processes, which they are constantly seeking to understand more fully. Though endowed by their unknown creators with this technology enabling a total control and exploitation of individual humans, they seem in all other respects soulless and inferior to the species whose attributes they are apparently seeking to appropriate.

Abductees are selected quite at random from all walks of life, with the proviso that they must either be sexually functional or pre-pubertal. There have been instances of older people, such as Elsie Oakensen and Alfred Burtoo, being rejected on these criteria. Victims are preferably taken at night and when alone, so that they are less likely to be missed, though any companions can if necessary be "switched off" until the abductee returns, unaware also of the time that has passed.

On reaching the UFO, the victim is stripped naked, secured to a table and subjected to an exhaustive and often painful physical examination. If this is a second or subsequent occasion, any changes are at once noted and enquired into. Sperm is taken from men and eggs from women, who are liable also to be implanted with a fertilised and manipulated egg which will be removed at some subsequent stage of foetal development.

The ideological aspect of the abduction is now carried out by a process Jacobs calls "mindscan", in which a taller being looks deeply into the eyes of the subject, simultaneously both reading and controlling his or her thoughts. Physical control of the victim is maintained at all times by what appears to be a manipulation of muscle tone, often induced by a mere touch from the alien.

At some point in the series of abductions all victims undergo, they are shown the mechanisms of the hybrid breeding programme - tubes leading to transparent fluid containers holding fetuses in various stages of development, surrounded by machines controlling the supply of nutrients. At a later stage they are shown the babies thus produced, which appear sickly and languid by human standards, and every effort is made to provoke feelings of bonding in the women, who are always asked (and if necessary made) to hold babies said to be their own. It appears that human contact of this kind is essential for the proper development of the hybrid children, whose conception, "birth" and rearing is the sole apparent purpose of the whole amoral project.

Although witness reports are generally recovered by investigators using hypnosis, there is usually no difference between memories spontaneously recovered and those re-experienced under the guidance of a skilled and impartial hypnotic investigator. There is, undeniably, a danger of

confabulation and False Memory Syndrome, where the investigator is consciously or unconsciously influencing the subject's recall, and this must always be discounted if there is reason to suspect it has occurred. The findings of Professor John Mack of Harvard have been challenged in this respect, for although many of the details he reports from hypnotic sessions are entirely congruent with those of other investigators, some of his suggestions concerning developing relationships between humans, alien androids and bastard hybrids have received no support as yet from other investigators, and must consequently be considered suspect.

Nevertheless, for the achievement of the alien intentions previously suggested it would indeed be for them a logical step to find some way of becoming acceptable to at least some humans, who might be needed as allies in a final conquest of humanity. They cannot have failed to note that rejection by female abductees of the hybrid babies the aliens describe as "beautiful" was the normal reaction, despite repeated attempts to make these women believe themselves mothers of these listless children. If abductees can be persuaded that they are in fact alien souls in human bodies, then the recruitment of a subversive army devoted to the alien cause becomes a possibility. This is precisely what Mack, from his hypnosis of several abductees, claims to be the case: convinced of their alien identities, they now believe that achievement of the Phenomenon's purposes will be for the benefit of both races.

The only support forthcoming for this startling assertion comes from a single-witness case of 1973, when 51 year old "Elizabeth Richmond" (3) recalled some 18 years after the event her abduction in the Black Hills Forest of South Dakota, USA. Using a self-hypnosis technique, she claimed to recall that, after the usual medical examination, a taller being giving his name as Maag took her aside into a separate room and, grasping her hands and looking deeply into her eyes, told her that she was an alien who had been his partner and the mother of his two beautiful daughters. When he then presented them to her she was overcome by emotion, 'recognising' them and 'remembering' their names. Maag was pleased about this and told her that it was only because of the nasal implant they had just given her that this recall had been possible. He also told her that her alien soul had been inserted into her present body at the birth of her son when she was 22 years old. She embraced her 'daughters' warmly, and found them 'beautiful' without any urging. Mack might well consider this case to be an early forerunner of a process he now believes to have been perfected.

If it is true, as he suggests, that the ultimate purpose of the Phenomenon's breeding programme is the replacement of humanity on Earth by the hybrid race bred in the UFOs, then this is an outcome to which the human species can scarcely remain indifferent. Though Mack seems to think the bastard breed will contain the best elements of both its begetters, it could just as easily embody their worst, so why should mankind voluntarily abdicate in its favour?

If the android ufonauts who were the instruments of its creation were programmed to bring this about, then who could have written their program and loaded their operating system? Are they perhaps mere precursors, a fifth column infiltrating and preparing a takeover of Earth for the ultimate benefit of their begetters? And who might those begetters be?

When Presidents Reagan and Gorbachev spoke to each other of uniting in the face of alien invasion, could they perhaps have been given an inkling of such possibilities as the current activities of the UFO Phenomenon imply? Has anyone told Bill and Hilary? Time could be running out!

EXTRACTS FROM PETER ALEXANDER'S POSTSCRIPT TO HIS ORIGINAL
ACCOUNT

(Dated 7 February 1995)

I have since spoken to someone from the next village who, while walking with a friend, saw a very similar object in the sky a few days before, which behaved in exactly the same way that I have described. Gordon is aware of this person also, having been the first point of contact. Unfortunately the person concerned obviously doesn't want the matter taken any further and would only speak to me. (*And not to me when I phoned to follow up the individual's original report - G.M.*) I feel relieved to have spoken, because the description given to me of a large stationary object turning into a star and shooting off along the river very closely matches my own experience. I feel quite confident that this was a straightforward and truthful description of events.

It is now more than two weeks after the events I described and I still feel disoriented by it. Now that the initial excitement has also worn off, the incident is worrying me more than I would expect. I have what I can only describe as a dislocated feeling - I know I saw something but there is a dreamlike quality to it now, which feels almost like a mild form of amnesia setting in. It seems odd for the memory to be fading so quickly. I am very glad I talked to people more or less straight away and wrote as much as I could down while everything was still fresh and clear, I was so deeply impressed with what I had seen. The dark triangle was something that came only from my own experience; that is, before talking to anyone or reading about anything in any way similar. It also came at a time when UFOs could not be further from my thoughts - it is not even a subject that has particularly interested me.

This lack of outside influences is important, because I am convinced that what I saw could not be imaginary or suggested, but despite that it is almost as though something is blocking me from remembering this part of the incident clearly now. I almost feel I saw the triangle from a higher vantage point than I could have had from where I was standing in the garden. (*My emphasis. Was the witness lifted up? - G.M.*) There was something very special about that night and I can't explain this, but I have a very irritating feeling that there is more to remember about some point in time during the night, that I can't get at now for some reason. There is something missing or not right about it which is more apparent now. It really is almost as though the image of the triangle is all that remains from a period approximating to some sort of black-out. (*My emphasis again. A period of missing time is, of course, characteristic of an abduction. G.M.*) It feels as though there should have been more detail between the time of looking round from the glow in the garden to the time of bseeing the "star" shoot off. Instead, I have only this stark, dreamlike image of the triangle, but I have since heard of time displacement and in a way that I am finding quite disconcerting.

The trouble is, I can't even put it down to having read too many books, because the truth is, I haven't! I am just starting to grope around for some facts now, to help put this in perspective. In the past, I always assumed people who saw things just saw things. I had no idea there might be so many other ramifications.

CATTLE MUTILATIONS & THE GREYS

This information is controversial. You have been warned! Here's a scenario with respect to the aliens and their possible connections to cattle mutilations that may explain some of the questions people ask. I believe that, although the greys are very intelligent, they are implanted and mind controlled by other aliens (the Reptilians?). UFO ABDUCTION PHENOMENA AND TEMPORARY SCHIZOPHRENIA

Anyone who has read my articles about UFO abductions or heard my lectures on the subject will know that I support the theory that, though these abductions do not represent objective experiences, such reports are not fraudulent. Most abduction accounts, such as those from motor vehicles, seem to have quite different backgrounds.

Some researchers in the USA, England and Germany too, take the view that UFO abductions are subjective experiences generated by the witness. Werner Walter speaks of human fantasy projections symbolic of hidden archetypes. Ulrich Magin approaches the problem from a sociological viewpoint, while dismissing resemblances between UFO abductions and tales from various cultures about goblins. I think the psychological and psychiatric background, to which latent schizophrenia and the secret emotions evoked during the abduction experience are strongly connected, is very important.

If we keep in mind the classical abduction accounts, we find that they have a surprising number of features in common, as do the previous life-histories of the abductees. There is a tendency to a certain over-sensitivity, and perhaps also the ability to manifest occult phenomena. Sometimes drug addiction plays a part, bringing in the sociological aspect. In the American accounts we also have to consider the influence of the science fiction boom which has affected the world for the last half-century, also the cold war and the fears of a nuclear holocaust. Personal conflicts prior to their experience affect many abductees, and then they see in their neighbourhood or in the sky something which frightens them and is the trigger for their abduction experience. Often there is amnesia, which can be penetrated by hypnosis. The victim feels himself carried off under compulsion aboard a UFO and meets strange beings. Medical examinations mainly concerned with reproduction and the sex organs are carried out in low temperature conditions. Sometimes a syringe is inserted into the stomach. The abductee is given a message to pass on, and now the temperature is not so low. The Aliens have established their dominance, so that the extra-terrestrial race will be saved by cross-species breeding. Later the abductee is released.

Such are the usual details of a UFO abduction, and certainly in the victim's mind memories of total dread remain, though in time the emotional stresses of the encounter diminish through a process of suppression, during which the victim of schizophrenic recall remembers
....

That is how I have always argued, so far. I have spoken of a possible latent capacity for schizophrenia in everyone, one which in times of emotional stress can possibly break out in the period while the stress lasts. This is admittedly speculation, for such a process is unknown to neurology and psychiatry. Where is this inner self? How can a situation of stress or an emotional condition provoke a hallucinatory experience? How does it happen that a person in such a situation suddenly behaves like a schizophrenic?

I have no complete answer to this question, but I have put together a chain of logically coherent ideas about it. I have, however, a problem with one missing link.

Perhaps I have come a step nearer this missing link in recent months, since I occupied myself with the Theory of the Origins of Consciousness through the Bicameral Division of the Mind, by Professor

Julian Jaynes. According to his theory, in ancient times the human brain was organised in such a way that people's minds operated in two quite separate ways. A director and leader named God and a servant called Man lived together in the one brain. Man had his place in the left hemisphere (in which all speech functions were located) while God inhabited the right hemisphere where, in contrast to the left, no speech centre developed. Thus all important brain operations were established bilaterally and only the capacity for spatial discrimination was established in the right hemisphere. Jaynes says the two parts lived in mutual ignorance of each other's existence and he calls this human cerebral pattern the "Bicameral Mind."

Of course it is impossible to set out Jaynes' very complex theory of the two lobes in detail here; from simply reading this article the whole idea must seem almost incredible, so I must ask those interested in the theory to read his book and study his ideas, especially the weak points in the theory which might undermine the whole basis of his approach. I will try to set out below the main features of this Theory of the Origins of Consciousness through the Bicameral Division of the Mind.

Let us first go back in Time to when men first began to live in groups of about thirty members for social intercourse, which of necessity developed, according to Jaynes, at the time of the first ice age into an information exchange system. Speech, in fact, developed.

Let us now take a further step forward. Suppose a man is told to make a dam for fishing. He knows no "I", no personal consciousness for, if you believe Jaynes, this only comes later. So he cannot envisage it in his "inner eye" and has only the word itself as a reminder, which he repeats over and over to himself.

In time, all significant experiences the individual undergoes are stored in the right brain hemisphere, while in the left side (the more important) the speech centre develops. This explains why no speech centre arose in the right hemisphere, for the experiences were stored in verbal form, so that whenever the individual was in a situation where a decision was needed, then the previously stored knowledge from the right lobe would be expressed verbally and decide the choice of action. This store of experience, now also presenting itself in visual terms, becomes known to the individual as "God". On the neurological level it is so presented that the actual immediate experience, whenever it occurs, passes from the right hemisphere over the commissure connecting the halves of the brain into the left hemisphere as a form of audible hallucination, so that the individual hears what "God" is saying.

In a theocratically organised State it becomes important for the king to hallucinate the voice of God, or of several gods, and that his subjects in turn hallucinate the voice of their king. Whatever the king does, his subjects hallucinate the same sort of things, and in his voice. Thus it is logical for them to put food in the grave of a dead king, for if he can still speak then naturally he also needs to eat. When there is a new king, the voice of his predecessor continues to speak through him, and also through his successors.

That is how tribal life, the organisation of a culture, operated. As people increasingly came into contact with other cultures and found new experiences in wider contexts, they encountered different forms of behaviour. Other people's Gods gave different instructions, other people had different kinds of traditions. Man found himself the possessor of a subjective consciousness, for which at the time he was not really prepared, but he got used to it in the end. Thus the "Ego" of subjective consciousness, which was the antithesis of the bicameral mind, developed as an internal analogue of the exterior world through the power of speech. God was struck dumb or gave contradictory orders, and the subjective man was uncertain how to behave; his decisions were

undermined, his subjective evaluation of a situation and all the circumstances he could envisage were now controlled by the force of external events.

At the same time as all this was happening, the development of writing began to render superfluous man's auditory hallucinations, for he soon began to read written messages and had no further need of them. In the Old Testament God suddenly no longer gave his messages directly, but revealed them instead to his chosen servant Moses in writing!

At all events, the bicameral psyche becomes weaker, the auditory hallucinations fall silent and the individual increasingly asks himself why, when it had always been quite normal for the gods to give their orders directly, they are now in heaven, on Mount Olympus or some such place, to be addressed through prayer. The threshold at which the internal voices became audible was raised, so that such aids as self-hypnosis and drugs became necessary if one was to approach the gods. Later the voices of the gods could only be heard through the individual mediation of prophets, soothsayers and holy men; it became impossible for ordinary people to hear them any more.

Julian Jaynes believes that vestiges of the bicameral psyche continue to exist in the modern world and sets out his views in several of his books, including some on hypnosis and schizophrenia, which brings us back to our original theme. I quote Jaynes:

"Most of us live the greater part of our lives unaffected by these remains of the bicameral mind. Some of us hear voices once or twice in our lives, but in the case of just a few among us, as a result of a hereditary deficiency of the hormones which enable excretion of the biochemical waste products produced by stress, it takes the form of a very primordial and painful experience, the hearing of voices forcibly invading the mind and making the individual yield to them. At the same time, the boundaries of the self seem to become uncertainly defined, Time is dissolved away and the percipient does things without even knowing he has done them, as spatial consciousness begins to slip away. He feels panic, yet this panic does not really affect him, for there is no longer an identifiable self to suffer it. One could say that he no longer has anywhere to go; he has reached a dead end where he is no more than a mechanical puppet without motivation, subject to manipulation by inner voices not his own. He is diagnosed as schizophrenic, but in reality he has regressed to the state of the bicameral mind."

Jaynes himself marks this paragraph as "much simplified" and abridged. He stresses that it is only through schizophrenia that a partial regression to the bicameral mind can occur. He further states that schizophrenia arises from a failure to reduce stress, so that the pristine mind-set appears to return again. But as Jaynes had previously written, "Some people (not schizophrenic) do on one or two occasions hear voices..." The trigger that sets off the voices is stress, he says, and we recall that stress in the bicameral mind was decisive in awakening the "gods". In normal people this stress is relieved before the voices from the right lobe of the brain can manifest themselves.

According to Jaynes' theory, emotional stress can become so high that it cannot be relieved soon enough, and this brings us back to the UFO abduction phenomenon. How did this occur in the best-known case of UFO abduction? Betty and Barney Hill were a mixed race couple, which at that time was in itself a big problem. Barney was ill and anxious about his forthcoming surgical operation. Both had personality problems to overcome. Betty was unable to bear children. They lived in a fantasy world and Barney was an aeroplane-freak. They had dabbled in the supernatural and seen science-fiction films. All this was stored up in a rudimentary "hallucination centre" in the right brain lobe which, according to Jaynes' theory, related to the left brain's speech centre. They were driving along together when the clouds suddenly parted to

reveal the brightness of Jupiter; subjective consciousness overwhelmed the Hills ("Now what is that up there, and what can we do about it?"), so that a powerful charge of stress was built up, so great that it caused the "gods" to manifest themselves. The Hills had regressed to the bicameral mind-state, as other abductees have also done. They were no longer in a state of normal consciousness, had lost awareness of Time and were thus in a schizophrenic condition. So it is quite clear that both schizophrenia and hypnosis, which was first used in this case, both represent a regression to the bicameral state.

I remind myself how many abductees like Betty Hill have suddenly felt a trust and an attraction for the leader of the Aliens as their experience drew to its end. This is hardly surprising, for the "Alien" is a part of themselves, created from their own store of memories. Let me quote Jaynes' own words:

"The "gods" were in no way figments of the imagination, fictions of people's own intentional construction. They were wish-fulfillments originating from the nervous system, above all from the right hemisphere of the brain, in which the percipients met people who told them in intelligible speech what it was they had to do."

Hearing and obeying were, in the bicameral era, the same thing; but later, as consciousness developed, there grew up a divorce between hearing and obeying. God and Man became strangers to each other.

In every historical period people have tried by all possible means to invoke the "gods" again. Prayers, meditation, concentration on particular sacred objects or statues have all been made use of, and drugs too pressed into service to bring about the return of the "gods". Several UFO abduction cases (e.g. Sammy Desmond) have shown drugs to be a relevant factor where personality changes have been observed. Abductees have become introverted, occupied themselves with books about UFOs and the occult, for they were actually in search of something that has been lost, whether we call it bicameral function or, as is often the case, extra-terrestrial beings.

When, as Julian Jaynes asserts, godlike functions in the right half of the brain, effective even if yet rudimentary, are present, then the experiences of individuals from birth until they become ill, whether derived from sexual encounters or from the imaginative stimuli of fictional media such as films, will re-emerge when the stress level is high enough to release them.

In the light of this, it is not surprising that none of the many hypotheses put forward to explain the abduction syndrome is wholly satisfactory. The theory which claims the syndrome to originate in the bicameral mind is far more comprehensive, but unfortunately I must add that this theory too is only speculative and hypothetical, though none the less fascinating. I hope that research in this area will be intensively followed up, so that not only will all the UFO abduction stories be dismissed, but also that many other problems both past and present will be found to have been explained. But that is quite another matter ...



NEW AGE UFOLOGY

BEFORE WE BEGIN....

This is an attempt to set out the New Age understanding of the UFO Forces that visit our planet. It suggests a view of how and why the UFO Forces come to our planet, and also contains some metaphysical concepts concerning the reality of UFOs.

FOREWORD....

Too close encounters

Normal people whisked away by fear, anxiety

CATLETT, Va. — Clare Holcomb and Diana Graves say aliens grab them without warning, usually at dusk or out of deep sleep.

Sometimes a spaceship — the saucer-shaped vessel of B movies — touches down silently in a corner paddock of this Virginia horse farm.

Sometimes, "the beings" materialize out of thin air.

The "experiences" that follow are always terrifying, even though they've happened hundreds of times. Holcomb and Graves report pokes and prods by aliens deaf to their cries, skin excisions and forced feedings of unknown concoctions.

They talk of being plucked from bed and transported to "egg-shaped" rooms where they are probed with needles, about being impregnated by aliens who routinely "take" the fetuses and develop them in spaceship nurseries.


Afterward, they feel wretched for days.

"Every day or two you deny the whole thing. It's all going to stop because I don't believe it anymore," says Holcomb, explaining how she copes.

Holcomb and Graves sometimes question their sanity.

But people who report abductions or UFO sightings are not necessarily psychotic, fantasy-prone or more imaginative than anyone else, according to research reported in the November issue of the *Journal of Abnormal Psychology*.

Nicholas Spanos, professor of psychology at Carleton University in Ottawa, compared the intelligence, imagination and hypnotic suggestibility of abductees and UFO sighters with the general population.

The only difference he found between the two groups was that UFO-sighters believed that extraterrestrial life existed before they experienced aliens up-close.

The researcher's findings are old news and cold comfort to Holcomb and Graves.

"I'd be happy with (being) crazy," says Holcomb. "You can see a professional. There's medication to help you. I can't call 911 when I'm abducted."

Holcomb, 47, and Graves, 44, are among at least 1,000 people in the United States who claim to have been contacted by space aliens.

These people — 250 more each year — live in constant states of anxiety and depression, afraid they're crazy, afraid they're not.

Catlett, Va., seems a cliché setting for a close encounter of the third kind. This 2,000-population town is home of corn farms, orchards and country roads lined with old oaks.

Holcomb says her first abduction took place on a deserted road near the Moonraker Equestrian Academy, the farm where she lives and teaches horseback riding.

On Dec. 15, 1991, at 7:30 p.m., Holcomb was returning from nearby Winchester, Va.,

when a pair of low-flying bright lights demanded her attention. "I stopped the car and got out," she says. "This light was so bright I couldn't look at it directly. There wasn't a sound at all. The last thing I remember doing was blinking."

What seemed like a moment

later, Holcomb was driving five miles further down the road and feeling nauseated. She arrived home more than an hour later than usual, her ear lobes inflamed and bleeding, her pierced earrings inserted backward.

"I assumed I had had a nervous breakdown," she says.

The memory, which she retrieved about a year ago, sparked flashbacks of regular abductions — sometimes weekly, often with Graves — dating back to childhood.

"They seem to have an infinite variety of uncomfortable things they can do to you," Holcomb says.

"They've threatened that someday they'll take us and we're not coming back," says Graves, a policy analyst for the U.S. Forest Service.

Both have sought professional help.

A year ago, Holcomb consulted David Ruxer, a Fairfax, Va., psychologist who has treated a dozen UFO abductees.

Ruxer says abductees often display anxiety, depression and flashbacks.

"It's not really a post traumatic stress because it is an ongoing stress," he says. "This person is telling you it happened last night, it's going to happen tomorrow."

Ruxer says abductees come to him for hypnosis to recover suppressed memories, or for a safe place to talk.

When Holcomb and Graves first became aware of the abductions, they stayed close to home and close to each other.

"It's like being wanted by the police, hiding out with a new identity," Holcomb says.

Graves sets her jaw.

"We've made up our minds we are going to survive it, deal with it in whatever way we could. Ninety-nine percent of the time our lives have nothing to do with them. It's the 1% invasion that sure does mess up your life."

HARASSMENT

Quite a number of witnesses report harassment after their experiences. I have had a hell of a lot of this myself - a protracted reign of terror, in fact, that includes many provable incidents. A few days ago I got an incredible letter from a friend who was breakfasting with me at a hotel in New York two years ago. A business partner was accosted on a plane in February and asked questions about me by a person showing an NSA identification card. My home was broken into on May 28 of this year, a virus was put on my computer and a six thousand dollar cheque stolen. Ultra-high-tech electronics that involved the reprogramming of my alarm system's CPU were used in the break-in and the virus was extremely sophisticated.

These are only a few of the things that I've endured, and others have been much worse. My first run-in with the CIA came in 1983 when I was doing research for a book about mind control called BLACK MAGIC. Ironically, and to my own disgust, Wm. Cooper has accused me of being a CIA agent, which is utterly false. Budd Hopkins has said in lectures that I probably know more about what is going on inside the government than anybody, implying that I am somehow a part of the "inside"--I, who loathe the whole concept of insiders and consider official secrecy a crime against the Constitution.

I have written the whole story of these problems and will publish it in BEYOND COMMUNION. But I'm REAL interested in other witnesses who have been harassed. I know that there was a harassment panel at the Whole Life Expo in LA last year. Was anybody on this forum there? What was said? I am being practically beaten to death by this. Literally, in one case. About two weeks after I refused to help the CIA in '83, I was beaten almost senseless, and bear some permanent injuries to my diaphragm. Of course, I was never able to prove a connection. But when I went to the NYPD, I started getting death threats on the telephone, a nasty male voice threatening to pull my son's head off. He was just a baby then.

Attempts to follow up these calls with the NYNEX nuisance bureau and the police were unsuccessful, and no charges were filed as a result of the beating, although I was able to identify the assailant. I consider the secret government a costly, unconstitutional and downright evil enterprise that we ought to get rid of. Period. It has no business existing in a free nation like ours. No more CIA, DIA, NSA, NRO, or military intelligence beyond the battlefield, and throw open every single existing file to public scrutiny, without exception. Maybe it was OKAY during the cold war, but that's over. Lately, the harassment of Whitley Strieber has stepped up dramatically. Is this happening to others, too? Is somebody about to replace communists with aliens, because they are losing budget and credibility? SO - does anybody want to conference on the subject of harassment? If so, we could set a time in the next few weeks...
