A THOUGHT ON THE WILD SIDE

It is reasonable to expect that the solution to a high strangeness problem will itself prove highly strange; ufology would therefore be unwise to dismiss out of hand any evidence with a possible bearing on the human dilemmas arising from the existence of the UFO Phenomenon. That is not to say that all witness evidence must be accorded equal credibility, for obviously status and significance will only accrue when uncontaminated corroboration is found from other sources. Evidence must be evaluated and, so long as the sifting process is effective, no hypothesis, however incredible it may at first appear, need be excluded from consideration. In this issue our members will find several such.

We have long felt that physical scientists are the least suitable assessors to pronounce on the validity of evidence in a field requiring above all expertise in the comparison and balancing of witness statements, of which virtually all ufological evidence is comprised. A panel of High Court judges would be much more competent, since evaluation of witness accounts is precisely their peculiar skill.

Men have gone to the gallows on the strength of evidence far less compelling than the case which could be presented for the proven existence and activities of UFOs, and governments have acquiesced in the verdicts. Yet there is no court in which ufology can present evidence and no jury other than the open minds of those who think for themselves.

For the past half-century governments have actively colluded to suppress such evidence or to deride it. Control of the media made this possible, but the emergence of the uncontrollable medium that is the Internet has made possible the worldwide transmission of any kind of information, an opportunity which ufology has been quick to exploit by adding its own quota of garbage to the considerable quantities already there.

Among the dross, however, there may yet be gold: amid the weeds that almost choke them, flowers of truth may yet somewhere have bloomed. If so, the questing reader may seek them in our wilder offerings of this issue: we neither believe nor disbelieve where we do not know.

# THE HUMAN MUTILATION FACTOR

In the last forty years of UFO research, one of the most baffling questions that have plagued researchers has been "Is the UFO Phenomenon dangerous to humanity?" Over the years, there have been numerous cases where the phenomenon has figured into human deaths, but as a rule, most cases have been officially ruled accidental. When speaking of cases where death has resulted, usually most assume cases where military pilots have died as a result of "chasing" the phenomenon. One of the most famous of these military chases that is discussed when ever the subject of death and UFOs is raised, is the famous "Mantell Case". This case is so well known that I will not discuss it here, but there are many others. In one of the less well known cases, during the mid 1950's, a military jet interceptor was observed on radar being "absorbed" into a UFO over the Great Lakes. No trace of pilot or aircraft was ever found. In another case reported in the excellent work "Clear Intent" was the case of the "Cuban MIG Incident". In this case a Cuban MIG was locking on his weapons radar when the aircraft exploded in mid-air. The wing man was certain that the UFO had fired some type of weapon, but other than the jet exploding, no other smoke, flame or other obvious weapon firing was observed.

The matter of either overt or covert hostility on the part of UFOs has always been treated warily by serious researchers. On the one hand, if the enigma is hostile, then several questions must be faced. What if anything should the powers in authority tell the public? Is the government capable of handling a threat of this type? Is the public ready to face an issue as potentially terrifying as a "possible threat from somewhere else?" Other than incidents involving military involvement, have there been cases where civilians have been injured or killed during some type of UFO encounter? Is it possible that the reported cases of UFOs and their occupants abducting unwilling humans for some type of medical or genetic experimentation could be true? Now, if any of this is factual, then what ramifications does the Human Race face in light of the above?

According to Mr. Phil Imbrogno, during the research that led to the writing of "NIGHT SIEGE The Hudson Valley UFO Sightings" by Dr. J. Allen Hynek, Philip Imbrogno, and Bob Pratt, Imbrogno has stated that on several occasions, Hynek specified that he wanted no mention of the dozens of human abductions that they had already uncovered at that time, to be mentioned in the book. Hynek was afraid of the adverse publicity if word of this aspect leaked out to the public. After Hynek's death, Imbrogno stated publicly on Compuserve and other public forums, facts of abductions, animal mutilations, and EVEN several cases of mysterious deaths of humans, that he indicated COULD possibly be linked to the UFO Phenomenon.

While researching several stories for UFO Magazine, I interviewed a number of prominent UFologists, over the last

several months, and in each case, the question of human deaths, in connection with animal mutilations, invariably was raised. Most readers of this text will be familiar with Mr. John Keel, who many regard as the last of the Great UFOlogists. From the earliest days of modern UFOlogy, Keel has been a force to reckon with. The author of numerous books that address various aspects of UFOlogy, and magazine articles too numerous to mention, Keel has a unique slant on the subject that most will never experience. According to Keel, the phenomenon has always had an unexplained hostility towards humans, that have led to untold numbers of deaths. While Keel will be the first to explain that he rejects the ET hypothesis, he does not doubt the phenomenon a bit. In what many UFOlogists consider as one of Keel's best works "The Mothman Prophecies", E. P. Dutton & Co., Inc. 1975, Keel related report after report of animal mutilations involving cattle, dogs, horses and sheep, and also related what were called "vampire killings" of four humans in Yugoslavia, where the victims were "mutilated and drained of blood".

After having spoken to John Ford, the Chairman of the Long Island UFO Network, for a news story for UFO Magazine, I became even more convinced that the aspect of potential UFO hostility should be investigated. Ford relayed a numbing number of animal mutilations, human disappearances, human abductions, covert Federal involvement in areas that suffered high numbers of animal mutilations, and even armed military helicopters that chased UFOs over civilian communities. Ford, who is an officer of the Federal Court system, did investigations into the disappearances of mostly young adults over a year period, in areas of high UFO overflights, and after having several personal friends who were police officers of the local municipalities look into the situation, came to the conclusion that the facts were being suppressed. The reason given was that there was "no need to panic the public." Although no iron clad proof can be made for direct UFO intervention, the circumstances are extremely suspect.

After growing up in an age where the entire human race can be decimated by nuclear, biological and chemical weapons, the human race somehow manages to keep slogging on. I have seen more people "panicked" over a shortage of gasoline than imminent nuclear holocaust, yet somehow when the subject of UFOs crops up, the government doesn't want to panic anyone. It really makes me wonder what they know, that I should. I really don't think that they are going to talk to anyone soon, as you will see.

In January, 1989, it came to the attention of the MUFON State Director of Idaho, Mr. Don Mason, that cattle mutilations had occurred once again in the southeastern section of Idaho. After an investigation by a MUFON investigator, the facts were as follows. The animals ( two cattle, same night, but each owned by different ranchers) were "somehow" killed, sexual organs removed, body fluids drained, patches of hide "surgically" removed. All the appearances of what is today considered to be a classic case of animal mutilation. As of this date ( February 15, 1989 ) the final lab reports are not back yet, but already the Sheriff's Department has labeled it a "cult killing." No tracks, tire or human, around the animals even though it had just rained, no unusual activity reported by the ranchers that

evening, and one animal was found next to an occupied house. One of the ranchers admitted that this was the second time he had been "hit" by the mysterious mutilators. The last incident had only been a bit over a year previously, and they were worried enough that all had their "deer rifle" within easy reach.

After having been personally involved in an investigation of cattle mutilations as a police officer back in 1982, I was very familiar with the "cult" theory of perpetrators. The Idaho Department of Law Enforcement drags it out every time there is a new rash of mutilations. The problem is, and every one is aware of it, that no one has yet been brought to trial, or arrested yet for these crimes. Out here in the west, people know that you are flirting with a rancher's bullet if you are caught fooling around with the rancher's cattle. They are his livelihood, and he will defend it. Yet the mutilations keep occurring, and no one is any the wiser, or are they?

With the subject of animal mutilations fresh in everyone's mind, I was once again speaking to Don Mason, when he informed me that the investigator who had been assigned to the above mentioned case had come across a very mysterious death of a man back in 1979. According to the report, two hunters in the Bliss and Jerome area of Idaho had literally stumbled across the nude body of a man that had been hideously mutilated. The body was in the middle of nowhere, nude except for a pair of underpants; his sexual organs had been removed, his lips sliced off, and several other classic mutilations. Although he was in very rugged country, his bare feet were not marked as if he had walked in that terrain but yet no other tracks, animal or human, were evident anywhere. After the police were notified, an intensive search was mounted, and miles away, the man's possessions were recovered, yet no one yet knows how the body ended up where it was found, or even more importantly, what happened to him. It should be noted that this area also had over the years, many unexplained UFO reports and cattle mutilations.

Now I must explain that I had very mixed feelings about whether I wished to attempt to explore this subject any further, or allow sleeping dogs to lie. On the one hand, I wanted more than anything to discover just what was occurring, and on the other, I realised that this had the potential to backfire on someone who disturbed the status quo. I was familiar with reports of human abductions and mutilations that had surfaced in the last several years in reports such as the Lear documents, Grudge 13 reports and others, but yet I was not sure what I believed, or even if there was anything to believe. I ran across a friend who was still employed by a police department in this area and who was a detective. I had mentioned to him the recent cattle mutilations, and what I suspected in the above mentioned case of a human who had been mutilated. Scot had also been involved in the last several years with several cases of mutilations he had been called upon to investigate, always with negative results. He was as curious about this phenomenon as I was, and since he was still an active duty police officer, he had access to the department computer, to access the NCIC system that is maintained in Washington D.C. by the FBI.

After giving Scot the criteria for a search of unexplained human deaths, that involved factors of mutilation, I asked that the search go back to at least 1973, involving this area of the Northwest. Scot (not his real name) ran the request through the department computer. As he mentioned at the time, he had expected to get reams of reports back that we would have to wade through to get to the reports that would be our further study. Scot ended up requesting that the inquiry be run back to 1970, and involve not only Idaho, but also Utah, Nevada, Oregon, and Washington states. Because of the magnitude of this search, Scot stated that it would take about one week to get the results back into his department. As a side note, for anyone who is not familiar with the NCIC system, it is a national data bank for Law Enforcement agencies all across the United States.

It is maintained and controlled by the Federal Bureau of Investigation, at FBI headquarters, in Washington D.C. On the 14th of February, Scot contacted me in person, and appeared very troubled. His exact words were that "something is really screwy, Don." "I got the request back from NCIC on Monday, and there has gotta be something wrong. They told me that they had NO unsolved murders at all, zero, that met those criteria. THAT ANY FURTHER REQUESTS WILL HAVE TO BE MADE BY VOICE, TELEPHONE CALL, WITH PROPER AUTHORIZATION. Somebody is sitting on something, big as Hell." I also knew that something was as screwy as hell. After all, anybody that has had any dealing with law enforcement knows about the "Green River Killer" in Washington state. This serial killer is credited with at least 30 to 40 murders of young women, and to this date, the case is as big a mystery as ever. Many of the killings showed some types of mutilation, and if nothing else, at least some of these homicides should have shown up.

Once more, as a side note, I had been warned by a prominent UFOlogist, that there was a lid "screwed down tighter than you would believe in regards to human mutes." I also was warned that in order to break through the secrecy, was going to be a long and sometimes weary job, but that if enough persistence was applied, then it was possible to get to the bottom of this facet of the UFO enigma. Do I think that this can be solved, along with the rest of the puzzle? Yes, I do, because I think that the secrecy can only be maintained for so long, and then no longer. I also believe very strongly that only if the entire UFO community works in concert will this be accomplished, and the infighting and arguments MUST CEASE for the good of us all.

On the ParaNet system and on Compuserve, I wrote and uploaded a file entitled LIGHT.TXT, and in UFO Magazine Vol. 3, No. 5 I called for a UFO summit to be held in order to get the UFO community organized and to present a unified front. Only by a unified front, and calling for Congressional hearings, will this lid ever get torn off, and the truth that is suppressed be brought to the light of day. ## AN INTERVIEW WITH ZECHARIA SITCHIN

Question: What are the Earth Chronicles about?

Zecharia Sitchin: The first book, "The Twelfth Planet," refers to the probability that there is one more planet in our solar system. That there are twelve members, counting sun, moon and ten planets, not the nine we know of. That people from that planet came to earth almost half a million years ago and did many of the things about which we read in the Bible, in the book of Genesis.

But that was not my starting point at all. My starting point was, going back to my childhood and schooldays, the puzzle of who were the Nefilim, that are mentioned in Genesis, Chapter Six, as the sons of the gods who married the daughters of Man in the days before the great flood, the Deluge. The word Nefilim is commonly, or used to be, translated "giants." And I am sure that you and your readers are familiar with quotes and Sunday preachings, etc., that those were the days when there were giants upon the earth. I questioned this interpretation as a child at school, and I was reprimanded for it because the teacher said "You don't question the Bible." But I did not question the Bible; I questioned an interpretation that seemed inaccurate, because the word, Nefilim, the name by which those extraordinary beings, "the sons of the gods" were known, means literally, "Those who have come down to earth from the heavens."

CL: From the Hebrew word Nafal, which means "fall"?

ZS: Right. Fall, come down, descend. So, what did it mean? This led me to biblical studies and then to mythology and archeology and all the other subjects, including the study of ancient languages, which became my education and avocation. So, my research and my decision to write about it started with a question, Who were the Nefilim?

All the ancient scriptures, the Bible, the Greek myths, the Egyptian myth and texts, the pyramid texts, everything, led to the Sumerians, whose civilization was the first known one six thousand years ago. I focused on Sumer, the source of these legends and myths and texts and information. I learned to read the cuneiform Sumerian texts and came upon their persistent and repeated statements that those beings, whom the Sumerians called Anunnaki, came to earth from a planet called Nibiru. The planet was designated by the sign of the cross and Nibiru meant, "planet of crossing."

The question thus shifted in my research from who were the Nefilim and the Anunnaki, to, "What planet is Nibiru?" Forced to become proficient in astronomy, I had to learn enough about it to deal with the subject. I found out that the scholars were divided. Some said it (Nibiru) was Mars, which of course was described and known to the ancient people, and others said, no, it was Jupiter. Those who said it was Jupiter and not Mars, had very convincing arguments why it could not be Mars. And those who said it was Mars and not Jupiter had very convincing arguments also.

Being able to go directly to those ancient sources, clay tablets and cuneiform scripts, it seemed to me that neither was right, because the description of Nibiru and its position when it nears the Sun indicated that it could not be Mars, and it could not be Jupiter. And then one night I woke up with the answer: Of course, it is one more planet that comes periodically between Mars and Jupiter; it is sometimes nearer to Mars and sometimes nearer to Jupiter, but it isn't Mars or Jupiter.

Once I realized that this was the answer, that there is one more planet, everything else fell into place. The meaning of the Mesopotamian Epic of Creation on which the first chapters of Genesis are based and all details about the Anunnaki, who they were and who their leaders were and how they traveled from their planet to Earth and how they splashed down in the Persian Gulf and about their first settlement, their leaders and so on and so on, everything became clear! The Sumerians had immense knowledge. They knew about Uranus and Neptune and described them and they knew about Pluto. They were proficient in mathematics and, in many respects, their knowledge surpassed modern times. They said, "All that we know was told to us by the Anunnaki." The first book's innovation, its impact, was the realization that the ancient peoples, beginning with the Sumerians, knew of and described and spoke of one more planet in our solar system. It was not a discovery like that of Pluto in 1930 (of which the Sumerians knew six thousand years ago). Pluto was a very interesting astronomical discovery; textbooks had to be revised. But to the average person, the man on the street, it really made no difference. Nibiru, on the other hand, was a different story. If Nibiru exists, (and this is the planet that astronomers nowadays call planet X) then the Anunnaki exist.

So the existence of Nibiru is not a matter of just one more globe in our solar system. This is different, because if Nibiru exists, and the Anunnaki exist, then the Sumerian claim that they come back to our vicinity every 3,600 years, at which times in the past they gave us civilization, then we are not alone and there are more advanced people than us in our solar system.

CL: What will happen next time around?

ZS: Who knows how they will feel about us when they come back? Will they decide to give us more knowledge again, and more technical advancement and more civilization, or will they decide that we are no good, as happened at the time of the Deluge, and try to get rid of us?

So, the first book, laying the foundation and describing Sumerian knowledge and concluding with the existence of one more planet is really the key to understanding what it is all about. What the tales of Genesis are, what the tales of creation are, what our past was, and in a way what our future will be.

CL: And the second book in the series?

ZS: "The Stairway to Heaven," looks at the tales of ancient times, primarily from two new aspects. One was to bring the Egyptian texts and mythologies into the picture and show how they fit with the Sumerian [texts] and what they really meant. The second was to look at the issue of Man's search for immortality. And this ties in with the Sinai, it ties in with the landing place, with the spaceports in the Sinai Peninsula, the role of Jerusalem and all that.

The third book, "The Wars of Gods and Men", continues the story and shows what happened after Kingship, a new phase of civilization, was given to mankind, dealing with the conflict that began with the rivalry between two half brothers, Enlil and Enki. It relates how this conflict continued among their sons and their grandchildren, leading to actual warfare which I call the Pyramid Wars (there were two) in which, eventually, mankind became involved. That is how mankind learned to make war. And this deals with a moral or theological subject: Is man a warrior by nature, or was he taught to become a warrior?

Book Four, "The Lost Realms," is the tale of the Americas. Not just what they call pre-Columbian times, but four, five thousand years ago, which was before the Incas, the Mayans and the Aztecs. Who really was in the Americas, how ancient are some of the antiquities and how were such incredible megalithic structures built? What for, How come, and by whom? "The Lost Realms" shows that it is part of the same story, that the same Anunnaki brought mankind or part of mankind to the Americas. Book Five, "Genesis Revisited", a companion book, was really written because in the fifteen years since the first book was published, there have been many scientific advances, especially in astronomy and all the discoveries of the Voyager Spacecraft, in geology, biology, the discovery of DNA, the ability to create babies in a test tube, linguistics, and [in unlocking the secrets of] the origin of languages. Each such discovery corroborated what the Sumerians had known and had written, and therefore fully confirmed what I said in my first book. And each time there was such a discovery I would literally jump out of my seat and say, "My god, this is exactly what the Sumerians said six thousand years ago!"

If you read the relevant page in *The Twelfth Planet*, you will see that I quote a Sumerian text that says exactly how the Adam, the first *Homo Sapiens*, was created. You will see that this is a process that today we call the test tube baby process. I quote a text that describes Uranus and Neptune as Voyager 2 saw them in 1986 and 1989. I finally sat down and put together all this scientific evidence, all these scientific discoveries to show how they match and corroborate ancient knowledge. Hence the subtitle of "Genesis Revisited" is "Is Modern Science Catching Up With Ancient Knowledge?" So, this is a review of the five books.

CL: Astounding work. And it all started with the word Nefilim?

ZS: Yes. That was the beginning.

CL: Might people read your books and say, "Well, he's doing a lot of presuming. He's got fragments of tablets, and pieces of cuneiform, and he's taken many liberties in piecing together the stories?"

ZS: There are several different answers to that. The best answer is what I brought out in "Genesis Revisited". The knowledge that we have acquired corroborates what the Sumerians knew six thousand years ago. You wonder how is it possible, how could they know? How, as another example, could their symbol of the entwined serpents, that we still use today to denote medicine and healing and biology, be 6,000 years ago, the symbol of Enki, who engaged in genetic engineering to bring about the Adam? That was a symbol of the DNA, the double helix of DNA.

How could they know without telescopes and spacecraft that Neptune is a watery planet? They provided the answer by saying "All that we know we have learned from the Anunnaki". So, you say, "Ok. There were Anunnaki." Now, who were the Anunnaki and where were they from? The Sumerians say, "They came here from Nibiru." And you say, "What is Nibiru?" So they say, "It is one more planet in our solar system." Now, if you say, "I'm really impressed by the Sumerian knowledge, and, maybe they knew what they were talking about regarding the Anunnaki. But I don't think there is another planet with these advanced beings on it near Earth." If so, what is your explanation of who the Anunnaki were? Was there really a race of giants who existed on Earth half a million years ago? Do you believe there was a civilization on Earth half a million years ago that surpassed our own and disappeared? When the focus shifts to explaining those other people, you have no explanation. I then say, if you have no explanation, why not accept the word of the Sumerians?

The second aspect of the answer is this. Nowhere in all these books do I use a text, or do I refer to a tablet and say, "I went to this or that place in the Near East and as I was visiting that place, I shifted the soil with my foot or with a stick and look what I found! I found this tablet and look what it says! It says that there was somebody called Enki who travelled from Nibiru to Earth and splashed down in the Persian Gulf". No, nowhere do I say, "Look what I found." All the time I say, "There is a tablet in the British Museum, its catalogue number is such and such; it was discovered in this and this place; the text was first published by this and this scholar, here is what it says." All the information, all the sources that I am giving, are academically, scientifically, scholarly known and accepted sources. At no time do I invent my own source.

CL: Just in "The Wars of God and Men", the sources you list take up almost 16 pages!

ZS: The difference is, and this is the key difference, that when there is a text, for example, that describes how Enki came to Earth and splashed down, the scholars, the text books, call this the "Myth of Enki and the Earth." Another text that deals with Enlil is called the "Myth of Enlil" and whatever the subject is. All these texts are called by scholars "mythology." I say: What if this is not a myth, what if these texts tell us what really took place? From that I created the scenario, a plausible, a logical scenario that explains so many of the enigmas and the puzzles and the mysteries which otherwise remain enigmas, and mysteries and puzzles. Like, who built the pyramids, what for, etc.

CL: What more can you tell us about the Anunnaki, and do we have free-will or is it all determined by these same Anunnaki?

ZS: I'm asked, "Do they look like us?" and I say, "No, we look like them. They made us through genetic engineering. They jumped the gun on evolution, and made us to look like them physically, and to be like them emotionally." That is what the Bible says: "Let us make the Adam in our likeness and after our image." Physically, outwardly and inwardly, so much of what they are, we are.

There is a tremendous difference in the lifespan, which is the cause of the notions of their immortality. Because one year to them is one orbit of theirs around the sun. So, one of their years equals three-thousand-six-hundred of ours. This is the key difference between us and them. Then there is the difference in their technological advancement which enables them not only to travel in space, and to have travelled half a million years ago, but also to revive the dead and do other things which in biblical times were considered miracles.

I feel that just as they came to earth and created us through genetic engineering, and mixed their genes with those of Ape-woman, that one day we will go out in space and land on another planet somewhere and do the same thing. In this sense, I believe things are ordained in a grand pattern.

But can events within this grand pattern be determined by individuals? I think so. Take the story of the Deluge and the destruction of mankind and the saving of the seed of mankind, through Noah and his ark. Enlil decided to use the opportunity of the avalanche of water to destroy mankind, while Enki told Noah, (the Sumerian Ziusudra) about what was coming. Enki taught Noah how to build an ark and cover and seal it so it wouldn't be swamped, and Noah was able to take himself and his family and others, according to the Sumerians, into the ark and save the seed of mankind. Here you have a conflict between two leaders of the Anunnaki. One felt one way and one felt another way. So the question of free choice, of what is right, what is wrong, what should be done, what should not be done, is there all along.

CL: What about the theory that we are the gods of before? That we created mankind and now are at the effect end?

ZS: All I can tell you is that I see my task, or maybe my mission, to bring to the knowledge of people today what the ancient people knew and believed in. To do so by being able to go to their sources and their writings and their depictions, and treating that material not as a myth but as a true story. Now, my writings have become a basis of quite a substantial literature. There are two dozen or more books that are based on my books. These are in theology, astrology, and so on and so forth, and I am sure there are many more about which I don't know. They refer to my writings or are based on them. I provide the facts as I see them, and everyone is free to interpret them as they wish.

CL: That's the scientific way of looking at it, which makes your work even more credible, That means you're not making guesses, you're going by the actual evidence that exists.

ZS: Yes. I am pleased that many have used this material as evidence, to build on it, to expound on it in various directions. Without saying whether I agree or disagree with the other theories and developments, I am very happy that my books have become text books about ancient times.

CL: You said when Pluto was discovered, in 1930, text books were rewritten to accommodate that fact. Has anyone or any textbook publisher done the same with this information?

ZS: It takes time, but it is beginning to filter through.

CL: When is this thirty-six hundred year cycle due again?

ZS: Well, you have to reach your own conclusions.\*

CL: If every time they came back they taught us something new, and advanced our civilization, do you have a theory what their next step for us might be?

ZS: No. As I said, one time they didn't give us any civilization. They tried to destroy us. So, I don't know what the odds are.





## OSCAR'S STORY - UFO CRASH RETRIEVAL

...The eggs had their typical lack of firmness and the sausage tasted more like greasy rope than pork links. The order to mobilize saved me from this breakfast experiment. We proceeded down six flights of stairs below the COMTRAPAC submarine base in San Diego to 'shoot-the-tubes.' After placing a few pieces of jewelry in a container I climbed into the cylinder to travel the tunnels to an unknown assignment. I wondered what was so important to upgrade our pay from E-3 to E-6 before we left and besides that, we could not even finish breakfast.

As I am told of our departure, a familiar uneasy feeling comes over me. When you push down on the accelerator in your car, you can feel the tug of inertia sinking you into the seat. When you travel the tubes there is no feeling of motion but you know when the door opens you will be in another place hundreds, even thousands of miles away. For some comfort I checked to see if the watch hidden in my pocket was still there. I quickly look to see if it is still running. It seems to be working normally, so why no jewelry? Because of electrical charge buildup perhaps?

The soft clang of the door opening made me tense again. I did not even feel us stop! Peeking at the watch, I noted only 30 minutes had passed. We must be in California, Nevada or Arizona, I thought. As I stepped from the windowless capsule I heard a military policeman murmur: "Turner's Rangers." Our reputation had preceded us. As I readorned my jewelry the first surprise of this assignment was about to come.

A high-ranking Naval O.S.S. Officer informs us that we will not be allowed above ground while in North Dakota. NORTH DAKOTA! Several of us were led to a large hangar-like room that had been quickly set up to function as a laboratory. Resting on heavy jack stands in the middle of the room was a large disk - shaped craft. The chief scientist present was introduced as Professor Bear. As his briefing and some discussion proceeded, I rapidly developed rapport with this talented, open minded and gentle man.

The craft had crashed near Phoenix, Arizona and was moved to this North Dakota base. Two dead alien bodies with fatal radiation exposure were found outside the craft. I reflected on my O.S.S. Training for crash retrieval and remembered thinking: "Why bother, we will never get a chance to be involved in anything that exciting." Well, not only was I involved, I was the security team leader. This meant that when the craft was opened I would be the first one inside! After all, one does not send in a high ranking officer or a chief scientist to possibly encounter an alien booby trap or extraterrestrial virus. Come to think of it, the prospect did not excite me either. As Professor Bear prepared his ultrasonic sound generators for opening the craft, my apprehension turned to intensity; after all, this was what my training was for.

As "The Bear" tuned his equipment, the smooth solid metal surface of the craft began to ripple like when you throw a stone in the water. When the ripples seemed to gain harmonic stability the now liquid metal parted in a circular iris-like fashion. As I stepped inside I noticed a fresh pine scent and a strange smoothness to everything. The interior was rounded off and continued with no seams or rivets. It was as if the walls, floor and ceiling were formed out of one piece of metal. Even a table in the center of the craft

looked as though it had been pushed up out of the floor. What appeared to be control panels had no knobs, switches or dials. There were strange symbols highlighting these futuristic yet simple consoles.

The outside of the craft had no apparent damage, yet the interior showed some distortion, possibly from the crash. Next to one of the panels I could see something that would challenge my training and change my perceptions of reality forever. The craft was just another piece of hardware, but seated next to the panel was a human! Its gender was obviously male. Aside from his unusual dress, he could have walked past you at a grocery store and not command much attention. Upon noticing some injuries about his head I instinctively and quickly moved toward him to help. His skin was a bronze color, reminiscent of Mediterranean or South American cultures. His hair was similarly brown and very short in a Roman or crew style cut. The only real difference in appearance from earth humans were that his ears were slightly pointed. He reminded me of pictures of Quetzalcoatl, the deity of the ancient Toltecs.

He was conscious and in great pain. One leg was partially pinned by the shifting interior. I was examining cuts on his cheek and lip when I first touched him. An overwhelming feeling of compassion came over me as I heard his voice in my head. I could understand him clearly even though his mouth did not move. The communication was strictly telepathic.

I perceived his fear of being harmed and told him that I would not let anyone hurt him. Suddenly, a voice from the doorway refocused my attention on the duties at hand. I called back that we had a live one. The craft filled with gloved and masked medical personnel to help free the occupant. He was quickly carried outside and placed on a gurney. I remarked that he felt heavy for his size and a few others that had assisted agreed. As the alien was whisked off for medical attention, Professor Bear examined the inside of the craft. He found what he thought was a star map depicting the constellation Eridanus and wondered if that might be where the alien was from. After a brief discussion concerning the nature of the communications, Bear asked me to accompany him to the medical lab. As we talked along the way I referred to the alien being as 'Hank.' The professor asked if that was the name the alien had given me.

I explained that it was not and that I had chosen that nickname based on its native American reference to a 'troubled spirit.' The professor smiled and said, "Hank it is," and the name seemed to immediately stick. In the antiseptic, impersonal medical room Hank's discomfort was compounded by his complete undressing. While still in great pain he was examined from head to toe. No stone was left unturned, so to speak. They treated him as if he were a baby of some rare animal species being first born into captivity. It became evident that Hank could not communicate with everyone involved so I was asked to be translator. I had no trouble understanding that the normal anesthetics we were administering had little or no effect. Suddenly, with Hank's discomfort still a concern, everyone's attention became divided between the being and a new person arriving on the scene.

This new person was obviously important yet seemed to make everyone uneasy. Even Hank recoiled in fear when he came close. ## UFO 'buzzed' airliner

A BRITISH Airways passenger jet had a close encounter with an unidentified flying object while landing at Manchester airport, an official report disclosed last night.

The Boeing 737, with 60 people on board, was overtaken at high speed by a wedge-shaped craft as the plane descended through 4,000ft on the final stages of a journey from Milan.

A long inquiry concluded yesterday that they could find no likely explanation. The three previous reported sightings also baffled the CAA experts.

The incident happened at 6.48pm on January 6 last year with the aircraft just above the clouds and visibility at least ten miles. Then air traffic controllers had the following conversation with Flight 5061:

B737: "We just had something go down the right-hand side, just above us very fast."

Captain Roger Wills reported that the UFO, which was emblazoned with small white lights and possibly a black stripe down its side, flashed silently down the side of the jet so close that his co-pilot, First Officer Mark Stuart, involuntarily ducked as it went by.

There was no sound and no wake but both pilots were so concerned that they filed a formal "airmiss" report. The Civil Aviation Authority launched an investigation, the fourth such incident since 1967, and after a year-

Manchester: "Well there's nothing seen on radar. Was it an aircraft?"

B737: "Well, it had lights, it went down the starboard side very quick."

Captain Wills and First Officer Stuart are certain that the object was solid and not a balloon, a model aircraft or even a military Stealth aircraft which the captain had seen before and would have recognised.

Both pilots should be commended for their courage in submitting a report, the investigators said.

## REPTILIAN ALIENS

Some sources have indicated that Reptons or 'Lizard Like' beings have been seen in deep underground tunnel networks below the general southwestern areas of Albuquerque (especially Dulce and San Cristobel), New Mexico; Las Vegas (especially Groom Lake), Nevada; Salt Lake City, Utah; and within caves in the Black Mountains between Las Vegas, Nevada and Kingman, Arizona -- among other areas. These creatures have also been encountered, sources allege, in deep underground installations below the Mojave Desert region of California... and even on the fringe of the desert itself near Lancaster and elsewhere. In many cases they have been seen working closely with the 'Greys', who regard these Reptons or 'Lizard Men' as being their superiors.

Researcher Michael Lindemann of the '20/20 GROUP' related the following in a public lecture in Lancaster, California, concerning a woman who had experienced an 'abduction' by the alien group known as the Greys, on the outskirts of the Mojave Desert:

"...Lots of ordinary citizens in the Lancaster area...are having close-up alien encounters... the first one is a woman with a number of children who in 1972 was living with her then husband in Ridgecrest, California... This woman had never read any books about UFO's or aliens, and didn't have any interest in it. Indeed today she has not read any books. The first thing she tried to do recently when she realized that she had had alien encounters, was she went out and rented Whitley Strieber's movie 'COMMUNION', the video tape, and she stuck it in the machine and barely a minute into the movie she got very anxious and nauseous and ran out of the house. That was her only attempt to inform herself on, let's say, literature or information about aliens, and yet this woman has had astonishing experiences."

Following an entirely waking experience where she saw a seemingly half-physical or apparitional 'Grey', near her home which faced the open desert (the nearest neighbor being about two blocks away), she began having more intense experiences which she knew took place - but could not entirely understand or recall. She described the creature in the traditional 'gray' configuration described by so many other 'abductees' -- short gray with a large head and large black slanted eyes -- which in light of her ignorance of the overall UFO phenomena, according to Lindemann, only tends to substantiate her story. As a result of this initial experience, Lindemann explains, she contacted a hypnotherapist, a woman who incidentally had never read a UFO book herself. This psychologist concluded -- through various tests and observations -- that the woman from Ridgecrest was entirely sane and sincere. Michael Lindemann continues:

"...This woman has had lots and lots of experiences since then. Her next experience was also a waking experience which TURNED INTO an experience that she could not remember except through regression. But the 'waking' part of it was the 'clue' that she needed to start exploring her hidden memories.

"Her husband went off on a training program, he worked for a telephone company, (and) went off on a training program for a number of weeks some time later, toward the end of 1972.

"She was staying at home with her children. Of course because they were in an isolated spot, she slept in her bed with a loaded shotgun, and she was a very light sleeper, kind of nervous.

"One night she woke up because there was 'rustling' in her room. She looked and she saw what she thought was a sort of hooded, black figure over by her dresser. It looked as if somebody were sort of 'playing' with her jewelry box. And she of course felt as if someone had probably broken into the house.

"But as she was kind of thinking to herself, 'What can I do, what can I do,' kind of gripping her shot gun, she made a little involuntary gasp, and whoever it was turned around and walked over to her.

"She described this being as about...4 1/2 feet tall, very, very dark, with very... she said it looked like a lizard! Very rough skin, big yellow eyes...not the huge black almond shaped eyes...large, yellow with a slit iris, a muzzle, teeth. She said it looked like an iguana. And she said that IMMEDIATELY she could tell that this being was very menacing and didn't like her at all. This being was dangerous and nasty, and not to be trusted.

"She didn't remember what happened next, all she knew was she was terrified, because this being was literally leaning right into her face as she lay there in bed.

"And in regression she found out the rest of that particular story. She was floated downstairs and she found that some GREYS were PHYSICALLY CARRYING her three children outside to a waiting craft. She was levitated outside to the same craft.

"She recognized immediately that this black lizard-like guy, which she later learned actually had a tail... was actually WORKING WITH THE GREYS, but, she said, they did not (always) get along. It was the 'Greys' craft... she was literally 'listening' to their

'telepathy'. They were conversing about her as she was lying on a table in the craft waiting for their decision on what to do. She became convinced that the black one wanted to KILL her, and the Greys were 'saying'... 'No... not on OUR ship.' She said she saw something horrifying at that point. She said the black one just 'swept' its hand across the chest of one of the greys and literally tore the grey's chest open. It fell to the ground and she thinks it died. She says, 'I know they have GREEN blood, I saw it bleed.'

Before one feels too sorry for the greys, one should understand that many accounts indicate that the greys have participated in unknown numbers of animal and human mutilations in order to use the animal AND HUMAN secretions as a 'liquid protein' food source. And if we are to believe some of the more fantastic accounts of crash-retrievals, such mutilated animal and human organs have been discovered within or among the debris of crashed GREY craft. The 'reptilian' hierarchy seems to operate in an exactly opposite manner as the Judeo-Christian ethic, and instead of operating on faith, love and service the reptilian or sauroid hierarchy is said to operate on fear, hatred and competition. Since both the Greys and lizard-like 'aliens' operate on 'collective consciousness' and are neo-saurian in nature according to many sources, and since they have a similar agenda which seems to be imperial-conquest motivated, they inevitably work together in what Michael Lindemann calls a 'wedding of convenience'.

From one perspective, one should NOT see the 'iguanas' as being much worse than the greys. For what the green-blooded 'greys' lack in the way of demoniacal 'hatred' or contempt for humankind, they seem to make up in their profound 'indifference' to the human race. Over and over again abductees describe the greys as emotionless and methodical, and seemingly show no sympathy or pity whatsoever toward human suffering or death, but merely look upon it with scientific 'curiosity'. Although 'hatred' would seem to be the opposite of 'compassion', others would argue that 'indifference' is the antithesis of compassion, caring or love. From this perspective, 'indifference' to human life may be no less evil than raging 'contempt' for human life. BOTH may be the motivating factors behind all kinds of atrocities.

In reference to the case referred to above, Lindemann continues:

"...Her hypnotherapist said to us at this point, 'You know, you really ought to understand that this woman is a very, very good hypnotic subject and she actually re-lives her experiences in real time in the first person. She goes through all of the emotions and she has incredible recall of detail.' ...she says...as a therapist of long standing she has no reason to doubt that the detail that this woman brings forward is essentially accurate. It matches of course in many, many particulars the kind of information that other abductees have also told.

"...One of the other disturbing things that this woman has mentioned...is that in other sessions where she was abducted, she found herself in an underground facility which she feels quite certain was at George Air Force Base where she grew up. And in that facility underground she saw the greys were working side by side with human military personnel. And we do have other reports, not only 'we' but many people who study the abduction phenomena, collective reports indicating that the abduction phenomenon is occurring right under the noses of our own officials, that there is apparently some agreement operating here..."

The above account would seem to confirm that the SAURIAN GREYS (which are basically neo-saurian or reptilian in configuration according to alleged government autopsies) are being used by their larger reptilian superiors as the 'technical brains' behind some hidden agenda, and as a type of cosmic 'double agent' race. Numerous accounts indicate that the Greys are subservient to the larger 'Draconian' entities and, because of the OUTWARDLY less-intimidating though nevertheless frightening appearance, the greys are used to 'interface' with U.S. military personnel. Also, many individuals within 'deep' military organizations have since come forward and implied that the 'Greys' used these interactions to establish foot-in-the-door treaties with the Military which were never meant to be honored, but were used only as 'platforms' to get control, via implantation and so on, of sensitive government-military personnel. The Greys are said to have used deception profusely to get their way. Part of the reason why the 'agreements' continue even after the 'Grand Deception' was discovered, some suggest, is simply because the greys have 'taken over' the minds of certain officials in high government positions. This continued 'pact' with the serpent race may also, in part, be explained by the malevolent influence of the 'Jesuit-Illuminati' or the 'Serpent Cult' in certain policy making groups such as 'MJ-12', the Jason Society, etc.

The following article describes what might be a similar group of beings as the 'Lizard Men' described earlier, although these creatures seem to have been somewhat more human-size in their configuration and apparently intent on passing themselves off as human-like entities. The account appeared in the Omaha, Nebraska 'METRO UPDATE' for Oct. 29 - Nov. 4, 1990. Written by reporter Patricia C. Ress, the article was titled:

#### LINCOLN MAN RECOUNTS ABDUCTIONS BY ALIENS

"People have been talking about flying saucers for about 45 years now --longer if you count the reports of the so-called 'foo fighters' seen by pilots on both sides during World War

II. But within the past 20 years we've been hearing more about a more frightening side to these visitations - abduction by aliens.

"The most famous case was that of Barney and Betty Hill, two New Englanders returning home from vacation and unable to account for a large block of missing time. Under hypnosis, a very frightening and detailed account of alien abduction emerged. Later there was Betty Andreasson, who told of aliens who took her through walls and closed doors.

"Then came Budd Hopkins, who made a study of such abductions and chronicled one case in 'INTRUDERS-THE INCREDIBLE VISITATIONS AT COPLEY WOODS.' Next came the 'Gulf Breeze Sightings' in Florida, and most recently author Whitley Strieber's accounts of his own abductions in his books 'COMMUNION' and 'TRANSFORMATION.'

"While most of these abductions took place in the East, some say that visiting aliens have been just as busy in the Midwest -- even Nebraska. A Lincoln man recently recounted his experiences during a talk at the Oakcrest Institute in Elkhorn.

"John Foster has been an engineer in Lincoln for a number of years. Lincoln, in fact, is his home town and the place where his abduction experiences began back in 1950. A soft-spoken down-home type of man, Foster reminds people of a young Joel McCrea.

"'Alien abduction is a terrifying and traumatic experience,' Foster told the audience. 'Psychiatric counselors don't know how to deal with this - even if you can get them to believe you.'

"Foster has gotten help and understanding from people like Dr. Leo Sprinkle of the University of Wyoming, who has dealt with numerous alien abduction cases. He also has been the subject of ridicule and rejection by both family and friends.

"'Often in a UFO abduction experience, things happen that are absolutely unbelievable. I have been told that IT IS NOT UNCOMMON FOR FAMILIES TO BREAK UP AFTER SUCH AN EXPERIENCE. I finally reached the point where I no longer care what people think of me.' Foster said.

"He said he wasn't fully aware of what had happened to him over the years until the 1980s. In 1981 he was sitting outside his home in Lincoln with a friend and on a lark, they both said a prayer (or incantation?) that they would see a flying saucer and soon after, one appeared, he said.

"On another occasion in March, 1966, he saw a light out behind the trees as he sat on his patio, he said, and the sight triggered a distant memory of something that had happened to him when he was in grade school in Lincoln in 1950. He said 40 or 50 people were outside watching a movie when swirling lights suddenly appeared, ALONG WITH A CRAFT THAT INITIALLY LOOKED LIKE A HELICOPTER.

"Foster recalled being INCAPACITATED AND FEELING STRANGE. He said he saw a craft appear WITH THREE LITTLE MEN who appeared to be fixing it. He felt an overwhelming desire to get inside the craft, but once he did, he discovered it was in a different form. 'We got a lesson about history, mankind and something about Indians and buffalo,' he said. When he looked around him, he noticed that everyone else seemed to be FROZEN IN TIME. 'They all looked like statues,' he said. He saw a woman who told him she had FIXED HERSELF UP SO THAT HE WOULDN'T BE TRAUMATIZED.

"He said he was taken to an examining room BY CREATURES THAT LOOKED 'LIKE FROGS OR LIZARDS.' The 'woman' told him they were the educators and would supervise his learning experience, he said. Among other strange things, Foster recalled THAT THE LIZARD MEN ENCOURAGED HIM TO JOIN A MASONIC LODGE.

"In October 1986 Foster went camping with his wife and children at Niobrara Park and he had a short visitation which awakened more memories of previous abductions, he said. By mid-December he recalled 50 abduction experiences, and by January that number had grown to 2,000 and by January 1987, he had recalled 3,000 abductions. Foster has recorded memories of 50 of the abductions in detail, and another 450 in short notations."

# THE NEW WORLD ORDER?

## INTRODUCTION

According to John Lear, William Cooper, and several other researchers the U.S. government may have made a 'pact' with a non-human race as early as 1933. According to some this 'race' is not human as we know it, yet it claims to have its origin on earth several thousands of years ago. Some sources allege that this predatory race is of a neo-saurian nature. This has led others to suggest that the dinosaurs which ruled the surface of the earth in prehistoric times may not have become entirely extinct as is commonly believed, but that certain of the more intelligent and biped-hominoid mutations of that race developed a form of intellectual thought equal to or surpassing that of the human race, and then possibly went into hiding. If such an inhuman and alien race exists, then these genocidal 'policies' which the Illuminati - Club of Rome is carrying out no doubt originated from them. As William Cooper has stated elsewhere, whether the aliens exist or not makes no difference, since the idea of the existence of a non-human alien race is part and parcel of the Illuminati's one-world totalitarian plans. This has been confirmed by several researchers. With this introduction, the activities taking place at such underground installations as the Pine Gap Facility may be better understood.

From Dr. Jean Francois Gille, who moved to Albuquerque, New Mexico from France, comes a translation of a French document that exposes the relationship between several factors in the matrix of world affairs. The article, titled - 'PINE GAP BASE: WORLD CONTEXT', was written by Lucien Cometta and later translated into English by Dr. John Gille:

"In order to understand the case of the Pine Gap US base (near Alice Springs, Australia) better, I feel compelled to give some explanations beforehand. I hope these explanations will help to increase the general awareness of the extraordinary importance that facility has for mankind as a whole.

"The majority of people, all over the world, are not lingering in doubt as to whether UFOs and ETs are real. They know they are real. Here in early 1989, no one questions their existence. The case for UFOs and ETs aroused passions, controversies and disputes for many years. Some of it has not been quite rational. The matter being relatively settled, public opinions should cool down. It is with a serene and clear mind that we ought to be thinking of our future relationship with the peoples from space. However, the public mind is not at peace. It vaguely feels that the governments are hiding "something real big", and it wonders where our leaders are going to lead mankind.

"During the process of research and study of UFOs and aliens, researchers who do not take the explanations of the scientific establishment at face value have discovered unsettling facts; these facts have started the lifting of the lid of the coverup. The value and prestige of their

sources of information do not leave any doubt about the truthfulness of these reports; the main outlines are summarized below.

#### PINE GAP

"The United States has three major bases in Australia. One is in South Australia (Nurranger, near Woomera, T.N.), another in New South Wales, and the third (and by far the largest) is located within about 230 km (143 miles) of the geographical centre of the continent, not far to the west of Alice Springs (Northern Territory), at the foothills of the southern slopes of the MacDonnell Range. This base is completely underground, with barely visible entrances to the surface.

"This 'Top Secret' base is entirely financed by the United States Government, and is officially known as the Joint Defense Space Research Facility.

"When the JDSRF was first initiated, its aim was scientific research for the supposed development of a space defense technology. It is now known that since its inception, its primary purpose was research into electromagnetic propulsion. "What exactly is Pine Gap? As strange as it may seem, even Australian Federal Parliament members do not know. Among the Cabinet members, only a small number of 'initiates' have a vague idea of what this is all about. The only information source available to the public is the cross-checking done by private researchers such as Jimmy Guieu, following statements made by the United States or Australian magazines (always very short and terse paragraphs), and anything the locals may notice.

"It is said that under Pine Gap is the deepest drilling hole in Australia - about 5 miles (more than 8,000 meters). Such a hole is likely used as an underground antenna able to recharge the batteries of submarines in the Pacific and Indian Ocean through ELF broadcasts. Such a gigantic antenna could be used to generate a gigantic stationary wave around the Earth.

"Some say that Pine Gap has an enormous nuclear generator to supply energy to a new type of transceiver. It seems too that there is a high-powered, high-voltage plasma accelerator which may be put to use to transmit electric current, or even to produce a 'death-ray', or quite simply to feed a plasma gun. All this is not as incredible as it sounds: it is now known that the US base of West Cape, near Exmouth Gulf in Western Australia (Harold E. Holt USN Communication Station), has an older type of the transceiver used at Pine Gap which is used to send electric current to submerged US submarines who trail a wire antenna. It is known that electric currents transmitted in this way are referred to as plasmodynamic cells.

"Several times, locals have seen WHITE DISKS about 30' in diameter in the process of being unloaded from large US cargo planes at the airports serving Pine Gap. Those disks had the USAF emblem on them. It seems likely that disks are assembled and based at Pine Gap. The number of disks seen at night leaves no doubt in anyone's mind. An amazing quantity of furniture has been delivered by plane from the United States. The locals also say that an enormous amount of food is stocked in warehouses of what could well be a true multi-levelled underground city. "On the other hand, Pine Gap is well known as one of the most important control centres for spy satellites which circle the globe. An article published in late 1973 claimed that the Pine Gap installation, along with its sister installation in Guam, were used to control the photographic missions of the large American satellites in orbit above the Earth.

"Pine Gap has enormous computers which are connected to their American and Australian central counterparts, which collect all the information secured in these countries, not only about finance and technology, but on every aspect of the life of the average citizen. Those computers at Pine Gap are also evidently connected to similar mainframes in Guam, in Krugersdorp South Africa, and at the Amundsen-Scott US base at the South Pole. "Let us say, incidentally, that the employees (more than 1200) of the US base in South Africa all claim to be members of the US consular mission in that country. It may be worthy of note that the Amundsen-Scott base at the South Pole is located on a sensitive magnetic spot of our planet, that it holds exactly the same assets as Pine Gap, and that all the information about most of the average citizens of Western Europe is stored there in memory banks tens of metres under the icepack.

"A statement made by the Australian premier about 1987, assuring that 'France must disappear from the Pacific, from the Kerguelen Ridge, and from Antarctica' sheds light on the importance of this polar base for the Anglo-Saxon world.

"The most disquieting fact about Pine Gap may be that the employees working on the base, and especially those earmarked for duty on electromagnetic propulsion projects, have undergone brainwashing and even implantation of intracranial devices. Those employees have turned into unconditional slaves of their master, whoever he is. Rather scary, isn't it?

"The true point of the brainwashing of those individuals, along with the ruthless attempts to implement the coverup of really advanced military technology, will become clear at the end of this article.

"For me, it all began with the construction of the new Parliament building in Canberra, which cost billions of dollars. Australia has only 18 million inhabitants, yet it apparently treated itself to a building far beyond its means...supposedly to accommodate its government even if the old Parliament building was perfectly fine.

"This new building, enormous, immense and magnificent would easily fit the needs of the USSR or of the United States, which both have hundreds of millions of citizens to rule. That building puzzled me, and I started to talk about it until the day I bumped into an Englishman who told me that the Australian premier, Bob Hawke, was a Rhodes scholar, and as such he worked toward the setting up of a One World Government, and that this new Parliament building likely had something to do with it.

"Sometime after, I stumbled on a pamphlet published by the Human Rights Organization, which talked about a group of about a hundred people well-placed in high finance, politics, the judiciary branch and big business. This group was called the 'Club of ROME'. According to this pamphlet, the CLUB OF ROME was pledged to a consortium which controls all

international finance. A number of other groups similar to the CLUB OF ROME are equally pledged to that finance consortium, AND ARE INFILTRATING THE VARIOUS POLITICAL AND RELIGIOUS GROUPS WITH THE INTENTION TO MAKE PROGRESS TOWARD THE INSTITUTION OF A WORLD DICTATORSHIP.

"The whole thing looked a little bit too preposterous to be true, it seemed to me. Nevertheless, a friend of mine gave me an audio cassette taped at a lecture given by Peter Sawyer, a former high-ranking Australian civil servant, which exposed a certain number of facts he had noticed while in office. He talked, in particular, of a telephone exchange in Canberra called 'Deacon Center'. This exchange, built in concrete with 4 (ft.?) thick walls, cost hundreds of millions of dollars. It is outfitted with numerous computers, arrayed on four levels. When he tried to find out why such equipment was needed in a country of only 18 million, he discovered that those computers were connected to all the banks, to every post office, to all telephones, and to all of the police stations and customs houses; to every arrival and departure desk for air or sea travelers; and also and above all, to the other data centers collecting data on private citizens... in the United States as well as in Europe. "That facility on Deacon street is therefore a Centre where all the data pertaining to every citizen of the Western World ends up being stored. All financial, economic, political and military information, as well as the information on every inhabitant of those countries. As a matter of course, all people living in Australia are put on file, kept up with and labelled.

"Peter Sawyer discovered also that the president of the ROCKEFELLER FOUNDATION came for a lengthy stay in Australia to supervise in person the construction of 20 luxury residences in Canberra (the Australian government footed the bill), in the wonderful setting of a National Park, where, legally, nobody is allowed to build.

"The investigations lead by Sawyer exposed, first, that the new Parliament building is meant to accommodate the world government-to-be; and, second, that the 20 luxury residences will be allocated to the different foreign members of that government... Why choose Canberra as the headquarters of the new world government? Simply because Australia is a peaceful country, with very few natives likely to turn rebellious, and, above all, it's an English speaking country. No other English speaking country can offer the safety Australia will provide at the time of the taking over by the World Government. In America and Europe, uprisings are more than likely, and South America not only is not English-speaking, but its fondness for revolutions and social disturbances is well known.

"Australia is thus the ideal place for such an undertaking. How is the advent of a World Government possible in the near future? It is relatively easy, as we will explain.

"First, who are those 'internationalists' who want to take over the planet? THE ONES WHO WANT TO SET UP A WORLD GOVERNMENT ARE 15 FAMILIES OR SO, WHO ALREADY GOVERN ALL OF INTERNATIONAL FINANCE AND KEEP A TIGHT LEASH ON MOST GOVERNMENTS THROUGH THE ABSOLUTE CONTROL OF THEIR FINANCES AND THEIR DOMESTIC ECONOMY. These finance moguls devised their plan after World War I, and have been working since on an insidious undermining process aimed at economic destabilization all over the West.

"If those financiers are obviously labeled 'capitalists', it is a very deceptive label; for, in fact, they never ceased to pull the strings of the progressive parties, as well as those of the conservative parties. Their idea is logical and lay, quite simply, in the destabilization of the countries of the West on the political, economic and religious levels. IT MAY BE SURPRISING TO SOME THAT THESE 'INNOVATORS' HAD INFILTRATED THE TOP LEVELS OF THE MAIN RELIGIOUS ESTABLISHMENTS. ONLY A SMALL NUMBER OF YEARS WAS NEEDED TO MAKE THEM VIRTUALLY POWERLESS...

"Economic destabilization is implemented through a slower but most efficient process. This process (already under way) will cause the entire financial system of the West to collapse. The people involved are the same people who cause the price of oil to go up and then, after convincing European neighbours to agree to these price rises, provide that the yield coming from the price rises will be paid to the 'International Reserve Bank', which is entirely at their command. The Reserve Bank hands the money over to a 'holding bank' who lavishly loans the money to Third World countries for usurious rates of interest.

"The holding bank receives the interest paid by the underdeveloped countries, then puts it into another 'holding bank' which, in turn, invests the huge quantity of money on behalf of the Arabs.

"Those investments are made into thriving large businesses. In the meantime, only small interest is paid to Arab countries. "Those who engineered the plan were perfectly aware that the leaders of the underdeveloped countries would be tempted to pocket a good part of the received money.

"IRB will then tell the Arab countries that the holding bank investments have turned out badly, that all their assets have vanished and no interest will be paid any more. The Arab countries will then have no choice but to put all the securities they own on the market, as well as quite an amount of property bought by the second holding bank. A good part of these possessions will then be frozen, because they will have been bought with the aid of not entirely repaid loans, and they will be part of the assets of the first holding bank, gone bankrupt. The incredible quantity of shares put on the market at the same time will cause a stock market crash of such magnitude that all the national economies of the West will collapse at the same time.

"The planet will find itself in a desperate predicament. Cash will not be worth a damn, and the risks of a global confrontation (planned!) will be high.

#### ENTER PINE GAP

"At this point, the usefulness of bases like Pine Gap will become obvious. If a Global confrontation is going to break out, those bases will serve as a place of safety for the politicians and their staff, as well as the international financiers, their family and friends.

"If no confrontation breaks out, the financiers will adapt a 'saintly' attitude AND OFFER SUBSTITUTION OF ALL CURRENCIES BY PLASTIC CARDS, ENSURING 'TRUE EQUALITY' FOR ALL, THE ABOLITION OF ALL OWNERSHIP RIGHTS, and the setting up of a World Government that will 'ensure peace'.

"The masses will be convinced that it is necessary to ensure Peace and Social Justice by any means, including force. THE POTENTIAL ACHIEVED THROUGH THE EQUIPMENT OF THE UNDERGROUND BASES WILL MAKE POSSIBLE THE DISAPPEARANCE WITHOUT A TRACE OF THOSE WHO DO NOT CONFORM AND THOSE WHO 'HINDER THE HAPPINESS OF THE PEOPLE'. Also, it will ensure the swift crushing of any possible uprising. IT MAY ALSO HAPPEN THAT OUR NEW 'MASTERS' WILL END UP TELLING THE PEOPLE THAT THEY HAVE THE ALIENS' SUPPORT, AND THAT WE (ARE) AT THE 'EVE OF THE MILLENNIUM, A GOLDEN AGE'..... IT WILL BE THE WORST DICTATORSHIP EVER KNOWN TO MANKIND.

".....IT IS QUITE CERTAIN THAT OTHER BASES HAVE BEEN BUILT IN THE UNITED STATES AND ELSEWHERE IN THE NORTHERN HEMISPHERE. IT MAY EVEN BE THAT THE US BASES OCCUPIED BY THE GREYS, IN THE US MAINLAND, ARE OF THE SAME TYPE. ONE RUMOUR HOLDS THAT A REPRESENTATIVE OF THE GREYS IS FOUND IN EACH OF THE UNDERGROUND US BASES IN THE SOUTHERN HEMISPHERE.

## CHICAGO TRIBUNE REPORTS UFOFEST

The Chicago celebration of National UFO Awareness Week is a gathering that, while scarcely drawing every Tom, Dick and E.T., has generated enough mainstream interest to hop around to large rented space at such venues as the College of DuPage and the Museum of Science and Industry.

Serious science often has derisive beginnings, as French chemist Louis Pasteur found out when he urged people to boil milk before drinking it - and found people were laughing at him. UFO believers know how he felt.

"Yes, we do get questions," murmured Mary Kerfoot, a member of the Chicago UFO Education Committee. She was sitting on a beige sofa in Schaumburg, in a Living Room Encounter of the Close Kind. She wanted to talk about the work of the Chicago committee, an umbrella group for hundreds of local members of MUFON, the Mutual UFO Network; CUFOS, the Center for UFO Studies and FUFOR, the Fund for UFO Research. These national organizations each claim several thousand members. For those who believe, often passionately, in strange whirring lights, whizzing objects, small gray creatures undertaking invasive medical procedures, sinister-looking men in black suits and abrupt feelings of deep peace, it is not easy to face a newspaper reporter, barely two feet away.

Many others have come forward, including at least one mainstream scientist, the late Dr. J. Allen Hynek, an astronomy professor at Northwestern University. Hynek began as a debunker of UFO sightings. He ended up working out a classification system later used in Steven Spielberg's movie "Close Encounters of the Third Kind." Building on such recognition is a motive force behind National UFO Awareness Week, founded a decade ago by a consortium of alien-interest groups to "promote understanding of this field as a legitimate area of study."

"There is lots of documentation," Kerfoot said, passing chips and soda to guests and thumbing through a two-volume manual of UFO source materials, copies of which were piled high on her dining room table.

"We want to help the public understand. This is a real, scientific endeavor, not just the tabloid sensationalism most people think it is."
