




UFOs - THREAT OR PROMISE?

In 1987 Timothy Good published his seminal work *Above Top Secret*, conclusively establishing for all but the most obdurate sceptics the reality of a world-wide conspiracy by governments to conceal the facts about the UFO Phenomenon. Whatever her present views - and it is not easy to keep track of them - Jenny Randles in the same year published *The UFO Conspiracy*, a similar denunciation of superfluous secrecy. Over the last decade others also have produced a deluge of unimpeachable evidence, and yet in 1997 the bland bureaucratic denials still persist. Officially at least, British governments insult their electorate by handing over consideration of the military implications of UFOs to an executive officer, one of the lowest grades in the Ministry of Defence.

On both sides of the Atlantic, however, as we report in this current issue, influential voices are beginning to express the public's disquiet at these official insults to its intelligence. Dr. Steven.M.Greer, Director of CSETI in the USA and Admiral Lord Hill-Norton here in Britain, have both spoken out against this official blockade of information. UFOs may be friendly - though we have no evidence of this - or hostile in ways more subtle than is generally perceived: they may have their own agenda, involving the exploitation of humanity as just incidental; but if, as the X-Files constantly assure us, the truth really is out there, then it's surely time they brought it back in. People will brook no more Brookings!

UFOs and HUMANITY

Governments would like us to believe that UFOs are just some sort of hallucination, though they know well enough that the craft and occupants that landed at Roswell, at San Agustin and at Rendlesham are every bit as real as President Clinton or Prime Minister Major. For many years we could only guess what they were up to. Some people thought they were making a scientific survey of our world, and the Greys obligingly produced the sort of behaviour that would support the idea. They went in for what I call "prospecting", collecting samples of animals, plants and even soil to give the impression that they were strangers from distant galaxies visiting new worlds.

Ufologists call this view of them the ETH - Extra-Terrestrial Hypothesis - but all that most people ever saw of the visitors were LITS - Lights In The Sky, and it was quite a long time before anyone began to suspect that the UFO Phenomenon, as we call the intelligences directing the operations of these alien entities, was not here just to satisfy its scientific curiosity. For a long time we were into position to realise what a carefully devised operational plan the Phenomenon was working out in the open skies of our vulnerable world.

It was not until the ufonauts stopped pretending to be interested in taking plant and soil samples and started taking people instead, that we began to get reports from some of those unfortunate enough to have been abducted. There were and still are many who never tell what is happening to them, afraid to speak in case they are disbelieved and ridiculed. In the end, however, thanks to the work of researchers such as Budd Hopkins and Professor David Jacobs, the whole incredible story has begun to emerge.

The Phenomenon, as we shall see, was very skilful in its exploitation of humanity and was able to make sure that for many years no one really knew what was going on. Fear of ridicule was cynically used to prevent victims finding help, or speaking out even anonymously about the nasty things that were being done to them and the kind of beings which were doing them.

Looking back now, it is easy to see with hindsight how craftily the ufonauts were able to manipulate people and even governments in such a way as to prevent them finding out what they were doing, or guessing what they would do next. The Phenomenon knew that its activities could not be for ever hidden from humanity, that people would inevitably see UFOs and eventually talk about their experiences. There had to be a plan to make sure that for as long as possible no one would believe them, or that if anyone actually did believe them, they would be laughed at.

It was just after the world war had been ended by the nuclear destruction of two Japanese cities that the Phenomenon decided to go public in a big way. Kenneth Arnold's famous sighting of a UFO formation in Washington State, USA, had provided the media with the term "flying saucers", and soon these saucers were buzzing the White House and disrupting electricity supplies. The virtual erasure of these events from the public mind was a notable triumph for government spin doctors.

The Phenomenon had two aims - to be noticed, and to convince governments that they were not new weapons developments by potential enemies, so that the

USA and the USSR would not be suspecting each other on account of them and start preparing for a nuclear world war. Our Visitors were always anxious that the ecology of planet Earth should not be disrupted or destroyed, and at that time it never occurred to anyone that this might be because they had plans to take it for themselves. They had to make sure that all serious and sensible people actively disbelieved that flying saucers were real, and that meant ensuring that ridicule would be heaped on anyone who actually did think so. Some people had therefore to be provided with convincing experiences to make them believe in stories that could be exposed as false later on. So Adamski and others, collectively known as the Contactees, were the victims of a skillful presentation featuring tall, blond and noble ufonauts, delivering trite messages about peace, war and nuclear arms, and offering joyrides to nearby planets.

The Contactees sincerely believed all this, for they had indeed experienced such illusions, and they soon attracted groups of fellow believers. These "saucer cults" absorbed and presented to the world a picture of advanced and kindly space brothers visiting Earth to bring help and wisdom to its peoples. The same delusion is still being fostered in a more sophisticated form among to-day's unfortunate abductees. The promises made to the contactees were not kept and it gradually became clear to all that they had been deceived.

World opinion had thus been conditioned to a level of scepticism sufficient to permit the safe development of the third phase of the Phenomenon's successful manipulation of humanity. The major policy was the setting up of a breeding scheme to produce mutated hybrids, using genetic material stolen from abducted humans in combination with alien genes. The secondary policy was the setting up of a psychological programme of abductee conditioning, ultimately aimed at persuading its subjects that they were in fact alien soul matrices embodied in human form - in short, a fifth column to facilitate alien infiltration of human society. It has been only in the last few years that researches with abductees have shown us how the Phenomenon has combined the breeding and indoctrination programmes into this structured assault on the persons and personalities of its victims. In past ages it would have been called demonic possession.

The most significant and sinister feature of these grey aliens generally described is their ability to control both the minds and bodies of the humans they abduct. Physically, they can affect muscle tone so that any degree of control from simple weakness to total paralysis can be inflicted: mentally, they can control people's minds to make them experience whatever they wish. Communication with each other and with their victims are apparently entirely telepathic. They have no visible reproductive organs, though abductees always receive the impression that some are male and others female. Their height can vary between two and five feet, and the taller ones seem to be overseers and supervisors, who also carry out the more complex mental and emotional operations directed at the ultimate subjugation of their victims. Their behaviour suggests that they are computer-controlled organic androids, running internally a common programme dedicated to the one unique purpose. They show neither friendliness nor hostility, and operate with the impersonal efficiency of a combine harvester culling the human race. We would like to know who or what has created them and sent them here, but they never answer any such questions.

Abduction is nearly always an experience which begins in childhood and continues repeatedly and indefinitely, though it is not always subject to recall.

Victims are in some way tagged, and can always be located by their abductors, wherever on Earth they may be; for them there is no escape. Being among crowds in daytime does often give protection, but at some time the victim will be alone or in a small group, and it is then that the abduction will most probably occur, usually through a window, which need not be open, for the ufonauts seem able to pass themselves and their victims through solid matter, incredible as this may seem. We do well, however, to remind ourselves that according to modern physics so-called matter is in fact mostly empty space. Then the miracle seems less unbelievable.

Pulled up into the waiting UFO by a tractor beam, the abductee will first be stripped naked for an extensive physical examination on an operating table surrounded by a fearsome array of medical machinery. If the UFO is a large one with many operating tables, the victim may be placed in a queue by the small beings who carry out all the routine operations. In the main operating theatre they may sometimes see people they recognise, perhaps even their own children, and be powerless to help them.

Subsequent major operations may be divided into two areas - physical and psychological - and will be carried out by the tall overseers, who are always in charge. Physical manipulation involves the collection of eggs and sperm; for a woman it will also involve the initial insertion and later removal of a fertilised and mutated egg after some weeks of development in her womb. Both sexes may undergo insertion of a very small device into the nasal or some other body cavity, which apparently makes it possible for the aliens to find them wherever they may be.

The psychological conditioning appears to have two purposes - the study of human responses to various stimulus situations, and the moulding of those responses in ways the aliens wish to encourage. The abductees may be made to believe they are themselves aliens in human bodies, incarnated thus to serve their race in some future conflict with humanity. The strong-minded can fight successfully against the acceptance of such suggestions, but many succumb.

An important part of the psychological conditioning consists of being shown the hybrid embryos growing in transparent containers of nutrient solutions, surrounded by a life-supporting network of tubes. This is followed by visits to the nursery area where listless half-alien babies and children are said to need human contact, which the abductees are obliged to supply. Women especially are told that a particular child is theirs and are required to hold it. Usually they find the baby repulsive and do not wish to do so, but their captors insist.

There is scarcely any physical evidence in support of these witness accounts, except the correlations between hundreds of independent testimonies. Many witnesses have strange scars and sometimes suppurating wounds as a result of alien examinations; others have inadvertently expelled from their bodies the small locating devices implanted there, which are currently receiving scientific study: yet others have returned to earth wearing clothes incorrectly put on or to a place different from that from which they were taken up.

Some abductions have on occasion been observed by people not otherwise involved, but in general we have to admit that the Phenomenon has been almost totally successful in making sure that abductees have no objective evidence to produce in support of their testimony. Nevertheless, investigators confronted time and again by compatible versions of the same story feel obliged to accept it as in some way true. There can be little justification to doubt the existence of these UFO phenomena, which clearly represent a challenge Mankind should not ignore.

ADMIRAL FOUNDS UFO PRESSURE GROUP

Admiral of the Fleet The Lord Hill-Norton, GCB, has held the highest naval and defence posts and has long been interested in the UFO Phenomenon. Now, in a letter to the editor of *Flying Saucer Review*, he has announced his intention of setting up a group to be known as UFO CONCERN, open to all who feel, as he does, that this question is not receiving the attention it demands. "It has been suggested that I should take the initiative to establish an informal group of sensible and respected people who are genuinely concerned with the implications of the UFO phenomenon now manifest world-wide, including Britain. The aims of such a group would include the dissemination of information based on facts, not fiction, together with recommendations for appropriate action. I have been personally interested in this baffling but challenging problem for many years, and I am in touch with several others who share my view that strenuous efforts should now be made to address it.


"The available evidence indicates that alien, non-human intelligences and influences are operating increasingly amongst mankind, frequently in a manner which should cause real concern, not only from a national security standpoint, but also because (whatever they are) these 'UFOs' actually appear in a physical, material sense. Reported contacts with them have seldom been beneficial, even if sometimes they have appeared to be so.

"It has been suggested that the subjective influence of UFOs is essentially a **religious** matter, because any sort of contact made at the personal level frequently has some sort of religious, spiritual dimension, and quite often such experiences are definitely antithetical to orthodox Christian belief. Opinions may well differ as to the precise nature of these occurrences, and also what, if anything, can be done about them.

"In any case, my associates and I consider that the time may well be ripe to form an informal group which can both assess latest developments, and attempt to recommend appropriate action to deal with the problems involved. It is my present view that the first - and perhaps the most difficult - task will be to persuade the public that there really is a problem, and a serious one at that.

"I should be glad to hear from anyone who shares these views, and would like to support the initiative outlined above. Suggestions for practical steps which might be taken to further these aims would also be welcome."

RELATED TO THE UFO/EXTRATERRESTRIAL SUBJECT

A number of first hand military, intelligence and government-associated witnesses to covert projects dealing with UFOs and Extraterrestrial Intelligence (ETI) have been identified by CSETI's Project Starlight effort. Over the past three years, we have located several dozen such potential witnesses as part of a comprehensive strategy to collect adequate evidence for a global, definitive disclosure on this subject. The story which these important government witnesses can tell will make a credible, undeniable case for the reality of UFOs and the existence of extraterrestrial life forms in proximity to the earth.

One of the persistent obstacles to this testimony coming out into the public arena has been the issue of so-called national security oaths and restrictions placed on these witnesses. Some feel that they are not free to speak unless 'released' from these national security oaths and restrictions, and so we have been working to encourage Congress and the White House to take actions which would remove these restrictions. In the summer of 1995, a number of these witnesses gathered at a witnesses' summit, and we all signed a letter to President Clinton asking him to take actions leading to the release of these restrictions. While receipt of this letter was acknowledged by a special assistant to the President, we still await specific action from the executive branch of the US government.

With this said, it is important to visit the question of whether or not such national security oaths and restrictions are themselves legally valid. We have compelling witness testimony that the operations dealing with this subject currently exist, and have existed for several decades, outside of normal governmental projects. Members of the Project Starlight Team have met with very senior members of the Administration, Congress, the Joint Chiefs of Staff, the CIA and other relevant government agency operatives. The picture which emerges from these discussions is that of an operation dealing with UFOs which is functioning outside of the normal channels of government, as it is usually considered. Indeed, we have found that the most senior levels of the executive branch, Congress, the military etc. are totally out of the loop on this extraordinary matter. This then brings up the sobering question of who is in the loop, and under what authorization are such projects operating? It is our assessment that for the large part, these operations do not fall under any constitutionally sanctioned avenues of authorization, and as such are, perforce, illegal.

Aside from the lack of oversight and authorization from the executive branch and Congress, these operations have, from time to time, engaged in deceptive practices which have frustrated the organs of constitutionally legal inquiries and democratic processes.

Any such operation which behaves in this fashion unilaterally removes itself from the inherent legality and protection which exists for projects which are consonant with constitutional law.

This being the case (we are eager - nay, desperate - for someone to prove otherwise...) all of the so-called 'national security oaths' and other 'restrictions' placed on military, intelligence and government contract workers are null and void. That is, they appear to have no legal validity since the operations for which they were obtained are themselves illegal. In a constitutional democracy, it is a basic requirement of law that such operations be constitutionally legal, and if they are not, then all that flows from them - including such 'oaths' - are illegal and therefore non-binding. IF these operations are legal, nobody in the Congress, executive branch or senior military with whom we have spoken knows of it. The production of a single current executive order or congressional directive authorizing these projects, which can be independently verified, would convince us otherwise.

More than one covert contact has told us that, indeed, any such witnesses can and should speak out at the right time and place since no legal entity would - or legally could - do anything about it. We agree. Witnesses to come together, and at the highest, best and most credible venue possible, speak out in unison regarding the truth on this matter. Granted, if only one or two such persons come forward, the case will be weak, and the risk will be unacceptable.

But if ten, twenty or more such witnesses come together, and united, resolve to share their information and experiences on this subject, then a definitive case will be made, and a great service to the world and their country will be fulfilled.

The return of this matter to the legal channels of government and the deliberation of the people is one of the great unfulfilled tasks of the post cold war era. Over half a decade has elapsed since the end of the cold war, and there can no longer be a justification (if there ever was) for this type of extraordinary secrecy and covert agenda. Both national and world security requires that this matter be returned to the world community as soon as possible.

We recommend that men and women of vision, courage and dedication join with us in fulfilling this task. Far from being a legal violation of 'security oaths', the public testimony by such witnesses is a highly moral and legal act. Further, is it not true that the continuation of this secrecy itself is illegal and immoral, given the joining together and providing their testimony in a united strategy can return this subject to legal oversight and control, and thereby enable the people of our country and of the world to begin the public deliberations which should have occurred 50 years ago.

ANTIPOPE ... by Kevin McClure

Nick Pope is the chap who answered the phone to UFO spotters at the Ministry of Defence. While Nick may possibly know all sorts of fascinating things about substantial and unexplained reports of unidentified aerial phenomena, he clearly has little understanding of the potential hoax content of, in particular, the Roswell Autopsy and crop circles. I guess these misconceptions may derive from some of the people he's been mixing with. Anyway, you may recall that on the cover of *Open Skies, Closed Minds*, he compares his standing in the MOD with that of a ranking army Major. An earlier version of this claim was made in *The Cropwatcher*, in which Pope stated that, "I held the rank of Executive Officer when in Sec(AS)2a; this civil service rank equates to that of an Army Captain. I am now a Higher Executive Officer, which equates to the rank of Major."

As an Executive Officer (EO) myself, in the HQ of another department, I found this an intriguing proposition, because after more than twenty years in the EO grade, on the maximum of the ordinary pay scale, and with some additions for good performance, I earn around £16,000 a year. When I joined the civil service, the entry qualifications for the EO grade were two 'A' levels of any description, and I don't think that has changed much since. If you get fed up at your local social security office, or Jobcentre, and demand to see the supervisor, that will be an EO. It's a job where you need to be honest, accurate and technically sound, but it's nothing special in the great scheme of things. Higher Executive Officer is the next step up, and is a standard civil service 'middle management' grade.

The comparison with Army ranks suggested by Mr. Pope did not ring true to me. I had this impression that a Captain could well, in combat, be responsible for the lives and deaths of a substantial number of men. A Major even more so. Using the straightforward investigative technique of finding out the facts, I compared the pay scales of the two civil service jobs with their supposed Army counterparts. This was enlightening.

Executive Officer	between £11,433 and £16,286
Army Captain	between £23,668 and £27,521
Higher Executive Officer	between £15,463 and £21,491
Army Major	between £30,054 and £36,010

In addition, Army officers receive subsidies for food and accommodation, and various allowances. Civil servants seldom receive any addition except London Weighting. The differences in income are actually greater than the figures suggest. The differences in responsibility are as great.

Continuing my investigation - actually having a chat with the Sergeant in the local Forces Information Office - I found that probably the only way in which civil service grades equate with Army ranks as Mr Pope has suggested is in the privileges given to civil servants if they visit an Army base. Where they eat - the Officers' Mess - and where they sleep. Otherwise, I suspect that they do not equate at all, and that Mr Pope's comments might possibly be regarded as misleading.

If the Government has entrusted responsibility for the conduct of its information-gathering, assessment and public relations regarding UFOs to a mere EO, then you can be pretty sure of one of two things. Either it has secrets to protect, and has placed in the job someone who has no idea what they are, and whose ignorance is useful in protecting those secrets. Or - and this is far more likely - the Government has long since decided that UFOs have no defence or other significance, and decided to fill its 'UFO liaison' job as cheaply, and at as low a grade, as would be consistent with the rudiments of providing a service to its customers. Either way, Mr Pope seems to have been less than fulsome in describing the level of his status and authority, and it is easy to be reminded of prominent figures in the UFO field who claimed to have authority to make great revelations, but have recently been shown to be prone to exaggeration verging on deceit. Perhaps Mr Pope's reticence in conveying his real status should be considered in assessing the significance of anything else he has to say.

PANEL CONSIDERS ABDUCTOR MOTIVES

UFO EXPERTS DEBATE WHETHER ALIENS ARE GOOD OR BAD

A highlight of the Project Awareness UFO Conference held in Tampa, Florida the weekend of September 13-15 1996, was a panel discussion in which the audience directed questions to all the conference speakers. Repeatedly during the panel, questioners sought insight into the nature and motives of those who perpetrate abductions. Finally an audience member brought the question to a head and elicited response from all members of the panel. Here, with only slight editing for clarity, is a transcript of that entire exchange. QUESTION: When I go home tonight, I want to be able to sleep right. So I want to know, Are the so-called aliens benevolent or belligerent? And if they are so technologically advanced... if they can make us perceive anything they want, how do we know if they're good or not so good?

[The moderator, Michael Lindemann, requested each panel member to answer as concisely as possible. The panelist were Dr. Roger Leir, the California-based podiatrist who has pioneered the surgical removal of alleged alien implants; Linda Moulton Howe, award winning filmmaker and leading expert on UFO-related animal mutilations; Colin Andrews, leading expert on crop circles; John Carpenter, leading abduction researcher; Budd Hopkins, best-selling author and top authority on abduction; and Dr. Courtney Brown, a political science professor who has used remote viewing to investigate aliens.]

DR. ROGER LEIR: Let's suppose I have a vehicle, and I pull up in front of your house in the middle of the night, have the technology to come through your wall or window or ceiling, take your 11 year old daughter out to the vehicle through the wall, and perform medical experiments on her, play with her mind, screw with her genes, and then bring her back and put her to bed, sometimes upside down, wearing someone else's clothes... and after I get through doing all this, you find out who I am. What do you think the average person would do to me? What I'm basically saying is, if you want to go home tonight and think good thoughts, you can think what you want, postulate what you want, you can philosophize... you can say it's good, it's bad, it has benefitted mankind, it's been done for thousands of years... But this happens to be what's going on. And if a human did this kind of thing, boy, we'd be awfully mad. And I (the perpetrator) would not be walking the streets.

LINDA MOULTON HOWE: Your question is at the heart of the confusion of all of us. Motive has always been the thing that's haunted me, and I came at this through one of the most repulsive aspects, the mutilation of the animals. My own personal opinion is that what happens to the animals and what happens to the humans is related to the same end, it's just that they're treated differently. The animals are dead, and fluid and tissue are removed. Humans are taken and fluid and tissue are removed, and amnesia is [induced]. In the end, in the big picture, if we knew 50 or 100 years in the future that all this happened because we were headed in a dead-end game in which everything was going to be destroyed anyway, through some environmental destruction... if we knew for certain that this had a positive end-game to it, maybe our perspective would be a little clearer. But I really can't say that I sit here with clarity about the motive. And if I have any clarity at all, it would be that confusion and contradiction and manipulation are part of what [the phenomena] do, and perhaps in our innocence we interpret that as being evil and negative, when in the long run it may not be. But until it's proved, until we can actually have some direct knowledge, I think we're going to continue to be haunted by this question, which is at the heart of what we'd all like to know.

COLIN ANDREWS: I would certainly say that I could well lose much more sleep worrying about what man is doing currently, than I have since I got involved in the crop circle research itself. I of course have no idea who the circle makers are. But assuming them to be one of these races out there, extraterrestrial in origin, I certainly lost a night's sleep or two initially, in the early days of my own work, wondering what these things meant and how they got there. But since I began to see a picture forming, one that I believe I understand to some degree, and I see that, in broad terms, we're seeing a spiritual nudge occurring here, a reminder of who we are is beginning to emerge. And certainly, I sleep much sounder these days, as I see people beginning to address themselves to the focus that this single phenomenon itself has invoked... Here I think we have [both] spirituality and technical information, and I think we have, basically, the future, once we find ourselves.

JOHN CARPENTER: I do want to tell you that if, on your way home tonight, they want you, they're going to get you. But I have a brilliant perceptual, attitudinal solution for you. Think of it as a date. [audience laughter]. Seriously now, I have always tried to find the best parallel or example as to what they may be doing with us, that we may be doing as well. The wildlife example is always a good one. Do you realize how many grizzly bears meet in the woods every week and have a support group? Because these humans came in their helicopters, darted them, did experiments, put these stupid tags on their ears that they can't get off, and sometimes they beep and make sounds... And no one bothered to explain it to them, or ask their permission. So here are all these animals on our planet, wondering what the heck these humans are doing to [them]. But we don't think anything of it. We know we're not hurting them. We know we're not trying to do anything to cause them to become extinct -- in fact, it's just the opposite, many times. Dr. Leir gave a beautiful example of the human perception, and Linda Howe began to shed light on other perceptions, and I think these are very good things to keep in mind, because we really don't

know. In my cases, I see the whole range of human responses, yet what they [the aliens] are doing is pretty much the same in all those cases, despite the range of human responses.

BUDD HOPKINS: I think the basic thing we always have to understand is that if you have a non-human intelligence, to try to understand it with human equipment and human perspectives is extremely difficult. I don't care whether this is through interviews, your own emotional response or some technique like remote viewing. Whatever it is, we bring our own human perspectives to the subject. The thing is, every human being is born with a huge box of paranoid terrors. Little kids are always afraid of what's under the bed or something. As we get older, we're afraid we're going to have strokes, crash in a plane, terrorists are going to get us, whatever. We have boxes and boxes of fears born into us. On the other side, we all have religious hope that out there somewhere is a guardian angel, or God, or somebody looking after us, and the bad stuff that happens to other people is not going to happen to us. Now, when you bring into this context -- this box of paranoid terrors and this box of religious hopes -- something completely non-human, the tendency is to put it in one of those two boxes... or to say that there are two groups, the good group and the bad group. In all the work I've done over the years, I have never seen what seems to me to be evil, malevolent behavior on the part of the aliens, that they're here to kill us, cosmic storm troopers, anything like that. Never seen it, ever. On the other hand, I have never seen them do a damn thing for anybody that was helpful, except in the sense that we've had some cases where people were healed of some particular condition... and one of [Temple University professor and abduction researcher] David Jacobs' clients once said she didn't know whether to be grateful or not, maybe it was just equipment maintenance, like we would take care of a sick bunny in the laboratory. The point is, there is no reason to believe for one second that these are god-like people here to help us -- no evidence for that at all. And no evidence that these are here to swoop down like Independence Day and smash us all and blow up the Statue of Liberty. That's not true. They seem to be here for their own purposes, their agenda, very difficult to fathom. Certain things we can say for sure. They are not deliberately inflicting pain. They don't do that. They seem to be experimental. They sometimes say things like a dentist says to a five year old. "Don't worry, it won't hurt," but then it hurts. They do these things, obviously trying to keep the person comfortable. And if they take you out of your car on the way home tonight, they're going to tell you everything's OK, don't worry, we'll put you back in the car and it won't hurt. So we're stuck with this very strange problem of trying to handle something that we truly do not understand. We can say without any doubt that the amount of damage this has done to people, so-called collateral damage -- that's what the government says when it blows up civilians -- is enormous and extraordinarily unfortunate. I've seen people who have taken their own lives because of the terror and fear and everything else, and yet I don't think any of that is intended.... They don't kill you, they bring you back, they put you back in your car or your bed or wherever, they try to keep you calm, there's no evidence that they're doing you harm... BUT, if you go through these experiences, you are going to suffer. It's a very complex thing to face. Many abductees have said to me, "If I could regard [the aliens] as enemies, I would feel better. If I could regard them as saviors, I would certainly feel better." But they don't seem to be either one. And I think that is a true sign that this is not some kind of fantasy coming out of us, because it does not cohere with either of the basic science-fiction myths we have of the conquerors or the saviors. It's complicated and hard to deal with.

DR. COURTNEY BROWN: You know the old Biblical saying, As below so above - well, things may be much more complicated with regard to good guys and bad guys than I'm aware of. I would suspect that every problem and all the types of confusion that we have down here are the same types of things that go on up there... With that said, however, the remote viewing data and experiences that I have had, and the students and professionals that I've worked with have had, indicate two things that are very important. The first is that we really don't die, that we do have composite existence, and that the physical bodies that we're in right now are not everlasting things, they're just like school experiences that we have, things that we wear so that we can experience this physical life. And it seems that out there in the galaxy, not derisively but in an admiring fashion, we [humans] are labeled "the masters of limitations." That we have volunteered to come into bodies that have such spectacular limitations that we can't remember where we came from, can't perceive where we're going... And when we do this, we have special experiences we can get out of this life. You're born, you look at the end - at best you've got, say, about 100 years to go, and you say, Well that's it, I can't see past, I can't see beyond, back or forward, so I'd better pack as many experiences as I possibly can into this short life. And you have very, very rich experiences packed into an extremely short period of time, as you run the gauntlet of the few years you're experiencing here. When you think about that, "masters of limitations," it's very normal for us to have all types of fears, because we have self-imposed so many limitations on what we can perceive -- there are so many unknowns. Thus, in my view, when we have fears, we should remember that probably, in most cases, they are exaggerated. They are bigger than they need to be. They are consequences of our own self-imposed lack of ability (because we come into these bodies) to get some of the answers. So things can happen to us that we don't understand, and we can be frightened of it. That's one side of the story. But secondly, look at all the energy that's being put into, say, the gray genetic engineering project. They have their own limitations. Let us say that they get permission from a person who's abducted, before they're born [this is the consistent finding through remote viewing] -- and then the person is born, and [the aliens] follow the person through life, visit them when they're 13, visit them when they're 20, and so on like that. Just imagine... is it us only who have limitations? What do the experiencers often report back? The Spock-like mentality, the lack of variation in thinking, often very deep spiritual insights but at the same time very shallow electro-chemical emotional views. Imagine [the aliens] getting permission from this person, who says, "OK, you can abduct me, and I want to be involved in your altruistic project, because you guys really do need help

and I want to help." Now imagine the experiencer actually being abducted, and the grays bringing this person on board kicking and screaming, with an emotional electro-chemical brain that's just about out of control, and [the grays] themselves getting only one electro-chemical response in their own brains to virtually any stimulus... They can't even understand what this woman is going through. So if you think we're the masters of limitations, feel sorry for the grays on their side. They cannot even understand why she is so upset. "We asked you to do this... what else do you want us to do?" So, if you feel upset about what goes on on the human side, understand that it's natural that we should be upset because we have so many limitations on what we can do... But it's not just us. The other guys, the grays, also have difficulties, real difficulties. They want to get out of their cul-du-sac. They want to have more variation in their electro-chemical brain responses to stimuli, but they honestly can't understand what the woman or the man is going through. So, when you're feeling frightened, say two things (this is just my opinion). Say, part of the fear is probably unfounded, just because I am the way I am genetically, so let's not worry about it so much. Let the fear go. But then, also say, let's feel sorry for the grays, because they don't even understand the nature of the fear, the nature of these emotions, and in a very real sense they have very severe limitations as well. Neither side has got a perfect electro-chemical mechanical body to undertake all these things.

'ANTI-GRAVITY' DEVICE GIVES SCIENCE A LIFT

Scientists in Finland are about to reveal details of the world's first anti-gravity device. Measuring about 12in across, the device is said to reduce significantly the weight of anything suspended over it. The claim - which has been rigorously examined by scientists, and is due to appear in a physics journal next month - could spark a technological revolution. By combating gravity, the most ubiquitous force in the universe, everything from transport to power generation could be transformed.

The Sunday Telegraph has learned that Nasa, the American space agency, is taking the claims seriously, and is funding research into how the anti-gravity effect could be turned into a means of flight. The researchers at the Tampere University of Technology in Finland, who discovered the effect, say it could form the heart of a new power source, in which it is used to drive fluids past electricity-generating turbines.

According to Dr Eugene Podkletnov, who led the research, the discovery was accidental. It emerged during routine work on so-called "superconductivity", the ability of some materials to lose their electrical resistance at very low temperatures. The team was carrying out tests on a rapidly spinning disc of superconducting ceramic suspended in the magnetic field of three electric coils, all enclosed in a low-temperature vessel called a cryostat.

In recent years, many so-called "anti-gravity" devices have been put forward by both amateur and professional scientists, and all have been scorned by the establishment. What makes this latest claim different is that it has survived intense scrutiny by sceptical, independent experts, and has been accepted for publication by the Journal of Physics-D: Applied Physics, published by Britain's Institute of Physics.

VIDEO OF CROP CIRCLE FORMING IS PROBABLY HOAXED

Crop Circle Expert Colin Andrews Announces His Findings

[CNI News editor Michael Lindemann was among those in attendance when crop circle expert Colin Andrews unveiled a controversial videotape at a Springfield, Missouri UFO conference in mid-September. The video shows what appears to be several glowing balls of light moving quickly over a crop field in southern England. As the balls travel just above the grain, a crop formation is seen to form. The whole process takes less than ten seconds, leaving behind a large "snowflake"-shaped formation as the glowing balls exit the scene. It is an impressive sight. Now, however, Colin Andrews himself has apparently concluded that the videotape is a hoax. His statement follows.- CNI News.]

Several weeks of investigation into the video supposedly showing four Ufo spheres over a field while crop circles formed, reveal disturbing findings. The young man who took the film gave his name as John Wheyleigh. He is a young man approximately 25 years old and attended Nottingham Trent University in the past, as has another man with a similar name, John Wabe, who lives at Maple Grove, Bath, Avon. The latter studied 'American Studies' and is in partnership with a company in Bristol that edits video film for television companies.

When John Wheyleigh asked me to research his footage for him, he asked me to sign a roughed out contract. He suggested giving me 10% of all monies earned by this footage if any were forthcoming. He gave other details which have been checked out by agencies in England. These details, which were purported to belong to him, in fact belong to John Wabe.

Contact has been attempted with John Wheyleigh over several weeks without success. A telephone call to the home and work place of John Wabe has been answered by a man around 40 years [of age] claiming he has never heard of Wabe or Wheyleigh. Other enquiries are in hand and I have sought police advice regarding legal proceedings should that be necessary. Many things have not looked right with the film or the man since I met him in the Wagon and Horses pub where he asked to meet.

I have had an opportunity to match the video with the crop pattern details as recorded by CPR the day after discovery and study other details which trouble me in the film itself. My conclusions, pending detailed plant analysis results and photographic analysis, is that both the crop pattern and the video are hoaxes and both probably by the same group. What is most concerning is the planned intentions of the hoaxers. I have reason to believe that several persons are involved in this fraud scam and the video/television business is likely involved in it.

In view of my findings, it is not my intention to do any more work with the film but to spend some more limited resources in trying to learn more about the people concerned.

Some people might have been prompted by [certain Internet personalities] into believing that my reason for not showing the world [the video] sooner was so that I could make a lot of money out of it. I want to make it perfectly clear that no money has been given to me for the film, although many television stations wanted it and so did many researchers. My promise to the mysterious John was to have it analyzed and then the film would have been shared with all.

I think we can see by developments so far, that this was by far the right way to have gone about it. It is so unfortunate that the crop pattern and subsequent film appears to have been designed to damage researchers like myself and Peter Sorenson, and the phenomena itself.

Peter Sorenson has recently been given a copy of the film by "John," as has video film maker Lee Winterton. Peter is also having it analyzed in the USA, but early indications from his investigations too are very disturbing.

JIMMY GODDARD, SIGAP Member and well respected Ley investigator and Earth Mysteries researcher, has always accepted Adamski's account of the solar system. Now he describes a book which shares his views.

UFOs and the Complete Evidence from Space - The Truth about Mars, Venus and the Moon, by Daniel Ross. (Pintado Publishing, \$9.95)

This remarkable book was published in 1987, but for some reason has never become widely known in the UFO world. Written by a United States ex-submariner, it presents compelling evidence that the cosmology put forward by George Adamski is a true picture of the Solar System and the Universe, and that powerful factions here on Earth have gone to extreme lengths to give the public a very different view.

The book considers Mars, the Moon and Venus separately and in detail, and shows evidence that they are all living environments. Several photographs of Mars were published in the book, the most spectacular being one of Olympus Mons, showing extensive cloud cover and green areas - a very Earthlike environment in fact. The first Viking photograph is also there - showing a blue sky. The significance of this was not realised at first, but it was quickly denounced as false colour and replaced by lurid pink pictures.

The Moon's gravity is apparently much greater than the one-sixth Earth gravity that is accepted by orthodox science, and the whirls and leaps predicted for astronauts never happened. The astronauts were seen as "bouncing" because the video was slowed down to give this effect, but they did not reach appreciably greater heights than they would have on Earth. Also, the sight of stars from the Moon is evidence for its atmosphere. Astronauts have mentioned the fact that most stars are not visible from space - it would seem to be our atmosphere that makes most of the fainter ones visible by acting as a giant lens. This again was previously stated by Adamski when he said the background of space is totally dark. Also, soil from the Moon has grown plants and I have seen reports of this in newspapers, but the fact was soon quashed by the censors.

Venus seems to be the planet which is most similar to Earth, despite the statements of the most extreme sulphurous conditions. Russia's Venera landers showed a landscape bathed in sunlight, and none of the weird upward-curving horizon effects that were expected. They were also not pressure vessels like those sent later by NASA, yet sent back information. In fact it would seem that the sulphurous detection by Pioneer was caused by monitoring a major volcanic eruption, and these findings have been accepted as the norm ever since.

The other planets, although not mapped by our probes so intensely, were shown to have much better environments than expected. The description by Adamski of the asteroid belts acting as cathodes to boost solar radiation to give the outer planets habitable temperatures was confirmed by Voyager 1 in 1978, which found the area just beyond the known belt was the "hottest" place in the Solar System.

So the picture of the Solar System which has become "carved in stone" would seem to be very different from the true situation, which would seem to be much more like that described by George Adamski. The book is packed with evidence of all kinds for this. This is good news in that it shows the space friends Adamski met were real people from our neighbouring worlds, but it also is very frightening that a faction on Earth could have such international power that it can give a totally false picture of the Universe to the whole world for its own selfish purposes.




Plate 11. Extensive cloud cover and foliage near the summit of Olympus Mons - an area on Mars photographed in detail during the Viking mission.

Russians Report on Apollo

The Russian weekly television magazine "7 days" for 21/27 October 1996 carried this piece on the Apollo missions of 1969/70, under the title: "We were not the first to land on the moon."

In Yeltsin's Russia, the populace are now being allowed, for the first time, to read UFO related material, hitherto only available in clandestine "samizdat" publications. For this translation PEGASUS is indebted to SIGAP member Michael Colenso.

On the morning of 16 July 1969 the Apollo 11 rocket was launched from Cape Kennedy. The astronauts (Armstrong, Collins and Aldrin) reported to base, several hours into their flight, that some balls of light were following their craft and mimicking its manoeuvres. Staff back at Houston joked that "Those Russians get up to anything!" Various explanations were offered, including 'torpedoes'. Three days passed in tense expectation, but no explosion occurred. It was no comfort to the men that these were "UFOs" - their nerves were already at breaking point.

Twenty years on, a memorandum from the ufology organisation ICUFON addressed to George Bush and Mikhail Gorbachev cited the contents of a letter from one of Armstrong's colleagues: "At a distance a quarter of the way between Earth and Apollo, three unknown objects came within one metre of us. As the landing module began to descend, three UFOs each thirty metres in diameter settled on the edge of a crater ..."

Following the moon landing, Houston received new and alarming information (July 2nd). Every country in the world, except the USSR and China, was tuned in to the crew's direct transmissions. "I can see many small craters, from six to fifteen metres in diameter. About half a mile from us we can see track marks like those of a tank ..." TV viewers suddenly heard strange sounds like a train whistle or the whine of an electric saw. The NASA operator was worried. The astronauts checked their transmitter and ascertained that the sounds were emanating from elsewhere. Armstrong selected another frequency to contact Houston.

"What was that? What's going on?"

"There are some huge objects out here, sir! Oh God! They're on the opposite side of the crater," the crew answered.

"They're on the moon and they're watching us ..."

Ironically, the location of all these events was the Sea of Tranquillity.

Five hours later, when everyone's nerves were beginning to calm down, Armstrong and Aldrin finally decided to venture outside. Armstrong unexpectedly got stuck in the exit hatch, and for several minutes only the sounds of struggling were heard. Photographers captured the moment and took historic shots of NASA staff turning white with horror and of the terror-stricken faces of Armstrong's family. Finally the astronaut's footsteps on the step ladder were heard. With the excitement over, the world began to await man's first speech from the moon to the glory of America.

After landing back on Earth, the astronauts were quarantined and then sent for medical examinations. At this time the recordings of their conversations and their videotapes mysteriously vanished. They were later recovered, but found to be damaged beyond repair.

On 14 November 1969 Apollo 12 landed in the Sea of Storms without incident. The Apollo 13 crew were less fortunate when on 13 April 1970 an oxygen tank exploded on board their craft and they had barely enough air to return to Earth.

Alan Sheppard and Edgar Mitchell (Apollo 14) overstayed their time on the moon's surface; their oxygen supply was expected to have run out four hours previously, and America prepared to mourn the loss of her heroes. Their return to Earth was a miracle. Having returned from "the other side", the astronauts went straight into retirement and refused all press interviews.

Many years passed before Mitchell confessed to a journalist of his acquaintance that he had experienced a vision of a grey-bearded old man close to the crater. On the moon they had seen many strange phenomena, some of which he had been able to film. "We discovered strange bases on the moon, containing a vast number of round, cylindrical and oval objects. When I passed out for lack of oxygen, I regained consciousness close to the silicone capsule which had been left by Armstrong (containing recorded greetings in seventy four languages and an extract from the USA's code on space navigation).

"It was incredible, but I clearly saw an image of Armstrong himself, smiling at me. I thought I must have died and that everything that was happening to me was unreal. Armstrong was wearing hospital pyjamas and hardly able to move, having been pumped full of drugs. He was trying to show me or tell me something, but then he took my hand and pressed something into it. I don't remember anything else before awaking again in the rocket, with Alan lying next to me, groaning. A strange cylindrical object no longer than two centimetres, was in the palm of my hand.

"When I later tried to find Armstrong, I found him in hospital looking exactly as he had in the image seen on the moon. I think it was the existence of this cylinder that stopped me going out of my mind, but I seem unable to find out where it came from."

We would obviously like to have further information concerning this mysterious cylinder, just as we would also like to know which of Armstrong's associates wrote the description of the three UFOs accompanying Apollo 11. There have previously been reports from other sources of alleged alien spacecraft on the moon.

With our current rocket technology, it would take around 300,000 years to travel there. This poses a daunting engineering problem even for a more advanced civilization.

In addition to the unlikelihood that we have been visited by extraterrestrials, there is no scientific evidence to prove it. Personal accounts are not physical or verifiable evidence. These reasons are sufficient to exclude UFO's from the research objectives of the SETI Institute. **STORMY WEATHER?
AMERICA IS READY - EVEN FOR ETs!**

Few Americans are aware of the existence of Mount Weather, a mysterious underground military base carved deep inside a mountain near the sleepy rural town of Bluemont, Virginia, just 46 miles from Washington DC. Mount Weather - also known as the Western Virginia Office of Controlled Conflict Operations - is buried not just in hard granite, but in secrecy as well.

In March, 1976, THE PROGRESSIVE MAGAZINE published an astonishing article entitled "The Mysterious Mountain." The author, Richard Pollock, based his investigative report on Senate subcommittee hearings and upon "several off-the-record interviews with officials formerly associated with Mount Weather." His report, and a 1991 article in TIME magazine entitled "Doomsday Hideaway", supply a few compelling hints about what is going on underground.

Ted Gup, writing for TIME, describes the base as follows: "Mount Weather is a virtually self-contained facility. Above ground, scattered across manicured lawns, are about a dozen buildings bristling with antennas and microwave relay systems. An on-site sewage treatment plant, with a 90,000 gal. a day capacity, and two tanks holding 250,000 gal. of water could last some 200 people more than a month; underground ponds hold additional water supplies. Not far from the installation's entry gate are a control tower and a helicopter pad. The mountain's real secrets are not visible at ground level."

These "real secrets" are protected by warning signs, 10 foot-high chain link fences, razor wire, and armed guards. Curious motorists and hikers on the Appalachian trail are relieved of their sketching pads and cameras and sent on their way. Security is tight.

Mount Weather is virtually an underground city, according to former personnel interviewed by Pollock. Buried deep inside is the self-sustaining underground command centre for the Federal Emergency Management Agency (FEMA). The facility is the operational centre - the hub of approximately 100 other Federal Relocation Centres, most of which are concentrated in Pennsylvania, West Virginia, Virginia, Maryland and North Carolina. This network of underground facilities constitutes the backbone of America's "Continuity of Government" programme. In the event of nuclear war, declaration of martial law, or other national emergency, the President, his cabinet and the rest of the Executive Branch would be relocated to Mount Weather.

What Does Congress Know about Mount Weather?

According to the Senate Subcommittee on Constitutional Rights hearings in 1975, Congress has almost no knowledge and no oversight - budgetary or otherwise - on Mount Weather. Retired Air Force General Leslie W. Bray, in his testimony to the subcommittee, said "I am not at liberty to describe precisely what is the role and the mission and the capability that we have at Mount Weather, or at any other precise location."

Apparently, this underground capital of the United States is a secret only to Congress and the US taxpayers who paid for it. The Russians know about it, as reported in TIME: "Few in the U.S. government will speak of it, though it is assumed that all along the Soviets have known both its precise location and its mission (unlike the Congress, since Bray wouldn't tell); defence experts take it as a given that the site is on the Kremlin's targeting maps." The Russians attempted to buy real estate right next door, as a "country estate" for their embassy folks, but that deal was dead-ended by the State Department.

WHAT DO THEY DO AT MOUNT WEATHER?

1) Collect Data on American Citizens

The Senate Subcommittee in 1975 learned that the "facility held dossiers on at least 100,000 Americans. [Senator] John Tunney later alleged that the Mount Weather computers can obtain millions of pieces of additional information on the personal lives of American citizens simply by tapping the data stored at any of the other ninety-six Federal Relocation Centers." The subcommittee concluded that Mount Weather's databases "operate with few, if any, safeguards or guidelines."

2) Store Necessary Information

The Progressive article detailed that "General Bray gave Tunney's subcommittee a list of the categories of files maintained at Mount Weather: military installations, government facilities, communications, transportation, energy and power, agriculture, manufacturing, wholesale and retail services, manpower, financial, medical and educational institutions, sanitary facilities, population, housing shelter, and stockpiles." This massive database fits cleanly into Mount Weather's ultimate purpose as the command center in the event of a national emergency.

3) Play War Games

This is the main daily activity of the approximately 240 people who work at Mount Weather. The games are intended to train the Mount Weather bureaucracy to managing a wide range of problems associated with both war and domestic political crises.

Descriptions of the war games read a bit like a Ian Fleming novel. Every year there is a system-wide alert that "includes all military and civilian-run underground installations." The real,

aboveground President and his Cabinet members are relocated to Mount Weather to observe the simulation. Post-mortems are conducted and the margins for error are calculated after the games. All the data is studied and documented.

4) Civil Crisis Management

Mount Weather personnel study more than war scenarios. Domestic "crises" are also tracked and watched, and there have been times when Mount Weather almost swung into action, as Pollock reported: "Officials who were at Mount Weather during the 1960s say the complex was actually prepared to assume certain governmental powers at the time of the 1961 Cuban missile crisis and the assassination of President Kennedy in 1963. The installation used the tools of its 'Civil Crisis Management' program on a standby basis during the 1967 and 1968 urban riots and during a number of national antiwar demonstrations, the sources said."

In its 1974 Annual Report, the Federal Preparedness Agency stated that "Studies conducted at Mount Weather involve the control and management of domestic political unrest where there are material shortages (such as food riots) or in strike situations where the FPA determines that there are industrial disruptions and other domestic resource crises." The Mount Weather facility uses a vast array of resources to continually monitor the American people. According to Daniel J. Cronin, former assistant director for the FPA, Reconnaissance satellites, local and state police intelligence reports and Federal law enforcement agencies are just a few of the resources available to the FPA [now FEMA] for information gathering. "We try to monitor situations and get to them before they become emergencies," Cronin said. "No expense is spared in the monitoring program."

5) Maintain and Update the "Survivors List"

Using all the data generated by the war games and domestic crisis scenarios, the facility continually maintains and updates a list of names and addresses of people deemed to be "vital" to the survival of the nation, or who can "assist essential and non-interruptible services." In the 1976 article, the "survivors list" contained 6,500 names, but even that was deemed to be low.

Who Pays for All This, and How Much?

At the same time tens of millions of dollars were being spent on maintaining and upgrading the complex to protect several hundred designated officials in the event of nuclear attack, the US government drastically reduced its emphasis on war preparedness for US citizens. A 1989 FEMA brochure entitled "Are You Prepared?" suggests that citizens construct makeshift fallout shelters using used furniture, books, and other common household items. Officially, Mount Weather (and its budget) does not exist. FEMA refuses to answer inquiries about the facility; as FEMA spokesman Bob Blair told Time magazine, "I'll be glad to tell you all about it, but I'd have to kill you afterward."

What is Mount Weather's Ultimate Purpose?

We have seen that Mount Weather contains an unelected, parallel "government-in-waiting" ready to take control of the United States upon word from the President or his successor. The facility contains a massive database of information on U.S. citizens which is operated with no safeguards or accountability. Ostensibly, this expensive hub of America's network of sub-terranean bases was designed to preserve our form of government during a nuclear holocaust. But Mount Weather is not simply a Cold War holdover. Information on command and control strategies during national emergencies have largely been withheld from the American public. Executive Order 11051, signed by President Kennedy on October 2, 1962, states that "national preparedness must be achieved... as may be required to deal with increases in international tension with limited war, or with general war including attack upon the United States."

However, Executive Order 11490, drafted by Gen. George A Lincoln (former director for the Office of Emergency Preparedness, the FPA's predecessor) and signed by President Nixon in October 1969, tells a different story. EO 11490, which superceded Kennedy's EO 11051, begins, "Whereas our national security is dependent upon our ability to assure continuity of government, at every level, in any national emergency type situation that might conceivably confront the nation..." As researcher William Cooper points out, Nixon's order makes no reference to "war," "imminent attack," or "general war." These quantifiers are replaced by an extremely vague "national emergency type situation" that "might conceivably" interfere with the workings of the national power structure. Furthermore, there is no publicly known Executive Order outlining the restoration of the Constitution after a national emergency has ended.

Unless the parallel government at Mount Weather decides out of the goodness of its heart to return power to Constitutional authority, the United States could experience an honest-to-God coup d'etat posing as a national emergency.


