FEMA - THE SECRET US GOVERNMENT

Some people have referred to it as the "secret government" of the United States. It is not an elected body, it does not involve itself in public disclosures, and it even has a quasi-secret budget in the billions of dollars. This government organization has more power than the President of the United States or the Congress, it has the power to suspend laws, move entire populations, arrest and detain citizens without a warrant and hold them without trial, it can seize property, food supplies, transportation systems, and can suspend the Constitution.

Not only is it the most powerful entity in the United States, but it was not even created under Constitutional law by the Congress. It was a product of a Presidential Executive Order. No, it is not the U.S. military nor the Central Intelligence Agency, they are subject to Congress. The organization is called FEMA, which stands for the Federal Emergency Management Agency. Originally conceived in the Richard Nixon Administration, it was refined by President Jimmy Carter and given teeth in the Ronald Reagan and George Bush Administrations.

FEMA had one original concept when it was created, to assure the survivability of the United States government in the event of a nuclear attack on this nation. It was also provided with the task of being a federal coordinating body during times of domestic disasters, such as earthquakes, floods and hurricanes. Its awesome powers grow under the tutelage of people like Lt. Col. Oliver North and General Richard Secord, the architects on the Iran-Contra scandal and the looting of America's savings and loan institutions. FEMA has even been given control of the State Defense Forces, a rag-tag, often considered neo-Nazi, civilian army that will substitute for the National Guard, if the Guard is called to duty overseas.

THE MOST POWERFUL ORGANIZATION IN THE UNITED STATES

Though it may be the most powerful organization in the United States, few people know it even exists. But it has crept into our private lives. Even mortgage papers contain FEMA's name in small print if the property in question is near a flood plain. FEMA was deeply involved in the Los Angeles riots and the 1989 Loma Prieta earthquake in the San Francisco Bay Area. Some of the black helicopter traffic reported throughout the United States, but mainly in the West, California, Washington, Arizona, New Mexico, Texas and Colorado, are flown by FEMA personnel. FEMA has been given responsibility for many new disasters including urban forest fires, home heating emergencies, refugee situations, urban riots, and emergency planning for nuclear and toxic incidents. In the West, it works in conjunction with the Sixth Army.

FEMA was created in a series of Executive Orders. A Presidential Executive Order, whether Constitutional or not, becomes law simply by its publication in the Federal Registry. Congress is by-passed. Executive Order Number 12148 created the Federal Emergency Management Agency that is to interface with the Department of Defense for civil defense planning and funding. An "emergency czar" was appointed. FEMA has only spent about 6 percent of its budget on national emergencies, the bulk of their funding has

been used for the construction of secret underground facilities to assure continuity of government in case of a major emergency, foreign or domestic. Executive Order Number 12656 appointed the National Security Council as the principal body that should consider emergency powers. This allows the government to increase domestic intelligence and surveillance of U.S. citizens and would restrict the freedom of movement within the United States and grant the government the right to isolate large groups of civilians. The National Guard could be federalized to seal all borders and take control of U.S. air space and all ports of entry.

The Federal Emergency Management Agency has broad powers in every aspect of the nation. General Frank Salzedo, chief of FEMA's Civil Security Division stated in a 1983 conference that he saw FEMA's role as a "new frontier in the protection of individual and governmental leaders from assassination, and of civil and military installations from sabotage and/or attack, as well as prevention of dissident groups from gaining access to U.S. opinion, or a global audience in times of crisis."

FEMA's powers were consolidated by President Carter to incorporate:

- * the National Security Act of 1947, which allows for the strategic relocation of industries, services, government and other essential economic activities, and to rationalize the requirements for manpower, resources and production facilities;

- * the 1950 Defense Production Act, which gives the President sweeping powers over all aspects of the economy;

- * the Act of August 29, 1916, which authorizes the Secretary of the Army, in time of war, to take possession of any transportation system for transporting troops, material, or any other purpose related to the emergency; and

- * the International Emergency Economic Powers Act, which enables the President to seize the property of a foreign country or national.

These powers were transferred to FEMA in a sweeping consolidation in 1979.

FEMA has developed 300 sophisticated mobile units that are capable of sustaining themselves for a month. The vehicles are located in five areas of the United States. They have tremendous communication systems and each contains a generator that would provide power to 120 homes each, but have never been used for disaster relief.

FEMA's enormous powers can be triggered easily. In any form of domestic or foreign problem, perceived and not always actual, emergency powers can be enacted. The President of the United States now has broader powers to declare martial law, which activates FEMA's extraordinary powers. Martial law can be declared during time of increased tension overseas, economic problems within the United States, such as a depression, civil unrest, such as demonstrations or scenes like the Los Angeles riots, and in a drug crisis. These Presidential powers have increased with successive Crime Bills, particularly the 1991 and 1993 Crime Bills, which increase the power to suspend the rights guaranteed under the Constitution and to seize property of those suspected of being drug dealers, to individuals who participate in a public protest or demonstration. Under emergency plans already in existence, the power exists to suspend the Constitution and turn over the reins of government to FEMA and appointing military commanders to run state and local governments. FEMA then would have the right to order the detention of anyone whom there is reasonable ground to

believe...will engage in, or probably conspire with others to engage in acts of espionage or sabotage. The plan also authorized the establishment of concentration camps for detaining the accused, but no trial.

Three times since 1984, FEMA stood on the threshold of taking control of the nation. Once under President Reagan in 1984, and twice under President Bush in 1990 and 1992. But under those three scenarios, there was not a sufficient crisis to warrant risking martial law. Most experts on the subject of FEMA and Martial Law insisted that a crisis has to appear dangerous enough for the people of the United States before they would tolerate or accept complete government takeover. The typical crisis needed would be threat of imminent nuclear war, rioting in several U.S. cities simultaneously, a series of national disasters that affect widespread danger to the population, massive terrorist attacks, a depression in which tens of millions are unemployed and without financial resources, or a major environmental disaster.

On July 5, 1987, the Miami Herald published reports on FEMA's new goals. The goal was to suspend the Constitution in the event of a national crisis, such as nuclear war, violent and widespread internal dissent, or national opposition to a U.S. military invasion abroad. Lt. Col. North was the architect. National Security Directive Number 52 issued in August 1982, pertains to the "Use of National Guard Troops to Quell Disturbances."

The crux of the problem is that FEMA has the power to turn the United States into a police state in time of a real crisis or a manufactured crisis. Lt. Col. North virtually established the apparatus for dictatorship. Only the criticism of the Attorney General prevented the plans from being adopted. But intelligence reports indicate that FEMA has a folder with 22 Executive Orders for the President to sign in case of an emergency. It is believed those Executive Orders contain the framework of North's concepts, delayed by criticism but never truly abandoned.

The crisis, as the government now see it, is civil unrest. For generations, the government was concerned with nuclear war, but the violent and disruptive demonstrations that surrounded the Vietnam War era prompted President Nixon to change the direction of emergency powers from war time to times of domestic unrest. Diana Reynolds, program director of the Edward R. Murrow Center, summed up the dangers of FEMA today and the public reaction to Martial Law in a drug crisis: "In the short run, a national security state would probably be a relief to those whose personal security and quality of life has been diminished by drugs or drug related crime. And, as the general public watches the progression of institutional chaos and social decay, they too may be willing to pay the ultimate price, one drug free America for 200 years of democracy."

The scenarios established to trigger FEMA into action are generally found in the society today, economic collapse, civil unrest, drug problems, terrorist attacks, and protests against American intervention in a foreign country. All these premises exist, it could only be a matter of time in which one of these triggers the entire emergency necessary to bring FEMA into action, and then it may be too late, because under the FEMA plan, there is no contingency by which Constitutional power is restored.

Dear Mr. President:

The CIA has made a mockery out of our constitution. Our elected re-presentatives have no idea what we in the Military have done and are still doing, since the CIA decided that "they do not have a need to know," making it mandatory for all of us in the Military and Government, both active and retired, who have knowledge regarding UFOs, to testify with total immunity before a special congressional committee. The CIA can not object, because officially "UFOs do not exist."

The UFO cover-up is not in our national security interest. It should be stopped, because it hurts military morale. Our group, Justice for Military Personnel (JMP), consists of retired military personnel who were affected by, or involved in different capacities with the UFO cover-up. Under orders of the CIA, in the "interest of national security," we took part in intentionally misleading the nation, manipulating the press, the courts and most politicians.

INTRODUCTION:

The CIA UFO cover-up, is being perpetrated against the American people and not our potential enemies. The Russians have a whole town exclusively for UFO research. The CIA insists that the UFO cover-up must be kept at all costs, otherwise the military will be ineffective. The CIA correctly maintains, that military personnel will disobey orders when confronted by UFOs. For example, during the Vietnam War, pilots refused orders to fly night missions against UFOs. Since fatal accidents, UFO related, are relatively rare (with the exception of the Vietnam War), the CIA prefers to maintain the cover-up.

NSA, NASA, CIA, RAND and AFOSI associates, have informed us that UFOs have many origins. Some obviously represent civilizations, thousands of years more advanced than we are. Almost everything about them, their motives and operations are strange and incomprehensible to us. There is little we can do to protect ourselves from them. The Air Force is totally helpless to handle the situation, because of UFO's incredible flight performance. The CIA and Pentagon are bewildered by UFOs' apparent ability to jam all our ground and air electronic equipment, or instantaneously disable all our weapons control systems. The CIA has decided to try to understand and duplicate UFO propulsion systems at all cost. This means that pilots' lives have been sacrificed in UFO chases to get "UFO samples" for research, therefore 'Ignorance is Bliss.'

RAND maintains that the CIA is gambling that a major catastrophe, such as the July, 1952, mass UFO appearance over Washington, DC and the White House, will not happen again, so that no "explanations will be needed. NORAD, along with many of us in the armed forces, bitterly oppose perpetuation of this cover-up, pointing to the public panic potential of the 1952 disaster. We in the JMP feel that too many military personnel suffered or died as a result of not being informed about UFOs. It is time to tell our armed forces the truth. IT IS UNCONSCIONABLE to continue to use military personnel as guinea pigs.

CRIMES WE COMMITTED UNDER CIA PRESSURE:

Forty years ago, the cover-up was confined to a very few individuals within the Military and Government. Today, many thousands are affected or involved. This deceitful CIA policy is breeding resentment in the services, for we were ordered to act illegally, against our fellow military personnel and our nation. Our JMP group has many military personnel and others who are waiting to testify. The following are a few examples of deceptive activities we carried out while on active duty:

1: We intentionally ordered pilots to shoot at UFOs, with the hope of acquiring a UFO for research purposes. These resulted sometimes in instant explosions and death to the pilots or instantaneous "disappearances" of pilot and plane. The UFOs occupants seem to be monitoring all of our pilots' actions. We analyzed hundreds of UFO gun camera films and it seems that some UFOs are remote controlled.

2. We have strictly silenced military pilots who reported UFOs. We do not allow our pilots to discuss UFO chases EVEN AMONG THEMSELVES.

3. We interrogated, intimidated and harassed military personnel who saw UFOs, to "convince" them (excluding pilots and astronauts), that they "did not see" what they saw; frightened them with the prospect of long prison sentences if they told anyone what they saw; transferred them alone to bases around the world, where, even if they were to talk, nobody would believe them; forced some of them into mental institutions; jailed them; destroyed their military careers; did everything possible to intimidate UFO witnesses by fear into self doubt and silence.

4. We distributed fraudulent information, through Military and Government spokesmen or scientists, to debunk all public UFO sightings.

5. We forced the FAA, NASA, and other Government agencies to conform to CIA UFO policies.

6. We violated the Freedom of Information Act by hiding documents.

7. We smeared commercial pilots who publicly reported UFOs and forced their companies to silence them.

8. We did not confirm when civilian planes around the world also temporarily lost control or completely disappeared when UFOs were present. We slandered ruthlessly some of our most outstanding and competent citizens, who dared to report UFO sightings, while we knew all along that they were telling the truth, as we tracked the UFOs on radar.

10. We silenced Congressmen and Senators who requested UFO information for their constituents. These representatives are now silent partners to this cover-up and are consequently directly responsible for all the crimes we committed.

PRESS IN DEFAULT:

The national UFO debunking campaign ordered by the CIA in 1953, published books and planted hundreds of articles in the press, to create an atmosphere of ridicule around the subject of UFOs, falsely creating "UFO contacts" and "UFO" hoaxes. This campaign which is still in effect today, infiltrated major civilian UFO groups, to ridicule them or divert their efforts towards "other explanations." This UFO cover-up has been successful beyond CIA's highest expectations, due primarily to the brilliant manipulation of the press by the CIA via the ridicule strategy. The Establishment Press, afraid of being ridiculed, proved to be gullible beyond belief to "official statements."

The press, for example, in attempting to divorce itself completely from UFO data, did not question why the CIA refused to give UFO information to the then Senator Barry Goldwater, who at the time was chairman of the Senate Intelligence Committee. IF SENATOR GOLDWATER (WHO HAS BEEN AWARE OF THE COVER-UP) DOES NOT HAVE A HIGH ENOUGH SECURITY CLEARANCE TO GET UFO INFORMATION, THEN WHO IN OUR GOVERNMENT DOES? The press failed to ask, if UFOs "do not exist," why did the CIA tell Senator Goldwater that UFO data is classified "above top secret" and "above any other secret in the USA"? The CIA debunking campaign, using some of the best brains in this country, slowly "educated" most journalists that they can only be rewarded, by abandoning any sense of journalistic ethics when it comes to reporting about UFOs.

One of the most audaciously deceptive acts by the CIA involved President Carter (who himself had sighted a UFO), when he requested NASA to look into the possibility of UFO research. Until that moment, all of us who were involved with the UFO cover-up assumed that the President was informed by the CIA about UFOs the moment he entered office and that he was aware of the huge sum of money invested in UFO research since 1953. Until that moment, IT WAS INCONCEIVABLE to us that the President of the United States would be kept totally uninformed by the CIA.

At that time, NASA's scientific team concluded that the UFO cover-up should end because the public already knew that most astronauts in space photographed UFOs, or had been followed by UFOs, and that the astronauts were forced by regulations to lie to the press. Shortly before NASA's release of the news to the press, the CIA insisted on continuing to maintain the cover-up and pressured NASA to lie to the public. NASA therefore released a statement dictated by the CIA, contradictory to their own scientists' conclusions. Victor Marchetti (former Executive Assistant to the Deputy Director of the CIA), openly maintains that President Carter probably was forced to participate in the CIA's UFO cover-up. Most of the preposterous "explanations" of UFOs were originated by the CIA's debunking headquarters, and disseminated to the public mostly through the Air Force, FAA, FBI, CIA, NASA, NORAD or Pentagon spokesmen. These shocking, mind boggling "explanations" (swamp gas, stars, etc.), released usually after long delays, often constituted an insult to American public intelligence, instead of an explanation. Though these "explanations" often were not logical, scientific, or factual at all, they were eagerly accepted by the press, which was relieved to quickly dispose of "another UFO story." There were often sharp contradictions between these "explanations" and the pilots' and radar controllers' statements, which rarely seemed to bother the press, who claim to be Government watch dogs.

SCIENTIFIC COMMUNITY IN DEFAULT:

Project 'Blue Book', the 'Condon Report', and many notable scientists, are part of the CIA's cover-up. The 'Condon Report' is a scientific farce which was immediately exposed as a fraud by the late Professor James E. MacDonald (world's foremost, non CIA, authority on UFOs). The 'Condon Report' has been heavily criticized ever since by all other competent scientists (who do not work for the CIA), who actually examined the report in depth. Incredible as it seems, many in the scientific community today have not, and still regard the 'Condon Report' as an impartial scientific study. This attitude is a source of much amusement and self satisfaction in the intelligence community. This manipulation of American public opinion and the advanced mind control techniques employed by the CIA, were described by one Air Force doctor as: "Psychiatric Fascism contradictory to any democratic principles."

Now, more than ever, due to our highly sophisticated detection systems, UFOs are being detected frequently over our bases and missile silos and they have tampered with our nuclear missiles. They are being photographed in restricted areas, monitoring our military experiments.

We track them visually and/or on radar across the USA and Canada almost daily. World-wide intelligence reports indicate very similar sightings. Many of us objected long ago to this senseless UFO cover-up. But we could not do anything, because the CIA controls all our military intelligence agencies and has overwhelming influence over many Government agencies.

CONCLUSIONS:

FBI associates defined the UFO cover-up as the biggest crime ever perpetrated against our people. The CIA, in the name of "National Security Interest," has flagrantly violated the letter and spirit of the law. The Uniform Code of Military Justice DOES NOT offer our soldiers any protection regarding this cover-up. As JMP members, we are torn between our desire to maintain the military oath of secrecy and our sense of ethics as responsible loyal citizens of this great nation. Yet we are fully dedicated to preventing the UFO cover-up from continuing to be the status quo in this free nation. When our country requests us in the military to give up our lives for this land, the least the Government can do, is tell us against whom we are fighting and why. We have the right to know.

JMP CIVIL RESPONSIBILITY:


Lack of competent news reporting on this issue, has led to the creation of JMP. We feel it is our responsibility to speak up for our citizens who are still on active military duty. A RAND study indicates that, barring unforeseen circumstances, the CIA may continue the cover-up unabated under the umbrella of secrecy and ridicule. JMP members therefore have prepared a program that may effectively disintegrate the UFO cover-up. THE PERUVIAN STARGATE

[Author Paul Damon wrote the following brief article recently for the British TruthSeekers Review, then posted it to the internet without copyright restriction. Damon says he first heard of the possible "Stargate" in Peru from a Peruvian UFO researcher, then compiled additional information from various sources in Lima.]

A huge mysterious door-like structure has recently been discovered in the Hayu Marca mountain region of Southern Peru. Hayu Marca, 35 kilometres from the city of Puno, has long been revered by local indians as the "City of the Gods," and has never been fully explored because of the rugged mountain terrain. Although no actual city has ever been discovered, many of the rock formations of the region resemble buildings and artificial structures. The door, or "Puerta de Hayu Marca" (Gate of the gods/spirits), has been at some time in the distant past carved out of a natural rock face and measures exactly seven meters in height by seven meters in width, with a smaller alcove in the center at the base which measures just under two meters in height.

Jose Luis Delgado Mamani stumbled across the structure while trekking through the surrounding foothills trying to familiarize himself with the area. His job is as a guide for mountaineering tourists.

"When I saw the structure for the first time, I almost passed out," said Mamani in an interview with the local press. "I have dreamed of such a construction repeatedly over the years, but in the dream the path to the door was paved with pink marble, and with pink marble statues lining either side of the path. In the dream, I also saw that the smaller door was open and there was a brilliant blue light coming from what looked like a shimmering tunnel. I have commented to my family many times about these dreams, and so when I finally gazed upon the doorway, it was like a revelation from God... How do you make order of such a strange occurrence?"

After discovering the door earlier this year, Mamani contacted archeological authorities in Puno, La Paz and Lima. Within a short time the area was besieged with archeologists and Inca historians.

It turned out that the native Indians of the region had a legend that spoke of "a gateway to the lands of the gods." In that legend it was said that in times long past, great heroes had gone to join their gods and passed through the gate for a glorious new life of immortality. On rare occasions those men returned for a short time with their gods to "inspect all the lands in the kingdom" through the gate.

Another legend tells of the time when the Spanish Conquistadors arrived in Peru and looted gold and precious stones from the Inca tribes. One Inca priest of the temple of the seven rays named Aramu Maru fled from his temple with a sacred golden disk known as "The key of the gods of the seven rays," and hid in the mountains of Hayu Marca. He eventually came upon the doorway, which was being watched by shaman priests. He showed them the key of the gods, and a ritual was performed with the golden disk which opened the portal. According to the legend, blue light did emanate from a tunnel inside. The priest Aramu Maru handed the golden disk to the shamans and then passed through the portal, "never to be seen again."

Archeologists have observed a small hand-sized circular depression on the right side of the small entranceway, and have theorized that this is where a small disk could be placed and held by the rock.

Some individuals who have laid their hands on the small door [report] a feeling of energy, as well as strange experiences such as visions of stars,

DENTAL TECHNICIAN SAYS "MANDIBLE" MAY BE ALIEN

[John K. Mosgrove is a 67 year-old dental technician currently living in Richmond, Indiana. In 1979, he says, while working at a Veterans Administration hospital in Dayton, Ohio (about a 30 minute drive from Wright Patterson Air Force Base), he was assigned the task of replicating a strange mandible, or lower jawbone, taken from a creature of unknown identity. Under orders to remain silent, he told no one about these events for over 14 years; but he did create additional copies of the strange mandible for future study. Recently, several researchers have looked into the claims of John Mosgrove, including the late Leonard Stringfield, who discussed the case in his "UFO Crash/Retrievals: Status Report VII." Television newsman Carl Day of Dayton's WDTN Channel 2 also ran a special report on Mosgrove in 1995 and has continued to investigate the possible legitimacy of the "alien" mandible. CNI News first learned of the mystery mandible in the fall of 1995 from an intelligence source who sent us both text and illustrations over the internet. This material is posted on the CNI News web site at www.cninews.com/CNI_FTDalien.html. In early October, 1996, CNI News editor Michael Lindemann interviewed John Mosgrove by phone, then interviewed newsman Carl Day and another dental technician, Bruce Phillips, who is also familiar with the mandible. This is a summary of the information gathered from those interviews. Michael Lindemann's comments are in brackets. All other text is directly quoted from the interview subjects.]

John Mosgrove: I worked for the VA center at Brown Hospital in Dayton, Ohio. It was on a Thursday afternoon in October 1979. Now usually on Thursday afternoons it's pretty quiet in the dental center. Normally we would have a movie or seminar, or a study. Or, if we were running behind, it would be a good catch-up day. And I had just gotten back from lunch, and it was about 1:00 in the afternoon. At that particular time I was alone in the dental laboratory.

I was sitting at my bench and I was working on an upper and lower denture for a veteran, and I had just completed what I had to do on it when the Assistant Chief of Staff walked in. And he says, "Are you busy?" I said, "No, I just finished." He says, "I want you to take this impression and pour it up with Kwik-Set. I need it right away." I said, "Okay. Where's the prescription?" He says, "I haven't made it up yet. I'll make it up and give it to you after a bit." I said, "Okay."

The normal procedure when you do an impression is to go over to the sink and rinse it off, to rinse out the saliva, the debris, the blood, you know. [Later] I realized [that] when he handed that to me, he put [it] in my hand upside down so that I didn't look at it. I did not get a good look at it until after I pulled it out from underneath the running water. I shook it out and I thought, "My god, what have I got here?" I was amazed. I'd never seen anything like it before in my life.

And I started studying it, looking it over real good as I was walking to the plaster bench where we do pour-ups, and I thought, "My god, really, this is edent ["edentulous," or without teeth] because there is nothing but bone here."

I went ahead and poured it up with Kwik-Set plaster, made a nice padding for it, turned it over and set it on the padding. That stuff sets up real fast. The doctor, when he came back in, went over to it and separated the tray from the model, looked at it, and he was very happy with it. He took it over to the model trimmer, trimmed off the flash around it, dressed it up to make it look nice. He laid the impression tray on the plaster bench. I thought, "Boy, I've gotta have another one of that. I've just gotta have that." And I think that man was reading my mind because he picked up [the impression] in his right hand and crushed it, and threw it in the waste container. Then he started to walk past me again, and I said, "Doctor, wait a minute. I've got to have that prescription." He says, "John, you never worked on this, you never seen it, and you never talked about it. Okay?" And then he left, and went out the door.

So I thought, "Well, crap."

Anyway, I walked over to the door and I peered out the little window in the door. There was a Major and a Lt. Colonel in full uniform. [The doctor] handed that to them, shook hands with them, and they left. Now, the Lt. Colonel I'd seen before, and I always tried to decide where it was. It was either at the VA Hospital or it was at Wright-Pat.

But, anyhow, they had left. I waited a second or so, and I went out there, hoping that I would see something more. I walked from the laboratory all the way down to the Chief of Staff's office. Now, along that corridor they have operatories and surgical rooms. There was not a soul on the floor. No patients, no doctors, no nurses, no chair-side girls, no hygienists. Nobody was on the floor. That was very unusual.

I went back into the lab, because I got a little nervous about being down there. I couldn't have explained why I was way down by the Chief of Staff's office if I was caught out in the hallway. So I went back to the lab, and the chief of the lab came back and he had sort of a crappy grin on his face. I said, "You'll never guess what I just worked on." And he said, "You had something unusual, huh?" That was all the conversation. I didn't talk about it any more because I was afraid I was going to get into trouble if he told the Chief [of Staff] that I talked about it just after he'd told me not to. But I think he knew.

Well, I retrieved the pieces [of the original impression] out of the trash. [Mosgrove digressed at this point to explain that a "custom-made tray" had been used to create the impression. Normally, manufactured trays are available for varying sizes of human jaws. The tray holds the soft, rubber-based molding material as it is pressed into the teeth to form an impression. But in this case, Mosgrove said, "You couldn't have got a manufactured tray in there to get an accurate impression because it (would be) too damned big. (Even) a small child's manufactured

tray wouldn't have fit because it would have been rubbing up against the bone." Mosgrove then continued explaining his recreation of the mandible model.] Mosgrove: I got it back together, and also drew diagrams of it. I must say I didn't get exactly what I wanted at the end result [because it had been so badly crushed]. But what I did get was the shape of the jaw. [Mosgrove indicated that there were apparently three "teeth" still in the jaw bone.]

For lack of a better word, I'm gonna call these "teeth." They were all flat, as near as I can figure. They're not meat-eaters [referring to the "original owner" of the mandible. Mosgrove explained that there were two apparent "molars," one on each side, and one tooth in front. The front tooth, which in a human would be a sharp-edged incisor, was "perfectly round" and flat on top.].

Mosgrove: I could tell from the original impression that this person, or whatever it was, was in a terrible accident, or got hit, because of the bone fragments. This thing had a terrible hit in the face, like slamming into something. The main part of the force that hit the face would have been more to the upper than the lower. This knocked the teeth out but it didn't break the mandible. So that means an indirect hit. If there was anything broken on this lower arch, it would have been the hinge and not particularly the jaw bone.

[Lindemann asked Mosgrove if he had compared the anatomy of the mandible with other known primate anatomy.]

Mosgrove: Yeah, I've done it and so has Carl Day. Carl Day has sought out top people in that field, and they can't come up with anything. There is nothing to compare it with in the animal kingdom. Not at all. And I know it's not human. And I also know that there was no bone graft, so this was solid bone, all the way around, which eliminates any surgical operation or anything like, [so] it's not a hoax.

[Lindemann asked Mosgrove why he thought the military had brought the mandible to him, a civilian at Brown Hospital, some distance from Wright Patterson Air Force Base.]

Mosgrove: This [was] damned unusual. Why did they bring it all the way out there when they had a dental laboratory right there on base, a nice, big clinic? I don't even have a high security clearance. [But] there was a lot of scuttlebutt going around on base, and if they'd taken it to the dental clinic on base -- heck, they could just as well say, "Yeah, we got it." Only one time did I hear any scuttlebutt that I really believed. There's a radio station there in Dayton, one of those talk shows, and I heard them talk about it on the radio. And, boy, they got quieted right away. I'm sure the government quieted them down on that.

Now, Carl Day I think had a little more information than what I had, because I asked him, "What do they say it is?" And he says, "Alien." And, not only that, Carl Day came up with [a] photograph [actually an illustration of a "gray" alien] after all of this occurred, and I didn't know that he had it. He had a luncheon or a dinner with Air Force personnel. And when he held that mandible up to the photograph, they got very upset and then jumped out of the chair.

[Mosgrove had given Carl Day one of the three existing models of the mandible.]

Not only that, in 1978 they had a seminar on aliens and UFOs at Wright Patterson Air Force Base, and Carl Day knew about that. [It was] only for military personnel.

[Lindemann asked Mosgrove why he decided to talk, and whether he had experienced any repercussions.]

Mosgrove: I was sort of ticked off at the Federal government anyhow. So I didn't give a damn. I'm sort of worried about it now, but at that time I guess you should say I had an attitude problem and decided to go for it. I've been told that I talk too much. And I'll tell you something else that happened in 1982. My house was shot up.

I don't know if that's related to it or not, but at that time I was really getting into this UFO thing and I was talking quite a lot, and then one morning at about 4:15 a.m. my house was shot up. And it scared my wife to death. My wife told me to keep my mouth shut. But the Sheriff's Department could not substantiate it to have any connections with what I was doing or saying or. They never came up with any answers, don't know who shot my house up. But the evidence is still on the outside. A shotgun blast [destroyed] the whole front window. Fifteen minutes later my wife would have been walking through there because she works at the hospital. It could have killed my wife. But that's the only thing I've had happen -- other than I lost a job. I took a break from dentistry because I was getting burned out, so I got a job in security. I worked at this place for about two or three years, and then all of a sudden I was fired. That was after my interview with Carl Day. I was working at Kemper Division. And they came up with a cock-and-bull story that I sexually harassed a woman. I've never even seen this woman. I was so mad, I was crying. I can only talk to my wife about it. They wanted me to sign papers that I did it, and I refused. I told them to go to hell. I didn't do anything like that. I know I was set up. And everybody who knows the story knew that I was set up.

[Before concluding the interview, Lindemann asked Mosgrove for a more detailed description of the mandible and how it compared to a human jaw.] Mosgrove: From your second molar to your canine tooth is pretty much a straight line. But this thing's shape, from the second molars, starts out a little wide, then the bone goes concave, and then it straightens out and comes around the lower incisor area. It curves inward, down to the incisor area, and then it goes right across, which indicates a very small mouth, and a very narrow tongue, like a lizard's... I'm really curious about the tongue... If it has a tongue at all, it has to be narrow. I've never seen an alien. But due to the shape and the contour of this thing, and considering where it came from, I don't know what else it could be. It's not animal, and I know it's not human. It's not a freak. Air Force don't deal with freaks. And... this mandible has been around for awhile, because you could see the pit holes in the bone from being dried out. I think it's been around for at least 50 years.

[After interviewing John Mosgrove, Michael Lindemann talked with Dayton television newsman Carl Day about his own investigation of the mandible case. Day said that Mosgrove had first called him after Day broadcast a news report on "legends of Wright Patterson." Day interviewed Mosgrove on camera in February of 1995. However, in the news special that he later broadcast, he did not show

Mosgrove's face or use his true name. Following are excerpts of Carl Day's remarks to Michael Lindemann.]

Carl Day: I took an open minded view of everything. I checked John out, talked with people who'd worked with him, double checked at the VA hospital (Brown Hospital in Dayton). Yes indeed, he had worked there during that time period. Yes, people remembered him. No, he was not crazy -- things like this. Then when I spent time with John in his home, I just let him talk, and it was an absolutely amazing story. He was the first to admit he didn't have any idea what [the mandible] was.

[By the time Day met Mosgrove], Len Stringfield was dead, so I thought somebody's got to pick up the ball and see if we can get some more answers. So I told [John] I would, and he gave me a copy of [the mandible]. I've since taken it around to anthropologists, archeologists, forensic dentists -- and to date, nobody has really given me an answer as to what it is. At one of the museums where I was talking to several anthropologists, we went through all of their books together, trying to find a match. The closest we could find was a lemur. But the teeth don't match. The shape of the jaw also does not match. There's a lot of stuff that doesn't match. I don't know what it is. And the circumstances around it... it is either a very elaborate hoax - perpetrated in this case not by John, but by whoever the officers were, for whatever purpose -- or he's on to something, and somebody goofed. It still raises a heck of a lot of questions.

A friend of mine is one of the leading dentists in Ohio. He's seen it and he's fascinated by it. Can't come up with anything there. I've got an appointment in the next few weeks with a gentleman who specializes in reconstruction -- they find bones out in the field somewhere, and it's his job to reconstruct it to what it probably was. He's anxiously waiting to look at it. But so far nobody has been able to give me any answers. At this point, the weight is still toward the unknown, rather than toward the known... A lot of these people I've talked to are very reliable individuals, and there is something going on. I don't know what. There's a lot going on at Wright-Pat. I had sources at Wright-Pat that were pretty reliable who really wanted to get to the bottom of it. Even with their clearances, they couldn't find anything.

[At the urging of John Mosgrove, Michael Lindemann also interviewed another dental technician, Bruce Phillips, who lives in Richmond, Indiana, and has seen the mandible. Following are excerpts from that interview.] Bruce Phillips: I came in contact with the mandible from John. He showed it to me one day and asked me to take a look at it to see if I've ever seen anything that looked like it, like a chimpanzee or a gorilla mandible or whatever. I looked at it real well and looked into some books to see if anything could possibly resemble the shape of this mandible, and I haven't come across anything yet. I do have my degree in dental technology. We did study a bit about different mandibles.

I don't think anyone knows what it is for sure. With the story John has, it being so secretive, I have to think it would be something in the classified area. There's no other reason for the officer to come back in and destroy the impression, crumple it up.

I was stationed at Wright-Pat from the latter part of 1971 to 1975. I have a suspicion that they were keeping evidence of ...crashes there. When I was stationed there and working in the dental clinic -- this would be late 1974, probably -- I was cleaning teeth then, and I got people from all different parts of the base as patients. I had an officer, a Major, come in. And [at that time] there was speculation in the local paper that there were aliens being kept on base to be analyzed. I was not a believer then. I just kind of made a joke with that officer who came in, because it was supposed to be in his area -- I think it was the AFIT organization -- where they were supposed to be kept. And I was joking with him. I said, "What about those little green men you're supposed to be hiding? Is there any truth to that?" He got a real serious look on his face, looked over at me and said, "I'm not going to say that it is true, and I'm definitely not going to say that it's not true." He was totally serious. Why he said that to me, I have no idea. I think he was wanting to tell somebody. That's the only thing I can think of. I said, "Can you give me a little bit further... Are you serious?" He said, "That's really all I can say." I said, "Jeez, you're saying that if it definitely wasn't true, you would say it wasn't true." And he said, "Yes." I could not believe what I was hearing, actually. That kind of stuck with me. That kind of relates back to John's story of the mandible. He was working at the VA in Dayton at that time. It would make sense that if anything was going to be poured up, they would not do it in the dental clinic [on base], because it would just spread all through the organization. So they took this thing off base to the VA center to get poured up, hoping that no one would think anything of it. That's the only thing I can come up with. They had a wonderful dental facility on base. But with the rumors going on base, if we bring something that they're not used to seeing, and be all secretive, it would spread like wildfire. This is only my speculation. I would say [the creature] was a vegetarian. The teeth that were left in the mandible were all flat-planed, which would mean that there was no reason for incisors to tear. Just a kind of grinding was all they would need, which would mean to me that they were plant eaters. The most striking part of the thing was the shape of the mandible. If you would put tissue on this -- you know how you see on TV when people have drawn aliens and they all have little, real pointed chins -- that's exactly how it would look. You would have a pointed, very small chin area, and wider where it connected to the temporal mandibular arch.

Nothing I've ever seen looks like it. Can I say it's alien? No. But I have to say there is something hush-hush about this mandible. Putting two and two together, that makes me very suspicious.

[CNI News has received additional commentary on this case from other sources and seeks further information on the possible identity of the mandible as well as the possible military involvement with it. We will report new findings as they become available.]

Philadelphia Experiment by Brad Steiger

First of all I would like to start out by saying that all I know is what I read. I have absolutely no insider information on anything related to the legend of the Philadelphia Experiment, ETs or UFOs. While that may be true, I do get gut-feels on things and the purpose of my letter is to relate these feelings.

While I will always describe the Philadelphia Experiment (PE) as a legend, if there is truth to this legend, I believe that it is the central, focal point regarding the reported stories concerning ETs.

I have included a section of Brad Steiger's book on PE which I would recommend as one of the books to read several times cover-to-cover. This section potentially uncovers some myths. These include the following:

- The first "Treaty" was not with Truman, but rather with FDR. This, to me, makes sense because the United States was in a very vulnerable position with the threat of Nazi Germany. FDR would be at a point of desperation willing to trade "alien technology for certain planetary privileges". I might add that the "treaty" certainly was not legal because it did not abide by the terms of the US Constitution. Therefore, this "treaty" does not need to be recognized by other alien confederations.

The "treaty" was made with the "K-Group". I believe we need to be careful here because it is not species that we are dealing with but rather confederations. To check out what confederation is being dealt with is to identify the character and actions of a given group. Both the Pleiadean Confederation and the NU (Galactic) Confederation believe in and adhere to the law of noninterference. Therefore, they would not exchange anything for technology until a planet has evolved to the stage where it could handle that technology. Even in 1996 the inhabitants of this Earth, in general, have a considerable way to go to become law-abiding and respecting the rights of others. What I mean by this is that I believe that the Law regarding the rights of other people needs to be written in a person's mind and heart so that the actions of that person coincide with the belief structure. Now, when we talk about the "K-Group" appearing human, that does not make them the good guys, for the Draco Confederation has people who appear to be quite human. Since this "treaty" would break the law of noninterference, there is only one group that does that, and that is the Draco Confederation. The Draco Confederation is also called the Leverons or Orions. I recognize that this gets complex because of the number of names involved; but if we just keep looking at character, we can identify the good guys from the bad guys. Thus, I believe it is a myth to presume that any ET species by itself is either good or bad, and that just because one might be dealing with an ET species that looks human does not necessarily mean that the ET is either trustworthy or honorable.

- There has also been a myth that we had no choice but to make such a "treaty". You will note in what is stated below that Bielek stated that FDR met with the Pleiadean group first. Since the Pleiadean group was not going to violate the law of noninterference and exchange technology for anything, they were passed over in favor of the "K-Group" which undoubtedly represented Draco.

As an aside, from what I read and my gut feel, the law of noninterference is very meaningful to the two ethical confederations. This law probably is not necessarily simplistic but rather complex just like most of the laws we have here in the U.S.

The following comes from the book, The Philadelphia Experiment and Other UFO Conspiracies, by Brad Steiger. This portion is the beginning of chapter six called Ripping A Hole In Hyperspace.

When the Eldridge dematerialized in 1943, it ripped an enormous "hole" in Hyperspace, "forty years wide," according to Al Bielek.

"This tremendous tear in time allowed a vast contingent of aliens to enter our space-time continuum," Bielek said. "At first I thought this had just been a peculiar side-effect or by-product of the experiment. Now I understand that the whole thing was a set-up."

A set-up? By whom?

Bielek's voice takes on the tone of one annoyed by an unpleasant memory: "Extraterrestrials. The whole Philadelphia Experiment was set-up by an alien group that had met with President Franklin Delano Roosevelt in 1934."

Whoa! Roosevelt? FDR? We all know about the allegations that President Harry S. Truman set up the secret study group known as MJ-12, but now we're talking about a meeting with a U.S. President and aliens that allegedly took place thirteen years earlier.

FDR'S Secret Treaty With The Alien "K-Group"

Bielek is adamant: "Yes, FDR met with aliens somewhere in the mid-Pacific--I believe it was on board the Pennsylvania. He signed an agreement that would exchange alien technology in return for certain planetary privileges." Was this treaty with the "Greys," the large-eyed, insectlike entities that have become popular extraterrestrial villains in the UFO Abduction cases circa 1965-'90 (and especially after Whitley Streiber's best-selling book, *Communion*, in 1987)?

Bielek is certain that the so-called "Greys" were not involved in this particular agreement.

"The treaty was made with a group that I'll just label the 'K-Group,'" he continued. "These aliens can pass for humans, although their skin tend to have a slightly greenish tint. Because of this tendency, they often 'bleach' their epidermis white in order to pass among us as human beings."

Bielek reflected that FDR had been "mildly psychic" and quite interested in other-worldly subjects. On occasion, his wife Eleanor was known to have sought the counsel of astrologers. "The meeting between FDR and the aliens had been set up by Nicola Tesla, who had himself been in contact with alien intelligence since the late 1920s and the early '30s, ever since he created the huge radio receivers for RCA."

Bielek commented on the peculiar fact that although the genius Tesla had been communicating with entities from the Pleiades, who appeared to be completely human, issuing from the same original stock as homo sapiens, the meeting arranged for FDR was with a Pleiadean group first, then later with the "K-Group," a "nearly" human species.

Almost immediately after the President of the United States signed the treaty of mutual noninterference, our science enjoyed a remarkable acceleration of theory and application on nearly all levels of material application.

A NEARLY SUCCESSFUL "PHILADELPHIA EXPERIMENT" in 1936

"A partially successful test in invisibility was accomplished by the research group at the Institute for Advanced Study at Princeton as early as 1936," Bielek claims. "The instrumentation seemed correctly situated, but I don't think the aliens were much concerned at this point. There was a great deal of research yet to be done.

"You see, they had been making a careful study of the Earth's biorhythmic cycles for decades, if not centuries--something that our science didn't really get into until around 1985-'86. They wanted the experiment to take place exactly when it did in August 1943 so they could tear that massive hole in Hyperspace."

By strange coincidence--if coincidence--a UFO crashed in Germany in 1936. "Since the craft was more or less intact," Bielek said, "the artifact greatly stimulated Nazi science. We know that they had replicated many of the spacecraft's facilities and functions by 1944. Fortunately, for the enemies of the Third Reich, the Nazi scientists were never able to crack the problem of the UFO's basic drive mechanism. Plans for such circular craft were found by the Allies when they invaded Germany and seized Peenemunde, one of the Nazi's major rocket plants."

THE PHILADELPHIA EXPERIMENT WAS AN ALIEN SET-UP!

According to Al Bielek, the bottom line on the Philadelphia Experiment is that it was all a set-up by aliens of the humanoid "K-Group" to create an opening for extraterrestrials to have easy access to Earth.

The U.S. Navy, the many scientists assembled, the government officials privy to the secret experiment were all laboring under false assumptions when they believed the efforts to be an attempt to achieve invisibility for U.S. military vessels.

"Yes," Bielek repeats his statement, "we were working to achieve the goal of invisibility, but the aliens among us had a much larger and more self-serving goal in mind--to tear a 40-year-hole in Hyperspace."

After the last terrible effort when the lives of so many Navy men were lost, the Philadelphia Experiment was officially shut down.

Do we have a problem with the time continuum? Does the time vortex still need to be fixed?

If the Philadelphia Experiment occurred, what could be its greatest significance? Could the answer to this question be that the Philadelphia Experiment was an alien set-up? And could these aliens from the "K-Group" have represented the Leveron Confederation or sometimes referred to as the Draco Confederation or Orion Confederation? Is it true that the Leveron Confederation essentially consists of reptilians and Greys who represent the dark side?




ALIENS from outer space may be visiting Britain, the Government has sensationally admitted. CREW FAIL TO SHOOT UFO ON SIGHT


A BBC natural history programme turned, I learn, into something from television's The X-Files. Sarah Byatt, assistant producer of the forthcoming series Spirits Of The Jaguar, out in December, tells me: "We were filming ancient Mayan temples in Mexico when suddenly we saw a terribly bright light in the clouds, shaking from side to side. It suddenly got brighter and disappeared. My cameraman swears he saw a porthole and a cabin." So all this is captured on film? Alas, no. "Our cameras were fixed on time-lapse for a sunrise," says Sarah. So surely someone got out a box Brownie? 'Fraid not. "It all happened so quickly," wails Sarah. The truth is out there, as they say in The X-Files.

SIGHTINGS COULD BE SECRET MILITARY AIRCRAFT Follow up from :

SUSPECTED UFO sightings over Fleetwood could be of a top secret military aircraft being tested off the Fylde coast. Fleetwood UFO expert Jenny Randles said she and others had been tracking recent sightings because of the sheer volume of local reports. And she said the indications were the craft was flying out from the Warton area where British Aerospace tests fighters. Jenny believes the craft could be a covert, British version of the US Stealth bomber, an unmanned craft she believed to be called HALO - High Agility Low Observability. But a spokesman for British Aerospace insisted that no aircraft had been flying on the days the UFO sighting had been logged. The mystery object has been described as a bright light which hovers in the air, zig zags for a minute, and then shoots off at an incredible speed. Apart from three recent sighting in the Fleetwood area, there have been reports all over the Fylde Coast. Jenny, a television UFO investigator and writer, said that if the object wasn't part of a secret British military project, the possibility of it being extra-terrestrial couldn't be discounted.

THE SQUIGGLES NEAR THE BRIDGE AN ALIEN MESSAGE ?

IT's bright. It's white. And they say it has taken fleeting residence above a house in Liverpool's Knotty Ash. It might not be X-Files material but it is being submitted as evidence of Merseyside's UFO credentials. The object is said to be a UFO in a hurry. It floated in for a couple of minutes before disappearing into the night. Luckily, for posterity, an 18-year-old student spotted the phenomenon, grabbed a camcorder and captured the "event" for analysis by UFO experts, although the film quality is too poor to allow reproduction here. The film was confirmed as genuine, and not the result of an elaborate photographic hoax. But researchers from the British Unidentified Flying Object Research Association (BUFORA) still had to carry out a series of rigorous checks on the footage. A simple explanation for the light could have been a bright star or planet visible in the night sky. But astronomic charts for the region and date have shown there was no chance that the object could have been a heavenly body. Other possible solutions, such as weather conditions or aircraft, have also been checked and discounted. An unusual aircraft may also hold the truth behind a bizarre sighting experienced by a middle-aged woman on Speke Road, Liverpool. She claims she was forced to drive at 90 mph to escape the attentions of a massive shining disc that followed her car all the way to the Runcorn Bridge. The witness alleges that the object displayed "squiggly" writing underneath perhaps the letters of an alien language? Despite being within one mile of Liverpool Airport, inquiries aimed at explaining the sighting as an aircraft have drawn a blank. The clear night skies also suggest it is unlikely the strange vision can be dismissed as lights reflecting from clouds or other meteorological effects.

RETIREED businessman Raymond Hampson said his days of being a sceptic are over after he saw a UFO circumnavigate Taunton. Insomniac Mr Hampson, aged 82, of Palmerston Road, Taunton, was awake at 3am last Friday when he heard a droning noise in the sky. He thought it was an aircraft and stayed in bed but after a while got up to look out of the window. Mr Hampson told the County Gazette: "I couldn't believe what I saw. It was absolutely fascinating. I was looking up at this huge object sideways on. It was a large circular object with a ring of blue lights and a much larger wing of orange and red lights. The red lights kept flashing. It was so clear I could draw it. I think the object I saw was just camouflage for the larger power unit inside." Mr Hampson has reported his sighting to the National UFO Society and is hoping to see a local representative this week. "Seeing this was just as exciting as when I watched tests of planes with no propellers at Farnborough during the Second World War!" Sightings of UFOs are becoming more commonplace as many people are less afraid to speak out. This week there were press reports of strange sightings in the Trull area of Taunton kept under wraps since 1962.

UFO researchers in North Yorkshire are investigating their most bizarre case yet - the alleged abduction by aliens of a family of four. According to Andy Rayner, who heads Yorkshire UFO and Paranormal Research, the family are terrified by their experience and just want to get to the truth. The story begins in June 1995, when the family - two adults in their 40's and two teenagers - together with a family friend were holidaying in Brittany, France. They had just been for a meal and were driving back to the farmhouse where they were staying when they saw a strange light in the sky. They pulled up and this light was about 30 to 40 metres behind them. It was illuminating the road with a green, hazy light. They could make out that it was a solid object," said Mr Rayner, of Ulleskelf, near Tadcaster. A car came towards them and at this point the 'craft' became transparent. When the car went past it appeared again. The family drove on and the 'craft' disappeared. It later reappeared, after the family had passed through the village, and landed in a field. They stopped the car to watch the craft, which they describe as being the size of a detached house and of being rhomboid in shape. All of a sudden everyone became terrified. They drove off again and the 'craft' started chasing them down the road until they got to the farmhouse. It then disappeared. The strange thing was that the journey from the restaurant should only have taken five or ten minutes, but two hours had passed!" When they returned to their home at Hornsea, on the Yorkshire coast, the husband started having nightmares about strange 'grey-coloured' creatures doing tests on him. Then just over a week ago his wife experienced something she described to Mr Rayner as "quite terrifying". While lying in bed, she felt something sharp enter her neck. She put the light on to see if there was anything there but there wasn't. She then went into the bathroom and saw there were four small holes in her neck, said Mr Rayner. "Her husband then told her he had a weird dream that she was having something put into her neck, but he was being held down so he couldn't help." She went to her GP, who examined her and confirmed that there were small pinpricks on her neck behind the left ear. He said they looked like they had been made with a scalpel. But the strangest thing was the doctor found a small scab behind her other ear which looked like it had been there a while. The incident is still being investigated. The family seems 100 percent genuine. They have written to both the British and French governments asking for an explanation but so far they have not got anywhere. All they want is the truth.

BAFFLED BY UFO

Aviation experts are baffled by a fast moving, shining object seen by two policemen as it flew over North Norfolk. Air traffic controllers have no logical explanation for the luminous oblong shape which the pair tracked for 10 miles. Sgt Steve King and PC Andy Collier stared in disbelief as the UFO with red, white and blue lights darted across the sky, but they lost sight of it when it hovered over Cromer and then sped out across the North Sea. The policemen, stationed at Fakenham, were left "mystified" by the object, which they followed from near Holt to the coast. The sighting is the latest in a series in recent weeks that have not been satisfactorily explained. Just two months ago a tanker crew tracked two sets of strange coloured lights hovering in the sky off the East Anglian coast. The sightings by the tanker Conocoast near the Wash prompted an investigation by the Ministry of Defence. But UFO sleuths accused the MoD of staging an X-File style coverup and dismissed the official explanation that the mystery lights were caused by a combination of the Boston Stump church tower and an electrical storm over the north sea.

There has still been no conclusive explanation for the so called Boston Stump UFO. Meanwhile, colleagues of the two officers were so intrigued by the craft with bright white and red lights that they contacted Norwich Airport. A spokesman for the air traffic department said yesterday: "They phoned up and spoke to the controller at about 6:15am on Sunday. It certainly wasn't anything from the airport. It's recorded in the book as a possible UFO sighting." Colleagues at Fakenham police station say the two officers are treating the sighting seriously. PC Collier and Sgt King were not available to comment yesterday but would like to know more about the UFO sighting at 4.40am on Sunday. BOOK REVIEW

LEFT AT EAST GATE by Larry Warren and Peter Robbins. A first-hand account of the Bentwaters - Woodbridge UFO incident, its cover-up and investigation. (Michael O'Mara Books, 1997 - £15.99)

This is, in a sense, two books in one. There is the autobiographical account of his life, before, during and after the incident by Larry Warren and there is also an account by Peter Robbins of his researches over ten years, seeking confirmation of his co-author's claims. The contribution of each is distinguished typographically, Robbins' work being printed wholly in italic - not a happy solution, as it tires the eyes. A different font would have served the purpose better..

The Rendlesham incidents have sometimes and with reason been dubbed "The British Roswell", for although the human participants were all members of the armed forces of the USA, the actual incidents all occurred in British territory or airspace, outside the limits of the RAF bases on lease to the Americans, who were using them to store their main supplies of tactical nuclear weapons. December 1980 was, it will be recalled, a time of some international stress, with Soviet forces massing on the Polish frontier as the Solidarity trade union made its bid for power.

UFOs pouring down energy beams into the weapons storage area, with one apparently malfunctioning and thrashing about in Rendlesham forest; the same or another surrounded by US forces, emitting harmful radiations as its occupants allegedly arranged with the local commander for technical help - this was the scenario generally depicted. Remarkably, none of this was subsequently held by the British MoD to be of any military significance.

Larry Warren emerges from his book as a credible witness, a stubborn "whistle-blower" whose revelations brought him involvement with the NSA and inevitable grief, while the painstaking and well-documented researches of his co-author wrestle bravely but inconclusively with the web of half-truths and intelligence cover-up in which the happenings have become enwrapped.

We don't even know the exact dates the main events occurred, but it is clear that the governments concerned are determined to keep hidden from their respective peoples for as long as possible the truth about these happenings: we can only suppose, therefore, that this truth would, if revealed, be a cause for considerable concern.
