

**T**he assumption underlying conspiracy theories, especially those in the field which is our peculiar concern, is that various clandestine organisations, usually world-wide and often including national governments, are engaged in operations detrimental to the welfare and interests of the governed, who would be outraged and angry if they were to discover what is in fact being done by those who have power.

Undeniably and necessarily, all governments have ongoing programmes, especially in the field of national security, which are justly classified into various levels of secrecy. Equally, the mere existence of such covert operations inevitably invites suspicion that if we, the excluded citizenry, knew what they were doing we probably would not approve of much of it. This suspicion, that the ruling elites are exploiting and deceiving the masses is endemic, unavoidable and only too often found to be justified.

Though governments are in many areas often inefficient or incompetent, the maintenance of secrecy is one in which they are generally ruthless and successful. In the former Soviet Union the only really effective arm of government was the KGB, which was able to ensure that betrayers of secrets would be eliminated and their revelations discredited. It is an open question to what extent other nations operate similar sanctions.

Secrets, however, do get discovered and published, usually in a form which makes it difficult or even impossible to establish their validity. Much of the material presented in this issue falls into this category. Some of it is certainly true. Members will have to decide for themselves what, if anything of it, they believe. The truth, as Mulder has always assured us, is out there - but exactly where he seems not to know!

## ROSWELL EYEWITNESS "INTERCEPTED"

Roswell's UFO Museum Puzzles Over One That Got Away

It is the kind of story that raises, then dashes, a UFO researcher's fondest hopes. It is the kind of story that stokes legend and breeds paranoia -- and leaves many burning questions unanswered.

A credible-sounding witness to the Roswell UFO crash of 1947 is on his deathbed. His adult son, never privy to the father's dark secret until recently, calls the Roswell UFO Museum, hoping someone will hear him out and understand what he's saying. The old man has some important information - and an artifact. Personnel at the museum are intrigued but cautious. They've heard this kind of thing before. But in a second phone call, the old man himself tells a story full of tantalizing details that seem to ring true. Arrangements are made for a meeting in Oklahoma. Everyone emphasizes the need for confidentiality and security. The son is particularly concerned for the welfare of his father and other family members. Precautions are taken to insure that identities and plans are protected.

But the precautions are thwarted. The planned meeting does not take place. Instead, the museum representative, who has driven hundreds of miles, finds himself unable to locate the son or the father. He waits impatiently in his hotel room, waiting for a message that does not come.

Instead, he receives a totally unexpected phone call. He is directed to a nearby restaurant, there to meet two people he has never heard of before. At the meeting, he is told that the two are government agents, but their real names and exact affiliations are not disclosed. They explain to the museum representative that they have intercepted the father and son, who are now cooperating with the government.

The agents tell the museum representative that the Roswell incident is real. However, they say, it is not yet time to allow such things as a real alien artifact into the light of day. The museum representative goes home puzzled, scared -- and empty-handed. Further efforts to contact the father and son are unsuccessful. This, in brief, is a sequence of events that really happened earlier this year. At least, this is the story told by Dennis Balthaser, Operations Manager for the Roswell International UFO Museum and Research Center in Roswell, New Mexico. Balthaser himself was the museum representative who drove to a town in Oklahoma, intending to meet the father and son who might -- just might -- turn over a real piece of the Roswell UFO. Balthaser says that his planned meeting was "intercepted." Balthaser first told his full story in a public lecture at the Roswell UFO Museum on October 11. He has provided CNI News with a complete text of that lecture.

Balthaser says that the man he refers to only as "the son" first called the museum in late May. The son said that his father had just told him an astonishing story.

The son had never had any interest in UFOs and knew nothing about the Roswell incident of 1947, he said. After hearing his father's story, he first tried to contact the Roswell Army Air

Field where his father had once been stationed -- not even realizing that that military facility was long gone. In due course, he was directed to the Roswell UFO Museum.

During the initial phone contact, the son gave many details that he attributed to his father. Museum personnel took extensive notes during the phone call. Balthaser says the son told them the following: The father had been assigned to protect a live being that had arrived from another world.

The father showed the son a strange metallic object which had been stored for years in an old footlocker. The father had kept the footlocker with him at the nursing home where he had lived since being diagnosed with terminal cancer.

The son said the metal piece was the size of a half dollar and looked like chewing gum foil. He said that when it was crumpled up and then released, it unfolded itself, leaving no creases. The father described a heavily armed military unit that had accompanied an ambulance back from the site of an apparent crash in the desert. The site, he said, was 45 or 50 minutes' drive from the airbase.

The father said he was assigned to help guard the back entrance to the base hospital. In that position, he watched as a being the size of a child, but deformed, walked under its own power into the hospital.

The father said all regular hospital personnel were cleared out, and the guards stayed on duty for the next eight hours with orders to shoot anyone who tried to enter without authorization. After the episode, the father was told never to talk about it, on pain of death. He had not talked about it until now.

After hearing these details, several key members of the museum staff, including Dennis Balthaser, deliberated on what to do. They decided to send some background information about the Roswell incident to the son and invited him to call the museum again after reviewing it.

On Sunday, June 1, the son called again. Balthaser took the call and took five pages of notes during the conversation. This time, the father got on the phone and told his own story.

To the previously mentioned details, the father added the following: He had been 23 years old and recently returned from two years' infantry duty in Europe when he was assigned to a military police detachment at Roswell Field. He was now 73 years old and was told he had six months to live. He said that on July 3, 1947, all leaves and passes at the base were cancelled. Early on the morning of July 4, he was part of a guard detachment that was driven to a location some 20 to 30 miles north of town.

There, he said, he saw quite a few vehicles and high ranking officers, including some who had flown in from Washington. He believed he was guarding the site of a military air crash. He found the strange piece of metal while at the site, and put it in his pocket.

He was told to escort an ambulance back to the base. Once there, he saw the strange being get out of the ambulance and enter the hospital. He said he was debriefed several times, including when he was discharged from the service later that year at Fort Sill, Oklahoma. He was told to forget everything that had happened at Roswell.

Dennis Balthaser asked if the old man would tell his story in front of a video camera. The man said yes, as long as his two sons were not involved. Balthaser then consulted with other

museum staff. It was decided that he would drive to Oklahoma for a confidential meeting with the man. If all went as planned, Balthaser would videotape the man's statement and would acquire the metal artifact and other promised materials and information. The son provided a private phone number to call when Balthaser arrived. Plans were made for the meeting. Museum personnel created a long list of questions they hoped the old man could answer, especially regarding the appearance and behavior of the alien being.

On June 13, Balthaser drove to the town in Oklahoma where he was to meet the man and his son. From his hotel, Balthaser called the private number given him by the son. A woman answered. She said the son was out of town on an emergency trip but would be back the next day. Balthaser said he would call again. Balthaser had the name of the son, who had said he was an attorney. But no one by that name was listed in the local phone book. Balthaser also had an address to which the museum had previously mailed Roswell information. That address turned out to be in a trailer park. Balthaser began to suspect trouble. The next morning, as agreed, he again called the private number. This time he got only a phone answering machine. He called again a few hours later, and then again still later -- each time getting a machine. Now he fully suspected a hoax. But he waited in his hotel room, still hoping the son would call. At 3:30 that afternoon, the phone in Balthaser's room rang. On the line was a woman who called herself Christi. She told Balthaser to meet her and her partner Ed at the nearby Denny's restaurant that evening. Balthaser agreed. The meeting at the restaurant lasted three and a half hours. It began, Balthaser says, with "Ed" and "Christi" telling him that he would not be meeting the people he had come to see.

Ed told Balthaser that he and Christi worked for the Office of Special Investigations (OSI). They were based in Texas, Ed said, but they took their orders from Langley Air Force Base in Virginia. They never showed identification of any kind. Balthaser believes that their names were not "Ed and Christi" (they said so). He does not know if they really worked for OSI. Ed told Balthaser that they had known he was coming. Ed said that Balthaser's home phone and the museum phones had been tapped. He also said that the son's wife had been the one who first contacted OSI about the father's information. Ed said that he had seen and handled the strange metal artifact the previous evening, and that it was now in safe hands.

Ed demonstrated to Balthaser that he had a very thorough knowledge of the Roswell incident. Ed said the government knows UFOs are real and that Roswell really happened. He said Majestic 12 was real and is still in operation. He said four aliens had been recovered from the Roswell crash, and that one of them is still alive.

Ed told Balthaser that the government wants to make UFO information public as soon as arrangements can be made to avoid panic and get the story accurately portrayed in the media. Ed said that someone in Roswell was keeping tabs on the museum and reporting back to Washington. He said that he and some other agents would be visiting Roswell at a later date and that they would contact Balthaser in an unusual way.

Ed also hinted that there might be an inter-agency conflict regarding the proper handling of UFO information. He told

Balthaser that his own boss had been gunned down two weeks earlier by agents of the CIA. He said he wanted the truth to be told but had to watch out for his own safety as well. The agents told Balthaser a great deal of additional tantalizing information, none of which could be verified. When the meeting ended, Balthaser knew he had no choice but to return to Roswell empty-handed. Before going to bed that night, however, he wrote down everything he could remember about the meeting. Back in Roswell a few days later, Balthaser tried calling the son. Surprisingly, after talking with an unidentified woman and waiting a long time, he heard the son's voice on the line. The son sounded very nervous and asked if they could talk later. Balthaser insisted on talking right then. The son said there were others present.

Then another voice came on the line. Addressing Balthaser by name, this voice said that the son and his family were now cooperating with an agency of the federal government. The voice then said, "You can call me Charles," and continued by telling Balthaser that in due time the museum might benefit by what the son's father had disclosed, but that for the time being it was best to keep it out of public view. Government scientists were going to study the metal. Usually, Charles said, such things turn out to be hoaxes, although this metal did seem quite unusual. Balthaser says that Charles sounded reasonable and conciliatory. He concluded the conversation by saying, "We have your information and we'll be in touch. Our office doesn't do any strong-arm tactics. When we get wind of something unusual, we investigate it. That's what we're paid to do. We're making sure that American tax dollars are being well spent."

Dennis Balthaser admits that for some days after this sequence of events, he felt paranoid. He is convinced his phone is tapped. He even wondered if his car would explode one day when he turned on the ignition. But as weeks went by without further incident, he calmed down.

More than a month later, on July 23, Balthaser tried once again to contact the son. The woman who had answered before answered again. The son, she said, had just left on a trip. Could he return the call? Balthaser left his name and number. The son never called back.

Again in early September, Balthaser tried to call the son. This time, a different male voice answered. Balthaser was told the son no longer lived there. The trail had gone cold. Summarizing his impressions of what happened, Dennis Balthaser says: "I had an experience with my government that I will carry for the rest of my life. I believe the United States government is still preventing people from obtaining information about the Roswell incident."

Balthaser says he has considered whether the father and son could have intended from the beginning to perpetrate a hoax. He can't disprove that notion, but he doesn't believe it. He says that everything he could tell about the father and son during their several phone conversations seemed authentic.

Dennis Balthaser says he is not scared, but he is deeply concerned. And, he says, if his concerns are as well-founded as he thinks, "then this country of ours has more perplexing problems than we can imagine."

# Alternatives and Kennedy

## William Cooper's Claims

A Symposium was held in in 1957 which was attended by some of the great scientific minds then living. They reached the conclusion that by or shortly after the year 2,000 the planet WOULD self destruct due to increased population and man's exploitation of the environment, WITHOUT ANY HELP FROM GOD OR THE ALIENS.

By secret Executive Order of President Eisenhower, the Jason Scholars were ordered to study this scenario and make recommendations from their findings. The Jason Society CONFIRMED the finding of the scientists and made 3 recommendations called "Alternatives 1, 2, and 3".

"Alternative 1" was to use nuclear devices to blast holes in the Stratosphere from which the heat and pollution could escape into space. Change the human cultures from that of exploitation into cultures of environmental protection. Of the three this was decided to be the least likely to succeed due to the inherent nature of man and the additional damage the nuclear explosions would themselves create. "Alternative 2" was to build a vast network of underground cities and tunnels in which a select representation of all cultures and occupations would survive and carry on the human race. The rest of humanity would be left to fend for themselves on the surface of the planet. "Alternative 3" was to exploit the alien and conventional technology in order for a select few to leave the earth and establish colonies in outer space.

I am not able to either confirm or deny the existence of "Batch Consignments" of human slaves which would be used for the manual labor in the effort as a part of the plan. The Moon, code named "Adam", would be the object of primary interest followed by the planet Mars, code named "Eve". As a delaying action, ALL THREE ALTERNATIVES included birth control, sterilization, and the introduction of deadly microbes to control or slow the growth of the Earth's population. AIDS is only ONE result of these plans. It was decided since the population must be reduced and controlled that it would be in the best interest of the human race to rid ourselves of the undesirable elements of our society. The joint U.S. and Soviet leadership dismissed "Alternative 1" but ordered work to begin on Alternative 2 and 3 virtually at the same time.

The "official" Space Program was boosted by President Kennedy in his inaugural address when he mandated that the United States put a man on the Moon before the end of the decade. Although innocent in its conception, this mandate enabled those in charge to funnel vast amounts of money into black projects and

conceal the REAL space program from the American people. A similar program in the Soviet Union served the same purpose. In fact a joint alien, United States, and Soviet Union base already existed on the Moon at the very moment Kennedy spoke the words.

On May 22, 1962 a space probe landed on Mars and confirmed the existence of an environment which could support life. Not long afterward the construction of a colony on the planet Mars began in earnest. Today cities exist on Mars populated by specially selected people from different cultures and occupations taken from all over the Earth. A public charade of antagonism between the Soviet Union and the United States has been maintained over all these years in order to fund projects in the name of National Defense when in fact we are the closest allies.

At some point President Kennedy discovered portions of the truth concerning the drugs and the aliens. He issued an ultimatum in 1963 to MJ-12. President Kennedy assured them that if they did not clean up the drug problem he would. He informed MJ-12 that he intended to reveal the presence of aliens to the American people within the following year and ordered a plan developed to implement his decision.

President Kennedy was not a member of the Council On Foreign Relations and knew nothing of "Alternative 2" or "Alternative 3". Internationally the Operations were supervised by an Executive Committee known as the "Policy Committee". In the United States they were supervised by MJ-12 and in the Soviet Union by its sister organization. President Kennedy's decision struck fear into the hearts of those in charge. His assassination was ordered by the Policy Committee and the order was carried out by agents of MJ-12 in Dallas.

President John F. Kennedy was murdered by the Secret Service Agent who drove his car in the motorcade and the act is plainly visible in the film. WATCH THE DRIVER AND NOT KENNEDY WHEN YOU VIEW THE FILM. All of the witnesses who were close enough to the car to see William Greer shoot Kennedy were themselves all murdered within 2 years of the event. The Warren Commission was a farce and Council on Foreign Relations members made up the majority of its panel. They succeeded in snowing the American people. Many other patriots who attempted to reveal the alien secret have also been murdered throughout the intervening years.

Attach copies of the Bill English file and John Lear's file. Send anything else which tends to support the information.

I Milton William Cooper, 1311 S. Highland #205, Fullerton, California, 92632, (714) 680-9537, do solemnly swear that the information contained in this file is true to the best of my knowledge. I swear I saw this information in 1972 in the performance of my duties as a member of the Intelligence Briefing Team of the Commander in Chief of the Pacific Fleet as a Petty Officer in the US Navy. I swear that I can and will take a lie detector test or any other test of any reputable persons choosing in order to confirm this information. I swear that I can and will undergo hypnotic regression conducted by any reputable and qualified Doctor of any reputable persons choosing in order to confirm this information. I will not, however submit to any test or hypnosis by anyone who is now or has ever been connected with the Government in any capacity for obvious reasons.

The following is a brief listing of everything that I personally saw and know from 1972 and does not contain input from any other source whatsoever.

MAJESTY was listed as the code word for the President of the United States for communications concerning this information.

OPERATION MAJORITY is the name of the operation responsible for every aspect, project, and consequence of alien presence on earth.

GRUDGE Contains 16 volumes of documented information collected from the beginning of the United States investigation of Unidentified Flying Objects (UFOs) and Identified Alien Crafts (IAC). The project was funded by CIA confidential funds (non-appropriated) and money from the illicit drug trade. Participation in the illegal drug trade was justified in that it would identify and eliminate the weak elements of our society. The purpose of project GRUDGE was to collect all scientific, technological, medical and intelligence information from UFO/IAC sightings and contacts with alien life forms. This orderly file of collected information has been used to advance the United States Space Program.

MJ-12 is the name of the secret control group. President Eisenhower commissioned a secret society known as THE JASON SOCIETY (JASON SCHOLARS) to sift through all the facts, evidence, technology, lies and deception and find the truth of the alien question. The society was made up of 32 most prominent men in the country in 1972 and the top 12 members were designated MJ-12. MJ-12 has total control of everything. They are designated by the code J-1, J-2, J-3, etc. all the way through the members of the Jason Society. The director of the CIA is appointed J-1 and is the director of MJ-12. MJ-12 is only responsible to the President. MJ-12 runs most of the worlds illegal drug trade. This was done to hide funding and thus keep the secret from Congress and the people of the United States. It was justified in that it would identify and eliminate the weak elements of our society. The cost of funding the alien connected projects is higher than anything you can imagine. MJ-12 assassinated President Kennedy when he informed them that he was going to tell the public all the facts of the alien presence. He was killed by the Secret Service agent driving his car and it is plainly visible in the film held from public view. A secret meeting place was built for MJ-12 in MARYLAND and it was described as only accessible by air. It contains full living, recreational, and other facilities for MJ-12 and the JASON SOCIETY. It is code named "THE COUNTRY CLUB". Only those with TOP SECRET/MAJIC clearance are allowed to go there.

MAJI is the MAJORITY AGENCY FOR JOINT INTELLIGENCE. All information, disinformation, and intelligence is gathered and evaluated by this agency. The agency is responsible for all disinformation and operates in conjunction with the CIA, NSA, and the Defense Intelligence Agency. This is a very powerful organization and all alien projects are under its control. MAJI is only responsible to MJ-12.

SIGMA is the project which first established communications with the aliens and is still responsible for communications.

PLATO is the project responsible for Diplomatic relations with the aliens. This project secured a formal treaty (illegal under the Constitution) with the aliens. The terms were that the aliens would give us technology. In return we agreed to keep their presence on earth a secret, not to interfere in any way with their actions, and to allow them to abduct humans and animals. The aliens agreed to furnish MJ-12 with a list of abductees on a periodic basis.

MAJIC is a security classification and clearance of all alien connected material, projects, and information. MAJIC means MAJI controlled.

AQUARIUS is a project which compiled the history of alien presence and their interaction with Homo Sapiens upon this planet for the last 25,000 years and culminating with the Basque people who live in the mountainous country on the border of France and Spain and the Syrians.

GARNET is the project responsible for control of all information and documents regarding this subject and accountability of the information and documents.

PLUTO is a project to evaluate all UFO/IAC information pertaining to space technology.

POUNCE is the project formed to recover all downed/crashed craft and aliens. REDLIGHT is the project to test fly recovered alien craft. It is conducted at

AREA 51 (DREAMLAND) in Nevada. It was aided when the aliens gave us craft and helped us fly them. The initial project was somewhat successful in that we flew a recovered craft but it blew up in the air and the pilots were killed. The project was suspended at that time until the aliens agreed to help us. SNOWBIRD was established as a cover for project REDLIGHT. Several flying saucer type craft were built using conventional technology. They were unveiled to the press and flown in front of the press. The purpose was to explain accidental sightings or disclosure of REDLIGHT as having been SNOWBIRD craft.

LUNA is the alien base on the far side of the Moon. It was seen and filmed by Apollo Astronauts. A base, a mining operation using very large machines, and a very large alien craft described in sighting reports as MOTHER SHIPS exist there.

NRO is the National Recon Organization based at Fort Carson, Colorado. It is responsible for security for all alien craft connected projects.

DELTA is the designation for the specific arm of the NRO which is especially trained and tasked with security of these projects. JOSHUA is a project to develop a low frequency pulsed sound generating weapon. It is said that this weapon would be effective against the alien craft and beam weapons.

EXCALIBUR is a weapon to destroy the alien underground bases. It is a missile capable of penetrating 1000 meters of Tufa/hard packed soil such as that found in New Mexico with no operational damage. Missile apogee not to exceed 30,000 feet AGL and impact must not deviate in excess of 50 meters from designated target. The device will carry a 1 megaton nuclear warhead.

ALIENS, there were 4 types of aliens mentioned in the papers. A LARGE NOSED GREY with whom we have the treaty, the GREY reported in abductee cases that works for the LARGE NOSED GREY, a blond human like type described as NORDIC, a red haired human like type called ORANGE. The home of the aliens were described as being a star in the constellation of Orion, Barnard's star, and Zeta Reticuli 1 and 2. I cannot remember even under hypnosis which alien belongs to which star.

EBE is the name or designation given to the live alien captured at the 1949 Roswell crash. He died in captivity.

KRLL OR KRLLL OR CRLL OR CRLLL pronounced Crill or Krill was the hostage left with us at the first Holloman landing as a pledge that the aliens would carry out their part of the basic agreement that was reached during that meeting.

KRLL gave us the foundation of the yellow book which was completed by the guests at a later date. KRLL became sick and was nursed by Dr. G. Mendoza who became an expert in alien biology and medicine. KRLL later died. His information was disseminated under the pseudonym O.H. Cril or Crill.

GUESTS were aliens exchanged for humans who gave us the balance of the yellow book. At the time I saw the information there were only 3 left alive. They were called (ALF's) Alien Life Forms.

RELIGION The aliens claim to have created Homo Sapiens through hybridization. The papers said the RH- blood was proof of this. They further claim to have created all our major religions. They showed a Hologram of the crucifixion of Christ which the Government filmed. They claim Jesus was created by them.

ALIEN BASES exist in the four corners area of Utah, Colorado, New Mexico, and Nevada. Six bases were described in the 1972 papers, all on Indian reservations and all in the four corners area. The base near Dulce was one of them.

MURDER The documents stated that many military and government personnel had been terminated (murdered without due process of law) when they attempted to reveal the secret.

CRAFT RECOVERIES The documents stated that many craft had been recovered. The early ones from Roswell, Aztec, Roswell again, Texas, Mexico, and other places.

GENERAL DOOLITTLE made a prediction that one day we would have to reckon with the aliens and the document stated that it appeared that General Doolittle was correct.

ABDUCTIONS were occurring long before 1972. The document stated that humans and or animals were being abducted and or mutilated. Many vanished without

a trace. They were taking sperm and ova samples, tissue, performed surgical operations, implanted a spherical device 40 to 80 microns in size near the optic nerve in the brain and all attempts to remove it resulted in the death of the patient. The document estimated that 1 out of every 40 people had been implanted. This implant was said to give the aliens total control of that human.

CONTINGENCY PLAN SHOULD THE INFORMATION BECOME PUBLIC OR SHOULD THE ALIENS ATTEMPT TAKEOVER.

This plan called for a public announcement that a terrorist group had entered the United States with an Atomic weapon. It would be announced that the terrorists planned to detonate the weapon in a major city. Martial law would be declared and all persons with implants would be rounded up along with all dissidents and would be placed in concentration camps. The press, radio, and TV would be nationalized and controlled. Anyone attempting to resist would be arrested or killed.

CONTINGENCY PLAN TO CONTAIN OR DELAY RELEASE OF INFORMATION This plan called for the use of MAJESTIC TWELVE as a disinformation ploy to delay and confuse the release of information should anyone get close to the truth. It was selected because of its similarity to MJ-12. It was designed to confuse memory and to result in a fruitless search for material which did not exist.

SOURCE OF THE MATERIAL CONTAINED IN THE DOCUMENTS WHICH I SAW The source of the material was an ONI counter intelligence operation against MJ-12 in order for the Navy to find out the truth of what was really going on. The Navy (at that time or at least the Navy that I worked for) were not participants in any of this. The different services and the government conduct this type of operation against each other all the time. The result of this operation was that the Navy cut themselves in for a piece of the action (technology) and control of some projects.

As you can see this file is only a little different from my previous file. Only some names were scrambled previously to confuse the government long enough for someone to verify that what I have said is the truth. I have added information in this file that puts my life in absolute danger. I have sent a copy of this file to people all over the country and will continue to do so. Please get this file into as many hands as you can and maybe that will protect me but I doubt it.

HISTORY WILL BE THE JUDGE OF ME AND THIS INFORMATION AND I HAVE NO FEAR OF THAT JUDGEMENT. I SWEAR THAT THIS INFORMATION IS TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE.

I wish to thank all those people who have aided me in reaching this point and for their patience and understanding. I owe you all more than I can ever repay.

Finally, it does not matter who is right or who is wrong or if a project name is in the wrong place. It does not matter who is working for whom or what is really what. It should be obvious that something sinister and terribly wrong is going on involving the government and the UFO phenomenon. We must all band together and expose it now. I have done my part in the best way that I could. I can add nothing else except my testimony in Congress or a court of law that what I saw and have written in this file is true and that I saw it.

Everything in my previous file that does not conflict with this file is true and correct to the best of my knowledge and some of it is from sources and research. You may combine the files to get the entire picture. Throw out only that information which conflicts with that contained in this file.

There will be no further additions or corrections to this information either now or in the future. My file is complete and stands to be judged by history. Sometime in the future the exact papers that I saw will surface and you will all see this exact information contained within them.

JOHN LEAR

DECEMBER 29, 1987

John Lear, a captain for a major US Airline has flown over 160 different types of aircraft in over 50 different countries. He holds 17 world speed records in the Lear Jet and is the only pilot ever to hold every airline certificate issued by the FAA. Mr. Lear has flown missions worldwide for the CIA and other gov't agencies. A former Nevada State Senator candidate, he is the son of William P. Lear, designer of the Lear Jet executive airplane, the 8-track stereo, and founder of Lear Siegler Corporation. Lear became interested in the subject of UFOs 13 months ago after talking with United States Air Force Personnel who had witnessed a UFO landing at Bentwaters AFB, near London, England, and three small aliens walking up to the Wing Commander.'

The following is a continuation of a previous correspondence. It is purportedly John Lear's Note to the Press:

The government of the United States continues to rely on your personal and professional gullibility to suppress the information contained herein. Your cooperation over the past 40 years has exceeded our wildest expectations and we salute you.

"The sun does not revolve around the Earth"

"The United States Government has been in business with little gray extraterrestrials for about 20 years"

The first truth stated here got Giordano Bruno burned at the stake in AD 1600 for daring to propose that it was real. The second truth has gotten far more people killed trying to state it publicly than will ever be known.

But the truth must be told. The fact that the Earth revolves around the sun was successfully suppressed by the church for over 200 years. It eventually caused a major upheaval in the church, government, and thought. A realignment of social and traditional values. That was in the 1800's.

Now, about 400 years after the first truth was pronounced we must again face the shocking facts. The "horrible truth" the government has been hiding from us over 40 years. Unfortunately, the "horrible truth" is far more horrible than the government ever imagined.

In its effort to protect democracy, our government sold us to the aliens. And here is how it happened. But before I begin, I'd like to offer a word in the defense of those who bargained us away. They had the best of intentions.

"Germany may have recovered a flying saucer as early as 1939. General James H. Doolittle went to Sweden in 1946 to inspect a flying saucer that had crashed there in Spitzbergen.

The "horrible truth" was known by only a very few persons: They were indeed ugly little creatures, shaped like praying mantises and who were more advanced than us by perhaps a billion years. OF the original group that were the first to learn the "horrible truth," several committed suicide, the most prominent of which was General James V. Forrestal who jumped to his death from a 16th story hospital window. General Forrestal's medical records are sealed to this day.

President Truman quickly put a lid on the secret and turned the screws so tight that the general public still thinks that flying saucers are a joke.

Well, that's all for now. But the story get even better as it provides an account for all of those mysterious "alien abductions" that are always being reported on in TV shows such as "Unsolved Mysteries."

More from the John Lear "Press Release," continuing from where I left off:

"In 1947, President Truman established a group of 12 of the top military scientific personnel of their time. They were known as MJ-12. Although the group exists today, none of the original members are still alive. The last one to die was Gordon Gray, former Secretary of the Army, in 1984. As each member passed away, the group itself appointed a new member to fill the position. There is some speculation that the group known as MJ-12 expanded ~~by~~ at least several <sup>more</sup> members.

There were several more saucer crashes in the late 1940's, one in Roswell, New Mexico, one Aztec, New Mexico, and one near Laredo, Texas, about 30 miles inside the Mexican border.

Consider, if you will, the position of the United States Government at that time. They proudly thought of themselves as the most powerful nation on Earth, having recently produced the atomic bomb, an achievement so stupendous, it would take Russia 4 years to catch up, and only with the help of traitors to the Democracy. They had built a jet aircraft that had exceeded the speed of sound in flight. They had built jet bombers with intercontinental range that could carry weapons of enormous destruction. The post war era, and the future seemed bright. Now imagine what it was like for those same leaders, all of whom had witnessed the panic of Orson Wells' radio broadcast, "The War of the Worlds," in 1938. Thousands of Americans panicked at a realistically presented invasion of Earth by beings from another planet. Imagine their horror as they actually viewed the dead bodies of these frightening looking little creatures with enormous eyes, reptilian skin and claw like fingers. Imagine their shock as they attempted to determine how these strange "saucers" were powered and could discover no part even remotely similar to components they were familiar with: no cylinders or pistons, no vacuum tubes or turbines or hydraulic actuators. It is only when you fully understand the overwhelming helplessness the government was faced with in the late 40's that you can comprehend their perceived need for a total, thorough and sweeping cover up, to include the use of 'deadly force.'"

"The cover-up was so successful that as late as 1985 a senior scientist with the Jet Propulsion Laboratory in Pasadena, CA, Dr. Al Hibbs, would look at a video tape of an enormous flying saucer and state the record, 'I'm not going to assign anything to that (UFO) phenomena without a lot more data.' Dr. Hibbs was looking at the naked emperor and saying, 'He certainly looks naked, but that doesn't prove he's naked'."

Stay tuned 'til next time when we see the U.S. gov't making a deal with the ugly little creatures...

"In July of 1952, a panicked government watched helplessly as a squadron of 'flying saucers' flew over Washington, D.C., and buzzed the White House, the Capitol Building, and the Pentagon. It took all the imagination and intimidation the government could muster to force the incident out of the memory of the public.

"Thousands of sightings occurred during the Korean war and several more saucers were retrieved by the Air Force. Some were stored at Wright-Patterson Air Force Base, some were stored at Air Force bases near the location of the crash sight.

"One saucer was so enormous and the logistic problems in transportation so enormous that it was buried at the crash sight and remains there today. The stories are legendary on transporting crashed saucers over long distances, moving only at night, purchasing complete farms, slashing through forests, blocking major highways, sometimes driving 2 and 3 lo-boys in tandem with an extraterrestrial load a hundred feet in diameter.

"During the period of 1969-1971, MJ-12 (ed. note: MJ-12 is the special task force for the study of UFO's) representing the U.S. Gov't made a deal with these creatures, called EBE's (Extraterrestrial Biological Entities, named by Detley Bronk, original MJ-12 member and 6th president of Johns Hopkins

University). The 'deal' was that in exchange for 'technology' that they would provide to us, we agreed to 'ignore' the abductions that were going on and suppress information on the cattle mutilations. The EBE's assured MJ-12 that the abductions (usually lasting about 2 hours) were merely the ongoing monitoring of developing civilizations."

Here things get wild:

"In fact, the purposes for the abduction turned out to be:

(1) The insertion of a 3mm spherical device through the nasal cavity of the abductee into the brain. The device is used for the biological monitoring, tracking, and control of the abductee.

(2) Implementation of Posthypnotic Suggestion to carry out a specific activity during a specific time period, the actuation of which will occur within the next 2 to 5 years.

(3) Termination of some people so that they could function as living sources for biological materials and substances.

(4) Termination of individuals who represent a threat to the continuation of their activity.

(5) Effect genetic engineering experiments.

(6) Impregnation of human females and early termination of pregnancies to secure the crossbreed infant.

"The U.S. Gov't was not initially aware of the far reaching consequences of their 'deal.' They were led to believe that the abductions were essentially benign and since they figured the abductions would probably go on anyway whether they agreed or not, they merely insisted that a current list of abductees be submitted, on a periodic basis, to MJ-12 and the National Security Council. Does this sound incredible? An actual list of abductees sent to the National Security Council? Read on, because I have news for you."

"The EBE's (extraterrestrial biological entities) have a genetic disorder in that their digestive system is atrophied and not functional. Some speculate that they were involved in some type of accident or nuclear war, or possibly <sup>they</sup> on the back side of an evolutionary genetic curve. In order to sustain themselves they use an enzyme or hormonal secretion obtained from the tissue that they extract from humans and animals. Note: Cows and Humans are genetically similar. In the event of a national disaster, cow's blood can be used by humans (Editor's note: does anybody know if this is true?).

<sup>were</sup> The secretions obtained are then mixed with hydrogen peroxide and applied on the skin by spreading or dipping parts of their bodies in the solution. The body absorbs the solution, then excretes the waste back through the skin. The cattle mutilations that were prevalent throughout the period from 1973 to 1983 and publicly noted through newspaper and magazine stories and included a documentary produced by Linda Howe for the Denver CBS affiliate KMGH-TV, were for the collection of these tissues by the aliens. The mutilations included genitals taken, rectums cored out to the colon, eyes, tongue, and throat all surgically removed with extreme precision. In some cases the incisions were made by cutting between the cells, a process we are not yet capable of performing in the field. In many of the mutilations there was no blood found at all in the carcass, yet there was no vascular collapse of the internal organs. This has been also noted in the human mutilations, one of the first of which was Sgt. Jonathan P. Louette at the White Sands Missile Test Range in 1956, who was found three days after an Air Force Major had witnessed his abduction by a 'disk shaped' object at 0300 while on search for missile debris downrange. His genitals had been removed, rectum cored out in a surgically precise 'plug' up to the colon, eyes removed and all blood removed with, again, no vascular collapse. From some of the evidence it is apparent that this surgery is accomplished, in most cases, while the victim, animal or human is still alive.

"The various parts of the body are taken to various underground laboratories, one of which is known to be near the small New Mexico town of Dulce. This jointly occupied (CIA-Alien) facility has been described as enormous, with

huge tiled walls that 'go on forever.' Witnesses have reported huge vats filled with amber liquid with parts of human being stirred inside. "After the initial agreement, Groom Lake, one of this nation's most secret test centers, was closed for a period of about a year, sometime between about 1972 and 1974, and a huge underground facility was constructed for and with the help of the EBE's. The 'bargained for' technology was set in place but could only be operated by the EBE's themselves. Needless to say, the advanced technology could not be used against the EBE's themselves, even if needed.

"During the period between 1979 and 1983 it became increasingly obvious to MJ-12 that things were not going as planned. It became known that many more people (in the thousands) were being abducted than were listed on the official abduction lists. In addition it became obvious that some, not all, but some of the nation's missing children had been used for secretions and other parts required by the aliens.

"In 1979 there was an altercation of sorts at the Dulce laboratory. A special armed forces unit was called in to try and free a number of our people trapped in the facility, who had become aware of what was really going on. According to one source, 66 of the soldiers were killed and our people were not freed."

"By 1984, MJ-12 must have been in stark terror at the mistake they had made in dealing with the EBE's. They had subtly promoted 'Close Encounters of the Third Kind' and 'E.T.' to get the public used to 'odd looking' aliens that were compassionate, benevolent and very much our 'space brothers.' MJ-12 'sold' the EBE's to the public, and were now faced with the fact that quite the opposite was true. In addition a plan was formulated in 1968 to make the public aware of the existence of aliens on Earth over the next 20 years to be culminated with several documentaries to be released during 1985-1987 period of time. These documentaries would explain the history and intentions of the EBE's. The discovery of the 'Grand Deception' put the entire plans, hopes, and dreams of MJ-12 into utter confusion and panic.

"Meeting at the 'Country Club,' a remote lodge with private golf course, comfortable sleeping and working quarters, and its own private airstrip built by and exclusively for the members of MJ-12, it was a factional fight of what to do now. Part of MJ-12 wanted to confess about the whole scheme and shambles it had become to the public, beg their forgiveness and ask for their support. The other part (and majority) of MJ-12 argued that there was no way they could do that, that the situation was untenable and there was no use in exciting the public with the 'horrible truth' and that the best plan was to continue the development of a weapon that could be used against the EBE's under the guise of 'SDI,' the Strategic Defense Initiative, which had nothing whatsoever to do with a defense for inbound Russian nuclear missiles. As these words are being written, Dr. Edward Teller, 'father' of the H-Bomb is personally in the test tunnels of the Nevada Test Site, driving his workers and associates in the words of one, 'like a man possessed.' And well he should, for Dr. Teller is a member of MJ-12 along with Dr. Kissinger, Admiral Bobby Inman, and possibly Admiral Poindexter, to name a few of the current members of MJ-12.

"Before the 'Grand Deception' was discovered and according to a meticulous plan of metered release of information to the public, several documentaries and videotapes were made. William Moore, a Burbank, CA based UFO researcher who wrote 'The Roswell Incident,' a book published in 1980 that detailed the crash, recovery and subsequent cover-up of a UFO with 4 alien bodies, has a videotape of 2 newsmen interviewing a military officer associated with MJ-12 and the cover-up, the recovery of a number of flying saucers and the existence of a live alien (one of 3 living aliens captured and designated, or named, EBE-1, EBE-2, and EBE-3, being held in a facility designated as YY-II at Los Alamos, NM. The only other facility of this type, which is electromagnetically secure, is at Edwards AFB in Mojave, CA). The officer names as previously mentioned plus a few others: Harold Brown, Richard Helms, Gen. Vernon Walters, JPL's Dr. Lew Allen and Dr. Theodore von Karman, to name a few of the current and past members of MJ-12.

## CNI INTERVIEW WITH AMERICAN COMPUTER PRESIDENT JACK SHULMAN ON THE ROSWELL/BELL LABS CONTROVERSY OVER ET INFO OBTAINED

[Since mid-August, a controversy has raged on the Internet concerning highly provocative information posted on the web site of American Computer Company (see CNI News of September 16, 1997; and visit ACC's web site: <http://www.american-computer.com>). In brief, ACC has suggested that the historic invention of the transistor at Bell Laboratories in December, 1947 might have been aided by covert transfer of technology from an alien spacecraft recovered near Roswell, New Mexico. This suggestion directly parallels similar claims made by Lt. Col. Philip Corso in his recent book, "The Day After Roswell." However, ACC personnel state they had no knowledge of Corso or his book, but relied instead on information provided by a "consultant" who remains nameless. American Computer's president and chief technical officer is Jack Shulman. In recent weeks, Shulman himself has come under scrutiny by UFO researchers, as have several other people who have presumed to speak in a seemingly authoritative way on behalf of American Computer.

CNI News, working in cooperation with radio host Jeff Rense of the popular syndicated program "Sightings on the Radio," [see Jeff's web site at <http://www.sightings.com>], is seeking to verify or dispel the various rumours swirling around ACC and the person of Jack Shulman, so that public attention can be refocused to the significant issues raised on the American Computer web site. This special supplement to CNI News is directed to that goal.

The following is an edited transcript of a telephone interview between Jeff Rense and Jack Shulman which took place on September 29. Jeff Rense and CNI News editor Michael Lindemann consulted together on the questions to be asked prior to the call.

Thanks to Jeff Rense for sharing the complete contents of this interview with CNI News.]

JEFF RENSE: It's September 29, and we're talking with American Computer Company president Jack Shulman.

RENSE: What is your purpose in exposing the Roswell/Bell Labs allegations on the ACC web site, thereby attaching your credibility, for better or worse, not only to Roswell, but to claims concerning Bell Labs' access to alien technology -- claims which either must be substantiated, or which could make you look like a nut, or a disinformant?

SHULMAN: I don't think there was any purpose -- either to look like nut, a disinformant, a credible source or anything -- taken into consideration at first. We had a consultant come to me and tell me this story. At first, I was quite sceptical about it. I knew a lot of the facts, because they are pretty much matters of record, but had always thought that the reason there was a cloud of -- shall we say -- controversy about the exact origins of William Shockley's transistor was that it stemmed perhaps from a prehistory that AT&T didn't care to disclose. I didn't have any idea, up until the time that the consultant came to me and raised these issues, that it might in fact be related to the Roswell incident. I originally thought [the origin] was something like German rocket scientists....

RENSE: How did this consultant come to you?

SHULMAN: I had known the consultant years ago. We had met each other in the hinterlands of AT&T. I've worked on and off in AT&T contracts over the course of a couple of decades. And about a year ago, in my capacity as the chairperson of the American Computer Science Foundation, I was asked to review materials that pertained to an ongoing investigation of telephone company practices that were pertinent to the success of the computer industry, during the course of which I happened to come across some fairly strong allegations that were made by the consultant in the dominion of that specific investigation. I was not at that time informed of the possibility of an alien technology transfer. It was not until he came to me personally and suggested it that I said to him, "Well, you're going to have to show me some bonafide evidence before I even consider this." About six months later he came back to me with what appeared to me to be... some evidence that might suggest in fact that the transistor came from some kind of a project involving investigation into an alien technology of some kind.

RENSE: Can you elaborate on that evidence at all?

SHULMAN: I can tell you that I have seen what appears to be some notes from someone. However, I cannot verify their authenticity, so I'd really not like to describe them in any detail. Frankly, Jeff, I grow concerned about leading people in the wrong direction. They did give me the appearance of a lab notebook, of a lab-keeper's notebook. In fact, they did appear to describe or

have an actual memorandum referring to a disinformation campaign in late 1947 at AT&T. But again, they could have been a complete forgery. They could have been anything. They might have been legitimate too. (He agreed to posting the info on their website.)

SHULMAN: Well, interestingly, exactly what I thought might happen did happen -- that is, it struck a chord with somebody and they wrote us. Sure enough, the first week someone wrote us and said, "Yes, my father worked for AT&T/Bell Labs in 1947, and in the early '60s took me to see a UFO." I was flabbergasted, absolutely floored. You could have knocked me over with a feather at that moment. Not because I was sceptical, but in the context of how ridiculous it makes AT&T look, I found it to be humorous. What, are they crazy? Why didn't they come out with it in 1947? The world would have been in their debt. AT&T would have been the greatest company that ever lived. Why would they hide it?

It was then that the full import of the suggestion of profiteering began to occur to me. If in fact this were true, the profiteering aspect was something that none of us considered. If people were ready to make billions and billions of dollars for 200 years on this kind of technology, and it came from an "alien source," they would keep it a secret -- because if it came from outside of AT&T, it wouldn't belong to AT&T. It hadn't even dawned on us, because we were looking at it from the perspective of how amazing the story is, how earthshaking, and how silly it would be to keep it a secret - until we began to realize who was in the business of profiting from this kind of technology.

RENSE: Do you have any relationship with Bell Labs now, Jack? SHULMAN: Not really. They call us every once in a while to look at buying equipment, but I am no longer personally doing any consulting for Bell Labs.

RENSE: Does the consultant?

SHULMAN: Occasionally. He or she does communications-related consulting in the defence industries, and very specifically his or her identity is being withheld for security reasons.

RENSE: Has the consultant expressed to you any surprise at the amount of Internet interest in this story?

SHULMAN: He and several of our public relations consultant clients said that, frankly, it will do quite well as a story on the Internet because it will serve to brighten up the interest of some very frustrated people. This information will give people in your investigative field some leverage in dealing with the whole subject. Even if the entire story might not be 100 percent accurate for whatever reason, the facts described in our story are materially largely true. For instance -- and it's been interesting to see how many people have reacted adversely to this suggestion -- if you take a look at the part about the Nike-Ajax missile bases, and the anti-aircraft guns that preceded them, in and around AT&T down in Red Bank, outside of Crawford's Corners, up in Murray Hill and over in Holmdel, it's almost shocking to discover that, while New York City and New Jersey sat undefended, AT&T had both anti-aircraft and then anti-missile batteries constructed around them in the 1940s and 1950s. This is painfully humorous. It actually hurts to consider that AT&T and Bell Labs are more important than the citizens of our country. So I'm thinking, wow, there must be more than just the labs there. Because I know something about the research community, and I don't know that there is anything at AT&T from 1947 to 1997 that was irreplaceable. Whereas, when I think of places like the Applied Physics Laboratory, Cold Springs Harbor, Lawrence Livermore -- there are projects going on there that are not reproducible, and I'm not sure they all have Nike-Ajax missile bases around them.

RENSE: Is American Computer consciously part of a larger coordinated campaign of public disclosure or education aimed at revealing things about the alleged alien presence on earth?

SHULMAN: No. Not unless you call ACC's own campaign that broader one. Nobody came to us other than this consultant.

RENSE: So would you say that Jack Shulman, as a matter of conscience and patriotism, independently decided to put this on his web site?

SHULMAN: Conscience, yes, simply because I thought that the facts deserved disclosure and consideration. The public should know. Even if they're not true, the fact is they appear to have some degree of plausibility, so they

should be considered on their own weight.

By the way, I was caught completely off guard by Colonel Corso's book. I did not know the book existed until Jared Anderson called here and spoke to John Schwartz, one of my VPs, who got me on the phone immediately and said, "Did you know there's a book that describes transfers of technology from either Roswell or some other crash to AT&T?" That was the first I heard of it. I happen to love this country and the people who live here, and I think that if they have a gripe or a beef, it deserves to be aired. And this is one of those that appears to deserve to be aired.... I raised that very issue in a letter to, dare I say, Secretary of Defence William Cohen. I stated my concern that -- what do they say, "Soothe the savage beast"? -- I'm concerned that a "savage beast" will emerge eventually from the disinformation, lack of information, strangely conflicting or compelling stories, and the lack of a basic kind of town-hall sit-down to discuss these matters. I mean, how expensive is it for the government to respond to a million FOIA requests a year, compared with one concerted effort to gather all the information, keep it pure, break down a few barriers that might be left over from some nameless classified project....?

RENSE: It sounds like you don't subscribe to the idea of a fifty-year, coordinated cover-up of the UFO subject.

SHULMAN: I think I would have to see actual evidence of a coordinated cover-up. It's not that I don't subscribe to it. It's that I don't as yet see evidence of anything other than bureaucracy, technical deficiencies in requests [for information], a disinclination on the part of the government to discuss the matter. I think, if anything, I'd call it a fifty-year disinclination, rather than cover-up.

RENSE: But the reasons for that "disinclination" are the key... SHULMAN: That's correct. That's one of the things we raised in the Shadowlake Invitation page on our web site [an open letter to the Secretary of Defence, Joint Chiefs of Staff and other top officials to participate in an open forum on the subject of UFOs.

RENSE: That letter has caused a lot of reaction. Who wrote that? SHULMAN: It was written by American Computer Company. You have people working here, including myself, who are less than inclined to seek the public spotlight on this issue. We are not what you'd call publicity hounds.

RENSE: I understand. What is your personal opinion about the ET issue, vis a vis our military and our government?

SHULMAN: My personal opinion is a very troubled one. I have a degree of personal integrity that forbids my [drawing conclusions] until I've seen the absolute facts. I have not concluded one way or the other. But I am inclined to believe that it is more likely that there is some shred of truth to visitation than that there is no shred of truth.

RENSE: Do you expect any more information from your consultant to come through ACC's web site?

SHULMAN: I can't say at this moment. We have a plan in place, that we're considering, to raise the ante a little bit to try to generate some kind of reaction out of the Department of Defence that might lean toward the town-hall, public-forum type of meeting. But I really don't want to reveal any more about this now.

RENSE: Is the consultant's agenda, in your opinion, personal, or is he or she being directed by any agency?

SHULMAN: The consultant does not work, to my knowledge, on this particular story for any agency, because that would probably violate the consultant's security oath. The consultant has been advised, and has advised us, that the information that he or she has given us is "allowed" to be given to us by whatever agency he or she consults to, because the information was obtained other than through their employment by the U.S. government. Meaning, the guy worked at AT&T, came across this information, and was not working for the federal government at the time, so the federal government cannot prevent him or her from releasing it to us. But to be very distinct here... the federal government is not particularly happy that the information is being given out.

## UK GOVMT'S UFO PORKIES?

In and out of parliament, British ministers have consistently denied the existence of a cover-up of UFO information and that certain government departments have a special and secret remit to investigate UFO incidents. Both of these assertions have been disproved, claims Matthew Williams, a former civil servant in HM Customs and Excise Criminal Investigations department, by his researches, mainly at the Public Records office in Kew. Since his own UFO sighting in 1990, Williams has devoted himself to full-time investigation of the UFO enigma. The Public Records office is the custodian of all government files which have been downgraded in security classification and are thus available to anyone on request. Bureaucrats, however, do sometimes slip up and let through material which was probably intended to remain classified as secret.

File Number AIR2/16918 is an interesting example of this, for it shows that in the 1960s there were seven secret departments within the MoD investigating UFO reports, though Nick Pope denied any knowledge of them. Most likely they didn't tell him - as a lowly executive officer he had no need to know. The seven 1960s departments (which may now operate under different names), frequently mentioned in this file and in no other available files, are as follows:-

- (1) AMOC - Air Ministry's Information Centre
  - (2) AIS - Air Information Service
  - (3) AI(Tech)4a{ Air Intelligence}
  - (4) AI(Tech)4b{ Technical }
  - (5) AI1 - Air Intelligence #1
  - (6) DSTI - Dept. of Scientific & Technical Intelligence
  - (7) DDI Tech - Dept. of Defence Intelligence Technical
- (Departments DS8 and Air Staff 2 and S6 were simply letter-writing front agencies for the operational departments.)

When the activities of researchers had drawn attention to File # AIR2/16918, it mysteriously disappeared from the Public Record Office and was only returned after parliamentary questions by the Rt.Hon. Ieuan Wyn Jones, MP for Anglesey North.

Williams lists also the following files upon which he based his researches:-

He claims that the files also contain entries relating to operations at Rudloe Manor, Corsham, Wilts., and to the activities of MIBs. He followed up his Kew investigations at the MoD Central Records Management Unit, housed inside the Metropole building in Northumberland Avenue, hoping to access files on the past activities of the secret seven departments. He was not successful, but is now presenting his work in a book - "A Covert Agenda" - to be published by Simon & Schuster.
