

**DO YOU HAVE ALIEN
IMPLANTS IN YOUR EARS?**

I decided to write this article to see if there is anyone out there who has had a similar experience to me. I recently did an ear candling and found a strange object in what came out of my ear.

[Background: If you don't know what ear candles are, they are long, hollow tubes made of wrapped muslin. Ear candles are used for ear wax removal. When using ear candles, the small end of the cone is put into an ear and the other end is lit. As the candle burns, the smoke travels into the ear canal, warming the ear wax and creating a gentle vacuum. This can dislodge the wax or foreign debris and pull it into the ear cone, thus causing ear wax removal.]

I have been doing ear candling on myself fairly frequently for about five years now. Over the years I have heard stories which made me wonder if there was more to ear candling than merely removing wax. For example, I heard of a health food store that got raided by government authorities and THE ONLY THING THEY CONFISCATED WAS EAR CANDLES. Plus, the guy at quackwatch.com really goes to a lot of trouble to put people off ear candling. (Don't worry about him - Tim Cohen is handling him, and may even send him to prison. For example, Tim is asking questions like "How can a man who earns a claimed \$30,000-\$50,000 a year sue over ten people in one year, which would have cost him a minimum of \$1 million. Obviously, he is backed by big business). I heard that in Australia, the government is trying to ban ear candles. When I was in Australia, I had not even HEARD of ear candles.

And then, one day around August 2003, something happened which makes my skin crawl whenever I think of it. I was candling my ears. By this stage, I had probably used up about 50-80 candles in total on myself over five years. After candling, I always cut open the bit of ear candle that was left. Usually this is around 4" or a bit longer. Over the years, I have NEVER seen anything turn up other than the light-coloured powder which is from the candle, and the dark-brown stuff which was my ear wax. But this day was different.

On this day I saw a very strange object in the piece of candle which was left. It was probably a little over 1/4" long. It was greyish in colour

and kind of opaque looking, kind of like a semi-clear plastic. It was oval in shape. It gave me the creeps. I called my husband Michael in to see it. He moved the candle around to see how it would move, and it moved kind of like a balloon full of liquid would move. He then pushed the end of a match into it. Here comes the really weird bit: This DID NOT burst the object. Instead, a small piece broke off and formed its own oval. And then it rejoined the original! IT ACTED JUST THE WAY MERCURY DOES.

We put it into a small glass jar, and it didn't break. Later on, it seemed to dry up and nothing was left.

On discussing this with a friend of mine, she reminded me that she had earlier suggested that maybe aliens were putting implants into the ear. I did not remember her saying this. Although it made sense - if they put them in the nose, why not in the ear?

Muscle testing indicated that it was used for tracking. I believe that these tracking implants (if that is what it was) need to be in the nose or ear so that they can be in contact with the outside, and not be interfered with by the body. Muscle testing also indicated it was inserted by reptilians during my last (forever, I pray to God) abduction. (See: http://www.metatech.org/cause_of_miscarriage_reptilian_abduction.html)

If that was the case, then it was inserted about two years previously. In that time, I have candled maybe 10-12 candles on that ear, with no strange results. So, if it was an implant (and I can't imagine what else on this earth it could possibly be), then they don't come out immediately. If someone wanted to candle to see if they had a similar object come out, it might help to pray first, visualise it coming out etc. to speed its exit).

The candles I use are 50% beeswax. I had an intuitive thought recently that this will not work with 100%-paraffin candles. I feel that the beeswax is somehow loosening the bonds that make the implant stay there. (Note that many candles that SAY they are 100% beeswax cannot possibly be that, as beeswax is way too sticky and soft - think of a jar of honey).

If anyone else has had any similar experiences, PLEASE email me.


UPDATES

1) Several months later, in August 2004, another one of these implants came out my other ear when I was candling. By coincidence, a friend of mine who has metaphysical abilities was present when this happened. She then went home and candled and she also found one of these in each ear. They came out after using four and three ear candles for each ear.

We had already told this friend that we believed she had been abducted. It wasn't too hard to guess. For example, one night she woke up and she was LEVITATING TOWARDS THE CEILING. She called out to Jesus for help and was lowered to the bed. She thought the whole thing was demonic, rather than aliens.

2) Several months after this she found two more implants in the ear of her daughter. In both cases, she did not manage to save the implants - they got destroyed accidentally by such methods as dropping in the sink.

I have since found that the implants have some kind of holographic command "destroy us" which I believe begins to transmit if the implant is exposed to light. So if you do any ear candling, work out BEFOREHAND what you will do if you find an implant.



SCIENTIFIC 'EXPLANATIONS' **LACKING IN MEXICO UFO CASE**

Some readers are probably aware of my long-time interest in the UFO topic. Although I no longer report on UFO matters for local TV, my face seems to pop up weekly on some cable network UFO special. (In just the past week, I received three more requests for interviews and/or assistance from international journalists working on separate UFO programs.)

Mainstream science and the U.S. government have done all they can to discourage serious public interest and inquiries into the UFO subject, but the damned flying saucers just don't want to cooperate. They keep popping up at inopportune moments. Most are explainable, but a few are not.

The UFO news out of Mexico in the past few weeks caused a minor stir on this side of the border for a day or so, then quickly faded into oblivion, overwhelmed by grim news in Iraq. But the Mexican incident is one of the most intriguing cases in recent memory -- and one of the best documented. It deserves some attention. The source of the information is the Mexican Air Force, which was given the green light to release the data by Mexico's equivalent of Defense Secretary Donald Rumsfeld.

On March 5 a Mexican Air Force C26A, while on a drug interdiction and surveillance mission over the state of Campeche, encountered 11 unidentified flying objects. The UFOs were detected on both radar and a sophisticated thermal imaging sensor (known as FLIR) aboard the plane. The encounter occurred at 11,000 feet an hour before sunset and in clear weather. It lasted about 15 minutes and was recorded on the plane's cameras. At one point, eight of the objects formed a circle around the plane. Crew members were understandably shaken.

Mexican defence officials ordered a hush-hush study of the incident. They spent five weeks trying to figure out what had happened but couldn't come up with any explanation for what had been seen by radar, FLIR, cameras and eyewitnesses. The best they could do was to conclude the UFOs were solid objects of unknown origin and that they had flown along with the C26A under what appeared to be intelligent control. That's when they decided to go public.

They took the highly unusual step of contacting prominent Mexican TV journalist and UFO investigator Jaime Maussan and then simply handed over everything they had on the case. Astonishing, to say the least. Governments do not cooperate with UFO investigators, as a rule, at least not the U.S. government.

Maussan, whom Knappster has known for nearly 10 years, broadcast the Air Force footage on his popular TV program. He and the Air Force held a news conference and made the footage and evidence available to other media outlets.

That's when the debunking started. Mexican scientists seemed to take their cues from all the old excuses handed out by the U.S. Air Force in years gone by, dredging up a veritable hit parade of weak explanations.

The first explanation was that this must have been ball lightning, a rare atmospheric phenomenon that has been used many times by American debunkers to try to explain away UFO cases. A nuclear scientist named Dr. Julio Herrera of National Autonomous University was contacted by the Associated Press. Herrera theorized that the UFOs were electrical flashes, and AP went with the story, ignoring the fact that this incident occurred in a cloudless sky and that it lasted for more than 15 minutes. Las Vegas physicist Dr. Eric Davis spent six years studying ball lightning and wrote a paper about it for Air Force Materiel Command at Edwards Air Force Base, where Dr. Davis worked for a time. Simply put, there is no way that ball lightning could be responsible, Davis says. Ball lightning occurs during storms, not in cloudless skies. It generally lasts only a few seconds, sometimes up to a minute, but NEVER for 15 minutes. Besides, the Mexican Air Force had already looked at this explanation and found it wanting.

The inestimable Dr. Herrera wasn't deterred, though. A day or two later, he offered a new explanation that was dutifully reported by skeptical media. He theorized that the UFO flashes were caused by the ignition of natural gases in the atmosphere. (He didn't actually use the term "swamp gas," but it would have been ballsy if he had). The Campeche coast is an oil-producing region, so there is natural gas in the area. But no-one knows of natural gas pockets that rise to 11,000 feet. Besides, the sensors on the plane revealed the objects to be solid, with definable parameters. Plus, the objects followed the plane for many miles and even formed a circle around it. Does gas do that?

Another scientist speculated that the UFOs were "almost certainly" space junk, pieces of satellite debris that had burned up in the atmosphere. Again, this explanation doesn't fit the described behaviour of the objects. Debris

doesn't surround a plane and fly along with it. In addition, the Mexican Air Force certainly would have known if the Campeche coast was being dive-bombed by a vast field of space debris.

Finally, another critic offered up the old chestnut that it must have been weather balloons that caused the sightings. As with the ball lightning explanation, this one would have been more credible had anyone bothered to contact Mexico's National Meteorological Service, which explained that there were no weather balloons anywhere near Campeche on that day. A spokesman also noted that no-one had bothered to contact the NMS to find out if ball lightning would have been a possible explanation. It would not have been, the NMS concluded.

A couple of UFO enthusiasts on this side of the border have taken the case to the other extreme, declaring that the Campeche UFOs were "alien motherships" and that the incident is a sign of more encounters to come. Simply put, we don't know what the objects were. They are, by definition, unidentified and will probably remain so.

The most significant development to come out of this, in my opinion, is the willingness of the Mexican government to openly discuss a UFO encounter. It is a demonstrable fact that world governments have classified files on UFO incidents, files that have never seen the light of day. For the Mexican military to openly admit that it has no idea what was flying around in its airspace is an astounding departure from the party line toed by other governments.

One other explanation needs to be considered. A colleague of mine with extensive experience in UFO investigations and with government agencies suggests that perhaps the Mexican Air Force assumed the UFOs were some sort of secret American craft being tested in Mexican airspace. It is conceivable they decided to go public with the incident because they wanted to put the American military on notice that this has got to stop. Of course, this scenario depends on the idea that the United States has developed some sort of invisible craft that mimics the characteristics of ball lightning and space debris.

HOAGLAND ON THE "AGE OF HORUS" AND POLE SHIFTS

Richard Hoagland has written an excellent series of articles which have loads of information that is important to us all with regard to earth changes.

Title: The "Age of Horus" dawns or "The Time is now"

Hoagland starts off by discussing the last US election, and how desperate both parties were to win THAT election. Here's Hoagland:

"So why, given this well-known political history, are both current candidates apparently so desperate to achieve the Presidency of the United States in this "Turn of the Millennium" election? Both are certainly still young enough to attempt another run for the White House in four years. Bush especially, with virtually half the country expressing a desire to have him be the next President, is in an extraordinarily strong position to come back in 2004 and revisit the closest U.S. election in history. What could motivate them both to potentially throw it all away in a desperate power-play right now -- at the probable expense of their place in history and their standing with the people who elected them (and who could elect them again!)? And what of the serious, looming national crisis of "illegitimacy" overhanging any attempt -- by either man -- to govern after this bitterly contested election?"

The answer, strangely enough, lies not in present day America but in the vast ancient sands of post-diluvial Egypt and Sumer. What we are seeing here is not merely the use of "any and all means" to obtain the powers of the day, but rather a playing out of an ancient symbolic conflict that will inevitably consume all the rest of us ... whether we know of it or not!

Let's start with the term "president" itself: from our previously-published extensive historical and mythological research we now know this title directly derives from ancient Egyptian mythology, being one of the many terms for Osiris, the "god of the dead" himself. The actual title is "Osiris, President (First) of the Westerners" -- "Westerners" being a term referring to those who

died in Egypt and were subsequently buried on the Western side of the Nile. The term "First" (president) is especially interesting, as a close reading could also apply it to Osiris's son, Horus, who was his "first son." So, in this context, "president" could also be directly translated as "Horus"!

What we are seeing play out in Florida, we believe from our previous research into this entire issue of the historically-documented Masonic/Egyptian origins of the office of "President (First) of the United States," is nothing less than a battle among self-appointed "gods," Gore and Bush, over who gets to be "Horus" at the "end of days!"

And make no mistake, we are truly at The End of Days. We have waited nearly a year now to reveal what we have come to know (and yet still have an incredibly hard time believing ...). The "Millennium" (as popularly perceived on January 1) just past, was NOT an insignificant, arbitrary event. It was, in fact, a specific marker set up as a "final warning" of what is to come, of "the Eternity, before which we stand upon the Brink ..."

Other things Hoagland mentions

He talks about the huge show that was put on in Times Square at the beginning of the millennium, and how there were all kinds of hidden Egyptian messages for people "in the know".

Another, more important, Masonic show was put on by Bill Clinton at the base of the Lincoln Memorial in Washington. Clinton referred to Egypt, Horus, etc. "and perhaps even a portent of an impending pole shift".

Here's an important interpretation of this ceremony that had all kinds of messages (you have to read the article to see how he gets to this conclusion): "the strong suggestion that those watching both on the

Mall and over TV are "soon to be carried away on the wings of Pegasus to be judged by Osiris" (that is, are soon to die).

Another quote: "If in fact the Earth were to experience a pole shift, as is now publicly acknowledged to have happened in the past, one of the likely effects would be the temporary cessation of the planet's rotation. If this were to happen, the possibility is fairly high that the Sun could seem to RISE IN THE WEST on that fateful day".

"So, does the rising of "Horus" in the West - aligning with EQ Pegasi - mean that somebody is telling us that we will experience death by pole-shift and be judged by Osiris?"

Part II goes on to show that "we live in a very special time". Hoagland says that there was an amazing alignment of Sirius on the Giza meridian at PRECISELY THE TURN OF THE NEW MILLENNIUM. He goes on to show that this was ONLY possible by the fact that our entire system of time, the "Gregorian calendar" we use today, was apparently specifically designed - LITERALLY THOUSANDS OF YEARS AGO - so as to arrange the precise astronomical conditions around which this one UNIQUE celestial event would happen.

To quote: "But it is clear that Dinoysius did not actually set his "Christian Era" by what he thought was the birth year of Christ. REPTILIANS STEAL BABIES

This article is dedicated to God who helped me through this, and to all the women who have lost babies through abduction

On Friday 13th July 2001 I was two months pregnant with what we hoped would be our first child. I had turned 42 around that time. My husband Michael and I had been happily married for four years. I spent all of that day in our apartment near Norfolk, Virginia, while Michael was at work.

I felt wonderful all day until 3.30 - 4.30 pm when I suddenly felt VERY tired, terrible and wiped out. I felt so bad that I decided to take a nap. I was asleep when Michael came home at 6.00 pm. By this time I was still feeling really bad and even nauseous. This was very unusual as I am very healthy.

We quarrelled, which again was very unusual. Finally, I overcame my negative feelings enough to ask Michael for a kinesiology balance to find out what why we were quarrelling, and why I felt so bad. (Kinesiology makes use of "muscle testing". Through this simple technique which can be learned through a system called "Touch for Health" you can learn how to communicate directly with the brain, which knows everything about your body. See www.tfhka.org).

Michael gave me the kinesiology balance. My 'Cloacals' were out of balance. The Cloacal system is an energy system known by hardly anyone except a few people who have learned this correction from Applied Kinesiology. The Cloacal System controls and regulates most if not all of the major fluctuating qualities and quantities in the body. When your Cloacals are not working you are like a 'leaf in the wind' and will be much more affected by different stresses.

The Cloacals seem to work by acting as a reference point for the Autonomic Nervous System, which has the main job of maintaining stability within your body. Therefore, with the Cloacals 'blown', as we say, a person will be continually out of balance and the body will not be able to completely heal itself. In addition, they may be operating on, say 30% to 70%, of normal body energy levels. In this case, there is little energy available for any needed healing.

If the Cloacals are not working properly, a few of the things that will be affected are; body energy levels, bladder, bowels, reproductive organs, pregnancy, sexuality, hormone levels, body fat, metabolism, blood sugar

levels, blood pressure, body temperature, speed of healing, immune efficiency, brain chemistry, learning abilities, coordination, emotional stability and allergic responses! It takes a VERY large stress to knock the Cloacals out of balance, for example a car crash, divorce, death in the family, being born, having a child, being vaccinated or --- being abducted.

Michael muscle-tested me to find out why my Cloacals were out of balance. Through a long process of questions and answers, my body indicated that I had been abducted. On asking the body whether the abductors were humans, aliens, reptilians or something else, the body indicated that they were reptilians. (Note: It has been found by muscle testing that our bodies don't classify reptilians as "aliens". Presumably this is because they have been on this planet long enough to count as natives).

From personal experience and also from doing kinesiology on a number of people, I believe that anyone who has been subjected to abduction or mind control will have programs put in their brain called "Wernicke's Commands".

A "Wernicke's command" is a sabotaging command stored in the right Wernicke's area of the brain. Most of us have a lot of these. They got stored there whenever someone whom we held as someone in authority, such as a parent or doctor, said something to us. These commands are worded from a "you" point of view. For example, if a person has a belief that "I'm not good enough" the command is likely stored in their brain as "You are not good enough", which is what the person said to them. Wernicke's commands are bad enough for messing up one's life, but when they are put in a person's mind INTENTIONALLY by mind controllers, using force, they cause even more problems. I presented the "Wernicke's Commands" at the July 2002 annual conference for the Touch for Health Kinesiology Association of USA (www.tfhka.org). They loved the correction when I taught it to them! Then I finished up with ten minutes explaining that healers should keep an eye out for victims of alien abduction, reptilian abduction, military abduction and mind control. I also explained that if they suspected that a client had been affected by these things, to first check for "booby traps". These are Wernicke's commands to (1) die if the person remembers (e.g. "Have heart failure if you remember this") and/or

(2) kill the healer who helps them to remember (e.g. "Kill the person who helps you to remember this").

Around 2000 a healer in Melbourne Australia was killed by one of her clients. I believe that she probably unknowingly uncovered the client's programming, without first removing booby traps to make the person kill whoever helped them to remember.

At the end of my ten-minute dissertation on aliens etc., most people were frozen in their seats. However, a number of people afterwards expressed their appreciation of the new information. Since that time, I have learned that at least one kinesiologist found on returning home that all kinds of new clients turned up to see her - and they were all abductees who needed this correction! One man had leukaemia. Just removing the Wernicke's commands (such as "Have lung failure if you remember) his pulmonary capacity doubled within a day (as confirmed by his doctor)!

Muscle testing on the day that I had been taken by reptilians indicated that I had been given twelve Wernicke's commands. This felt correct to me.

Before we could remove the Wernicke's commands, a drug was balanced out with kinesiology.

The twelve Wernicke's commands that were removed were:

1. Don't remember this
2. You are ours
3. Forget this
4. This didn't happen
5. You belong to us
6. Nothing happened today
7. We weren't here
8. Today was great
9. Stop fighting us
10. We're invincible
11. You will lose
12. You don't want to do this anymore

Further evidence that I had been abducted was a very strange, very dark purple bruise that I had on my inner right thigh. It was in the shape of three fairly distinct solid diamonds joined to each other in a line. The whole bruise was about one inch long and ¼" inch high. I had done nothing at all to create such a weird-looking bruise. I had done no exercise and had hardly been out of the house for days. I do not bruise easily.

Michael also balanced out the effect of a machine which looked inside my body.

We both 'got' that the reptilians had used some kind of technology that was not on Michael's usual prayer list, which had been protecting us for many months from the monthly military abductions which Michael had been undergoing. (See 'The Mars Records'). We 'got' that the reptilians' technology in this case created a wormhole leading to an artificially-created reality.

I suggested that in future Michael add "protect against all negative energy -- physical, metaphysical and spiritual", in addition to the specifics that he prayed for, for protection.

After I was balanced my energy and sense of wellbeing started to return.

It may not have been an accident that they decided to do the abduction on Friday the 13th.

I was hoping that the reptilians had not taken our baby, which should have been two months old at that stage. I had had an exceptionally vivid dream, weeks earlier, that I was carrying a baby girl. I had never had a dream like it in my life. On the strength of that dream we named the baby Susan. I wasn't able to fully face the truth after realizing that I had been abducted - that Susan was gone. But the next day (Saturday) I was spotting blood, and two days later (Sunday) I was bleeding copiously.

On one night - I guess it was Sunday - I was in agony. It is so easy to say "Had a miscarriage". I had never heard that they could be so difficult! Perhaps 'normal' miscarriages do not affect the woman greatly. I was up for hours on the toilet, in total agony. Only prayers helped to finally put an end to it all, and finally get the placenta out.

The baby was gone.

For those who think that this was just a miscarriage, I would like to point out to them that we knew that I had been abducted before we knew that the pregnancy was no longer there.

A few days later, Michael helped me to do a Clearing session with a biofeedback meter, to verify the truth of what had happened. That session may not have been as accurate as possible, since Michael was not trained in the use of the biofeedback meter. I basically did a solo session, with Michael supporting me by holding the space, acknowledging me and watching the meter.

During the session I came to remember what happened. As soon as I started the meter indicated that there was something highly stressful to my body. Once Michael commanded me to tell him what happened, the pictures of the abduction came to my mind. In addition, the various reads on the meter indicated that all that I remembered was true. I was in the living room when I was transported through the roof of the apartment, by being transported through a wormhole into another dimension. I was put on a cold metal table. There were four reptilians. They had a big jar for the baby. They attached some kind of machine to my leg, where the bruise was. Through this machine they teleported Susan straight out of my body into the jar.

There were two other incidences after this when I was abducted, after which I was totally wiped out for hours. I could hardly move, I was so de-energised. We 'got' that I had been abducted again because they needed me to give my life force to Susan to keep her alive.

There were numerous times after the first abduction when I would cry a lot over the incident. I finally realized that not all the grief was coming from me - most of it was coming from Susan, who was totally distraught at being stolen from her mother.

Since this time I have wondered how many 'miscarriages' are really abductions. I feel that quite many of them are. My understanding is that the aliens or reptilians have to allow the baby to progress to a certain stage (2-4 months) in the mother, because if they remove it too soon, it won't live.

I have been told that it is "normal" to grow a placenta without a foetus inside. Well, my understanding differs. UFO ENCOUNTER OF EUGENE CUTHBERTSON

In early November, 1983, Gene Cuthbertson surveyed the miles of scorched hills east of the Villa Park stables where he boarded his mare, "Feisty." Most of the stable had been spared and he was glad to have helped in the evacuations, but the heavy smell of smoke still dogged him. He organized volunteer horsemen to transport donated food to the surviving animals. Feisty was packed with grain, wild bird seed and bruised apples in two burlap feed bags. Eight riders assembled, their horses packed with edibles for the surviving wildlife. The horses were uneasy about entering the fire area, so Gene swabbed their nostrils with Vick's ointment to keep their tear ducts open and block the smell of smoke.

The Morales sisters insisted on leading since they had a Minolta camera. They rode up the jagged scar of a rabbit trail into the hills, as dusk threatened to settle. Gene followed, with his German Shepherd "Breta" in the lead. The riders followed at roughly hundred yard intervals. The plan was to dump food where animal tracks or birds were seen. Gene saw the Morales girls ahead of him, dissolve into the gathering darkness, but he knew where they were. Indirect lighting from the distant Riverside Freeway made the trail murky when seen from the horseback, so Breta led the way. Gene spread his food among rabbit and quail tracks and the scorched area was as close to hell as he might ever have imagined. Only deflated cacti and singed scrub brush survived. He became swamped in complete darkness.

Suddenly Breta burst into a fit of shaking, throwing her head around, barking, and making gurgling sounds. Feisty acted erratically, shaking wildly, and pounding her hooves into the ground. Gene's first thought was "rattlesnake," and he feared that Breta had been bitten. Gene began to swing out of the saddle and froze. A huge disk drifted over him, perhaps only 15 feet overhead. It glowed faintly. The ground swirled with debris and fine dust, but he remained transfixed. Both awed and dumbfounded, he hung, partially dismounted. The disk, 55-60 feet in diameter, floated away at an increasing pace. Gene's dog and mare never quite settled down. He later thought that only about twenty seconds had elapsed, but his watch died and even battery replacement couldn't fix it. He could see the disk assume the classic saucer shape, its top bulge becoming more apparent. Camera flashes came from one of the Morales girls in the distance. When the disk reached the end of the fire area, two others like it appeared. They took on incredible acceleration together, swinging northeast toward Nevada, and vanished. This craft is identical to the one described.

Gene spun Feisty around and backtracked toward the stable. When he arrived, he walked Feisty the old-fashioned way until she was cool. He was combing the sweat marks out of the her back, when old George Thompson, the stable's caretaker, intercepted him and asked if he'd seen anything unusual in the burned-out hills. Gene nodded. "No one will ever believe me, so I guess I'll just take notes, file it away and shut up."

Gene went home and soaked in a hot bath, with his loaded Ruger .44 magnum close at hand. Fear began to seep into every part of him as the UFO encounter repeated itself at fantastic speed within his mind. Waves of nausea swept through him and he leaned over, vomiting in the trash can. He nearly panicked, but the sight of Breta sleeping in the bathroom doorway calmed him. He finally got out of the tub, feeling unnaturally awkward and feverish.

He dried himself and grabbed his Bible as he flopped onto the bed. He started to read Joshua 1: 9 and fell uneasily to sleep.

It seemed like only a few seconds had passed when the ringing phone awakened him, but it was a little after dawn. He felt weak and generally wretched. George Thompson was on the phone telling him that his mare, Feisty had collapsed and that Equine Veterinary Associates had been called for her in an emergency situation. Gene wanted to rush to the stable and meet with the veterinarians, but he found his body lethargic and his thinking somehow slow and cluttered. He managed to get dressed, but when he called Breta, she didn't move. She was limp, glassy-eyed and had laboured breathing. Gene's adrenalin kicked in and he phoned ahead to his small-animal vet, Dr. Helmut Denberg, a specialist in German Shepherds. He met with his own physician, Dr. Milton Okin, and results of medical tests showed he was anaemic. Veterinarian Denberg revived Breta and eventually restored her to health but determined, after extensive testing, that she was badly anaemic. EVA later phoned in the test results on Feisty, describing her anaemia.

Gene thought about possible radiation exposure, but he didn't know of anyone with a Geiger counter and he was so miserably weak and nauseated that he couldn't immediately look into such a possibility. It might seem strange to people not familiar with veterinary science, that Feisty, Gene, and Breta were all treated basically with the same medications and procedures. Each received massive vitamin injections and ferrous sulphate tablets and antibiotics, in addition to their normal nutritional supplements and lots of rest. It took well over two weeks for them to show signs of recovery and renewed strength.

A month later, Gene examined the photos of the disk, taken by the Morales sisters. The pictures were of poor quality and showed the saucer as little more than a blob, making them only a slightly better than useless. The pictures reminded him of the encounter and he shuddered, preferring to forget the experience, if only he could, but it haunted him. It still haunts him. Basically a shy, sensitive man, even among his fellow university students, Gene avoided the topic of UFOs entirely and suppressed memories of the UFO encounter. He reviewed his notes and placed them in a folder, which he rarely opens. Years passed quickly and the UFO phenomenon gained credibility, and Gene Cuthbertson quietly began to study the UFO phenomenon. He joined MUFON and helped organize the Orange County Chapter, but has until now declined to relive the encounter or to write about it.

AMERICAN OFFICER KEPT HIS SILENCE FOR TWO YEARS

Aliens took part in a military exercise in Arkansas

An American officer, who wished to remain anonymous, affirmed that aliens had participated in a military exercise that took place in Arkansas several years ago. "There are some things that I cannot talk about. Yet, I think I can say something."

Airborne troops conducted their exercise from April 15 to May 5, 1992. The event took place on the territory of the Fort Chaffee army base. "A strange noise could be heard in the distance at about 00.30 a.m. Soldiers thought that the 'enemy' landed on the other side of the swamp. Everybody was ready to meet them. The only aspect that we did not know was the time it would take for the 'enemy' to cross the swamp. Before the exercise started, the commandos were given an order not to use night-vision devices. However, there was an American sergeant among the Puerto-Ricans who had such a device.

"The soldiers soon heard strange sounds coming from the other side of the swamp. The sounds were getting more and more distinct. Everybody was staring in the direction of the sound, but no one saw anything at all. Suddenly, everyone smelled the strong smell of the swamp. One of the Puerto-Rican officers ran out of patience and asked the American sergeant to give him the night vision device. The officer looked around the territory and he saw three small creatures. They were visible with the naked eye. The officer gave the night vision device to another officer and so on. Everybody saw the weird 'enemy.' The soldiers eventually contacted their command. The command kept

silence for a long while, and then it was ordered to carefully watch the creatures without bringing harm to them.

NEW MEXICO CITY UFO FLEET SIGHTINGS CAUSE COMMOTION

The dynamic of UFO sighting events following Xalapa's incident took a new course last week with yet another mass sighting of a UFO fleet over Mexico City, an event that caused considerable commotion and many reports from witnesses, even during a daily TV show broadcast.

The information and details of this new incident were released by journalist/researcher Jaime Maussan during the radio show 'Los Grandes Misterios' last Sunday July 3, 2005 as part of the continuous coverage of the UFO incidents that followed Xalapa's event.

The morning of Thursday June 30 was clear in Mexico City. A strong rain during early hours left a clear sky in this populated city and the visibility conditions were exceptional.

At 10:00 a.m. Pedro Avila, skywatcher and director of The Vigilantes skywatch group received a call from colleague Enrique Vallarino reporting that an employee had alerted him of a UFO sighting outside their office on Cuahutemoc street near the Medical Center.

Out on the street, a number of people were already excitedly pointing to the sky. What they saw was another 'cluster' sighting...this time about FORTY UFOs flying at the same altitude.

At the same time, the Jaime Maussan Research Center began receiving several calls from different parts of the city. Witnesses were reporting an unusual phenomenon in the sky that was attracting the attention of scores of people who were watching many shining UFOs flying together and appearing as a 'fleet.'

Once alerted, Pedro Avila made several calls to his research team and colleagues like Maria Montserrat Romero, Salvador Guerrero, etc. to advise them of a UFO fleet sighting taking place and to try to get video of the event. A few minutes later Avila received calls from other sources giving the news of the UFO sighting from different parts of the city.

According to Pedro Avila, interviewed on radio by Jaime Maussan, it took just a few minutes to receive confirmation from his Vigilantes colleagues. The sighting was taking place and they were videotaping the numerous objects, which looked metallic, spherical and shining in the sun.

Almost 40 objects were counted, moving in harmony according to the classic patterns of the many other UFO 'fleets' seen over Mexico in recent years. There was a single, larger object noticed above the main formation, which was described as having a yellowish colour, a feature similar to the Guadalajara sighting.

Some minutes later Jaime Maussan received a report from Alfredo Adame, a popular TV host from a daily show by TELEVISIA, saying that many people were calling the TV show and reporting a huge UFO sighting taking place over the city. Alfredo Adame was interviewing researcher Rodolfo Garrido live on air when the people called in to report the unusual phenomenon in the sky urging them to go outside and record the event.

Staff at the airport's control tower were asked if their radar screens were detecting the objects, but they declined to make any statements.

By this time Pedro Avila at The Vigilantes Research Center had already received confirmation of at least three videos taken by Maria Montserrat Romero from Tlalnepantla, Salvador Guerrero from Agricola Oriental and another witness from Coacalco in an extraordinary coordination of skywatch efforts to document the incident.

The images were carefully analyzed and the 'balloon' explanation was quickly discarded, because of the patterns flown by the whole mass of UFOs and its synchronized flight path -- a classic feature of a UFO flotilla. Pedro Avila made an analysis of a zoomed frame of one object and confirmed that it had no cord attached and that its shape was not that of a common balloon.

THE PEOPLE'S AWARENESS

On Sunday July 3, Jaime Maussan made a national call on television for eyewitnesses to come forward and share their sightings from that June 30 morning, and for anyone who may have videotaped the UFO flotilla over the city. The response was remarkable, and Jaime received calls and emails from many actual witnesses to this massive sighting.

The next day Maussan received an important testimonial and video from Mr. David Olazcoaga from Ecatepec, Edo. de Mexico, who along with his young son Jesus Alfonso witnessed the UFO fleet.

Mr. Olazcoaga managed to capture on video the moment when the UFO formation moved slowly with the moon behind, a beautiful image. His son Jesus is heard on the tape asking him: "Are they going to attack us?"

Tenth planet found in Solar System

NASA has announced the discovery of the "tenth" planet of the Solar system, that is one and half times the size of Pluto. Planetary scientist Dr. Mike Brown of the California Institute of Technology in Pasadena, California, whose research is partly funded by NASA, announced the discovery of a planet larger than Pluto.

But Critics point out that US space agency has claimed many times before to have discovered the "tenth" planet, or Planet X, of our system, only to late reveal that the so called planets were nothing but large insignificant space debris.

"NASA's real discovery is the debris falling out of Discovery," said an astronomer on the condition of anonymity. "Instead, they are trying to portray space debris as planets to take the heat away from them."

The "planet" is a typical member of the Kuiper belt, but its sheer size in relation to the nine known planets means that it can only be classified as a planet, Brown said. Currently about 97 astronomical units from the Sun (one astronomical unit is the distance between the Sun and Earth), the planet becomes the farthest-known object in the solar system, and the third brightest of the Kuiper belt objects.

NASA made a similar claim in 2004 when they announced the discovery of the tenth planet "Sedna." Later it was relegated to the status of a planetoid.

Australia Top-end X-files revealed

SECRET -- Documents released by the Northern Territory Government reveal a mass of UFO sightings across the Top End, many of them unexplained. The documents - declassified after 30 years under lock and key - detail a history of UFO activity across the Territory by a wide range of 'sighters', including RAAF crews and weather forecasters. The files were classified and only became

available to the public from the National Archives in Darwin after 30 years. One sighting, by the crew of a RAAF Hercules in Darwin in 1968, also appeared on radar, although no known aircraft was identified in the area at the time. The crew described a series of lights which crossed their take-off path from Darwin airport, with no visible fuselage or structure. RAAF command in Sydney said the contact may have been a foreign aircraft. The fact that the sighting was made by an RAAF aircrew and detected by the aircraft's radar leaves very little doubt that something was in the area," RAAF command said: "As the aircraft has not been identified, a violation of our national airspace cannot be discounted."

Another of the secret documents, obtained by the Australian UFO Research Association, describes a sighting by a weather bureau forecaster at Daly Waters in November, 1966. The forecaster was tracking a weather balloon with a theodolite when he noticed a flying object in the sky. He reported sighting a metallic-grey, oblong object flying at high altitude.

A third file reports the sighting of a saucer-shaped object by a group of nurses in Alice Springs in 1967, who spotted the UFO in the middle of the day and said it was a silver colour with a copper band around the centre. UK UFOs sighted

BRACKNELL NEWS -- UFOs were sighted in the sky over Crown Wood on July 19, 2005, when Maurice Jones looked through his binoculars, which he uses to spot birds. But when he and some of his family saw not one, but two UFOs hovering above their house at 4 p.m., they knew something strange was happening. They got some neighbours to look as well. Maurice, 50, a Parcel Net courier, said his 12-year-old daughter Alaina, spotted the strange object first.

Maurice said: "The first object was huge and the shape of a plane fuselage or a cigar tube. It was brown and rotating in the sky. When it caught the sun it had a metallic appearance. It came right over the top of us." Mr. Jones said the object was in the sky for around 20 minutes before disappearing. But the group could not

believe their eyes when they saw the second object a few minutes later -- a flying saucer spinning fast. Both objects were in the Heathrow Airport flight path.

THE EXTRATERRESTRIAL EXPOSURE LAW

On 16 July 1969, a United States law was passed, called the "Extraterrestrial Exposure Law," that made it illegal for the public to come in contact with extraterrestrials or their vehicles. (Title 14, Section 1211 of the Code of Federal Regulations). Anyone found guilty of such contact could face up to one year imprisonment as well as a fine of \$5000. Also, any individual who had been "exposed" could be quarantined under armed guard by the NASA administrator without a hearing.

The law was passed originally to protect Earth from possible biological contamination resulting from the US Apollo Space Program and other space exploration programs. It has been suggested by researchers and scientists that the U.S. government was very concerned that contact with extraterrestrial bacteria could result in a worldwide plague. The immune system of human beings wouldn't be able to fight off extraterrestrial bacteria, so therefore any kind of "extraterrestrial exposure" was taken very seriously.

People in the UFO community especially were alarmed with the law because its broad definitions could allow the US government to prosecute people in NASA as well as individuals of the general public who come into contact with extraterrestrials and their vehicles.

UFO and ET believers found it interesting that on one hand the government was denying they had any interest in extraterrestrials, yet they had a law which forbade contact with ETs and their craft.
