Flying Saucers In The Stone And Outer Space Age

Let's Expand Our Research!

During the past few months, the trends seem to have become developed by people who are not interested in flying saucers, to poo-poo the idea of the existence of saucers. This poses the problem of getting better facilities to do better flying saucer and U.F.O. research.

Our excellent American Air Force is a national defense unit. Many people are under the impression that a defense facility is also a private civilian thing and therefore they expect the Air Force to respond in an open civilian capacity. This view has been a false idea in the minds of people everywhere.

The shocking truth of this problem, people are faced with, consists of people refusing to launch a civilian proposed form of research which will not infringe upon the Air Force defense function. The Air Force has announced with emphases, that the flying saucer and the general UFO sighted, are not a menace to the American national security. Yet, people have ignored the fact that since the Air Force is a military unit of defense, any saucer reports goes into their files and becomes defense property. This means no civilian is allowed to prowl through military files.

The failure of the American public lays in the fact that the people themselves have failed to set up inexpensive research and analytical facilities under civilian supervision.

It is no idle theory now. If the American public wants to gain facts on flying saucers, they must begin looking to themselves for the answers and stop annoying the Air Force with civilian interference. As to why American people are so lazy they have refused to do civilian research and set up civilian facilities that do not cost much, is also neglect and laziness on the part of those people who have the added funds to do so. The initial job of determining the friendliness or hostility of the flying saucer and UFO, was done by our Air Force. They gave that announcement to the public.

Now, that the public knows the flying saucers and the UFOs are not a menace to our national security, it is perfectly safe and logical for anyone and everyone to engage in the business of doing private and cooperative research in analyzing saucer data on a civilian basis. Those who wish to feel patriotic can always send duplicate reports of all sightings to the Air Force. But let's also keep our self interest in our private research.

The job now, consists of a form of comparison projects being set up where there is a full scale cooperation between all UFO research groups. Unless there is a cooperative movement between all research groups who do material collecting, certain UFO organizations will simply be bypassed by the Powers that designed the flying saucers. As to how the cooperative functions are worked out, it is immaterial one way or another. The individualized problems involved can be met and overcome.

One word of caution is given. The so-called flying saucers are mechanical craft that use Universal dimensional flight functions. The historical records show these craft have existed for millions of centuries and they will keep right on existing and no one in this world will stop them.

The Space People who go with these flying saucer air craft, were at one time, the humans who were in mortality prior to our coming into mortal existence. These humans gained Mastery of the Mortal Realm and moved into the next Realms higher. They really were mortals before we came along. These people used technical sciences that were developed by manual labor and by their own effort. The Possibility of Little Men

This article is in reality a compressed lecture, for it was taken from the notes on the lecture given for the Discussion and Lecture Committee of "Saucer News" on the Possibility of Little Men. The list of sightings, which were given in the original lecture, must be deleted, for fear of overburdening the reader and the printer. However the article will make an attempt to expound the hypothesis, which creates the title.

I shall begin with an examination of the stories which create the Little Men Theory. I cannot give the reader any proof that these stories are true. The idea may very well have originated with the writings of one man. A presentation of the first stories which refer to little men, will allow the reader to judge for himself.

The first mention of little men in the saucer research field other than the little green men of myth and fairy tales, seems to occur in the book by Frank Scully titled "Behind the Flying Saucers" which was published in 1950. In this book a "Dr. G." relates his story of a saucer 100 ft. in diameter, which had been forced down due to some type of malfunction. The event had been disastrous and within the saucer 16 little bodies had been found. The bodies ranged from 36 to 42 inches in height and were all of a dark chocolate color. The saucer is supposed to have been dismantled for study by our government. One is left to assume that the little men received a like fate. "Dr. G." also continues his tale by reporting that the government has three ships for study. A second ship had landed near the proving grounds in Arizona which contained 16 little men who were not burned brown, while a third craft had landed in Paradise Valley near Phoenix.

Other stories of a similar nature occur in "Flying Saucers on the Attack" which was written by Harold T. Wilkens. The first of which is a story credited to a Mr. Joe Rohrer of the Pikes Peak Radio Company. We learn that during an address by Mr. Rohrer to the luncheon guests of the Pueblo, Colorado, Chamber of Commerce, he informed his listeners that a California Air Pilot had made the following statement to him.

I have been inside a saucer 100 feet in diameter, there was a little man taken from it, who is being kept alive in a sort of incubator pressure chamber which is located at an Air Force Base near San Diego. Surgeons of the Air Force Medical Division are dissecting the cadavers of two other little men. The bones of the little men are heavier than the bones of humans.

The second story refers to a research technician named Mr. N. Bean. Mr. Bean addressed the Miami Beach Rotary Club in Florida. In his after dinner speech Mr. Bean said that he had talked with a truck driver who had hauled a saucer, which had been forced down by radar, from New Mexico to somewhere in Ohio. The truck driver said that the government had been unable to gain entry to the craft.

The third story concerns an unnamed correspondent of Mr. Wilken's who wrote him that during a business trip he had met a very reliable man. These two solid citizens, As Long John Nebel of Party Line fame would say, had discussed information given the reliable person by a party of the third part,

information regarding little men and saucers. Evidence such as this would never be admitted in any court in our land and we may well refuse it ourselves.

The fourth story reaches back into the 1880's and relates a story told to a man who related it to someone it was heard from. All these tales are not related directly by the person whom they may have happened, therefore we may very well say that they are "One Step Beyond".

There is another famous or infamous odd ball little man story, that is the Fred Regan story. This was published in Action magazine, May 1953. Under the title "I Rode A Flying Saucer" Fred Regan recounted a supposedly true story. The story involved a plane which was struck in mid air by a flying saucer. The pilot of the plane, Fred Regan was thrown clear of the wreckage of his plane minus a parachute. His rapid descent was stopped and he was drawn into a saucer thru a circular hatch. He saw objects described as animate three foot stalks of metallic asparagus. He fainted from fright and revived to hear a voder type voice speaking thru a loudspeaker in English. The stilted and metallic voice apologized for the accident, assured him that he had been examined and found well, and informed him that an abnormality of his body had also been corrected. The abnormality was one he would term cancer, he was told. It had been adjusted the voice informed him as he lost consciousness. He next awoke in a hospital where he learned that he had been found lying besides his demolished plane in a cornfield. He, the hospital authorities amazingly informed him had sustained no injuries. The article ended with a news paper clipping, which gave the following information.

#### Saucer Passenger Dies

Atlanta--May 16th 1953

Fred Regan who made headlines last year when he claimed he had been a visitor aboard a flying saucer, died today in the State Asylum for the Insane. Cause of death was determined to be degeneration of brain tissue due to extreme radiation. Authorities are unable to offer an explanation.

Personally I have always felt that another contactee was making an attempt to assert that he was contacting little people. The reader will recall that the saucer woman from Truman Bethrum's Space Scow Aura Rahnes was only four feet tall. I remember this rather vividly, for the best of my knowledge, she is the only space woman who ever figured as a correspondent in a divorce trial on earth.

All the foregoing tales and stories have never been verified. I personally do not think they ever will be. They seem to be tales told for profit, publicity or prestige. To entertain any theory about little men, we will have to find something more factual upon which to base the theory.

An examination of some sightings will give us the base we need to build upon. During 1950 the Sawbill Bay sightings were originally published in the Steep Rock Echo, this is the official news organ for the Steep Rock Iron Company and is edited by a Mr. B.J. Eytan. The Sawbill Bay sightings involved a couple of sightings of little people who were active about a saucer type craft which rested on the waters of Sawbill Bay before it took off. On August 27th 1952, a tiny saucer type craft struck a chimney, according to a Buffalo news paper report. The craft landed a little man hopped out surveyed the damage to his craft then reentered and took off. Later during the months of May and June of 1953 the well known Brush Creek sightings were reported. Much of the northern portion of the continent of North America is sparsely populated and the mountain regions are comparatively wild we may assume that

landings which were unobserved took place more than once. Whatever the reason the North American little men sightings are few and far between.

The next event relating to little men in saucers happened in Europe. (Note.- There is only one sighting I know of which leaked out of the occupied zone previous to the fall of 1954. This is the Hasselbach sighting in Germany which occurred on July 11th 1952. The Hasselbach sighting involves a former mayor of an occupied town who swore to an affidavit, which stated that he and his daughter had seen a saucer and two figures on the date above. This date was previous to his escape from the Soviet Zone. If saucers with little men in them were landing in Russian territory the information has never been revealed to the Capitalistic World. Perhaps the little men would not become good part members.)

On September 10th 1954 a sighting by a couple of road repair men just about to quit work for the day, was the start of a little men saucer flap which occurred in France, Italy and unoccupied Germany. I have been able to secure information regarding over twenty five sightings or contacts, which happened in those countries during the fall of 1954.

Life magazine for November 11th 1954 ran pictures of the French farmers, bakers and other simple working men who became involved with something they could not explain. Men who not only gave evidence by showing marks left by the craft but also drew pictures of the little men and craft they swore they had seen. The sightings reported in Life include those which occurred at Lectudy, Marcoing, Toulouse as well as the individual sightings of Jean Narcy and Gregoire Oduet at Wassey. The issue also contained a picture of Marius De Wilde of Quarcoble which showed the marks left on the railroad tie by the craft he saw.

The November 29th 1954 issue of Life magazine printed a report of the Signora Rosa Dainelli incident which happened near the Tuscan village of Bucine in Italy. This issue contains pictures of Signora Dainelli and her family in their humble Italian peasant home.

During the last of the European incidents, the first of the events began to occur in the South American continent. The little men may have found the summer climate of the southern hemisphere more agreeable, for they now seemed to appear without their diving suits or other protective clothing, at times they were seen in only a type of loin cloth. Now that the bodies of the little men could be seen they are described as being very hairy.

The few persons who attack them or who were attacked by them all gave the same type of information. The little men were light in weight but very powerful for all their diminutive size. They seemed to have long nails or claws which inflicted deep gashes and scratches similar to the claw marks of a large animal. The gashes, deep scratches ripped and torn clothing exhibited by those persons who came into close contact with these creatures, as well as the condition of hysteria or shock which necessitated hospitalization, gives proof that these people were telling a story of a physical experience. Their stories were not told for profit, publicity or prestige. A better example of this may be seen in the case of the young man who smashed his treasured gun in a struggle with some of the little men. Rifles and shotguns are a costly item and a rare possession when you work at the starvation wages of a peon in South America. This was a gun it would take years to replace. Proof that the incident took place, as related, was verified by the authorities, who checked the signs of the struggle and the condition of the man's companion, who also swore to the same story. The clubbed gun had been the means of saving the companion from being dragged away at the time of the struggle. There was no profit in it for the lad with the gun except the gratitude of his friend.

Now that we have established a more factual basis for a little man theory, can we further elaborate this theory? It is a matter of record that Dr. Aniceto Lugo observed flashes of light inside the moon crater Kepler

During the European invasion and Mr. Venagas the Minister of Communications, Venezuela, an amateur astronomer reported seeing light flashes of one or two minute duration emanating from the Crater Copernicus.

Examination seems to show that the sightings follow a pattern. A possible pattern of survey and exploration. First North America then over the Atlantic to the continent of Europe and finally to the southern hemisphere continent of South America. The landings which seem at first to have been done in a tentative manner in America, would seem to have become bolder in Europe until at the end they are attempting to snatch articles. In South America the pattern becomes even more clear the actions more bold. They attempt to abduct, they openly take samples of plant life, of stones and dirt. They may have taken a sample of a human in some isolated spot, a person who is now presumed missing.

If we are to entertain our theory we must also examine the possibility of a race of little men having existence on some other planet which may even be outside our solar system. Science now grants the premise that other stars in our galaxy have inhabited planets.

What are the chances that such a planet might have little men, what were the chances that this planet might have had little men. We do have pigmies on earth but they are a branch of the humanoids. The hairy aspect and the claws of the creatures we are theorizing about are not human like. We do have evidence that a type of little men developed early in our own evolutionary cycle all though it faded out on earth many years ago.

In Casper, Wyoming at 1419 East Second Street a man named Ivan P. Goodman possesses a little mummy that is about  $6\frac{1}{2}$  inches tall. The mummy was found in a burial crypt and its body now weighs about  $\frac{3}{4}$  of a pound. It has a bronze skin, low forehead, flat nose and a warped unintelligent head fringed with hair. The body is the equivalent of about 65 years of age, has a full set of teeth and its glazed eyes seem to peer at you. X-Rays have revealed a vertebrae and bones similar to a humans. The Anthropological Dept. of Harvard University reports that there is no doubt of the rarity of this type of fossilized mummy. Dr. Henry Fairfield, a noted scientist calls the little creature, Hesperopithecus after a form of anthropoid which roamed the North American continent during the Pliocene Period. This specimen is the most perfect prehistoric mummy ever discovered. (Reference-See December 1958 issue of Flying Saucers "The Reality of the Little Men by Coral Lorenzen)

If the ancestors of a potential little man race roamed our earth during the Pliocene Period but were discarded in favor of larger beings, might they not have been able to evolve more successfully on some other planet?

Until now our hypothesis has been without any scientific background. Could a scientist accept any part of our theory. Strange as it may seem he could for it fits well within the Huygens Theory of Biologican Construction. Christian Huygens first proposed the theory in the 17th century, it has since been adopted and adapted by many later scientists.

We will find that by granting two simple assumptions the theory is in accord with our Little Men Hypothesis. The assumptions have already been allowed by our theory, they are to it-

- 1.- Their bodies must consist of protoplasm like ours.
- 2.- They must be intelligent-How else could they build space ships?

Since the first hurdle is so easily passed let us examine the Huygens Theory for any further agreement.

- 1.- The being would have to breath a type of atmosphere or air. A water breather would be unable to smelt or heat metals and attain a high level of technology.
- 2.- The being must eat both plants and meat.

A life form which subsists on vegetation only would be too occupied in getting nourishment from a great amount of low protein plant life, to devote

time toward developing a technical civilization which was capable of space craft manufacture.

3.-The being would not be much larger than a human.

The square cube law works in the factor of size here for a twelve foot man would weight eight times as much as long as the proportions of the body were not changed. A larger being would be clumsy and unable to perform the delicate precision work necessary for the building of a space craft instrumentation.

4.-The being would have a complex brain which weighed at least two pounds.

A complex brain could not weigh less and contain the information needed for the technical ability required. This also involves a limiting factor as to the weight of the being for a brain this involved would require that the being must have a weight mass of about 40 pounds biologically to creat within it a brain this size, not could it be contained in a body which was smaller in size.

5.- The being would have a type of head and skull.

Since the brain would be a very valuable organ to such an evolved being, a protective capsule such as a skull of bone would have also been evolved for its protection from any injury or damage.

6.- The being would have two eyes and two ears.

Biological factors would create a being with two eyes which are needed for the ability of gauging distance and estimating size and height as well as realizing the beings ears. Allocation of sound and its distance is sterophonic as the present day music listener known. Possession of more than two of either of these organs would be excessive and perhaps create confusion more than they would lend extra ability.

7.- The beings eyes and ears would be in a type of head near the brain.

Efficiently evolved beings have no time lag of long nervous systems between danger perception and the reflex danger reaction. Unless this is so the species does not survive.

8.- The being would have a set of appendages similar to our own

Since the being would have to move around he would have evolved legs. Somewhere along the line of his evolution a pair of these would have to have been freed to act as hands. Without hands of some type he would have been unable to create a civilization capable of space craft technology. The most biologically sound position would be an upright one while the best freedom is attained from only having a pair of legs. This theoretically resolves into a basic primordial creature which evolved into a two legged upright being with hands having opposable thumbs similar to ours. The hands would have to be able to pick up, grasp, twist, hold and bend; as well as to strike, push and pull. For all these actions the hand is best pincers or claws will not do and tentacles can only pull they cannot push.

The Huygens Rules of biological construction lends a scientific answer to our theory. The world wide sightings and contacts of common people with the little men make our theory seem more than a possibility. It is also possible that Frank Scully's "Dr.G." was a reality; and that little men have been found in saucers.

Dear Tim:

You probably are familiar with the correlations between Mars and the UFO sightings. In 1950, '52, '54 and '56. These were "flaps" which corresponded with the close approaches of Mars, yet in late 1958, when Mars came close again, there was no increase. Also, there were none in early 1961, when Mars came close again. Some researchers think that this disproves the correlation, but I think different. In 1950, during the "flap" the majority of the sightings were coming from Mexico and the western U.S.A.; in 1952, from eastern U.S.A.; in 1954, from Europe; and in 1956, from the Orient. Each time the area of concentration has moved east. Therefore, in 1958, if the pattern were to continue, the sightings would have taken place in the western U.S. again. But this section had already been visited in 1950. So, the pattern stopped. The UFOs had observed the entire world by sections, and in 1956 they finished. Thus, the sightings after 1956 probably would indicate an entirely different pattern. 

Forecaster E.L. Hill of the U.S. Weather Bureau office stated that he saw the object or material, and two smaller "pieces" from the bureau's 14th floor office. The two smaller objects appeared to fall to the earth several blocks away.

HERE'S A FRIGHTENING STORY

Petalume, Calif. Argus Courier- April 1, 1963. Air Force and civilian authorities are checking out a mysterious flying saucer report from the Chileno Valley area. According to Angelo Mostaccioli, a milker, he was out rounding up cows about 5:30 in a pasture when he saw a huge, disc like machine come over the horizon, emitting a blue glow and settle to the ground near a grove of eucalyptus trees. Sheriff Louis Mountanos of Marin County, told the Argus Courier shortly before noon that he is still interviewing Mostaccioli, who is "most excited" according to the sheriff, and that "so far we have no reason to doubt this man's story." AF officers also are in on the investigation, checking out the report as to whether an UFO is actually involved. Shortly before Mostaccioli said he saw the machine, citizens in the Pt. Reyes area phoned Hamilton AFB complaining of a sonic boom. However the AF denies any of its planes of supersonic capability were in the area at the time. Also a check with the 12th Naval Dist. Headquarters indicates that no Navy aircraft could have been responsible. The military is certain the responsible craft is not one from a potential aggressor. Radar observers are being questioned further today to see whether any strange "blips" appeared about that time. Sheriff Mountanos, working from fragments of Mostaccioli's story, reconstruct the incident like this: The Milker was returning toward the barn, when the machine swiftly came into view and settled on the ground. Cattle panicked and several broke a wire fence and ran onto a neighbor's ranch. Mostaccioli saw several small figures get out of the saucer and walk about. With considerable difficulty some of them managed to catch a calf and took it into their UFO. Other spacemen took containers out and filled them with small pieces of (Cont. on next page)

turf and plants from the pasture, carefully transplanting them into containers which then were stowed in the ship. Mostaccioli, said, talking almost incoherently, some of the figures approached him and seemed to beckon to him. But he ran as hard as he could and made a getaway down a creek bed where the small creatures did not venture. A few minutes later he heard a loud humming noise from the pasture and saw overhead a weird bluish glow as the craft sped out of sight in the general direction of Nicasio. When the authorities looked over the sight of the landing they were amazed to find that the area was scorched in the green grass, about 10 yards across, and several small holes in the turf nearby as though someone had removed bits of turf of plants. There were also faint tracks which could not be identified.

Have you noticed that when contact stories are being discussed, someone inevitable shrugs them off with the remark: "If these space people are so bright, then why do they not contact someone in authority? The President of the United States or the Prime Minister of Great Britain. Someone who carries weight and influence in the world. Someone who will be listened to with respect. But a lorry driver or a simple farmhand. Really!"

It never seems to occur to some people that if the space visitors contacted those in 'authority' they would immediately meet all kinds of built-in reactions - the result of orthodox 'education' and long years of training for their important positions, quite apart from national prejudices. Most politicians and military men who in the "eyes of the world" might seem likely candidates for contact would naturally be keen to learn the technological secrets of the space people, and to keep them for the use of their own country.

Many of the publicised contactees are people in simple walks of life which uncluttered minds. I am not proposing to discuss here which of the many contact stories are authentic, but I am merely indicating that the tendency seems to be to reach people who have not got a heap of prejudices, 'education', and positions in life, as a result of which their training might lead them to take certain actions if contacted.

The above expressions of opinion do not mean that those from out there never contact people in positions of some importance. They may well have done so, but you can bet your last dollar that these would not be publicised. I think that many contacts are now taking place on all levels, but you can be fairly certain that the majority (if not all) are probably being made with those who have uncluttered minds. This includes the few contacts that may have been made with those who have achieved positions of some importance in the world. Their positions would have been attained as a result of their own thinking. They may have passed examinations, taken degrees, and absorbed certain data, to qualify for their positions, but not necessarily have accepted all the information as correct. Their minds would still be uncluttered and free to some extent, even though working in politics, science and industry. Leonardo da Vinci and Nikola Tesla are examples from history of what I mean. I am not saying definitely that these two great men were contacted, but it is possible. Their minds were free and capable of the greatest achievements possible to anyone in a chemical body on this planet.

In these present times, apart from built-in prejudices, orthodox education and a natural desire to keep their positions, the politicians, scientist, military man and the industrialist, are all increasingly concerned with the realm of 'hush-hush' security. There is National and military security, and even Big Business has its own security departments. A man in an important position has many security responsibilities, besides directives coming to him under the label of 'classified', secret, and top secret. If he was contacted by the visitors, his security training and loyalty would make him a big 'risk' to the space people. This fact, too, makes yet another barrier to completely free communication between space people and those in 'positions of importance'.

I think that individual selected contacts have been going on for a very long time, and possible, will continue to do so for some little while. If the space people landed openly before we were ready to receive them that would not be wisdom. You do not teach a child calculus before he leaves the nursery. And let's face it, despite the vast amount of technology we have accumulated in the last 150 years, we are still in the nursery stage, fighting both on an international basis and in the home like naughty children. However, humanity is growing up, albeit slowly (although when one reads the daily papers doubts arise)

and more contacts are, I think, taking place, on an increasing scale.

We must realise, too, that in their choice of contactees, the visiting 'parents' sometimes have to take chances. It must be extremely difficult to locate suitable candidates with the right qualifications from the visitor's point of view. The eventual choice may seem to be all right, the 'background' of the candidate encouraging and with an uncluttered mind, and, perhaps, also a suitable environment. But, what will the contactee do after he has been contacted? Will the shock prove too much for his mind? Will he go berserk, turn missionary, or distort the whole thing altogether? The visitors may have some problems, too.

I do not consider that the space visitors are interested in making us into a race of slaves. They could have done that long ago. There are records of Sky People coming to this planet all through history. (See the books of M.K. Jessup and D. Leslie) Why wait until Earthmen have rockets, polaris submarines and the Bomb before invading?

Some researchers insist that the flying saucers are hostile. The Mantell case is often brought up as evidence. When Captain Mantell and his two wing men in their F-51's, climbed higher and higher to get a look and try to identify the giant UFO over Godman Air Force Base, Kentucky, their leader far outstripped the other two planes. So much so, that when the two wing men were at about 15,000 feet, Mantell was approaching 20,000 feet. According to Edward J. Ruppelt, then head of the USAF Project Blue Book investigating flying saucers, the two wing men were very worried about Mantell, as none of them had any oxygen. Mantell's plane crashed and he was killed. More than likely, as Ruppelt points out, Mantell blacked out due to lack of oxygen and crashed. Alternatively, his aircraft may have come in contact with the powerful force field surrounding this giant space ship. In any case, I do not see how this incident can be used as evidence of saucer hostility.

Vol. 1, No. 4, issue of the Interplanetary News Service Report carries a letter from Edward J. Babcock, Jr., Director of NJAAP. Here is a short quote from it. ".....Mrs. Coral Lorenzen, in her book The Great Flying Saucer Hoax, describes numerous cases of UFO hostility. You might say that 'perhaps all this is not hostility but due to the force field' or something similar. I won't buy this. There are hundreds of cases on file which UFOs show deliberate hostility....."

I am sorry Mr. Babcock, but I do buy it. If you collide with a chair and hurt yourself, do you smack it and say "Horrid chair, who did you do this to me?". This is three-year old thinking. If you get near a hot stove and put your hand on it, do you say the stove is hostile?

Because people who have not yet had the same experience of UFOs as they have had of hot stoves, get burnt, suffer nausea or sunburn, or have their car immobilised, through getting too close to the force field of a saucer, does that make the craft or its occupants hostile? Let us be a bit more adult in our approach to this aspect of the subject.

There have been literally thousands of saucer sightings all over the world since 1947. If the visitors wished to have conquered us, destroyed our atomic piles, our cities, our industries, our civilization, and made us slaves or even eaten us, they could have done all this long ago. It seems so absurd, for serious researchers, to quote a few isolated cases of hairy dwarfs, sunstroke or unexplained aeroplane crashes, as being indicative of hostility on the part of the Sky People.

Mr. Schaefer believes that we may find the following two reports of some interest. The first one occurred on the nights of April 25 and 27th, 1962 at 9 P.M. At this time an astronomer's club in Hanover, Ontario, witnessed and counted some seventy UFOs flying in many different formations, in groups of threes, sixes, eights and tens. One group of 12 to fifteen and another group of 20 to 30. The other sighting took place over Kitchener, on the morning of December 18th, 1962 around 8 A.M. Brian Kuehl at that time watched three bell shaped UFOs fly past his home in a perfect triangular formation, making a low pass over the trees banked sharply and headed in a North East direction.



# A PRIEST UFO FAN

## A Whisking Whirl

If my memory serves me right, two engineers, among many others, repeated with great success Jean Perrin's famous 'experiment'. They had put up at a hotel, as the story goes, and just before leaving their room for a lecture, which they were about to give, they made their rather heavy gyroscope spin at maximum speed while it was standing VERTICALLY in its 'suitcase' in the corridor just outside the door. Then, they immediately called the bell-boy, a colored gentleman and asked him to carry their 'suitcase' to the elevator around the corner. Everything went along very smoothly until the porter tried to make the sharp turn to the right. He twisted and contorted; but the "diabolical" thing refused to turn. When he spread and planted firmly his two huge flat feet on the terrazzo and applied with violent determination his two big hands on the handle, the stubborn thing finally gave in and turned. But only a bit; moreover, the confounded 'goblin' seemed sorry it had weakened, and so it came right back to its original position with such violence that it wrenched itself out of his hands. By that time he was as 'pale' as a ghost and screaming "Ah's got 'nough'."

But, as you can surmise, it was simply an application of one of the Newtonian laws of motion: A body in motion, stays in motion with the same velocity and direction until acted upon by an external force...

Of course, most scientifically minded people know about this rule and its applications. However, surprisingly enough, many of these do not know, or at least are not aware that it applies as well to fluids including gases. Yet, it is demonstrated daily before our very eyes in God's nature. Researchers and lecturers made it stand out under controlled conditions. Among them Mr. John Perry, a British professor, around the year 1910 showed to his audience that flexible and even fluid bodies, including gases in rapid motion manifest a quasi-rigidity. For instance: 1) a disc of quite thin paper in rapid rotation resists blown as if it were made of steel and resounds like a solid body. 2) a flexible ring of chain made to spin fast on a mandrel will become stiff and when you slide it off it will roll on the floor like a ring. When it drops to the floor, it rebounds like a hoop. 3) Give a box with smoke in it a rapid spin. If there is a round hole on the side, the smoke will come out in rings which, keeping their shape, will move through the air quite a distance.

Many reliable eyewitnesses have told me that tornados drive straws into boards. I am inclined to believe that in view of the above-mentioned principle and specifically because I have in front of me an authentic photo released by the U.S. Weather Bureau showing a 10-foot plank driven by a hurricane (maximum speed 150 mi./hr.) half its length through the hearth of a palm tree and stuck there like the horizontal beam of a cross. The straw was made rigid...more rigid than the board by a wind which sometimes reaches 500 mi/hr. And the plank that pierced the tree was given momentary- additional rigidity.

In view of the above-given facts and many more below, regarding twisters and especially gusts of wind, I, too, am of the opinion that we need not blame the ufos for the cakes of ice, frogs and various other animals and inanimate objects that "fall out of clear skies."

And here are my reasons: A tornado is defined as a mass of air in SPIRAL motion; counterclockwise in the Northern Hemisphere; but clockwise below the equator. It often develops suddenly and momentarily wind velocities up to 500 mi./hr. Now, since these and other tropical storms are uniform as to the direction of their winds, it's reasonable to assume that a strong, widespread unidirectional and constant force is the cause of this particular aspect. The earth, like a supergiant top, spins constantly on its axis eastward once every 24 hours, so that material objects, including the atmosphere, at the equator cover more than 1,000 mi./hr; about 600 at the 45 latitude. Hence, if you are north of the equator, the air at a point 25 miles due south of you, moves eastward 2 mi./hr. faster than you and the air around you, assuming the velocity of the wind is zero. On the other hand, the air 25 miles north, moves more slowly by 2 mi./hr.

But why does the air rise in a spiral? Suppose for instance that in the middle of winter in one of the southern states, say, Texas, the sun beats down for many hours out of a clear sky on a naked area of predominantly black soil. This 'color' is technically not a color at all, since it absorbs all the frequencies of the spectrum from red to violet inclusively. It is important to note in this study that this form of energy is transformed into heat, which will be transferred in part to the adjacent air in two ways: 1) The particles which constitute the various substances in the soil will vibrate more rapidly and thus will impart some of this energy directly to molecules of the air that are near them. 2) At the same time these warmed up substances will radiate, not heat precisely, but radiant energy (infrared rays), which will be transformed into heat. But since these substances will never reach the temperature of incandescent bodies, at least not under these circumstances, they will emit, not short but long infrared rays. Now, the latter, as far as I could find out, do not penetrate the air and water vapor in it as well as the short ones. So, the atmosphere immediately above the ground especially will absorb and transform this second source of energy. Thus its molecules will oscillate faster and further and somewhat counterbalance the force of gravity. As they rise they will do so not vertically but diagonally towards the east for the reason given above. But this ascending air will sooner or later arrive over a terrain which has not warmed up as fast, and consequently it will hit a cold front which will push it back to some extent. Briefly, the warm air will rise spirally, for the reasons just given and for others yet to come. The rising air will create a partial vacuum near the ground causing a reduction of pressure. Hence, the air from the cooler areas under higher pressures will rush in. Now, the air coming from the south, instead of moving in directly on the straight south-north path, will follow a course which will be north-northeast or even northeast, etc., depending on its latitude and other factors which can easily be surmised. The reason for this important change in direction is that the earth is constantly rotating eastward, dragging the atmosphere along. As it can easily be visualized, the new air that just moved over the warm soil will warm up and so follow its predecessor.

On the other hand, the air moving in from the north, strange as it may seem, actually enters the warmer area while following a south-southwestward or even southwestward course according to an up-to-date textbook on physics. That, of course, adds momentum and volume to the above mentioned column of air. I have yet to find an explanation given by the experts on the subject. I am convinced, however, that the following, is as good as any: The air rushing in from the north will also drift eastward under the influence of gravity. But, so will the area

towards which it is heading, and FASTER for the simple reason that it is closer to the equator however so little. Hence, the molecules from the north will strike south-southwestward or even southwestward. This of course, will increase the volume and momentum of the column of air spiralling upwards counterclockwise for localities above the equator. A NW cold front abruptly and violently pushing the warm air up, is the A-1 factor. In all truthfulness I must warn you that most of the explanations given above are personal and may be wrong. However, regardless of the explanations of the facts, the facts themselves remain steadfast. And what are those FACTS? They are extreme disturbances in the atmosphere called tornadoes, cyclones, waterpouts, typhoons, hurricanes, whirlwinds, etc. which are known to lift suddenly even heavy objects like houses, automobiles, etc. and carry them away at amazing distances.

Anyone can see that since the winds in tornadoes, for instance, are strong enough to uproot "big trees," and carry automobiles even just across the street should have enough power to lift up and carry fish, frogs, pebbles and the like great distances. But, obviously, further explanations have to be given if we take into consideration all the facts and circumstances regarding the many and well established Fortean cases of objects falling from the skies. Among these facts and circumstances, the main ones are as follows:

- 1) - Fish live in water wherein you don't find even a light breeze.
- 2) - Many times these objects and / or animals fall out of a clear sky.
- 3) - There is generally no mixture in one fall, the objects are of one kind.
- 4) - There seems to be selection as to time, place, and manner of fall.
- 5) - These objects and / or animals are strangers in the location in which they fall.
- 6) - The fall often consists of flakes, thin strips or shreds of fresh flesh.
- 7) - There are live animals at times.
- 8) - Cakes of fallen ice will often explode.
- 9) - Fish and / or frogs are often found frozen in ice.

Consider a rather small lake with plenty of dark soil around it not too many obstacles that might stop and / or disrupt masses of wind, which, when in rapid motion, behave like quasi-solids as described above. Now, suppose that this small body of water is situated somewhere in the south of the United States, say in Arkansas. It stands to reason that the water in it will become rather warm during the summer and keep its temperature for a long time through the Fall. Finally, visualize one of those very warm days in that area late in the Fall or even early in the winter. On a sunny day by late in the afternoon, you have a great deal of rising hot air, and all you need now for a tornado or waterspout is a cold front swooping down with arctic air from the north west. These are not rare, and they sweep a very wide area for many days sometimes. So, sooner or later they trigger a tornado. The fact is that in the U.S. alone they spawn an average of 240 of them yearly; in 1957 there were 864. Who knows how many elsewhere? Over the globe there are thousands of little lakes, ponds and other such locales, which are ideally situated with all the ingredients for the fermenting of some kind of tropical storm.

Let's come back to our small lake, which, as one can see is not all hypothetical. Sooner or later a tornado will originate over the surrounding area or, if already "born" and hefty but just floating around in the skies, will touch ground again on account of the highly favorable

circumstances. A cold body of water "kills" or at least deviates a tornado. But, our body of water is warm. So, suddenly our tornado with its giant "vacuum cleaner hose" is bound to zigzag over our little lake raising high tides, white caps and spray. So, now we have a waterspout, which in Webster's dictionary is defined as a "funnel-shaped or tubular column of rotating cloud down to a cloud of spray torn up by whirling winds from an ocean or lake."

Now, under these circumstances there are always high waves, and these at times contain fish, frogs and other forms of aquatic life. Then not far away from the middle of our little lake you have the shore and the beach with many and various kinds of round, smooth pebbles, snails, clams, etc. A 300-mile-per-hour wind can certainly pick those up and whisk them up into and even beyond the above mentioned clouds, flinging some of these entities in this mixture far away from the stormy area. As a result some of them will "fall out of a clear sky." In case you are not convinced, consider the following details. The atmospheric pressure in the "eye" or center of this funnel or tube, because of Bernoulli's principle I think, is greatly reduced. As a result, the higher pressure elsewhere on the surface of the water causes it to rise in the form of waves and white caps. When the "eye" moves further, the violent spiralling winds lash up the water and its contents, producing the spray and cloud. This is now a waterspout, which, at least sometimes becomes a whirlwind. In the latter case, the system, as far as I can gather from the descriptions given here and there, is a double cone (end to end). On the surface of the water you have the base of the first cone. The "shell" of this cone is made up of the air, plus the water and its contents spiralling inward and upward. As you can see the circumference gets smaller and smaller as this revolving mass ascends. As a consequence the angular speed, I surmise, is bound to increase. And this has two results, which are of tremendous importance in our present study: 1)- The drops of water in the spray are thrown together to form one mass, a "water pocket" as it were; and, of course, the fish, frogs, pebbles and whatever else was picked up are flung into it to form, as it were an aerial, balanced aquarium in a swirl. 2)- When this ribbon-like mass gets to constitute the vicinity of the apex of the cone, the radius will have diminished and since the centrifugal force varies inversely with the radius, it will have increased. This force will now begin to build the "shell" of the upper cone by centrifuging the mass further and further outward and also upward. Meteorologists say that the winds revolving around the funnel-shaped cloud of a tornado are so fast that instruments can't measure them. According to their estimates, however, they have ranged as high as 50 mph. At any rate, you can visualize that the last and topmost spiral arm of this gigantic cone will catapult itself (water, fish, etc) out and up, perhaps even into a clear, sunny area 5 to 10 miles away in one minute. On that trajectory, as the velocity of this mass diminishes, the fluid will lose its quasi-solidity and fall down as rain, hail or snow depending on the temperature, pressure, etc. And the pebbles, being heavier will have more momentum, and will go further. But sooner or later they will fall, and perhaps together, especially if they have the same size, weight and shape. These factors are the main ones that still determine their coming together in the first place and their staying together against the same forces of gravity, pressure, etc. So, we need not assume that, since objects of the same type fall together at the same time in the same place, there has to be selection made by some extraterrestrial creature who dumped them there. "Birds of a feather gather together." More on this next issue.

U.F.O. Discussion Heard Over Armed Forces Radio

I have just received a report from a friend of mine in the Army in Germany concerning a UFO lecture heard on the Armed Forces Network some time ago. I believe the date was approximately a year ago. I have copied his report to me verbatim, and am including a personal note at the end.

UFO DISCUSSION -- AFN RADIO -- BAD KISSINGEN, GERMANY.

"I shall write this one statement as near as I can remember it being spoken: SPEAKER -- March 9, 1960, a small, wingless, circular plane landed on top of a large mesa in the state of Nevada. The occupants consisted of two men of average size. They appeared to be quite friendly and spoke the English language well.

They approached a small ranch dwelling owned by a Edwin Connell, making him an offer. In exchange for room and board, they would take him on one trip in their plane. The destination was not given. Though frightened by the appearance of the strange plane, he later agreed. He was a bachelor. The visitors stayed 13 months, making frequent trips by train and bus to New York and other major cities including Little Rock, Arkansas.

April 16, 1961, they entered the plane and within moments were gone. Connell described the plane as being "saucer" shaped and made a loud hum when departing. Though offered a considerable amount of money, Connell would give no information concerning the ship's interior, the contents, the trip he had supposedly taken or the "visitors" mission. With a shy grin, the rancher would only state, "all mankind shall benefit within a few years". The reality of the plane and the outward appearance was verified by three local residents who visited the scene. Quoting one spectator, "It appeared to be about 50 feet across and round--almost flat, standing only about 7 feet tall. It rested flat upon the ground. There were no visible signs of doors, windows, or openings of any type. The edge was quite sharp to the touch and the metal seemed to be of aluminum, highly polished." The plane vanished within a few days, re-appearing in the early part of April 1961.

The ship's final departure was verified by a 16 year old youth who stated, "I visited the object several times when it was first here. Later, after it disappeared, I would walk over occasionally. That day, I saw it again. I was at the edge of the mesa and, being alone, I was afraid to go too near. It was then I saw Mr. Connell and two men walking toward the plane. About 25 to 30 yards from the plane they stopped and talked for a few minutes. They shook hands. The two men continued on toward the ship. As they drew near, a small, narrow door began to open--opening from the bottom upward. The men went inside and the door shut. There was a loud, high-pitched "hum" and the ship began vibrating. I blinked my eyes and it was gone. I went home....."

I hope you enjoyed this--I shall tell you more stories the speaker told at a later date.

Incidentally, he gave several incidents of "visitors" living among us--sometimes permanently. Two are in Arkansas but he didn't name the city! He states he has known many women "visitors" as well as men.

Their main reason, other than helping mankind mechanically, is to prevent total destruction should war occur. Their normal length of "stay" is 1 year before replacements are sent. Some enjoy their visit so greatly they choose to remain."


Well there it is! Have you readers heard of this contact before? Its a new one on me. He should be sending me the other accounts soon.
