

The following is based upon a report by Mrs. Mary Lou Guenther detailing an unusual UFO incident which allegedly occurred in eastern Canada last year. Most of the wording is her own, although some revision and editing were necessary in order to place events in their proper sequence. The investigators alluded to are members of the Saskatoon UFO Club, which on October 13, 1963, held an extensive interview with witness Brian Whitehead, aged 11; from this have been gleaned most of the details reported below.

About the witness' credibility, Mrs. Guenther writes, "Brian is a quiet, well-mannered boy. He had no conclusions about that which he saw. His humble attitude, his sincerity, and complete lack of drama or plot convinced the investigators that he was honestly trying to report a very baffling experience."

She goes on, "Brian has received considerable ridicule and 'ribbing' at school and by other parents in the neighborhood. Brian was available to interview only because one of our members is a friend of his mother's."

On Thursday evening, September 19, 1963, about 8 p.m., four children and others were playing on the swings in the playground behind Henry Kelsey School in Saskatoon, Sask., Canada, when they saw a strange object come down from the north and hover over a vacant field across from the playground. 11-year old Brian Whitehead, one of the witnesses, reported that the phenomenon resembled "a whole light" and that it lit up the "whole field like day." Other descriptions he used were "a vague oval" with "funny wings, like circles in circles." He stated that he could see the telephone pole through a part of it or "something which reminded him of a wing." Brian, having seen airplanes at close range at the airport, said that the object was "larger than a T.C.A." (Trans Canada Airline large passenger jet). From across the street they saw what they were sure was a box fall out of the object.

"How high was the object when it hovered in the air?" he was asked.

"Not any higher than that house," he replied, pointing to a Mr. Levorson's one-story bungalow.

"Did it make a noise?"

"No, I didn't hear anything."

The object came in from a northerly direction and left in the same direction. Brian wasn't sure, but he thought he saw the object altogether about three to five minutes. After the object left, the four children went across the street to investigate the "box". But when they got within 10 to 15 feet from where they thought it fell--a man stood up.

"Where was the box?" an investigator asked.

Brian didn't know and merely stated, "We couldn't see any box."

Brian said the man was about 10 feet tall. Thinking that the youth might have unintentionally exaggerated the size because of fright, one questioner asked, "How big was he compared to Mr Levorson?" (who is 6' 2"). Brian said, "Much taller -- about twice as tall as my mother" (who is 5' 3"). He described the man as being dressed in clothes which "were like a monk's." The "suit" was "white like a crayon." When questioned whether he saw pants legs, he seemed puzzled and said, "I don't know; sometimes I could

see through him." The man held out his hands and came towards them, moaning, whereupon the children turned and fled in terror. They did not see his face.

They ran off the vacant field, and Brian fell on the sidewalk, where the bank of the field (which is on a rise) had been cut down in the sidewalk construction. As he fell, he remembered the streetlights going on. The children reached home, hysterical and badly frightened. As a result of the experience, the girl was admitted to a hospital, where she was held for at least two weeks. Brian said, "Barbara is tough -- she doesn't scare easy."

After the children had calmed, police were summoned, and they arrived about 45 minutes after the incident took place. The investigation centered around the field for several days, and the details of it are sketchy. The boys were questioned separately and made to draw sketches, which apparently agreed. At one time during the investigations, Brian said, the police made three boys sit on each other's shoulders and try to walk. They immediately fell down. Then two policemen tried it, and they, too, fell. They concluded it couldn't be done, except with considerable practice. The police were uncooperative with the UFO group and denied that they knew anything about such an incident.

The following evening, some boys, Brian among them, while in the playground saw the same UFO return to the field and hover over it. They thought they saw a man lying on the ground because they saw "arms and legs move." The object took off, and they saw nothing else.

The lot is out of bounds to the children after dark. They have, nevertheless, come home with fantastic versions of the experience passed from person to person by word-of-mouth. Some families, which UFO members know personally, said the children were having nightmares; many parents, in fact, strictly forbid their children to speak about it.

Personal Sighting by Mrs. Guenther

Friday evening, September 20, 1963, at 8:30 p.m., two of my sons, aged 8 and 6 years, and I were outdoors looking at the stars (which we do regularly in nice weather). I noticed a pinkish object as large as the largest "star" (Jupiter), but the light was contained within the object. My sons noticed it quickly and easily and were very much excited. I asked each in turn, "What color is it?" The older reported, "red"; the younger, "pink." The object crossed the sky and disappeared into the distance rather than over the horizon. It travelled from a northwestern to a southeastern direction and crossed the sky in no more than two minutes. We wrote the sighting on the calendar, and it was not until October 7 that I heard of the Hudson Bay Park incident of the same night. Hudson Bay Park is one mile to a mile and a half north of Mount Royal (where we live).

JACKIE GLEASON, famed television personality, once again made public his opinions on UFOs.

On his nationally-televised broadcast of February 15, 1964, Gleason stated that he felt "all these things (saucers) couldn't be left over from hang-overs," when referring to the numerous sightings since 1947.

ANSWERS TO SOME QUESTIONS

Did you ever say to yourself, "Boy, if one of those saucers would just land and take me for a ride, I'd find out the answers to some of those puzzling mysteries connected with the UFO's!". Well, I am sorry to report that I have not been taken for any rides, met any spacemen or had telepathic communication with any "ascended masters". I am just like the majority of you readers in that I am forced to rely mainly on second-hand information. When I received a notice in late 1961 that C.A. Honey was starting a monthly newsletter based on the writings and teachings of George Adamski and would answer any personal questions sent to him, I thought to myself, "Here's my chance for some answers". So, since November 1961, I have been continually bombarding Honey with questions pertaining to every phase of UFO and Fortean research. Now, I am not going to tell you that all of my questions have been answered 100% to my satisfaction, for such is not the case. There have been many "I don't know's" and "I have no information on that's". But, as a friend once told me "It's the man with all the answers that you have to watch." So, let me take this opportunity to publicly thank C.A. Honey for all his time and effort in answering my questions. Now, on to some of the information I have received, which I thought might prove interesting to some of you readers who have not had access to this particular source.

One of my first questions to Honey involved the many sightings of objects apparently using some type of jet or rocket propulsion. Since Adamski had said that the space ships were powered by electro-magnetic means, I wondered about these other sightings. Here is Honey's answer: "Many objects have been sighted using a form of jets for propulsion. In most cases they were not space craft but were experimental devices of our own government. Our government is working closely with space people in our laboratories and is continually testing strange new devices. The magnetic propulsion system of saucers looks like jets or rockets at times depending upon the type of maneuver they are engaged in. The tremendous field ionizes the air and causes dust particles, etc., to burn with an actual fire that gives the appearance of jets."

I often wonder about some of the mysterious disappearances of aircraft and people that we hear about in UFO literature. Here is Honey's answer on that score: "Many 'swallowing up' incidents have been cases where space people working here decided to go back and were picked up. If any other types of 'kidnapping' occurred, I have no information on it." Later, he said, "Yes" in answer to my question asking if the space people ever took the crews of our aircraft or ships aboard, leaving the vessel adrift in the case of ships, such as the Marie Celeste, Joyita, etc. Also, at another time he said, "Yes, sometimes planes are drawn aboard spacecraft for unknown reasons."

The much discussed mystery of Mt. Shasta, California, came to my mind, so I asked about that. He answer, "No one lives in Mt. Shasta, either Lemurian or space man." Later, in answer to a question about saucer bases on Earth, he said, "Saucer bases do exist on the Earth but I doubt very much if the places you named (Shamballa, Rainbow City) are such. Most of these ideas have no basis in fact. One saucer base

exists in Australia and other ones are in different world areas including the Shasta area. This might be the basis for some of the stories about the area." Again, on the subject of saucer bases, he said, "In using the term saucer base, I referred to a small landing area with living quarters etc., that is utilized as a hide-away for their craft. It is inaccessible except by air and is located in an area where treacherous air currents keep most aircraft of our type away. Another such area is in Mexico. There may be others I am unaware of."

The controversy concerning the Russian Tunguska "meteor" of 1908 came to mind so I asked. The answer, "The crash in Siberia in 1908 was a space craft. The Russian story was substantially correct. My information was that the ship crash was an accident caused by some sort of mechanical failure."

One of the greatest mysteries in UFOlogy has been the enigmatic "angel hair", sometimes seen falling from the UFOs themselves. I asked Honey to elaborate on this subject. "Much of the angel hair is created by the particles in the air reacting within the force field of the ship. It is created like cotton candy at a fair. Some may be coolant escaping overboard and starting the above creation. Liquid tin is used as a coolant sometimes although other liquid metals are used also. Usually ejection is caused by faults occurring in the ships and repairs having to be done." Does this perhaps explain the chemically pure tin which fell from a UFO over Campinas, Brazil in 1954?

One subject which was of interest to me was the jobs taken by the space people while here on Earth. As Southern California seemed to be loaded with space people, and since Hollywood is nearby, and since Adamski described the people he met as being extremely handsome, I reasoned that some of the space people might obtain jobs as actors in our movies without too much trouble. In addition to this, I had seen one picture with an actor who had a very enigmatic look about him. This coupled with my active imagination prompted me to ask Honey if the space people did act in movies. His answer was short, but very informative to me. Always before when I had asked a question, his answer had been direct with a definite yes or no. This time he said, "Could be." My interpretation of this was that he did not particularly want to give out this information.

After reading Percival's book THINKING AND DESTINY, I asked Honey about Percival's theories that the ultimate state of the human form was sexless. Was it true, I asked? "No, we don't want to get rid of that.", he said. Touche!

The Russians came back into the picture with the Soviet writers, Agrest, Rich and Chernenkov, and their theories that the Biblical cities of Sodom and Gomorrah were destroyed by the explosion of an atomic powered space ship. When I asked about this, Honey said, "According to the Russian release (they say the information was based on the Dead Sea Scrolls) the accident occurred causing a forced landing. The reactor couldn't be repaired and they knew an explosion was imminent so they warned the people. I don't know if their conclusions are correct or not but I do know such explosions have occurred." Later, in the October 1953 issue of FATE, I found an article by Dr. W. D. Chesney entitled "Lost Language of the Bible", which is concerned with the Lamsa edition of the Bible written in Aramaic. One paragraph was particularly significant. "It was anciently the custom for a conqueror to plow and sow an enemy field with salt--as the Romans did to Carthage. Salt in the east is a symbol of barrenness. Dr. Lamsa explains that Lot's wife who disobeyed God's command, was punished by

being made barren, instead of being turned into a pillar of salt." So, salt symbolizes barrenness or sterility. Now what is one of the effects of excessive radiation. Sterility. Does it add up?

We hear so often the statement, "The space people walk our streets among us." I get to wondering, if this was true, just how many are walking the streets not noticed. So, I asked Honey approximately what per cent of the population of the United States consists of space people. He said, ".00025% approximately as an estimate. I don't really know how many were born here from higher planets. The percentage above is those that came in ships." Well, according to my figures that's about 46,000, so maybe there are quite a few around after all!

I certainly don't mean to imply that the above questions are the only ones I have asked. Far from it! I selected these for this article because I thought they were some that practically everyone in the UFC field wonders about and thought they might like to hear the answers from the contactee side of the fence.

For all of you who disregard the contactee stories as too ridiculous to waste your time with -- oh, well, they probably didn't even read the article. To those who are willing to give everyone a chance, as your Editor is doing, I hope you learned a little from this article. Why not ask some questions of your own? C.A. SAUCERS REACH FEVER PITCH

BIGGEST FLAP SINCE 1957 STARTLES AMERICAN PUBLIC INTO BELIEVING FLYING SAUCERS ARE REAL. AIR FORCE REFUSES TO MAKE COMMENTS.

Early in the year an Unidentified Flying Object was not only sighted by Newcastle, Wyoming residents but they also caught it. Now they don't know what to do with it - and aren't even sure what they have caught. The object is described as an aluminized ball about 6 feet in diameter with some strange markings on the side. It is partially filled with helium.

On February 7th at 5:04 P.M. Joe L. Burris, Ted Bowers, Grover and Richard Hinson all of Albermarl, North Carolina were witness to a large silvery UFO which came into view in the northwestern part of the sky. It appeared to be about twice the size of a B-52 Bomber. Both ends of the object were of a dull silver color, while the middle of the craft reflected sunlight like a mirror would. A smaller object appeared a few moments after the larger craft had gone out of view.

Reports of flashes and strange noises in the sky were made by Eastbay, California observers on February 15th and 16th. One witness who was standing along with several dozen other persons in front of a theater during intermission observed a strange light which appeared to be hovering low in the northern sky. The witnesses stated that the object seemed to explode with a shower of sparks.

An Agate Beach, Oregon couple reported on February 19th that their car had been struck by an object which fell from the sky. The object landed on the front part of their car and left the windshield in pieces. Investigators who returned to discover what had caused the shattered windshield could locate nothing.

High over the Atlantic just off the coast of Ireland two jetline pilots saw an object explode with tremendous force on March 19th. What appeared to be fragments of the object plummeted downward toward the sea, leaving behind it a trail of white smoke. The sightings were reported by Capt. E. D. Morris a pilot for Pan American bound to London from New York with 42 passengers, and Capt. R. A. Botthos, piloting a DC-8 jetliner of the same line from New York to Frankfurt with 77 passengers reportedly aboard. "We were about 100 miles west of the Irish coast at 29,000 feet" Botthos said later at London Airport. "I saw this object travelling high up on a north-to-south trajectory. Suddenly it exploded with a big flash and parts of it fell into the lower atmosphere trailing columns of white smoke. I have no idea what it could have been." Morris, whose plane was in the vicinity at 31,000 feet, said he saw the same thing. A spokesman for Pan American said that the information was being passed to the appropriate authorities in Britain and America.

On March 28 a UFO which Air Defense Command believes to have been a Russian satellite was viewed between the Dakotas and Quebec. The main body of the object was believed to have crashed in the Atlantic Ocean. First reports of the object's burning up came from the Royal Canadian Air Force.

The following evening Fletcher King noted researcher stated that while at a drive in at Hallandale, Florida along with his Daughter, with their car facing Northward observed a group of 4 UFOs flying in a triangular formation. They all kept fixed, and very accurate distance apart, and after passing directly over the screen momentarily turned off their lights then a second later turned them back on again.

Dr. Gee said that there were little wafers which appeared to be food on this ship. The scientists fed them to guinea pigs, and they seemed to thrive on them.

This author begged UFO fans to get to a UFO landing in the next saucer flap, and get some manna; before the Air Force gets it silent hands on it. Keep it air-tight, and let me or Timothy Green Beckley know, and we will have it chemically analyzed, at our expense, or we will return the sample registered. - (3) He has no idea how the solar system originated: see Page IX EARTH, MOON AND THE PLANETS, by Fred Whipple.
- (4) He does not know where comets come from, yet he is sure he can see through any comet that has ever existed.
- (5) Man has no idea what the Earth is or looks like 32 miles down.
- (6) Man does not know what caused the ice ages; how mountains came into being, or how palms formally grew in the polar circle.
- (7) He knows not how the sea got its salt.

Yes, man has a few hypotheses about these things, but thanks to present day astronomers, these hypotheses are too ridiculous to consider.

Many of the "new age" UFO fans gaze up into the night sky and say, as your author did once: "What harmony".

In what harmony are the following facts?

The Sun has nine planets. Venus and Mercury have no satellites. The Earth has one moon, Mars has two small rocks revolving around it. Jupiter has 12 known satellites, and of those the 8th and 9th moons are constantly changing orbits, and will someday collide: see page 221, ASTRONOMY 1959 by R. Baker.

Saturn has nine moons, Uranus five, Neptune one, and Pluto none.

The orbits of Pluto and Neptune cross each other and someday the two planets will collide, although at present they approach each other no closer than 240 million miles; see page 233 ASTRONOMY, 1959.

Mercury always keeps its face toward the earth: it is not known if Venus rotates fast or slowly (C.K. contactees find out the rotation of Venus in hours or days.) Mars rotates in some 24 hours 37 minutes and Jupiter, thirteen hundred times larger than the earth, turns in exactly 9 hours 55½ minutes.

While the Earth is inclined 23½ degrees to its path around the Sun, Uranus is flopped on its side 98 degrees to its path around the Sun.

Do you astronomers call this "Celestial Harmony"?

Was this always so? Immanuel Velikovsky says not. Starting with page 29 in WORLDS IN COLLISION:

The conception of World Ages, which were brought to their violent end by changes in nature, is common all over the world, even today.

Censorinus, a compiler of Varro, in the 3rd century A.D. taught that different prodigies (look up the dictionary meaning of the word) appeared by means of which the Gods notified mortals at the end of each age.

The Greeks said that there is a period, called a supreme year by Aristotle, at the end of which, the Sun, Moon and Planets return to their original positions (note: this does not say a straight line). This supreme year has a winter called KATAKLYSIOS, with a deluge, and a summer called EKPYRISES, or combustion of the world. It seems that the world has alternately been burned or inundated in each epoch.

A word of warning here by this author is necessary. Those readers who now are becoming frightened should realize

- (1) This is no worse than standing "eyeball to eyeball" against Russia over Cuba in a proposed atom war.
- (2) It is very clear from letters from Dr. Velikovsky to this author, that the things described in his books are actual "near collisions" between celestial bodies, such as comets and planets. No mystic "End of the World Day", or "conjunction" can cause these things to happen. The only thing that can cause it is something "every eye can see".
- (3) The promise in the Bible of never another flood, means only, that the world will never be entirely covered with water again: the whole world.
- (4) If a saucer landed in this author's back yard, and the saucer men said that on such and such a date, Velikovsky's theory would come to pass; this writer would not consider it worth repeating, unless he saw a GIANT CELESTIAL BODY approaching the earth.
- (5) This writer hopes that a contactee of the next saucer flap, will have read this article and will have enough sense to say "prove it" to the Saucerians: predict something small, and no excuses! This is one reason they haven't told the reason they are here up to now. We humans are, in their opinion, too stupid to find out ahead of time, and ask them; even when they have left manna at least 3 times. They do not lie when confronted, but never volunteer information.

(6) The reason for 5, above is that none of the public will even consider something unpleasant. And alot of thanks I'll get for writing this article. If some astronomers had their way I would be in the process of being tarred and feathered right now. But on the other hand, this author thinks its now time to talk, if he is ever going to talk at all.

So ahead we go with Dr. Velikovsky's theory.

Page 39 of WORLDS IN COLLISION tells an incredible story. Joshua ben Nun, when pursuing the Canaanite Kings at Beth-horon, commanded the sun and moon to stand still. And so the Sun stood still and the Moon stayed in sight, until the Isrealites took revenge on their enemies (JOSHUA 10: 12-13)

This part of the Bible is beyond the belief of the most religious person today.

Modern astronomers have called this even a want of reverence for the Supreme Being.

The only possible thing that could have caused this is a disruption in the rotation and tilt of the earth, wrote another astronomer.

But suppose that a huge comet crossed the path of the earth, and this comet had the mass of Venus, what would happen?

First would come a distortion in the axis of the earth and a rain of meteorites would fall on Earth.

I must stop here to tie this in with the UFO. Do you UFO fans remember the "VAST BAT-LIKE MACHINE", that cruised over San Diego, California, from 7 to 9 P.M. during "a meteor shower" on October 9, 1946, page 41 FLYING SAUCERS ON THE ATTACK, by H.T. Wilkins?

This author talked a long time with Mark Probert, an eye witness. It had huge bat wings, miles long, a long neck, with two eyes, which seemed to be "cold light", and red. It seemed to have a pole for a tail, and many people who saw it crossed themselves.

In fact, October 9, 1946 is the date that George Adamski says he saw a gigantic space ship hovering south of Palomar Gardens, and the six "military officers" became "interested". See page 172, FLYING SAUCERS HAVE LANDED.

But what caused this gigantic "BAT" to be so interested in the earth that day? ASTRONOMY 1959 by R. Baker, says, page 257. America's turn to pass through the tail of the Giacobini-Zinner Comet came October 9, 1946, two weeks after the comet passed, with the resulting meteor shower. The bat? Oh, that is easy!

Page 187 of WORLDS IN COLLISION says that the Indians of the PACIFIC COAST say that when Venus passed close to the Earth it looked like "AN ENORMOUS BAT WITH WINGS SPREAD".

This "bat" October 9, 1946 might be said to have kicked off the age of FLYING SAUCERS.

Now, back to page 42 of WORLDS IN COLLISION. Joshua 10: Verse 11, says that, as the Canaanite Kings fled from Isreal,..The Lord cast down great stones from heaven upon them and they died: More of the Canaanites died with the hail of stones of "barad", than the children of Isreal slew with the sword.

So two things happened here when Venus passed close to the earth.


(1) The axis of the Earth tilted due to the gravitational pull of the mass of Venus, and the Sun and the Moon appeared to stand still.

(2) The tail of the comet Venus hurled giant meteors on the Earth.



FLYING SAUCERS AND THE SMEAR TECHNIQUE

In the three years that I have been involved in UFO research, one alarming aspect has been brought to my attention. I refer to the unquestionable success of the "smear technique" in making the flying saucer sighter a figure of public ridicule.

Since the adoption of this despicable policy, countless competent observers have reported their observations to the proper authorities, who in grateful appreciation have publicly branded these honest citizens as hoaxers, crackpots, and victims of hallucinations.

In some cases, the resultant aftermath of scorn and abuse had made it necessary for the observer to leave all that he has strived for behind, and move to more tolerant surroundings in order to salvage what little bit of reputation he has left. In the early stages of the slander policy, it was not uncommon for the average American to pick up the evening paper and read about the person who had been admitted to a mental institution for "observation" after reporting his conversation with people who invited him into their flying saucer, or the inference that a certain airline pilot who reported UFO's was under the influence of liquor, and the UFO he saw was not in the sky, but in his mind.

These were obviously scare tactics that were employed for the sole reason of convincing the public that it was much safer to "keep your saucers to yourself." The smear technique has been a success, in that many people are now hesitant to disclose their sightings, unless the sighting is attested to by other witnesses. This seriously impairs the efforts of UFO researchers. As an example of the hesitancy to report sightings, I have included the conversation I had with Mr. Everett Ducharme, of East Street, Woonsocket, Rhode Island, concerning a sighting he had in 1961.

Altho he had not previously heard of George Adamski or showed any intense interest in flying saucers the drawing which I made of the craft is surprisingly like the photos taken by Mr. Adamski.

I have visited with this man frequently and can vouch for his honesty and sincerity. It took two years for this man to muster enough courage to tell me about this experience which is the most significant sighting I have had the opportunity to investigate.

If it were not for the fear created by the exponents of the "smear technique," this sighting might have been checked out and proven to be a real thorn in the side of the slander group personnel. Perhaps if some good evidence is found to substantiate this account, we may still give the "silence group" a kick where it hurts.

Transcript of Conversation with Mr. Everett Ducharme

Ferriere: In reference to the unusual experience you had in the latter part of June, '61, were there any other people in the area who may have witnessed same?

Ducharme: No, sir, there wasn't a single person in sight to vouch for my story, and that is one reason why I felt hesitant to disclose my experience.

Ferriere: I believe that many people have had sightings which were never reported due to the unavailability of a substantiating witness. I am glad that you decided to make your encounter known. Now, Mr. Ducharme

what time of day did you encounter the object, and what where the weather conditions?

Ducharme: It was just about ten-thirty a.m., on a beautiful clear morning. There were only a few scattered clouds way up in the sky and no breeze at all. Visibility was excellent.

Ferriere: Would you please describe the area in which the incident occurred?

Ducharme: It took place in an open field directly adjacent to a wooded area in Chepachet, Rhode Island, where I was born and brought up.

Ferriere: Now Mr. Ducharme would you please relate in your own words, what happened that morning?

Ducharme: Yes, sir, I'd be glad to. Having been raised in the country, I developed a great interest in nature, and to this day there is nothing I enjoy more than to take a walk through the woods and observe all the interesting things that one is able to see. This is exactly what I had set out to do on that particular morning. In order for me to reach the wooded area I had to walk through an open field and I heard a high humming sound when I started to cross the field. It was barely audible and so I didn't pay much attention to it, and continued walking. About a half-minute later, I noticed the humming sound was increasing a bit, so I looked toward the west where it seemed to be coming from. There in the sky I noticed a round, gray shape, about the size of a baseball. It seemed to be moving in my direction as it was increasing in size. It appeared, at this time, to be a balloon and I decided that I would stop and watch it for a while. When it got directly above me, it stopped and hung motionless for a minute. It was quite high in the sky and still looked like a balloon. I thought the sudden stop was quite strange and the humming sound was louder now. All of a sudden the thing started to drop straight down! It was terrified. I remember thinking that it was going to fall right on me! It stopped abruptly at a height of about 600 feet, and then streaked off toward the south at a great rate of speed. It stopped again, when it was the size of a baseball. As it receded toward the horizon it seemed to be more flat than round. By now, I was a badly frightened man. Although my mind wanted to reject what my eyes had seen, I reluctantly admitted to myself that I had seen one of the much talked-about flying saucers. As these thoughts were racing through my head, the saucer, started moving in my direction once again. Once again it got almost directly overhead. It started to descend and this time, it came down to a height of about 200 feet! I estimated it to be about 350 feet away from me. I could see it quite clearly now; it was disc shaped with a cabin or dome on the top portion. I could see portholes around the cabin, but they must have been closed, for I saw nothing behind them. The whole thing was a blue-gray color and it seemed to be about 250 - 300 feet in diameter and 50 feet thick from top to bottom. The humming sound was very loud, and now it began to develop a steady throbbing. The object kept moving in closer and I began to feel a prickly sensation on the back of my neck, and especially in my head. For a brief second there was a definite feeling of contact between me and the ship.

The saucer was now only 60-70 feet away and the sound and prickling sensation was throbbing violently. I panicked and tore myself from the spot running reverberantly toward the woods with the object following over the treetops. The saucer suddenly reversed direction and went back toward

the field. I leaned against a tree in a state of near-shock and nervous exhaustion. After I had regained my composure, I decided to return home to the safety and security of my family. As I returned to the edge of the field I was just in time to see the saucer hovering no more than 50 feet off the ground with an apparent tremendous amount of force hitting the ground, the pressure coming from somewhere underneath the saucer. The saucer then shot straight up and was out of sight in 25 to 30 seconds.

That was the most phenomenal burst of speed I have ever seen!

I went home and told nobody of my experience, not even my family. All that night, I kept wondering if it had really happened. I thought I was going out of my mind. The next day I went back to the same spot and then I saw the proof. I had not imagined the whole thing. There, in a one hundred foot wide circle, the grass was scorched and black.

That's the whole story, Mr. Ferriere, exactly as it happened.

Ferriere: Thank you Mr. Ducharme for giving such a vivid description of the events that transpired. It leaves me very little left to question you about. I feel sure that this is one of the most significant sightings to occur since 1957, in that it was very nearly an actual contact.

There are just a few more questions I would like to ask. Do you feel that the actions taken by the manipulators of this strange craft were of a hostile nature?

Ducharme: At first I assumed that there was hostility in the minds of whoever the beings were that were piloting the saucer. However, now that I've had time to give the incident some rational thought, I find that most likely what I thought and interpreted as aggressive action was nothing more than curiosity. At one time the saucer was no more than 70 feet away from me. If there were intentions to harm me, surely they could have rendered me helpless then and there. I do not believe their intentions were hostile.


Ferriere: One final question, Mr. Ducharme why have you waited this long to report the incident, and why aren't you going to report it to the Air Force or some local agency?

Ducharme: Until I heard about your interest in the UFO subject, I have remained silent for fear of public ridicule and embarrassment, for myself and my family. I have read in the papers, and heard of aspersions that have been cast upon the veracity of certain individuals who have come in close contact with saucers. I feel it would be very un-healthy for me to report my sighting to those who might show their appreciation, by ridiculing my honest efforts!

Ferriere: That answers my question very well, Mr. Ducharme, and I will be glad to comply with your request that I do not make your name public. (EDITOR'S NOTE: At press time Mr. Ducharme has given us permission to use his name in regards to this account.

Be assured that the authenticity of your report is not impaired because you fear ridicule.

LARGE SPHERE OBSERVED CHANGES COLOR AND LEAVES BEHIND STRANGE SIGHT

On November 14th of 1963 Mr. Charles Romero was driving north at 45 miles per hour and was approximately five miles out of Wagonmound, New Mexico, when his wife called his attention to the right side of the road. 
Investigating for I.N.S. Robert L. Dobbins New Mexico Representative and a teacher in the Magdalena, New Mexico High School came across a student who observed a similar phenomena on January 12 in Springer, New Mexico. It is both Mr. Dobbins and your editor's belief that some of our readers may have encountered similar phenomena, and if so we would like very much to have this recorded in our files.



FIRST STAGE





Informal Group in Aurora Talks Over Parapsychology

Every other Wednesday evening, 25 to 30 women gather at an Aurora apartment. They are housewives, mothers, office workers, a saleswoman, artist and writer who come from all parts of the area to participate in "parapsychology" which deals with "psychic phenomenon."

Occupant of the apartment at 1434 Macon St. is Miss Evelyn Ferguson, organizer of the group. The tall, blonde woman, an office manager by day, became "fascinated" by the subject three years ago, but it wasn't until last spring that she found other women who shared her interest. The response was immediate to an inquiring ad she placed in The Denver Post.

Miss Ferguson said there is no other group in the Denver area that meets to study and discuss various aspects of parapsychology in the atmosphere of a living room.

Other groups' sessions are more formal, she said.

The women who take part range in age from 24 to 75. They come in slacks, casual dresses or business clothes. An occasional Wednesday evening stretches into a Thursday morning during their pro and con discussions of hypnotism, extra-sensory perception, spiritualism, yoga, reincarnation, astrology and unidentified flying objects.

Miss Ferguson supplies much of the reference material. Her library contains "Hidden Channels of the Mind" by Dr. Louisa Rhine of Duke University as well as "Hidden World" by Richard Shaver.

"I read Shaver, but that does not mean I believe it," Miss Ferguson stressed. "We don't want to accept one side before looking into the others." (Shaver, she explained, expounds the theory that there are inhabited caverns under the earth's surface.)

The Aurora woman recently wrote to England's Patricia Crowther, "high priestess of witches," because, she said, "I never heard of anyone who was a 'practicing' witch."

Miss Ferguson's greatest interest lies in ESP and mental telepathy. She believes, "These are gifts we all have, but they need to be developed."

A few minor experiments have been conducted with her discussion group and a sealed box containing brightly colored objects. Each person tries to determine the contents through concentration. Miss Ferguson discovered that "for some reason, people are apt to pick out the brightest objects first." Several women have been 60 per cent correct.

This mental exercise is but a preliminary one in Miss Ferguson's plans. She is planning a nationwide experiment in meditation. About 100 letters have been received from persons throughout the United States who are willing to cooperate.

"A definite subject for concentration will be chosen for this first attempt," she explained. Each participant will concentrate during the same 15 minutes every evening for a period of 18 days and keep a record of the experiences.

"After results are received from four or five different ex-

periments," she concluded, "we feel certain that the data we obtain will do much to demonstrate the power of the human mind when it is generating positive energy directed at a definite point."

Despite Miss Ferguson's enthusiasm for ESP, she concedes word of mouth has proved more effective in the formation of her discussion group.

New people show up at meetings because, like Mrs. Mary Wyatt, of 511 S. Yates St., "I heard about it from a friend." The friend, in this instance, is Mrs. Lillian King, 3221 Utica St., who has been attending for several months.

The number has doubled since the first meeting last May. Though new participants are added, the reason for coming is usually the same given by Mrs. Pat Farley, of 1633 Newark St., Aurora: "I've always been interested in the workings of the human mind — and people in general."

Flash Is Still A Mystery

An explosive flash that lit up the western sky Thursday evening turned into a major scientific mystery yesterday.

It sparked controversy among astronomers and a swift, intensive investigation by a scientific team from the RAND Corporation, the Air Force's top research organization in Santa Monica.

The RAND investigators flew to the Bay Area last night and plan to interview scores of Bay Area residents who saw the flash.

The brightly flaring burst of light — some said it had a long blue tail — appeared to explode

and then die swiftly away, followed by a noise like distant cannonading.

Astronomers, military satellite trackers, radio engineers, and air defense controllers could offer no firm explanation that fit all the facts.

But the RAND team, a Space Agency scientist at Moffett Field, and a Berkeley radio astronomy researcher were all convinced it was a "detonating fireball," otherwise known as a bolide, or a meteor that explodes and sends a blasting shock wave down to earth.

The phenomenon startled the Bay Area at 6:15 p. m. Thursday. It was a flaming ball and San Mateo county residents said it seemed to rush swiftly from east to west, dropping toward the ocean.

Dr. Rolf Dyce of Stanford Research Institutes' Radio Propagation Laboratory calculated its flight path from observation reports and estimated it plunged into the Pacific about 50 miles off the coast.

Radio Station KSFO reported a wholly unfamiliar beeping coming in as interference on its frequency of 560 kilocycles. The beeping was tape recorded. It sounded like a satellite transmission.

But Dr. Dyce, who heard the recording, said he was virtually positive the beeps had no relation to the falling object.

Arthur Setteducati, a data analyst at the University of California's Radio Astronomy Laboratory, contradicted Dyce's opinion.

Setteducati reported he has observed meteors in the past by tuning in on short wave radio signals that are reflected from the ionized gaseous trails of the meteors. The trails, he said, act like radio mirrors.

SIGNAL

He suggested that the mystery signal originated with Station STS, a Bay Area maritime transmitter broadcasting at 535 kilocycles. It would have been heard as beeps on KSFO's frequency, he said, because of a distorting phenomenon in the receiver known as cross-modulation.

At Point Arguello, down the coast, the Navy maintains a space tracking station and a "radio frequency guard" to scan the broadcast bands.


The Navy reported no satellites were launched Thursday evening, and no unexplained radio signals were heard.

Vandenberg Air Force Base also said there were no launches—and added that no satellites decayed in the atmosphere yesterday either.

The Air Defense Command at Hamilton Field said no planes had crashed at the time, and no plane was dropping flares off the coast.

California, said he doubted the object was a meteor because a meteor would have lit the entire sky over extremely great distances.

And the loud noise, like a detonation, that followed the death of the flaring object was distinctly un-meteorlike, Dr. Cunningham said.

Dr. Cunningham believes the reports of noise are old wives' tales, and not scientifically confirmed.

Mystery Blast In Bay Skies 1963

SAN FRANCISCO (UPI) —

Even meteor experts could not agree today if a brilliant streak across Bay Area skies Thursday night and a fiery explosion afterwards were caused by a meteor.

Two experts said the spectacle was probably an exploding meteor, relatively common on a small scale but rarely large enough to be heard.

"If there were different colors it almost certainly came in from outside," said C. P. Butler of the Morrison Planetarium here.

University of California astronomer C. R. O'Dell said that the description sounded like that of an exploding meteor, or bolide.

But Dr. Leland Cunningham of the University of California said he still was not convinced that the explosion was not a sonic boom preceded by the colorful vapor trail of a jet aircraft.

Authorities at Alameda Naval Air Station and Hamilton Air Force Base said no military aircraft were in the sky at the time. Vandenberg Air Force Base also reported that no missiles were in the area.

Whatever it was, thousands of observers saw a bright object with what looked like a flaming tail out over the Pacific Ocean about 6:15 p.m.

A rumble explosion variously described as green, white, or orange followed and the sky resumed its normal hue.

London, Jan. 25 (Reuters)—Anyone meeting a Martian from a flying saucer should send him to Leningrad where his speech will be understood, the Soviet news agency Tass advised today.

Tass said Leningrad scientist Nikolai Andreev, had devised a linguistic key for deciphering unknown texts which required no knowledge of the language in which it is written.

Helped by an electronic computer, he claims the key can analyze mathematically any language—including Martian—and understand it.

AND THEN THERE WERE NONE: SOME PLAN YOU AND I KNOW NOTHING ABOUT BY STEVE ERDMANN

Your articles are very good. You are a most knowledgeable fellow and as time goes by, all that is now a big mystery to you and to mankind in general, re the UFO's, will be made plain. I doubt that my little contribution to the field of UFOlogy will prove to be the missing key to the problem, but if it serves to provide a tiny wedge, then perhaps some good will have been done.

Now, please understand that I am not in the slightest way trying to be "mysterious" when I say that humanity en masse is not ready for the final answers to this hellishly gigantic "jig-saw puzzle" of what the saucers are, who fly them, and where they really come from. I sometimes have a strong sense of destiny about this whole matter--and where the Germans come into the picture, in the way they are doing right now, one wonders if fate is moving according to some plan you and I know nothing about.

Do not look to me for facts other than those I have already presented in my book WE WANT YOU. I do have opinions and conclusions today, which I can freely give you for whatever they may be worth to all of us in the final analysis. For example Brazil is a "hot-bed" of UFO activity, and we might well question WHY? Several theories as to the saucer origin can be linked with Brazil. One, Nazi craft built in underground installations in remote parts of Brazil. Two, hidden deep in the "Green Hell" of the Matto Grosso jungles, are entrances which could conceivably lead into the interior of this very earth itself. Out of this earth the saucers may be coming. In addition to this thought, we must not forget that many UFOs have been seen plunging into the ocean and rising from the ocean. So there may be an "inner earth" of which earthman knows nothing. Openings into that inner world may be "underwater", to prevent detection by us.

Or, to further complicate matters, we have never--at least to my personal satisfaction, written off the "interplanetary" theory of UFO origin. So we have a Dickens of a lot of possibilities to toy with, and I say "toy" because it is all we can really do with these ideas. But our minds get a terrific stretching regardless of anything else. I have been a reader of Herbert W. Armstrong's magazine THE PLAIN TRUTH, for several years now, and enjoy reading it. He has insight that is quite remarkable, there is no denying that fact, and in his basic observations and concepts re Germany and the revival of the Holy Roman Empire I can concur practically without reservation. As to the Bible conclusions and "predictions" of the future, I must admit here is where Armstrong and I part company. I believe in "emmergent evolution" as

Thank you, Michael, for your kind and gracious words concerning my articles. I feel, as you do, that if it is at all possible--no matter how weak and sloven--or how strong and valuable--that my opinions, facts, my "faith" can, in some way, provide a missing key to the "existence" (I call it the "existence mystery", instead of the UFO mystery) problem.... if only as a crack in a monstrous wall, it may be of some good. It is HE who INTERVENES in circumstances occasionally to guide the course of human events in accordance with His plan and His purpose which STANDS FIRM."

appeals to their INTELLECTUAL VANITY. It was VAGUE on many points. It did not speak with AUTHORITY! It gave them a lot of room to 'guess' and 'postulate' ideas of their own, in short, to intellectually PLAY AT BEING GOD!"

Furthur, the Bible does not speak of the million and one statistical facts. But, what the Bible DOES SAY, Armstrong would point out, IT LEANS! The fact that millions of other worlds may contain life, may be very, very true. That intelligent life may exist on these millions of worlds, may be very, very true. But that these beings will have any intrinsic connection with this planet and its future, as I see it, cannot be just doubtful, but void of such connection...unless, there is something drastically wrong with Bible prophecy. Neither is it named after any nation. Nor is it named after any form of church government, or any single doctrine or combination of individual doctrines or belief. If we cannot look to you for facts concerning the "rise" of Nazism, who else can we look to for statistical facts, other than those personages who claim knowledge of such things? Ergo, if you or any of these individuals have positive knowledge of such things, it is mandatory that such individuals keep from cloaking their ken in an area of mystery. There can be a number of reasons for activity in Brazil. It is a "hot-bed". And it is all the more that we can secure positive and genuine facts concerning these things. It is a source of UFO activity. However, to say why and how, without steel and concrete knowledge leaves us with mongering that shouldn't be accepted. Secnd, if the UFOs come from the earth's interior from some "Nation" that isn't mentioned in the Bible, we must remember that IF they are to have any connection with future happenings... and any connection with existing nations in prophecy...they must be mentioned in the Bible. This is SIGNIFICANT, and is demonstrated in many scriptures...Jesus said: 'Howbeit when he shall not speak of himself; but whatsoever he shall hear, that shall he speak: and he will show you THINGS TO COME.' 

For if Armstrong is right, they will have a great part in our future. And, as I see it, if we have a choice to save our saucers... they may be Nazi inventions. If not--we have to give them to the Devil, or not have any at all!!! And if anyone doesn't like what I just said, let's break down the fastidious "wall" that exists between us and bring our minds to honestly and sincerely study the problem.



THE SHADOW OF THE UNKNOWN

"The Shadow of the Unknown" edited by the former director of the New Jersey Association on Aerial Phenomena is a written evaluation of 5 years of investigation by the society into the flying saucer enigma.

It is good to see in this day and age when saucer books must be sensationilized in order to sell to the general public as well as to saucer fans that a volume such as this can be published and still have a reasonable circulation. In fact the response for the first edition was so great, all copies were sold in 5 months, that a second edition is now being prepared and will be issued shortly. It will once again be co-sponsored by our own society.

The editor, Edward J. Babcock Jr., who besides being the former director of the NJAAP is also a personal and close friend of your editor. "The Shadow of the Unknown" provides a scientific glance at the present status of the UFO mystery. This volume presents the findings on the subject by the young author and his last appearance before leaving active saucer research. He will be greatly missed.

The National Investigation Committee on Aerial Phenomena located in Washington D.C. helped to provide many of the incidents recorded in this volume. Over 35 pages are devoted to the subject of orthoteny discovered by Aime Michel during his investigation of the 1954 flap in France, in which he plotted sightings on a map of the area. For those who are not aware it showed that the saucers are controlled by intelligent beings and for some unknown reason travel in straight lines.

With the help of Dave Halperin, the two plotted on a series of nine maps the sightings of the 1952 flap in the United States. Over 140 sightings from June and July of that year were plotted yet they did not find any conclusive proof but merely interesting material. One of the biggest stumbling blocks was the fact that the incidents in question happened over 11 years ago.

An evaluation of contact claims is given by Jerome Clark who is also assistant editor of this publication and author of quite a bit of material in your editor's INSIDE THE SAUCERS...1962. Despite the fact that he quickly does away with Adamski, Van Tassel, Nelson and the other run of the mill contactees he puts much emphasis on the little known meetings with small hairy four foot beings in many out of the way places. Much of this information cannot be checked out and thus we wonder why he didn't attempt to concentrate more so on the incidents in this country.



A PRIEST U.F.O. FAN

Fellow ufofan, are you oftentimes strongly tempted to give up your study of ufology because, among other reasons, the skeptics are confronting you with too many objections which you can't seem to answer? Is one of these objections the fantastic speeds often reported by a ufo observer? If so, take heart, for these fantastic speeds, i.e. the authenticated ones, are not impossible. In fact, they have existed for billions of years and we, on earth are actually and REALLY traveling 6 times faster than the speeds the ufos obtain in their flight. Indeed, according to astronomers, we earthlings along with the rest of the Milky Way, as one piece, are traveling at 600,000 m.p.h. Nobody will question that, for, it is a well established fact. So, it must be possible since it's a measured actuality.

Amazing, isn't it, when you consider that our sky buggies, we call "satellites" burn up at velocities far lower than that. When they plunge through the air, infernal heat is produced by the friction between the air molecules and the craft. Yet, these sky carts even at their topmost speeds, are just crawling when you compare their motion to curs as part of the Milky Way. But, how is it that the friction doesn't burn us up? It's very simple: There is no friction...absolutely none whatsoever; not enough to tickle a flea. How is that? Our sky carts heat up as they plow into and THROUGH the atmosphere. But, we on earth, as we hurtle through space, we do not plow into nor through the atmosphere, indeed, this "ocean" of air is part of our environment and it comes along with us.

So, in view of the above, I no longer feel obliged to reject as impossible a raderscope ufo account because the controllers recorded a speed of 45,000 or even 90,000 m.p.h. "through" our lower atmosphere. In other words, I believe that the ufo is a little world by itself with an atmosphere of its own making, which it pulls along around itself as it goes, just like our planet, the earth, does as it rushes in its annual course around the sun at an average velocity of 65,000 m.p.h.

All astrophysicists agree that terrestrial gravity is the force which accounts for this phenomenon: a planet and its atmosphere are as inseparable as an elephant and his skin.

In this indisputable fact, I think that we have an excellent hint as to the mode of propulsion used in the ufos. Some kind of gravitational field, as theorized a few years ago by Jean Plantier, and published in his book: La Propulsion des Soucoupes Volantes. In the case of our earthly vehicles the propelling force, whatever it is, is applied only to definite parts of the vehicle (a wheel, a shaft, etc.), and also it is applied to these parts or to that part as a whole. That is true even in our very latest models. For instance, in a rocket the hot gases in the tube are under great pressure, which is felt or manifested in all directions including the front end which is closed.

Now, as the gas molecules hit against the closed end, they obviously encounter a resistance, which here is technically called "reaction". Briefly the molecules are pushed backward while the closed end of the tube is pushed forward. But, the rest of the tube has to follow and so

the rest of the craft including the pilot because all parts are attached directly or indirectly to that ONE part to which the force is applied. The molecules of air in front are also pushed forward; but, only to a limited degree since they are not attached to each other nor to the aircraft. So there is friction; sometimes melting and even burning. Consider one of our astronauts on the launching pad at Cape Kennedy during the countdown. His body is at rest and according to the law of inertia it has a tendency to stay that way. So, if an OUTSIDE force sets it in motion it resists by its inertial force, measured in g's, equal in magnitude and opposite in direction to the accelerating force.

Notice that inertia is defined basically as a "tendency" and that it is inherent to the body itself. This inherent tendency becomes active only when some external force butts in and sets the body in motion. Now, suppose that some agent were to nip in the bud the tendency itself. Obviously, the object thus 'frustrated' couldn't react to the act. That means it would have lost its mass and weight. So, you could zoom it away with the speed of light, even faster, without friction, noise or heat.

How do you "kill" this inertial tendency (mass)? How do you kill an army? There are many ways. One way: cut off its food supply-line. Granted the army will remain...as bones. But, it will be ineffective. How do you apply this principle to gravity and weight and mass? Gravity, more recently, is defined as an APPARENT force. The great Einstein says it's not a force at all in any sense: It's just a rapport between two bodies. Now a rapport is a relationship, and you don't have a relationship between two objects unless there is some kind of "line" or "path" between the two. That idea seems to fit perfectly with the theory of relativity according to which gravitation is said to be a physical property in space itself: space-time tracks which are concave nearby massive bodies. Radiant energy such as visible light follows these tracks and therefore is bent towards the massive body as if it were composed of particles.

The concept that gravity is a change, a conditioning of the "path" between two objects rather than a force residing in the objects themselves, explains, I suggest, the fantastic maneuvers of the ufos and also the accompanying phenomena, which are out of this world.

For example, July 20, 1952, shortly after midnight senior Controller Barnes and some of his assistants saw on radar a ufo, among 9 others, that streaked out of range in seconds at 7,000 m.p.h. through the lower atmosphere. Later, another while going 130 m.p.h. stopped dead and immediately reversed its course at 125 m.p.h. These and other elsewhere still more amazing turns, accelerations and decelerations should cause tremendous friction, heat, noise, etc. Why not here in this and other ufo cases. The propelling energy must be gravitational in nature; it must create and hold in and around the ship an artificial, dense but gradient atmosphere, which merges imperceptible with our atmosphere. The g's do not pile up on the craft nor on the ufo-nauts because these do not exert any reaction. There is no force applied to the vehicle nor to the occupants, i.e. there is no action; so, there can be no reaction. The reaction is just apparent; it's fictional.

It sounds like I'm quibbling because earlier in this dissertation and also in my 10 page article entitled "The ufo and its Fuel" written on December 10th of 1962, I seem to say that the force is applied to the ufo itself. It's applied to each and every subatomic and subnuclear particle in and about the ufo individually and simultaneously. Don't they constitute the ufo? May they do, maybe they don't. Suppose for instance the simplest atom, that of hydrogen. The nucleus has one proton

and around it in orbit there is one electron. Every atom of hydrogen, barring isotopes, is made that way and all these points of relationship are absolutely necessary and exclusively. In other words, suppose you have in a given area vigintillions of protons and as many electrons. The "pocket" could be completely devoid of hydrogen. It is, if no electron is "cemented" to a proton. An atom, even the simplest is very much like a building. Imagine that you have a large mound of bricks piled up pellmell and in between the "empty" spaces you have powdered cement mixed with sand, and all the various materials necessary for a building. Do you have a construction? Obviously not. The ingredients are there; but the proper relationship among them is missing and that makes the difference between a delicious piece of cake and a mouthful of dry cake-mix followed by a gulp of cold water.

So, objects are made up of molecules. These in turn contain atoms and the latter contain electrons plus other subatomic particles. Now, the relative positions occupied by these various elements give in part the properties. Gravity or antigravity, I suggest, tugs, not at the whole ufo nor at parts of it really but at the subatomic particles directly, individually and simultaneously. Evidence? Plenty. The gravitational field between objects A and C is not impeded at all by object B lying between the two. The field then must be constituted by something very thin; something which permeates everything else. That's ether. I suggest that ether in real and that among other things it is a wavy "path" or the gravitational rapport between two objects. It is my contention that the ufonites have destroyed the waves, the "path" between their ufo and planet-3 when they hover, and have created an entirely different type of wave (antigravitational) when they race away. In a word, the ufodyne is applied really not to the **craft** but to the "path".

I am fully cognizant of the well known fact that certain ufos have eerie light about them, heat, sound and other signs that their fuel is basically like the kind used in our own machines. And that apparently smashes to pieces my pet theory. I say "apparently" for, note well that, although the gasoline engine in your celler makes a frightening noise, gets hot, etc. the electricity it produces is absolutely silent. So, in my judgement, the ufo while spinning, as it is often seen to do, is then acting as a prime-mover using the kind of fuel we use, but the best: nuclear energy. But, this prime-mover, I believe, generates antigravitation (ufotons) by which the ufo is propelled.

Do we earthlings have within our reach right now exmplications of the use of such powers? Yes, many, for example: levitation, telekinesis, teleportation, poltergeistism, apportism, materializations (certain types).

It has been demonstrated again and again under very strict scientific conditions that, barring fraud, etc. certain people with mediumistic powers, at times, in a trance or normal state, subconsciously with their **psysic** lift objects cause them to perform various antics, to float about, pass through walls (leaving no marks), or cause them to suddenly appear at a point on a ceiling from a great distance.

The ufonites, I believe, have the power far more developed than it is here on planet-3, and, moreover, they may have found various ways and means of recording on tape the brain waves produced by one or several people while they thus move objects so mysteriously. Later maybe they play back these tapes in their ufos and thus propel their crafts.

Flying Saucer Spotted in 1933

Flying saucers have been reported by persons in all walks of life all over the world, including the Lehigh Valley. About 30 years ago a Lehigh Valley man claims he actually entered and inspected a saucer at close hand. Mr. X's identity has been withheld to protect him from hecklers but his story is recounted here.

Early on a warm summer morning — actually about 2:30 a.m. in 1933 — I was on my way to Nazareth from Lehigh-ton. I was driving a 1925 Ford roadster.

Between Cherryville and Berrestown at a lonely spot on the road one of my tires went flat.

While jacking up the car, I noticed a faint violet or purplish light in the field on my right. It was not especially bright but the peculiarity of the hue made me curious.

Bell-Shaped Object

I walked about 200 feet toward the light. On the grass lay a bell-shaped object about

ten feet in diameter and about six feet high.

There was no moon but a faint light emanated from the stars. Light was also issuing from a slit in the object which proved to be a circular door, slightly ajar, on close examination.

This door was about a foot in diameter. When I pushed it, it swung open. It was constructed somewhat like a bank vault door with sealing steps on its edges and at the opening.

There was nobody around so I put my head inside. But, because of the peculiar light — apparently coming from the ceiling—I had difficulty seeing.

Tubing and Dials

The chamber was full of tubing and dials with a kind of console in the center. There were no perceivable windows. The chamber was about six feet in diameter and about four feet high and it had a dome.

I could see no beds or seats. But, I remember the walls had a striated pattern like that of marble. Since I was able to put my head through the door directly into the chamber, the object apparently had no air-lock — a device that is said to be important to earthly space ships.

The odor in the chamber was similar to ammonia and the temperature was quite cold.

The shapes of several small objects in the chamber had strange curves — unlike anything I had ever seen before or since.

No Windows

I withdrew my head and walked around the object. There were no windows visible on the outside, either. Nor could I see any person or creature.

The outside surface of the object was extremely smooth — metallic in texture as I recall — and cold to the touch.

I walked back to the car after spending about ten minutes examining the object.

I fixed my tire and went home.

At the time Mr. X was about 18. Today he makes this recapitulation of his experience:

When I had this experience I had never heard of a flying saucer and hadn't the remotest idea what the object was. But, now, looking back I am convinced I saw something not of this earth and perhaps not even of our planetary system.

While inspecting the object, I neither saw nor heard any living thing. In fact, the si-

lence was deadly. But, it's entirely possible I was observed.

I think we of this planet are presumptuous to suppose that all other intelligent beings in the universe have two arms, two legs and look like us.

From the size of the door and the odor emanating from the object, it's possible the occupants of this ship were reptilian in nature.

And, obviously, judging from its shape, this vehicle propelled by some means other than our clumsy and relatively inefficient rockets.

Anti-Gravity May Explain

Sir Isaac Newton discovered and explained gravity. Our world is waiting for some unknown genius to discover and explain anti-gravity.

It's quite possible other people in that neighborhood saw the object. It would be interesting to hear their views.

Our scientists say it would take four years to reach the nearest star if we traveled at the speed of light — roughly 186,000 miles a second. How long would it take traveling at, shall we say, a billion miles a second?

The Orlando Evening Star for March 31 stated that residents in the area of Bronson, Florida had spotted an unidentified flying object wavering in the night sky around midnight. Levy County Sheriff office said an unidentified motorist reported a crater 20 feet across and 40 feet deep open in the westernbound lane of U.S. Alternate Highway 27 four miles west of Bronson, causing speculation that a UFO had crashed to the earth. However the Florida State Road Department said the crater was caused by the same sort of limestone cavcins that have plagued the University of Florida in recent years. This was confirmed in a personal letter to I.N.S. by Carolyn Cooksey secretary to the Director of Information and Research, Carrol Lancc. However they added that the width and depth of the crater was not as large as indicated in the news story. It was according to them only the width of a traffic lane which measures 12 feet. The Road Department informs us that the northern and central parts of the state are infested with limestone cave-ins and the area in which this incident occurred seems to have more limestone deposits than any other area. Hence, the numerous craters reported on the campus of the University of Florida. They also reported that their office had no communication regarding the incident from the Air Force or any civilian body.

As if they knew about the crater in Bronson an unidentified flying object fell from the sky into a residential back yard in Baton Rouge, Louisiana on April 6. The object shook a house and dug a four-foot deep crater in the earth. There were reports of four other objects falling in outlying areas. Floyd L. Marston said one of the objects plunged through a large tree in his back yard, stripping branches as it went, and dug a crater about 18 inches wide and four foot deep. He said his entire house shook when the object hit. Police dug down six feet in Marston's yard but came up with nothing. Two strikes were reported northwest of the city near Ryan Airport, one to the east and one to the southwest.

By far the best sighting of this year and which proved to be the first of a very large "flap" occured in Socorro, New Mexico on Friday April 24, 1964. City officer Lonnie Zamora said he was chasing a car on U.S. 85 when he heard what he thought was an explosion. He said he drove to within 150 yards of a draw about one mile southwest of town when he saw what appeared to be an overturned car in the draw.

"I saw two figures in what appeared to be white coveralls like mechanics wear." Zamora said "I lost sight of them behind a hill and drove closer and parked again." He said his first impression was that he had seen an "overturned car and two youths."

Zamora said he then proceeded to walk within 200 feet of the object when he again heard a roar. He said he saw a brilliant white metal object about the size of a car rise, and hover about 20 feet off the ground. It then flew off to the west, rising gradually.

Zamora said he was scared and that this experience taught him one thing if it happened again he would still run away but this time he would not tell a soul about what he say.

Army Capt. Richard T. Yolder uprange commander of White Sands' Stallion Range said Zamora is a "very reliable witness". Deputy Sheriff James Lukie who was called to the scene of the landing said "its something out of the ordinary, something very few have ever seen."

Zamora said the machine had been supported on the ground by four spider-like legs. The brush was supposedly burnt by exhaust from the saucer. The craft appeared to be made of a shiny, aluminum-like substance and flew away when he got within 100 yards.

State Police Capt. Sam Chavez said he was told by Zamora that the UFO he saw had red markings on its side. Chavez said Zamora told him the design was an inverted V with three bars crossing it, but that the Air Force had told him not to discuss the markings.

The following evening two unidentified motorists said an object similar to the one described by Zamora swooped down out of the sky toward their car in the Espanola, New Mexico area. Similar crafts were observed on Saturday from a Socorro teenager, an Albuquerque motorist and by George Mitropolis of Albuquerque south of Truth or Consequences near Caballo Reservoir.

On Sunday Orlando Galegos of Santa Fe told State Police he got within 200 feet of a huge metal object which looked like an egg-shaped tank. He said flames sputtered silently from numerous jets around the bottom of the object. It was as large as a telephone pole and about 14 feet in circumference. State Police Capt. Martin Vigil investigated the La Madera sighting and discovered that the ground was still smoldering 20 hours after the sighting. He said rocks in the center of the area were split, a bottle was melted and green brush had been set on fire, evidently by intense heat of some sort. An Espanola newspaper correspondent said whatever the object was it was not a conventional type object employing thrush. He said the ashes were in place, not scattered. Also found were "paw prints" like a mountain lion's as well as landing gear marks which were in the form of four impressions in the dirt.

Dr. J. Allen Hynek special UFO consultant for the Air Force arrived in Socorro on Tuesday night to begin his investigation. Dr. Hynek said he hoped to talk to Zamora and then visit the site where the officer says he saw the object land.

Shortly before Dr. Hynek's arrival State Policeman Tommy Richardson arrived at police headquarters to report that he had had a call from a Don Adams of Edgewood, near Moriarty, who told of seeing an object about 100 feet off the ground. He said it appeared to be a fluorescent or green colored glowing object.

Adams told the officer he drove his car under the object and his car stalled. The youth reported he then got out and fired six shots at the object, reloaded and fired again.

On April 30 at Canyon Ferry Village, Montana a group of youngsters saw a four-legged flying object land. One of the youngsters had called the sheriff's office the night before and reported a bright egg-shaped object hovering outside her window. Newsmen and sheriff's deputies investigated the area just east of Helena where the object was sighted. They found four holes about 13 feet apart, 6 to 8 inches deep and 8 to 10 inches across. The holes smelled like diesel fuel, according to one newsman. A circular spot was seared into the top of underbrush. First report of the object came from Linda Davis, 11, who said "it was a bright glow in my bedroom window" and was also observed by her brother at approximately 10:30 p.m. The holes were discovered about 125 feet from the rear of the Davis home and about the same distance from the lake shore.

At Baker, California, three Californians traveling by car to Las Vegas reported seeing a mysterious dome-shaped object the size of an airship which disappeared while their attention was momentarily diverted.

The Californians, Mr. and Mrs. Gus Biggs and Mrs. Lorene Ayres, all of Fontaba, California said they spotted such an object crouched on a hilltop just off U.S. 91, 10 miles west of Baker. They said they watched the smooth, brownish dome-shaped object for about five or six minutes as they drove along the highway but that it disappeared when they looked away for a moment. Mrs. Biggs said the only subsequent sign of the object's presence was a large depression on the hilltop.

The sighting by the Biggs family was within the confines of the U.S. Army's coming Desert Strike maneuvers May 17-30.

One of the things that is bothering the scientist's investigating the current rash of reports is the lack of the mention of radar contacts. Dr. J. Allen Hynek is quoted as saying "I'm going to check to see if there have been radar contacts that might tie into these reports."

Dr. Hynek says that this is one of the best sightings, and best substantiated flap that he has ever investigated. "Usually one finds many contradictions or omissions in these reports but Mr. Zamora's story is simply told, certainly told without any intent to perpetrate a hoax. The story of course was told by a man who obviously was frightened badly by what he did see. He certainly must have seen something."

Zamora's reliability is supported by Dr. Lincoln LaPaz of the University of New Mexico who has an international reputation in running down reports on fireballs and meteorites.

However Dr. LaPaz goes on to say that he believes that the object observed by Zamora may have been a U.S. Military craft. However officials say that this cannot be possible since they have no type of craft which could do the things described by the witness. And if any earth bound pilot from the Air Force did land in Socorro he has not come forward.

The current flap in the Farmington, New Mexico area brings back memories of the 1950 sightings in the same area. Frank Scully in his BEHIND THE FLYING SAUCERS covered this "flap" in great detail.

The flap currently taking place in this country particularly on the west coast is far from over. I.N.S. plans to have a leading author write the account up in more detail and we shall publish it as a special report to be sold at a reduced price to all members.
