



## WEIRD WATER WONDERS



**PYTHON IN THE SEWER LINE** - Mountain View, California police lassoed a 13-foot python found by a public works employee in a sewer line. The snake slithered into view Friday morning as Jose Aguilar, 34, a waste water worker, was flushing out the sewer at a downtown intersection. (Lincoln, NE Journal August 8, 1987)

**PIRANHA CAUGHT IN NEBRASKA LAKE** - An angler who landed a fish that resembled a bluegill with teeth may make the record books - he hooked a piranha. Bruce Beins, owner of North Shore Marina at Harlan County Lake, said the fish had "teeth like a cow." The unidentified fisherman from LaVista, Nebraska brought the fish to the marina because he didn't know what he'd caught, Beins said. "He said when they landed it, it was clicking its teeth at them," Beins said. The mystery was solved when Monty Madsen, a Nebraska Game and Parks Commission fisheries biologist, identified the fish as a non-ferocious variety of piranha. "It wasn't the type of piranha you think about...not the kind in the Tarzan movies," Beins said. The piranha, a tropical fish, weighed  $1\frac{1}{4}$  pounds and was 12 inches long. It was caught using nightcrawlers as bait, from rocks off the face of the dam. (Lincoln, NE Star, September 10, 1987)

**NOT THE AVERAGE FISH STORY** - When Tim DeMatteis told his father about his big catch last week during a trout fishing trip in Ontario, Canada, it was enough to make the average fish story seem credible. DeMatteis said he snagged a moss-covered knapsack that his father, Butch, lost two years ago in a boating accident in the same remote area of the Flint River. The knapsack contained his father's shoes, a couple of candy bars and a wallet containing \$225 and credit cards belonging to a friend of Butch. "When he told me what he had found, I couldn't believe it," Butch DeMatteis, of Columbus, Ohio said. Tim's father and Ernie Johnson were fishing in the summer of 1985 when their boat capsized before landing on some rocks just short of a 30-foot waterfall. The both felt lucky to escape with their lives and didn't worry about the money and other gear they lost. Tim, 28, received \$100 from Johnson for recovering the wallet. Johnson said he has special plans for the money. "I'm going to have that stuff bronzed and mounted on some kind of plaque," he said. (Lincoln, NE Journal, August 21, 1987)

**AUSSIES CAPTURE ALBINO CROCODILE** - Wildlife rangers have captured a cream-colored crocodile, the first-known albino crocodile found in the wild, the Australian Associated Press reported from Darwin. (Lincoln, NE Star, September 19, 1987)

**BLUEFISH TRY TO EAT SWIMMERS** - Hungry migrating bluefish with razor-sharp teeth are apparently mistaking swimmers for their favorite prey and have bitten at least five people, although none seriously, authorities said. The victims were attacked when they swam into a feeding frenzy. (Lincoln, NE Star, April 20, 1987)

At 4:10 a.m., January 18, 1967, [REDACTED]

[REDACTED] advised that he desired to report that he had observed a large oblong-shaped object which alighted in the street in front of him when he was on his way home from his television repair shop, the [REDACTED], Chesapeake, Virginia. He believes that he was taken into this craft which he recalls as being made of a glass like substance and being transparent. It was manned by several individuals who appeared to be undersized creatures similar to members of the human race, probably not more than 4 feet tall. They were allegedly wearing regular trouser pants and T-Shirts. [REDACTED] believes that he was transported by this craft for an undetermined distance and returned to his point of take-off approximately one hour later.

[REDACTED] spoke in a coherent manner although he appeared to be under certain emotional strain. He claimed he had not been drinking any intoxicants but he was unable to account for the time between 8:00 p.m. and 4:00 a.m.. He stated he was telephoning from his workshop, but had no recollection of being elsewhere between 8:00 p.m. and 4:00 a.m.

There currently are rumors over the grapevine and in print that suggest men with oriental features wearing dark clothes go around terrorizing people who have had close-up views of UFO's. It is also rumored these creatures have impersonated armed forces officers and FBI investigators. They are supposed to ride around in black or dark automobiles that either have old licence tags or none at all. Several are reported to have attempted to run down witnesses of UFO sightings, made disturbing almost macabre phone calls, silenced several investigators who were supposed to have learned some dark secret about extraterrestrial craft or mission plans and opened mail, tapped telephones and even taken pictures of several homes where UFO witnesses lived.

On March 9, 1973, Sergeant [REDACTED] United States Air Force, Recruiting Office, Professional Building, Waco, Texas, advised that a man identifying himself as [REDACTED] contacted the night-shift supervisor at the [REDACTED] and inquired regarding any information the [REDACTED] could be able to furnish him concerning any unidentified flying objects observed in the Waco, Texas area. [REDACTED] had identified himself as a Captain in the United States Air Force. [REDACTED] was described as having on an Air Force uniform with a chaplain's badge on the uniform. [REDACTED] also had in his possession at the time a folder marked Top Secret which contained pictures of various military installations. No specific information concerning these photos could be provided by Sergeant [REDACTED].

Sergeant [REDACTED] stated that when [REDACTED] was informed that they could provide no information to him he left his card which contained his name and the following information:

Dear Sirs:

In approximately seven months or January, 1972, certain copies of top-secret documents shall be sent to the New York Times as well as two other newspapers. These documents are related to and will be an ostentation of the involvement of the pentagon in the controversial "Unidentified Flying Objects" or "Flying Saucer" subject. It will show that not only the U.S. Air Force was involved in UFO research but the other military branches as well.

Analysis and the actual conclusions of the classic UFO cases shall be revealed. This shall be accomplished by zeroxed documents and photographs that General Wolfe had reviewed when he was head of the Army's UFO support program in the Pentagon during the Eisenhower years.

Sorry, but it is concluded here that this is the best course to take because we feel that the secret UFO investigations are parallel in nature to the Times-Pentagon Vietnam controversy. If we are wrong in taking this action, time will tell.
