UFOs NOT TAKEN LIGHTLY BY MICHIGAN'S REPRESENTATIVES

Listed below are portions of some of the replies received from Michigan's senators and congressmen to a letter written by the Detroit U.F.O. Research Group as signed by Mr. Alan P. Rowe, director of research, DUFORG. In the letter, Mr. Rowe plainly indicated that the U.S. Air Force is withholding information on unidentified flying objects from the American public 'for reasons unknown! Further, Mr. Rowe called for 'a serious consideration (of the investigation of unidentified flying objects) by governmental agencies other than the investigation now being conducted by our Air Force.' Here are some of the replies:

"I wish to thank you for your letter...and the interest you have shown in the subject which is vital to the interests of our nation.. I assure you that when Congress reconvenes I will be glad to do everything possible so that the public is more fully informed of the developments in this field."

"Thank you for your letter... regarding your Research Group. I appreciate having the views of your group on unidentified flying objects, and have referred this matter to the Department of Defense."

"This will acknowledge your letter concerning the withholding of information by the Air Force with regard to their investigation of "unidentified flying objects". You may be sure that I appreciate your calling on me to do everything I can to have such information released to the public."

"I appreciate hearing from you with respect to public information in the field of unidentified flying objects...In every effort to be of assistance...I have requested of the appropriate authorities a report and will be pleased to advise you when this has been received.. From the information which has reached me from several sources, including your group, I am inclined to believe the entire problem should be reviewed by the Committee on Armed Services and representations to that effect are underway."

"Thank you for your letter regarding "unidentified flying objects." This has been a matter of considerable interest for some time, and it probably will continue to be in the future. I certainly do not scoff at those who have a serious interest in this field, and I have asked the Air Force about it on a couple of occasions. From what I get, however, there is no attempt to "cover up" by the Air Force. There simply appears to be nothing tangible to get hold of. As long as UFO's are reported, however, the Air Force will continue to investigate. I am sure that efforts in this direction are completely honest."

Ed.: The letter sent to Rep. Lesinski from the House Subcommittee on Government Information is as follows:

"Dear Colleague: Thank you for bringing to the attention of the House Government Information Subcommittee comments from your district on the availability of information about unidentified flying objects. ... The House Government Information subcommittee recently has intensified its study of the availability of scientific and technological information...Although it is unlikely that the Subcommittee's study will include the question of information on unidentified flying objects, you may be sure that if this question becomes a part of the investigation and hearings, it will be studied as exhaustively and objectively as possible."

"Thank you for sharing with me the views of your Group concerning the "Unidentified flying objects" phenomena. I am informed by the House Armed Services Committee that this matter is not currently an issue before that body. Through the 'Visitors' kind permission the preceding is a reprint from the Nov.-Dec.'57 issue. Through these letters we can obtain some insight into how our government officials are responding to inquiries on withholding information from the public. Serious UFO researchers believe it should not be withheld if not endangering national security. Their words are a partial basis on which you may judge for yourself if they are brush-off form letters, or, if the person writing will actually act in seeing that Mr. Rowe's request is carried out in the manner we would like to see it done. If you feel that any letter is a buck passer, why don't YOU write and tell that person why you think so. IT IS TIME TO ACT! Your elected officials are your government. If only a few bother to let them know how they feel, then, we will have to depend on their wisdom alone in guiding our destiny. We need to know more to continue our objective research. Let us not assume that the government has all the facts. The many research groups throughout the world have a great wealth of material that has been collected with an open mind unrestricted by government red tape or the super intellect who in his minds eye believes his knowledge is so great that it could not be

improved upon.

In Kent Cooper's book "The Right to Know" he states some very important facts which the people and government officials of all levels, national, state and local, should remember:

1. Confidence and loyalty thrive where people have the Right to Know;

2. There is no greater inducement to patriotic achievement than that which springs from a peoples own convictions, based, not upon a vulnerable unilateral propaganda line, but on full information on all sides of every question; and

3. Governmental power, backed by a force thus intelligently engendered in the individual, is unassailable because, through full availability to the news, an equal partnership, between the government and the individual in the country's welfare is established, based upon respect for the latter's Right to Know a policy which stands for human justice in its finest flower.

How nice it would be to escape into another solar system, for example, where the labors of life are at the extreme minimum, where every need is satisfied, where the creative spirit impregnates every human activity..and the feeling of harmony dominates every human affair. This idea may become obsessive, and we pass into a distorted world of illusion, expecting the 'benevolent space brothers' to cure our every ill and remedy all of our problems.

By taking this attitude, we lose our individuality..our very personality slowly disintegrates...we lose our sense of balance between reality and fancy. Should we not realize the fact that we must solve our own problems? ? Let's stop looking to the out side for a saviour to our self-made dilemmas...and begin to look within...take stock of ourselves...make an honest effort first at solving our own short-comings...and perhaps then be prepared to meet these beings from other worlds closer to their own level.
