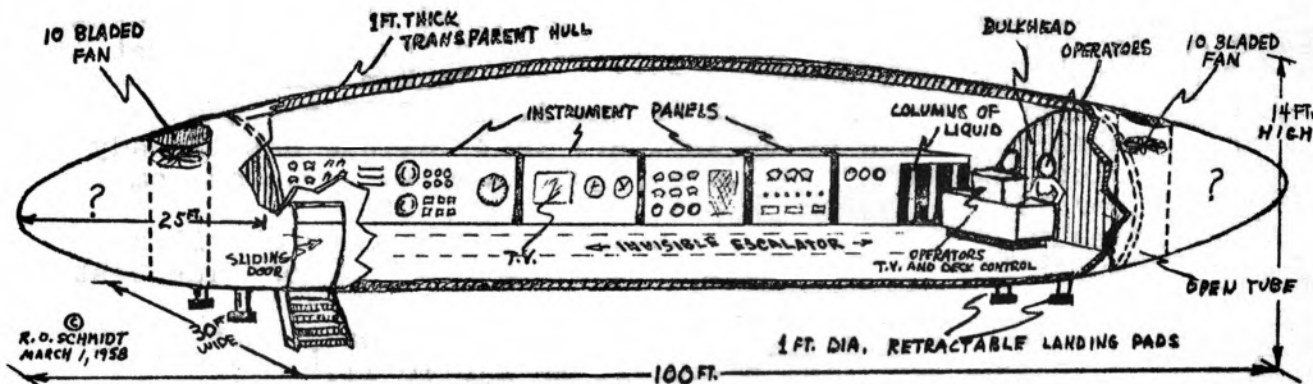

"A FALLING OUT" WITH "THE FALL OUT"

We are on that road leading to the end of the earth. Here in America, the "fallout" from exploded atomic bomb tests grows daily over our cities and farms. An invisible blanket of strontium 90 is descending daily upon mankind. According to the unimpeachable Bulletin of The Atomic Scientist..... "accidental radiation cases indicate that fallout has already caused blood cancer, bone cancer, genetic deviation and complete sterility".

Already the U.S. and the Soviet Union have stock piled enough super bombs to obliterate the earth. Why continue testing bombs whose fallouts may destroy mankind?

We as a free thinking, democratic people say that it has gone far enough. THERE MUST BE AN END TO IT!

Radiation contaminated grass can transfer the strontium 90 into the system of dairy cows thus creating a calcium deficiency in bones. Doses of radiation in the air, can fall on all the fruits and vegetables we eat daily, yet we have to eat to live. Don't we want to live so that we can live to be able to eat uncontaminated foods?

The children in each generation are the sufferers, far more likely than their elders, to pick up the deadly product of the bomb.

President Eisenhower has tried to negotiate a test ban with the Soviet Union. Where and when will it end? "The final decision regarding the testing and development of more powerful nuclear devices rests with the people", said Dr. Edward Teller, Professor of Applied Physics at the University of California, and the man who is credited of the development of the Hydrogen bomb.

Scientific judgement that the amount of radio active material injected into the stratosphere should not exceed ten megatons a year. Significantly, this information came from the lower echelon scientists connected with the Atomic Energy Commission. The question now arises; what values is the commission using in its official safety standard /? The Congress and the PUBLIC have not been told about this important information. Secretary of State Dulles, announced a month or two ago....the U.S. bomb tests would involve only a small fraction of what was considered a DANGEROUS level. But what fraction? And what IS a harmful level? THESE FACTS WERE REVEALED. Why should the official government agency charged with full responsibility in the atomic energy field, keep the American people in the dark?.

This is what some of the important men in the AEC state- Former AEC Commissioner Murray says, "Strontium 90 hazard is a real danger."

Dr. Linus Pauling, Nobel prize winning Bio-chemist says, "There is no safe amount of radiation."

Albert Schweitzer, Dr. Robert Oppenheimer, and other humanitarians, have been acting as judge and jury of its own cause.

These are some of the viewpoints of some well informed men, as expressed in an article, which appeared in the current (Feb.-Mar.) issue of 'Truth' Magazine.

We, as the people, have to literally squeeze the information out of the AEC. Even the men directly connected with the nuclear program contradict each other, on their points of view, concerning the dangers, or no dangers of radiation. WHAT ARE WE TO BELIEVE? Even skillful newspaper reporters, not to mention the layman on the outside, have difficulty in piecing together the information or understanding its significance. So much double talk.... and jabber-de-wock, that we are kept in the dark legally.

Who is behind all the SECRECY? Have we lost our democratic right to know WHAT is going on in our country? Are there a special few who will dictate to us what we can or cannot know about these atomic tests?

How can we help to clear up this maze of confusion and obtain a clearer perspective on this vital subject of nuclear fallout? YOU can write courteous and intelligent letters to your local Congressman, Senator, and representatives, and urge them to stop these atomic tests. Written on the 'Fact Sheet', is the correct method to do this. Ask them also, that when the House Resolutions Bill No. 9901 comes up for vote, that they amend this Bill to include this phrase.....

That they put a stop to our atomic testing, and that they further their studies on interplanetary relations. Also to stop the SECRECY on the U.F.O.'s. If enough letters reach these men, and they can be made to realize the seriousness of it, only good results will follow.
