The talk on april 24th at the Riverhead Free Library was to a standing room only crowd. The estimated size of the audience was between seventy to eighty people. The talk was well received and L.I.U.F.O.N. has been asked to come back again on July 14th to give another talk to the people of Riverhead..... The following newspapers carried full page stories on the talk and the Moriches Bay Case. They were; "The Suffolk Times", "The News Review", "Dan's Papers" and "The Hampton Chronicle". On Friday, April 27th, Chairman John Ford met with the folks at WRIV in Riverhead and did a full hour talk show on the Moriches Bay Case. The radio station was very well pleased with the popular response and has asked us in the near future to come back and present our additional findings....

L.I.U.F.O.N. is giving a presentation at the Center Moriches Library on June 5th at 7:00 p.m. and on June 9th at the Lindenhurst Library for the full afternoon. The Lindenhurst talk will be starting at 1:00 p.m. that Saturday. On July 11th, L.I.U.F.O.N. will be giving a talk at the Community Center at Artist Lake for the residents of the Artist Lake Condos. That will start at 7:00 p.m. and will go to 11:00 p.m.....

We are making arrangements with the management for L.I.U.F.O.N. members to attend the talk. It will require you to present your I.D. card at the door... On October 27th and 28th we will be holding our next conference at Artist Lake. It will be a two day conference and will feature some very good line ups of speakers. We are still negotiating for the moment with several speakers and can not give the line up of who they will be until it is finalized. We are trying to get Linda Howe and Bud Hopkins to speak, but it is not certain if they can make it. Only time will tell..... We hope that the membership likes the new format of the newsletter and the more professional appearance that it has given our monthly publication. More reports are coming in each week and the archives are growing. The tape recordings of interviews with witnesses and associated video interviews now number in the hundreds and are filling our storage space....

L.I.U.F.O.N. has for some time been exchanging as a courtesy to other organizations our newsletter and journal. In return we have been getting copies of other newsletters from around the country and from Canada. ## SPECIAL REPORT: THE BELGIUM SIGHTINGS.

The most incredible UFO sightings in European History have been occurring in Belgium since November of 1989. With more than 6000 witnesses and hundreds of sightings, the object which has been described as a large triangular type craft, has been observed in the night sky of Belgium for some 150 straight days so far. The object which is reported to be several hundred feet across has been reported to have 3 very large white lights in each corner of the underside of the craft.

The object which has been chased by Belgium Air Force F-16 jets on several occasions is reportedly capable of;

- 1) Traveling at low altitude at speeds as low as 10 mph.
- 2) Reportedly makes almost no noise and it has been alleged on occasions to make a slight humming noise based on witnesses' reports.
- 3) It can change directions on a dime or accelerate at speeds faster than the capabilities of known aircraft.
- 4) It has been able to make hairpin turns and then accelerate off at incredible speeds.
- 5) It has been seen throughout the Brussels metropolitan area and in surrounding districts.

Colonel Wilfred DeBrouner of the Belgium Air Force has publicly stated, "These are UFO sightings; we don't know what they are." Colonel DeBrouner has stated that the Belgium Air Force is under orders to continue its investigations and to try to determine what it is.


The Free University in Brussels which is partly state run is conducting investigations into the alleged sightings. Under the auspices of noted physicist Prof. Leon Brenig, the university has been conducting investigations into the craft and its flight characteristics. Prof Leon Brenig has publicly stated that no modern jet aircraft known could duplicate the maneuvers or speed of this strange aircraft.


The incidents have been so astounding and have attracted so much attention that news papers and T.V. in France, Spain and Germany have picked up the story. Some of the reports mentioned so far out of the hundreds are:

- A) On November 29, 1989 near the Belgium and West Germany border, it was reported to have appeared. It was spotted by Police on both sides of the border while it was observed to be flying at extremely slow speeds and at very low altitudes. The Police gave chase and eventually it involved three Police cars which followed it until it zoomed off.
- B) The object terrified office workers in a 20 story office building in Brussels. The office building was repeatedly buzzed by the object and convinced the people inside that it was going to crash into the building. The result was near panic.
- C) On March 30th, Nato radar detected the strange object amid a flurry of strange sightings. The Belgium Air Force scrambled two F-16 jet fighters to chase the object. At least five radar units were able to track the object and confirm its presence. Two of the units were airborne and the other three radars were ground based. The jets reported that they chased the object out to sea only to have it out distance them and then suddenly disappear in front of them.
- D) In January, the object appeared over a Soccer game in Brussels and was seen by hundreds at the stadium. It was described as huge and absolutely silent.
- E) There have been dozens of reports of the object buzzing cars and terrifying motorists on roads as it moved slowly down the highways at tree top altitudes.

The Belgium Government is determined to get to the bottom of these reports. It has ordered the Air Force to continue its investigation. In desperation, the Air Force has turned to the Belgian Society for the Study of Spacial Phenomena. This Brussels based UFO research group has studied the phenomenon for years in that country. It has been asked to lend its expertise in this investigation. The Belgium Air Force has even provided a jet transport plane to carry the researchers and Air Force technicians aloft with cameras, computers and tracking equipment at a moment's notice.

The Brussels based group has stated that they have been receiving at least fifteen calls a day about sightings of this object. As of this writing the Belgium flap continues.

Something totally strange has happened to you. It's weird, it wild and you know that if you tell anybody that they would just laugh at you. What has happened was so strange that you don't even want to tell your family; your're sure that they wouldn't believe you. Maybe they would even think that you were crazy.

Guess what ? I've just described about half of the reports we get at LIUFON.

But most of all they are afraid to tell anyone; they believe that they are the only one who has had such a bizarre experience and that no one else could ever understand or believe them.

Here at LIUFON we have reports from people whose lives were totally upset by encounters with UFOs and, yes, what seem to be extraterrestrials. We have descriptions of phenomena associated with UFOs that we can not explain. We have technical measurements taken with electronic equipment that appear to defy scientific laws. the range of phenomena associated with UFOs and their effects on people goes beyond anything we had thought possible.

So call us and tell us what you saw and what happened to you. We know how strange some UFOexperiences can be. Talk to us; we'll listen and possible make some suggestions that you may find helpful.

SPECIAL REPORT:

THE SOUTH AFRICAN U.F.O. CRASH RETRIEVAL

On May 7th, 1989, it has been reported that the South African Air Force intercepted and brought down a U.F.O. over the North Western part of the Kalahari Desert in South Africa. Timothy Good, noted U.F.O. researcher, has apparently been able to obtain copies of Top Secret South African Air Force Documents from a active service South African Air Force General leaked the information.

The incident began on the morning of May 7th, when a South African Navy frigate reported an incoming object heading North West along the Western Coast line of South Africa. Shortly after this, inland radar stations confirmed the track of the object which was traveling at high speed. Two South African Mirage IIIE interceptors were scrambled to intercept the object. One of the jets was equipped with an experimental laeser weapon which was used to bring down the craft.

The object was described as a 40 to 60 foot metallic disc was damaged and made a crash landing impacting some twenty feet into the desert floor. The fuselage of the craft was reportedly ruptured at the point of the laeser burn.

A Retrieval operation was mounted involving several French made Super Frelon Helicopters. The helicopters had difficulty approaching the object since the propulsions system of the craft interferred with their electronics and engines. One of the helicopters supposedly crashed with full lost of life of its crew when it got too close to the downed object when it lost full engine power. The other helicopters landed some distance away and the recovery teams approached on foot.

After arriving at the crash site, the South African Military personal were able to recognize the object as a classic disc shaped object with a pronounced dome. They were able to force open the hatch on the craft and remove several bodies. Two of the beings survived the crash. One died within hours of the rescue operation while the other being was able to survive two weeks before succumbing to respiratory problems stemming from difficulty breathing our atmosphere.

The papers Timothy Good has revealed also indicate that a deal was made between the United States Government and the South African Government. In exchange for the craft, the bodies and the technology recovered; the United States Government promised to turn over twenty nuclear warheads to the South African Government. Subsequently, the craft and the bodies were shipped to Wright Patterson Air Force Base where it is currently being examined.

Timothy Beckly, editor of the national magazine, "U.F.O. Universe", has received copies of the documents and plans to publish them. Leonard Stringfield, noted authority on Crash Retrieval Information, indicates that he gives the story some credence, but the final word as to its authenticity will have to wait further investigation. It appears the final word on this report will be based on the authenticity of the documents.

There is some speculation that this case may be an elaborate fraud, but again it will take some time in sorting out the facts. As the story develops more will be reported to you.

To the membership: As this issue of the newsletter was being prepared, Antonio Hueeneas contacted L.I.U.F.O.N. to inform us that a very clever hoax may be involved in this story. Several nationally known researchers have uncovered some disturbing information on this case.

WYTHVILLE, VIRGINIA: Wythville Community College on February 18th this year sponsored a lecture by noted U.F.O. Researcher Tony Gonsalves on U.F.O.s. Tony Gonsalves has been active in investigating reports of UFO-Stealth Technology connections. At the talk at the Community College, Gonsalves addressed a crowd of 75 people in this city which in the last several years has been a focal point of many UFO sightings. Tony showed a model of a boomerang object which many of the people there identified as the object they saw in and around Wythville the last couple of years. The model closely resembled the Stealth Bomber.

It is Tony's contention that some of the 22 billion dollars recently appropriated to develop the Stealth Bomber went into developing an aircraft built with Alien technology captured from crashed U.F.O.s. This aircraft has been tested in the skies of the United States with the result that people claim they have seen a U.F.O..

Tony claims the aircraft can hover and is completely silent since it is nuclear powered and uses anti-gravity to propel it. Tony is collecting his information for a forthcoming book.

GREENSBURG, PENNSYLVANIA: The "Post Gazette", which is published here in Greensburg, reported that the Pennsylvania Society for the Unexplained released the following information for the year 1989. Stan Gordon, founder and director of the Pennsylvania based volunteer research organization, reported that there has been a significant drop in UFO sightings for the year. In 1989, the number of sightings reported were 168 for the year, this was 87 fewer than for the previous year. No explanation was given for the drop in the number of sightings reported to the organization. The association also investigated 51 reports of other unexplained incidents last year. This was a sharp decrease of the 125 reports from 1988.

Many of the alleged U.F.O. reports were explained away as meteors, planets, aircraft lights, unusual atmospheric phenomenon or search light displays. Some 27 sightings in Westmoreland, Butler, Indiana, Bedford, Crawford and other counties could not be explained away.

Some of those reports were:

- 1) Two women in Squirrel Hill reported on May 17th, 1989 at 2:57 a.m. a silent luminous object hovering over the area. They subsequently filed a local police report.
- 2) On August 31, 1989 U.F.O.s were spotted in several Counties in a rather short space of time. During the course of these three sightings the objects were observed pursued by military jets.
- 3) On October 28th, 1989 a report of a unusual hovering light that picked up speed as numerous military jets in single formation chased it.
- 4) On December 23, 1989 in Warren County, a number of triangular shaped aerial objects were seen in the afternoon near a power station. This follows these objects long established tendency to be seen near and over power stations and generating facilities.
- 5) The Association continues to receive reports of numerous Bigfoot sightings especially in the Chestnut Ridge area of Westmoreland County. A fisherman in Donegal reported that at 12:15 a.m. on April 20th, 1989 of an encounter with a 7 foot tall hair covered biped upright creature, The creature made loud shrilling sounds before moving off into the woods.

EUGENE, OREGON: A report of a diamond shaped U.F.O. was documented by the Eugene Oregon, "Register-Guard," as occurring on New Year's Eve of last year. The report centered around a formation of five bright lights that appeared in a diamond formation that moved across the night sky in a North to South direction. A group of New Year's Eve party goers totaling some twenty people reported the sightings in the area of East 15th Street and Moss Street in this Oregon City. The sighting was also substantiated by a Robert McCaffrey, a real estate salesman, and five house guests who saw the diamond formation from the back of his home in the Perry Street Aridge Area. All witnesses agreed that the object or objects made no sound. The lights reportedly split in formation with two going one way and the other two going the other way. After passing over head a fifth light appeared like a trail in a kite. The lights

disappeared after 10 minutes after passing over the nearby Coburg Hills area. The nearby Pine Mountain Observatory associated with the University of Oregon reported no sighting of the strange lights or had any explanation for them. It was also reported that Robert McCaffrey's fifteen year old son photographed the lights with his instamatic camera. The picture showed two smudged circles of light. The entire incident has had no explanation.

GULF BREEZE, FLORIDA: This information has come by way of the Fund for U.F.O. Research. Since November of 1989 the City of Gulf Breeze has been the center of continuing U.F.O. activity. Almost daily nighttime and daylight sightings have been occurring over this Florida City. This is the same place in 1987 where Ed Walters and his family had their famous sightings and where the Walters family took their famous pictures. Those same pictures that are now considered the most revealing U.F.O. pictures in U.F.O. history. Not only Ed Walters and his family, but over one hundred other witnesses in this city also reported seeing the objects. There were also some 18 independent photos taken by other witnesses.

This area which adjoins the Pensacola area has had ten confirmed landing sights since November of last year. It has also involved more military jet and helicopter scrambles to chase these objects which have proven to be fruitless efforts since the objects outfly the aircraft. This has been almost a daily occurrence with the military now giving up any response. There have been daily photographs and video tapes taken of both day light and night time objects. Some of the pictures have been taken by civilians and the local T.V. station, while newspaper photographers have been involved in some of the picture taking.

Some of the activity also involves reports of alien abductions which have now totaled some fifty one in and around Gulf Breeze so far. There have been also reports of animal mutilations and reports of missing persons.

While some of this information has come from The Fund for U.F.O. Research, L.I.U.F.O.N. members down in Florida have been keeping us informed for the past seven months with reports of the activity down there. It has reached a "Flap" proportion. The case continues.

MOSCOW, SOVIET UNION: The famous U.F.O. landing case which occurred here in August of 1989 was just the tip of the iceberg. Antonio Hueeneas reports that the case was just one off a year long "Flap" which rocked the Soviet Union last year. There were literally hundreds of sightings and reports of landings all over the Soviet Union in 1989. Reports of alien encounters and abductions were also known to have occurred. This information came from Soviet Researchers at the West German Conference in Frankfurt in October last year. Much of this information has never reached the West till now.

Alarmed at these persistent intruders the father and son retreated to the house to go call the police. When the police arrived they found no trace of any one in the area. The family decided to call us to check out the story. The main reason they wanted our assistance is because they reported to us that they have had two dogs and cats disappear from their property in the last three years without a trace.....It should be noted that during the height of the Gulf Breeze sightings people down there in that small Florida Community were reporting their dogs disappearing without a trace from their backyards. Is the same pattern emerging here on Long Island ?
