FROM THE DIRECTOR'S DESK

For those of you who have read "Visitors From Within," you will recall Keith and Lyssa wrote that one of the functions of alien implants in abductees was to collect neurochemical data. Well, now science is catching up with UFO research. In the July 19 issue of US News and World Report, scientists have just announced their discovery of a sixth sense, a tiny organ that responds to chemicals known as pheromones -- *located in the nasal cavity*. As we know from our own research, that is the location of most of the implants placed by aliens in the bodies of abductees. The natural substances called pheromones are thought to play a role in basic human emotions such as fear, hunger, and love. We now know that one aspect of UFO abductions is to monitor and examine our emotional response to certain types of stimuli. 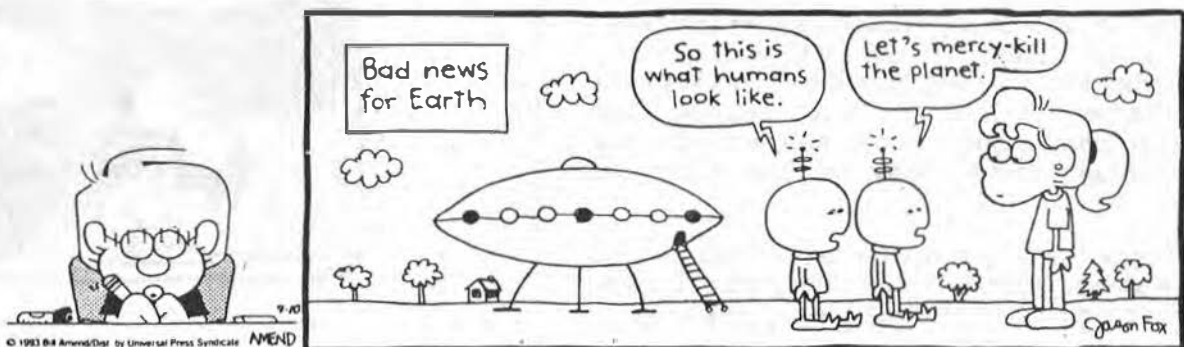
August has been an interesting month as far as UFOs go. The "Big Event," as predicted by Ed Dames, did not occur -- at least not to our knowledge!

In an interview with J. Antonio Hunerus in the September 1993 "FATE" magazine, Ed explained his "Big Event" prediction. He said the "Big Event" was to be the "coming out" of the aliens near Chaco Canyon in northern New Mexico -- where a group of female aliens, with hybrid children, are currently in a state of hibernation in an underground facility!

Richard Hoagland, author of "The Monuments of Mars," was a guest on the Jim Bohannon program on KTAR a few weeks ago. It was a most interesting program, and we are attempting to obtain a copy of the program.

Also, employees of KTAR radio who were climbing Squaw Peak at 5:00 a.m. recently phoned the MUFON Hotline to report a bright object in the sky.

Various reports of bright objects have been reported by several other members of our group and the public, including observations on at least three separate occasions by our own Mary Hart. Mary works evenings and has an irregular schedule which results in her leaving work anywhere from 12:15 a.m. to 4:30 a.m. on any given work night. The first time she saw the object, which she described as "as bright as a plane's landing light, but just one instead of two lights," was in mid-August. She noticed the object as she left work near downtown Phoenix and observed it all the way home. The object was in approximately a "2:30" position (due north being 12:00, of course) and a bit above mountaintop "altitude." The light wavered in brightness but did not change location; she was able to "sight" it in her driveway at home using trees for reference in case she saw it again, which she did. On subsequent occasions she was able to ascertain that the object was NOT present every night, which rules out its being a planet or star. She observed the object at approximately 1:00 a.m., 3:00 a.m. and 4:30 a.m., and each time the object was identical in location and brightness. Upon reporting it to me, she was interested to learn that others had also reported the object. As yet there has been no explanation for the object, and no one has been able to photograph it. If anyone has camera equipment with *telescopic*, not just telephoto, lenses, please be sure to contact me so we can possibly get a shot of the object should it continue to appear.

Art Bell, with a talk radio program out of Las Vegas (and until recently a UFO skeptic), has done an about-face after a recent sighting. The reasons for this follow in this article. Art can be heard on KTAR Radio at 2:00 a.m. most mornings. I was listening to the program recently when John Lear was his guest!

Kevin Randall, co-author of "Crash at Corona," was a guest on the Pat Murphy program on KTAR radio recently. KTAR was doing a series on conspiracy, with a different type each day, and the UFO conspiracy was the topic this particular day. Nothing really new was reported, though, but at least it keeps the topic before the public.

Sounds as if there is some activity in the Yuma area, as will be seen in the two articles contributed by Yuma member Doris Barley (also elsewhere in the newsletter).

Channel 15, Fox Network, repeated a program entitled "The UFO Report" on the final episode of "Sightings." It was, in my opinion, one of the best -- showing many aspects of the UFO puzzle: crop circles, abductions, cattle mutilations, "crashes," and various former Presidents (Ford, Carter, and Goldwater) commenting on the subject. Luckily, several members were ready for the show and recorded it.

Jay Lawrence had an abductee as a guest on his KTAR talk show recently -- but nothing terribly new. Mr. Lawrence would be well advised to take the

subject a little more seriously and not make a "joke" out of every comment.

ART BELL HAS SIGHTING

As mentioned above, Art Bell (radio personality, whose show originates at KDWN Las Vegas and is carried by over 80 radio stations nationwide [including KTAR Phoenix]) announced Monday, August 30, that he and his wife had witnessed the presence of a UFO near Pahrump, Nevada.

Art says he and his wife were driving home from Las Vegas around 11 p.m. on Sunday [August 29] when his wife saw lights in the sky and pointed them out to Art. They stopped the car, got out, and looked up to see a huge craft approximately 150 feet across in a triangular shape drifting slowly to the northwest at a speed too slow to estimate. Art says he particularly noticed that there was no sound being emitted from the object, even though he estimated its altitude to be only 150 to 200 feet. The object was apparently black, or appeared to be so against the dark sky, and it had two white lights and a blinking red light. Art is an Air Force veteran and is familiar with aircraft and distance estimation.

Although he has interviewed Budd Hopkins, George Knapp, John Lear, Bob Lazar and other UFO researchers on his radio shows, this was the first time Art or his wife has ever witnessed a UFO personally.

The "Coast to Coast AM" radio show featuring Art Bell is heard on KTAR [620 AM] in Phoenix starting at 2 a.m. Tuesday through Saturday.

YUMA SIGHTING

[Doris Barley sent me this report concerning a sighting in Yuma. The people making UFO observations will not be named, nor will their addresses be given for purposes of this article; however, all names and addresses are in Doris' report.]

Doris had called me August 28 to report UFO activity in her area, and when she sent me this written report she said that it had been "nothing but a nightmare ever since."] - Tom Taylor

DORIS: The Police Department dispatcher called our home at 4:35 a.m. Saturday and said that they knew I wanted to be told about any UFO calls. I asked for the caller's name and when it had happened. The dispatcher said "It's going on right now" and that the police officers were out observing it. I raced out and saw an object larger than a star in the east that was blinking red, white and blue. When I came in (the object disappeared about 5:00 a.m.) there was a message from the man who had called the police. The following is his story, which he had put on my answering machine:

The man said that around 4 a.m. he was at his girlfriend's house when he got a call from some friends who had seen "something." Several others went outside with him, where they saw a bright object changing shapes from round to triangular, and would then be flashing red, white and blue. It was zigzagging all over. The police sent a car out; when it arrived, the officers were observing the object through police binoculars. Through these binoculars the object appeared to be a purple ball with a yellow haze around it. The object disappeared around 5 a.m. [which corroborates Doris' account] after remaining motionless.

DORIS: It was after getting this information that I called the police dispatcher to thank her for calling me. She stated that the Police Department was logging the incident as an official UFO sighting. I then got several more calls.

Saturday night [08/28/93] I got a call from Yuma TV station KYMA asking me for an eyewitness account of the incident, which I gave. They also talked to the man who had given me the [above] report. This information was the "Top Story of the Day" on the 5 p.m. and 10 p.m. news. I did not know they were going to put my phone number on the screen -- but they did!! And all hell broke loose!!

I think the best thing to do is lump all of the sightings together, because I was not able to get a thorough investigation on all of them. I have the call waiting feature on my phone, and it was completely backed up -- one call right after another. Some people called to give me reports of sightings they had prior to this night's activities. By the way, KYMA was also informed by the Police Department that the incident had been designated an official sighting, but KYMA couldn't get the names of the police officers who

made the report, and I was not able to get the names either.

One man [name and address given in Doris' report], who is a stargazer, was up on the Yuma Mesa with a telescope looking at the stars. At first he thought the object he saw was an airplane, but it was making erratic movements. He said through the telescope the object looked like a purplish circle. The National Weather Service had given him my name and phone number.

A woman [name and address given in Doris' report] was on the patio with her husband drinking coffee before he had to go to work. For 20 minutes they watched a brilliant white light, which was stationary; then all of a sudden it "kind of drew up into itself, like it swallowed itself."

Another man [name and address given in Doris' report] observed a round glowing object in the east around 9:15 p.m. He called me about it around 10:20, but I did not see anything.

Another woman [name and address given in Doris' report] was traveling east on 24th street around 4 p.m. on August 28 and saw a white circular object moving in front of her from right to left. She said it was the size of a corporate jet and was bright white. Suddenly it stopped and shot straight up, disappearing with no trail.

Another woman [name and address given in Doris' report] called back Sunday night and said she had seen activity around 2:30 a.m. on the morning of August 29 [Sunday]. There were 10 or 12 red, white and blue flashing objects along with a round white object. The white object was two times larger than the blinking lights, and it looked like the objects were surrounding their area. Her friends and relatives all observed this.

Another woman [name and address given in Doris' report] also called and stated that on Tuesday, August 24, about 9:30 p.m. she and her husband were traveling west into Yuma on Highway 95 when an extremely bright light appeared, clear and giving such a brilliant flash that she said it looked as if "you could see the whole world."

None of the people in the above reports who were in vehicles had any mechanical problems or experienced time loss. Weather conditions on the 28th were partly cloudy.

J.J. Carr, an FAA employee working in the tower at the Yuma airport, said he got a call from a man in Dome Valley [east of Yuma] who reported that he experienced a light beam so bright coming into his house that it lit up his bedroom and bathroom.

I also got a couple of calls from people who had had previous sightings:

A woman [name and address given in Doris' report] reported that in December 1989 or January 1990, around 6 a.m. as she was driving to work, she observed a hovering bright green light as large as a basketball in front of her. She was frightened and pulled off the street. There was no one else around. The light appeared to be solid and kept changing shapes. It had blue flashes. It stayed only a few seconds before literally disappearing into thin air.

A man [name and address given in Doris' report] reported that he and a church group were camping east of Yuma in May 1993 when around 3 a.m. a number of the boys observed a large orange light, bigger than a large star. They watched it for 6 or 7 minutes, and during that time one beam of clear light came straight down from it. When a plane appeared in the sky, the object shot up to the northeast and disappeared.

DORIS: On Monday afternoon the Yuma newspaper reported that the object in my first report had been a star and not a UFO [copy of the article appears elsewhere in this Newsletter]. I got calls from everyone who had previously called; they were very upset by the article. They stated they knew what they had seen, and that stars do not zigzag and change shape. Also, one of the former callers said that no one had a telescope out when the police were there [as was reported in the article]. I am very upset by the article, as I feel it is meant to discourage people from calling when they DO have a sighting. Many of us have tried to call the dispatcher, but now when you call they say "Is this an emergency?" If you say "No," you are put on hold permanently until disconnected. On Monday morning [08/30/93] I was finally able to contact the FAA Public Affairs Officer at the Marine Corps Air Station and Yuma Proving Grounds. All were very cooperative and the PAO/YPG promised to call me if any unusual testing was about to occur. J.J. Carr at the FAA wants to join MUFON, as does the Master Sgt. at MCAS.

All the people who called on this and former sightings seemed very sincere and excited about the activity. One "new age" person who called said he "knows" we will be having a lot more UFO activity this month. We'll see!

[Doris went on to say that she got calls from many people just interested in UFOs, some from people frightened by the sightings (she attempted to reassure them that UFOs have been around for years and not to worry) and that the calls went on into the wee hours and she finally had to unplug the phone so she could get some sleep. She spoke with a lot of nice people and says she has recruited several for MUFON; she would like to get a MUFON branch group started in Yuma if possible, as there is a lot of interest in the subject.

Look! Up in the sky!

It's . . . oh. It's just another star.

A reported unidentified flying object this weekend turned out to be a star, Yuma police determined.

The first report of the UFO was at about 4 a.m. Saturday by a caller who telephoned the police department and reported seeing a red-and-green flashing light in the southeastern part of the sky.

Police said officers and dispatchers went outside and they, too, saw the flashing light in the sky.

However, the officers reported the light was standing still and not zig-zagging as the caller had reported. Police said a citizen offered the use of a telescope and the officer who looked through it determined the light was actually a star.

After a short investigation, police determined that unusual atmospheric conditions caused the star to look bigger than normal. Police explained that the ice crystals in the upper atmosphere distorted the light from the star.

On the next night, police said the star was in the same position. But because the atmospheric conditions weren't as unusual, the light looked like a normal star, according to police.

MORE SIGHTINGS

The following sightings were made by "Jane Doe" of Yuma, who was referred to Doris Barley by her hairylist (who had known "Jane Doe" for three years).

The first sighting took place in Mesa, the second in Yuma, and the third on Highway 85 returning to Yuma, just before reaching Gila Bend.

Jane Doe believes she was possibly abducted in 1953, when she was 5 years old. Following are her statements to Doris:

When I was 5 years old, in the mid-morning, I was sitting outside when I had a visual image of a brown, receding planet. My mother looked out the window to check on me, and I said something like "Mother, is it possible to have people from somewhere else come to visit?" My mother didn't answer me, as she really didn't know what I was talking about. I still feel frustrated to this day that my mother had no idea what I was talking about. Immediately after this incident sensory images and feelings of "green" flashed into my mind.

I have known since that time I was different from others, and I felt that my purpose was to improve other people. I felt it was because of certain people knowing me that they were successful, popular in school, etc.

The next year, when I started school, I began to have violent headaches. I can remember the teacher having to help me get to the nurse's office to lie down. It was not like I would go to sleep, but I seemed to become unconscious and would then wake up.

I can't remember my mother ever taking me to the doctor for headaches, and I can't understand why they didn't. My mother took very good physical care of me, to the extent of having braces put on my teeth when I was in the 6th and 7th grades. Also, while wearing the braces, my headaches went away. They began again later, and I have had blinding headaches to this day -- sometimes so intense I can literally "see" the pain.

On one of the trips to the nurse's office at school I was numb all over. I could not see, and sounds were heavy and muted. When in the nurse's office, I would wake up in the dark all by myself. I now wonder if anyone ever tried to wake me up and if the nurse ever recommended to my mother that I be treated. My mother, in later years, would take me to the Emergency Room for shots.

I have had psychic and ESP experiences. When in the military from 1967 to 1969 I was stationed in Alabama. When I was in a certain location I could visualize a battlefield. On different occasions I would be watching a documentary and I wanted to yell [at the TV] "hey, dummy, that's not the way it happened." I have had many, many psychic experiences -- not only visually, but I could also feel

them. I have never talked to a psychiatrist or psychologist about these feelings; most people have not believed the things I have told them. I am unable to visualize auras and have no healing abilities.

DORIS: When Jane Doe was relating the information about her 1987/1988 sighting, she told me, "I just knew it was a UFO." I asked if she had been reading about UFOs or watching programs about them, but she said, "No, I just seemed to know what it was."

Jane Doe has recently started reading about UFOs and abductions. She is presently reading "Secret Life" by Dr. David Jacobs and saw him on TV on the Jane Whitney talk show. She has commented that she would like to put down all of her thoughts and send them to Dr. Jacobs; she also just recently read "The Intruders."

Jane Doe has also had several out-of-body experiences. She accomplished this on purpose when she was about 13 or 14 years old by slowing her breathing. It has happened to her several other times; she says she would just wake up with a severe jolt when she came back. She can recall "flying around her neighborhood."

Jane Doe does not sleep during the night. She cannot remember when this started, but it was during her school years. Her mother would have a difficult time getting her up for school. She says she remembered just lying there in bed in the dark. She does not remember if she was scared or not, but she would just lie there, listening to her radio until 3 or 4 a.m. She does not know why she cannot sleep, but she has stated that she does not feel afraid of the dark, but just of "something."

When Jane Doe was 13 or 14, her parents would sometimes leave her alone in the house when they went grocery shopping in the late afternoon or early evenings. She said at those times she would turn on every light in the house, take two knives, and sit in the middle of the hallway (which was in the center of the house). This made her feel safer. While in the hallway, she would place her back against the water heater closet door. Sometimes she felt as though she wanted to crawl inside the area with the water heater. She states she was not just scared -- she was terrified. She repeated that she was never afraid of the dark, just what was in the dark.

When Jane Doe was an adult, during her husband's tour of duty in Spain, she was examined for her headaches, including a CATSCAN. No medical reason was found for the headaches.

Jane Doe's first UFO sighting occurred in Mesa between 7:30 and 8:00 a.m., sometime during school year 1965-1966. She was getting ready for school and always looked out a south facing window to check the weather. When she looked out the window on this day she remembered it was a cool, clear day. She saw an object about the size of a light bulb -- brilliant, opaque, bright as a star, and seeming to glow. She called for her stepfather and brothers

to come and look; they all watched as the object abruptly changed directions. She knew the object was not a plane, and she was not afraid of it but felt excitement. As she had to get to school, she had to quit watching after observing it for approximately 5 minutes.

In 1987 or 1988 in Yuma Jane Doe reports that she observed what she calls her "lifesaver" UFO. She is unable to sleep at night and was outside looking at stars between 1 and 3 a.m. In the east, she noticed a solid, round shape about the size of a dime when held at arm's length. It had red, yellow, green and orange lights which rotated as the craft moved. It moved very slowly at first, then paused, and then shot up in the air at a left angle. It then disappeared. When she saw the UFO, she was fascinated and excited. Sky conditions were clear.

The third sighting occurred in 1990 or 1991. Jane Doe was returning to Yuma from Phoenix between 1:30 and 2:30 a.m. As she was approaching Gila Bend, in an area where the highway dips down, a large round object with colored lights appeared to rise out of the desert. She stated that the object was larger than a standard size car. The area was pitch black, with no moon, and sky conditions were clear. The object hovered a few seconds and then shot straight up. Jane Doe said she was the only one on the road, and she felt like she had startled the object. She could not see any definite outline, and the lights on the object were stationary. No beam came from the object. Her vehicle did not malfunction; she heard no noise from the object, but this may have been because she was wearing headphones. She said she felt no fear.

HOW TO SPOT A UFO

■ YOU DON'T have to travel to far-off, exotic places to have a close encounter with a UFO. There are plenty of hot spots right here in the U.S.!

Strange-looking aircraft are constantly buzzing Niagara Falls, the Pacific Northwest, Texas and the Gulf Coast, says author Jenny Randles in her book *UFOs & How To See Them* (Sterling, 1992).

Randles surveyed heavy UFO activity throughout the world, but found that in many areas Americans need look no farther than their own back yards for alien encounters.

Here are four areas that are out of this world for spotting spaceships:

■ NIAGARA REGION. This spectacular area attracts more than just honeymooners.

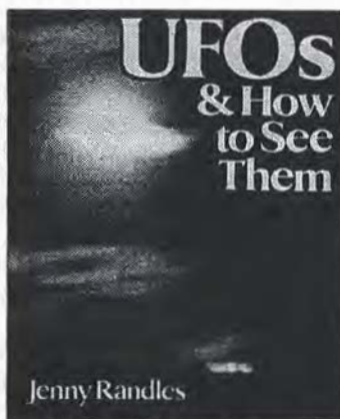
"The region has had more than its share of UFO encounters," Randles says — possibly because there are so many electrical generating stations.

"UFOs are known to appear in the vicinity of power stations," she adds. "Some people believe that they draw motive power from our circuits."

■ THE PACIFIC NORTHWEST. "This is one of the best places in the world for photographing UFOs," says Randles, who attributes the attraction to earthquake and volcanic activity.

"UFO researchers recognize a connection between seismic activity and sightings," she ex-

plains. "It is not surprising that California has had numerous encounters.

"However, in Oregon and Washington, volcanoes are the real attraction. The awesome detonation of Mount St. Helens in 1980 is a ready reminder of the raw power trapped beneath the rocks. That may help explain why this is such a UFO-active location."

■ TEXAS TRIANGLE. A trian-

gular area between Lubbock and Alpine in Texas and Albuquerque, New Mexico, consists mostly of desert and canyons. But Randles says this sparsely populated area is the site for some of the world's most significant UFO events.

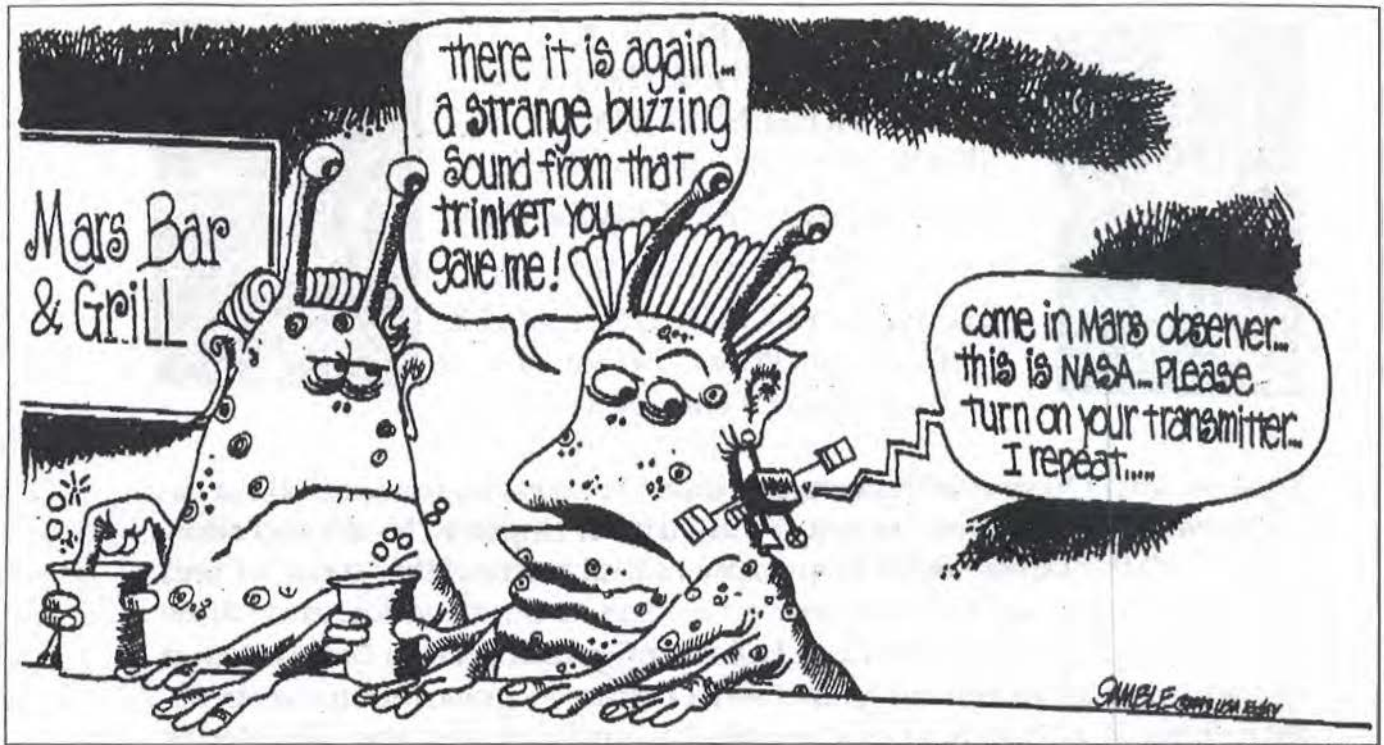
Among them are a UFO crash near Corona, New Mexico, an amazing number of cars that mysteriously stopped dead around Levelland, Texas, when UFOs were in the area and the landing of an object with aliens seen by a Socorro, New Mexico, police officer.

■ GULF COAST. A stretch of beach from Pensacola in Florida westward through Alabama to Biloxi, Mississippi, has been a major area of UFO activity, Randles says.

During a rash of UFO sightings, two Biloxi fishermen claim they were abducted by strange creatures and taken aboard a blue glowing object.

Afterward, they say they were dumped out of the craft and left with only hazy memories of what happened.

The Martians must be up to their old tricks

Fellow taxpayers, it's time for the truth about the Mars Observer.

Have the reports out of NASA during this whole Mars Observer fiasco struck you as just a bit disingenuous?

For instance, NASA says problems first occurred with the spacecraft during "pressurization of fuel tanks ... for the rocket firings that are to slow down the vehicle."

Right. Even my 6-year-old knows you don't fire rockets to slow down. You fire rockets when you want to speed up — or make the leap to hyperspace.

Next, they tried to tell us that we were out of contact with the spacecraft for four days because the clock broke.

I know we can't always expect the truth from NASA, but at least we ought to get a more plausible cover-up. It just shows how far our once-proud space program has deteriorated. I mean, these are the same folks who staged the moon landing in 1969.

If you ask me, relations between Earth and Mars have been none too cordial since 1976 when our Viking spacecraft landed a

biological laboratory on the Martian surface to look for signs of life.

Based on its tests, most scientists concluded "there was an absence of any microbiotic activity." Of course, nobody asked the obvious follow-up: "Forget the microbes! What life forms did we find?"

That same spacecraft photographed a Martian "rock formation" in the shape of a human face, longer than the Golden Gate Bridge and as tall as the World Trade Center. This, NASA explained, was just a "trick of lighting."

Five years ago, the Russians lost two spacecraft as they approached Mars. Subsequently, the entire Soviet system collapsed, turning the former superpower into a nation of subsistence farmers and setting in motion worldwide climate changes, disastrous storms and the expansion of major league baseball into Florida and Colorado.

For the past 10 months, our Observer

spacecraft has been merrily winging its way to Mars. Then, just as it's about to move into camera range, it falls silent. Did anyone wonder if maybe the guy in the rocks didn't like having his picture taken?

The thought never occurred at NASA. They are holding out hope that the spacecraft will eventually phone home. Of course, if that happens, how will we really know who's on the other end of the line?

NASA has made it clear that if this mission fails, it'll want to try again. But it is not as easy to slip a \$1 billion item through the budget process as it used to be. It's time for a different tactic. One that NASA is loath to employ: full disclosure.

All it takes is for one NASA scientist to stand up and confront what everybody already knows by saying: "Folks, I wanna appeal to the mixed-breed, underdog, fighting spirit that has made this nation the great come-from-behind team that it is."

"I know times are tough, and a buck's a buck. But I need another billion dollars so I can build a bigger, better spaceship equipped with the very latest Timex technology so we can go back out there and retrieve the Observer."

"Because the damn Martians took it."

Many theories have been advanced to explain these mysterious appearances which pique the curiosity of scientists, philosophers, researchers and metaphysicians. Close examination reveals clockwise patterns, with layers underneath swirling counterclockwise, and sometimes a mixture of both directions. The glyphs can form in 20 seconds or less.

These energies have great impact on sacred sites and often form on or close to the ancient sites in England. Are they holding a language for us to decode? What are they preparing us for? Why are they giving us teachings in gigantic symbolic form (thousands have been flashed before the **eyes** of the world for us to decipher). As a result of this phenomenon, our consensus view of reality has been forced to expand. If you want to plug into the Bigger Picture, come explore the implications of these bold configurations.

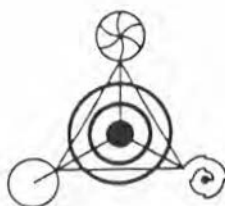
