## MUFON 2004 International UFO Symposium— Denver, CO July 16-18, 2004

### Program Abstracts

#### John F. Schuessler – “Unconventional Flying Objects: The Body of Technological Evidence.”

It is no longer necessary to refer to UFOs as unidentified. We have amassed sufficient evidence to show they are “unconventional,” rather than “unidentified.” UFOs are not airplanes, rockets, planets, weather balloons, space debris, ball lightning, remnants of comets or meteorites, or constructs of the imagination. We know this because a thorough study of the evidence in thousands of UFO cases has eliminated all of these things as explanations for UFOs. What remains is a huge reservoir of Unconventional Flying Object reports that defy explanation. Unfortunately, the evidence has been ignored, misrepresented or covered-up for so long that most people accept this as normal and no longer question it. We do have the evidence and we will discuss it based on the criteria given in McCormick’s Handbook of the Law of Evidence.

#### Stephen Bassett – “Deception, Denial and Disclosure.”

For the past ten years a growing political movement has targeted the politics of UFOs/disclosure. All levels of the media have received extensive materials on the subject. Former members of the U.S. military, former astronauts and many other government employees have been speaking privately and publicly in unambiguous terms regarding the extraterrestrial presence and a government cover-up. Each day the UFO/ET cover-up continues and each new revelation of abuse of power by this or that government agency further erodes the fundamental trust the American people hold in their government – and benchmarks for trust in government are at all time lows. If you truly wish to unite the country and begin a new era of cooperation, you must engage an issue of transcendent importance. That issue is at hand.

#### Grant Cameron – “Seeking a Checkmate Move: A Search for Conclusive Technological Evidence.”

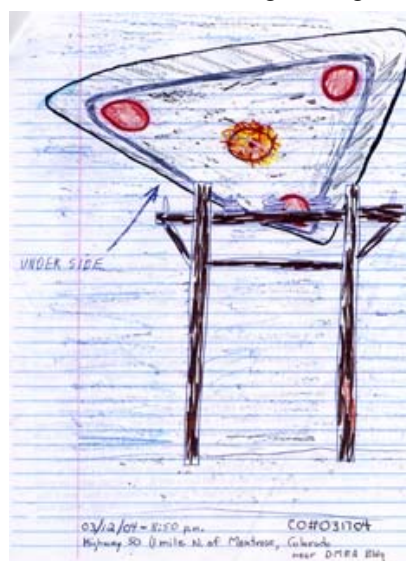

## TRIANGLE UFO SIGHTING Friday March 12, 2004 - 8:50 P.M.

On March 15, 2004, I met with the witness, her husband, and their 2 small children along with the witness's mother. They watched the children while I interviewed her. She was alone in the car at the time of her sighting. She was on the outskirts of Montrose heading south into town on Highway 50. She described seeing a triangle shaped object over a

power pole on her left across the medium and the 2 north bound lanes plus another 100 or so feet to the pole. It was hovering only a few feet above the power pole. It was dark but this object was very visible. It had lights on each corner and one in the middle. The witness remembers seeing red colors. There were some cars that pulled over and were

looking at this, other cars were honking, and she remembered a white truck and another vehicle that just floor boarded and was speeding through there, despite the fact that the speed limit was reduced at this point down from 65 to 55, and then 45 coming up on the first stop light going into Montrose. She slowed down to 45, but drivers were either speeding up more than they should, or slowing way down and some pulling over. She had a feeling or sense that the speeding people were nervous about what they were seeing. She kept going and for awhile could still see the object in her rear view mirror. She said she really did not

decide an important case. Your job will be to decide on the basis of all the evidence I will present if there is a case beyond a reasonable doubt that UFOs represent a technological phenomenon, and moreover, if it's someone else's advanced technology. Your job will not be an easy one. That is because evidence is treated differently in the UFO world than it is in the world at large. The standards are much higher.

**Peter B. Davenport – “Using Multistatic Passive Radar for Real-time Detection of UFO's in the Near-Earth Environment.”**

The author proposes a system for the remote, real-time detection of UFO's in the near-Earth environment, using passive, multi-static, frequency-modulated (FM) radar. The system capitalizes on the use of multiple, time-synchronized radio receivers to capture high-frequency radio signals reflected from a target. The time-lapse between received signals, together with three-dimensional Doppler-shift analysis, permits calculation of target's location, velocity, acceleration, flight path, and other parameters, possibly to include target size estimation. Signal analysis of the reflected signal, combined with analysis of target characteristics, will permit discrimination between suspected UFO's, and targets of terrestrial origin, e.g. aircraft, satellites, space debris, meteor trails, upper atmospheric conditions, weather phenomena, migratory birds, the Moon, etc. One application proposed may allow detection of UFO's out to a range of at least 27,600 kilometers from the Earth's surface.

**Deborah Lindemann C.H.T. – “Signatures of Extraordinary Technology in Abduction.”**

As I approach the twenty-year mark investigating UFO encounter cases, I continue to witness the extraordinary signature of abduction, written in the lives of hundreds of people I have worked with. The American Heritage Dictionary defines signature as, “A distinctive mark, characteristic, or sound indicating identity.” This forensic blueprint shows up in a multitude of ways: physical trace evidence, unexplained technology, not to mention the profound emotional impact these encounters have upon individuals. Throughout the UFO encounter experience runs a common thread of anomalous experiences and evidence with unworldly implications. This common thread runs through all cultures, all ages of people and between people who have never met. I will present the tapestry of the alien signature in several categories, reflected in a number of important cases including the Stan Romanek case.

**Budd Hopkins – UFO Abduction Cases: The Medical Evidence.”**

want to look at "that" (She never really liked the subject of UFOs). However her husband has been somewhat interested. He mentioned that he wished he could have been with her at the time of the sighting. I asked her to describe what it looked like to the best of her ability for the short time that she saw it. She said it was a dull black color with some texture to the flat bottom, and that it was hard to describe it, except to say it looked like grooves or something. The corners were pointy, and there was some thickness to the object, but due to her close proximity to it, she could not see much more than just the bottom of it. The witness filled out the sighting form and drew a quick sketch. They were somewhat rushed as the children were fussy and they needed to get home. I asked if she would draw a more detailed sketch at home when she had time. This she did. Please note the second sketch. The day after the interview I went to Montrose, met with the family again, and together we went to the location of the sighting. This was about 3:00 in the afternoon, and the correct power pole was pointed out to me. I took a photo, and the second full paged sketch shows the double poled power pole, which is more accurate, than the first initial sketch on the form. I made phone calls to the Montrose Press (newspaper), the Sheriff, and Police Depts to see if they had received any reports. I called the Airport FSS station to see if there had been any unusual aircraft reports for the place and time of the report. There were none. (The location of the sighting is not far from the north end of the runway of the Montrose Airport). The FSS people told me that in order to find out about radar reading/trackings I would have to call Denver Central. I continued to have trouble getting through with the number that they had given me.

Later in the week I went on the air with Rick Steele on the Montrose radio station KYDR to talk about the sighting and encourage others who might have witnessed the same UFO to call in. However neither the station or myself received any calls. A couple of weeks later Montrose Daily Press did an article on my investigative work, MUFON and recent sightings. I am hoping that I will receive more calls about this sighting and any others that might have occurred recently.

Among individuals reporting prior alien UFO abductions, three different kinds of physical aftereffects are often found within or upon their bodies:

The most commonly noted are surface lesions of two types: “scoop marks,” shallow, oval depressions, usually found on an abductee’s leg, and suggesting that layers of tissue have been systematically removed, and fine, straight-line cuts reminiscent of surgical incisions. Both types of lesions usually leaving lasting scars.

Radiological reports of small metallic objects – alleged implants – which occasionally appear in X-rays of abductees’ skulls and are inaccessibly located.

A wide range of other unusual medical symptoms which occur immediately after an abduction experience and appear to have no acceptable medical causes. These anomalous symptoms include sudden, profuse bleeding from the bladder in males, the absence of a previously existing ovary in females, numerous “disappearing” pregnancies, and other difficult to explain medical conditions.

**David Sereda – “Has NASA Made Contact With Extraterrestrial Intelligence?”**

This is the deepest investigation and dialog ever made about some breakthrough footage that was filmed by NASA. This footage records high numbers of disc-shaped objects, ambiguously classified, and until now, unidentifiable as any known phenomenon. He shows proof of intelligent craft through the process of elimination of other plausible phenomena; fundamental principles of faster-than-light technology and corroborating evidence found on disc-shaped objects; links to the supposed spacecraft and an identifiable star system.

**Nick Redfern – “Flying Triangles’ in British Airspace: Evidence of Advanced Technology.”**

In early 1993, a series of truly earth-shattering UFO encounters occurred in British airspace that went on to have a profound effect on high-ranking sources within both the Royal Air Force and the Ministry of Defense. More importantly, it was that single wave of encounters that ultimately convinced British military and defense personnel that the phenomenon was one that clearly demonstrated the presence of an advanced, high-performance technology. Some UFOs do indeed display evidence of advanced technology, not built by us and that the so-called Flying Triangle phenomenon is the latest and most significant example of that same advanced technology.

**Ryan Wood – “Evidence for the Existence of TOP SECRET/MJ-12: A Forensic Examination of Leaked Classified Documents.”**

At the heart of the debate of Government complicity in the UFO cover-up at Roswell, and more broadly with highly credible UFO related activity, is the existence of a blue ribbon panel of military and scientific minds code-named

Majestic 12 or MJ-12. For more than two decades there have been documents: some photocopies, some undeveloped film and some original papers that tell the detailed story of explicit involvement and extreme military and government secrecy toward UFOs. Not only are documents in the public domain, but living witnesses also corroborate the documents, the military procedures and the long-standing cover-up – which the vast majority of Americans believe.

**Leslie Kean – “Combating Media Ridicule and Searching for Evidence on the 1965 Kecksburg Crash Case.”**

In May 2000, I published an in-depth story for the Sunday Boston Globe about the French COMETA report and the broader issue of UFOs and national security. My prior experience was as a widely published, print journalist and a producer and host for an investigative news program on KPFA Radio, a Pacifica station in Berkeley, CA. When I received an advance copy of the English translation of the COMETA report from a colleague in France, I recognized that the extraordinary conclusion reached by the distinguished authors was newsworthy, and that this report had potentially profound implications that needed to be addressed and made available to the public.

**Paul Davids – “Profiles in UFO Courage.”**

The thesis of this highly visual presentation is the UFO disclosure has been like “time-release aspirin” – and that the media has been skillfully utilized by a relatively small group of courageous people, who at times risked ridicule and being discredited, as well as being targeted for onslaughts of debunking, in order to help the public assimilate the very controversial concept that “We Are Not Alone.” My interest in the UFO field was propelled by a daylight flying saucer sighting in 1987 in close proximity, with my two children. It provided the motivation for my becoming executive producer and co-writer of the Showtime film ROSWELL, starring Kyle MacLachlan, Dwight Yoakam, and Martin Sheen. It also led to my conviction that excessive official secrecy on this issue is a negative and mistaken national policy.

**John Greenewald, Jr. – “The U.S. Government’s Present Day UFO Interest. The Black Vault Uncovers What the Government Doesn’t Want You to See.”**

It has been over seven years now since I started what has now become the largest database in the world, outside of the U.S. Government itself. Many Internet users and television viewers worldwide have seen this site known as ‘The Black Vault’ grow beyond anyone’s imagination. Archiving over 114,000 government documents, 20,000 historical photographs, a message forum with over 270,000 posts, and over 10,000 news articles, The Black Vault is by far one of the largest sites on the Internet.

## Artist Pictures of July Lights Sighting in 2003

I first met the witness, (wishes to remain anonymous), on July 17th at noon on the corner of Ford and 13th in Golden, at a gas station. He worked at the large plant on the other side of the street. On a later date, Gail Barton, COMUFON Artist/Field Investigator, was able to make some drawings near the location of the sightings, and with the witness's direction.

The witness states that on July 11<sup>th</sup> at about 8:50 PM, he stepped out onto a stairwell, on the side of the building, outside his work area on the second floor.

He was looking out into the northwest, when he noticed just above one of the hills, there were three lights (Event 1 in the pictures). They were in a triangular pattern, very close to each other, and stationary. Together they were about the size of a quarter at arms length. He said they didn't cast any light on the mountain, and actually seemed some distance past the mountain. He described them as

looking white, like the color of halogen lights. He said they had definite outlines to them, and looked like three marbles in a perfect triangular pattern, with its base facing the ground.

After watching what he felt were 3 different objects, for about 1 or 2 minutes, they disappeared.

About a minute later, the witness described a volley of lights looking almost like tracer fire, coming from the ground behind the mountain (Event 2 in the pictures). Then a couple seconds after those lights stopped, the three lights seen previously appeared where the "tracer" lights terminated, and streaked off in a "Star Trek warp" like fashion (Event 3 in the pictures).

The witness had kept his eyes glued to all of this. He said a co-worker was just inside the door, but he didn't want to miss anything. After it all had disappeared he called the co-worker out to take a look with him. The lights were all gone, but after a couple of minutes they both saw what the witness believes to be a Stealth fighter (Event 4 in the pictures). He said it came from the north, and was flying towards the activity he had just witnessed. He said the Stealth was flying with no lights on. The witness said he

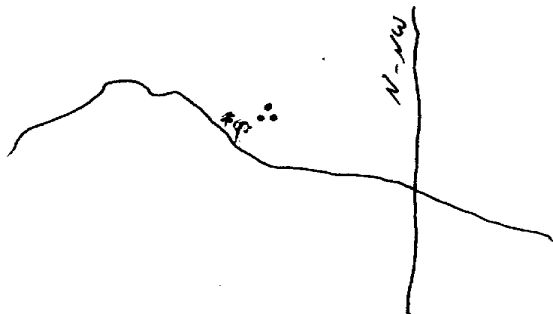

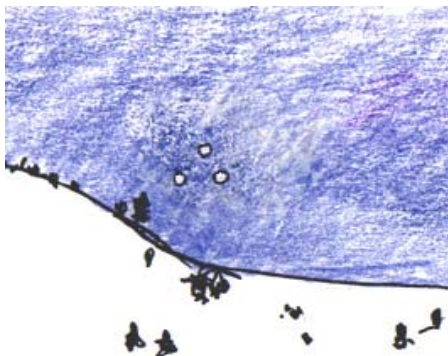
Peterson AFB never returned my message regarding this sighting.



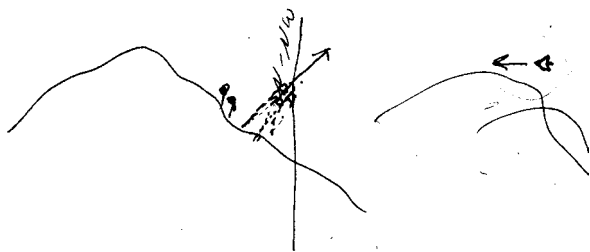
Composite of witness's view.



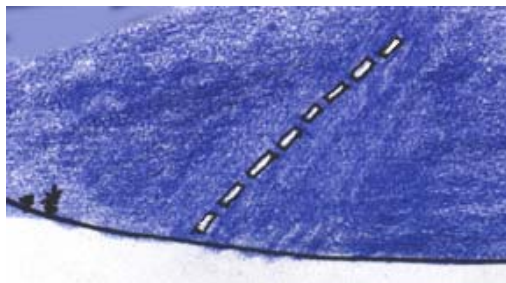
Witness's drawing of first event.
