Police Interact With UFOs: The 1967 Georgia Incident

On October 20 and 22, 1967, twenty known Georgia Police and State Patrol agencies were observing, chasing, or being chased by UFOs. This is the only year in Georgia where all known sightings involved the Law Enforcement community. This started me to ponder the question: Why target this group of people? Then I recalled the December 3, 1967 incident involving Sgt. Herbert Schirmer of Ashland, Nebraska. This officer had a close encounter with a UFO, while on patrol. Later, under hypnosis, Sgt. Schirmer recalled one of the "operators" of the craft asking him, "Are you the Watchman over this place?" If you think about it the law enforcement community is in charge of physically controlling the general population. The term "Watchman" would be correct. Don't you think another intelligent life form would be interested in this group of individuals or their agencies?

As for the Georgia events of 1967, they started at 4:40 AM on October 20. Milledgeville police officers reported observing an "object as bright red, about 25 feet in diameter and moving due west." Later Milledgeville Police reported "the object changing from red to green and from a ball shape to a four-leaf clover shape." No noise was reported associated with the unknown object. So many sightings were called in that the State Patrol office in Thomson, Georgia was used to coordinate all reports. Warner Robins

Crop Circles

Part 3 of 3

This is the last installment of the article on Crop Circles continued from Georgia Sky Watch issue number 12.

It should be noted that phototropism (the natural tendency of plants to bend toward or away from a light source) does occur in plants downed by any force, causing the plants to bend at the node. This bending will be more pronounced in young crop, occurring within a few days after being downed, but is not concurrent with elongation of the node or the presence of expulsion cavities in the same

Air Force Base was also contacted to investigate. Before the day was over reports had come in from law enforcement agencies in McDuffie, Baldwin, Washington, Elbert, Greene, and Laurens Counties.

On October 22 the UFOs went from sightings to close encounters. Milledgeville Police Chief Eugene Ellis reported his men were being chased by unknown objects and is quoted as saying, "There are no green me and we're not drunk, but we've seen something and we don't know what it is." Chief Ellis with two groups of police officers from his department, at two different locations, observed a UFO along the Oconee River. The object was a half mile from the Chief and he was in constant radio contact with his men who all reported observing the same object. The object rose up near a pecan grove. After rising it "very rapidly sped out of sight." Chief Ellis reported "it appeared to be perhaps 40-50 feet across and maybe 30 feet high, seemed cylindrical comparable to an old fashioned water-tower tank not the mushroom type and was glowing orange-yellow." At the same time Warrenton, Georgia police officers were observing a UFO to their west. The object in Milledgeville was being viewed in the eastern sky. For those not familiar with these two locations Warrenton, Georgia is northeast of Milledgeville and both locations are separated by Hancock County. Warrenton is in Warren County and Milledgeville is in Bibb County.

In Manchester, Georgia State Patrolman Jerry Goldin reported observing two UFOs, "one ice blue and about a mile high and the other one a yellow rectangle shaped object with a red side about 100 yards above the trees."

Newnan police officers Dale Spradlin and Gerald Mascon reported they followed an eight inch ball of light for eight miles at 4:30 AM. It was flying at tree-top level and heading East. When the object started to pull away the officers turned around and headed back to town. The object then started to follow them. Officer Spradlin stated, "The object turned on us and followed. It was gaining on us and we were going about 75 miles per hour. It was a bright light and looked a lot like one of those mercury-vapor lamps - with sort of a bluish glow. It moved around all right, but I don't know what it was. After the object caught up, it pulled into the sky, emitting a beam of bluish light that illuminated the roadway." This event was witnessed by two citizens and a Highway Patrol Officer.

Other officers over a wide area of Georgia reported watching an object during the early morning hours and stated "it had climbed high in the sky, looking like a bright star except for erratic movements."

Warner-Robins Air Force Base personnel stated nothing was seen on the base radar. By the end of the day reports had come in from police and State Patrol offices in Coweta, Meriwether, Baldwin, Talbot, Fayette, Taylor, Houston, Bibb, Sumpter, Warren, and Laurens Counties.

According to Lt. H.M. Spurlin, a GBI supervisor for District Three, the UFOs sighted over Georgia "probably were the result of work by mischievous teenagers." According to The Atlanta Constitution, October 25, 1967 issue "Spurlin said several weeks ago he discovered a group of teen-aged boys who were putting candles in plastic bags, like those on finished laundry, and setting them aloft. "When they hit the wind currents, they really go," Spurlin reported. "It's almost frightening to see them."

This explanation makes about as much sense as the explanation offered by scientist at the University of Colorado. They ruled the Georgia Police had been looking at the planet Venus.

A year later personnel at the Institution of Atmospheric Physics, at the University of Arizona, disagreed with Colorado's findings (The Condon Report). After all, if the Millidgeville Police were observing their object in the eastern sky then they were not looking at Venus. Also, Venus does not rise up from a pecan grove. Further investigations by the University of Arizona discovered just after Millidgeville Police lost contact with their object, Dublin Police "radioed that they saw it coming down from North to South, from the direction of Milledgeville."

As a police officer I feel I would have to side with the Arizona group until someone can convince me that over a two day period a number of law enforcement agencies were fooled by a candle in a plastic bag, or conspired to create an elaborate hoax that would serve no purpose, but cause ridicule to those agencies.

State Director's Message

Last year at this time, we were snowed under with many reports of possible UFOs and other anomalous events. While we tried to investigate the more pressing cases, we found that getting qualified Field Investigators or even active Trainees assigned to all of the cases was impossible. Some cases just went uninvestigated. This is hard for me to accept when we have so many members who are Field Investigator Trainees, but never attend our training, functions, sky watches or other activities. Nor have they met with other members to network or discuss operational procedures. They have never even ordered the MUFON Field Investigator's Manual.

We understand that volunteers have to juggle their occupation, financial situation, and family time with MUFON activities, and we try to take that into consideration. If we can get all, or even most, of our FITs active, attending our training and functions, studying the Manual toward certification etc., we would not find ourselves in such an overwhelming situation again. We would have sufficient personnel should such an increase in UFO reports occur again (and it will sooner or later).

There is absolutely nothing wrong with an active FIT being assigned to set up an investigation, do preliminaries etc. so that a certified FI can come forward to assist, allowing both the FIT and FI to handle the case jointly. This would be a great way to gain experience and get extra training. It is not beyond reason that an active and well studied FIT living in a remote region could handle a case solo, with assistance from the CFI, ASD or SD in the form of e-mail or telephone advice and guidance.

The secret is an 'active FIT', someone that has attended our functions, training, and networked with me or other experienced personnel in the HQ section in order to learn the system. Most important, however, is to obtain and read the Manual toward the goal of full FI certification. Hey folks, we need you!

There have been long periods where nothing is reported in our area, but then again last Autumn began rather slowly. One or two cases trickled in and then an avalanche! My phone was constantly ringing and even witnesses from out of state were calling!

While I often refer to our group as the "UFO Police" we are actually more like Firefighters/EMTs. Those valiant men and women spend a lot of time in the Firehouse with in-service training, classes and re-certification. They eat, sleep and live life 'on alert'. When they are needed however, they are needed RIGHT THEN, INSTANTLY, IN THE RIGHT PLACE WITH THEIR GEAR, READY TO DO THEIR DUTY. Our situation is similar. We normally spend our UFO time studying the Manual, reading the UFO literature/Internet, going to meetings or other activities, working an occasional case, and living our normal life, but prepared (and hoping) for a situation like that of last Autumn!

We understand that a member or FIT may not be able to make every meeting, every function, and every sky watch. Members do however need to try to attend some of these, especially the larger general meetings where the training is offered. Questions can be answered and issues resolved. Please call me or send an e-mail at any time if you need to discuss our objectives and operations or have any questions.

Mark and I have discussed holding a 'Leonids' sky watch during November 17-18th. Preliminary indications are that it will be more spectacular than last year. Our old location on Ft. plants. Many factors must be taken into consideration when trying to determine causation in this situation, rather than reliance upon one single finding--the age of the plants at the same time they were downed, the amount of time elapsed since the event, the over all prevalence of the bending, the presence of node elongation and expulsion cavities, as well as the results of microscopic examination, germination and growth trials. Snap judgments based on a single observation or finding are probably misleading.

The work of science is not only to explore and document unknown aspects of reality, but also to attempt to establish causative models or theories which can eventually be tested in the laboratory. In the case of crop formation phenomenon this is a tall order. It is very easy for modern man to forget the decades of pure research which eventually resulted in modern medicine, agriculture and technology, benefits which many of us now take for granted--but a thorough grasp of any new area of investigation takes time, work, and the efforts of many researchers.

Dr. Levengood has, in a 1994 paper published in a peer-reviewed scientific journal ("Anatomical anomalies in crop formation plants," *Physiologia Planetarium* 92:356-363), presented one possible causative mechanism for the crop formation process, and the continuing field and laboratory data obtained since that time continues to support this theory. The affected plants reveal evidence of exposure to rapid air movement, unusual electrical fields, very brief exposure to extreme heat, and ionization in a thermodynamically unstable system; one naturally occurring atmospheric force which includes each of these features is an ion plasma vortex--one very "high energy" example of which is a lightning discharge.

Ion plasma vortices probably form in unstable regions of the upper atmosphere, due to an energy exchange between the ionosphere and electrical storms. Once formed, these highly charged plasmas form into vortices--rotating, whirlwind-like systems--which are then drawn to earth and shaped by variations in the Earth's magnetic field. And, although it is difficult for most people to easily imagine, it is entirely possible

for such vortices to produce an enormous array of complex symmetrical and non-symmetrical patterns upon impact at the Earth's surface.

It should be noted that our research indicates that non-geometric "randomly-downed" areas of crop, sometimes associated with the more symmetrical designs and sometimes found by themselves, exhibit the same alterations to plant tissues as those observed in the more dramatic patterns, suggesting the same causative agency at work. Much of what farmers have called "lodging" in the past, attributing this downed crop to a combination of over-fertilization and subsequent weather damage, is instead an additional aspect of the crop circle phenomenon which is generally unrecognized.

It should also be pointed out that intricate and varied designs are abundant in Nature. They are so common that most of us don't even notice them; they are also most often observed by people on a relatively small scale. Think, for example, of snowflakes--their amazing variety and delicacy of pattern. If snowflakes were considerably larger than they are we would surely be as astounded by them as we often are by the crop formations.

Given the accumulated scientific data which currently exists regarding the crop circle phenomenon we feel that the most logical causative mechanism--the explanation that most closely fits the known "hard" data collected so far--is the theory that highly charged, thermodynamically unstable ion plasma vortices are responsible. Microwave radiation is known to be associated with ionized plasmas & microwaves, of course, emit very intense bursts of heat; and many of the documented physical changes to the formation plants are consistent with this fact. Add to the presence of microwave radiation the effects of an electrophoretic component functioning within the framework of a kinetic, oscillating system which is also thermodynamically unstable and you have a solidly based description of an energetic system which can account for the documented alterations to crop formation plants, the various design and random patterning, as well as, the changes observed in soil samples to-date (see Levengood, Wm. C. and Burke, J., "Semi-Molton Meteoric Iron Associated with Crop

Formation," J. Sci. Exploration (9:2), pp. 191-199 (1995).

Why and how these turbulent, energetic plasma systems form--what possible modifications, alterations or changes in Earth's upper atmosphere, or perhaps some other triggering mechanism--remains unknown. Perhaps recent loss of ozone, or alterations in the atmosphere caused by air pollution, or even modifications in the environment related to increased technological development and application may eventually be found to be responsible. Whatever the originating factor or factors is eventually determined to be, the fact remains that more than 90% of the formations meticulously investigated by this group of researchers reveal anomalies in the affected plants and soil which are consistent with these materials having been exposed to an energetic system as described above. Approximately 10% of the events studied do not show these changes, and are suspected to be the result of direct human intervention.

Individuals interested in participating in field-sampling, should also contact Nancy Talbott. Our spotting and field-sampling network increases each season as the phenomenon continues to expand, and we're grateful for assistance.

It isn't uncommon for discoveries to be made simply by accident. Several years ago I was told to make sure I include a magnet as a tool for use in crop circle investigations. I was given a "story" that a researcher while investigating a crop circle had a magnet in his shirt pocket that fell out as he bent down. When he picked it up he noticed material clinging to the magnet that turned out to be magnetic. Unfortunately, I passed this "story" on to anyone who would listen! Finally, I had an opportunity to speak with John Burke and passed this story on to him. He was amused and

promised to send me the correct version. With permission from John Burke of the BLT Research Team, Inc., I share his summary with you:

In August 1993 Peter Sorenson of Los Angeles was investigating a fresh crop formation near Cherrill when something caught his eye. Peter had collected rocks since childhood, is a professional stone carver in fact, and he was always bored by the relentlessly white chalk stone which is all that exists over the chalk aquifers where crop circles tend to occur. so when he saw a reddish brown stone he picked it up. When he turned it over he discovered that it was white underneath. But the brown upper surface wasn't dirt. It wouldn't wash off. He collected several such odd rocks and gave some to Linda Moulton Howe, who forwarded them immediately to Dr. W.C. Levengood, the one professional scientist doing serious crop circle research. Examining this puzzling material, Levengood finally decided to try a magnet on it and discovered much to his surprise that the material was magnetic (chalk is not). He told Linda to tell Peter to get a magnet and go back and drag the area with it.

The material Peter sent back included not only stones but even bits of plant matter! The microscope showed that some tiny grains of this magnetic material had become embedded in some plant tissue, enabling one to pick them up with a magnet. This has been widely misreported as magnetizing the wheat tissue itself, which was not the case. Spectroscopic analysis revealed the material to be pure iron and oxygen. Droplets of it had cut into some stalks from bottom to top along the stalks, showing the material likely hit the stalk as it was being laid down and that the material was traveling in the same direction as the force which laid it down. Electron microscopy showed the material to be composed of a coagulated layer of tiny black and red bubbles. Numerous characteristics showed that the material had been semi-molten at the time it was hit. Flakes Dr. Levengood peeled off wheat stalks had the grain of the stalk imprinted in the iron.

What was this stuff? Months of intensely searching the scientific literature ruled out terrestrial iron ore, as none in that country was ever pure iron without other minerals present. The form of tiny bubbles was quite

puzzling too. It turned out though that the biggest meteor shower in 25 years had hit Western Europe a few days before the formation. Searches of meteor literature revealed the key to the puzzle. When iron meteors enter Earth's atmosphere their surfaces heat to molten temperatures and droplets of pure magnetite (iron and oxygen only) are blown off by the wind into the upper atmosphere where they congeal into tiny spheres and bubbles of microscopic size. (The nickel and other meteoric elements drop out during this process, called ablation.) What's left is meteoritic dust so fine it takes days to settle to the ground.

A spiraling plasma descending from the ionosphere generates its own magnetic field, and shrinks in size as it nears the ground. It would gather up much or all of the magnetite it encountered during its slice through the atmosphere and swirl it around within the plasma. Tighter plasma spirals generate stronger magnetic fields and it is worth noting that nearly all the magnetic material recovered by Peter had been concentrated in the smaller, sub-spirals within the formation. Since spiraling plasma generates microwaves and microwaves interact powerfully with metal, it is not unreasonable that the magnetite dust was heated to a near molten state. Why it failed to then char the wheat is likely because magnetite's melting point is almost a thousand degrees lower than pure iron, and the farmer told Peter it had rained the night of the formation. As magicians show when they dip their fingers in a bowl of water and then into molten lead without harm, a thin layer of water can provide great insulation for a short time. The rain also rusted much of the otherwise black magnetite into its reddish cousin hematite, which gave the rock its odd color.

Meteoric dust is always in the air and therefore is likely to be deposited in lesser amounts in other plasma-caused crop formation. Tests of many American formations have shown this to be the case. To properly sample for this, use an 8 oz. cup and ziplock bags. At the same spot where plant samples are taken, scoop up a cupful of surface dirt, place in the baggie, and label the location. This enables Dr. Levengood to do a thorough magnet drag of the dirt at the lab, weigh it, and calculate the dirt's content of this material. As with plant samples, controls taken

well outside the formation are vital. All dirt has meteoritic dust; the important question is its relative content at different spots within the formation as compared to controls. The best data can be obtained when samples are taken at the formation center, the edge, and in between; then a control sample slightly outside the formation and another 1 or 2 taken 100 yards away or more away.

Day in and day out, I spend a good portion of my time on the internet compiling sights that deal with Ufology, Abduction Theory and the paranormal. In this issue, I am going to focus on three internet sights that I have discovered: THE UFO CONSPIRACY, UFOCITY.COM and CSETI.COM. Each of these internet sights have become very popular, very interesting and full of serious information for the Ufologist and the investigator.

The UFO Conspiracy: The words UFO and Conspiracy seem to have gone hand-in-hand for quite a long time. The website which can be accessed by typing in www.geocities.com/Area51/Dunes/2484/index2.html, is a great website for the UFO enthusiast. There is an easy to follow layout so that even the internet amateur can work with ease. The home page lays out a generous offering of topics which include the following: Breaking News in Ufology, Area 51 (new area - still under construction), Majestic 12, Crop Circles, Ten Things to Do If You See a UFO, Exclusive Interviews, and Classic UFO Sightings. Presently, the website also discusses Black Programs run by the Pentagon and its misuse of funds. The author of this website also discusses his gathering of Freedom of Information Act Documents relating to the subject of Ufology. There are also links to other great UFO websites, especially, UFOCITY.com, the UFO Alliance and the Citizens Against UFO Secrecy (CAUS) Website.

UFOCITY.COM: Here is another great website dedicated to UFOs and the government coverup. On the main page of this website is a great layout with many subjects and discussions as well as news from The National Aeronautics and Space Administration (NASA). The subjects and articles change frequently, so the best way to follow and track these websites is to bookmark them. Some of the present topics

discussed at UFOCITY.com are: STS-93, Columbia and its mission in launching the Chandra Space Observatory (at the time of this writing, the mission was a complete success and the shuttle landed flawlessly at Cape Canaveral, FL), Ex-NASA Worker says that Space Agency knows about UFOs, UFOs and Law Enforcement, Political Action Committee to Target the politics of UFOs and ET Phenomenon to be launched, and the ever-popular Filer's Files can be viewed here as well.

CSETI.COM: Wow! (the only word to describe this website) The Center for the Study of Extraterrestrial Intelligence, which was founded by Dr. Steven Greer in 1991, has a great website to back-up its functions. CSETI presents a great amount of information in an easy to browse format. There are many great articles here. Presently, the topics range from sightings of UFOs during Star Wars testing, members of the President's staff who visit this website quite often, the public asking for Congress to investigate Ufology more closely, reviews on books dealing with the government and Ufology, interviews, and membership to CSETI.

This is Hwy 19-41. The hotel is within about a block north of the intersection of Hwy 92 and Hwy 19-41.
