The display covers such topics as types of sightings, Mass. MUFON, UFO photos, Govt. Documents, UFO History, Investigative Forms and Information, Close Encounters, etc.

News Briefs

REPEAT OF '75?

During late February and continuing in April, a number of UFOs were reportedly sighted over Brunswick Naval Air Station in Maine and also over bases in North Dakota. Several FOIA requests have been filed by CAUS in connection with these sightings.

ADDITIONAL BENTWATERS WITNESS FOUND

During the second week of April, an important new development occurred in the Bentwaters/Woodbridge case. An additional witness who was stationed at Bentwaters during the incident in the Halt Memo, has been located, and has confirmed the details of "Art Wallace's" story. The witness has also added some information to the case information. The name and whereabouts of the new witness are being held confidential at this time in order to not compromise the investigation which is still ongoing.

UFO BUMPER STICKER CONTEST HELD

*****CLEAR INTENT - Update*****

Prentice-Hall, publisher of Clear Intent, by Barry J. Greenwood, and Lawrence Fawcett, has notified us that the books will be in the warehouse on June 15, and on shelves in bookstores on June 30. The spokesperson from Prentice-Hall stated that the advance letters and phone calls they have been receiving inquiring about this book have been unprecedented! Also, the person, who evidently does not normally make predictions about books, has decided to make a prediction about this book. That prediction is that Clear Intent is definitely going to be a Best-Seller!

As reviewers read the manuscript, similar comments and predictions continue to pour in. Fred Whiting, of the Fund for UFO Research, has stated that this is "the best-written UFO book ever published." Attorney Bob Bletchman (MUFON's State Dir. of Conn.) reviewed the book for the MUFON Journal. His comments strongly echo those of Fred Whiting, and he feels that the book will truly make a difference in informing the general public with regard to the UFO reality.

The Fund for UFO Research has put its support staunchly behind the book, and is working with Prentice-Hall to hold a press conference on July 15, at the book store at the Pentagon, in Wash., D.C., with the authors present to autograph books. The Fund will also offer a package deal for \$20, including the book and a group of supporting documents.

Prentice-Hall plans a national publicity tour for the authors in July, with guest appearances on "Good Morning, America," "The Merv Griffin Show," and many others in N.Y., Washington, D.C., and California.
