IMPORTANT NEWS

NEW MEETING LOCATION

As of January, 1985, we will be holding our monthly meetings at a function room at JOHN MARTIN'S MANOR RESTAURANT, on US Rte. 1, (Southbound) in Saugus, MA.

We recently held a dinner meeting at the restaurant, and found it to be thoroughly enjoyable and conveniently located. At that time, the decision was made to move our meetings to the that location.

NEW MEETING FORMAT

We will now hold dinner meetings monthly, but members will have the option of coming at 7:00 p.m. for both the dinner and the meeting, or of coming at 8:00p.m. after dinner, for the meeting only. We will no longer have a refreshment break, but will have a brief coffee break.

DINNER ARRANGEMENTS

Prior to each monthly meeting, we will need a head count of those planning to have dinner at the restaurant at the meeting. If we have at least 15 persons have dinner, the function room will be available at no charge to us for the evening. If we have fewer than 15 persons having dinner, the room will cost us \$15 for the evening, which is less than the cost of our current location for the same amount of time. The accommodations at the Manor are much more pleasant than those at our current location.

Entrées at the restaurant range in price from \$8.95 to \$13.95. There is also a salad bar included in the meal price.
