July/August, 2012 – Children of Earth and Sky

The last few months have been interesting, to say the least. In recent weeks, especially, I have visited a number of locations, including other MUFON chapters, doing regression work with close encounter experiencers. In the process, I have seen the emotional impact the phenomenon has in store for those who experience it.

Several powerful experiences stick in my mind – regression sessions with clients who have had hair-raising and life shattering encounters with ‘Them.’ To protect the identity of the experiencers involved, I will aggregate several such cases together into that of one composite person whom I will call ‘Mattie.’ Simply stated, what Mattie has gone through has to be one of the most powerful, heart-tugging experiences I think I’ve ever observed.

Most of the cases I assisted with have appeared to be classic abduction events. In each case, the witnesses described missing time, bedroom intrusions, close UFO sightings and a high degree of fear. In Mattie’s case, hypnosis turned out to be an excellent means of breaking through the amnesia barrier and exploring what the experiencer’s subconscious could recall of the events behind the veil of mystery.

In the process of hypnotherapy, we conducted the pre-hypnosis interview and I explained the process of hypnosis. Mattie explained to me how her life had been touched with strangeness from her earliest memories. She and her family had experienced a long series of strange events. She had also experienced challenges in her life, difficulty relating to her peers, isolation from family and friends, as well as a wide range of psychic/paranormal events. Many of these events were directly traceable to the UFO and close encounter phenomenon and at least some of them appeared to have a powerful emotional load. Clearly, something had happened, something we didn’t understand.

A few years after the abduction event we had planned to examine, Mattie had encountered the apparition of a tiny child. In her memory, the child had appeared as a dream-like or ghost-like being, standing at the foot of the bed. It was an angelic little girl, tiny with blonde hair and porcelain skin. She didn’t have a name for the child so we gave it a nickname, which I will refer to now as ‘Angel.’

Immediately upon breaking the temporary paralysis so common in abduction cases, Mattie ran throughout the house attempting to find this little child, but ‘Angel’ was nowhere to be found. Mattie then looked into the bedroom where her own children lay sound asleep. She found them safe, secure and unharmed. Finally, she returned to bed –

relieved yet haunted with the image of her tiny white visitor in the night. Thus, we conducted the hypnotic regression with one objective being to understand what had happened on that night.

Prior to the regression, Mattie had described some moderate female issues but indicated that at the time of the encounter, she had never been pregnant. Now, while in deep trance, Mattie found herself reliving a scenario within the alien realm, a medical procedure with alien beings extracting something from inside her body. Suddenly, she burst into tears with a heart-wrenching cry. "They've taken my baby!!!"

We immediately stopped the regression activity. I invited her to stand back and observe the event as if watching it on a TV screen. I gave her hypnotic suggestions of safety, comfort in the arms of her family and security in the company of her friends. We focused on healing work for the rest of the session.

I cannot imagine what it must be like to lose a child. It has to be the one of the worst events a human being can experience. As grief filled Mattie's face, I felt a wave of sadness as powerful as anything I had known during hypnotherapy sessions - ever. It was truly time for the researcher to take a back seat and the healer to come to the fore. Yet during the entire session, Mattie had the powerful sense that the child taken from her was the same child that a few years later stood at the foot of her bed.

Budd Hopkins, in his classic works *Missing Time* and *Intruders*, was the first to describe the missing child phenomenon. He described a pattern now commonly seen in abduction research - a sudden/unexpected pregnancy, frequently in a situation where the experiencer has not had any recent sexual contact. A few months later, just at the time that the woman realizes - and has accepted - that she is pregnant, another encounter occurs. The pregnancy suddenly disappears - no apparent miscarriage, no sudden illness or crisis that would cause the body to reject the baby. The child is simply gone.

In *The Cosmic Bridge*, I recount the poignant story of Carolyn, a woman who had experienced a nearly identical situation. Like Mattie, Carolyn experienced a sudden, unexpected pregnancy. And like Mattie, just at the point where she was ready to welcome the new baby into the family, suddenly the child was gone. Like Mattie, few years after the loss, Carolyn experienced a 'dream' in which she met a

child - with the unmistakable sense that this child was her own.

In Mattie's case, and in several similar cases, there is medical evidence to suggest that she had borne several children, even though (at the time) she had never been pregnant. A few years later, she and her husband had begun raising a family but at the time of the initial event, no children had come into the world - at least not in the 'usual' way...

Numerous such accounts fill my own files, as well as those of other close encounter researchers. In each case, we can only wonder - what's going on? Does each of these women have one or more children out there somewhere? Is 'Angel' living somewhere out there among the stars - perhaps along with other extraordinary children? Or is there some other explanation? I don't know.

There are several possible prosaic explanations for at least part of this phenomenon. Medical phenomena ranging from miscarriage to false pregnancy - and perhaps each might partially explain some aspects of this mystery. Yet can any fully account for the phenomenon, such a common, consistent and coherent narrative so full of emotion and pain? Can any of them explain the medical effects associated with these missing baby events? While science requires that we reserve judgment, so far, in my view, the possible explanations seem to fall short.

In the many close encounter witness interviews, and in fifteen years of hypnotherapy work, few cases are as poignant as those abduction cases involving missing pregnancies. In each case, we can only wipe away the tears and wonder what happened. I will always wonder if somewhere out there, the child we nicknamed 'Angel' is waiting - one of the legion of starchildren, the Children of Earth and Sky.

A third of Earthlings believe in UFOs, would befriend aliens By Natalie

Aliens often compete with superheroes, vampires and zombies to top hit movie lists - but more than a third of Americans say UFOs are not a fantasy.

That's the word from a new National Geographic Channel study finding that 80 million Americans

are certain UFOs exist and that one in 10 believe they've spotted one.

"We wanted the pulse on people's opinions," says Brad Dancer, senior vice president of research and digital media for National Geographic. "We wanted to get a sense of how Americans view UFOs, what people believe and how mainstream pop culture may or may not be playing into their opinions on it."

The results are in: Seventeen percent of Americans don't believe UFOs exist, 36% think they do, and 48% aren't sure.

The survey was commissioned for National Geographic Channel's series Chasing UFOs, premiering Friday at 9 p.m. ET.

About 79% of those surveyed think the government has kept information about UFOs a secret from the public, and 55% believe there are real-life Men in Black-style agents who threaten people who spot UFOs.

So what if they stopped by? The survey shows:

- 22% would try to befriend the alien, 15% would run away, 13% would lock their doors, and only 2% would try to inflict bodily harm.

- If angry aliens did attack Earth, 21% would call the Hulk in to deal with it, 12% would call Batman, and 8% would call Spider-Man.

- Nearly 65% think Barack Obama would be better suited than Mitt Romney to handle an alien invasion.

Extraterrestrial beings could not be reached for comment.

The Great Government Alien Cover-up: It's For Your Own Good?

Remember when you questioned your mum about one of the unfair restrictions she was placing on your 8-year-old life and she would say, "It's for your own good."

Her clipped tone added silently, "and that's the end of it."

When it comes to the US government covering up UFO's and alien abductions, they are acting like your mum. Ever since the incident in Roswell, New Mexico in 1947, they've covered up the existence of aliens among us.

Consider the comments of Edgar Mitchell, an Apollo 14 astronaut in a conversation with WPTV, a West Palm Beach TV station. Tim Malloy, reporter, told the home viewers, "He says the government he served in the military, and as an astronaut, is perpetuating cover-ups of alien sightings going all the way back to the legendary July 9, 1947 Roswell incident, an alleged alien spacecraft crash where remains were allegedly recovered."

Mr. Mitchell explained, "The reason for the denial is, number one, they didn't know if they were hostile, and could we protect ourselves from them? And they didn't want the Soviets to know, so they devised to lie about it and covered it up."

At Roswell, Air Force officers first turned in reports that they discovered parts and debris from a flying disc that had crashed. Later they came out with an official report that said that the debris had come from a "downed weather balloon."

This was the beginning of many times the US government would cover up UFO sightings and paranormal phenomena. Researcher Leslie McAney reported in an article in Gallup Poll Monthly that 71 percent of people surveyed expressed a belief that the US government knows more about UFOs than it is publicly admitting.

Wide Spread Doubt

The idea that the government is conducting an alien cover up permeates the media. Every night in the United States, radio listeners tune in to Coast To Coast, a nationwide program featuring conspiracy theories, paranormal activity and UFOlogy. Many movies such as Men In Black and Independence Day as well as TV shows such as The X-Files use a conspiracy theme.

It's not just UFO "watchers" and "abductees" that believe the government is keeping secrets. A 1971 survey conducted by Industrial Research/Development magazine revealed that 76 percent of respondents believe leaders are not telling everything they know about UFOs.

Some government officials have stated openly they think UFO evidence is being kept secret. They include Vice Admiral Roscoe H. Hillenkoetter,

astronauts Edgar Mitchell and Gordon Cooper, Senator Barry Goldwater, former Canadian Defense Minister Paul Hellyer, and various French generals and space experts.

Abduction Groups

There are several different alien abduction groups. They share interest on different types of aliens: Grays, Reptilians, and Nordics. Each is believed to have different rationale for coming to Earth. The groups claim that the lack of awareness about UFO's is due to the aliens own agenda, or the government is covering it up.

In *The Hidden Hand*, an award-winning documentary that explores UFO's and US military cover-ups, Stanton Friedman, a nuclear physicist and author of *Flyers Saucers* and *Science* said, "The government is important because they have the radar systems. They are in a position to connect, and to collect the data."

In the same film, Richard Dolan, a historian, and author of *UFOs and the National Security State*, Volumes 1 and 2, said, "People in the national security world are dealing with the fact that this is a lie that has gone now for so long, how do you undo such a long-standing series of deceptions?"

Merged Technology

Some UFO enthusiasts believe the explosion in technology in our modern world is the result of the government merging their technology with that of aliens. One theory is that aliens help "reverse engineer" their knowledge to make it work on our planet.

In a speech at an Exopolitik.org conference, Paul Hellyer, an author and former Canadian Defense Minister, said he believes the USA is using alien technology, and feels the opportunity has been wasted:

"We have a problem when official US policy says UFO's don't exist...The veil of secrecy has to be lifted now, before it is too late...How much has been accomplished in 60 years of feverish activity by some of the most educated minds in the United States. Has America developed flying saucers that are visually indistinguishable from the Visitors as alleged, and if so what do they propose to do with them?...Well, who has the answers? Well, somebody does! But, apparently they aren't telling the Secretaries of Defense or Presidents because they don't have a "need to know."

UFO's Are Real

On MSNBC-TV, Hellyer spoke with host Tucker Carlson. Carlson asked Hellyer if UFO's were real.

Hellyer answered, "For the last two or three years I've been looking at the evidence and assessing it much as a judge would, trying to determine who was telling the truth and who wasn't and I finally concluded, especially after reading a book called *The Day after Roswell* written by Col. Philip Corso, that Unidentified Flying Objects are in fact as real as the planes flying overhead, and there has been a monumental cover-up for more than half-century.

"This is after looking at a lot of evidence in trying to discern who was telling truth and who wasn't, and I've concluded unequivocally that the people who claim that they have either seen UFOs or seen classified documents about UFOs, or have seen wreckage from the crash at Roswell on or about July 4, 1947, are the ones who are telling the truth. And consequently, I'm basing my policy considerations on that."

Later Tucker asked, "Does this make sense: if in fact there are extraterrestrials and they are buzzing our planet, why wouldn't we want to take steps to defend ourselves from them if they turn hostile?"

Hellyer said, "Well, I think the critical question is whether or not they are hostile? When the crash first occurred (in Roswell) General Nathan Twining...declared that there were enemy aliens. There is no evidence that I've seen that would convince me that they are in fact enemies. What I would like to know is whether that classification of enemy aliens still exists, and if it did exist, what is the evidence that the United States government bases its conclusion."

Karl Wolf

What about people actually inside the US government? Consider these statements from ex-Air Force air-man Karl Wolf: "I was a precision electronics photographic repairman with the top secret crypto-clearance in the United States Air Force. I was stationed at Langley Air Force Base in Virginia in mid-1965. I was loaned to the lunar orbiter project of NASA at Langley Field.

"I was taken into the laboratory where the equipment was malfunctioning...about 30 minutes into the process, he said to me in a very distressed way, 'By the way, we've discovered a base on the back side of the moon. And then he proceeded to put photographs down in front of me.

“Clearly in these photographs were structures, mushroom shaped buildings, spherical buildings and towers, and at that point I was very concerned because I knew we were working in compartmentalized security, and he had breached security. I was actually frightened at that moment and I did not question him any further.”

Donna Hare

Donna Hare worked for a NASA supplier and learned about cover-ups early on. She said, “I worked at Philco-Ford Aerospace from 1967 to 1981. During that time I was a design engineer/illustrator draftsman. I did the launch slides, the landing slides, and also projected lunar maps for NASA.

“We were contractors but most of the time I worked on site in building 8. I had the opportunity to do extra work through downtime, which was between missions, and I walked in to the photo lab, which was a NASA lab across the hallway.

“I had secret clearance and I was able to go into restricted. One of the techs in there drew my attention to a photograph—it had a dot on it—I said was that dot on the emulsion? He smiled and he had his hands crossed, and he said round dots on the emulsion don’t leave shadows on the ground.

“This was an aerial photograph of the Earth. There were shadows of a craft, I did not know what this was, but I realized at this point that it was very secretive, that it was a ‘kept secret.’ I asked him what he could do with this piece of information. He said ‘we always airbrush these out before we showed them to the public.’”

Edgar Mitchell

Edgar Mitchell told WPTV, “I don’t know how many or where or how they’re doing it but they been observing us here for quite some time and we see these craft all the time. I believe what I’m saying and I cite the evidence that I know.”

According to WPTV reporter Tim Malloy, “Mitchell is unbothered by critics who think the guy with the right stuff has taken a wrong turn. He has no doubt that there are alien craft observing Earth right now and many more out there looking for us.”

Malloy asked Mitchell, “How many civilizations do you believe are out there?”

Mitchell answered, “Billions. There are billions and billions of stars in the galaxy, and billions and billions of galaxies doesn’t take but a few planets around a few stars to have quite a few civilizations.” Dr. Mitchell is one of only 12 people who have walked on the moon. He said he has never personally seen an alien but believes people who have.

Specific incidents

There have been several incidents over the past few decades where the government has covered up reports, commentary, photographs, films and more from people inside and outside the government. Here are a few examples:

-On July 7, 1947 William Rhodes took a picture of a strange object in Arizona. The pictures were published in a Phoenix newspaper and several other publications. An Army Air Force intelligence officer and a member of the FBI soon met with Rhodes and talked him into turning over the negatives. They then told him he would not be getting them back. The pictures ended up in classified Air Force UFO reports.

-In 1958, Donald Keyhole, a retired US Marine and UFO specialist, appeared on TV. His commentary about UFOs was “pre-censored” by the Air Force. As the show went on, when he tried to interject original statements that were not in the “pre-censored” script, the network cut his sound, saying later that he was about to violate security standards. Conspiracy theorists believe that what he was about to reveal were several unknown military studies that make the assertion that UFOs were interplanetary.

-John Callahan, a former Division Chief of the Accident and Investigations Branch of the Federal Aviation Authority in Washington said that in 1986, after a Japanese Airlines 747 had an encounter with a giant UFO over Alaska, it was recorded by radar on both the ground and in the air. The FAA started an investigation. Callahan held a briefing for the President’s Scientific Study Group, and other intelligence offices. Shortly after the briefing, one of the CIA agents in attendance said, “They were never there and this never happened.” The rationale given for this positioning was that they did not want the public to panic.

Why is the government trying to cover-up UFO sightings? What are they afraid of? Mass panic? That seems dubious. Maybe that was a concern in 1947. More than fifty years later, however, nearly

everyone has a cell phone. We have an orbiting space station. Governments are being overthrown by reformists using Twitter and Facebook.

In other words, we've come a long way technologically. We can handle some grown up talk about science, space and aliens. It is time for the government to come clean and tell us everything they know about UFOs, aliens and alien abductions.

We don't need another Mum. We like the one we have.

DO UFO-U.S. INTELLIGENCE COMMUNITY OFFICIALS HAVE A UNIQUE APPROACH ON UFOs and EXTRATERRESTRIAL LIFE FORMS?

If extraterrestrial and/or extra-dimensional beings, or other intelligences, are visiting Earth as some researchers suspect, are we approaching the situation in the best way? This discussion has been in the news recently due to the comments of physicists Stephen Hawking and Paul Davies as well as other emerging developments.

In his book "Messengers of Deception," researcher Jacques Vallee describes his interaction with a person he calls "Major Murphy."

"Then he posed a question that, obvious as it seems, had not really occurred to me: 'What makes you think UFOs are a scientific problem?'" wrote Vallee. Vallee explained, "Now, the UFO phenomenon could be controlled by alien beings."

To this, Major Murphy responded, "If it is, then the study of it doesn't belong in science. It belongs in intelligence." "Meaning counterespionage," Vallee noted. "And that, he pointed out, was his domain."

Murphy told Vallee, "Now, in the field of counterespionage, the rules are completely different."

Murphy also advised Vallee " ... you should look for the irrational, the bizarre, the elements that do not fit ... Have you ever felt you were getting close to something that didn't seem to fit any rational pattern, yet gave you the strong impression that it was significant?"

TRANSCENDENT INTELLIGENCE

Does Vallee's mysterious source Major Murphy have a point?

Is the conventional scientific approach used by humans in our current stage of understanding the only or best way to deal with the question of possible anomalous visitation to Earth and contact with humans?

We might consider the same question when pondering other interesting phenomena. What about life after death and the alleged dimension we call the afterlife? How about extrasensory perception (ESP) of various kinds?

There may be several complementary paths that can be used to explore these and other fascinating topics. The conventional scientific approach has an important role. First-hand experiences and intuitive perception about certain phenomena might also be helpful.

And, as Major Murphy told Vallee, the intelligence and counterintelligence concepts and methods might also be valuable and useful. The integration of these different ways of perceiving current situations might lead to a synergy or transcendent perspective and understanding.

Maybe this is part of what has been termed "transcendent warfare." The phrase was used by a Navy SEAL officer for a research paper about the U.S. defense and intelligence program on advanced human perception, Project STAR GATE.

The follow-on concept of "transcendent power" is meant to be one that is complementary to and synergistic with the military, diplomatic and persuasive elements called "hard power," "soft power" and "smart power."

Major Murphy might have even been referring to something we could call "transcendent intelligence and counterintelligence."

ADVANCED UNCONVENTIONAL OSINT

Just as average people from many walks of life try to become familiar with scientific developments, current events and contemporary issues of various kinds, our exposure to intelligence concepts might also be helpful. In fact, "open source intelligence (OSINT)" is simply the information out there in the

media, the Web, books, movies, TV shows and elsewhere that we can access and interpret.

In this sense, all people can become agents of transcendent intelligence. This perspective about the grassroots awareness and empowerment of average human beings might also create increased synergy that can contribute to progress in many areas of human development.

When it comes to normal current events as well as unconventional topics such as UFOs, ETs, ESP, life after death and angels, a higher intelligence and many other mysteries of Nature and the Universe, we probably all have potential access to greater understanding.

We might even consider that OSINT, though it typically refers to gathering open information from conventional sources, might also have leading-edge aspects related to unusual or alternative acquisition of knowledge and understanding.

That is, greater perception by average people at the grassroots can include normal information gathering and more forward-leaning methods, such as intuition and advanced perception that have been identified by U.S. intelligence and defense programs such as Project STAR GATE.

By exploring these kinds of transcendent intelligence, it is possible that we can learn more about the many mysteries that seem to hold the potential for important discoveries. Copyright (c) 2010 / Steve Hammons

PHYSICS OF THE IMPOSSIBLE

Recently I have been reading physicist Michio Kaku's book "Physics of the Impossible". On page 68 he says that "coherence" is the key to achieving both quantum computing and practical teleportation. Coherence is the condition in which a group of atoms or molecules are all in the same state – energy, spin, etc. – and behave like a single atom or molecule. Professor Rudy Schild gave a presentation to a MUFON Symposium a few years ago in which he said that the space-time travel principal used by aliens involves black holes and mental concentration on a chamber in the craft filled with quantum chaos. I'll offer the theory that these mental actions achieve coherence of the kind needed to teleport the craft and everything inside it to a specific time and place in the universe.

Experiencer Roger Kvande believes that the alien craft, in which he says he found himself on several occasions, used a black hole as the starting point for space-time jumps. I'll offer the further theory that the "semi-sentient mind" which Kvande said was controlling this alien craft was a quantum computer, and was therefore able to achieve the required coherence. In the 1800s, mentalist (my term) David Home (pronounced "Hume") was witnessed by reliable witnesses, including one of England's premier scientists, Sir William Crookes, as he levitated himself and other objects, including a grand piano. (This last feat took place in the home of a well-to-do Englishman, not on stage in a theater where Home could have prepared means of deception.) Once again I'll offer the theory that Home had discovered how to use his mind to "cohere" matter, and use "short distance teleportation" to achieve these feats. These theories are mere "hunches" of course, and may be partly or completely wrong. But I have read and seen enough of unusual human mental powers to believe that almost anything is possible. Keep an eye on the physicists; they may solve this puzzle yet.

Government Psychic Spies and Extraterrestrials

In April, SRI International announced (<http://www.sri.com/news/releases/041312.html>) it will be taking over the management of the Allen Telescope Array, whose primary purpose is listening for signals from extraterrestrial civilizations. The array was built by the Search for Extraterrestrial Intelligence Institute (SETI) and the University of California, with the majority of funding coming from its namesake, computer magnate, Paul Allen. SRI is no stranger to controversial projects. In the '70s SRI developed a method of psychic spying called "Remote Viewing," which quickly caught the attention of the CIA, and eventually culminated into a formal project ran by U.S. Army intelligence. Founding members of this clandestine organization claim they even used their skills to remote view UFOs and extraterrestrials.

SRI was originally the Stanford Research Institute, however, in 1970 it severed its ties with Stanford to become an independent non-profit organization and settled on the name SRI International in 1977. Founded in 1946, SRI is a research institute responsible for many important inventions

including the computer mouse you are using to scroll through this story right now.

In the early '70s, SRI physicist, Dr. Harold Puthoff (http://archived.parapsych.org/members/h_puthoff.html), began looking into psychic phenomena. According to the book, *Psi Spies*, by Jim Marrs, Puthoff's interests were piqued after reading a book on Russian psychic experiments. His colleague, Clive Backster, had been working on psychic experiments and one of the men he worked with, Ingo Swann, seemed to exhibit real psychic abilities. One of these skills being what Swann called "Remote Viewing," which was visualizing objects or places at a distance.

The same book that had piqued Puthoff's interest in psychic phenomena, *Psychic Discoveries Behind the Iron Curtain*, had prompted the CIA to begin monitoring the Russian's psychic research and inspired them to begin their own. They contacted SRI in 1972, and convinced by Swann's ability, the CIA funded Project Scanate. This eventually turned into the Army intelligence project Stargate, in which the remote viewing protocols SRI had developed were taught to a group of soldiers who would use the skill to remote view for various intelligence agencies. Stargate was headquartered at Fort Meade in Maryland.

Army intelligence officer Joe McMoneagle was the first man taught by SRI to remote view for project Stargate. In an interview (<http://www.blogtalkradio.com/ufothinktank/2011/06/07/joseph-mcmoneagle-remote-viewing-ufos-and-ets>), McMoneagle told me, "If someone would have told me we think you are psychic and we want you in this program, I would have told them, 'What, are you out of your gourd?'" McMoneagle was more than a little reluctant when he was first invited to discuss the project. He says a bunch of men were brought into a room and asked about paranormal topics. McMoneagle recalls that his reaction was that he felt the Army needed to be on top of paranormal research due to the possible implications. This answer must have been what they were looking for because he soon found himself undergoing psychic testing, something he surprisingly showed a great aptitude for.

The original group for Stargate consisted of six remote viewers, and the program ran for nearly 20 years. McMoneagle says the program was very successful. They were tasked by nearly every known intelligence organization to retrieve data on items such as missing fighter bombers, terrorists, enemy bases, and even a kidnapped general. He says often

the projects brought to them were cold cases that were over a year old, but within hours their group was able to provide new information which was accurate 22 percent of the time.

McMoneagle said that throughout the program there was also an interest in UFOs, and that he had remote viewed extraterrestrials himself. He shares many of these experiences in his books (<http://www.mceagle.com/remote-viewing/>) documenting his career as a psychic spy. Swann also wrote about his remote viewing of extraterrestrials in his autobiography, *Penetration: The Question of Extraterrestrial and Human Telepathy*. In the book he claims he remote viewed alien bases on the far side of the moon.

McMoneagle says most of the remote viewing of ETs and UFOs was done independently of requests by governmental agencies. However, he did recall being asked about an object he sensed while remote viewing a base in the eastern bloc for the Air Force. He described a saucer shaped object at 13,000 feet moving at 4,000 miles per hour that had made a hard 90-degree turn. He later found that at that target, the Air Force had gotten pictures of an unknown object travelling at 3,900 miles per hour at 11,000 feet that had made a hard right turn just as McMoneagle had described.

Project Stargate was shut down in 1995 after two independent studies on the validity of SRI's work. One of the studies (<http://anson.ucdavis.edu/~utts/air2.html#7>), done by Dr. Jessica Utts at the University of California, concluded, "It is clear to this author that anomalous cognition is possible and has been demonstrated. This conclusion is not based on belief, but rather on commonly accepted scientific criteria." Another study, done by Dr. Ray Hyman at the University of Oregon, disagreed. Either way, the government did not feel that the expense of the program could be justified and the government's foray into psychic spying ended.

De Void - A snowball's chance?

So what really happened to radiation-burn victims Betty Cash, and Vicki and Colby Landrum outside Houston on the evening of Dec. 29, 1980? They claimed their car was blocked by a glowing, diamond-shaped UFO on said date, and that the object was surrounded by 20-plus military helicopters, including twin-rotor Army Chinooks. It's a well-chronicled story

<http://devoid.blogs.heraldtribune.com/11457/cash-landrum-gone-with-the-wind/>, and not even the Army Inspector General's report could dismiss it as a hoax. However, it couldn't, or wouldn't, account for the military aircraft reported on the scene by multiple witnesses.

Retired Army Col. John Alexander is sticking to a contention raised in his 2011 book, *UFOs: Myths, Conspiracies, and Realities* – the Defense Department knows nothing about this subject, and the phenomenon is far more bizarre than anyone could ever suspect. "Whatever the widget (UFO) was, it projected holograms or put things in people's minds," Alexander says. "There was a thorough investigation to find the helicopters, and they absolutely could not find them."

He argues that any harassment of military personnel who speak up about UFOs was/is conducted by lower-ranking officials with no authority to do so. So certain is Alexander that no military policy-level censorship of UFO data exists, he issued a written appeal last week to SecDef chief Leon Panetta http://www.huffingtonpost.com/2012/05/16/ufo-amnesty-sought-by-army-colonel_n_1513197.html, CIA director David Petraeus, and National Intelligence Director Gen. James Clapper to formally release military veterans from their security oaths on UFO matters. "I suspect I'll get a form letter back, one of those 'thank you for your interest' letters," he says from his home in Las Vegas. "We'll see."

By contrast, former MUFON International Director John Schuessler and lead investigator on the Cash-Landrum Incident is "99 percent confident" the military was up to its eyeballs in that event. Furthermore, he suspects that any sort of amnesty the feds might extend to military witnesses to encounters like Cash-Landrum would be fruitless.

"What have they got to gain, after all these years? People don't usually do things like this except for personal gain, usually money," says Schuessler, who dismisses Alexander's hologram theory as bunk. In fact, during the buildup to the 50-year anniversary of the Roswell Incident, USAF Secretary Sheila Widnall in 1994 extended blanket amnesty to any veterans with inside dope on that maddening affair. Not a single witness stepped forward. Maybe those guys were all dead by then. Or maybe Schuessler is right.

"I think amnesty would be great, quite honestly, but the Catch-22 is, where do you stop it? It opens up a Pandora's box. I mean, there are real threats to this country and I don't think the public has a right to know everything that goes on at Area 51 or Los Alamos."

What Schuessler and Alexander agree on is that "de facto amnesty" is already in effect. Countless veterans have shared their experiences — e.g., the Rendlesham Forest episode in 1980 <http://www.nickpope.net/bentwaters-ufo-incident.htm> — without being court-martialed. Indeed, as UFOs and Nukes author Robert Hastings notes, scores of USAF veterans have gone on record in his 2008 book or at his 2010 press conference <http://www.youtube.com/watch?v=3jUU4Z8QdHI> without being prosecuted for spilling the beans.

Writes Hastings, "Not a single one of my former or retired USAF sources has ever suffered legal or other untoward repercussions as the result of speaking to me about their involvement in a still-classified nuclear weapons-related UFO incident."

De Void's two cents: The Pentagon doesn't have the stones to give Alexander what he wants. That would force the USAF to admit its 40-year-old press release on UFOs is a sham.

Nazi spaceship film sparks UFO debate

A new sci-fi film about Nazis has reignited a debate in Germany about Hitler's development of UFOs.

The Finnish sci-fi comedy 'Iron Sky' centres on real-life SS officer Hans Kammler who was said to have made a significant breakthrough in anti-gravity experiments towards the end of WW2. Trailer: http://gcdn.2mdn.net/MotifFiles/html/1139716/GMBV12TV110H_VeranoPreRoll_133165028129857_H263_high.flv

The film relates how, from a secret base built in the Antarctic, the first Nazi spaceships were launched in late 1945 to found the military base Schwarze Sonne – Black Sun – on the dark side of the Moon.

This base was to be used to build a powerful invasion fleet and return to take over the Earth once the time was right, in this case 2018.

But a new report out this week in Germany in the magazine PM purports that there is "strong evidence" that a Nazi UFO program was well advanced.

Hitler ordered Luftwaffe chief Hermann Goering to develop the super weapon that would change the war.

The PM report quotes eyewitnesses who believe they saw a flying saucer marked with the Iron Cross of the German military flying low over the Thames in 1944.

At the time the New York Times wrote about a "mysterious flying disc" with photos of the device seen traveling at extremely high speeds over the high-rise buildings.

The best known of the Nazi UFO projects was the Schriever-Habermohl scheme, named for Rudolf Schriever and Otto Habermohl.

Initially a Luftwaffe project, it fell under the auspices of armaments minister Albert Speer before being taken over once again in 1944 by Hans Kammler.

Eyewitnesses captured by the Allies after WW2 claimed to have seen the saucer produced in Prague fly on several occasions in early 1945.

Joseph Andreas Epp, an engineer who served as a consultant to the Schriever-Habermohl project, stated 15 prototypes were built in all.

He described how a central cockpit surrounded by rotating adjustable wing-vanes formed a circle.

The vanes were held together by a band at the outer edge of the wheel-like device. The pitch of the vanes could be adjusted so that during take off more lift was generated by increasing their angle from a more horizontal setting.

In level flight the angle would be adjusted to a smaller angle, similar to the way helicopter rotors operate. The wing-vanes were to be set in rotation by small rockets placed around the rim like a pinwheel.

Once rotational speed was sufficient, lift-off was achieved.

After the craft had risen to some height the horizontal jets or rockets were ignited. "After this the wing-blades would be allowed to rotate freely as the saucer moved forward as in an auto-gyrocopter. In all probability, the wing-blades speed, and so their lifting value, could also be increased by directing the adjustable horizontal jets slightly upwards to engage the blades, thus spinning them faster at the digression of the pilot," he said.



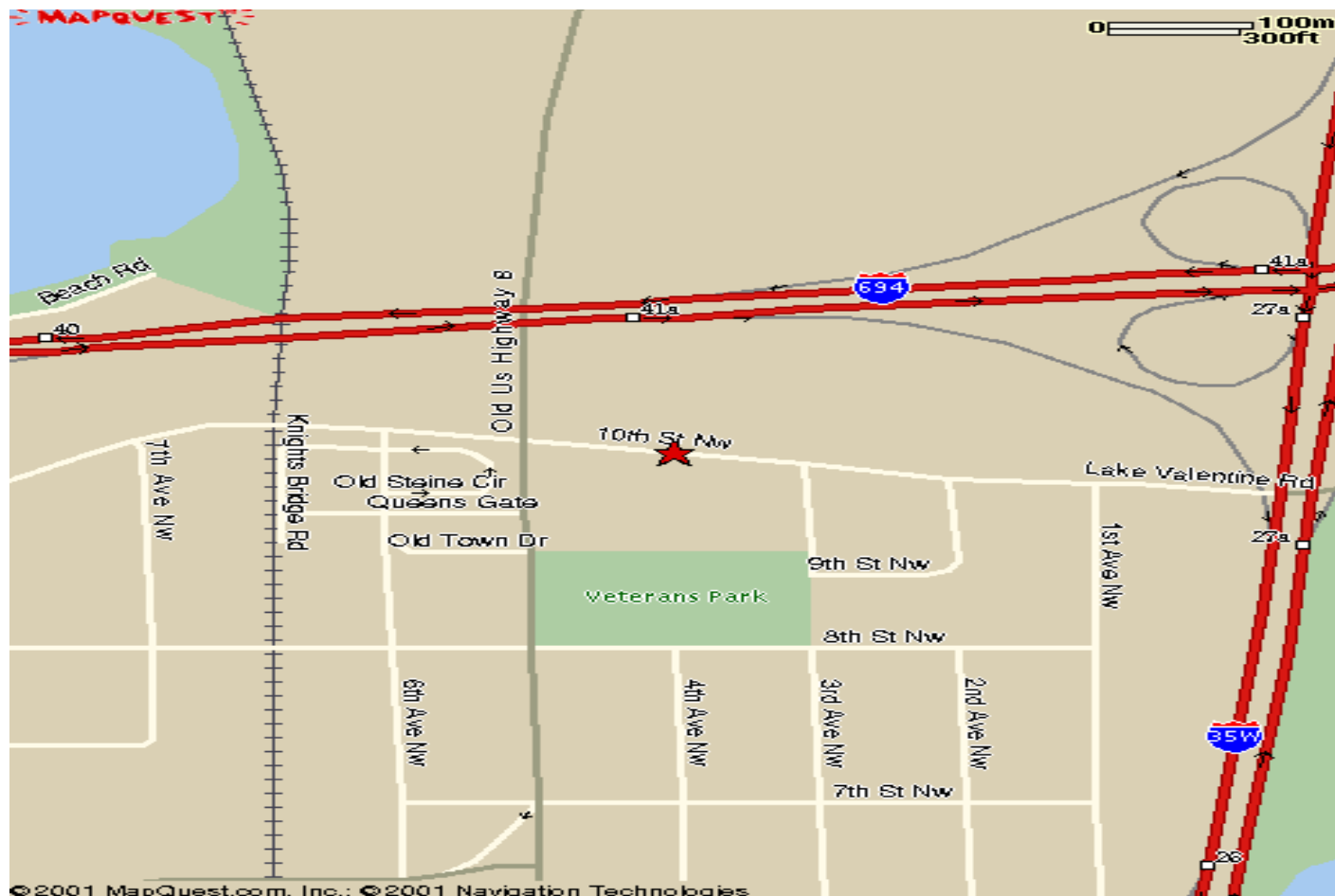
