

Three UFO Lights Reported From Two States

Witnesses in Kansas and Missouri seem to be describing the same object - or objects - when three lights were reported in both cases that occurred on December 21, 2010, according to testimony from the Mutual UFO Network (MUFON) witness reporting database.

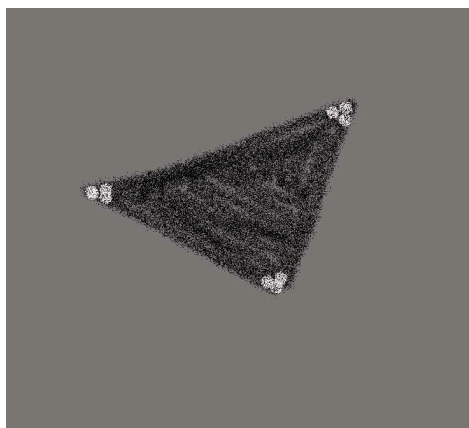
An Overland Park, Kansas, witness is curious about three lights seen while driving east on I-435 at Highway 69 on December 21, 2010, in MUFON Case # 27078.

"Two of them were together, then after 15 seconds or so, the other joined the two and they all continued flying east out of our sight," the witness stated. "Probably had sight of them for a total of 2-3 minutes. Couldn't hear them, but they all had 1 or 2 blinking lights on them and couldn't make out shapes. The only reason I write this is because I don't see three aircraft like that flying together over the city together like that."

A Kansas City, Missouri, witness was driving along Red Bridge Road at 7 p.m. on December 21, and reports "three bright lights" in MUFON Case # 27077.

"Object looked quite big," the witness stated. "As it flew closer,

It looked like a triangle, that's what I thought. I actually pulled off the road, got out of my car

and watched this thing fly, literally, over my head slowly and very low, maybe several hundred feet up, over the road. It made a noise like a flying craft of some sort."

The object seemed to be triangle in shape and dark grey.

"There were three lights on each point, so to me it really seemed triangular. It was really strange, it was completely grayed out, meaning that you couldn't see any real shape. Last night was cloudy, but not black. This thing was just a little darker shade grey that barely could be made out."

Both reports were filed with MUFON on December 23, 2010. No video or No images were included with either report.

Please keep in mind that most UFO reports can be explained as something natural or manmade. If Missouri or Kansas MUFON investigates and reports back on these cases, I will release an update. Please report UFO activity to MUFON.com.

From the editor: Stan Seba from Kansas, and Margie Kay from Missouri are continuing to work on this case and will report any new findings on the Missouri Mufon Chat List. The locations of each sighting are within several miles of each other.

Stan is currently checking for other sighting reports from other states on the same night that are similar to this one. The investigators think it is possible that three separate craft merged into one.

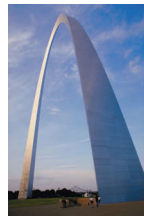

Book Review: The Art of Close Encounters

Yesterday, December 27, 2010, I received my copy of **The Art of Close Encounters** by Kim Carlsberg. I had originally ordered this book in early November. After two printing delays, I finally received it. Was I disappointed? Not in the least.

Kim Carlsberg is an accomplished photographer and artist who has worked in the entertainment and music industry. Her fine-art images have been used in books, magazines, television, print ads, major motion pictures, as well as being featured in solo gallery exhibitions in Los Angeles, CA, Santa Fe, NM and Aspen, CO. She is also an extraterrestrial experimenter and contactee. She has both the life experiences and graphic skills to put together a fine volume such as this.

George Noory (Coast to Coast) has stated "The sheer volume of

stories, the authenticity and range of the encounters, and the beauty and diversity of the art makes this new book the closest we will have to a reference guide to this extraordinary phenomenon. A remarkable achievement."

Leo Sprinkle, PhD (Contact researcher, University of Wyoming) remarks regarding **The Art of Close Encounters** "Visually stunning, intellectually compelling and spiritually illuminating."

I have shown this book to some friends and family members who are not as interested in the UFO phenomenon as I am. Generally, they quickly became fascinated with the artwork and asked ques-

tions regarding ET as their interest peaked. The multicolored graphic layout, heavyweight paper and secure binding indicate that this was an expensive book to print. I ordered it from Close Encounters Publishing. The book is \$34.95. With shipping and sales tax the total was \$42.29.
